NEXT-TO-LEAD ING ORDER CORRECTIONS TO e⁺e ! FOUR JETS

Abstract

I present a general purpose M onte C arlo program for calculating the next-to-leading order corrections to arbitrary four-jet quantities in electron-positron annihilation. In the current version of the program, som e subleading in color term s are neglected. A s an example, I calculate the four-jet rate in the D urham scheme as well as the Bengtsson-Zerwas angular distribution at O ($\frac{3}{s}$) and compare the results to existing data.

Four-jet events have been copiously produced at the Z-pole and at smaller energies at electron-positron colliders. These events allow the study of new aspects of QCD. For instance, the three-gluon coupling and the dependence on the number of light avors, N_f, enter already at tree level. Therefore, this seem s to be an ideal place for a measurem ent of the color factors [1, 2, 3]. Even if there is no doubt about the correctness of QCD as the theory of the strong interactions, these measurem ents are not purely academ ic. In fact, the ongoing debate about the existence of light gluinos could be settled immediately by measuring N_f precisely enough (see e.g. ref. [3] and references therein). Indeed, the addition of a massless gluino amounts to a change of N_f from 5 to 8. A loo at LEP2 four-jet events will play an important role, since they are the main background for the W pair production. Thus, a next-to-leading order prediction for such quantities is highly desirable.

In this talk I present some next-to-leading order results for the four jet fraction and some angular distributions. These results have been obtained with a program [4] which can compute an arbitrary four-jet quantity at next-to-leading order. However, as will be discussed below, some subleading in color contributions have been neglected so far.

A ny next-to-leading order calculation involves basically twom a jor steps. First, the corresponding one-loop amplitudes have to be computed and second, the phase-space integration has to be performed. This second step involves the cancellation of the real and virtual singularities. I used the general version of the subtraction method as proposed in [5] to do the phase space integrals. Thus, no approximation at all has been made in this part of the calculation.

The one-loop amplitudes which are needed for the calculation of four-jet events are $e^+e^-! qqq^0q^0$ and $e^+e^-! qqqg$. Recently, the amplitudes for four quarks in the nal state have been computed [6, 7]. However, the situation concerning the one-loop amplitude for the qqgg nal state is less satisfactory. Unfortunately, only the leading in color terms are known so far [8]. As a result, subleading in color pieces of the cross section can not yet be computed at next-to-leading order. Writing the color decomposition of any four-jet cross section as

Besides the one-loop am plitudes, the tree-level am plitudes for the processes e^+e^- ! $qqq^{q}q^{q}g$ and e^+e^- ! qqgggg are required for the computation of the real contributions. They have been obtained by several groups [9, 10]. In the program the results of ref [9] are used.

In the calculation of these amplitudes all quark and lepton masses have been set to zero. This is usually a very good approximation, although the b-quark mass e ects can yield considerable corrections [11]. Unfortunately, the complete inclusion of mass e ects at the order O ($\frac{3}{s}$) is presently out of reach, the main reason being the fact that the one-loop amplitudes are known only for the massless case.

Besides the mass elects and subleading in color terms, three more contributions were neglected, although in principle their inclusion would not pose a problem.

(1) Contributions coming from Pauli exchange. The corresponding O ($_{s}^{2}$) terms are known to be numerically tiny and it is expected that the O ($_{s}^{3}$) terms are numerically not very signi cant.

(2) C ontributions proportional to the axial coupling a_q of the Z⁰ to quarks. A nalogous term shave traditionally been on itted from 0 ($\frac{2}{s}$) program s, as they cancel precisely between up-and down-type quarks in the nalstate (for zero quark mass), and their contribution to the three-jet rate is at the percent level [12].

(3) Contributions proportional to $({}^{1}_{q} v_{q})^{2}$, where v_{q} is the quark vector coupling. These \light-by-glue scattering" terms do not appear at 0 (${}^{2}_{s}$) at all, have a partial cancellation from the sum over quark avors, and contribute less than 1% to the 0 (${}^{3}_{s}$) term in the total cross-section [13].

I rst present the results for the four-jet rate R_4 $_{4 \text{ jet}} = _{\text{tot}}$ at next-to-leading order in $_{\text{s}}$ in the D urham scheme [14]. The y_{cut} dependence is shown in Fig. 1. The solid (dashed) line represents the one-loop (tree-level) prediction. The renormalization scale has been chosen to be the center-ofm assenergy $^{\text{P}}$ s, the number of avors $N_{\text{f}} = 5$ and $_{\text{s}} = 0$:118 [15]. The data points are preliminary SLD data [16] and are corrected for hadronization.

The truncation of the perturbative expansion for any physical quantity leads to a dependence of the theoretical prediction on the choice of the renorm alization scale . The tree-level

dependence is much stronger for the four-jet rate than for the three-jet rate, because the form er is proportional to $\frac{2}{s}$ instead of s. As expected, this strong renorm alization-scale dependence is reduced by the inclusion of the next-to-leading order contribution. Fig. 1 also plots the -dependence of R_4 at tree-level and at one-loop for $y_{cut} = 0.03$.

Four-jet angular distributions [17] have been m easured by several collaborations [1, 2, 3]. The general procedure is to choose a certain jet de nition. Then, in the case of a four-jet event, the jets are ordered according to their energies such that $E_1 > E_2 > E_3 > E_4$. U sually, them ost energetic jets are associated with the prim ary quarks whereas the remaining two jets either origin form a quark or gluon pair (at tree level). This can be exploited to construct angular variables which have a completely di erent shape for the four-quark and the two-quark-two-gluon nal state. Since the two nal states are proportional to di erent color structures one can attempt to measure the various color factors and in particular the num ber of light avors N_f. Unfortunately, the four-quark nal state is strongly suppressed.

As a result, the full distributions are not very sensitive to N $_{\rm f}$ and the error on the m easured value of N $_{\rm f}$ is accordingly large.

A n advantage of the angular distributions lies in the fact that one does not need to worry about large logarithms coming from a particular choice of the renormalization scale. The reason for this can easily be understood. At tree level, the strong coupling constant appears only in an overall prefactor. Since these distributions are normalized, the value of $_{\rm s}$ and thus the choice of the renormalization scale has no in uence at all on the result. Only the inclusion of the one-loop corrections introduces a extrem ely mild -dependence.

As an example, I consider the Bengtsson-Zerwas angle, $_{\rm BZ}$, and compare the next-toleading order prediction with the two most recent analyses of OPAL and ALEPH [2, 3]. In [2] jets were de ned according to the JADE scheme with $y_{\rm cut} = 0.03$, whereas in [3] the D urham jet algorithm with the EO recombination scheme was used and $y_{\rm cut}$ was chosen to be 0.008. Note also that the two experiments use di erent normalizations. Fig. 2 compares the tree-level (dotted) and next-to-leading order (solid) predictions to the data which have been corrected for detector and hadronization elects. The dotted line can hardly be seen because it nearly coincides with the solid line. The theoretical curves have been obtained by binning $_{\rm BZ}$ into twenty bins. This rather ne binning results in a som ewhat larger statistical error, which is of the order of 2% for the shown curves. In order to illustrate the mild dependence on N f I plotted also the one-loop results for N f = 8 (dashed). A lthough this dependence and thus the precision on the measurement of N f m ay be enhanced by additional cuts or by b-quark tagging [18], Fig. 2 shows that it is very di cult to get a precise measurement of N f f m angular distributions alone.
