In ationary reheating classes via spectral methods

In ationary reheating is almost completely controlled by the Floquet indices, $_k$. Using spectral theory we demonstrate that the stability bands (where $_k$ = 0) of the M athieu and Lame equations are destroyed even in M inkowski spacetime, leaving a fractal C antor set or a measure zero set of stable modes in the cases where the in aton evolves in an almost-periodic or stochastic manner respectively. These two types of potential model the expected multi-eld and quantum backreaction elects during reheating.

I. IN TRODUCTION




FIG.1. A schem atic map of models and approximations in preheating. M in im al references for techniques in the exactly periodic case are shown in brackets. The right-hand branch corresponds to paradigm s developed in this paper.

In ation is perhaps the heir apparent in high energy cosm ology. No other theory can be cast successfully in so many guises. Yet, to be successful, any in ationary scenario must reheat the universe. This epoch is typically very short and has become a powerful virtual laboratory for researching non-equilibrium quantum eld theory in curved spacetime [I{11}. It is dened by rapidly evolving paradigms (see the left half of Fig. 1), attempting to deal with the non-perturbative processes occurring in preheating [I]. The dening characteristic of a preheating model are its F loquet indices $_{\rm kR}$ which control the number of produced particles $n_{\rm k}$ dkk² e^{2m} $_{\rm k}$ t and variances of the elds [9].

O fparticular interest are the issues of how the $\, _k \,$ vary as (i) the param eters (typically the coupling constants) of the theory are changed, and (ii) the functional form of the in aton evolution is altered. The rst has been studied in depth in the case where the in aton evolution is exactly periodic and is the very origin of preheating. The second issue ism uch less studied and is the subject of this paper where we introduce spectralm ethods as an elegant classic cation tool for in ationary reheating classes; though it also applies to the param etric amplication of gravitational waves [11]. To illustrate the idea, consider the Hill equation:

where P (2t) is any periodic function of the independent variable t. When P () / \cos (), we have the M athieu equation, while P () = $\dot{\text{cn}}$ () yields the Lam e equation, where cn() is the elliptic cosine function. Now Eq. (1) is equivalent to the one-dimensional Schrodinger operator-eigenvalue problem:

under the transform ations $x \$ t, $Q(x) \$ 2qP (2t), S A. We denote the spectrum of L by (L), its complement by (L). The crucial point to notice is that the set of modes with positive F loquet index of Eq. (1) contains

the set (L) of Eq. (2). By exploiting this equivalence we will show that:

I-G enerically for alm ost-periodic potentials Q(x), the corresponding spectrum is a fractal C antor set. This implies a Floquet index which is positive on a dense subset of momenta $k \in [0;1]$. As the strength of the coupling is varied, drastic changes to the spectrum can occur that are absent in the purely periodic case.

II – P reheating exists in stochastic in ation and the F loquet index is positive with Lebesgue m easure 1 for all m om enta k. E stim ates for $\ _k$ are given in the perturbative and non-perturbative lim its by Eq.'s (15) and (16) respectively.

These results describe geom etrically the breakup of the stability-instability chart that in the case of the H illequation (1) has a neat band-structure. V isually, this is similar to the breakup of invariant tori in the KAM theory of chaos [15]. Similar results to those of H above have recently been found independently [16,17] in special cases for the noise. In particular, Zanchin et al [17] rewrite Eq. (1) as a restorder matrix equation and then use Furstenberg's theorem [18] regarding products of independent, identically distributed random matrices to obtain estimates of $_{\rm k}$, showing that noise increases the $_{\rm k}$ over the periodic case and that $_{\rm k} > 0$ for all wavelengths, thus also demonstrating the break-up of the stability bands, although in the context of small noise.

The results of I and II above enlarge the known reheating territory (see Fig. 1). The classical theory of reheating was developed in the early 80's [12], with recognition of the importance of perturbative resonances [13]. In this case the resonance bands essentially dw indle into a discrete sequence of lines. The paradigm shift of preheating [1], showed that the resonance bands could be very broad at large q, a fact that extends to gravitational waves [11,14]. This was followed by approxim ations to deal with the non-perturbative e ects [5,4], and the idea of non-therm alsym metry restoration induced by the large quantum uctuations [3]. Recently stochastic resonance [9,10] has represented a shift away from the sim ple picture of static resonance bands, due to the large phase uctuations which, mod 2, behave random ly in the non-perturbative regime in an expanding universe. Finally, the negative-coupling instability [8] represents

the exciting possibility that modes can evolve where the spectrum of the corresponding Schrodinger operator is almost empty, and Floquet indices are very large. This mechanism has been realised within the framework of non-minimal elds coupled only to gravity, which therefore o ers a geom etric reheating channel [11] due to the oscillation of the Ricci curvature.

In this paper we consider almost-periodic (section II) and random (section III) potentials which are both realizations of metrically transitive (i.e. ergodic and hom ogeneous) operators [20,21].

II. CANTOR REHEATING

We limit our discussion in this section to Minkowski spacetime y . Consider the in aton, , and the two minim ally coupled scalar elds ', with the natural mass hierarchy m m, m . In this section we consider the e ective potential:

argum ents. The evolution of the k m odes is then [1]:

Instead the in aton zero-mode evolves according to:

where the frequency of oscillation is partially controlled by the e ective m ass:

In the case that $h^2i = h^2i = 0$, the in aton simply oscillates with constant period. However, when there are multiple-elds, or the mass acquires corrections due to quantum uctuations, the period is no-longer constant, but may increase monotonically, oscillate or exhibit random uctuations. As an example, in the special case of a Yukawa interaction, F () = , Eq. (5) has a pure driving term / g^2h^2i .

Understanding the behaviour of the F loquet indices in these more general cases is extremely complex and we therefore search for special, solvable classes, which naturally leads to the study of almost-periodic potentials [25]. In this case, the spectral theory becomes signicantly richer and more beautiful.

In general, for a separable Hilbert space, as we have here, the spectrum can be decomposed w.r.t. an abstract measure d as = $_{AC}$ [$_{P}$ [$_{SC}$ [20], where $_{AC}$ is the absolutely continuous, P is the pure point and SC the singular continuous part of the spectrum. An important constraint is that the F loquet index must vanish for 2 $_{AC}$, i.e. $_{AC}$ = f 2 R j = 0g bar a set of m easure zero [20], and hence $_{\rm A\,C}$ corresponds to m odes with bounded evolution (extended eigenfunctions). On the complement, $\overline{\ }_{AC}$, the Floquet indices are known to be positive, and hence in the case when AC is empty,




FIG. 2. A schematic diagram comparing the spectrum of the Mathieu equation (upper) and that of a generic limit-periodic operator with fractal Cantor spectrum (lower). The black shading represents the complement of the spectrum, i.e. modes with $_{\rm k}$ 60. The Cantor spectrum is only shown at second level due to resolution limitations. The same pattern repeats itself in each white gap and hence the number of stable modes is much smaller than in the periodic case.

 $_{k} > 0$ alm ost everywhere [29]. To understand this better, consider the periodic potential. In this case, (L) = AC and on (L), > 0. It is the fact that $_{A\,C}$ is so large that forces the strong band structure of the Mathieu and Lame equations. In the Lame case, (L) consists of a single band and there are very few exponentially growing modes [4]. A comparison between the archetypalCantor set and the spectrum of the Mathieu equation is shown in Fig. (2).

The almost-periodic potentials are those for which the Fourier transform consists of a frequency basis flig where the smallest vector space containing this basis, M, F (); J () are assumed to be analytic in their respective is dense in R . As a simple example consider Eq. (4) with F () = 2 ; J (') = $^{\prime}$ 2 and = 0. Then the equations for the quantum uctuations of k are:

with sin (m t) and ' sin(m,t). When m = m, is irrational, the potential is quasi-periodic. The spectrum of Eq. (2) for almost-periodic potentials can be pure point and is, in a non-rigorous way, generally a nowhere dense Cantor set [26]. Hence, in the example above, for in nitely many irrational values of m = m, we may expect that the spectrum of k will be nowhere dense, and

This can be restated as the fact that the integrated density of states, proportional to the rotation number [30], vanishes.

consequently that alm ost all m odes w ill grow exponentially.

However, unlike the random potentials to be considered in section (III), the Lebesgue measure of the spectrum, even if a C antor set, need not be zero [25] and $_{\rm AC}$ may be non-empty. Indeed it is possible to have $_{\rm AC}$ [19].

M ore rigorous results exist in the case that Q is lim itperiodic, i.e. it is a uniform lim it of periodic potentials. A typical example is provided by:

Thus the set of k for which $_k$ \in 0, is dense in R $^+$ despite the fact that $_{A\,C}$ is not empty. This existence of only a C antor set of stable m odes leads us to call this cantor reheating. An associated issue is what happens as the coupling to the potential (analogous to q in Eq. (1)) is increased. While in Eq. (1) this simply changes the breadth of the instability bands and magnitude of $_k$ while always leaving $_{A\,C}$, in the almost-periodic case this is not the case. Indeed, as in the example below, the nature of the spectrum (w.r.t. the splitting into P; SC; AC) can change suddenly with q.

${\tt A}$. The discrete alm ost-M athieu equation

Consider the discretized Schrodinger eq. (2), which is also used (in higher dimensions) in numerical preheat-

ing studies [6,7]. A special case is the almost-Mathieu equation with exhibits a rich variety of e ects $^{\times}$:

When is rational the potential is periodic and one has the band spectrum of the Mathieu equation. However, for irrational, the spectrum is a Cantor set generically for pairs (q;) 2 R 2 [33]. This shows that the nowhere dense nature of the spectrum is not lost as one increases q and hence moves from perturbative reheating to broadresonance preheating. Further, when is irrational, the F loquet index has the lower bound [35]:

so that for jqj>1, $_k>0$ and hence the absolutely continuous part of the spectrum , $_{A\,C}$, become seem pty. In this case, if is a Liouville number , then the spectrum is purely singular continuous, = $_{S\,C}$ [27]. Conversely if jqj<1, the point part of the spectrum is absent for irrational [34].

III. STOCHASTIC INFLATIONARY REHEATING

We now consider the case where the potential Q in Eq. (2) is random. This models for example, the classical lim it of stochastic in ation, where the dynam ics of the local order parameter in a FLRW background, are described by [22]:

where H \underline{a} =a is the stochastically evolving Hubble constant [24], is a coloured gaussian noise of unit amplitude with a correlation time of order H $^{-1}$, so that the in aton evolves stochastically. The origin of the noise is the backreaction of quantum uctuations with wavelengths shorter than the coarse-graining scale [23,24,16].

Here we will consider the potential V() = 4=4 and as before an interaction term $g^{2-2}=2$. The quantum uctuations of the elds and are then given by YY:

where p = $(\frac{1}{2}-^2 \ \ \ \ \ \)$) is the pressure and = 8 G . These equations are again equivalent to Eq. (2), but this time with stochastic potentials, which are the opposite extreme to periodic potentials since they generically have empty $_{AC}$. In fact we have the following theorem:

<u>Theorem 2</u> [31,32] { If Q (x) is a su ciently random potential for Eq. (2), then > 0 for almost all 2 R and $_{AC}$ of L is empty with probability one.

Indeed we see that a positive F loquet exponent is guaranteed for all modes bar a set of measure zero, and again reheating is signi cantly dierent from the periodic case. Here \su ciently random "means nondeterministic [20] and is typically a requirement that correlations decay sufciently rapidly. An example is a Gaussian randomeld whose correlation function has compact support. To proceed to obtain quantitative estimates of the F loquet indices, we exploit the fact that Eq.s (12,13) have the form of stochastic harm onic oscillators.

A . Explicit estim ates for the F loquet indices

Consider the stochastic harm onic oscillator, with frequency given by $!^2 = ^2 + q$ (t), where q is a dimensionless coupling to the mean-zero coloured stochastic process (t) and $^2 = k^2 = a^2$ in our case. The F loquet index has been shown to be strictly positive for all q [28]. It has also been related to the spectral density of uctuations via averaging over the second moments [37] of the random process [38]:

This has the form of a uctuation-dissipation theorem since uctuations in the in aton eld determ ine the dissipation rate into other elds. In the case that (t) is a mean zero ergodic M arkov process, $_{\rm k}$ can be explicitly estimated as [36]:

where \hat{f} is the Fourier transform of the expectation value of the two-time correlation function h (t) (t 0 ti. Note that ${}_{k}$ / ${}_{k}$ 2, so that although all modes grow exponentially, the Floquet index is, as in the periodic and stochastic resonance [9] cases, a rapidly decreasing function of k. In the broad-resonance limit, q! 1, we write 2 = 0 + 1 2, which gives (assuming max 2 3) [36]:

where G is the in nitesim algenerator of (t) de ned by the lim it of the operator sequence: $G = \lim_{t \ge 0} (U_t I) = I$. Here I is the identity operator and U_t is a family of operators on the space of bounded continuous functions f, de ned by $U_t f(x) = E[f((t))j(0) = x]$, where E denotes the expectation operator [21]. Again $_k > 0$ for all k, and given a model of evolution, one can explicitly estimate $_k$, and hence the numbers of produced particles n_k and variances h^2 i and h^2 i.

IV.AM PLIFICATION OF GRAVITATIONAL WAVES

Here it is demonstrated that the evolution equatons for gravitons can be cast in the form of the Schrodinger Eq. (2). Within the Bardeen formalism [11], or by using the Weyltensor, there exists a strong correspondence between gravitational waves and scalar elds during reheating [14]. In the Bardeen approach, gravitational waves are described by transverse-traceless metric perturbations, with mode functions h_k satisfying [11]:

so that Q \$ 3p=4, $k^2=a^2$ \$ and $a^{3=2}h_k$ \$ y establishes the equivalence with Eq. (2). This implies that during reheating with an almost-periodic or stochastic inaton evolution, all wavelengths will be amplied, rather than just those in the Floquet instability bands. In the stochastic case with small noise, Eq. (15) shows that the tensor spectrum will acquire a tilting with $_k$ k^2 , causing further subtleties for the in ationary potential reconstruction program .

V.CONCLUDING REMARKS

U sing spectral theory we have shown the breakup of the stability bands of the M athieu equation. For constant q, the set of stable m odes becomes a C antor set generically for almost-periodic in aton evolution and a set of measure zero if the evolution is su ciently random. This implies that quantum corrections to the elective mass will lead to an exponential growth of all modes of the reheated eld, and of the gravitational wave background produced during in ation. Further, there exists the possibility, absent in the periodic case, of drastic qualitative changes to the nature of the spectrum at certain transitional values of q, as demonstrated by the discrete almost-M athieu equation.

This is of relevance to the issue of non-therm alsymmetry restoration, since the quantity $\frac{1}{2} \log k$ dk is much

larger in the classes considered here. This should reect directly in the number of particles produced, $n_{\rm k}$, the non-therm ality of the spectrum and the variances of the elds.

We have largely limited ourselves here to the study of spectral changes as the potential is changed and found drastic changes from the simple band structure of Floquet theory. However, as a warning, beautiful counterexamples exist, though they are suitably rare. Firstly, using inverse scattering theory for Eq. (2), one can show that there exist, and infact derive allexamples of, almost-periodic potentials which have band spectra similar to the periodic case. An example is given by the Bargmann potentials [30]. Hence it is not always true that the spectrum of an almost-periodic operator must be a Cantor set.

Neither is it true that altering the coupling to the potential always induces a change in the spectrum . From the theory of isospectral deform ations of the Schrodinger equation it is known that if Q (x;y) is a potential of Eq. (2) and satis es the K dV equation Q $_{\rm Y}$ 6Q Q $_{\rm X}$ +Q $_{\rm XXX}$ = 0, then (L) is independent of y and there thus exist 1-param eter families of potentials with the same spectra [30]. The connections with integrable systems become clear, and hence so do the rarrity of such events.
