# Time evolution of correlation functions in $N$ on-equilibrium $F$ ield $T$ heories

#### Abstract

We investigate the non-equilibrium properties of an N -com ponent scalar eld theory. The time evolution of the correlation functions for an arbitrary ensemble of initial conditions is described by an exact functional di erential equation. In leading order in the $1=\mathrm{N}$ expansion the system can be understood in term $s$ of in nitely $m$ any conserved quantities. They forbid the approach to the canonical therm al distribution. Beyond leading order only energy conservation is apparent generically. N evertheless, we nd a large $m$ anifold of stationary distributions both for classical and quantum elds. They are the xed points of the evolution equation. For sm all deviations of the correlation functions from a large range of xed points we observe stable oscillations. These results raise the question of if and in what sense the particular xed point corresponding to them al equilibrium dom inates the large tim e behavior of the system.

The understanding of the tim e evolution for a quantum eld theory w ith initial conditions aw ay from therm al equilibrium is needed for a large variety of phenom ena, ranging from in ationary cosm ology in the early universe to laboratory experim ents of defect form ation. First insights have been gained by perturbative $m$ ethods and, in particular, by an investigation of the leading order in the $1=\mathrm{N}$ expansion, w th N the num ber of com ponents of the eld [II\{ riety of problem s like decoherence of quantum states [1], heating after cosm ological in ation ral condensates in heavy ion collisions [L] and photon pair creation from a hom ogeneous electric eld [5]']. In $m$ ost of this work a particle num ber basis was used in order to describe the evolution of each eld $m$ ode. From the $m$ ode evolution the tw o point function can in tum be constructed.

It is a severe lim itation, how ever, that the leading $1=\mathrm{N}$ approxim ation neglects scattering and cannot describe the approach of a system to a therm alequilibrium state. A system atic extension of the particle num ber form alism to nite N seem s a di cult task. W e pursue here an altemative strategy and investigate directly the tim e evolution of the correlation functions of the system. O ne starts, at $t=0, \mathrm{w}$ ith an ensem ble of in itial values for the eld variables and their tim e derivatives. This speci es the initial correlation functions. At any later tim $e t$ the correlation functions are, in principle, com putable from the $m$ icroscopic eld equations. In practioe, we follow this tim e evolution by $m$ eans of an exact functional differentialevolution equation for the generating functional of the correlation fiunctions [iG]. A pproxim ate solutions can be obtained by truncation.

Our main tool is the tim e dependent e ective action [ ; ; t] [G] . For eld theories is a functional of the elds $(x)^{-}$and $(x)=a_{t}(x)$ and generates the one particle irreducible equaltim e correlation functions. Its tim e

where the rst operator, $\mathrm{L}_{\mathrm{cl}}$, generates the classical evolution, whereas $L_{q}$ determ ines the dynam ics of the quantum e ects. W e em phasize that the $m$ inim um of [ ; ; t] describes the time evolution of a cosm ological scalar eld like the in aton. The true dynam ical equation (1, (1) for nonequilibrium situations di ers, in general, from the variation of som e equilibrium e ective action or the classical action. The latter are at best an approxim ation to Eq. [1] in certain lim iting situations not too far from equilibrium. A $n$ understanding of the structure of the dynam icalequations follow ing from ( $\overline{11}_{1}$ ) is of crucial im portance for an understanding of cosm ologicalm odels like in ation.
$W$ e assum e an $O(\mathbb{N})$-sym $m$ etric initialdistribution for which all termswith odd powers of the elds in vanish. This property rem ains conserved by the evolution. Sim ilarly, we consider a translational and rotational invariant situation. The $m$ ost general form of consistent w ith these sym $m$ etries can be expanded in term $s$ of the Fourier com ponents of the elds

W e suppose that all m om entum integrals are ultraviolet regularized by a cuto , $\left(q^{2}<{ }^{2}\right)$. For the sim ple system of N coupled anharm onic oscillators ( $D=0$ ) the m om entum labels and integrals should be om itted. For large $N$, with ;u;v;w;s;y;z scaling like $1=\mathrm{N}$, one $m$ ay expand in $1=\mathrm{N}$ as a sm all param eter. W e observe that $q \quad 1=\mathrm{N}$ and ! ${ }_{q}$ becom es independent of $u ; v ;::: ;$ in leading order. In the $\lim$ it N ! 1 the system of evolution equations for the inverse two-point functions $\mathrm{A} ; \mathrm{B}$ and C is closed.

For a solution ofEq. (1-1) at nite $N$, how ever, one needs the tim e dependent four point functions. Their evolution equations involve, in tum the six point functions. The exact system is not closed and for any practical punpose we have to proceed to som e approxim ation. In the present note we sim ply om it allcontributions from 1 P I six point vertices. Furthem ore for $D \quad 1$, we neglect the mo $m$ entum dependence of the quartic couplings. $W$ ith this truncation the evolution equations for the quartic couplings are given by

For D 1 there rem ains at this stage an am biguity at which $m$ om entum the couplings $u$;v; etc. and therefore the barred quantities ! ${ }^{2}$; ; $;$; $B$, should be evaluated. (For $D=0$ the bars should be om itted.) O ne $m$ ay choose som e appropriate $m$ om entum average to be discussed below. From the truncated evolution equation of the quartic couplings we have om itted som e term $s \quad 1=\mathrm{N}^{2}$ which involve tw o-loop integrals. The neglected six point functions can also be treated consistently as being $1=\mathrm{N}^{2}$. On the other hand, the di erence $u\left(q ; p ; p^{0}\right) \quad u(0 ; 0 ; 0)$ appears in the contributions $1=\mathrm{N} . \mathrm{N}$ evertheless, the $e$ ects of this $m$ om entum dependence are partly averaged out by the $m$ om entum integrations. Thus our set of evolution equations (131) contains for $D=0$ all contributions in the next to leading order $1=\mathrm{N}$. This extends to arbitrary $D$ only if the $m$ om entum dependence of the quartic couplings can be neglected.

Them icroscopic eld equations ( $\overline{-1}$ ) conserve the total energy $E$ for every choige of in itial state

$m$ ust be conserved by the exact evolution equations. W e have veri ed that the truncated evolution equations ( $\left.\overline{7}_{1}\right)$, (13) conserve for $D=0$ and arbitrary $N$. For D 1 this holds autom atically in leading order in the $1=\mathrm{N}$ expansion. For nite $N$ our truncation conserves energy only provided the averages! ${ }^{2}$, B, C, , are chosen appropriately such that they obey the relation

For practical purposes it $m$ ay be su cient that this relation holds in a tim e averaged sense. W hereas 1 is separately conserved in the leading $1=\mathrm{N}$ approxim ation the ow of energy between 1 and 2 can be attributed to scattering.

W e observe a largem anifold of xed points since qs . $\left.{ }^{1} 1 \mathbf{1}_{1}^{\prime}\right)$ have solutions for arbitrary $B$ (q), s and $z!T h i s p r o p-$ erty seem $s$ not to be an artifact of the truncation. It persists for $m$ om entum dependent four point functions. $T$ he xed point $m$ anifold becom es even larger if one includes the six point functions and seem $s$ to characterize any higher ( nite) polynom ialtruncation. C lassical therm odynam ic equilibrium, at tem perature T (for $\mathrm{h}=0$ ) corresponds to the particular point in this $m$ anifold:

Here the xed point conditions for $A_{\text {eq }}$ and $u_{\text {eq }}$ constitute classicalSchw inger-D yson equations (corresponding to a Euclidean D-dim ensional quantum eld theory at zero tem perature) for the e ective propagator ( $m$ ass and kinetic term $s$ ) and the e ective quartic coupling, respectively. In quantum eld theory ( $\mathrm{h}=1$ ) the therm al equilibrium xed point does not correspond to $w_{\text {eq }}=s_{\text {eq }}=z_{\text {eq }}=0$, anym ore. $T$ he Schw inger $-D$ yson equations have now to be evaluated in a D + 1 dim ensional quantum eld theory w ith periodic boundary conditions in ' Euclidean tim $e^{\prime}$. The di erence betw een the quantum and classical xed points is due to the nonzero $M$ atsubara frequencies. W e observe, nevertheless, a rather sim ilar structure of the classical and quantum dynam ical system s . In particular, we nd in the quantum system a xed point, which di ens from the classical equilibrium xed point only by $z=h^{2} B^{3}=\left(4!^{2}\right)$, instead of $z_{e q}=0$. For this xed point, allcorrelation functions involving only are the same as for classical equilibrium . Inversely, for every xed point of the quantum system there is a corresponding one for the classical system, differing only by a shift in $z$. Up to this shift, the quantum equilibrium could be reached by the classical system !

T he centralissue ofthis w ork is the question ofw hether and how the xed points are approached fort! 1 . We start $w$ th the leading behavior for $N$ ! 1 , where

T he late tim e behavior of the system is clearly not ergodic. Ergodicity is usually thought to be a su cient, albeit not necessary, condition for subsystem s of a large closed

B eyond linear order it is then
conceivable that the oscillations are dam ped by the nonlinear ow - at least for a large class of trajectories. Of course, $\hat{\mathrm{T}}$-invariance im plies that for any tra jectory w ith ow towards the xed point there $m$ ust also exist a trajectory w ith ow away from it. N evertheless, for a nonlinear ow it seem spossible that only a very special class of excitations around the xed point leads to unstable behavior. The relative volum e of the space of unstable excitations (as com pared to the stable excitations) could shrink to zero as the num ber of degrees of freedom goes to in nity.

W e should point out that the general oscillatory behavior found in our linear analysis is not in contradiction $w$ ith the dam ping rates com puted in linear response theory for classical or quantum eld theories in therm odynam ic equilibrium [q] [q]. Indeed, a linear superposition of a continuum of frequencies w ith suitable am plitudes can easily lead to a dam ped behavior, as illustrated by the identity ${ }_{1}^{R_{+1}} \frac{d!}{!!^{2}+{ }^{2}} e^{i!t}=e^{\mathrm{jjj}}$. $T$ his conclusion also extends to non-vanishing ! and $s$, as long as ! $1=\mathrm{N}$. W e conclude that the equilibrium xed point has no unstable direction for linear uctuations. By simple continuly considerations this stability can be extended to a whole region in the xed point $m$ anifold around the them al equilibrium point.

T he discussion of the nonlinear behavior for large 'distances' from the xed point $m$ anifold rem ains outside the scope of this note. $W$ e only report, here brie y som e results for $D=0$ where Eqs. (T1), (22) reduce to nine coupled ordinary di erential equations, which we have solved num erically. T he stable sm all oscillations around the xed points near classical therm al equilibrium can easily be observed, being determ ined by three relevant frequencies. In this case we have not observed any nonlinear dam ping. As the am plitudes of the oscillations increase the stable behavior continues for a while. The tim e averaged $m$ ean value corresponds now to a 'dynam ical xed point', which is close to but not part of the xed point $m$ anifold. For a Gaussian initial distribution not too far from the $x e d$ point $m$ anifold ( and for $m^{2}>0$ ) this behavior is approached after a certain tim e. Finally, for large distances from the xed point $m$ anifold the behaviorbecom esm uch $m$ ore com plicated. T ypically a very large range of frequencies becom es im portant after a certain tim e interval and the problem becom es sti. A nalogous behavior has been observed in other anharm onic oscillator system s treated in the $1=\mathrm{N}$ expansion $\left.{ }_{1} 1 \overline{1} 1 \mathbf{1}\right]$. We w ill address these interesting phenom ena elsew here.

In conclusion, the step beyond the leading order $1=\mathrm{N}$ expansion seem $s$ crucial for the understanding of nonequilibrium eld theories. O ne nds in leading order innitely $m$ any unphysical conserved quantities which prevent the system from approaching them al equilibrium. They do not survive the inclusion of scattering, beyond leading order. N ew m ysteries have appeared, how ever.

This concems, in particular, the existence of a continuous $m$ anifold of stationary distributions $w$ thin which the them al equilibrium distribution is just a particular point. It has also becom e clear that sm alldeviations from the xed points are not dam ped in the context of linear uctuation analysis. The understanding of the them alization of isolated tim e reversible system $s$ described by eld theories rem ains an unsolved challenge. A s long as such basic questions are not fully understood the use of equilibrium eld equations in cosm ology should be regarded w ith caution.
