A quark mass de nition adequate for threshold problem s

A bstract

R ecent calculations of heavy quark cross sections near threshold at next-to-next-toleading order have found second-order corrections as large as rst-order ones. We analyse long-distance contributions to the heavy quark potential in m om entum and coordinate space and demonstrate that long-distance contributions in m om entum space are suppressed as $^2_{QCD} = q^2$. We then show that the long-distance sensitivity of order $_{QCD} r$ introduced by the Fourier transform to coordinate space cancels to all orders in perturbation theory with long-distance contributions to the heavy quark polem ass. This leads us to de ne a subtraction scheme { the potential subtraction scheme e' { in which large corrections to the heavy quark potential and the potential-subtracted' quark m ass are absent. We compute the two-loop relation of the potential-subtracted quark m ass to the \overline{MS} quark m ass. We anticipate that threshold calculations expressed in terms of the scheme introduced here exhibit im proved convergence properties.

1. M otivation

Heavy quark production near threshold through virtual photons or Z bosons is very sensitive to the quark mass and therefore may allow us to determ ine heavy quark masses precisely. Recently, the two-loop corrections to the colour C culomb potential [1] and to the matching relation between the relativistic and non-relativistic vector current [2, 3] were obtained. The two together provide the necessary input to compute heavy quark properties near threshold in next-to-next-to-leading order (NNLO). In this context NNLO' means that all corrections to the Born cross section of order ($_{\rm s}=v)^n$ $_{\rm s}^k$ for any n and k = 0;1;2 are taken into account, where v is the small relative velocity of the two quarks in their centre-ofm ass frame and $_{\rm s}$ is the strong coupling. (Additional logarithm s of v are not written explicitly.)

NNLO calculations have now been completed for top-anti-top production near threshold [4, 5], for bottom onium threshold sum rules [6, 7] and for quarkonium energy levels [8]. In all three cases the NNLO correction is as large as the next-to-leading order (NLO) correction, which suggests that a perturbative treatment has already reached its limits. In case of tt production the NNLO correction shifts the location of the cross section peak position by about 1 GeV, which implies an uncertainty in m_t of about 0.5 GeV, if the threshold cross section is used as a measurement of the top quark mass. This result is unexpected, in particular as the relevant physical scale is given by C_{F-s} (m_tv) m_t=2 15-20 GeV at which perturbation theory should work.

Following a di erent line of investigation, the Coulom b potential in m om entum and in coordinate space is analyzed in [9, 10]. It is found (see also [11]) that the e ective couplings de ned by the two versions of the potential are related by a rapidly divergent series, the origin of which is a long-distance contribution of relative order $_{QCD}$ r. This leads to large num erical di erences in di erent, but consistent at NNLO, im plan entations of the C oulom b potential in cross section calculations. The authors of [9, 10] conclude, in agreem ent with the evidence from the NNLO tt and bb com putations mentioned above, that there is a large and irreducible uncertainty that a ects the threshold region. This would lead to rather gbom y prospects as to our ability to constrain the bottom and, eventually, the top quark m ass.

In this paper we show that despite these evidences perturbation theory does not (yet) failand that the actual uncertainties can be smaller than those indicated by [4, 5, 7, 9, 10]. Our main point is that, contrary to intuition, the notion of a quark pole mass, which has been in plicit in the discussion above, is in fact inadequate for accurate calculations of heavy quark cross sections near threshold. The argument goes as follow s:

We rst analyse (Sect. 2) the heavy quark potential ∇ (q) in momentum space and nd that long-distance contributions have a relative suppression $(_{QCD}=q)^2$. Hence the potential in momentum space is better behaved than the potential in coordinate space. K now ing that the long-distance contribution of relative order $_{QCD}$ r to the potential in coordinate space enters only through the Fourier transform, we can elim inate it by restricting the Fourier transform to jqj> $_{f}$ for some factorisation scale $_{f}$ which satis es $_{QCD} < _{f} < mv$. This de nes a subtracted potential V (r; $_{f}$), from which large perturbative corrections are elim inated (Sect. 3). The Schrodinger equation takes its conventional form only if the pole quark mass de nition is assumed. The Schrodinger equation form ulated with the subtracted potential contains a residual mass term m(f). As a consequence the input parameter for threshold calculations in terms of the subtracted potential is not m_{pole} but $m_{PS}(f) = m_{pole} m(f)$. It is known that the pole mass also receives long-distance contributions of order $_{QCD}$ [12,13] and it was noted already in [13] that they are related to the C oulom b contribution to the self-energy. The crucial point is that the long distance sensitivity of order $_{QCD}$ in the coordinate space potential ong-distance sensitivity in pole mass (Sect. 4). Hence the potential-subtracted' mass $m_{PS}(f)$ can be related to more conventional (long-distance insensitive) mass de - nitions by a well-behaved perturbative expansion. The two-loop relation to the MS mass de nition can be trivially obtained (Sect. 5).

It follows from this argument that one can avoid large perturbative corrections as were found in the NNLO calculations mentioned above by formulating the threshold problem in terms of $m_{PS}(_{f})$ and the subtracted potential V (r; _f) rather than the pole mass and the ordinary C oulomb potential. O ne can then determ in $m_{PS}(_{f})$ and relate it reliably to m_{MS} . The dependence on the factorisation scale _f cancels in this process.

2. The potential in m om entum space

The static potential in coordinate space, V (r), is de ned in terms of a W ilson loop $W_c(r;T)$ of spatial extension r and temporal extension T with T ! 1 [14, 15, 16]. In this lim it $W_c(r;T) = \exp((iTV(r))$. The potential in momentum space, $\nabla(q)$, is the Fourier transform of V (r). (We use r = jrj and q = jqj.) One can compute the potential directly in momentum space from the on-shell quark-anti-quark scattering amplitude (divided by i) at momentum transfer q in the lim it of static quarks m ! 1 and projected on the colour-singlet sector. In addition one has to change the sign of the i -prescription of some of the anti-quark propagators in some diagrams (such as D_1 below), so that the integration over zero-components of loop momentum can always be done without encountering quark poles in the upper half plane. The quark poles amount to iterations of the potential, but do not give a contribution to the potential itself.¹

The potential is infrared (IR) nite² and ultraviolet (UV) nite after renormalisation of the coupling. In this Section we ask how sensitive the Feynman integrals that contribute to the momentum space potential are to the IR regions of loop momentum integrations. The reason is that these regions give rise to large corrections in higher orders in perturbation theory through IR renormalons (see [12, 13] for references). Note that we are not concerned with the long-distance behaviour of the potential at q $_{QCD}$, but




Figure 1: One-loop corrections to the heavy quark potential.

with the leading power corrections of form $(_{QCD}=q)^k$, which correct the perturbative C oulom b potential when q is still large compared to $_{QCD}$.

Consider 1st the one-loop corrections to the potential (see Fig. 1) in dimensional regularisation. In Feynman gauge D₃ is zero. The colour C_F^2 -term cancels in the sum D₁ + D₂. D_{1;2} are logarithm ically IR divergent. This IR divergence is cancelled by the (logarithm ic) scaleless integrals D_{4;5}, whose only e ect is to convert the IR singularity in D_{1;2} into a UV singularity, which can be absorbed into a renormalisation of s. Hence, we are left with the IR nite parts of (the $C_A C_F$ -part of) D₂ and D₆, which yield the well-known one-loop correction to the potential [15, 16]. D₆ is given in terms of the gluon self-energy at o -shell external momentum q. For small loop momentum k, the integral scales as

and gives rise to a contribution of order $^2_{QCD} = q^2$ from the region k $_{QCD}$ relative to the tree diagram which scales as $1=q^2$. The integral relevant for D₂ is

where v = (1;0) and v = 0. To not the leading infrared contribution, which is left over after the IR divergence is cancelled as described above, we expand the integrand in k around k = 0 and around k + q = 0. The integrals in each term of the expansion depend only on the vector v. Hence, in a regularisation scheme that preserves Lorentz invariance allodd terms vanish because v = 0. The long-distance contribution is again of relative order $\frac{2}{QCD} = q^2$. (Note that we are only concerned with IR contributions that are connected with the large-order behaviour of perturbative expansions.)

This argument generalises to an arbitrary diagram. Because v = 0 and because there is no other kinematic invariant linear in q, it follows from Lorentz invariance that the leading power correction to the potential in momentum space cannot be $Q_{CD} = q$,

but has to be quadratic:

The implication is that the expansion of the potential in the coupling a_s (q) diverges as $P_n r_n s (q)^{n+1} P_n (a_0)^n n h^b s (q)^{n+1}$ with a = 1 and $a_0 = (11 2n_f=3)=(4)$ the rst coecient of the -function. A linear IR power correction would have led to a = 2 and, hence, a more rapidly divergent perturbative relation. The parameter b remains undeterm ined by the above analysis, but does not in uence the power behaviour.

3. The potential in coordinate space

Consider now the potential in coordinate space, de ned by the Fourier transform

Note that in the W ilson loop de nition of the potential in coordinate space there is a (divergent) constant related to the self-energy of the static sources. This r-independent term is usually discarded when one refers to the static potential, and it is also discarded, when V (r) is de ned in term s of the Fourier integral above. In what follows the interpretation of this constant plays an important role.

To see that the potential in coordinate space is more sensitive to long distances than the potential in momentum space, it is enough to take the tree approximation to ∇ (q) and to calculate

It follows that the leading power correction is linear in $_{QCD}$ r:

($_{\rm E}$ is Euler's constant.) The implication is that the expansion of the coordinate space potential in $_{\rm S}$ (e $^{\rm E}$ r) diverges as $^{\rm P}_{\ n}$ r_{n} $_{\rm S}$ (e $^{\rm E}$ r)ⁿ⁺¹ $^{\rm P}_{\ n}$ (a_{0})ⁿ n h^b $_{\rm S}$ (e $^{\rm E}$ =r)ⁿ⁺¹ with a = 2, much faster than the expansion of the potential in momentum space. Note that in absolute terms the IR contribution is a constant of order $_{\rm QCD}$.

The rapidly divergent behaviour of the coordinate space potential has been noted in [11] and is discussed in detail in [9, 10]. W hat we add here is the observation that the linear power correction and, by in plication, the rapid divergence originates only from the Fourier transform to coordinate space and is not present in the potential in m om entum

space. Knowing this we can subtract the leading long-distance contribution and the leading divergent behaviour completely by restricting the Fourier integral to $j_{\rm H}j > {}_{\rm f}$ with ${}_{\rm f}$ a factorisation scale which we make more precise later. The result will be called the 'subtracted potential' V (r; ${}_{\rm f}$). The subtraction terms can be evaluated order by order in ${}_{\rm s}$ given ∇ (q) to that order. The relevant calculation will be done in Sect. 5. To be precise, we write

To subtract the leading long-distance contribution of order $_{QCD}$, it is legitim at to replace $e^{iq r}$ by 1 in the Fourier transform and we use this for the de nition of the subtraction term. We now de ne the 'potential subtracted' (PS) quark mass parameter as

In term s of the subtracted potential and the PS m ass the G reen function is determined from the Schrodinger-type equation

and it is in portant that the non-relativistic energy is de ned as $E = p_{\rm s}^{\rm p} 2m_{\rm PS}(_{\rm f})$, with s the centre-ofm ass energy, as compared to the usual de nition $p_{\rm s}^{\rm p} 2m_{\rm pole}$. The equation above is the conventional Schrödinger equation, but with a 'residual' mass term ⁴. The subtracted potential V (r; _f), which contains the residual mass, does not su er from large loop corrections associated with the leading asymptotic behaviour of its perturbative expansion.

D espite this fact we have not yet gained anything, because the large loop corrections have only been hidden in the contribution m(f) to $m_{PS}(f)$. The crucial point is this: W hen m_{pole} is expressed in terms of a 'short-distance' mass parameter such as the \overline{MS} mass $m_{\overline{MS}}$ through a perturbative series, this perturbative series also has large loop corrections [12, 13]. The large perturbative corrections absorbed into m(f) cancel exactly with large perturbative corrections to the pole mass. The argument is given in the following Section. Hence one can not determ ine the PS mass from the threshold cross section without encountering large corrections, because of the subtraction in the potential. One can then relate the PS mass to the \overline{MS} mass, again without encountering

 $^{^{4}}$ W e have replaced m _{pole} by m _{PS} (_f) also in the kinetic energy term in the Schrodinger equation. The di erence to using the pole mass is m =m r², i.e. of higher order in 1=m. Since other terms of order 1=m are neglected in the Schrodinger equation, the replacement of m _{pole} by m _{PS} (_f) is justified. If one chooses the PS m ass as the m ass de nition and derives the Schrodinger equation from Feynman diagrams, the kinetic energy term is divided by the PS m ass by construction. An additional nite renormalization of the kinetic energy term can be neglected in the present context.

large corrections related to the asym ptotic behaviour of perturbative expansions. In this way, one can, in principle, determ ine the \overline{MS} m ass from threshold cross sections to better accuracy than the pole m ass, the use of which is in plied by the unsubtracted potential. C onversely, one can begin with $m_{\overline{MS}}$, compute the PS m ass and predict the threshold behaviour. The perturbative relation between the PS m ass and the \overline{MS} m ass is given in Sect. 5.

O nem ay ask why we do not suggest to avoid using the coordinate space potential and to work with the momentum space potential directly. The reason is that the Schrödinger equation for the Coulomb G reen function G_C (p;E) in momentum space contains the integration $\frac{Z}{2} = \frac{3}{2}$

which contains exactly the same leading long-distance sensitivity as the Fourier integral (4), because $e^{iq x}$ may be replaced by 1 as far as the leading power in $_{QCD}r$ is concerned, cf. (8). Hence the problem one encounters with the unsubtracted coordinate space potential enters in momentum space when one solves the Schrödinger equation.

How large can $_{\rm f}$ be? We shall see below that the expansion of m ($_{\rm f}$) is naturally expressed in terms of $_{\rm s}(_{\rm f})$. Perturbativity hence requires $_{\rm f} > _{\rm QCD}$. The scale relevant to the potential is 1=r m v. Since the subtraction should a ect the potential only at distances larger than the physical scale of the process described by the potential we require also $_{\rm f} < m v$. There is another way to arrive at this constraint. If $v = \frac{q}{1} \frac{4m_{\rm pole}^2}{4m_{\rm pole}^2}$ is expanded in terms of $m_{\rm PS}()$, one generates singular terms (as v ! 0) of order (m ($_{\rm f}$)=(m v^2))^k. These terms are small if m ($_{\rm f}$) is small compared to scale m v^2 of binding energies of a Coulomb system. Counting $_{\rm s}$ v and using m ($_{\rm f}$) $_{\rm f}$ s, one arrives again at $_{\rm f} < m v$.

4. Cancellation of long-distance contributions with the pole mass

Expressing the pole mass in terms of the MS mass and m ($_{\rm f}$) as a series in $_{\rm s}$, we can write " #

where $M = m_{MS} (m_{MS})$. Both series diverge as r_n ; s_n (a $_0$)ⁿ n h^b with a = 2. We now show that this behaviour cancels in the di erence in (12). Because this divergence arises from long-distance sensitivity of order $_{QCD}$ in the Feynman diagrams that contribute to the two series, it is enough to show that the corresponding linear⁵ IR behaviour of the Feynman integrands cancels to all orders in perturbation theory in the di erence. The remaining long-distance contributions to the di erence are of order $_{QCD}^2 = M$ and the corresponding divergent behaviour has only a = 1. This establishes that the PS m ass can be reliably related to the \overline{MS} m ass.

⁵A bop integral that behaves as $d^4k = k^4$ for small k is called logarithm ically IR sensitive, an integral that behaves as $d^4k = k^3$ linearly IR sensitive etc..

Since we are only concerned with infrared behaviour we may work with unrenormalised quantities which di er from \overline{MS} renormalised quantities only by pure UV subtractions. Radiative corrections to the pole mass are given by the self-energy, evaluated at $p^2 = m_{pole}^2$: $m m_{pole} m_0 = \int_{\overline{p}=m_{pole}}^0$, where m_0 is the bare mass and 0 the unrenormalised self-energy. Consider the cancellation at the 1-bop order. As long as we are interested only in the leading behaviour at small bop momentum, we can approximate the one-bop contribution to 0 by

setting $p = m_0 v$. At this order one need not distinguish between m_{pole} and m_0 in the integrand. Taking the integration over q_0 in the upper half plane, we obtain

which is exactly the leading-order contribution to m(f), cf. (8), for small q. Thus the Feynman integrands of the integrals contributing to M r_0 and fs_0 cancel each other in the infrared region of small q. Note that the leading infrared behaviour can be obtained by replacing

in (13). In other words, the relevant IR behaviour is obtained from setting $q_0 = 0$ rst and then from the small-q behaviour of the remaining three-dimensional integral.

The denom inator of an on-shell heavy quark propagator with momentum mv + 1 is $v + 2 \equiv (2m)$. To demonstrate the IR cancellation in higher-loop order, we consider rst the static approximation, in which the denom inator is simplified to v + 1 and the gluon coupling to heavy quarks by v + 1 ence the Feynman rules reduce to those implicit in the denition of the potential. The static approximation implies that we consider all loop momenta small compared to m and take the rst term in an expansion in 1=m. We show that the leading IR contributions of order $_{QCD}$ to the pole mass in this approximation cancel exactly with those to the coordinate space potential. At the end of this Section, we address the question of what happens, when one includes further terms in the expansion of the heavy quark propagator in 1 and the region 1 m, in which the propagator cannot be expanded.




Figure 2: (a) Structure of an arbitrary self-energy diagram . (b,c) Som e 2-loop examples. The double line denotes the static approximation.

A general self-energy diagram in the static approximation can be written as (see Figure 2a) $\frac{Z}{2} = \frac{1}{2} \frac{1}{2$

where the line m om enta l_i are linear combinations of the loop m om enta k_m and S (l_i) contains no heavy quark propagators. Consider any one-particle irreducible (1PI) subgraph contained entirely in S at xed, non-zero, external m om entum. Such subgraphs

are \mathbb{R} nite and at most quadratically \mathbb{R} sensitive. It follows that any subgraph that can give rise to linearly \mathbb{R} sensitive integrals must contain at least one heavy quark propagator with v ill 0. Let us call a self-energy diagram (ir-)reducible if it contains (does not contain) a self-energy subgraph.

Consider irreducible diagram s such as the diagram depicted in Figure 2b rst. Irreducible diagram s are IR nite on mass-shell and none of the heavy quark line momenta coincide. The leading IR behaviour is obtained by letting one of the v $_{i}l = l_{i}^{0}$ go to zero and by neglecting l_{i}^{0} in the other propagators. This can be summarised as the substitution

In a term with (v_j) change one loop integration variable to $q = l_j (k_m)$. The deltafunction kills the q_j integral and sets $q_j = 0$ in the integrand. One can interpret (17) as cutting the diagram at any heavy quark propagator. This gives rise to N four-point diagram s, to be integrated with $d^3q=(2)^3$, and it is easy to see that the result matches exactly with contributions to $m(f_j)$. For example, the diagram of Figure 2b cancels with the contribution to $m(f_j)$ from $D_2 + 2$ D_j in Figure 1. The signs and i's work out correctly and the factor 1=2 in (8) comes from the fact that we have in (17) but one factor 1=(2) from the four-dimensional integration measure.

One may be concerned about the fact that after setting $q_0 = 0$, the integrals become IR divergent and that hence the leading-order IR approximation (17) may not be su cient for linearly IR sensitive contributions. The IR divergences are just the IR divergences in individual contributions to the potential mentioned in Sect. 2, which cancel in combinations such as $D_2 + 2$ D_1 . Moreover, the next term in the small-loop momentum expansion of the integrand is quadratically IR sensitive as shown in Sect. 2, and this is enough to quarantee that (17) is legitimate.

O nem ay also be concerned about the fact that application of (17) does not lead to D_2 literally, but to an integrand which di ers from (2) in that the two factors of v k have

di erent i -prescriptions. However, in Sect. 2 we have shown that linearly IR sensitive contributions originate only from the IR behaviour of the Fourier integral. Hence we should consider q sm allat xed k or both q and k sm all simultaneously (but not sm all k at xed q), in which case the potential pinch singularity is not a problem.

The situation ism one complicated for reducible diagram s such as the one in Figure 2c. For reducible diagram s some of the heavy quark line m on enta coincide and cutting such a quark line in the sense discussed above leads to one-particle reducible contributions to the potential, i. e. to lower-order contributions to the potential multiplied by on-shell renorm alisation of the external legs. (D₅ in Figure 1 is an example.) M oreover, reducible diagram s are IR divergent when evaluated on-shell, while M is IR nite. This is related to the fact that M is not given by ${}^{0}_{\{\mathbf{p}}=\mathbf{m}_{0}}$ but by ${}^{0}_{\{\mathbf{p}}=\mathbf{m}_{pole}}$. To make the IR niteness explicit, the contributions from reducible diagram s to M should be combined with contributions at the same order in perturbation theory that arise from expanding ${}^{0}_{\{\mathbf{p}}=\mathbf{m}_{pole}}$ in M:

This expansion reproduces precisely the combinatorial structure of self-energy subgraphs in reducible diagrams. Combining the various terms on the level of integrands, the resulting integral is IR nite. Moreover, after this cancellation all heavy quark propagators have dierentmomenta and one can again use (17). The but' diagram sthen cancel again with diagrams to the potential.

Let us illustrate this for the diagram of F igure 2c. A coording to (18) we combine the diagram with the product of 1-loop contributions to the second term ⁷ on the right hand side of (18). This gives the following contribution to M:

To arrive at the last two lines we have used (17). Since 1=2 D₅ is the on-shell wave function renorm alisation for a single external quark leg times the leading-order potential,

we obtain the desired cancellation with IR contributions to the potential. The example and the structure of (18) make it transparent how the IR cancellation for reducible diagram s extends to all orders.

Let us return to the validity of the static approximation. Consider rst the contributions to the pole mass from the region of loop momentum where all momenta are sm all compared to m . All heavy quark propagators can be expanded about the static lim it. The corrections to the static approximation are suppressed by at least one power of bop m om entum divided by m. This in plies a suppression of long-distance sensitivity by a factor of OCD = m relative to the leading term . Since the leading term is already linear in OCD, we conclude that if the heavy quark line momentum is small, it is sufcient to keep only the leading term in the expansion of the propagator. Consider now the contributions from the region of loop momentum where some loop momenta are of order m and others (at least one) are small compared to m. The hard subgraphs with bop momentum of order m reduce to local interactions of form $(l_i=m)^k$ with respect to the small loop momenta l_i OCD. One obtains contributions suppressed by powers of OCD = m unless k < 1. Hence we need to consider only hard self-energy and vertex subgraphs. The e ect of these subgraphs is to renorm alise the coe cients of the $Y = A_0$ and ${}^{y}Q_{0}$ interaction terms in the non-relativistic elective Lagrangian, from which the potential is derived. In the standard norm alisation of the non-relativistic Lagrangian the coe cients of these operators are 1 to all orders in perturbation theory. It follows that the hard subgraphs have no e ect on the IR cancellation, or, in other words, they are in plicitly taken into account through the coe cient functions of the interaction terms in the non-relativistic Lagrangian which enter the calculation of the Coulom b potential.

5. Relation to the \overline{MS} m ass de nition

It is straightforward to work out the mass subtraction $m(_{\rm f})$ from known results on the potential in momentum space:

with $a_1 as in (3)$ and $a_2 = 634:402$ $66:3542n_f + 1:246n_f^2$ [1]. From the de nition (8) one obtains

where $b_0 = 4_0 = 11_{2n_f} = 3$ and $b_1 = (4_)^2_1 = 102_{3n_f} = 3$. Note that the logarithm s disappear when the coupling is normalised at the scale f, which follows from the fact that the potential is physical and independent of . At f = 1-1:5 GeV, a typical

scale relevant for bottom quarks, the third-order term already exceeds the second-order term. This is not a point of concern as the series expansion of $m(_{\rm f})$ is expected to behave badly and we are interested only in the combinations V (r) + 2 m ($_{\rm f}$) and $m_{\rm pole} = m(_{\rm f})$, both of which have better behaved series expansions. The subtracted C oulomb potential V (r) + 2 m ($_{\rm f}$) at leading order in $_{\rm s}$ is given by

To see the numerical e ect of the subtraction, we choose the values r = 1 = (20 GeV) and $_f = 3 \text{ GeV}$ ($n_f = 5$) as would be appropriate to tt production and compare the subtracted and unsubtracted C oulom b potential. The result, including the known higher-order corrections, is

The convergence of the series is in proved and the strength of the potential is reduced. For bottom systems one observes a similar e ect, although the requirement that $_{\rm f}$ > $_{\rm QCD}$ does not allow us to choose $_{\rm f}$ r as small as we would like.

Since the relation of the pole mass to the MS mass is known only to second order [18], we can only make use of m ($_{\rm f}$) to second order to express the potential-subtracted mass m $_{\rm PS}$ ($_{\rm f}$) = m $_{\rm pole}$ m ($_{\rm f}$) in terms of M m $_{\rm MS}$ (m $_{\rm MS}$). The result is

where K = 13:44 1:04n_f from ⁸ [18] and $a_1 = 10:33$ 1:11n_f. Num erical values for the rst and second-order coe cients for various values of f=M are given in Table 1. For small values of f=M as relevant to the production the series is not very dimension the series for the pole mass, re ecting the fact that at this order both series still converge well. In absolute terms the dierence between the pole and PS mass may still amount to several hundred M eV, which is signi cant close to threshold. In fact the e ect of the subtraction is far from small on the potential even for tt production as illustrated by (23) above, because f has to be compared to the scale $m_t v=2$ $m_t s=2$ in case of the potential. For ratios of f=M that may be contemplated for bottom quarks near threshold the second-order one cient in (25) is already considerably sm aller than the one in the relation of m pole to M and the convergence of the series expansion is im proved. This lends support to the hypothesis that the IR cancellations between m pole and m(f) occur not only asymptotically but already at second-order. Eq. (23) and (25) taken together suggest that threshold calculations at NNLO form ulated in terms of the subtracted potential and the PS mass exhibit reduced NNLO corrections and that the PS mass can indeed be reliably related to the MS mass.

6. Conclusion

In this paper we proposed that perturbative calculations of heavy quark properties near threshold should not use the pole mass but a subtracted mass together with a subtracted potential. This elim inates one source of large corrections in perturbation theory, related to small momentum contributions, although we cannot exclude large corrections due to other reasons. The num erical estimates presented above suggest, how ever, that the convergence is indeed in proved. We emphasise that the potential-subtracted mass is gauge-invariant, because it is derived from the pole mass and an integral over the momentum space potential, both of which are gauge-invariant.

The crucial point is that heavy quark cross sections near threshold are in fact less sensitive to long distances than the quark pole mass parameter. This follows from the observation that the C oulom b potential in momentum space is less sensitive to long distances than the potential in coordinate space and that the large perturbative corrections to the potential in coordinate space cancel to allorders in perturbation theory with those to the pole mass, because of an exact cancellation of the small momentum behaviour of the respective Feynman integrals. That the pole mass is not relevant for physical quantities involving top quarks is quite obvious, because the width of order $1.5 \,\text{GeV}$ provides an intrinsic cut-o for long-distance e ects [19]. In particular, the location of the resonance-like peak in the production cross section is not a direct measure of the top quark pole mass is not even relevant for (quasi-) stable quarks near threshold.

Making use of the results of [1] we derived the mass subtraction term to order $\frac{3}{s}$ and the relation between the potential-subtracted (PS) mass and the \overline{MS} mass to order

 $\frac{2}{s}$. These relations provide the link with other physical quantities involving heavy quarks. In particular, they allow us to determ ine directly the bottom and top \overline{MS} masses from bottom online sum rules and the tt cross section, thus obviating large NNLO corrections that appear when these quantities are expressed in terms of pole masses [4, 5, 6, 7]. One may hope that this leads to more accurate quark mass determ inations than for the pole masses, whose accuracy is limited to order $_{QCD}$ by long-distance e ects [12, 13] independent of the process utilised to determ ine them. We will report on these applications in a forthcom ing publication.

O ne cannot use the \overline{MS} m asses them selves for threshold problem s, because they di er from the pole masses by an amount of order m s. This causes singular terms of order $(s=v^2)^k$ to appear in perturbative expansions. The all-order resumm ation of these terms leads one back to the pole mass. It is necessary to introduce a factorisation scale $_{\rm f}$ and to choose a mass de nition (the PS mass) that diers from the pole mass by an amount sm aller than the typical energies of a Coulom b system, while at the same time not being too sensitive to con nem ent e ects. This leads to a linear dependence on the subtraction scale f. The use of a heavy quark mass with a linear factorisation scale dependence has been repeatedly advocated by Bigi et al. (see [13] and the review [20]). In [21] a (f) (the analogue of our m (f)) is derived to order $\frac{2}{s}$ from m ass subtraction term certain integrals over the spectral densities of heavy-light quark currents. This mass subtraction di ers from (8) already at order s. This does not im ply an inconsistency, since the necessary requirem ent is only that the long-distance sensitive regions cancel asymptotically in large orders. On the other hand, it seems to us that a subtraction based on the heavy quark C oulom b potential is most natural (and technically sim plest) not only for threshold problem s involving two heavy quarks, since, as observed in [13], the leading long-distance sensitive contribution to the pole mass is in fact conceptually related to the Coulom b interaction.

N one added: A fler this paper was completed, we received Ref. [22], which addresses related questions. The authors also note that linear IR sensitivity cancels in $2m_{pole} + V$ (r) and demonstrate this at the 1-bop order.
