# Soft Term s in M -theory

#### A bstract

We discuss dilaton and Moduli dom inant SUSY breaking scenarios in M-theory. In addition, for the nonperturbative superpotential from gaugino condensation, we discuss the soft terms in the simplest model (only S and T moduli elds) and in the T  $^6$ =Z  $_{12}$  model from M-theory. From the phenomenology consideration, we suggest massless scalar SUSY breaking scenario.

#### 1 Introduction

M -theory on  $S^1$ = $Z_2$  suggested by H orava and W itten [1] seem s to be a better candidate than the weakly coupled string to explain the low energy physics and uni cation of all the fundam ental interactions [2]. M any recent studies in M -theory compactication and its phenomenology implications [3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23] suggest that this may be the right track for super unication.

In this paper we discuss the soft term s in M -theory derived m odels. In supergravity G rand U ni ed T heory (G U T ) m odels, there are several soft term s to determ ine the low energy physics: universal gaugino m ass M  $_{1=2}$ , universal scalar m ass m  $_0$ , trilinear coupling A -term , bilinear coupling B -term (s). C om pared to the spectrum of low energy super particles, the input parameters are really very few . However, a futher reduction of parameters m ay be realized in string theory. In the weakly coupled string, there are two simplifying choices: (1) No-scale scenario [24, 25] with m  $_0$  = A = 0; (2) Dilaton scenario [26, 27] with M  $_{1=2}$  = A = M  $_0$  =  $\overline{3}$ . In our present discussion, we consider dilaton and moduli dominant SUSY breaking scenarios in M -theory. In addition, with the non-perturbative superpotential from the gaugino condensation [7, 21], we obtain the soft term s: M  $_{1=2}$ , M  $_0$  and A in terms of the hidden sector gauge coupling (at the scale of M  $_{\rm GUT}$ ) in units of the gravitino m ass. We not no consistent solution for moduli dom inant SUSY breaking and only one choice of dilaton dom inant supersymmetry breaking, the latter gives

which diers from previously obtained results [26, 27]. There might exist further Moduli or other Dilaton dominant SUSY breaking models, for there might exist other trigger of the SUSY breaking and we do not have a realistic model yet. Furthermore, we suggest a massless scalar SUSY breaking scenario. Because the gauge coupling in the hidden sector can not be too small, this scenario does not have avour changing neutral current (FCNC) problem because derivations from zero mass for the scalar masses in dierent families are much smaller than the gaugino mass [9]. In this scenario, the soft terms are:

where i=1,2,3 for three fam ilies.

## 2 Dilaton/ModuliDominantSUSY Breaking

The Lagrangian for the Yang-Mills eld in M-theory is [1]:

where  $^2$  denotes the 11-dim ensional gravitational coupling and i=1,2 for the observable sector, hidden sector. In the simplest model, the GUT scale coupling is related to moduli elds S and T by [9, 18]:

and is the ffth (or eleventh) dimension radius, V is the internal Calabi-Yau volume and! is the Kahler form. Similarly, the gauge coupling in the hidden sector at the GUT scale is

Inverting the relations in Eq.s (4) and (6), we obtain:

The Kahler potential K, the gauge kinetic function f and the superpotential W in the sim plest compactication of M-theory are [9, 18]:

where  $C^{\times}$  are the matter elds. We do not specify the exact trigger of the SUSY breaking, but just assume SUSY breaking by the F terms of the dilaton and moduli. Then, we obtain the gaugino mass M  $_{1=2}$ , scalar mass M  $_0$  and the trilinear parameters A by standard soft term from ulae [26, 27]. We introduce the following parametrizations of F  $^{\text{S}}$  and F  $^{\text{T}}$ :

where C is given in terms of the tree-level vacuum energy density V given by C  $^2$  = 1+  $\frac{V}{3M} \frac{2}{3=2}$ . A fler normalizing the observable elds, the soft terms are given by [8, 9, 7] 1.

where  $^{S}$  =  $\theta_{S}$  and  $^{T}$  =  $\theta_{T}$  . If one consider  $\frac{^{S}}{}$  =  $\frac{^{T}}{}$  = 0, then one obtain:

 $<sup>^{1}</sup>$ B ecause the bilinear parameter B depends on the speci c mechanism which could generate the associated term [8], we do not discuss it here. In fact, if we had such term, we can discuss it by the same way in this paper. It is [20]

Because > 0 and the gauge coupling in the hidden sector can not be in nity or negative, we have

Taking the Cosmology constant is zero, i. e., V=0, we have C=1. We choose  $_{GUT}=1$ =25 for the following discussion. Generically, the dynamics of the hidden sectorm ay give rise to both  $<F^S>$  and  $<F^T>$ , but one type of F term often dominates. Therefore, we concentrate on the two limiting cases: dilaton dominant SUSY breaking ( $F^S=0$ ) and the moduli dominant SUSY breaking ( $F^S=0$ ) [26,27]:

(I) D ilaton dom inant SUSY breaking scenario (F  $^{\rm T}$  = 0). In this case, the soft term s relations becom e  $^2$




Figure 1: The gaugino m ass M , scalar m ass m , and the trilinear coupling A versus  $_{\rm H}$  in units of the gravitino m ass in the dilaton dom inant SUSY B reaking scenario,.

The values of M  $_{1=2}$ , M  $_0$  and A versus  $_{\rm H}$  are plotted in Fig. 1 in units of gravitino mass. When  $_{\rm H}$  =  $_{\rm GUT}$ , we obtain the predicted relation in the weakly coupled string [26, 27]. When the gauge coupling in the hidden sector increases, M  $_{1=2}$ , M  $_0$  and A glecrease. From the requirement M  $_0^2$  > 0, we obtain that x is smaller than 3 + 3  $_0^2$  = 2 or 0.67423. In the limit of M  $_0$  = 0, we not that A=M  $_{1=2}$   $_1^2$  0:77, and the  $_{\rm H}$  is about 0.2056.

(II) M oduli dom inant SUSY breaking scenario (  $F^{\,\rm S}=0$  ). In this case, the soft term s relations becom e  $^3$

If one consider  $\frac{s}{m} = \frac{T}{m} = 0$ , then one obtain:




Figure 2: The gaugino mass M , scalar mass m , and the trilinear coupling A versus  $_{\rm H}$  in units of the gravitino mass in the moduli dom inant SUSY B reaking scenario.

From Fig. 2, we see that if the coupling in the hidden sector is strong enough (i. e.,  $_{\rm H}$  > 0:4), M  $_{1=2}$ =M  $_{0}$  is about 2. In addition, M  $_{1=2}$ , M  $_{0}$  and A increase with the gauge coupling in the hidden sector.

### 3 Hidden Sector Gaugino Condensation

The nonperturbative superpotential in the simplest model was calculated recently, and its form is [7]:

$$W_{np} = h \exp\left(\frac{8^2}{C_2 Q} (S T)\right); \tag{33}$$

where the gauge group in the hidden sector is Q (we do not consider massless Q matter elds except gluons and gluinos). In the simplest model Q is E $_8$ . C $_2$  (Q) is the quadratic C asim ir of Q and for E $_8$ , C $_2$  = 30.

Next, we can calculate F  $^{\rm S}$  and F  $^{\rm T}$  from W  $_{\rm np}$  [26; 27]. Noticing that < C  $^{\rm a}$  > = 0, we have

Taking the ratio F  $^{\rm S}\text{=}\!\text{F}^{\rm T}$  , we obtain the value of tan  $\,$  in term s of  $_{\rm H}$

We now discuss the soft term s of compactication of M-theory on T $^6$ =Z $_{12}$  [21, 22]. Although this is a toy model, it has three families, so it may shed light on the realistic model. The Kahler potential is:

where i=1,2,3 is the family index,

and the superpotential is 4

W e param etrize  $F^S$  and  $F^T$  as follows:

Then the norm alized soft gaugino m asses M  $_{1=2}$ , the un-norm alized soft scalar m asses M  $_{0}^{12}$ , and the trilinear param eters A  $_{abc}$  are given by [21]:

The non-zero  $\hat{K_m}$  ,  $\ell_m$   $K_{ii}$  and  $\ell_m$   $\ell_n$   $K_{ii}$  were calculated in Ref. [21].

To discuss the number of variables in this model, we introduce:

$$x_i = \frac{i(T_i + T_i)}{S + S}; \qquad (50)$$

where i=1,2,3, with the condition that

$$x = x_1 + x_2 + x_3 : (51)$$

Thus only two of the  $x_i$  are independent variables when we consider  $_{\rm H}$  as a fundam ental variable. The angles  $_{\rm L}$  and  $_{\rm L}$  can be calculated in a way similar to the simplest model. We can express the 5 soft terms (M  $_{\rm L=2}$ , M  $_{\rm L}^{\rm i}$  (i= 1,2,3), A) in terms of four variables ( $_{\rm H}$ , M  $_{\rm S=2}$  and two of the  $x_i$  (for example:  $x_1$  and  $x_2$ )). The problem with this general model is that the universality of scalar masses may be violated and there are too many variables to make predictions. To obtain universal scalar masses, we assume that:

Therefore, we can write the F  $^{T_i}$  as

A fler som e calculations, we are able to show that the scalar masses are universal and that the soft terms are given by Eqs.(19), (20), (21) and is given by Eq. (36).




Figure 3: In M -theory model with E  $_8$  as hidden sector group, the gaugino mass M , scalar mass m , and the trilinear coupling A versus  $_{\rm H}$  in units of the gravitino mass.

Because x is a function of  $_{\rm H}$ , M  $_{1=2}$ ; M  $_{0}$  and A are given by  $_{\rm H}$  in units of the gravitino m ass. In addition, it is obvious that m oduli dom inant SUSY breaking scenario does not exist for the numerator in tan is larger than zero. In the simplest m odel and the T  $^{6}$ =Z  $_{12}$  m odel, the gauge group in the hidden sector is E  $_{8}$ , for which C  $_{2}$  (Q) = 30. The result is shown in the Fig. 3. In order that the scalar m ass square non negative,  $_{\rm H}$  can not be larger than about 0.18. There is only one choice of exact dilaton dom inant SUSY breaking, which is:

In order to avoid FCNC problems that might arise from the violation of the universal scalar masses in three families (although this kind of the violation might be very small), it is reasonable assume that:

If the gaugino m ass is very large compared to the scalar masses, i. e., M  $_{1=2}$  >> M  $_0^i$ , the universal radiative contribution to the scalar masses from the gaugino mass by RGE running may wash out the non-universal scalar masses and avoid FCNC [9]. In addition, the gauge coupling in the hidden sector can not be too small as to go to the weakly coupled case and can not be too large, because the gaugino condesation scale is [7, 9]

In oder to have the gravitino m ass at TeV or hundred GeV range, we can not have large  $_{\rm H}$  or too small  $_{\rm H}$  for a realistic model where  $C_2$  (Q) might be about 12 as Q is  $E_6$ , and when one consider the massless Q matter elds in hidden sector, the total factor may be smaller. We propose the scalar massless scenario (strictly speaking, very small scalar masses scenario) as the most realistic. In this case, the soft terms and  $_{\rm H}$  are given by:

$$M_{1=2} = 1.022M_{3=2}$$
;  $M_0 = 0.003M_{3=2}$ ; (61)

$$A = 0.776M_{3=2}$$
;  $H = 0.1801$ : (62)

In a realistic model, the gauge group in the hidden sector might not be E $_8$ , If consider E $_6$  as the gauge group in the hidden sector, the quadratic C asim ir of E $_6$  is 12. In this case that  $_{\rm H}$  can not be larger than 0.151, and the scalar massless scenario is:

$$M_{1=2} = 0.989 M_{3=2}$$
;  $M_0 = 0.008 M_{3=2}$ ; (63)

$$A = 0.761M_{3=2}$$
;  $H = 0.1522$ : (64)

In comparison, the dilaton dominant SUSY breaking in this case is:

$$M_{1=2} = 1.534M_{3=2}$$
;  $M_0 = 0.870M_{3=2}$ ; (65)

$$A = 1.517M_{3=2}$$
;  $H = 0.052$ : (66)

From above discussion, in the dilaton dominant SUSY breaking scenario, the approximate soft term relations are

$$M_{1=2}$$
 '  $2M_{0}$  ' A: (67)

In the massless scalar scenario, the soft term relations are

It will be interesting to explore the phenomenology consequences of these relationships which are under investigations.




Figure 4: In M -theory m odel with E  $_6$  as hidden sector group, the gaugino m ass M , scalar m ass m , and the trilinear coupling A versus  $_{\rm H}$  in units of the gravitino m ass.
