THEORETICAL UNCERTAINTIES ASSOCIATED WITH THE EXTRACTION OF M $_{\rm W}$ AT HADRON COLLIDER $S^{\rm a}$

In this contribution I brie y sum marize several topics related to the measurement of the W -boson mass, M $_{\rm W}$, at hadron colliders.

1 Introduction

A precise m easurement of M $_{\rm W}$, along with other m easurements like the mass of the top quark, will indirectly constrain the mass of the elusive H iggs^b, the m issing piece of the very successful Standard M odel. This is important, an indirect m easurement tells us where to look for the Higgs in direct m easurement and later when (if) the Higgs is discovered a comparison of the direct and indirect m easurements will provide an important test of the Standard M odel. Both the Tevatron and LEP have already made very precise measurements of M $_{\rm W}$, as reported in these proceedings². In Table 1, I summarize the (CDF) expectations for the uncertainties on M $_{\rm W}$ for R un II at the Tevatron ³. As can be seen in this table, the W production m odel

uncertainty dom inates. This is the uncertainty associated with the transverse momentum of the W, the parton distribution functions (PDF's), and the QCD and electroweak corrections. The fact that this uncertainty dom inates represents both a challenge and an opportunity. It is a challenge because it is not acceptable and we should not ways to decrease this uncertainty below the experimental uncertainty. It is an opportunity because if we successfully decrease it then the Run II measurement of M_W at the Tevatron will be even better than currently anticipate. Note also that the W production model uncertainty is fully correlated between the electron and muon channels, such that not much improvement is gained by combining the two. If we succeed in controlling the W production model uncertainty we could get four (two per

detectors) m easurem ents with uncertainty sm aller than 40 M eV, and an overall uncertainty of the order of 20 M eV m ight be possible.

In the remainder of this contribution, I review the current status of the electroweak corrections to Z and W production at hadron colliders, a ratio method to measure M_W (and $_W$), recent developments on PDF uncertainties, and the opportunity to very precisely measure M_W at the LHC. I give my conclusions in the last section.

2 Electroweak Corrections to Z and W P roduction

This section is a sum m ary of the work done in collaboration with U.Baur and W. Sakum oto in Ref.⁴ (corrections to Z production) and with U.Baur and D.W ackeroth in Ref.⁵ (corrections to W production). There is a shift in M_Z and M_W extracted from the data due to the electroweak corrections of the order of 100 M eV.W e need to understand the uncertainty associated with that shift. The uncertainty was assumed to be of the order of 20 M eV for R unIa analysis at the Tevatron.

The electroweak corrections to Z production are also needed because the m easured M $_{\rm Z}\,$ and $_{\rm z}$ are used to calibrate the detector when compared to the values m easured at LEP.

In the calculation used so far to extract M_W (Berends and K leiss⁶, 1985), only the nal state photonic corrections are included using a very good approximation. The accuracy of this approximation can only be estimated by doing the full calculation. Our calculations include initial and nal state corrections and their interference. We used the phase space slicing method, as in QCD⁷; the advantage of that method is that the experimental cuts can be imposed without any di culties, without having to redo analytical integrations. In the calculations, we kept the mass of the nal state charged lepton (s), it protects the nal state collinear singularities. The

nal state photonic corrections dom inate the electrow eak corrections because they are enhanced by $\log M_{2 \text{ orW}}^2 = m_{\text{lepton}}^2$) when the charged lepton and photon momentum are not recombined. These large contributions are not present in the integrated cross section as required by the KLN theorem ⁸. The universal initial state collinear singularities have to be absorbed into the PDF's by factorization, in complete analogy with QCD. In principle, for the overall consistency of the calculations, the QED corrections should be added to the evolution of the PDF's and incorporated into the global tting of PDF's. Because this has not yet been done, we only have partial inform ation about the impact of the initial state corrections.

In the Z case, the QED corrections are gauge invariant by them selves, and so farwe neglected the weak corrections, they are expected to be small. In the W case the QED corrections are not gauge invariant by them selves, the weak corrections must be included. The non trivial calculation of the matrix elements for the W case was done in Ref.⁹ by D.W ackeroth and W.Hollick.

Our results are showing that, as expected, the nal state corrections dominate the shape change of the distributions in the region of interest for the measurement of M_W . The most important detector e ect is the recombination: when the electron and the photon are close to each other then their momenta is recombined to an electric electron momenta. This electron reduces the size of the corrections, although not to a level where they can be neglected.

The most important result is that the Z and W masses obtained by tting with our O() calculations are about 10 MeV smaller than that obtained by tting with the approximate calculations used so far. This is a good because this 10 MeV shift is smaller than the uncertainty so far assumed in the analysis. It is important to understand that this 10 MeV is NOT the uncertainty on the O() calculation, it is simply the di erence between two calculations of the O() corrections. The uncertainty on the O() calculation can only be estimated from the size of the O(2) corrections. Now that we have shown that the approximation a la Berends and K leiss is very good for the O() corrections, the same type of approximation could be used to

obtain an estimate of the O (2) corrections.

3 Ratio M ethod to M easure
$$M_W$$
 (and $_W$)

This section is a summary of the work done in collaboration with W. Giele in Ref.¹⁰. Instead of using the W distribution to measure M_W and the W width, $_W$, the ratio of W over Z distributions can be used. The normalization of the ratio should be included in the t as it is sensitive to $_W$. This idea is not really new, after all the measurement of M_Z and $_Z$ is already used for calibration of the detectors. However, with the upcoming high luminosity run at the Tevatron, the idea can be brought to full maturity. The main di erence between the W and Z production is due to their di erent mass (M $_V$). Mass-scaled variables must therefore be used:

where 0 is the observable under study. M $_{\rm W}$ can be tted for such that the measured ratio R is equal to the calculated one.

The obvious limitation of the m ethod is that it depends on the Z statistics. It is about 10 times lower than in the W case, such that the statistical uncertainty is about $\frac{P}{10}$ times larger^c.

There are m any advantages to the m ethod. First, the experim ental system atic uncertainties tend to cancel in the ratio. Potential problems that will spoil the cancellation are, e.g., the isolation criteria of the 2nd lepton in the Z case and som e of the backgrounds that are di erent. Second, M_W and _W are directly m easured with respect to M_Z and _Z which were accurately m easured at LEP. Third, the QCD corrections to the ratio are smaller than for the W and Z observables them selves which m eans that the theoretical uncertainty on the ratio is also sm aller (we have checked this statem ent for the transverse m ass, the transverse energy of the vector boson and the transverse energy of the lepton distributions, see R ef.¹⁰). Finally, the expectation is that the PDF uncertainties will also be sm aller.

In this ratio m ethod, there is a clear trade-o between statistical and system atic uncertainties: the statistical uncertainty is increased while the system atic uncertainty is decreased. We therefore expect this m ethod to be very competitive at high lum inosity (R un II, TeV 33^{11}) because there the standard m ethod uncertainty is dom inated by the system atic uncertainty, see Table 1.

D0 has already applied the ratio method to the transverse mass distribution with very encouraging results, see Ref.¹². The ratio method applied to the transverse energy of the charged lepton might yield the smallest uncertainty on M_W at high lum inosity.

4 Parton D istribution Function Uncertainties

This section is a summary of the work done in collaboration with W. Giele in Ref.¹³. Standard sets of PDF's do not come with uncertainties. The spread between di erent sets is often associated with PDF uncertainties. This is the case for the M_W analysis at the Tevatron. As is

well known, it is not clear at all what this spread represents. It is time for a set of PDF's with uncertainties. In Ref.¹³ we developed a method, within the framework of statistical inference, to take care of the PDF uncertainties. Here I simply explain two important steps of the method.

The rst step is the propagation of the uncertainty to new observables. The PDF's are assumed to be parametrized at a scale Q_0 , with N parameters, f g 1; 2;:::; N. The probability density distribution of these parameters, P_{init} (), is also assumed to be known.

For any observable, 0(), the prediction is simply given by the average value over the multidim ensional parameter space:

To calculate the integral we use a M onte-C arb approach with importance sampling. We generate 100 random sets of parameters distributed according to the initial probability density distribution, P_{init} (). This corresponds to 100 sets of PDF's that represent the uncertainty. The observable can be calculated for each set, O^j, and the prediction is then given by the average value over the 100 PDF sets:

whereas the PDF uncertainty is given by the standard deviation, $_{0}$, of the 100 PDF sets:

This gives a simple way to propagate the uncertainties to new observables, in particular there is no need for the derivative of the observable with respect to the parameters.

The second step I want to describe is the inclusion of the e ect of new data on the PDF's. If the new data agrees with the prediction then the e ect of the new data can be included by updating the probability density distribution with Bayes theorem . Initially, each of the 100 sets of PDF's (PDF_i) has a constant weight because of the use of in portance sampling. Now each of the sets acquires a di erent weight given by the conditional probability density distribution of the set considering the new data:

The latter is directly given by Bayes theorem :

If the uncertainties on the data are Gaussian distributed, then the weights are given by:

P (new data=PDF_i) / e

where $\frac{2}{i}$ is the dri-squared of the new data with the theory calculated with the speci c set of PDF's. P rediction for yet other observables that includes the e ect of the new data can now be calculated by using weighted sum. No information about the data used to derive P_{init} () is needed. O ther advantages of the method are as follows. The probability density distribution of the parameters does not have to be G aussian. A data set can be easily excluded from the t and experimenters can include their own data into the PDF's during the analysis phase. Finally, the theory uncertainty can be easily included.

It is worth m entioning that S.A lekhin about a year ago extracted PDF's with uncertainties from deep inelastic scattering (DIS) data ¹⁴. Both the statistical and system atic uncertainties with correlations were included. However the theoretical uncertainty was not considered. In Ref.¹³ we used his results for our initial probability density distribution to predict two observables at the Tevatron: the single inclusive jet cross section and the lepton charge asymmetry in W decays. Note that the initial probability density distribution could also be entirely based on theoretical consideration, in the spirit of Bayes theorem. One remaining problem is the uncertainty associated with the choice of param etrization of the input PDF's. This is a di cult problem that does not have a clear answer and will require a comprom ise between the number of param eters and the sm oothness of the PDF.

5 M easurement of M $_{\rm W}$ at the LHC

This section is a sum mary of the work done in collaboration with J.W omersley in Ref.¹⁵. The LHC will be a copious source of W. The cross section for W production (with appropriate cuts) at the LHC is about four times larger than at the Tevatron. The statistical uncertainty should therefore be small.

A priori, the system atic uncertainty is expected to be large at the LHC. However it is likely that the LHC will run at \low " lum inosity (10^{33} cm² s¹) for at least a year, corresponding to an integrated lum inosity of L = 10 fb¹. At that lum inosity the detector capabilities are very good: triggering on leptons with transverse energy as low as 20 GeV is possible, the num ber of interactions per crossing is of the order of 2, providing a quiet environment, and the m issing transverse momentum will be well measured because the hadronic calorim eters have large coverage (up to pseudorapidity of 5). Furthermore, both the ATLAS and CMS detectors o er advances over their counterparts at the Tevatron for lepton identic cation and measurement.

The QCD corrections to the shape of the transverse m ass distribution are of the order of 10% in the region of interest. The corrections are larger than at the Tevatron (2%) but still reasonable. The NNLO calculation will be useful in this case. If necessary the ratio m ethod, explained in section 3, could be used to reduce the theoretical uncertainty.

Scaling from the current m easurement at the Tevatron, about $15\,10^6$ W $\,!\,$ e reconstructed events are expected for 10 fb 1 at the LHC. The uncertainty obtained by using the parametrization developed for the Tev2000 16 study is very small, of the order of 8 M eV. It is dicult to believe that such a small uncertainty will be reached. However, we take this as an indication that there is an opportunity to make the world's best m easurement of M $_{\rm W}$, i.e. to measure M $_{\rm W}$ to a precision better than 15 M eV, the goal of TeV 33.

Note also that the B jorken-x probed is di erent at the LHC and the Tevatron. Therefore the PDF uncertainty will be di erent and from that point of view the two m easurements will be complementary.

6 Conclusions: Things to do!

A precise m easurement of M_W will be important to further constrain the mass of the Higgs. Current extrapolations to higher luminosity at the Tevatron indicate that the uncertainty on the extraction of M_W will be dominated by theoretical uncertainties. We therefore have work to do to ensure that this does not remain the case. For example, the two loop corrections $(O (\frac{2}{s}), O (\frac{2}{s}), O (\frac{2}{s}), and O (\frac{2}{s}))$ are needed to evaluate the theoretical uncertainty on the one loop calculations. A more de nite statement about the impact of the initial state contribution of the electroweak corrections is needed. We only have indications that they have a small e ect. D IS and Tevatron data should be used to extract PDF's with uncertainties with the method described in Ref.¹³. A lot of work remains to be done but the theoretical uncertainty should be signi cantly decreased by the time the Tevatron takes data again.
