# F lavor A sym m etry of the Sea Q uarks in the Baryon O ctet

## A bstract

We show that the chiralSU(n) SU(n) avor symmetry on the null-plane severely restricts the sea quarks in the baryon octet. It predicts large asym $m$ etry for the light sea quarks (u;d;s), and universality and abundance for the heavy sea quarks. Further it is shown that existence of the heavy sea quarks constrained by the sam e sym m etry reduces the theoretical value of the E llis-Ja e sum rule substantially.

## 1 Introduction

$M$ any years ago, based on the current antioom m utation relation on the nullplane $[\overline{1} 1]$, the $G$ ottfried sum rule [ī근 w as re-derived. Since the re-derived sum rule had a slightly di erent physicalm eaning from the original one, I called it as the m odi ed G ottfried sum rule $\operatorname{lin}_{1-1}^{1}$. Several years ago, this sum rule

where ${ }^{K^{+} N}() w$ ith $N=p$ orn is the totalcross section ofthe $K^{+} N$ scatterings and $f_{K}$ is the kaon decay constant. $T$ his gave us a new w ay to investigate
the vacuum properties of the hadron based on the chiralSU (n) SU (n) avor sym $m$ etry on the null-plane. In this paper I explain the fact and show that it severely restricts the sea quarks in the 8 baryon. Before going into details let us rst explain som e backgrounds about the sum rule (1). The classicalm om ent sum nulesbased on the operatorproduct expansion (OPE) were derived only at even integers or at odd integers [通], where the integer $n$ was de ned, for exam ple, for the structure function $F_{2}$ as

Then we call the integers where the classicalm om ent sum nules do not exist as the m issing integers. $\mathrm{For}_{2}$ in the electroproduction, these m issing integers are odd ones. The reason why we lose the m om ents at m issing integers is clear. In the classical derivation, we rst do the short-distance expansion. Then we analytically continue it to the light-cone one with use of the dispersion relation and expresses it by the structure function in the $s$ channel. In these processes we need som e relation for the structure function originating from the crossing sym $m$ etry. $W$ e usually take this as the one de ned by the current com $m$ utation relation because we can use the causality condition directly in this case. N ow this relation depends crucially on the way how we de ne the quantity in the $u$ channel. Hence by the proper consideration of this quantity, it $m$ ay be possible to get the sum rules at the $m$ issing integers. In the perturbative Q CD , the situation was resolved by using the analytical continuation w ith respect to n in the anom alous dim ension up to the two loops $\left[\frac{1}{1}\right]$, and as a by-product the G ottfried sum nule was revised as

for arbitrary $Q^{2}$, since the $Q^{2}$ dependence in Eq.(3) is negligibly sm all com pared $w$ ith $1 / 3$. This $m$ ethod of the analytical continuation in $n$ was conm ed directly also in Ref. $\left.\mathrm{Q}_{1}\right]$ in the perturbative approach up to the next to leading order. N ow the integer $n$ was known to be the $O$ (4) spin, and the $m$ om ent M ( $n$ ) should be replaced by the $N$ achtm ann $m$ om ents $\left[\frac{⿹_{9}^{1}}{1}\right.$ w hich are essentially the $O$ (4) partialw aves apart from the trivial kinem atical factors. $H$ ence the $m$ ethod of the analytical continuation in $n$ could be checked from
 pendent of the OPE. In thism ethod we rst de ned the signatured $m$ om ents as in the case of the Froissart-G ribov pro jection in the $O$ (3) partialw ave expansion. Then we found that the O (4) partial w aves at the w rong signature points exactly corresponded to the N achtm ann m om ents at the m issing integers. This stem $m$ ed from the fact that the scattering am plitude was de ned by the retarded product whose im aginary part was the com mutation relation. N ow what we really needed in the inclusive reaction was inform ation of the product of the current. Thus we constructed the am plitude whose im aginary part was the anticom $m$ utation relation. By applying the $O$ (4) partial wave expansion to this quantity, we found that the $m$ issing integers in the classical derivation corresponded to the right signature points of this expansion. The kinem atical form of the $m$ om ent at $n=1$ for the structure function $F_{2}$ obtained in this way in the electroproduction w as exactly the one obtained by the analytical continuation of the $m$ ethod in Ref.[i]. H ow ever the sign from the crossing sym $m$ etry for the structure function was not the usual one de ned by the current com mutation relation but the one de ned by the current anticom $m$ utation relation [İini]. It is this relation which is necessary to derive the sum rule (1). A physical m eaning of the di erence will be explained $m$ ore in the next section. Since a review of the derivation of the current anticom $m$ utation relation on the null-plane $w$ ith consideration for causality and the spectral condition for hadrons is described in detail in Ref.[5] $]$, we give here the result

where $c m$ eans to take the connected $m$ atrix elem ent and the state $j p i$ is the stable one particle hadron state. C om pared w th the current com m utation relation on the null-plane given as

the relations (6) are restricted greatly because they are not operator relations. In spite of this lim itation we can get $m$ any inform ation from them. Let us tum to discuss the di erence between Eq.(1) and Eq.(3). The both-hand sides of the sum rule (1) are related to the sam e quantity

as far as the $m$ om ent of the structure function $F_{2}$ at $n=1$ is concemed. We need caution in this identi cation. T he bilocal current on the left-hand side of Eq. (9) is not the regular one in the follow ing sense. Each coe cient of the expansion of the bilocal current on the nullplane into the local operator gets the singular piece due to the anom alous dim ension. The $Q^{2}$ dependence given in Eq.(3) corresponding to the $m$ om ent at $n=1$ is one exam ple which originates from this fact. H ow ever this $Q^{2}$ dependent piece w as negligibly sm all. T he experim entalvalue of the G ottfried sum the originally predicted value $1=3 \quad\left[\begin{array}{l}{[-1}\end{array}\right]$ and by this negligibly $s m$ all value it becam e im possible to explain the defect. On the other hand, the m odi ed G ottfried sum nule explained the defect $[\underline{4} \overline{4}]$. $T$ hus the term in the expansion of the bilocal current corresponding to the $m$ om ent at $n=1$ should be the one predicted by our method. In other words, we can consider that the perturbatively predicted $Q^{2}$ dependence is shielded by the large nonperturbative e ects, orm ore practically, we can regard it negligible com pared $w$ ith the non-perturbative contribution as far as the $m$ om ent at $n=1$ is concemed. Thus our method is com plem entary to the perturbative Q CD which is believed to be valid for the $m$ om ents above $n=2$ except the large $n$ region. Finally, it should be noted that the physical origin of the deviation from $1=3 \mathrm{w}$ as the sam e as that of the axial-vector coupling constant from 1 in the sense that both the deviations are proportional to the square of the pseudo-scalar decay constants.

## 2 The relation to the quark distribution functions

H ere we explain the role of the integral of the type $P^{R_{1}}{ }_{1}^{d}$ in Eq.(8). At $\mathrm{x}^{+}=0$, Eq. (8) corresponds to

T he rst term of the right-hand side ofEq. (12) contributes to the quark distribution function and the second one to the antiquark distribution functions. Let us now de ne a part of the quark distribution as

Thuswe se that the antiquark term gets extra $m$ inus sign due to the integral of the type $P^{R_{1}}{ }_{1}$ d . This explains a physical di erence between the modi ed G ottfried sum nule and the A dler sum rule. In the parton model we know

where the subscript $v m$ eans the valence quark and $i m$ eans the $i$ type sea quark. The di erence between the two sum rules is the sign in front of the antiquark distribution. The current anticom $m$ utation relation on the nullplane which leads to the $m$ odi ed $G$ ottfried sum nule isproportionalto $P \frac{1}{x}$. $T$ his factor is the origin of the integral of the type $P{ }_{1}^{R_{1}}$ d $\quad$. W hile the current com $m$ utation relation on the null-plane which leads ${\underset{\mathrm{R}}{1}}^{(t h e} A$ dler sum ${ }_{R_{1}}^{n}$ le is proportional to $(x)$. Thus, under the assum ption ${ }_{0}^{R_{1}} d x i_{i}\left(x ; Q^{2}\right)=$ ${ }_{0}^{R_{1}} d x{ }_{i}\left(x ; Q^{2}\right)$, the A dler sum rule $m$ easures the $m$ ean $I_{3}$ of the $f[q u a r k]+$ [antiquark]g and hence the one of the valence quarks being equal to the $I_{3}$ of the proton, while the $m$ odi ed $G$ ottfried sum nule $m$ easures the $m$ ean $I_{3}$ of the $f$ [quark] - [antiquark]gin the proton. In conclusion we can say that the $m$ odi ed Gottfried sum rule naturally explains the physical di erence betw een the A dler sum nule and the $G$ ottfried sum and that it directly probes the vacuum of the proton. This fact is the fundam ental im portance of the sum nules obtained by the current antioom $m$ utation relations (6).

## 3 The sym $m$ etry constraint on the light sea quark distributions in the baryon octet

$M$ any years ago, $W$ einberg showed that at high energy there is a sym $m e-$ try closely connected w th the dynam ic sym $m$ etry at low energy [1] 10 . The pion coupling $m$ atrix discussed there is very sim ilar to the $m$ atrix elem ent $<j_{a}^{5+}(0) j>$ on the null-plane at $q^{+}=0$ where $q=p \quad p$ and ; are one-particle hadron states. This is because this $m$ atrix elem ent pidks up the non-pole term since $<j_{a}^{5}(0) j>=f g \quad q q=\left(q^{2} \quad \mathrm{~m}^{2}\right) g<$
$j_{a}^{5}(0) j>_{N}$ where $N$ means the non-pole m atrix elem ent. Because of this property the light-like charge algebra plays very sim ilar role as the algebra of the pion coupling $m$ atrix. It relates the low energy to the high energy and the relation betw een the two energy regions is controlled by the sym $m$ etry. It is this sym $m$ etry which we discuss in this paper.
N ow $A_{a}(; 0)$ is govemed by this sym m etry,ie.,the chiralSU (3) SU (3) avor sym $m$ etry on the null-plane. If we take the state on the lefthand side of Eq.(9) as the 8 baryon, it becom es

$T$ hese are the constraints by the chiral avor sym $m$ etry and the discussion can be extended to SU (4) SU (4) or stillhigher sym $m$ etry w ith som e restrictions explained later.
Let us continue to discuss the SU (3) case. W ith use of $F^{P}$ and $\bar{f}$ given in Eqs. (23) and (24), it is possible to get the constraints on the sea quarks in each baryon by repeating the sam e kind of the discussions as those for the proton [్ర్|]. We rst regularize the sum rule by using analytical continuation from the non-forw ard direction. This regularization is based on the $m$ ethod
 The im portant point in this $m$ ethod lies in the fact that the sum rule is convergent under the physically reasonable assum ption, ie., the tra jectory of the pom eron satis es $P_{P}(t)<1$ for som $e$ sm all $t$ where $t$ is the $m$ om entum transfer. Thus once we can identify the parts which become divergent as $t$ goes to zero, we can safely subtract them from both-hand sides of the sum rule. T he soft pom eron by D onnachiand Landsho [ī which $m$ akes it possible to carry out the program easily. $N$ ow the assum ption
P ( t ) < 1 for som e sm allt can not be satis ed by the hard pom eron based on the xed-coupling constant the defect of this pom eron [1]-1. The next-to-leading corrections seem s to suggest a substantial reduction of the value of the intercept [i] $\left.{ }_{1}^{9}\right]$. T hem ultiple scatterings of the pom eron gives us im portant unitary corrections at low x [ $\overline{2} \overline{0} \overline{0}]$. Thus even in such a perturbative approach there is a hope to satisfy the assum ption. W e use the soft pom eron to explain the regularization, but in view of the situation, we clarify the quantities which do not depend on the assum ed high energy behavior in the follow ing. N ow the discussion of the regularization in the non-forw ard direction is cum bersom e kinem atically, and the technical aspect of the $m$ ethod can be explained by the e ective $m$ ethod in the forw ard direction, hence we recapitulate it here. H ow ever, It should be noted that, corresponding to the nite sum rules in this e ective $m$ ethod, there alw ays exist truly convergent sum rules in the above sense. The sum

W e take the leading high energy behavior of $\mathrm{F}_{2}^{\mathrm{ep}}$ is given by the pom eron as $\left.\left(\frac{1}{Q^{2}}\right)^{\mathrm{P}}()^{1} \mathrm{epp}^{2} \mathrm{Q}^{2} ; 1 \quad \mathrm{p}(0)\right)(2)^{\mathrm{P}}(0){ }^{1}$, and assume it to be the avor singlet, where $P_{p}(0)$ is the intercept of the pom eron. N ote that what we assum e here is only the high energy behavior (2 $)^{p(0)}{ }^{1}$ and no assum ption is $m$ ade about the $Q^{2}$ dependence, since all the unknown $Q^{2}$ dependence is absorbed in ep. This also applies to the scale factor in 2 . Then the regularization of the sum nule goes as follow s . W e rew rite the left-hand side of Eq. (25) as

Here the superscript 3 in $S_{0}^{3}\left(; 0 ; Q^{2}\right)$ and $S_{0}^{3} m$ eans the singlet in $S U(3)$. By com paring Eqs. (25) and (28) we see that the regularization of Eq. (25) sim ply results in the $Q^{2}$ dependence in the singlet com ponent and that all the relation from the sym $m$ etry is inherited. By keeping this fact in $m$ ind, $W$ e de ne the sea quark distribution of the itype one in the 8 baryon as $\frac{B}{i}$, and regularizes its $m$ ean num ber as

$N$ ote that the superscript $B$ drops out in $a$. This m eans that the result holds for all $m$ em bers in the 8 baryon. In the follow ing we use the policy to drop the superscript $B$ in the case where the relation holds for allm em bers in the 8 baryon. Further the su $\mathrm{x} i$ is dropped, since the value a is proportional to ${ }_{\text {ep }}^{0}$ and was determ ined through the sum nule as $a=12$ for $i=u ; d ; s$ in $R$ ef. assum ption that the pom eron is avor singlet. This can be seen by the fact that allthe coe cients of the singlet com ponent in the sea quark distributions are the sam e. Now, in general we can take the high energy behavior m ore com plicated than $P^{P}(t){ }^{1}$. For exam ple in case of (ln $)^{n}{ }^{P}(t){ }^{1}$, we will obtain the expansion of the form $\left[a_{1}=(\quad b)^{+1}+a_{2}=(\quad b)^{n}+\quad n^{t=} \quad\right.$ b) $]$ in stead of the sim ple pole ${ }_{\mathrm{ep}}^{0}=(\quad$ b). A ll these term s belong to the singlet and hence controlled by the sym $m$ etry. Thus am biguities due to high energy behavior can be absorbed into the nite part as $S_{0}^{3}\left(; 0 ; Q^{2}\right)$ also in this case. Eqs.(30) and (31) should bem odi ed appropriately according to the assum ed high energy behavior. Though we lose the explicit value $a=1: 2$ in this case, we stillhave the relation which relates the coe cient of the leading singularity in $\mathrm{F}_{2}$ and that in the pion nucleon reactions through the sum nule. N ow
retuming back to the soft pom eron we explain how the constraints on the sea quark distributions are obtained. A s an exam ple let ustake the proton $m$ atrix elem ent in Eq.(19) w ith $K=\frac{a}{2}=\operatorname{diag}(100)=\frac{\frac{\overline{6}}{6}}{6} 0+\frac{1}{2} \quad 3+\frac{{ }^{2}}{6} \quad 8$, where diag ( a b c) m eans the 3 m atrix whose diagonalelem ent is a;b;c and allo diagonalelem ents are zero. For the proton $=\frac{1}{2}(4+i 5) ;=\frac{1}{2}(4 \quad i 5)$. Since it is straightforward to repeat the same kind of the calculation for other sea quarks, we give the results in Table ${ }_{-1}$ in , where we use $\mathscr{S}^{3}$ de ned as $S^{3}=\frac{\overline{6}}{3} \mathbb{S}_{0}^{3} \cdot Z_{1}^{2}$ By using the fact that each valence part is m erely the num ber of the valence quark, we get $m$ any sum rules from the relations in $T a b l e$运. A $m$ ong them the sum nules for the $m$ ean quantum numbers of the light sea quarks are fiundam ental since they do not depend on $\mathbb{S}^{3}$. Here the light sea quarks $m$ ean the $u ; d$; s type sea quarks. $W$ e sum $m$ arize them in Table '2-1. N ote that $\underset{i}{e B}$ is replaced by ${ }_{i}^{B}$ because the divergent part is canceled out in each expression through the condition (31). The sam e kind of the fact holds also in the general case as far as the divergent part is assum ed to be avor singlet. P ractically, all the results in Table considering the quantity corresponding to $\mathrm{hI}_{3} \mathrm{i}, \mathrm{hY} i$, and hQ $i$ for the light sea quarks directly as in the exam ple in the section 2. In this case the singlet com ponent do not appear explicitly, hence if we assum e that the pom eron is avor singlet and that it contributes universally to every sea quark, we do not encounter the divergence. T hough such a practicalapproach obscures the physical view that at high energy there is a sym $m$ etry closely connected w ith the dynam ic sym $m$ etry at low energy, it convinces us that the results in Table ' ${ }_{2}$, are insensitive to the regularization. The perturbative QCD corrections to these relations begin from the 2 loops and they enter the sam e way as the one in the m odi ed G ottfried sum rule. Therefore they are negligibly sm all com pared w ith the non-perturbative values listed in Table ${ }_{2} \overline{2}-1$.

## 4 The sym m etry constraint on the heavy sea quark distributions in the octet baryon

Here we extend the sym $m$ etry from $S U(3) \quad S U(3)$ to $S U(n) \quad S U(n) w$ th n 4. In general, such sym $m$ etry is considered to be badly broken in the H am iltonian. H ow ever, in our case we do not use it explicitly. O ur starting

point is the local current algebra on the null-plane for good-good com ponent. In this case we do not need the equation of $m$ otion, hence in this sense all the results in this paper do not depend on the $H$ am iltonian which badly breaks the sym $m$ etry. H ow ever we need the assum ption conceming the classi cation of the $m$ atrix elem ents by the sym $m$ etry. It is not clear how far such classi cation holds. W e know that the $m$ ethod works well for the badly broken SU (3). Then it $m$ ay be useful to have physical predictions under this extension. A s it is explained later in this section and in the next section the physical results obtained seem to have som e experim ental relevance. Let us now discuss the heavy sea quarks in the 8 baryon. For concreteness we take the chiral SU (4) SU (4) avor symm etry. In this case the 8 baryon belongs to $20_{\mathrm{M}}$, and the currents to 15 . The matrix elem ent in this case can be classi ed by the singlet com ponent in the product $20_{\mathrm{M}} \quad 20_{\mathrm{M}} \quad 15$. Since the adjoint representation 15 appears tw ioe in the product as $20_{\mathrm{M}} \quad 20_{\mathrm{M}}=\begin{array}{lllllllll}175 & 84 & 45 & 45 & 20 & 15 & 15 & 1 \text {, and }\end{array}$ since only these two 15 can $m$ ake the singlet $w$ ith the rem aining 15 , we have two di erent term $s$ in the matrix elem ent. Further these two 15 can be represented by the $4 \quad 4 \mathrm{~m}$ atrix whose $3 \quad 3$ sub-m atrix agrees $w$ th the 33 m atrix in SU (3). N ow two di erent term s have already appeared in Eq. (20) as $F(; 0)$ and $D(; 0)$ in $S U(3)$. Henœ, even in $S U(4)$, Eq. (20) holds at least for ; $=18$ and $a=1$ 15. However, in this generalization, the singlet in $S U$ (3) is not the singlet in $S U$ (4). To see this fact $m$ ore concretely, we take the $m$ atrix $K=\operatorname{diag}\left(\begin{array}{llll}1 & 0 & 0 & 0\end{array}\right)$, and decom poses it as $K=\frac{\mathrm{P}_{\overline{2}}}{4}{ }_{0}^{4}+\frac{1}{2} \frac{4}{3}+\frac{\mathrm{P}_{\overline{3}}}{6}{ }_{8}^{4}+\frac{\mathrm{P}_{\overline{6}}}{12} \frac{4}{4}_{15}$. Here the ${ }_{k}^{4}$ is the Gell M ann m atrix generalized to SU (4). SU (3) singlet part in this decom position is $\frac{{ }^{\mathrm{p}} \overline{2}}{4}{ }_{0}^{4}+\frac{\mathrm{P}^{\mathrm{6}}}{12}{ }_{15}^{4}={ }_{\mathrm{p}} \frac{1}{3} \operatorname{diag}\left(\begin{array}{lll}1 & 1 & 1\end{array} 0\right)$. Since the $3 \quad 3$ sub-m atrix diag $\left(\begin{array}{lll}1 & 1 & 1\end{array}\right)$ is expressed as $\frac{{ }^{\frac{3}{6}}}{2} 0$ in $S U(3)$, the coe cient of the singlet part in $S U$ (3) is di erent from the one in $\operatorname{SU}$ (4). On the other hand, $3 \quad 3$ sub-m atrix in the part $\frac{1}{2}{ }_{3}^{4}+\frac{p_{3}}{6}{ }_{8}^{4}$ has the sam e expression in these two cases. Thus we nd one relation between the singlet contribution in SU (3) and the one in $S U$ (4). If we denote the $S U$ (4) singlet contribution as $\mathbb{S}_{0}^{4}$ corresponding to $\mathscr{S}_{0}^{3}$ in $S U(3)$, we obtain $\frac{p}{3} S_{0}^{3}=\frac{p^{2}}{2} \mathscr{S}_{0}^{4}+\frac{1}{3} \mathbb{E}$. Expressed in the parton $m$ odel, this generalization from $S U(3)$ to $S U(4)$ corresponds to the addition of the charm sea quark w ith the condition (31) w ithout changing anything in the light sea quarks. A fter all we nd that all the relations in Table $\overline{\mathrm{I}}$. and Table'ī̄ hold in SU (4) w thout changing anything. The discussion here also show $s$ that all the charm sea quark distributions in the 8 baryon corre-
sponding to the $m$ atrix elem ent of diag ( 00011 ) are the same. Explicitly in case of the soft pom eron we obtain $\left.2<e_{c}\right\rangle=S^{3} \quad \frac{4}{3} \mathbb{E}$ for all $m$ em bers in the 8 baryon. Since we already have the result that the charm sea quark in the proton is abundant [ $\left.{ }^{[ }, 12 \overline{1} \bar{j}\right]$, we reach the conclusion that the charm sea quark is universal and abundant in the 8 baryon. It should be noted that the ghon fusion like term is in general included in our de nition of the charm quark distribution function, but the ghon in our case is not necessarily the perturbative one. Experim entally HERA found $\underline{\underline{L}=-\overline{2}]}$ ] abundance of the charm sea quark in the proton which is qualitatively sim ilar to the one investigated in the toy m odel in Ref. $\mathrm{H}_{1}$ ] in the follow ing tw o respects. The one is that abundance of the charm sea quark is correlated w ith the rapid rise of the structure function $F_{2}$ in the sm all $x$ region. The other is that this rise persists even at $s m$ all $Q^{2}$, which can naturally be understood by this abundance. Further som e unpleasant features of this toy $m$ odelw hich com e from the constraint obtained by the soff pom eron analysis m ay be im proved if we take into account the perturbative analysis. H ow ever, even in such a case the property of abundance of the charm sea quark in the above sense rem ains. Now the m ean quantum number < Y > and $<Q>$ extended to SU (4) are not so useful since they do not correspond to the traceless $m$ atrix. H ence the dependence on $\mathbb{S}_{0}^{4}$ rem ains. R ather even in $S U$ (4), the $m$ ean quantum num bers of the light sea quarks in $T a b l e!\overline{2}$ are usefil. The heavy quark e ect should be exam ined by the $m$ ean quantum number such as < c $s>$, which corresponds to the sum of the $m$ ean charm and the $m$ ean strangeness. The sam e kind of the discussions can be repeated in the SU (5) or SU (6), and we get $\left.2<e_{b}\right\rangle=2\left\langle e_{t}\right\rangle=\mathbb{S}^{3} \quad \frac{4}{3} \mathbb{E} w$ th the constraint (31) for the bottom and the top sea quarks in case of the soft pom eron.

## 5 F lavor asym m etry of the spin-dependent sea quark distribution

It is interesting to note that sim ilar discussion to extend the sym $m$ etry from SU (3) to SU (4) can be applied to them atrix elem ent<p; ; j jJa (0) ip; ; ; which is directly related to the Elis-Ja e sum nule $\left[\begin{array}{l}2 \\ 3\end{array}\right]$ the $S U$ (3) case. W e de ne

Here $4 q^{p}$ includes the contribution from the antiquark as usual. Since $4 Q_{a}^{p}$ is proportionalto $A_{a}$, W e can apply Eq.(33) to this quantity. Thus we obtain

U sing experim ental value of $=0: 46 \quad 0: 01$ and $D=0: 79 \quad 0: 01\left[\begin{array}{l}{[2 \overline{4} 4]}\end{array}\right.$, we see that for a reasonable value of $S$, the theoretical value of the $E l l i s-J a ~ e ~ s u m ~$ nule is reduced substantially by the charm quark. It is usually considered that the light sea quark gets contribution from the gluon anom aly because of the $s m$ all-ness of the quark $m$ ass com pared $w$ ith the infra-red cuto $m$ agnitude of this gluon contribution is determ ined by input inform ation. Then, to $m$ ake the Ellis-Ja e sum rule consistent with the experim ent by this ghon polarization, it must be taken very large. In our case, such large ghon polarization is not necessary. The heavy quark such as the charm one is $s u$ ce to $m$ ake it consistent $w$ ith the experim ent.

## 6 C onclusions

In conclusion we show that the chiral SU ( $n$ ) $S U(n)$ avor symmetry on the null-plane combined w th the xed-m ass sum nule developed in Refs. $\underline{I N}_{1}$,
 a large asym $m$ etry for the light sea quarks, and universality and abundance for the heavy sea quarks. Further we show that the sam e sym $m$ etry restricts the fraction of the spin of the 8 baryon carried by the quark. Especially $W$ e show that this e ect is outstanding for the intrinsic charm sea quark in the nucleon and that it plays the role to reduce the theoretical value of the Ellis-Ja e sum rule substantially.
