# Isovector unpolarized quark distribution in the nucleon in the large $\left\{\mathrm{N}_{\mathrm{C}}\right.$ lim it

#### Abstract

W e calculate the isovector ( avor\{nonsinglet) unpolarized quark \{ and antiquark distributions in the nucleon at a low norm alization point in the large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ lim it. The nucleon is described as a soliton of the e ective chiral theory. The isovector distribution appears in the next\{to\{leading order of the $1=\mathrm{N}_{\mathrm{c}}$ \{expansion. N um erical results for the quark $\{$ and antiquark distributions com pare w ellw th the param etrizations of the data at a low norm alization point. This large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ approach gives a avor asym m etry of the antiquark distribution (violation of the G ottfried sum rule) in good agreem ent w ith the $m$ easurem ents.

## 1 Introduction

The parton distribution functions of the nucleon contain the non-perturbative inform ation which enters in the cross section for deep \{inelastic scattering and a variety of other hard processes. Their scale dependence in the asym ptotic region is govemed by perturbative QCD and well understood. The starting points of the perturbative evolution, how ever, that is, the distributions at a relatively low nom alization point, belong to the dom ain of nonperturbative physics and can at present only be estim ated using approxim ate $m$ ethods to dealw th the problem of the structure of the nucleon.

A very usefulapproxim ation is the theoreticallm it of a large num ber of colors, $\mathrm{N}_{\mathrm{c}}$ ! 1 . It is know $n$ that in this lim it Q CD becom es equivalent to an e ective theory ofm esons, w ith baryons em erging as solitonic excitations [i-1 theory is determ ined by the spontaneousbreaking ofchiralsym $m$ etry. The rst realization of the idea of the nucleon as a solton of the pion eld was proposed by Skym e hen, how ever, based on an arbitrary choice of higher\{derivative term s of chiral Lagrangian. A $m$ ore realistic e ective action for the pion eld is given by the integralover quark elds w ith a dynam ically generated $m$ ass, interacting $w$ ith the pion eld in a $m$ inim alchirally invariant way [ī]. Such an e ective action has been derived from the instanton vacuum of QCD, which provides a $m$ icrosoopic $m$ echanism for the dynam icalbreaking of chiral sym $m$ etry ${ }_{\underline{-1}, 1}^{1}$.
 very sucoessful in describing hadronic observables such as the nucleon $m$ ass, $N$ \{splitting, electrom agnetic and weak form factors etc. [8్ర్ర-1.

Recently it has been dem onstrated that it is possible to com pute also the leading $\{\mathrm{tw}$ ist parton distributions at a low norm alization point in the chiralquark \{soliton $m$ odelof the nu-
 requirem ents on parton distributions, such as positivity and the partonic sum nules which hold in QCD. In particular, it allow s a consistent calculation of the antiquark distributions. The approach has by now been extended to transverse polarized distributions [1] $\overline{2}]$ as well as to 0 \{forw ard quark distributions

The large $\left\{\mathrm{N}_{\mathrm{c}} \lim\right.$ it im plies a classi cation of the parton distribution functions in \large" and \sm all" ones $[\overline{[9]}]$. Generally, at large $\mathrm{N}_{\mathrm{c}}$ the quark distributions are conœentrated at values of $x \quad 1=N_{c}$, and $w$ th the chiral quark \{soliton $m$ odel we aim to com pute them for values of $x$ of this param etric order. The distribution functions which appear in the leading order of the $1=\mathrm{N}_{\mathrm{c}}$ \{expansion are of the form

where $(y)$ is a stable function in the large $N_{c}\{$ lim it, which depends on the particular distribution considered. They are the isosinglet unpolarized and isovector (longitudinally or
 tor unpolarized and isosinglet polarized distributions, on the other hand, appear only in the next\{to \{ leading order of the $1=\mathrm{N}_{\mathrm{c}}$ \{expansion and are of the form

In this paper we com pute the isovector unpolarized quark $\{$ and antiquark distributions in the chiralquark \｛soliton m odel． T he generalm ethod for calculating the $1=\mathrm{N}_{\mathrm{c}}$ \｛subleading distributions and a discussion of their properties have been given in Ref．［⿹勹龴⿵⺆⿻二丨． H ere we actually com pute the distribution function，including the $G$ ottfried sum，which is a m easure of the
 am ong other things，to generalize the analytical and num ericalm ethods for the com putation of distribution functions ${ }_{\underline{-1}-10]}^{-1}$ to the case of the $1=\mathrm{N}_{\mathrm{C}}\{$ subleading distributions，taking into account the rotation of the chiral soliton．

The isovector distribution considered here is of particular interest for understanding the relation of the low \｛scale parton distributions to the chiral e ective dynam ics．The distribution functions com puted w ithin the e ective chiral theory correspond to distributions of \constituent＂quarks and antiquarks，i．e．，ob jects which possess a structure in term s of
 quark is the ratio of the dynam icalquark $m$ ass to the ultraviolet cuto of the e ective theory the \size＂of the constituent quark．In the instanton vacuum this ratio is proportional to the sm allpacking fraction of instantons，$(=R)^{2}$ ．Before com paring the quark $\{$ and antiquark distributions com puted in the e ective chiral theory w th the param etrizations of the data at a low norm alization point $\left.\dagger \overline{1} 8{ }_{1}^{1}\right]$ one should \resolve＂the structure of the constituent quark． From the singlet distribution，$u(x)+d(x)+u(x)+d(x)$ ，\resolving＂the constituent quark structure one recovers the true singlet quark and ghon distributions．Phenom enologically one nds that gluons carry about $30 \%$ of the nucleon $m$ om entum at a norm alization point of $\quad 600 \mathrm{M} \mathrm{eV}$ ，so in the singlet case the \resolution＂of the constituent quark structure is a rather sizable e ect $\underline{9}^{9}, \underline{1}$ distribution due to the \resolution＂of the constituent quark structure is expected to be less im portant，as this distribution does not $m$ ix $w$ ith the gluon distribution and its norm alization is scale independent（isospin sum rule）．C onsequently，the isovector distribution calculated in the e ective chiral theory can alm ost directly be com pared w th the param etrizations of
 a com plete understanding of the structure of the constituent quark．

The plan of this paper is as follow s．Section＇ī，contains a brief exposition of the e ective chiral theory and the description of the nucleon as a chiralsoliton，including the sem iclassical quantization procedure．In Section＇ī－1 we derive the expressions for the isovector quark distribution functions in the e ective chiral theory and discuss their properties．We rst outline the expansion in the soliton angular velocity（ $1=\mathrm{N}_{\mathrm{c}}$ \｛ expansion）which is necessary for com puting the $\backslash s m$ all＂（ $1=\mathrm{N} \mathrm{c}_{\mathrm{c}}$ \｛suppressed）distribution functions，in particular the isovector unpolarized one．W e then discuss the in portant issue of ultraviolet regularization，which has been treated in detail in Ref． 1 in 0 ］．We show that the distributions obtained in our approach satisfy the isospin sum rule．W e also discuss the $G$ ottfried sum．In Section $\frac{14}{2}$ we brie $y$ describe the num ericaltechnique used for com putation of the $\backslash s m a l l " 1=N{ }_{c}$ \｛suppressed distribution functions．Sim ilarly to the $\backslash$ large＂ $1=\mathrm{N}_{\mathrm{c}}$ \｛ leading distributions they are com puted as sum s over quark single\｛particle levels in the background pion eld；how ever，now one is dealing w ith double sum s over levels．We then discuss the num erical results and com pare

[^0]them to the param etrizations of the data at a low norm alization point $1 \overline{1} \overline{8}]$. C onclusions and an outlook are given in Section 哭.

A calculation of the isovector unpolarized and isosinglet polarized distributions follow ing
 H ow ever, these authors have neglected certain contributions to the distribution function, which are im portant in particular at sm all values of $x$, as we shall discuss below. A lso, a calculation of the isovector unpolarized structure function in a related approach has been reported in Ref.[2̄]]. In that calculation, how ever, only the contribution of the so-called valence level is taken into account. T his approxim ation leads to a num ber of inconsistencies, as has been discussed in Refs. ${ }^{-19}, 1$ in 10.1 .

## 2 The nucleon as a chiral soliton

The starting point for the chiral quark \{soliton $m$ odel of the nucleon is the e ective action for the pion eld, which is obtained by integrating over quark elds in the badkground pion

Here, is the ferm ion eld, $M$ the dynam icalquark $m$ ass, which is due to the spontaneous breaking of chiral sym $m$ etry, and the pion (G oldstone boson) eld is described by an SU (2) m atrix, U (x), with

In the long\{wavelength lim it, expanding in derivatives of the pion eld, the e ective action Eq. (2._ַ_ W ess\{Zum ino term. It is understood that the ective theory de ned by Eq. (2, is valid for $m$ om enta up to an $U V$ cuto , which is the scale at which the dynam ical quark $m$ ass drops to zero. W e shall take in the discussion here the quark $m$ ass to be $m$ om entum \{independent and assum e divergent quantities to be $m$ ade nite by applying som e UV regularization later. [W hy this is generally justi ed w ill be discussed below .]

The spectrum of $H\left(\mathrm{U}_{\mathrm{C}}\right)$ inchudes a discrete bound \{state level, whose energy is denoted by $\mathrm{E}_{\text {lev }}$, as well as the positive and negative D irac continuum, polarized by the presence of the pion eld. The soliton pro $l e, P(r)$, is determ ined by minim izing the static energy of the pion eld, which is given by the sum of the energy of the bound \{state level and the aggregate energy of the negative $D$ irac continuum, the energy of the free $D$ irac continuum ( $U=1$ ) subtracted [a]],

Here the sum over $n$ runs over all occupied states, i.e., the discrete level and the negative D irac continuum, the sum over m over all non-occupied states, i.e., the positive D irac continuum .

The H am ittonian Eq. ( $\left.\overline{2} \overline{1} \overline{1}^{2}{ }^{2}\right)$ describes a spherical top in spin/isospin space, sub ject to the constraint $S^{2}=T^{2}$, which is a consequence of the \hedgehog" sym m etry of the static pion

$T$ he four nucleon states have $S=T=1=2$, with $S_{3} ; T_{3}=1=2$, while for $S=T=3=2$ one obtains the 16 states of the resonance. The rotationalenergy, $S(S+1)=(2 I)$, gives a $1=\mathrm{N}_{\mathrm{c}}$ \{correction to the nucleon m ass, which should be added to Eq. ( $\left.\overline{2} \cdot \bar{T}_{1}\right)$. The expression for the $m$ om ent of inertia, Eq. ( $\left.\overline{2} \overline{-1}^{-1} \underline{4}^{\prime}\right)$, contains an ultraviolet divergence which is to be rem oved by the ultraviolet cuto . T he ultraviolet regularization of them om ent of inertia m ust be consistent with that of the isovector quark distribution fiunction; it will be discussed below in Subsection

## 3 The isovector unpolarized quark distribution

### 3.1 T he isovector distribution function in the large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ lim it

To compute the tw ist\{2 quark and antiquark distribution functions in the e ective chiral theory we start from their \eld \{theoretic" de nition as forw ard $m$ atrix elem ents of certain light \{ray operators in the nucleon, which can be regarded as generating functions for the localtw ist $\{2$ operators $\stackrel{[12}{2} \overline{-}]$.  polarized antiquark distribution is given by the function at $x!x$ without $m$ inus sign. In Eq.(근) we have dropped the gauge eld degrees of freedom (the path \{ordered exponential of the gauge eld), a step which is justi ed when working in leading order in the ratio of $M$
to the UV cuto, viz. the packing fraction of the instanton medium ; see Refs. detailed discussion.

Thanks to its relativistically invariant de nition the m atrix elem ent Eq.( $\overline{3} \mathbf{3} \mathbf{I} \mathbf{1})$ can be evaluated in any fram e; for us it is convenient to com pute it in the nucleon rest fram e. The calculation follows the usual procedure for com puting $m$ atrix elem ents of quark bilinears in the chiral quark \{soliton $m$ odel $w$ thin the $1=\mathrm{N}_{\mathrm{c}}$ expansion. The $\lim$ it $\mathrm{N}_{\mathrm{c}}$ ! 1 justi es the use of the saddle point approxim ation for the pion eld. The $m$ atrix elem ent can be calculated w ith the help of the quark Feynm an $G$ reen function in the background pion eld,

The $m$ atrix elem ent of a quark bilinear betw een nucleon states of given spin and avor quantum num bers is obtained by integrating over soliton rotations w ith wave functions of the collective coordinates, $R$, corresponding to $a$ given spin/isospin state. In addition, one has to perform a shift of the center of the soliton and integrate over it w ith plane\{wave wave functions in order to obtain a nucleon state of de nite three\{ $m$ om entum. This leads to the follow ing expression for the forw ard $m$ atrix elem ent of a color\{singlet quark bilinear in the nucleon state ( $T$ denotes the tim e\{ordered product):

O ne should keep in $m$ ind, how ever, that this distinction is quite form al, and that only the total sum over occupied (or, equivalently, non-occupied) states has physical signi cance.

In the derivation of the expressions for the quark distribution function we have so far not taken into account the ultraviolet cuto intrinsic in the e ective chiral theory. In fact, the expressions for the isovector distribution, Eqs. (3) an ultraviolet divergence due to the D irac continuum contribution, and thus require regularization. $Q$ uite generally, in a calculation of parton distribution functions there are very strong restrictions on how one should introduce the UV cuto in the e ective theory. The point is that one has to preserve certain general properties of parton distributions such as positivity, sum rules etc., which can easily be violated by an arbitrary UV regularization. Speci cally, the regularization should preserve the com pleteness of the set of quark single\{ particle wave functions in the soliton pion eld. O ne possible regularization m ethod which ful lls all requirem ents is a Pauli\{V illars subtraction, which was used in the calculations
 Thus, we regularize Eqs. ( $\overline{3} \cdot 1$
$w$ here the subscript $M_{P v}$ denotes the corresponding expression com puted $w$ ith the con-

subtraction rem oves the logarithm ic divergence of the distribution function, as can be shown using $m$ ethods sim ilar to those developed in $R$ ef. 1 ī ${ }_{-1}$ (gradient expansion). We do not include the contribution of the discrete level to the isovector distribution in the P auli\{V illars subtraction; this contribution is nite and does not need to be subtracted.

The $m$ om ent of inertia of the soliton, Eq. (2. $\left.\bar{I}^{-1} \overline{4}^{\prime}\right)$, is also ultraviolet divergent. It m ust be regularized consistently w ith the isovector distribution in order to preserve the isospin sum rule (see Subsection $\left.1 \overline{3}-\frac{1}{-3}\right)$. This is acheved by regularizing it by a P auli\{V illars subtraction analogous to Eq. ( $\left.\overline{3}-2 \overline{1} 1 \overline{1}^{\prime}\right)$.

W e stress again that the calculation of parton distributions in the e ective chiral theory, i.e., the identi cation of the tw ist $\{2 Q C D$ operator $w$ th an operator expressed in term $s$ of elds of the e ective theory, Eq. ( $\bar{i} . \overline{1}$ ) , is based on the param etric sm allness of the ratio of the constituent quark m ass, M , to the ultraviolet cuto (here: $\mathrm{M}_{\mathrm{pv}}$ ). The approach is consistent in the sense that the expressions for the parton distributions in the e ective theory are logarithm ically divergent and thus insensitive to the details of the ultraviolet regularization (assum ing that the latter does not violate any im portant properties such as com pleteness etc.). It should be noted, how ever, that the ladk of precise know ledge of the \true" ultraviolet regularization leads to a theoretical uncertainty at the level of nite term s , $/ M^{2}=M_{P V}^{2}$. For instance, Pauli\{V illars subtraction of the nite level contribution would correspond to a m odi cation of the distribution function by an am ount of order $M{ }^{2}=M{ }_{P V}^{2}$. The num erical results presented in Section :"-i should be understood as a calculation of the parton distributions w ith a typical regularization ful lling allgeneral requirem ents, w ith the theoretical uncertainty in the ultraviolet regularization leading to a num erical unœertainty of typically $10\{20 \%$ | except for the sum rules, which follow from general principles not violated by the ultraviolet regularization.

### 3.4 The G ottfried sum

The integral on the R H.S. is scale\{dependent only at two\{loop level; its scale dependence is negligible over the entire perturbative region. If the sea quark distribution were isospin sym $m$ etric, $u(x)=d(x)$, which would be the case if, for exam ple, one assum ed the sea quark distribution to be generated entirely radiatively, this quantity would be equal to $1=3$ (G ottfried sum rule). H ow ever, the NM C experim ent [2] this value,

indicating that the sea quark distribution is rather far from avor\{symmetric. N ote that the $G$ ottfried sum rule does not follow from any fundam ental principles of $Q C D$. In fact, the large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ picture of the nucleon as a chiral soliton naturally explains the presence of a avor\{nonsym $m$ etric antiquark distribution.

The expression for the $G$ ottfried sum in the chiral quark \{soliton $m$ odel is obtained by integrating the expression for the total isovector quark distribution, Eqs. (3]. $x$ from 1 to 0 , keeping in $m$ ind that the antiquark distribution is given by $m$ inus the
 axis, also the total derivative term, Eq. ( $\left(\frac{1}{1}{ }_{1}^{2}\right)$, contributes to the $G$ ottfried sum, in contrast to the isospin sum rule, Eq. $(\overline{3}-2 \overline{2})$, where the integration nuns over the whole $x\{a x i s$ and Eq. ( $\left(\overline{3} .11^{1}\right)$ drops out. This contribution to the $G$ ottfried sum in the chiral quark \{soliton m odel has not been m entioned in Ref. $\left.{ }_{-1}\right]$.

W e refrain from writing dow $n$ the analytic expressions for the $G$ ottfried sum obtained by
 $m$ erically com puted antiquark distribution function, see below. In particular, the ultraviolet regularization of the $G$ ottfried sum and all other properties $w i l l$ follow directly from that of the distribution functions.

W e note that the $G$ ottfried sum in the large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ lim it has been discussed previously in the context of the chiral quark-soliton $m$ odel were, how ever, based on expressions for the R H S. of Eq. ( $\overline{3} 2 \overline{2}$ ) which do not follow from a consistent identi cation of the isovector distribution function $w$ ithin the ective $m$ odel.

## 4 N um erical results and discussion

Them ethod we choose for the num erical com putation of the isovector unpolarized distribution function parallels that for com puting the isosinglet unpolarized one [1]O-1]. We evaluate the sum s over quark single\{particle levels in the background pion eld by placing the soliton in a spherical 3\{dim ensionalbox, where the eigenfiunctions of the $D$ irac $H$ am iltonian in the background pion eld can be obtained by num erical diagonalization $\underline{2}_{2} \bar{\eta}_{1}$. For the ultraviolet regularization of distribution functions we em ploy the $P$ auli\{V illars subtraction, Eq. (3̄ $\overline{2} \overline{1})$ ). For the sake of num erical stability we rst evaluate the sum s over levels Eqs. ( $\overline{3} 18$ the usualquark $m$ ass, $M$, and the regulator $m$ ass, $M_{P v} . W$ e then perform the Pauli\{V illars subtraction, Eq. (3̄2 $2 \overline{1} 1)$, and rem ove the energy cuto by extrapolation to in nity.

W e have calculated the isovector quark distribution for tw o values ofthe constituent quark m ass, $\mathrm{M}=350 \mathrm{M} \mathrm{eV}$, which is the value obtained in Ref.[5].] for the instanton vacuum, and $\mathrm{M}=420 \mathrm{M} \mathrm{eV}$. The ultraviolet cuto is in both cases determ ined by tting the pion decay constant, Eq. $\left.(\underline{2})^{2}\right), M_{P V}^{2}=\mathrm{M}^{2}=2: 52(\mathrm{M}=350 \mathrm{M} \mathrm{eV})$ and $\mathrm{M}_{\mathrm{PV}}^{2}=\mathrm{M}^{2}=1: 90(\mathrm{M}=420 \mathrm{M} \mathrm{eV})$. The soliton pro le, Eq. (2. $\mathbf{L}_{1}^{\prime}$ ), and the nucleon $m$ ass have been found by self consistent $m$ inim ization of the P auli\{ V illars regularized static energy in Ref . $\left[1{ }_{1}^{1}\right], \mathrm{M}_{\mathrm{N}}=1140 \mathrm{MeV} \mathrm{M}=$ $350 \mathrm{MeV})$ and $\mathrm{M}_{\mathrm{N}}=1040 \mathrm{MeV}(\mathrm{M}=420 \mathrm{M} \mathrm{eV})$. A num ber of other hadronic nucleon observables such as the isovector axial coupling constant $g_{A}^{(3)}$ have been calculated w th this ultraviolet regularization in Ref. $\left.{ }_{2} \bar{L}_{-1}^{1}\right]$. The results for the isovector unpolarized quark and antiquark distributions are shown in $F$ igs'

Before com paring our results w ith the param etrizations of the experim ental data it is instructive to study the behavior of the di erent contributions to the distribution fiunction in

[^2]this $m$ odel. $F$ ig ${ }_{2}^{2}=1$ show s the function $u(x) d(x)$ forboth positive and negative $x$, describing the isovector quark distribution at positive and $m$ inus the antiquark distribution at negative values of $x$. The dashed line shows the contribution of the discrete level, as de ned by Eq. ( to the bound\{state level contribution to the isosinglet unpolarized and isovector polarized
 the dot\{dashed line. Sim ilar to the isosinglet distribution this contribution is peaked around $\mathrm{x}=0$; how ever, in the isovector case this function does not change sign at $\mathrm{x}=0$. The total is given by the solid line; one observes that it is essentially a sm ooth function except for a region of $x$ around $x=0$, where it is dom inated by the $D$ irac continuum contribution. N ote also that the calculated distribution satis es the isospin sum nule, as discussed in Subsection ,

The isovector quark and antiquark distributions calculated here refer to a low norm alization point of the order of the cuto of the e ective chiral theory (r 600 M eV ), and can be com pared to experim ental data for structure functions only after perturbative evolution to larger scales. H ence the $\backslash s m a l l\{x "$ behavior of the calculated parton distribution apparent from $F$ ig ${ }_{2}^{2}$, has signi cance only in the sense of an input distribution at a low scale and does not im ply a statem ent about the sm all\{x behavior of the structure functions at experim ental scales.

The parton distribution functions calculated in the e ective theory are but logarith$m$ ically divergent $w$ ith the UV cuto and thus, for typical values of $x$, insensitive to the details of the UV cuto (assum ing a physically acceptable regularization schem e m eting the criteria discussed above). H ow ever, it is known that in the param etrically sm all region ixj $\quad(M=)^{2}=N_{c}$ the shape of the distribution depends on the details of the $U V$ regularization, as has recently been discussed in connection with the calculation of o \{forward parton distributions in this approach [13]. For instance, it was seen there that the discontinuity at $\mathrm{x}=0$ of the isosinglet distribution calculated w ith P auli\{V illars regularization is reduced to a sm ooth transition when the regularization is im plem ented in the form of a m om entum \{dependent constituent quark m ass, as suggested by the instanton vacuum. For values of $x$ not in the vicinity of zero results are practically unchanged as com pared to the Pauli\{V illars regularization.] O ne $m$ ay thus sum ise that also the shape of the peak in the isovector distribution at $x=0$ depends strongly on the ultraviolet cuto . The calculation of the $1=\mathrm{N}_{\mathrm{c}}$ \{suppressed distribution functions w th regularization by a m om entum \{dependent $m$ ass is outside the scope of the presently available $m$ ethods. T he interesting general problem of the relation of the ultraviolet cuto of the e ective theory to the \sm all\{x" behavior of the low \{scale parton distributions w ill be left for further investigation.

In Fig'in we com pare the distribution functions obtained for two di erent values of the constituent quark m ass, $\mathrm{M}=350 \mathrm{M} \mathrm{eV}$ and $\mathrm{M}=420 \mathrm{M} \mathrm{eV}$. W ith the ultraviolet regular-
 by $m$ inim ization of the energy Eq. (2. $\mathbf{L}_{1}$ ), the only rem aining free param eter in this $m$ odel calculation is the value of the constituent quark m ass, M . R ather than trying to detem ine an \optim um" value by perform ing a best $t$ to a number of hadronic observables, it is $m$ ore interesting here to study the dependence of the calculated parton distributions on this

The parton distributions com puted here should be used as input for perturbative evolution, starting w ith a scale of the order of the cuto ( $\left.{ }^{\prime} 600 \mathrm{M} \mathrm{eV}\right)$. We shall not perform the evolution here, but rather com pare our results w th the param eterizations by G luck, Reya, and Vogt [īq]. These authors generate parton distributions at experim ental $Q^{2}$ from \valence\{like" (non-singular) input quark \{, antiquark and gluon distributions at a norm alization point of the order of 600 M eV and obtain excellent ts to the data from deep \{inelastic scattering and a variety of other processes. In $F$ ig ${ }^{2}$ - we com pare the isovector distribution of quarks, $x[u(x) \quad d(x)]$, and antiquarks, $x[u(x) \quad d(x)]$, to the G RV param etrization [1] O ne notes that the calculated distributions are system atically harder (i.e., centered at larger values of $x$ ) than the GRV one, indicating that the nom alization point of the calculated distributions is even low er than that of the G RV param etrization. This is consistent w th the
 polarized $[\overline{\underline{9}}, r i \overline{1} \overline{\underline{q}}]$ distributions to the G RV param etrizations; how ever, in the isovector unpolarized case considered here the com parison of the calculated distribution w th the G RV
$t$ is $m$ ore direct since, contrary to the isosinglet unpolarized distribution, this distribution does not $m$ ix with the ghon distribution under evolution, and its nom alization is scale\{ independent. A lso, contrary to the isovector polarized distribution whose norm alization is given by the isovector axial coupling constant, $g_{A}^{(3)}$, whose value in our approach is model\{ dependent, the nom alization of the the isovector unpolarized distribution is universal thanks to the isospin sum rule.]
$N$ ote that the order ofm agnitude and shape of the calculated isovector antiquark distribution are in good agreem ent w ith the G RV param etrization, see Fig'넌. A s can be seen from $F$ ig'2̄ the antiquark distribution is dom inated by the $D$ irac continuum contribution. W e note that our distribution di ers signi cantly from the result of Ref. ${ }_{10}^{-9} 9{ }^{-1}$, where the contribution from the term Eq.( $\overline{3}$. 1 did) has been dropped; our distribution vanishes rapidly for large $x$, in contrast to the one of Ref. $[1]$
$W$ ith regard to the isovector antiquark distribution it is interesting to com pute the G ottfried sum, Eq. ( $\overline{3} \mathbf{2} \mathbf{2}$ ) $)$. The results for the two constituent quark m asses $\mathrm{M}=350 \mathrm{MeV}$ and $M=420 \mathrm{M} \mathrm{eV}$ are given in Table' ${ }_{\mathrm{I}}^{1}$, where we also list separately the contributions of the
discrete level and the $D$ irac continuum to the integral from of the antiquark distribution. As can be seen, the deviation of the $G$ ottfried sum from from $1=3$ is dom inated by the $D$ irac continuum contribution. The values are in reasonable agreem ent w th the NM C value [2] ${ }_{2}$ W e note that, since our D irac continuum contribution strongly di ers from that of Ref. 19 the good agreem ent of the value of $I_{G}$ reported there $w$ ith experim ent seem $s$ fortuitous.

Finally, we note that the parton distributions studied here refer to the large\{ $\mathrm{N}_{\mathrm{c}} \operatorname{lm}$ it, where the nucleon is heavy, $\mathrm{M}_{\mathrm{N}} / \mathrm{N}_{\mathrm{C}}$. The calculated distributions therefore do not go to zero at $\mathrm{x}=1$, rather, they are exponentially sm all at large x , as discussed in Ref. $\left.\underline{g}_{\mathrm{g}}^{\mathrm{n}}\right]$. For this reason we have evaluated the integral of the antiquark distribution in Eq. ( $\left.\overline{3} \overline{2} \overline{2} \overline{5}^{\prime}\right)$ and $T a b l e ' 1 \overline{1}$ w ith the upper lim it replaced by in nity. N um erically, the contribution from values of $x>1$ to the integral is negligible.

## 5 C onclusions

In this paper we have extended the approach to calculate parton distributions at a low norm alization point in the large $\left\{\mathrm{N}_{\mathrm{c}} \lim\right.$ it to the case of the distributions which appear in the subleading order of the $1=\mathrm{N}_{\mathrm{c}}$ \{expansion. Speci cally, we have com puted the isovector unpolarized distribution of quarks and antiquarks. T he m ethods developed here can readily be generalized to com pute also the other $1=\mathrm{N}_{\mathrm{c}}$ \{subleading distributions, nam ely the isosinglet longitudinally and transverse polarized ones, as well as the rotational $1=\mathrm{N}_{\mathrm{c}}$ \{corrections to the isovector polarized distribution. T hese distributions are currently being com puted.

W e have found reasonable agreem ent of the calculated distributions $w$ ith the param etrizations of the data at a low nom alization point. In particular, the large $\mathrm{N}_{\mathrm{c}}$ approach naturally predicts a avor\{asymmetric (i.e., non-radiative) sea quark distribution of correct sign and $m$ agnitude. The $x\{$ dependence of the isovector antiquark distribution com pares well $w$ th the G RV param etrizations. It is interesting that the calculated distributions exhibit a strong rise at $x=0$. A lso, the integral of the calculated isovector antiquark distribution (the violation of the $G$ ottfried sum nule) is com patible $w$ th the experim ental data, in view of the general theoretical uncertainties of the present approach.
