Photon splitting above the pair creation threshold in a strong magnetic eld

Abstract

The process of photon splitting ! in a strong magnetic eld is investigated both below and above the pair creation threshold. Contrary to the statem ent by Baier et al., the \allowed" channel $_k !$, is shown not to be a comprehensive description of splitting in the strong eld because the \forbidden" channel $_k !$, is also essential. The partial amplitudes and the splitting probabilities are calculated taking account of the photon dispersion and large radiative corrections near the resonance.

Now adays it is generally recognized that an external electrom agnetic eld plays the role of an active medium. It can induce new interactions and can also change the dispersion properties of particles, thus allowing processes which are forbidden in vacuum. The photon splitting processs ! could be a prominent example of the magnetic eld e ect.

The theoretical study of this process has a rather long history [1, 2, 3]. Recent progress in astrophysics has drawn attention again to the photon splitting induced by a magnetic eld. This process may explain the peculiarity of the spectra of the observed -bursts [4, 5]. The origin of these -bursts is not clear yet. Some models exist where astrophysical catacitysms like a supernova explosion or a coalescence of neutron stars could be the sources of such -bursts. It is generally supposed that these objects have strong magnetic elds 10^{46} 10^{47} G [6] much greater than the Schwinger value, $B_e = m^2 = e'$ 4:41 10^{46} (hereafter m is the electron mass, e > 0 is the elementary charge).

In our opinion, continued investigation of the process ! is in portant not only because of its possible applications, but to also gain an improved understanding of radiative processes in intense external elds. The study of the photon splitting ! in a strong magnetic eld [7, 8, 9] has so far considered only the collinear lim it of the process, when the only allowed transition with respect to photon polarizations is, k! ; ; (in Adler's notation [2]). How ever, photon dispersion in a strong m agnetic eld, B B_e, leads to signi cant deviations from the collinearity of the kinem atics of this process. This is due to the fact that the eigenvalues of the photon polarization operator (the photon e ective m ass squared) becom e large near the so-called cyclotron resonances [10]. The lowest of them is only essential in a strong eld and corresponds to the pair creation threshold $!_0 = 2m$ (in the frame where the photon momentum is perpendicular to the eld direction). A photon of the ? mode acquires in this region a signi cant e ective mass, $k^2 = !^2$ $k^2 < 0; k^2 = 1$ $!^2$, and this de nes the kinem atics of the photon splitting, which is far from collinearity.

On the other hand, a large value of the polarization operator near the resonance requires taking account of large radiative corrections which reduce to a renorm alization of the photon wave-function

Here $\mathbf{W}^{(k)}$, $\mathbf{W}^{(r)}$ are the polarization four-vectors of the photon m odes and P are the eigenvalues of the photon polarization operator, corresponding to

these m odes [10].

Both the e ect of noncollinearity and radiative corrections have not, so far, been taken into account. For example, in the paper by Baier et al. [7] the amplitude and the probability of the photon splitting were obtained for the photon energies up to the threshold $!_0 = 2m$. Strictly speaking, that result is incorrect because the noncollinearity of the photon m om enta and the photon wave-function renorm alization were not considered. In fact, their am plitude describes the photon splitting correctly only in the limit ! m. The same criticism is appropriate for the paper [9].

It should be stressed also, that the channel $_{k}$! $_{?}$? is not adequate to describe photon splitting because of the noncollinearity of the photon m om enta. In particular, the transition $_{k}$! $_{k}$? forbidden in the collinear lim it, gives an essential contribution into the splitting probability, contrary to the statem ent by Baier et al. [7].

In this paper, photon splitting in a strong magnetic eld is investigated both below and above the pair-creation threshold, with an emphasis on the noncollinearity of the kinematics, and taking account of large radiative corrections. The splitting probability of a photon with high energy is of particular importance for calculations of the spectra of strongly magnetized cosm ic objects.

The process of photon splitting in an external eld is depicted by two Feynm an diagram s, see Fig.1. The electron propagator in a magnetic eld could be presented in the form

where A is a 4-potential of the uniform magnetic eld. The translational invariant part $\hat{S}(x = y)$ of the propagator has several representations. It is convenient for our purposes to take it in the form of a partial Fourier integral expansion

where are the D irac matrices in the standard representation, the fourvectors with the indices? and k belong to the (1, 2) plane and the M inkow ski (0, 3) plane correspondingly, when the eld B is directed along the third axis. Then for arbitrary 4-vectors a , b one has

where the matrices are introduced = (' '), ^e = $(' \sim ')$, connected by the relation ^e = g = diag(1; 1; 1; 1), ' = F = B; '~ = $\frac{1}{2}$ " ' are the dimensionless tensor of the external magnetic eld and the dual tensor, (a b) = a b.

In spite of the translational and gauge non invariance of the phase (x;y) in the propagator (2), the total phase of three propagators in the loop of F ig.1 is translational and gauge invariant

The amplitude of the photon splitting ! takes the form

where k = (!;k) is the 4-vector of the momentum of initial photon with the polarization vector ", k^0 and k^{00} are the 4-momenta of nalphotons, X = z x; Y = x y.

Substitution of the propagator (4) into the amplitude (5) leads to a very cum bersom e expression in a general case. Relatively simple results were obtained only in the two limits of a weak eld [2] and of the strong eld with collinear kinem atics [7].

It is advantageous to use the asymptotic expression of the electron propagator for an analysis of the amplitude (5) in the strong eld without the collinear approximation. This asymptotic could be easily derived from Eq. (4) by evaluation of the integral over in the limit $eB = jn^2 p_r^2 j$ 1. In this case the propagator takes the simple form

which was obtained for the rst time in Ref. [11]. Substituting this in Eq. (5) and integrating, one would expect to obtain the amplitude which depends linearly on the eld strength, namely, as $B^3=B^2$, where B^2 in the denom inator arises from the integration over d^2X_2 , d^2Y_2 . However, two parts of the amplitude (5) cancel each other exactly. Thus, the asymptotic form of the electron propagator (6) only shows that the linear-on-eld part of the amplitude is zero and provides no way of extracting the next term of expansion over the eld strength.

As the analysis shows, that could be done by the insertion of two asymptotic (6) and one exact propagator (4) into the amplitude (5), with all interchanges. It is worthwhile now to turn from the general amplitude (5) to the partial amplitudes corresponding to de nite photon modes, k and ?, which are just the stationary photon states with de nite dispersion relations in a magnetic eld. There are 6 independent amplitudes and only two of them are of physical interest. We have obtained the following expressions, to the term s of order 1=B

As for remaining am plitudes, we note that M $_{k! \ kk}$ is equal to zero in this approximation. On the other hand, the photon of the ? mode due to its dispersion can split into two photons only in the kinematic region $k_k^2 > 4m^2$ where the tree-channel $_{?}$! $e^+ e$ [12] strongly dom inates.

Thus we will analyse further the photon splitting of the k mode in the region $k_k^2 < (m + \frac{1}{m^2 + 2eB})^2$ where the tree-channel $_k ! e^+ e^-$ does not exist. In the form all imit of the collinearity of the photon momenta, the amplitude M $_{k!k?}$ goes to zero while the amplitude M $_{k!??}$ coincides with the amplitude obtained in Ref. [7].

A lthough the process involves three particles, its am plitude is not a constant, because it contains the external eld tensor in addition to the photon 4-m om enta. The general expression for the splitting probability can be written in the form

where the factor g = 1 $\frac{1}{2}$ ∞ is inserted to account for possible identity of the nalphotons. The factors Z account for the large radiative corrections which reduce to the wave-function renorm alization of a realphoton with definite dispersion ! = ! (k). The integration over phase space of two nal photons in Eq. (10) has to be performed using the photon energy dependence on the momenta, ! = ! (k), which can be found from the dispersion equations

where P are the eigenvalues of the photon polarization operator [10]. In the limit of a strong eld and in the kinematic region $k_k^2 = \frac{1}{2} =$

where H (z) is the function de ned in Eq. (9).

A calculation of the splitting probability (10) is rather complicated in the general case. In the lim it $m^2 l^2 \sin^2 eB$, where is an angle

between the initial photon momentum k and the magnetic eld direction, we derive the following analytical expression for the probability of the channel $k = \frac{1}{2}$:

W ithin the same approximation we obtain the spectrum of nalphotons in the frame where the initial photon momentum is orthogonal to the eld direction:

where $!;!^{0}$ are the energies of the initial and nalphotons of the k m ode.

In conclusion, we have investigated the photon splitting ! below and above the pair-creation threshold in the strong magnetic eld, B B_e. We have found the amplitudes and the probabilities of two channels, $_{k}$! the process kinematics, and of large radiative corrections. The photon spectrum and the splitting probability are calculated analytically for the dominating channel $_{k}$! $_{k}$, at high energies of the initial photon. The splitting probabilities are calculated num erically for both channels. The results should be used for quantitative studies of the role of the exotic eld-induced process of photon splitting in high-energy astrophysics.
