## HANDBOOK OF HIGHER TW IST DISTRIBUTION AMPLITUDES OF VECTOR MESONS IN QCD

W e give a sum mary of existing results on higher twist distribution amplitudes of vector m esons in QCD. Special attention is payed to m eson m ass corrections which turn out to be large. A \shopping list" is presented of m ost im portant nonperturbative parameters which enter distribution amplitudes.

#### 1 General fram ew ork

The notion of distribution amplitudes refers to momentum fraction distributions of partons in the meson in a particular Fock state with xed number of components. For the minimal number of constituents, the distribution amplitude is related to the Bethe-Salpeter wave function  $_{\rm BS}$  by

The standard approach to distribution amplitudes, which is due to B rodsky and Lepage<sup>1</sup>, considers the hadron's parton decom position in the in nite momentum frame. A conceptually di erent, but mathematically equivalent formalism is the light-cone quantization<sup>2</sup>. Either way, power suppressed contributions to exclusive processes in QCD, which are commonly referred to as higher twist corrections, are thought to originate from three di erent sources:

contributions of \bad" com ponents in the wave function and in particular of those with \w rong" spin projection;

contributions of transverse motion of quarks (antiquarks) in the leading twist components, given for instance by integrals as above with additional factors of  $k_2^2$ ;

contributions of higher Fock states, with additional gluons and/or quarkantiquark pairs.

We take a som ewhat di erent point of view and de ne light-cone distribution am plitudes as meson-to-vacuum transition matrix elements of nonlocal gaugeinvariant light-cone operators. This form alism is convenient for the study of higher-twist distributions thanks to its gauge and Lorentz invariance and allows to solve all equations of motion explicitly, relating di erent higher-twist distributions to each other. We will nd that all dynam ical degrees of freedom are those describing contributions of higher Fock states, while all other highertwist e ects are given in terms of the latter without any free parameters.

The report is divided into three sections, the rst of which is introductory and the last two present the sum mary of distribution amplitudes up to twist 4. The expressions collected in these sections are principally the result of recent studies reported in Refs.<sup>3;4;5</sup> which considerably extend the earlier analysis in Ref.<sup>6</sup>. We use a simplified version of the set of twist-4 distributions derived in <sup>5</sup>, taking into account only contributions of the lowest conformal partialwaves, and for consistency discard contributions of higher partial-waves in twist-3 distributions in cases where they enter physical amplitudes multiplied by additional powers of m. Four-particle distributions of twist 4 start with higher conform all spin and must be put to zero to the present accuracy. The SU (3)-breaking e ects are taken into account in leading-twist distributions and partially for twist-3, but neglected for twist-4. Explicit expressions are given for a (charged) -m eson. D istribution amplitudes for other vector-m esons are obtained by trivial substitutions.

Throughout this report we denote the m eson m om entum by P  $\,$  and introduce the light-like vectors p and z such that

The meson polarization vector  $e^{(\ )}$  is decomposed in projections onto the two light-like vectors and the orthogonal plane as

W e use the standard B jorken-D rell convention<sup>7</sup> for the metric and the D irac matrices; in particular  $_5 = i \ ^{0} \ ^{1} \ ^{2} \ ^{3}$ , and the Levi-C ivita tensor is de ned as the totally antisymmetric tensor with  $_{0123} = 1$ . The covariant derivative is de ned as D  $\dot{D} = 0$  igA, and we also use the notation

D = 0 + igA in later sections. The dual gluon eld strength tensor is de ned as  $\mathfrak{G} = \frac{1}{2}$  G .

### 1.1 Conform al partial wave expansion

C onform al partial wave expansion in QCD <sup>8;9;10;11;12;13</sup> parallels the partial wave expansion of wave functions in standard quantum mechanics, which allows to separate the dependence on angular coordinates from radialones. The basic idea is to write down distribution amplitudes as a sum of contributions from di erent conform al spins. For a given spin, the dependence on the momentum fractions is xed by the symmetry. To specify the function, one has to x the coe cients in this expansion at some scale; conform al invariance of the QCD Lagrangian then guarantees that there is no mixing between contributions of di erent spin to leading logarithm ic accuracy. For leading twist distributions the mixing matrix becomes diagonal in the conform al basis and the anom alous dimensions are ordered with spin. Thus, only the rst few \harm monics" contribute at su ciently large scales (for su ciently hard processes).

For higher twist distributions, the use of the conform albasis o ers a cnucial advantage of \diagonalizing" the equations of motion: since conform al transform ations commute with the QCD equations of motion, the corresponding constraints can be solved order by order in the conform alexpansion. Note that relations between di erent distributions obtained in this way are exact: despite the fact that conform al symmetry is broken by quantum corrections, equations of motion are not renorm alized and rem ain the same as in free theory.

The general procedure to construct the conform al expansion for arbitrary multiparticle distributions was developed in  $^{10;12}$ . To this end each constituent eld has to be decom posed (using projection operators, if necessary) in com – ponents with xed (Lorentz) spin projection onto the light-cone.

Each such component corresponds to a so-called quasiprimary eld in the language of conformal eld theories, and has conformal spin

where l is the canonical dimension and s the (Lorentz) spin projection.<sup>a</sup>

Multi-particle states built of quasiprimary elds can be expanded in irreducible unitary representations with increasing conformal spin. An explicit

expression for the distribution amplitude of a multi-particle state with the low – est conform al spin  $j = j_1 + \dots + j_n$  built of m primary elds with the spins  $j_k$  is

Here  $_{k}$  are the corresponding momentum fractions. This state is nondegenerate and cannot mix with other states because of conformal symmetry. Multiparticle irreducible representations with higher spin j + p;  $n = 1; 2; ..., m_{k=1}$  are given by polynomials of m variables (with the constraint  $m_{k=1}^{m}$   $_{k} = 1$ ) which are orthogonal over the weight function (5).

#### 1.2 Equations of motion

W e collect here exact operator identities which can be derived using the approach of  $^{14}$  and which present a nonlocal equivalent of the equations of motion for W ilson local operators. Taking suitable matrix elements one derives a set of relations between distribution amplitudes, which generally allow to express two-particle distributions of higher twist in terms of three-particle distributions. The corresponding relations are taken into account in the results given in later sections. The rationale for presenting the operator relations them selves is that we found them useful in practical calculations:

In all cases gauge factors are implied in between the constituent elds,

and we introduced a shorthand notation for the derivative over the total translation:

## 1.3 Meson mass corrections

The structure of meson mass corrections in exclusive processes is in general more complicated than of target mass corrections in deep inelastic scattering in which case they can be resummed using the Nachtmann variable <sup>15</sup>. For illustration, consider the simplest matrix element

We assume that  $x^2 = \frac{2}{QCD}$ , but nonzero, (u) is the twist-2 distribution amplitude and (u) describes higher-twist corrections in which we want to calculate \kinematic" contributions due to nonzero -m eson m ass.

A common wisdom tells that meson mass corrections are related to contributions of leading twist operators. Indeed, conditions of symmetry and zero traces for twist-2 local operators in ply

Expanding (16) at short distances  $x \ ! \ 0$  and comparing with (17), we nd that the same reduced matrix element gives a contribution to the twist 4

distribution amplitude

which is the direct analogue of N achtmann's correction for deep inelastic scattering.

The result in (19) is, how ever, incomplete. The reason is that in exclusive processes one has to take into account higher-twist operators containing full derivatives, and vacuum -to-m eson matrix elements of such operators reduce, in certain cases, to powers of the meson mass times reduced matrix elements of leading twist operators. For the case at hand, write<sup>14</sup>

where we used Eq. (15) to arrive at the last line. In the matrix element one can make the substitution  $e^2$  m<sup>2</sup>. Expanding, again, at short distances, and comparing with the similar expansion of (16) we get an additional contribution to M<sub>n</sub><sup>()</sup> so that the corrected version of (19) becomes

A ssum ing the asym totic form of the leading-twist distribution amplitude ,  $(u) = 6u(1 \quad u)$ , so that  $lhO_n ii = 3=[2(n + 1)(n + 3)]$ , this equation for m om ents is easily solved and gives

where we have included the \genuine" twist 4 correction (term in  $_4$ ) due to the twist 4 quark-gluon operator, see de nition in Eq. (43). The QCD sum rule estimate is  $_4$  0:15<sup>17</sup>, so that the meson mass e ect onto the twist 4 distribution function is by a factor two larger than the \genuine" twist 4 correction. This is an important di erence to deep inelastic scattering, where the target mass corrections are small.

The present discussion is still oversimplied and does not provide with a complete separation of meson mass elects. The major complication arises

because of contributions of operators of the type

Such operators can be expressed in terms of operators with extra gluon elds, which m eans, conversely, that certain combinations of qGq operators reduce to divergences of leading twist operators and give rize to extra m eson m ass correction terms. The corresponding corrections to twist 4 distributions involve, how ever, higher-order contributions in the conform al expansion of the distribution amplitudes of leading twist and do not a ect the result in (22), which is to leading conform al spin accuracy. A detailed analysis will be presented in 5.

# 2 Summary of chiral-even distributions

Two-particle quark-antiquark distribution amplitudes are de ned as matrix elements of non-local operators on the light-cone<sup>4</sup>:

which can be checked by comparing the two sides of the dening equations in the limit  $z \ ! \ 0$  and using the equations of motion. We keep the (tiny) corrections proportional to the u and d quark-masses m<sub>u</sub> and m<sub>d</sub> to indicate the SU (3)-breaking corrections for K - and -mesons.

The distribution amplitudes V and A are of twist-3, while the rest is twist-4 and we have not shown further Lorentz structures corresponding to twist-5 contributions<sup>b</sup>.

Calculation of exclusive amplitudes involving a large momentum -transfer reduces to evaluation of meson-to-vacuum transition matrix elements of nonlocal operators, which can be expanded in powers of the deviation from the light-cone. To twist-4 accuracy one can use the expression for the axial-vector matrix element in (25) as it stands, replacing the light-cone vector z by the actual quark-antiquark separation x. For the vector operator, the light-cone expansion to twist-4 accuracy reads:

The terms in and <sup>e</sup> specify quark-mass corrections in twist-3 distributions induced by the equations of motion. The numerical values of these and other coe cients are listed in Tables 1 and 2°. Note that we neglect SU (3)-breaking e ects in twist-4 distributions and in gluonic parts of twist-3 distributions. In Fig. 1 we plot the leading-twist distribution amplitude  $_k$  for , K and m esons.

## 3 Sum m ary of chiral-odd distributions

There exist four di erent two-particle chiral-odd distributions<sup>4</sup> de ned as
