NEW TESTS FOR NEUTRINOS IN LOW ENERGY SOLAR EXPERIMENTS

ABSTRACT

We show how future solar neutrino experiments in the low energy region can be used to test novel neutrino properties. Information on the Majorana nature or neutrino magnetic moments can be extracted from the observation of electron anti-neutrinos from the Sun and the measurement of an azimuthal asymmetry in the total number of events, respectively.

1. Low -energy electron Anti-neutrinos from the Sun

Finding a signature for the M a jorana nature of neutrinos or, equivalently, for the violation of lepton number in Nature is a fundamental challenge in particle physics 1 . All attempts for distinguishing D irac from Majorana neutrinos directly in laboratory experiments have proven to be a hopeless task, due to the V-A character of the weak interaction, which implies that all such elects vanish as the neutrino mass goes to zero. We suggest an alternative way in which one might probe for the possibility of L-violation which is not directly induced by the presence of a Majorana mass. Although, Majorana masses will be required at some level, but the quantity which is directly involved is the transition amplitude for $_{\rm R}$! $_{\rm R}$ conversions in the Sun.

Here we propose to probe for the possible existence of L-violating processes in the solar interior that can produce an $_{\rm e}$ component in the neutrino ux. The idea is that, even though the nuclear reactions that occur in a normal star like our Sun do not produce directly right-handed active neutrinos ($_{\rm a}$) these may be produced by combining the chirality-ipping transition $_{\rm eL}$! $_{\rm aR}$ with the standard chirality-preserving MSW conversions $_{\rm eL}$! $_{\rm L}$ through cascade conversions like $_{\rm eL}$! $_{\rm R}$! $_{\rm eR}$ or $_{\rm eL}$! $_{\rm L}$! $_{\rm eR}$. These conversions arise as a result of the interplay of two types of mixing 2 : one of them, matter-induced avour mixing, leads to MSW resonant conversions which preserve the lepton number L, whereas the other is generated by the resonant interaction of a Majorana neutrino transition magnetic moment with the solar magnetic eld 3 . This violates the L symmetry by two units (L = 2) and is an explicit signature of the Majorana nature of the neutrino 4 .

We consider neutrino-electron scattering in future underground solar neutrino experiments in the low-energy region, below the threshold for $_{\rm e}$ + p! n + e $^{\rm +}$, such as HELLAZ $^{\rm 5}$ or BOREXINO $^{\rm 6}$. They will have low energy thresholds (100 keV and 250 keV, respectively). BOREXINO is designed to take advantage of the

characteristic shape of the electron recoilenergy spectrum from the ${}^{7}\text{Be}$ neutrino line, while the HELLAZ experiment is intended to measure the fundamental pp neutrinos.

The complete expression for the di erential cross section of the weak process e! e, as a function of the electron recoil energy T, in the massless neutrino limit, can be written as (see for instance ref. 7)

where h (a;b) a^2+b^2 (1 T=!) abm_eT=! 2 and $g_{eL}=\sin^2_W+0.5$, $g_{aL}=\sin^2_W$ 0.5 (a = ;) and $g_{e}=\sin^2_W$ are the weak couplings of the Standard M odel, and ! is the energy of the income ing neutrino. The parameter P_e in the equation above is the survival probability of the initial left-handed electron neutrinos, while P_e , P_a and P_a are the appearance probabilities of the other species, that may arise in the Sun as a result of the processes e_{eL} ! e_{eR} , e_{eL} ! e_{eR} , e_{eL} ! e_{eR} , respectively. These parameters obey the unitarity condition P_e (!)+ P_e (!)+ P_a (!)+ P_a (!)= 1. In general they are obtained from the complete 4 4 Ham iltonian describing the evolution of the neutrino system 4. In the L-violating processes one has in general all four contributions shown in eq. (1). In contrast, in the case where lepton number is conserved (like in M SW conversions), the solar neutrino ux will consist of neutrinos, so only the rst and third terms in eq. (1) contribute. It follows that the dierential cross section will be dierent in the case where $_{\rm e}$'s from the Sun get converted to electron $_{\rm e}$'s. Is it possible to measure this dierence in future neutrino experiments?

The relevant quantity to be measured in neutrino scattering experiments is the energy spectrum of events, namely

where d =dT is given in eq. (1) and N_e is the number of electrons in the ducial volume of the detector a . The sum in the above equation is done over the solar neutrino spectrum, where i corresponds to the dierent reactions i=pp, 7Be , pep, 8B ::; characterized by an integral ux ${}_{0i}$ and a dierential spectrum ${}_i(!)$ (for neutrinos coming from two-body reactions, one has ${}_i(!) = (! \ !_i)$). The lower limit for the neutrino energy is $!_{min}(T) = (T + \frac{P}{T^2 + 2m_e T}) = 2$, while the upper limit $!_{max}$ corresponds to the maximum neutrino energy. In order to take into account the nite resolution in the measured electron recoilenergy, we perform a Gaussian average of the cross section, indicated by h::i in eq. (2). For further details, see ref. 8 .

We have calculated the averaged energy spectrum of events for the two experiments in the $sim\ ple$ case where the parameters P_i do not depend on the neutrino




Fig. 1. Energy spectrum of events corresponding to 7Be solar neutrinos for the BOREXINO experim ent. The upper line corresponds to the case where one has no neutrino conversions ($P_e=1$). When electron anti-neutrinos are present in the solar ux the results are the lines labeled with excludated for the indicated value of P_e and the corresponding amount of a. The cases of e!; and e!; are the lower lines with labels a and a, respectively.

energy. Here we present our results for BOREXINO in gure 1, where one can see that it is possible to distinguish the case with $_{\rm e}$ considering the behaviour of the cross section for low energies. It is the slope of the measured spectrum the key for recognizing the presence of $_{\rm e}$'s in the solar neutrino ux, and correspondingly the presence of L-violating processes which can only exist if neutrinos are M a jorana particles.

The shortcom ing of the above discussion is that we have neglected the energy dependence of the physical parameters P_i . One must calculate the averaged cross section using analytical expressions for $P_i = P_i(!)$. However, since the ⁷Be neutrinos are mono-energetic, whatever the mechanism that produces the decit is, their survival probability will take on a constant value $P_e(!_{Be})$. Therefore one can apply directly the results we have obtained for constant P_i for the range of electron recoil energy where the contribution of ⁷Be neutrinos dominates. In ref. ⁸ we give a discussion of the experimental uncertainties.

There are however stringent bounds on the presence of solar $_{\rm e}$'s in the high energy region ($^8{\rm B}$). These would interact within the detector through the process $_{\rm e}$ + p! n + e $^+$. This process, which has an energy threshold of E = m $_{\rm n}$ m $_{\rm p}$ + m $_{\rm e}$ ' 1:8 M eV , has not been found to occur in the K am iokande experiment nor in the very recent data from Super-K am iokande 9 . A lso the results from LSD are negative 10 .

As we show in ref. 8 for the speci c scenario presented in ref. 2 , the co-existence of a suppressed production of high-energy $_{\rm e}$'s and a sizeable ux of anti-neutrinos at energies below $1.8~{\rm M~eV}$ can be easily understood theoretically. The resonance in the $_{\rm eL}$! $_{\rm eR}$ conversions can lie in the energy region below $1~{\rm M~eV}$ (relevant for HELLAZ or BOREXINO) provided that the neutrino parameters have reasonable values, so that the conversion probability is small for energies! $1~{\rm M~eV}$. Therefore the anti-neutrino ux would be hidden in the background and therefore unobservable in Super-K am iokande. Our conclusion is that neutrino conversions within the Sun can result in partial polarization of the initial uxes, in such a way as to produce a sizeable $_{\rm e}$ component without con icting present Super-K am iokande data. The observation of $_{\rm e}$'s from the Sun in future neutrino experiments in the low energy region could lead to the conclusion that the neutrinos are M a jorana particles.

2. Neutrino magnetic moments and low-energy solar neutrino-electron scattering experiments

In this section we are concerned with a particular e ect in neutrino-electron scattering for solar neutrinos which possess a D irac m agnetic m om ent or M a jorana transition m agnetic m om ents, that we will note generically as . The latter is especially interesting rst of all because M a jorana neutrinos are m ore fundamental and they arise in most models of particle physics beyond the standard model , and because its e ects can be resonantly enhanced in matter , providing one of the most attractive solutions to the solar neutrino problem . A nother practical advantage in favour

of M a jorana transition moments is that, in contrast to D irac-type $\,$'s, these are substantially less stringently constrained by astrophysics 12 .

For longitudinally polarized neutrinos the weak interaction and the electrom aqnetic interaction amplitudes on electrons do not interfere, since the weak interaction preserves neutrino helicity while the electrom agnetic does not. As a result the cross section depends quadratically on . However if there exists a process capable of converting part of the initially fully polarized e's, then an interference term arises , as pointed out e.g. in ref. 13. This term depends on the angle proportional to between the component of the neutrino spin transverse to its momentum and the m om entum of the outgoing recoil electron. Therefore the number of events measured in an experiment exhibits an asymmetry with respect to the above de ned angle. The asymmetry will not show up in terrestrial experiments even with stronger magnetic elds, since only in the Sun the neutrino depolarization would be resonant and only in the solar convective zone one will nd a magnetic eld B extended over such a wide a tenth of the solar radius). At earth-bound experiments the helicity-ip could be caused only by the presence of a neutrino mass and is therefore small.

Barbieri and Fiorentini considered 13 the conversions $_{\rm eL}$! $_{\rm eR}$ as a result of the spin- $_{\rm ip}$ by a toroidal magnetic eld in the solar convective zone. They showed that the azim uthal asymmetry could be observable in a real time solar 8B -neutrino experiment and as large as 20% for an electron kinetic energy threshold of 5 MeV, xing the $_{\rm e}$ survival probability $P_{\rm e} = 1$ =3 (as was suggested by the Homestake experiment) and the maximal Dirac magnetic moment allowed by laboratory experiments,

 $^{\prime}$ 10 10 B. On the other hand, Vogel and Engel 14 em phasized that if an asymmetry in the scattering of transversally polarized neutrinos exists, recoil electrons will be emitted copiously along the direction of the neutrino polarization in the plane orthogonal to the neutrino momentum. However both 13 and 14 overestimated the asymmetry by an approximate factor two. First, the weak term in eq. (11a) of ref. 13 is a factor 2 less than our eq. (3) and the interference term coincides with ours, while in ref. 14 the interference term (their eq. (A9)) is a factor 2 bigger than our eq. (4).

Here we show the sensitivity of planned solar neutrino experiments in the low energy region (! \leq 1 MeV) to the azim uthal asymmetries that are expected in the number of neutrino events, arising from the electromagnetic-weak interference term.

We consider the neutrino {electron scattering process $_{e}(k_{1}) + e(p_{1}) ! _{e}(k_{2}) + e(p_{2})$ when the initial ux of neutrinos is not completely polarized due to transitions induced by non-zero transition magnetic moments in the Sun. This includes both conventional Dirac-type magnetic moments as well as Majorana transition moments. The dierential cross section d = dT d, where T is the recoil energy of electrons and the azimuthal angle (see g. 2), can be written as a sum of three terms: weak, electromagnetic and interference. Let us rst assume that only the Dirac $_{e}$ magnetic moment exists, $_{e}$. For ultra-relativistic neutrinos the expressions for the weak,




Fig. 2. Coordinate system conventions.

electrom agnetic and interference term s are

where all parameters are the same as in eq. (1). The interference term is proportional to 13 , and $^{\sim}$? is the transverse component of the neutrino polarization spin vector with respect to its momentum. It has the value j $^{\sim}$? $^{\downarrow}$ 2 (P_e(1 P_e))¹⁼². This interference term depends on the azimuthal angle as dened in gure 2, since eq. (4) may be rewritten using

where $T_{max} = 2!^2 = (m_e + 2!)$ is the maximum electron recoil energy.

If neutrinos are M a prana particles they can only possess transition m agnetic moments, that we will denote $_{12}$. For simplicity we assume the case of CP conservation. For de niteness, moreover, we consider the case of two neutrino species, $_{\rm e}$ and $_{\rm e}$, with positive relative CP-parity 4 . The three terms of the dierential cross section will include an electrom agnetic term (same as in eq. (3) with $_{12}$), a weak term that consists of the rst and fourth terms in eq. (1), and an interference term which diers from eq. (4),

since in the Majorana case there are two active neutrino species. Here the mixed transversal polarization vector is given 7 by $\mathbf{j^{e}}_{2}^{e} \neq 2$ $\mathbf{P_{e}}(1 - \mathbf{P_{e}})$.

The relevant quantity to be measured in neutrino-electron scattering experiments capable (like HELLAZ) of measuring directionality of the outgoing exist is the azimuthal distribution of the number of events, namely

where d = dT d is the total cross section and all param eters are the same as in eq. (2). It has been written as a sum of three terms, where n^w , n^{em} and n^{int} account for the weak, electrom agnetic and interference contributions, respectively. The dierential azim uthal asymmetry is dened as

where $\,^0$ is m easured with respect to the direction of B $\,$, which we will assume to be along the positive x-axis. One can also de ne an integrated asymmetry

Here we have de ned A, the maximum integrated asymmetry measurable by the experiment, which is manifestly positive.

It is important to emphasize that HELLAZ willbe the rst experiment potentially sensitive to azimuthal asymmetries since the directionality of the outgoing example measured. The angular resolution is expected to be and 2, substantially better than that of Super-Kam iokande. Notice also that the Cerenkov cone dened by the angle is very narrow for high-energy boron neutrinos, as one can see from eq. (5). In contrast, for pp neutrino energies accessible at HELLAZ (T_{max} of 0.26 MeV, T_{th} of 0.1 MeV) we estimate that can be as large as 48.

Let now discuss how the measurement of the azim uthal asymmetry could be carried out considering that B is constant over a given period of time but its direction is unknown. One should collect events in every—bin, where—is dened with respect to some arbitrarily chosen axis, and then take for dierent—0s the ratio A (0) which should show a sin—0 dependence with a maximum equal to A. This maximum will show us the angle—0 which corresponds to the direction of B—0 if B—goes along the positive x axis). Then the direction of B—is measured together with A. Since this direction may change in time the experiment should accumulate events until the maximum sin—like correlation in A () is found and then start a new event




Fig. 3. M axim alintegrated azim uthal asym m etry A for Boron neutrinos and pp neutrinos, respectively, as a function of the electron recoilenergy threshold W $_{\rm e}$ for the param eters shown. Solid line: D irac case ($_{\rm eL}$! $_{\rm eR}$). D ashed line: M a jorana case ($_{\rm e}$!)

counting period when such correlation goes away due to the changing \mathcal{B} . Therefore the value of A could be extracted by perform ing a series of such measurements.

The rst plot of g. 3 corresponds to the values of A in the situation described in refs. $^{13;14}$. From our calculations the asym m etry in the D irac case is in fact approximately a factor two smaller than predicted by 13 . The asym m etry in the M a jorana case for equivalent , as expected, is smaller since there are two active neutrino species so that the weak term in the denom inator in eq. (9) becomes larger. The second plot shows the same kind of analysis for pp-neutrinos, which will be measured by an experiment like HELLA Z 5 , where both the recoil electron energy T and the recoil electron scattering angle should be measured with good precision. The Multi-Wire-Chamber in HELLA Z should be sensitive to the azimuthal angle , measuring the number of events in {bins. We use a more realistic survival probability for Resonant Spin-Flavour Precession (RSFP) in the Sun (Pe = 0.5) and for = 3 10^{11} B. This gives the maximum expected asymmetry and seems phenomenologically reasonable in order to convert the initial solar electrons of the RSFP scenario.

The dependence of A on the value of deserves a more detailed analysis. It follows that A is maximized when the pure weak term is equal to the electromagnetic contribution. This fact favours pp-neutrinos with respect to high energy neutrinos, since such a maximum is reached for lower values precisely due to the lower energies considered. In fact, for an energy threshold of recoil electrons W $_{\rm e}=0.1$ M eV (HELLAZ) the maximal asymmetry is reached for '3 10 11 $_{\rm B}$ in contrast to B oron neutrinos, for which it is reached for '10 10 $_{\rm B}$. This way one sees that gs. 3 describe approximately the most favourable situation for measuring A .

The fact that dA = 0 is reached for equal number of weak and electrom agnetic events seems to suggest that the measurement of the total number of events would be enough to rule out the values of to which the asymmetry is sensitive. However, it is not so if one bears in mind that background events from other processes always increase the total number of events and one needs to perform a good background subtraction to get some information on the term. In addition if the background is isotropic in the azimuthal plane, it should be absent in the numerator of A and then if some asymmetry is measured one can ascribe it to an elect of Note also that the asymmetry is a ratio of event numbers. Thus global normalization uncertainties (e.g. total neutrino uxes) completely drop out from the asymmetry, and energy-dependent uncertainties will be reduced since the same integrations appear in the numerator and in the denominator. For all these reasons the asymmetry measurement is preferred. It suers of course from the dependence on the unknown magnetic eld direction, but sensitivity to that information is also of potential astrophysical interest.

We have considered 15 how the above results are a ected by the energy dependence expected in the conversion probability in the simplest realization of the RSFP scenario 3 where vacuum mixing is neglected. It can be shown that the dependence of P_e on the neutrino energy leads to somewhat smaller azim uthal asymmetries, but qualitatively

very sim ilar to those obtained if the energy dependence is neglected.

We conclude that measuring azim uthal asymmetries in future low-energy solar neutrino-electron scattering experiments with good angular resolution should be a feasible and illuminating task. It should provide useful information on non-standard neutrino properties such as magnetic moments, as well as on solar magnetic elds.

Note we have assum ed $_{\rm e}$ m agnetic moments of the order 10 11 $_{\rm B}$, which is consistent with present laboratory experiments and, apart from possible e ects in red giants, a also compatible with astrophysical limits 12 , given the present uncertainties in these considerations. Finally, note that the future ITEP-M innesota experiment is planned for searching = $_{\rm B}$ down to 3 10^{11} with reactor anti-neutrinos 16 , while the LAMA experiment 17 will use a powerful isotope neutrino source.
