## D ynam ical screening aw ay from equilibrium : hard photon production and collisional energy loss

W e investigate the production rate for hard real photons and the collisional energy loss in the quark-gluon plasm a away from chem ical equilibrium. A pplying the H ard-T herm al-Loop resum m ation scheme a way from equilibrium, we can show that Landau dam ping provides dynam ical screening for both ferm ion and boson exchange present in the two quantities.

#### I. IN TRODUCTION

Considerable e ort is being made to experimentally realize a new decon nement phase of hadronic matter, the quark-gluon plasma, in ultra-relativistic heavy ion collisions. In parallel important progress has also been made in the theoretical understanding of this phase which is central for the experimental detection to be successful. For an equilibrated system in particular the Hard-Thermal-Loop (HTL) resummation scheme [1{3] allows to take consistently into account collective e ects on the soft scale within (resummed) perturbation theory [4]. A number of important quantities, with unscreened mass singularities preventing any prediction within a xed orderperturbative calculation, can be obtained consistently in this scheme.

It has been realized that a valid comparison of theoretical predictions with experimental data should include non-equilibrium e ects beyond the simpli ed assumption of thermal equilibrium, because a fully equilibrated plasm a might not be realized. In this work we therefore explore the role of collective soft scale phenom – ena away from equilibrium and the generalization of the HTL resummation scheme. This will be done on the relevant examples of hard photon production [5{11] and the collisional energy loss [12{14] which are known to be sensitive to soft scale physics. The following discussion is based on [15,16] where further details can be found.

### II. APPROX IM AT ION SCHEME: CHEM ICAL NON-EQUILIBRIUM

Our analysis assumes the scenario of chemical nonequilibrium that has been found to be a relevant, tractable approximation to the pre-equilibrium dynam ics in heavy ion collisions [17{20]. It is inspired from an analysis of the equilibration process in a heavy ion collision where the elastic m om entum exchange is found to be much more e ective than the inelastic particle production. W hile local therm alequilibrium m ight therefore be quickly established the parton densities are predicted to stay away from equilibrium through to the hadronization of the plasm a [18]. Thereby the undersaturation of quarks will be especially dramatic as has been form ulated in the hot-glue scenario [17]. Following [18] and as in [10,21] we parameterize this scenario in terms of factorized fugacities inserted into the distributions which are assumed to be equilibrated in momentum space

W e do not attempt to investigate the m icroscopic nonequilibrium evolution of the distribution functions in the quark-gluon plasma, the evolution of the fugacities (X) on the large scale X of inelastic processes is taken as input e.g. from [18]. On this background we calculate the emission and absorbtion rates for probes external to the plasm a such as electrom agnetic rates and the collisional energy loss of a projectile. For the description of the dynamics we rely on the Closed-Time-Path formulation of statistical eld theory [22,23]. The simpli ed scenario of chem ical non-equilibrium allows for the standard approxim ation scheme of neglecting any but the second order non-equilibrium correlations and perform ing a gradient expansion [23{26], here in terms of the large scale X  $1=q^{4}T$  of the inelastic particle production. Scales fast with respect to this, in particular both the hard (1=T) and soft (1=gT); g < 1, scales involved in the HTL resumm ation scheme, can be transformed to momentum space. To lowest order in the gradients a

perturbative expansion can be set up very similar to the equilibrium case with free in medium propagators depending on the modi ed distributions Eq. (1). In terms of W igner variables (X;p):

P redictions for absorption and em ission rates as calculated in this approximation scheme will incorporate the dependence on (X) locally. As in the equilibrium situation, nite results for the real hard photon spectrum and the collisional energy loss can be expected only after resummation of leading HTL corrections. Away from equilibrium taking higher order corrections into account brings about additional terms in the perturbative expansion [27,28] which vanish due to detailed balance in the equilibrium situation. A careful analysis is therefore required in order to dem onstrate that Landau dam ping provides dynam ical screening of the singularities also away from equilibrium.

# III. SOFT FERM ION EXCHANGE IN HARD PHOTON PRODUCTION




FIG.1. D lagram s contributing to hard realphoton production in xed leading order for hard exchanged m om entum (a) and in HTL-resum m ed perturbation theory for soft exchanged m om entum (b). The parameter  $k_c$ , separating hard and soft scales is introduced in interm ediate steps of the calculation [29]

The production of hard real photons to lowest order arises from annihilation and C ompton scattering. The rate can be obtained form the absorptive part of the twoloop approximation to the photon selfenergy as shown in Fig. 1.

The exchange of a massless quark in these processes induces a logarithm ic mass singularity when calculating to xed lowest order, Fig. 1(a). In equilibrium a solution to this problem is found within the HTL resummation scheme that accounts for the fact that for soft exchanged momentum the dispersion of the exchanged particle is modiled by leading interaction elects. Within the resummed theory in particular Landau damping elects are included that dynamically screen the singularity on the soft scale  $m_q$  gT [5,6]. Away from equilibrium, in

leading order of the gradient expansion, the resummed ferm ion propagator can be written

with a rst term having the structure of the equilibrium expression and a second term being nonzero only when detailed balance is violated,  $_{12} \notin e^{p_0=T} _{21}$ . Two remarks have to be added about the modi ed structure of the propagator, Eq. (3). First we not that the nonequilibrium modi cation of the dispersion as de ned by the pole of the retarded propagator in the rst term of Eq. (3) can be absorbed into a rede nition of the soft scale param eter used in the equilibrium situation

This arises, because, as in the equilibrium analysis, the leading HTL contribution to the one loop selfenergy is found to be proportional to the radial integral used in the de nition Eq. (4) that contains the only -dependence involved. Secondly, in order to discuss the role of the extra contribution to the propagator Eq. (3) it is convenient to decom pose the expression in square brackets

into a contribution from  $=\frac{1}{2}(_{12} _{21}) = i \text{Im}_{R}$ plus a remainder  $^{+} = \frac{1}{2}(_{12} + _{21})$ . In the ferm ionic case the contribution from  $^{+}$  is found to be suppressed with respect to the dom inant HTL scale  $g^{2}T^{2}$  as set by , Eq. (4). From an explicit calculation

for soft  $p_0$  gT.W ithin the HTL resummation scheme  $^+$  can therefore be neglected in the resummed propagator Eq. (3) and with

the remaining terms are rearranged into

G iven the close analogy of this elective resummed propagator with the equilibrium expression, the remaining steps are performed in parallel with the equilibrium calculation [5,6] taking only the modiled dispersion into account. We not the rate for hard photon production to depend on the modiled scale parameter Eq. (4) that enters as a prefactor and screens the logarithmic singularity:

where the nonsingular contribution C (E ;T;  $_{q}$ ;  $_{g}$ ) has been calculated explicitly in [15].

The result Eq. (9) is independent of the separating scale  $k_c$  introduced in interm ediate steps of the calculation by matching the soft partial result with the result from a xed order calculation for hard exchanged momentum. In this context it is in portant to point out that no additional singularities are showing up away from equilibrium although at one bop order the extra term in the ferm ion propagator analogous to Eq. (3) is pinch singular on the mass shell [27]. The important observation is that for hard realphoton production the singular con guration lies only on the boundary of the available phase space that is restricted to spacelike momentum exchange to be used in the upperpart of Fig. 1 (a) follows from Eq. (3) in the one bop approximation,

There remains no explicit dependence on the distribution  $r(X;p_0)$ . A mass singularity is induced, which, however, is dynamically screened upon matching with the contribution from the soft exchange with the propagator Eq. (8).

### IV.SOFT (GAUGE) BOSON EXCHANGE { COLLISIONAL ENERGY LOSS




FIG.2. D lagram s contributing to the collisional energy loss in xed leading order for hard exchanged m om entum (a) and in HTL-resum m ed perturbation theory for soft exchanged m om entum (b).

The collisional energy loss of a propagating heavy ferm ion with mass M [13,14], which is not therm alized, is obtained from the absorptive part of the ferm ion selfenergy, i.e. from its 21-component [4]. The corresponding diagram s are shown in Fig. 2. To lowest order the loss arises from the elastic interaction with the medium constituents via the exchange of one gauge boson, Fig. 2 (a); again mass singularities are known to arise for massless photon/gluon exchange.

It is in portant to recall that the energy loss is obtained form these diagram s only upon weighting the loop integration with one extra power of the energy exchanged:

The extra power of  $p_0 = v$  distinguishes dE =dx from the interaction/dam ping rate and makes it well de ned in equilibrium within the resummed theory.

Away from equilibrium the resummed propagator for soft gauge boson-exchange has a modi ed structure sim ilar to the ferm ion propagator [30]; longitudinal and transverse components in C oulomb gauge read

The discussion follows the lines of Sec. III. The modi – cations of the dispersion relation in HTL approximation can again be absorbed into a rede nition of the plasma frequency according to

in QED. For the role of the extra term however an important di erence with the fermionic case arises. In the bosonic case the contribution from  $+ = \frac{1}{2}(_{12} + _{21})$  is found to dom inate over  $= \frac{1}{2}(_{12} - _{21}) = \text{iIm}_{R}$  for both longitudinal and transverse components [30]

and therefore cannot be neglected in general. However, both contributions have a symmetry under  $p_0$  !  $p_0$ , while is odd, <sup>+</sup> is even. G iven the additional power of  $p_0$  present in the energy loss rate the contribution of

<sup>+</sup> therefore integrates to zero in this special case as

As a result the dom inant contribution to dE =dx com es from and the corresponding term s in the resum m ed propagator rearrange into

which is similar in structure to the equilibrium expression and allows to perform the remaining steps as in [13]. A s for hard photon production no additional (pinch) singularities arise away from equilibrium for spacelike momentum exchange. For energies  $E = M^2 = T$  we not the energy loss away from equilibrium to be well de ned

with Landau damping dynamically screening the logarithm ic mass singularity. Following the calculation for the equilibrium case it turns out that the regular contribution A (v) does not depend on the fugacity factor  $_{\rm f}$ , and that it is therefore the same as discussed in [13].

The generalization for a heavy quark propagating through a QCD-plasm a is obtained [16] with the help of the expressions given in [14],

introducing the QCD coupling g and the therm algluon m ass, including the proper quark and gluon fugacities:  $m_g^2 = g^2 T^2 (g + q \frac{N_f}{6})=3$ . Because in the QCD case contributions from the scatterings o quarks and gluons in the plasm a have to be added, a dependence on q and g is found also in the regular part of Eq. (17).

### V.DISCUSSION AND CONCLUSIONS

From the results given in Eqs. (9) and (17), respectively, both the hard photon production rate and the collisional energy loss are found to be suppressed by pow – ers of the fugacity in an undersaturated plasm a that is likely to be created in a relativistic heavy ion experiment [17,18]. Taking into account the extra o -equilibrium term in the propagator there is no dependence in the nal result on the distribution of the exchanged particle that would have introduced additional powers of fugacities. In the case of the photon production rate this result is especially important phenom enologically as higher powers of the small quark fugacity could seriously question its observability. It is encouraging that both rates can be obtained consistently in perturbation theory away from equilibrium with dynamical screening occurring also for

€ 1. We argued that no additional pinch singularities [27] do arise in the quantities considered that involve spacelikem on entum exchange only. The treatment given here how ever is not applicable to quantities involving onshellm on entum exchange as e.g. virtual photon production [31{33}. Further progress in these cases requires to take consistently into account the explicit time variations in the distributions [34,35] via the inclusion of gradient term s which could be neglected in the presented cases.
