# Optim ized Perturbation Theory at Finite Tem perature Renorm alization and Nambu-Goldstone theorem in O(N) <sup>4</sup> Theory

The optim ized perturbation theory (OPT) at nite temperature (T) recently developed by the present authors is reviewed by using O (N)  $^4$  theory with spontaneous symmetry breaking. The method resum s autom atically higher loops (including the hard therm alloops) at high T and simultaneously cures the problem of tachyonic poles at relatively low T.W e prove that (i) the renorm alization of the ultra-violet divergences can be carried out system atically in any given order of OPT, and (ii) the N am bu-G oldstone theorem is satis ed for arbitrary N and for any given order of OPT.

#### I. IN TRODUCTION

N aive perturbation theory is known to break down at nite tem perature (T). The two reasons are the existence of hard therm alloops (HTL) at high T [1] and the emergence of tachyonic poles at relatively low T [2]. If one adopts self-consistent resummation methods, HTL can be summed and tachyonic poles can be removed. How - ever, most of the self-consistent methods proposed so far have di culties of renorm alization [3] and/or the violation of the Nam bu-G oldstone theorem [4] at nite T.

In this talk, we show that a new loop-wise expansion at nite T recently developed by the present authors [5] can solve these problem s.

O ur starting point is the optim ized perturbation theory (OPT) which is a generalization of the mean-eld method [6] and is known to work in various quantum systems [7]. Its application to eld theory at nite T has been rst considered by O kopinska [8] and B anerjee and M allik [9]. We further develop the idea and prove the renorm alizability and the N am bu-G oldstone (NG) theorem in O (N) <sup>4</sup> theory at nite T order by order in OPT.

The organization of this talk is as follows. In section II, we introduce a loop-wise expansion on the basis of OPT. The renormalization of UV divergences and the realization of the NG theorem in this method are also discussed. In section III, OPT is applied for the O (4)

model which is a low energy elective theory of QCD. Summary and concluding remarks are given in Section  ${\rm IV}$  .

#### II.OPT IM IZED PERTURBATION AT T $\doteqdot$ 0

A.H ard therm alloops and tachyonic poles

Let us illustrate, by using <sup>4</sup> theory, the reason why the naive perturbation theory at nite T breaks down;

We rst consider the case  $^2 > 0$ . The lowest order selfenergy diagram Fig.1 (A) is O ( $T^2$ ) at high T. How ever, Fig.1 (B) is O ( $T^2 - T$ ). Furtherm ore, higher powers of T = arise in higher loops; e.g. the n-loop diagram in Fig.1 (C) is O ( $^n T^{2n-1} = ^{2n-3}$ ). Thus, the validity of the perturbation theory breaks down when T > = because the higher order diagram s are larger than lower ones. Therefore, one should at least resum cactus diagram s to get sensible results at high T [2]. Physics behind this resum mation is the well-known D ebye screening mass in the hot plasm a.

W hen  $^2<0$  and the system has spontaneous sym metry breaking (SSB), the naive perturbation show sanother problem . The tree-level mass m $_0\,$  in this case is de ned as

where (T) is the therm al expectation value of . As T increases, decreases. Then  $m_0^2$  becomes negative (tachyonic) even before the critical temperature  $T_c$  is reached. If this happens, the naive perturbation using the tree-level propagator does not make sense and certain resummation should be carried out [10]. Note that, for T <  $T_c$ , there is no reason to believe that only the cactus diagrams shown in Fig.1 are dominant; there exists a three-point vertex  $^3$  which is not negligible for T (T).

### B.Problem s in self-consistent resum m ation m ethods

Self-consistent resum m ation m ethod is a procedure to improve perturbation theory at nite T and to avoid the problem s in Sec. IIA. However, the m ethod has other di culties [3,4].

In the naive perturbation theory, there arises no new UV divergences at T  $\stackrel{\bullet}{\bullet}$  0 because of the natural cuto from the Boltzm ann distribution function. Therefore, all the UV divergences at nite T are canceled by the counter term s prepared at T = 0 [11].

On the other hand, in self-consistent m ethods at T  $\stackrel{\bullet}{\bullet}$  0, the situation is not that simple: In fact, the tree-level propagators have T-dependent m ass (such as m (T) in the above) which contains higher loop contributions through the self-consistent gap-equation [3]. This leads to a necessity of T-dependent counter terms which are sometimes introduced in ad hoc ways.

A nother problem is the violation of the Nambu-Goldstone (NG) theorem : In many of the self-consistent m ethods, resum m ation with keeping symmetry is a non-trivial issue, and the NG theorem is often violated.

#### C.New resummation method

For theories with SSB, bop-expansion rather than the weak-coupling expansion is relevant, since one needs to treat the them all elective potential. Therefore, we developed an improved bop-expansion at nite T for the purpose of resummation [5]. Them ethod keeps the renormalizability and guarantees the N am be-G oldstone theorem order by order at nite T.

In the following, we divide our resummation procedure into three steps and apply it to  $\ ^4$  theory. The case for 0 (N)  $\ ^4$  theory will be discussed in Sec. IIE.

W e start with the therm all e ective action with an expansion parameter  $\$  ":

If we explicitly write h in eq.(3), it appears as  $\frac{1}{h} \begin{pmatrix} R_{h}=T\\ 0 \end{pmatrix}$   $d^4xL$ . Therefore, the loop-expansion by at nite T does not coincide with the h expansion. The expansion by should be regarded as a steepest descent evaluation of the functional integral.

Start with a renormalized Lagrangian with counter term  $\boldsymbol{s}$

Here we have explicitly written the argument  $^2$  in L for later use. The  $\overline{MS}$  scheme with the dimensional regularization is assumed in (4). Just for notational simplicity, the factor  $^{(4 n)}$  to be multiplied to is omitted ( is the renorm alization point).

The c-num ber counter term D  $^4$ , which was not considered in [9], is necessary to make the therm all elective potential nite. A loo, it plays a crucial role for renorm alization in OPT as will be shown in Sec. IID.

The renorm alization constants are completely xed at T = 0 and  $^2$  > 0, in which A;B,C and D are expanded as

Note that (i) the coe cients (a  $_1$ ;b $_1$ ;c $_1$ ;d $_1$ ) are independent of <sup>2</sup>, since we use the mass independent renormalization scheme, (ii) the UV divergences in the symmetry broken phase (<sup>2</sup> < 0) can be removed by the same counter terms determined for <sup>2</sup> > 0 [12,13], and (iii) A;B;C and D are independent of T by de nition.

The relations of A;B;C and D with the standard renorm alization constants are A = Z 1, B = Z Z 1 and C = Z Z<sup>2</sup> 1, where Z's are dened by  $_0 = \frac{P}{Z}$ ,  $_0 = Z$  and  $_0^2 = Z$  <sup>2</sup> with su x 0 indicating unrenorm alized quantities.

## Step 2

Rewrite the Lagrangian (4) by introducing a new mass parameter m<sup>2</sup> following the idea of OPT [7]:

This identity should be used not only in the standard mass term but also in the counter terms [14], which is crucial to show the order by order renormalization in OPT:

A,B,C and D in  $L_c$  were already determ ined in Step 1. On the basis of eq.(7), we de ne a \modi ed" loopexpansion in which the tree-level propagator has a mass  $m^2 + r^2 = 2$  instead of  $2 + r^2 = 2$ . Major di erence between this expansion and the naive one is the following assignment,

The physical reason behind this assignment is the fact that relects the elect of interactions. If one makes an

assignment,  $m^2 = 0$  (<sup>0</sup>); = 0 (<sup>0</sup>), the modied bopexpansion immediately reduces to the naive one.

Since eq.(7) is simply a reorganization of the Lagrangian, any G reen's functions (or its generating functional) calculated in the modi ed loop-expansion should not depend on the arbitrary massm if they are calculated in all orders. How ever, one needs to truncate perturbation series at certain order in practice. This inevitably introduces explicit m dependence in G reen's functions. P rocedures to determ ine m are given in Step 3 below.<sup>1</sup>

To nd the ground state of the system, one should look for the stationary point of the therm alge ective potential de ned by V ('<sup>2</sup>) =  $[^2 = \text{const:}]_{0}^{1-T} d^4x$ . As mentioned above, V calculated up to L-th loops V<sub>L</sub> ('<sup>2</sup>;m) has explicit m-dependence. Thus the stationary condition reads

where derivative with respect to ' does not act on m by de nition. Eq.(11) gives a stationary point of  $V_{\rm L}\,$  for given m .

#### Step 3

The nalstep is to nd an optimal value of m by im - posing physical conditions a la Stevenson [15] such as the following.

(a) The principle of m inimal sensitivity (PMS): this condition requires that a chosen quantity calculated up to L-th loops (O  $_{\rm L}$ ) should be stationary by the variation of m:

(b) The criterion of the fastest apparent convergence (FAC): this condition requires that the perturbative corrections in  $O_L$  should be as sm all as possible for a suitable value of m.

where lis chosen in the range,  $1 \quad l \quad L$ .

The above conditions reduce to self-consistent gap equations whose solution determ ine the optim al param – eterm for given L. Thus m becomes a non-trivial function of ', and T. This together with the solution of (11) completely determ ine the therm al expectation value (T) h i as well as the optim alparam eterm (T). Through this self-consistent process, higher order term s in the naive loop expansion are resum ed.

The choice of O $_{\rm L}\,$  in Step 3 depends on the quantity one needs to improve most. To study the static nature of the phase transition, the thermal e ective potential V $_{\rm L}$  (' $^2$ ;m) is most relevant. Applying the PMS condition for V $_{\rm L}\,$  reads

which gives a solution m = m('). This can be used to improve the elective potential at nite T as  $V_L('^2;m) ! V_L('^2;m('))$ . Also, (T) and m(T) are obtained by solving (11) together with (14). In this case, the following relation holds:  $dV('^2;m('))=d'j_= = @V('^2;m('))=@'j_=$ .

To improve particle properties at nite T, it is more e cient to apply PM S or FAC conditions directly to the two-point functions. W e will use FAC for the one-loop pion self-energy in Section III to show its usefulness.

#### D.Renorm alization in OPT

We now prove the order by order renormalization in OPT.Let us rst rewrite eq.(7) as

The UV divergences arising in the perturbation theory are classi ed into two classes: The divergences in the G reen's function generated by L ( $;m^2$ ), and the divergences obtained by the multiple insertion of (1=2)<sup>2</sup> to the G reen's function generated by L ( $;m^2$ ).

Since we use the symmetric and mass independent renormalization scheme (such as the  $\overline{M}$  S scheme), any divergences in the rst class are renormalized solely by the coe cients A, B, C and D in L (; <sup>2</sup>). Although T-dependent divergences appear because of the T-dependent \resum ed" mass m<sup>2</sup>(T), they are properly renormalized away since the counter terms (such as Bm<sup>2</sup><sup>2</sup>, Dm<sup>2</sup> and Dm<sup>4</sup>) also acquires T-dependence through m<sup>2</sup>(T). In other words, the divergences arising from the resum ed propagator is rem oved by the resum ed counter terms. (See also, footnote 1.)

The divergences in the second class can be shown to be rem oved by the last three counter terms in (15). (Note that B and D are already xed in Step 1, and we do not have any freedom to change them .) This is obviously related to the renorm alization of composite operators. In fact, the standard m ethod [16] tells us that necessary counter term s are written as

<sup>&</sup>lt;sup>1</sup> One may generalize Step 2 by adding and subtracting  $_{0}(@_{0})^{2}$ ,  $_{1}(@_{i})^{2}$  and <sup>4</sup> with  $_{0}$ ,  $_{1}$  and being nite parameters to be determined by the PM S or FAC conditions (see Step 3). The renormalizability can be also shown to be maintained in this case. However, we will concentrate on the simplest version ( $_{0,1} = = 0$ ) in the following discussions.

Here Z  $_2$  is the renorm alization constant for the com posite operator  $^2$ , and rem oves the divergence in Fig 2 (A).  $_2$  and  $_1$  are necessary to rem ove the overall diver-

 $_2$  and  $_1$  are necessary to remove the overall divergences in Fig.2(B) and in Fig.2(C), respectively.

Now, one can prove that (16) coincides with the last three terms in (15):

The overall divergence of the vacuum diagram with no external-legs is removed by the c-number counter term  $D m^4$  in L (; $m^2$ ). Therefore, the last two equations in (17) are obtained as

Eq.(17) show sclearly that all the necessary counterterms s in OPT are supplied solely by the original Lagrangian L(;  $^2$ ). Thus, we can carry out renormalization order by order even within the self-consistent m ethod. For m ore detailed proof of the relations (17), see Appendix A of ref. [5].

# Three com m ents are in order here:

- (i) Because the renorm alization is already carried out in Step 2, one obtains nite gap-equations from the beginning in Step 3. Our procedure \resum m ation after renorm alization" has many advantages over the conventional procedure \resum m ation before renorm alization" where UV divergences are hoped to be canceled after in posing the gap-equation. The di erence between the two is prom inent especially in higher order calculations.
- (ii) The decom position (6) should be done both in the mass term and the counter terms. This guarantees order by order renormalization in ourmodied loop-expansion in any higher orders. (In ref. [9], the renormalizability was checked up to the two-loop level in the <sup>4</sup> theory at high T.) On the other hand, if one keeps the original counter term  $(1=2)B^{-2-2} + D^{-4}$  without the decom position (6), L-loop diagrams with L > M must be taken into account to remove the UV divergences in the M loop order. This is an unnecessary complication due to the inappropriate treatment of the counter term s. (See e.g. ref. [17] which encounters this problem).

(iii) As far as we stay in the low energy region far below the Landau pole, we need not address the issue of the triviality of the <sup>4</sup> theory [18]: Perturbative renorm alization in OPT works in the same sense as that in the naive perturbation.

### E.Nambu-Goldstone theorem in OPT

The procedure and the renormalization in OPT discussed above do not receive modi cations even if the Lagrangian has global symmetry. For  $O(N)^{4}$  theory, one needs to replace and <sup>2</sup> by  $\sim = (_{0}; _{1}; _{N}; _{1})$  and  $\sim^{2}$  respectively in all the previous form ulas.

In the symmetry broken phase of such theory, the N am bu-G oldstone (NG) theorem and massless NG bosons are guaranteed in each order of the modi ed bop-expansion in OPT for arbitrary N. To show this, it is most convenient to start with the thermal e ective potential V ( $^{2}$ ). By the de nition of the elective potential, V ( $^{2}$ ) has manifest O (N) invariance if it is calculated in all orders.

In OPT, V calculated up to L-th loops  $V_L(\mathcal{K}^2;m)$  has also manifest O (N) invariance, because our decomposition (6) used in (7) does not break O (N) invariance. Once  $V_L$  has invariance under the O (N) rotation ( $'_i ! '_i + i^a T^a_{ij} '_j$ ), the immediate consequence is the standard identity:

with T  $^{\rm a}$  being the generator of the O (N ) symmetry. Eq.(21) is valid for arbitrary L , m and N .

At the stationary point where the lh.s. of (21) vanishes, there arises massless NG bosons for  $T^{a}_{jk}$ '  $_{k} \notin 0$ , since the r.h.s. of (21) is equal to  $D^{-1}_{ij}(0)T^{a}_{jk}$  where  $D_{ij}(0)$  is the M atsubara propagator at zero frequency and momentum calculated up to L-th bops. Thus the existence of the NG bosons is proved independent of the structure of the gap-equation in Step 3.

Now, let us show an example of the unjusti ed approxim ations leading to the breakdown of the NG theorem. Suppose that we make a general decomposition such as

with  $m_{ij}^2 \notin m^2_{ij}$ . This leads to an O (N) non-invariant e ective potential, and the relation (21) is not guaranteed in any nite orders of the loop-expansion. For example, when the O (N) symmetry is spontaneously broken down to O (N 1), one may be tempted to make a decomposition  $m_{ij}^2 = m_0^2$  (i = j = 0),  $m_{ij}^2 = m_1^2$  (i = j  $\notin$  0), and  $m_{ij}^2 = 0$  (i  $\notin$  j) to impose self-consistent conditions for the radialm ode and the NG mode. How ever, the e ective potential does not have O (N) symmetry in this case and eq.(21) does not hold. III. A P P L IC A T IO N T O O (4) M O D E L

Let us apply OPT to the O (4) m odel. The model shares common symmetry and dynamics with QCD and has been used to study the real-time dynamics and critical phenomena associated with the QCD chiral transition [19,20].

#### A . P aram eters at T = 0

The O(4) model reads

A, B, C and D in the one-loop order are

where  $\frac{1}{n} = \frac{2}{4 n} + \log(4)$ , with being the Euler constant.

W hen SSB takes place ( $^{2} < 0$ ), the replacement !

+ in eq.(23) leads to the tree-levelm asses of and ;

The expectation value at T = 0 is determined by the stationary condition for the standard elective potential  $QV(^{\prime}) = Q'_{j} = 0$ .

Later we will take a special FAC condition in which m<sup>2</sup> deviates from <sup>2</sup> only at T  $\epsilon$  0, so that the naive loop-expansion at T = 0 is valid. The renorm alized couplings <sup>2</sup>; and h can thus be determ ined by the renorm alization conditions in the naive loop-expansion at zero T such as (i) m = 140 M eV, (ii) f = 93 M eV, and (iii) - scattering phase shift [19].

Instead of (iii), one m ay adopt m  $^{\text{peak}}$  (the peak position of the spectral function in the channel). We take this simplified condition with three possible cases: m  $^{\text{peak}}$  = 550 M eV, 750 M eV and 1000 M eV.m  $^{\text{peak}}$  = 550 M eV are consistent with recent re-analyses of the - scattering phase shift [21].

We still have a freedom to choose the renormalization point . Instead of trying to determ ine optimal by the renormalization group equation for the elective potential [22], we take a simple and physical condition  $m_0 = m = 140 \text{ MeV}$ . This choice has two advantages: (a) O ne-bop pion self-energy (k<sup>2</sup>) vanishes at the treemass; (k<sup>2</sup> = m<sup>2</sup>) = (k<sup>2</sup> = m<sup>2</sup>) = 0, and (b) the spectral function in the channel starts from a correct continuum threshold in the one-bop level. Resultant parameters are sum marized in TABLE I.

In Fig.3, the spectral functions and at T = 0, namely the T = 0 limit of eq.(26) de ned below, are shown as a function of  $\overline{s}$   $\frac{1}{2}$   $k^2$ . In the channel, there are one particle pole and a continuum starting from the threshold  $\frac{p}{s_{th}} = m_0 + m_0$ .  $\frac{p}{s_{th}}$  is the point where the channel + opens. In the channel, the spectral function starts from the threshold  $2m_{p} = 280$  MeV and shows a broad peak centered around  $\overline{s} = m^{peak}$ . The large width of is due to a strong -2 coupling in the linear model. The corresponding -pole is located far from the real axis on the com plex s plane.

Here we show the de nition of the spectral function at nite  ${\tt T}$  :

with h i being the therm alexpectation value.

# B.Application of OPT

Now let us proceed to Step 2 in OPT and rewrite eq.(23) as

Since  $(= m^2 ^2)$  is already a one-loop order, we have neglected the terms proportional to B , D  $^2$  and D which are two-loop or higher orders.

W hen SSB takes place (~ ! ~ +  $\sim$ ), the tree-level m asses to be used in the m odi ed loop-expansion read

Since m<sup>2</sup> will eventually be a function of T, the treem asses running in the loops are not necessary tachyonic at nite T contrary to the naive loop-expansion (see the discussion in Sec. IIA). The thermal e ective potential V ( $\sim$ ;m ) is calculated in the standard manner except for the extra terms proportional to . The e ective potential in the one-loop level reads

where E  $k^2 + m_0^2$ . A lthough this has the similar structure with the standard free energy in the naive loop-expansion, the coe cient of the rst term in the rhs. of (30) is <sup>2</sup> instead of m<sup>2</sup>. This is because we have extra mass-term proportional to in the one-loop level. The stationary point is obtained by

Since the derivative with respect to does not act on m, this gives a solution as a function of T and m. By imposing another condition on m (Step 3), one eventually determines both and m for given T.

# C.FAC condition for m $^2$

To resum the hard thermal bops, the PMS condition for the e ective potential requires 2-loop calculation, while the FAC condition for the self-energy requires only 1-loop calculation. Therefore, we adopt the latter condition here to determ in  $m^2$ .

The retarded self-energy <sup>R</sup> (de ned by  $\mathbb{D}^{R}$ ] <sup>1</sup> = s m  $_{0}^{2}$  <sup>R</sup>) is related to the 11-component of the 2 2 self-energy in the real-time form alism [24];

Here <sup>11</sup> (!; k; T) is a part having explicit T-dependence through the Bose-E instein distribution, while <sup>11</sup> (!; k) is a part having only im plicit T-dependence through m (T) and (T). In the one-loop level, <sup>11</sup> can be calculated only by the 11-com ponent of the free propagator,

with  $n_B = [e^{! = T} \quad 1]^{1}$ .

One-loop diagrams in OPT for <sup>11</sup> are shown in Fig. 4. Their explicit forms are given in [5]. The NG theorem discussed in Sec. IIE can be explicitly checked by comparing eq.(31) and the inverse pion-propagator at zero momentum  $\mathbb{D}^{R}(0;0;T)$ ]<sup>1</sup>.

Let us impose the FAC condition on  $\ ^R$ . Since we chose a renorm alization condition m  $_0$  = m = 140 M eV at zero T, one m ay be tempted to adopt the following condition at nite T:

;However, eq.(34) does not guarantees that m<sup>2</sup> is real, since the lh.s. of eq.(34) receives an imaginary part due to the Landau dam ping. To avoid this problem, we take a hybrid condition:

N ote that the external energy is set to be zero in the T - dependent part.<sup>2</sup> Because the second term in the lh.s. vanishes at T = 0, the solution of eq.(35) at T = 0 becomes

Therefore, the FAC condition (35) does not spoil the naive-loop expansion at T = 0.

At high T ( (T)  $^\prime$  0), the following analytic solution is obtained as far as T  $^2$   $\,$  m  $^2;$

which implies that the D ebye screening mass at high T is properly taken into account. For realistic values of in TABLE I, the condition  $T^2 m^2$  is not well satis ed and eq.(35) should be solved num erically.

For interm ediate values of T, eq.(35) can e ectively sum not only the contributions from the diagrams in Fig.4(a;b;h;i), but also from those in Fig.4(c;d;j). Thus, OPT can go beyond the cactus approximation which sums only the diagrams in Fig.4(a;b;h;i).

Two remarks are in order here.

(i) By eq.(35), only the k-independent part of the self-energy is resum ed. If one needs to resum k-dependent part too, one must introduce m<sup>2</sup> which depends both on T and k and im pose k-dependent FAC or PM S conditions [23].

 $<sup>^2</sup>$ Eq. (35) can be form ulated in a covariant way by introducing the four-vector n characterizing the heat bath. The rst term of the equation is only a function of  $k^2$  because it is T independent. The second term is a function of  $k^2$  and k n . Therefore, the condition reads  $^{11}$  ( $k^2$  =  $m_0^2$ ) +  $^{11}$  ( $k^2$  = 0; k n = 0; T) = 0:

(ii) In ref. [17], it has been studied the convergence properties of the free energy at high T with a variational condition equivalent to the PM S condition here. Although the approach has a problem of renorm alization as we have already mentioned, the result is suggestive in the sense that the optim ized bop expansion has much better convergence properties than the loop expansion based on the hard therm al loops [25]. Better understanding of the convergence properties both in PM S and FAC conditions is an important future problem.

### D.Behavior of m (T), m $_0$ (T) and (T)

In Fig.5 (A) the tree-levelm assess in eq.(29) and m<sup>2</sup> (T) are shown for m <sup>peak</sup> (T = 0) = 550 M eV.m<sub>0</sub><sup>2</sup> (T) is not tachyonic and approaches to m<sup>2</sup> (T) in the symmetric phase. This con rm s that our resummation procedure cures the problem of tachyons in Sec. IIA.

The solid line in Fig.5(B) shows the chiral condensate (T) obtained by minimizing the elective potential with m  $^{\text{peak}}$  (T = 0) = 550 M eV. (T) decreases uniform ly as T increases, which is a typical behavior of the chiral order parameter at nite T away from the chiral limit.

A swe approach the chiral limit (h! 0 or equivalently m! 0), (T) develops multiple solutions for given T, which could be an indication of the rst order transition. The critical value of the quark mass  $m_q^{crit}$ : below which the multiple solutions arise is

where we have used G ell-M ann-O akes-R enner relation [26] to related the pion mass with the quark mass.  $m_q^{\rm phys:}$  is the physical light-quark mass corresponding to  $m_q^{\rm phys:} = 140$  MeV. The critical temperature for  $m_q^{\rm crit:}=m_q^{\rm phys:} = 0.08$  is  $T_c$  ' 170 MeV. The behavior of (T) form (T = 0) = 30 MeV (just below the critical value m crit:) is also shown by the dashed line in Fig.5(B) for com parison.

#### E.Chirallim it

In Fig.6 the chiral condensates are shown for the chiral lim it (m = 0 M eV) and for m = 10 M eV. The phase transition looks like a rst order in these cases. The existence of the multiple solutions of the gap equation for the O (4) model in the mean-eld approach has been known for a long time [27]. Our analyses con m this feature within the fram ework of OPT.

However, this rst order nature is likely to be an artifact of the mean-eld approach as discussed in the second reference in [27]: the higher bops of massless and almost massless are not negligible near the critical point, and they could easily change the order of the transition. In fact, the renorm alization group analyses as well as the direct num erical simulation on the lattice indicate that the O (4) model has a second order phase transition [28].

W e have also studied the free energy as a function of T near the chiral limit and found that it has a discontinuity near the critical point. This is another sign that the rst-order nature is an artifact of the approximation. (Remember that, the free energy must be a continuous function of T irrespective of the order of the phase transition.)

### F.Spectral function at nite T

A some of the non-trivial applications of OPT, we show, in Fig.7, the spectral functions of and at nite T de ned in (26).

The gure shows that the spectral function of , which does not show a clear resonance at T = 0, develops a sharp enhancement near 2 threshold as T approaches  $T_c$ . This is due to a combined e ect of the partial restoration of chiral symmetry and the strong 2 coupling. This is an typical example of the softening (or the precursor of the critical uctuation) associated with the partial restoration of chiral symmetry [29]. The experimental relevance of this softening has been examined in the context of the low-m ass diphoton production [5].

In the -channel, a continuum develops by the scattering with therm alpions in the heat-bath; + <sup>therm al</sup>!

. Because of this process, the pion acquires a width

50M eV at T = 145 M eV, while the peak position does not show appreciable modi cation. They are in accordance with the N am bu-G oldstone nature of the pion.

### IV.SUMMARY

W e have shown that the optim ized perturbation theory (OPT) developed in [5] naturally cures the problem s of the naive loop-expansion at nite T, namely, the break-down of the naive perturbation at T  $T_c$  (due to the hard thermal loops) as well as at T <  $T_c$  (due to the tachyonic poles).

Furtherm ore, OPT has several advantages over other resum m ation m ethods proposed so far:

F irst of all, the renorm alization of the UV divergences, which is not a trivial issue in other m ethods, can be carried out system atically in the bop-expansion in OPT. This is because one can separate the self-consistent procedure (Step 3 in Sec.  $\Pi C$ ) from the renorm alization procedure (Step 2 in Sec.  $\Pi C$ ).

Secondly, the Nambu-Goldstone (NG) theorem is fulled in any give order of the loop-expansion in OPT for arbitrary N in O(N)  $^4$  theory. This is because OPT

preserves the global sym m etry of the e ective potential in each order of the perturbation.

There are m any directions where OPT at nite T m ay be applied. The phase transition in O (4) <sup>4</sup> theory as well as the dynam ical critical phenom ena near the critical point are one of the m ost interesting problems to be exam ined further. The PM S condition for the e ective action will be suitable for this purpose. OPT m ay also have relevance to develop an improved perturbation theory for gauge theories in which the weak coupling expansion is known to break down in high orders [30].




FIG.2. D iagram swhich contain UV divergences as a result of the multiple insertion of  $(1=2)^{-2}$ . (A) corresponds to a single insertion with two external lines. (B) and (C) have no external lines with a single insertion and a double insertion, respectively.




FIG.3. Spectral functions at T = 0 in the channel (A) and in the channel (B) for  $m^{\text{peak}} = 550 \text{ M eV}$ , 750 M eV and 1000 M eV.




FIG.5. (A) M asses in the tree-level  $m_0$  (T) and  $m_0$  (T) shown with left vertical scale, and the mass parameter  $m^2$  (T) with the right vertical scale. (B) (T) for  $m_0$  (T = 0) = 140M eV and 30 M eV with  $m^{\text{peak}}$  (T = 0) = 550 M eV.




FIG.6. (T) for  $\texttt{m}^{\texttt{peak}}$  (T = 0) = 550 M eV with <code>m = 0 M eV</code> and <code>m = 10 M eV</code> .




FIG.7. Spectral function in the channel (A) and in the channel (B) for T = 50;120;145 M eV with  $m^{\text{peak}}(T = 0) = 550 \text{ M eV}$ .
