M agnetic C atalysis and O scillating E ects in the N am bu $\{$ Jona-Lasinio M odel at N onzero C hem ical P otential 1

Phase structure of the four dimensional Nambu { Jona-Lasinio model has been investigated in two cases: 1) in nonsimply connected space-time of the form $R^3 \ S^1$ (space coordinate is compactified and the length of the circle S^1 is L) with nonzero chemical potential and 2) in M inkowski space-time at nonzero values of ;H, where H is the external magnetic eld. In both cases on phase portraits of the model there are in nitly many massless chirally symmetric phases as well as massive ones with spontaneously broken chiral invariance. Such phase structure leads unavoidably to oscillations of some physical parameters at L! 1 or H! 0, including magnetization, pressure and particle density of the system as well as quark condensate and critical curve of chiral phase transitions. Phase transitions of 1st and 2nd orders and several tricritical points have been shown to exist on phase diagrams of the model.

1. Introduction ³

The concept of dynam ical chiral sym m etry breaking (DCSB) plays an essential role in elementary particle physics and quantum eld theory (QFT). In QFT this phenomenon is well observed in Nambu { Jona-Lasinio (NJL) type models { four-dimensional models with four-fermionic interactions [3, 4]. The simplest one is presented by the Lagrangian

(In order to apply large N expansion technique we use here N -ferm ionic version of the model.)

Since there are no closed physical systems in nature, the in uence of dierent external factors on the D C SB mechanism is of great interest. In these realms, special attentions have been given to analysis of the vacuum structure of the N JL type models at nonzero temperature and chemical potential [5, 1], in the presence of external (chromo-)magnetic elds

[6, 7, 8], with allowance for curvature and nontrivial space-time topology [9, 2]. Combined action of external electromagnetic and gravitational elds on DCSB elect in four-ferm ion eld theories were investigated in [10, 11].

In the present paper we consider the phase structure and related oscillating e ects of the four dimensional Nambu { Jona-Lasinio model in two cases: 1) in nonsimply connected space-time of the form R^3 S^1 (space coordinate is compactified) with nonzero chemical potential and 2) in M inkowski space-time at nonzero values of ;H , where H is the external magnetic eld.

1.1 N JL m odel at 60.

First of all let us prepare the basis for investigations in following sections and consider phase structure of the model (1) at 60 in M inkowski space-time.

Recall som e well-known vacuum properties of the theory (1) at = 0. The introduction of an auxiliary Lagrangian

greatly facilitates the problem under consideration. (In (3) and other formulae below we have om itted the ferm ionic index k for simplicity.) On the equations of motion for auxiliary bosonic elds $_{1;2}$ the theory (3) is equivalent to the (1) one.

From (3) it follows in the leading order of 1=N -expansion:

Introducing in (4) Euclidean metrics (p_0 ! ip_0) and cutting o the range of integration (p^2 $\,$ ^2), we obtain:

The stationary equation for the e ective potential (5) has the form:

Now one can easily see that at $G < G_c = 4^{-2} = ^2$ eq. (6) has no solutions apart from = 0. Hence, in this case ferm ions are massless, and chiral invariance (2) is not broken.

If $G > G_c$, then Eq. (6) has one nontrivial solution $_0(G;) \in O$ such that $F(_0) = O$. In this case $_0$ is a point of global minimum for the potential $V_0()$. This mean that spontaneous breaking of the symmetry (2) takes place. Moreover, fermions acquire mass $M = _0(G;)$.

Let us now imagine that > 0 and temperature T $\in 0$. In this case one can not expected potential V_T () if the mesure of integration in (4) is transformed according to a rule




FIG 1 Phase portrait of the N JL m odel at nonzero and for arbitrary values of ferm ionic mass M . Phases B and C are massive nonsim metric phases, A is chirally sim metric phase. Here $_{2c}=M$, $_{1c}=\frac{q}{\frac{1}{2}M^2\ln(1+^2=M^2)}$, M $_{2c}==(2.21:::)$, M $_{1c}$ is the solution of the equation $_{1c}^2M$ $_{1c}=2=(4e)$. In the phase B particle density in the ground state is equal to zero. However, in phase C particle density is not zero.

It follows from (8) that in the case $G < G_c$ and at arbitrary values of them ical potential chiral sym m etry (2) is not broken. However, at $G > G_c$ the model has a rich phase structure, which is presented in the Fig.1 in terms of and M . (At $G > G_c$ one can use the fermionic mass M as an independent parameter of the theory. Three quantities G, M and are connected by the Eq. (6).) In this Figure the solid and dashed lines represent the critical curves of the second—and rst-order phase transitions, respectively. Futhermore, there are two tricritical points and , two massive phases B and C with spontaneously broken chiral invariance as well as the sim metric massless phase A on the phase portrait of the NJL model (detailed calculations of the vacuum structure of the NJL model one can nd in [1]).

2. Phase structure of the NJL model at 6 0 and in the R³ S¹ space-time

It is well-known that uni ed theory of all forces (including gravitation) of the nature is not constructed up to now. Since in early Universe the gravity was su ciently strong, so one should take it into account, many physicists study quantum—eld theories in spacetimes with nontrivial metric and topology. At this, NJL model is the object of special attention (see the review [10]), because the idea of dynamical chiral symmetry breaking is the underlying concept in elementary particle physics. There is a copious literature on this subject [9, 10, 11, 13]. In particular, the investigation of four-ferm ion theories in the space-time of the form $R^d = S^1 = S$ of great interest [13]. The matter is that such space-time topology occurs in superstring theories, in description of C asim in type elects and so on.

In the present section the NJL m odel in the R 3 S 1 space-time and at $\ \in \ 0$ is considered since great amount of physical phemomena take place at nonzero particle density, i.e. at nonzero chemical potential. Here space coordinate is compactified and the circum ference S 1 has the length L. For simplisity we study only the case with periodic boundary conditions: (t; x + L; y; z) = (t; x; y; z):

2.1 Phase structure

In order to nd the e ective potential V $_{\rm L}$ () at $\,$ 6 0 and L $\,$ 6 1 , we need to transform the integration over p_1 in (7) into a sum m ation over discrete values p_{1n} according to a rule

The case = 0; 1=L > 0.Putting in (9) equals to zero, we obtain e ective potential V_L () (11) in the case under consideration. This function at $G > G_c$ has a global m in im um point $_0$ () > 0, which means that for all values of 0 chiral invariance of the model is spontaneously broken. Obviously, $_0$ ()! M at ! 0.

When $G < G_{c}$, $_0$ () 0 at < $_0$ and $_0$ () > 0 at > $_0$ (here $\frac{^2}{2G}$ $-\frac{^2}{8}$ $-\frac{^2}{6}$ $\frac{^2}{0}$). In the point = $_0$ there is a second order phase transition from a sym m etric to a nonsym m etric phase of the model, because at ! $_0$ +

Details of above calculations and of following ones are presented in [2].

The general case ; $\in 0$. We shall not a one-to-one correspondence between points of the plane (;) and the phase structure of initial model. It is very convinient to divide this plane into regions $!_k :$





FIG 2 Phase portrait of the R 3 S 1 NJL model at 6 0 and G $_1$ < G < G $_c$ (= 1=L). Dashed lines are critical curves of rst-order phase transition, solid lines correspond to second-order critical curves. Points a and b are tricritical ones. There is a cascade of massless sym metric phases A_k (k = 0;1;2:::).

In $!_0$ only the rst term from a series in (9) is nonzero, in $!_1$ only the rst and the second term s are nonzero and so on. In order to obtain a phase structure one should study step by step the global minimum point of the function V_L () in regions $!_0,!_1,...$ O mitting technical details we show at once resulting phase portraits at G_1 (0:917:::) $G_c < G < G_c$ (see Fig 2) and at $G_c < G < (1:225:::)G_c G_2$ (see Fig 3) as well [2].

One can see in Fig 2 only two massive nonsymmetric phases B and C. In contrast, there are in nitly many massive phases C_k (k = 0;1;:::) in Fig.3. In phase B particle density is identically zero, but in C and in all C_k phases this quantity is not zero. In both gures there are also in nitly many simmetric massless phases A_k (k = 0;1;::) of the NJL model.

The line $_0$ (0) c_n c_2 c_1 b in Fig.3 is the critical line $_c$ () of the second-order phase transitions, where chiral symmetry is restored. The $_c$ () is dened by the equation

P hase structure of N JL m odel at another values of coupling constant G is presented in [2], where one can also nd m ore detailed description of above phase portraits at $G_1 < G < G_2$.

2.1 E ects of oscillations

Now let us show that, due to a presence in a phase structure of the NJL model of cascades of massless A_k as well as massive C_k phases, one can observe oscillations of some physical parameters. We shall consider only the case $G_c < G < G_2$.

The continuous physical quantity f(x) is called as an oscillating one at x! a, if there exist a monotonically encreasing (decreasing) sequence fx_ng such that: i) x_n ! a at n! 1, ii) f(x) is a continuous function at each point x_n and iii) $f^0(x)$ is a discontinuous function at points x_n .

At zero tem perature oscillating quantity satis es, as a rule, to this de nition (see, for example, magnetic oscillations in quantum electrodynamics [14, 15]). Of course, at nonzero tem perature one can observe a more smooth behaviour of oscillating parameters. Since we shall deal with zero tem perature case only, the above cited de nition of oscillations is well suited in the fram ework of present paper.



O scillations of the critical curve $_{\rm c}$ (). Recall that $_{\rm c}$ () is the solution of the equation

(13). Evidently, inside an arbitrary region $!_k$ (see (12)) this function has the form

Last inequalities mean that at in nite set of points t_k (k=1;2;::::) the function $_c$ () is not dierentiated. A coording to the above given de nition, the critical curve $_c$ () oscillates at ! 0 or, equivalently, at L! 1 (see Fig.3).

Finally, let us present this oscillations of the $_{\rm c}$ () in a manifest form. We need the following Poisson's sum mation formula [16]:

O scillations of the ferm ionic condensate. Ferm ionic condensate is de ned as < > , and in N JL m odel it equals to < > . Since the last quantity is the global m in im um point (;) of an excrive potential, we should study nontrivial solution of the stationary equation (11). Detailed analysis of (;) was done in [2], and this quantity at M < < $_{\rm c}$ (0) and at ! 0 (L! 1) behaves as

O scillations of the particle density. Suppose, M < < $_{\rm c}$ (0). Then the therm odynam ic potential (TDP) (;) of the NJL system is equal to the value of its e ective potential at the global m in im um point (;), i.e. (;) = V $_{\rm L}$ ((;). It is well-known that therm odynam ic potential dense the particle density n(;) through the relation: n(;) = 0 (;) =0. Hence,

Using in (21) the Poisson's sum mation formula (17) [2], we see that at = constand L! 1

Oscillations of the pressure. Let us suppose that > $_{\rm c}$ (0), i.e. for su ciently large values of L the global m in im um point of the elective potential equals to zero. In this case the TDP of the model equals to V $_{\rm L}$ (0). Then, at L ! 1 the TDP (;) oscillates with frequency = (2), because it looks like [2]:

In our case the pressure in the system is de ned as p = 0 (L)=0L. Using the above expression for (;), we see that the pressure in the vacuum of the N JL m odelalso oscillates with frequency = (2).

One can interpret the case under consideration as the ground state of the NJL system, located between two parallelplates with periodic boundary conditions. The force which acts on each of plates is known as generalized Casim ir force. Evidently, this force is proportional to the pressure in the ground state of the system . Hence, at nonzero chemical potential the Casim ir force of the constrained ferm ionic vacuum is oscillates at L! 1 .

3. Phase structure of the NJL model at 6 0 and in the presence of external magnetic eld

In the present section we shall study the magnetic properties of the NJL vacuum. At = 0 this problem was considered in [6,8]. It was shown in [6] that at $G > G_c$ the chiral symmetry is spontaneously broken for arbitrary values of external magnetic eld H , and even for H = 0. At $G < G_c$ the NJL system has a symmetric vacuum at H = 0. However, if the external (arbitrary small) magnetic eld is switched on, then for all $G = G_c$ one has a spontaneous breaking of initial symmetry $G = G_c$. This is a so called elect of dynamical chiral symmetry breaking catalysis by external magnetic eld.

The brief history of this e ect is the following. First of all such property of external magnetic eld was discovered in (2+1) - dimensional Gross-Neveu (3DGN) model [17, 18]. At H = 0 there exist two phases in 3DGN model: one of which is a massless chirally invariant phase ($G < G_c$), and another one is a massive phase with spontaneously broken chiral sym m etry ($G > G_c$). However, for each value of H Θ 0 as well as for all values of the bare coupling constant G > 0 the symmetric phase is absent in a 3DGN theory, and chiral symmetry is broken down [17, 18]4. Of course, in [17, 18] a special consideration was done for the case $G < G_{CJ}$ where the magnetic eld induces the D C SB even for weakest attractive interaction between ferm ions (the magnetic catalysis of DCSB). It turns out, that external chrom om agnetic eld is also a magnetic catalyst of DCSB [19]. The in uence of temperature and chemical potential on this elect was studied in [18]-[21], where the restoration of chiral symmetry at su cienly large values of T and was predicted. Later, in [22] the explanation of this phenomenon on the basis of dimensional reduction mechanism was found in the fram ework of 3DGN model. The magnetic catalysis takes place in four-dimensional NJL model [8, 23, 24] as well as in other theories, and now it is under intensive consideration (see, e.g. [10, 25, 26] and references therein).

(A uthors of [24, 26] declare that in our paper [18] only the "fact that external magnetic eld enhances a ferm ion dynam ical mass" was established. Hence, they assert that in [18] only the case $G > G_c$ was considered. In reality, in [17, 18, 19] the action of external (chrom o-)magnetic eld on the 3D G N model was studied for arbitrary values of bare coupling constant. The spontaneous breakdown of chiral symmetry was found there for all $G = G_c$, and even the case of arbitrary small values of $G = G_c$ (the magnetic catalysis of D C SB).)

In the present section we continue the investigatuion of magnetic catalysis e ect and this $tim e turn to the consideration of the four-dimensional NJL model at H; <math>\bullet$ 0.

3.1 M agnetic catalysis at € 0

Let us recall some aspects of the problem at = 0.00 sing a well-known propertime method [27] or a momentum—space calculations [28], one can not the elective potential V_H () of the

The potential V_0 () in (24) up to in nite additive constant is equal to the function (4). Hence, the UV-regularized expression for it looks like (5).

The in nite last term in (25) contributes to the renormalization of an electric charge and magnetic eld as well, similar as it occurs in quantum electrodynamics [27].

The potential V_H () in (25) has no UV divergences, so it is easily calculated with the help of a table of integrals [29]. The nalexpression for V_H () is:

For arbitrary xed values of H; G there is only one nontrivial solution $_0$ (H) of equation (27), which is the global minimum point of V_H ().

Hence, at $G < G_c$ and H = 0 the NJL vacuum is chirally symmetric one, but arbitrary small value of external magnetic eld H induces the DCSB, and fermions acquire nonzero mass $_0$ (H) (the elect of magnetic catalysis of DCSB).

In the present paper we shall consider only the case $G < G_c$. Therein, $_0$ (H) is a monotonically increasing function versus H . A part from , at H ! 1

Now let us consider a more general case, when H \pm 0; \pm 0. In one of our prevoius papers [21] the elective potential of a 3D G N model at nonzero H, and T was obtained. Similarly, one can indicate potential in the NJL model at H; T; \pm 0:

In order to get a phase portrait of the model one should nd a one-to-one correspondence between points of (;H) plane and global minimum points of the function (33), i.e. we need to solve equation (34), nd a global minimum (;H) for potential (33), to study properties of (;H) versus (;H).

In order to greatly \sin plify this problem let us divide the plane (; H) into a set of regions $!_k$:

In the region $!_0$ only a set term is nonzero from a series in (34-35). So, one can not that for the points (;H) $2!_0$ which are above the line L=f(;H):=0 (H) g, the global

m in im um is at the point = 0. Just under the curve L the point = $_0$ (H) is a local m in im um of the potential (33), and = $_0$ (H) transforms to the global m in im um when (;H) lies under the critical curve of the rst order phase transitions = $_c$ (H), which is de ned by the following equation:

Hence, we have shown that at $>_{\rm c}$ (H) (G < G $_{\rm c}$) there is a massless symmetric phase of the NJL model (numerical investigations of (33-34) gives us the zero global minimum point for the potential $V_{\rm H}$ () in other regions ! $_{\rm 1}$; ! $_{\rm 2}$; ... as well). The external magnetic eld ceases to induce the DCSB at $>_{\rm c}$ (H) (or at su ciently small values of magnetic eld H < H $_{\rm c}$ (), where H $_{\rm c}$ () is the inverse function to $_{\rm c}$ (H)). But, under the critical curve (37) (or at H > H $_{\rm c}$ ()) due to a presence of external magnetic eld the chiral symmetry is spontaneously broken. Here magnetic eld induces dynamical ferm ion mass $_{\rm 0}$ (H), which is not -dependent value.

At last, we should remark that in the NJL model the magnetic catalysis e ect takes place only in the phase with zero particle density, i.e. at $< _{\rm c}$ (H). If $> _{\rm c}$ (H) we have symmetric phase with nonzero particle density, but here the magnetic eld can not induces D C SB .

3.2 M agnetic oscillations

In a previous case we have shown that points (;H), which are above critical curve = $_{\rm c}$ (H), correspond to the chirally sym metric ground state of the NJL model. One ferm ionic excitations of this vacuum have zero masses. At rst sight, properties of this sim metric vacuum are slightly varied, when parameters and H are changed. However, it is not so and in the region > $_{\rm c}$ (H) we have in nitly many massless symmetric phases of the theory as well as a variety of critical curves of the second order phase transitions. On the experiment this cascade of phases is identified with oscillations of such physical quantities as magnetization and particle density. Let us prove it.

It is well-known that a state of the therm odynam ic equilibrium (the ground state) of arbitrary quantum system is described by the therm odynam ic potential (TDP) , which is a value of the e ective potential in its global m in in um point. In the case under consideration the TDP (; H) at > c(H) has the form

where $_{k}=\frac{p}{2eH}$ k. We shall use the following criterion of the phase transitions: if at least one rst (second) partial derivative of (;H) is a discontinuous function at some point, then it is a point of the rst (second) order phase transition.

Using this criterion let us show that boundaries of $!_k$ regions (35), i.e. lines $!_k = f(;H)$: $= 2eH kg (k = 1;2;:::), are critical lines of second order phase transitions. In arbitrary region <math>!_k$ the TDP (38) has the form:

The equality (40) m eans that the rst derivative @=@ is a continuous function at all lines l_k . However, the second derivative $@^2=(@)^2$ has an in nite jump at each line l_k (see (41)), so these lines are critical curves of second order phase transitions. (Similarly, one can prove the discontinuity of $@^2=(@H)^2$ and $@^2=@H$ at all lines l_n .)

Let the chem ical potential be xed, i.e. = const. Then on the plane (;H) we have a line, which crosses critical lines $l_1;l_2;:::$ at points $H_1;H_2;:::$ correspondingly. The particle density n and the magnetization m of any therm odynamic system are dened by the TDP in a following way: n = 0 = 0, m = 0 = 0H. At = const these quantities are continuous functions over external magnetic eld only, i.e. n n(H); m m(H). We know that all second derivatives of (;H) are discontinuous at every critical line l_n . So, functions n(H) and m(H), continuous at the interval H 2 (0;1), have derivatives broken at in nite set of points $H_1;:::;H_k;:::.$ A coording to the denition given in section 2.1 particle density and magnetization oscillate at H! 0.

In order to present oscillating parts of n (H) and m (H) in a manifest analitic form, we shall use the technique elaborated in [15], where a manifest analitic expression was found for oscillating part of (;H) for free relativistic electron - positron gas. This technique may be used without any diculties in our case as well.

Hence, one can rewrite the TDP (38) in the following form:

(To nd (43-44) it is su cient to tend the electronic mass to zero in the form ula (19) from [15].) Functions P (x) and Q (x) in (43-44) are connected with Fresnel's integrals C (x) S (x) [30]:

The form ula (44) presents the exact oscillating part of the TDP (38) for the NJL m odel at $G < G_c$. Since in the present case the TDP is proportional to the pressure of the system , one can conclude that pressure in the NJL m odel oscillates, when H ! 0. It follows from (44) that frequency of oscillations at large values of a parameter (eH) 1 equals to 2 =2. Then, starting from (44) one can easily nd manifest expression for oscillating parts of n (H) and m (H). These quantities oscillates at H ! 0 w ith the same frequency 2 =2 and have a rather involved form , so we do not present it here.
