The chiral phase transition from the exact RG

A brief introduction is given to the concept of the e ective average action. Its dependence on the averaging or coarse graining scale is governed by an exact RG equation for which nonperturbative approximation schemes are described. This form alism is applied to the computation of the equation of state for two avor QCD within an e ective linear quark meson model. Our results allow to derive the temperature and quark mass dependence of quantities like the chiral condensate or the pion mass. A precision estimate of the universal critical equation of state for the three{dim ensional 0 (4) Heisenberg model is given. The exact RG form alism applied to the linear quark meson model is demonstrated to provide an explicit link between the O (4) universal behavior near the critical tem perature and zero quark mass on one hand and the physics at low tem peratures and realistic current quark m asses, i.e., the dom ain of validity of chiral perturbation theory on the other hand.

I.THE CHIRAL TRANSITION AND THE LINEAR QUARK MESON MODEL

The chiral phase transition is very discult to tackle analytically. The main obstacles which arise are twofold. QCD as the microscopic theory of strong interactions is formulated in terms of quarks and gluons. The IR behavior of strong interactions is, however, dominated by collective degrees of freedom like mesons. For instance, the relevant modes for the chirally broken phase are Goldstone bosons which, in QCD, are quark {antiquark bound states. Furthermore, for the relevant length scales the running gauge coupling $_{\rm S}$ is large and a perturbative treatment is questionable.

A popular way to circum vent the rst di culty is the use of e ective eld theories for the most important degrees of freedom. The most prominent example is chiral perturbation theory based on the nonlinear sigm a model [1{3}] which describes the IR behavior of QCD in terms of the Goldstone bosons of spontaneous chiral symmetry breaking. This yields a very successfule ective formulation of strong interactions dynamics form omentum scales up to several hundred MeV or temperatures of several 10 MeV. For somewhat higher scales additional degrees of freedom like the sigmameson or the light quark avors will become important and should be included explic-

itly. We will therefore rather work with an elective linear quark meson model [4{7]. Here the lightest mesonic degrees of freedom are encoded in a complex scalar eld matrix which can be thought of as a (color{neutral}) quark {antiquark composite, ab $^{-b}$ $_{L}$ a , where a; b label the N $_{f}$ light quark avors. Spontaneous chiral symmetry breaking corresponds to a scalar vacuum expectation value ab = $^{-0}$ ab with $^{-0}$ 60. For the scale{ dependent elective action which describes the interactions of the light scalar and pseudoscalar mesons with quarks we make the Ansatz

where k denotes the relevant m omentum scale in a way de ned m ore precisely below . The meson and quark wave function renormalizations, Z and Z , respectively, are now functions of k and \overline{h} is a k{dependent Yukawa coupling. The scale{dependent e ective potential is denoted as U_k .

We will assume that (1) describes the most important low energy degrees of freedom of strong interactions for scales k below a \compositeness scale" k at which the original gauge interaction of QCD becomes strong enough to trigger the form ation of the light mesonic bound states. form of the e ective average potential U_k for all values of $k\,\boldsymbol{.}$

The success of the NJL (model to describe the strong chiral dynamics at low energies (see, e.g., [10] and references therein) serves as a further support for the use of (1). Our motivation to consider the linear quark meson model as an e ective eld theory for the IR behavior of QCD is, however, not only limited to the relation of (1) to NJL (m odels. It can be dem onstrated that, sim ilarly to chiral perturbation theory, also within the scalar part of the linear quark meson model a systematic expansion of observables like m eson m asses or decay constants in powers of the light current quark m asses is possible [5]. This allows for a successful \prediction" of the light quark m ass ratios [6] and a computation of several of the ${\rm L}_{\rm i}$ coe cients of higher dim ensional operators of chiral perturbation theory [7] in good agreem ent with the results of other m ethods.

W e will restrict ourselves here to the two lightest quark avors and neglect isospin violation. Furtherm ore, we decouple the 0 and the ao isotriplet. This is justi ed by their relatively large masses and can be achieved for $N_f = 2$ in a chirally invariant manner. This leaves us with the O (4) {sym metric Gell{Mann{Levy model for the three pions and the sigm a meson coupled here, however, to the up and the down quarks (instead of the nucleons). It should be noted, though, that our justic cation for the decoupling of the omeson is less clear at nite tem perature. It has been speculated [11,12] that close to the chiral transition temperature an e ective restoration of the axial U_A (1) sym m etry m ight take place. In this case the would become degenerate with the pions even in the spontaneously broken phase. In principle this question could be address within the linear quark meson model by allowing for a nite explicitly UA (1) breaking scalar interaction term $\overline{}$ (det + det y) in the e ective average potential U_k . This would lead to a nite 0 m ass even in the chiral lim it and the tem perature dependence of the coupling $\overline{\ }$ (T) would yield the require inform ation about an approximate restoration of U_A (1) within the linear quark m eson m odel. W e leave this generalization of our model to future work.

We furtherm ore note that even within this relatively simple elective model we have to deal with strong couplings. For instance, the renormalized Yukawa coupling acquires a value h' 6 to reproduce a realistic constituent quark mass of M $_{\rm q}=$ hf =2' 300 MeV . Thus a nonperturbative method is required which we discuss next.

II. EFFECTIVE AVERAGE ACTION AND EXACT RG

The concept of the e ective average action $_{\rm k}$ is most easily introduced by considering an O (N) {symmetric scalarm odelwith real elds $^{\rm a}$ in dEuclidean dimensions and classical action S []. We denote the scale dependent generating functional for connected G reen functions as

with IR cuto scale k. Here $S_k[\]=S[\]+S_k[\]$ with $S[\]$ the classical action and

We require that the IR cuto function R_k (q^2) vanishes rapidly for $q^2 - k^2$ whereas for $q^2 - k^2$ it behaves as R_k (q^2) ' k^2 . This implies that all Fourier modes ^a (q) with momenta smaller than k acquire an elective mass

k and decouple while the high m om entum m odes of a are not a ected by R_k . The classical elds a h $^a\,i=$ W $_k$ [J]= J_a now depend on k, and the e ective average action is de ned as

In order to de ne a reasonable coarse grained free energy we have subtracted in (5) the infrared cuto piece. This quarantees that the only dierence between k and

is the e ective IR cuto in the uctuations. Furtherm ore, it has the consequence that $_k$ does not need to be convex for k>0 whereas a pure Legendre transform is always convex. (The coarse grained free energy becomes convex only for k! 0.) This is important for the description of phase transitions, in particular, rst order ones. We note that the elective average action is a continuum implementation of the Wilson {Kadano block {spin action [13,14], however, formulated here for the generating functional of 1P I G reen functions.

For choices of the ${\rm I\!R}$ cuto function ${\rm R}_k$ like

the e ective average action $_{\rm k}$ interpolates between the classical action in the ultraviolet and the full e ective action in the infrared:

The high momentum modes are very e ectively integrated out in (3) because of the exponential decay of R_k for $q^2 - k^2$. All symmetries of the model that are respected by the IR cuto $_k$ S are automatically symmetries of $_k$. Hence there is no problem incorporating chiral fermions since a chirally invariant cuto—can be formulated [15,16,6].

The dependence of $\ _k$ on the coarse graining scale k is governed by an exact renormalization group (RG) equation [17]

the mesons a thought to form within QCD. The trace
includes a momentum integration as well as a sum mation
over internal indices. The second functional derivative

denotes the exact inverse average propagator. The exact RG equation (8) allows to start with a microscopic (classical or possibly already e ective) action at som eUV scale and successively include all quantum uctuations by lowering k to zero where subsequently all physics is extracted.

Eq. (8) is a partial functional di erential equation which, in general, will be di cult to solve. Its usefulness depends crucially on the existence of systematic approximation schemes. Besides conventional perturbative or large(N expansions there are two main directions which have been explored in the literature: an expansion of the ective Lagrangian in powers of derivatives

(If one chooses $\,_0$ as the k{dependent VEV of , the series (11) starts e ectively at n = 2.) The ow equations for the 1P I n{point functions $_k^{(n)}$ are obtained by functionaldi erentiation of eq. (8). The form ation of m esonic bound states [18], which typically appear as poles in the (M inkowskian) four{quark G reen function, is most e ciently described by an expansion like (11). On the other hand, a param eterization of $_k$ as in (10) seems particularly suited for the study of phase transitions and will therefore be our choice here.

Our Ansatz for the enective average action of the linear quark meson model is provided by (1). Inserting it into the exact RG equation (8) this complicated functional dineratial equation is converted into a set of coupled ordinary and partial dineratial equations for the k {dependence of the two wave function renormalizations Z, Z, the Yukawa coupling hand the enective average potential U_k . For the sake of brevity we will not display here the full set of ownequations and refer the interested

reader to [6,8]. It is, however, illustrative to consider the ow equation for the e ective average potential as an example. With the abbreviations u (t; ~) = k $^{\rm d}$ U $_{\rm k}$ () where ~ = k $^{\rm 2}$ d Z it is given by

Here $v_d^{\ 1}$ 2^{l+1} $^{d=2}$ (d=2) and primes denote derivatives with respect to \sim . We will always use in the following N $_{\text{C}}$ = 3 for the number of quark colors and d = 4. Eq. (12) is a partial dierential equation which governs the ow of the elective average potential u(t; \sim) with k starting from a xed UV scale to k = 0. Supplemented by similar (but ordinary) dierential equations for the owlother remaining parameters $\frac{d}{dt} \ln Z$, $\frac{d}{dt} \ln Z$ and $h^2 = Z^{-1} Z^{-2} \frac{1}{h}$ it can be solved numerically on a computer.

An important nonperturbative ingredient appearing in all these ow equations and, in particular, also in (12) are so called mass threshold functions. Full denitions of all threshold functions relevant for the truncation (1) of the linear quark meson model can be found in [4]. A typical example appearing in (12) is

with P $(q^2) = q^2 + Z^{-1} R_k (q^2)$. These functions decrease m onotonically with M = k and decay $(k^2=M^2)^{n+1}$ for M where M can be seen from (12) to be a renorm alized scalarm assofthem odel. This implies that them ain e ect of the threshold functions is to cut o quantum uctuations of particles with masses M² functions therefore autom atically and sm oothly decouple m assive modes from the evolution of the system whenever k becomes smaller than the (k (dependent) mass of a particle. The relevant masses typically receive contributions from arbitrarily high powers of the coupling constants of the theory and are therefore nonperturbative in nature. In fact, this nonperturbative dependence of the ow equations on the coupling constants of the model is already manifest in (8). The second functional derivative $\begin{subarray}{l} \end{subarray} (2) generically depends on all couplings present in$ the e ective average action which therefore appear in denom inators of the beta functions for these very sam e couplings. This nonperturbative dependence of the beta functions on the couplings is an important di erence to Polchinski's exact RG equation [19]. It corresponds to a resum m ation of the contributions from in nitely m any Feynm an diagram salready at the level of the beta functions. It is the main reason that nonperturbative problem s like the computation of critical exponents (see below) can be carried out in a straightforward way.

Furtherm ore, in the $NJL\{lim\ it\ the\ e\ ective\ average\ potential\ U_k\ is\ a\ purely$ quadratic function of with a positive mass squared co-1=G where G is the four{ferm i coupling of the NJL {model. We will be somewhat more general here and allow for a non {vanishing by small scalar wave function renormalization Z (k) 1 at the compositeness scale. Moreover, we will assume that the elective average potential is almost quadratic for k = k. More precisely, we take a starting function U_k (; y) which has its absolute m in im um at the origin = y = 0 but is otherwise unrestricted. The two remaining initial conditions can be freely chosen as Z(k) = h(k) = 1. The condition on the e ective average potential im plies that the evolution of the system starts at k in the chirally sym m etric regim e. C learly, because of quark uctuations with a large renormalized Yukawa coupling, the scalar m ass squared term will decrease with k and nally turn negative, therefore spontaneously breaking chiral symm etry. This typically happens at scales k $_{\rm SB}$ ' 400 M eV well above OCD. This may serve as a qualitative justication for the neglect of con nem ent e ects in this as well as in the lim iting NJL (model: The only degrees of freedom in the model which experience con nement directly are the two light quark avors. Yet, they acquire a constituent m ass of the sam e order as k_{SB} before k gets too close to OCD. They will therefore decouple from the evolution of the mesonic system before con nement e ects start to modify the quark propagator signi cantly. The sm allness of Z (k) implies that all m esons have large renormalized masses near kand therefore decouple e ectively. The model is thus dominated by quark uctuations for the beginning of its k{evolution. As a consequence, the ow equations exhibit an approximate partial IR xed point not far below k [6,8]. More precisely, except for the meson mass term all scalar self interactions contained in Uk divided by appropriate powers of the renormalized Yukawa coupling rapidly approach xed points and alm ost all inform ation about the initial conditions at k is washed out. This implies an enormous predictive power of the exact RG analysis of the

linear quark meson model which goes far beyond the chi-

ralW ard identities and has been successfully tested [6,8].

There are only three unknown parameters left in our

m odel which have to be xed using phenomenological input: the (bare) scalar mass \overline{m}_k at k as the only relevant initial condition, the compositeness scale k itself and the average light current quark mass m°. Using f = 93 MeV, M = 135 MeV and a constituent mass M $_{\text{q}}$ = 300 MeV as input we ndeg, k '600 MeV.

IV.CHIRAL PHASE TRANSITION AT NON {VAN ISH IN G TEM PERATURE

The introduction of nite tem perature in the exact RG formalism is straightforward. Since we are working in 4d Euclidean space time, at nite T the 4d momentum integral im plicitly contained in the trace in (8) is replaced in the standard way by a 3d integration tim es a M atsubara sum . Consequently, all scalar and ferm ion degrees of freedom are substituted by in nite towers of Matsubara m odes with increasing T (dependent masses. Technically, one can treat T as an external param eter and evolve the e ective average action (1) for each value of T from k to k = 0 using (8). In this context it is important that the initial conditions at k for the RG ow discussed above are practically insensitive to T (e ects up to tem peratures of approximately 170M eV [8]. It is crucial that the decoupling of massive modes through threshold functions also works for M atsubara m asses. For instance, eq. (13) is now replaced by

Using P (q^2) $q^2 + Z^{-1} R_k (q^2)$ we see that the squared scalar mass M 2 is e ectively replaced in (14) by the M atsubara m asses M 2 + (21 T) 2 , 12 \mathbb{Z} . The threshold functions therefore automatically decouple all massive M atsubara modes as k is lowered and the model is dimensionally reduced in a smooth way. This procedure yields, for instance, the full e ective potential as a function of , T and the external source | and therefore the equation of state (U (h i;T)=(= | which contains the T (dependence of various observables. In g. 1 we show the chiral condensate as a function of $T=T_c$. Lines (a), (b), (c), (d) correspond to m (T = 0) = 0;45M eV;135M eV;230M eV, respectively. For each pair of curves the lower one represents the full T {dependence whereas the upper one shows for comparison the universal scaling form of the equation of state for the O (4) Heisenberg model. We see a sharp second orderphase transition in the chiral lim it (this claim will be substantiated further below by dem onstrating the appropriate critical behavior near T_c).




FIG. 1. The chiral condensate as a function of $T = T_c$.

For non {vanishing quark masses this changes into a sm ooth crossover which becomes smoother for increasing m. The values for the respective (pseudo) critical tem peratures are given in table I. It is remarkable that T_c for the largest pion mass, computed within this very simple e ective model, is quite close to the result of current full two avorQCD Monte Carlo simulations perform ed for com parable quark m asses [20]. W e consider this as an indication that ourm odelyields indeed even quantitatively a reasonable description of the chiral transition. This hold for non {universal as well as for universal properties of the transition as will be demonstrated below. This claim is further substantiated by the following consideration: Because of the relatively large sigm a mass [6,8], for low tem peratures the linear quark meson model is well approximated by the nonlinear sigma model. In fact, (T) curve rather accurately agrees with that our of chiral perturbation theory for T < 60 M eV as shown qure 2. Here the solid line displays the exact RG result for vanishing average current quark mass $m^2 = 0$ whereas the dashed line shows the corresponding result of three{bop chiral perturbation theory [21,22] On the other hand, in the vicinity of T_c the universalbehavior of the model sets in which is independent of the details of the e ective action used in our approach and also accurately described by our method as demonstrated below.





FIG. 2. The chiral condensate as a function of $T = f^{(0)}$ in comparison with the result of chiral perturbation theory. Here $f^{(0)}$ denotes the pion decay constant for m = 0.

In order to demonstrate our ability to compute the complete temperature dependent elective meson potential we plot in gure 3 @U (T)=@R as a function of the renormalized eld variable R = (Z =2)^{1-2} for dierent values of T. The rst curve on the left corresponds to T = 175 M eV. The successive curves to the right dier in temperature by T = 10 M eV down to T = 5 M eV. One nicely observes the convexity of the potential even deep in the spontaneously broken phase, i.e. for small enough temperatures. This property of U is rather dicult to reproduce correctly in perturbation theory.

The e ective potential U(R;T) also contains the necessary information to compute the renormalized masses

(or rather inverse spatial correlation lengths) of the pions and the sigm am eson. These are obtained from U as second derivatives with respect to the appropriate scalar

eld components. Our results for the T (dependence of these two quantities are plotted in gures 4 and 5, respectively, for three dierent values of M (T = 0).




FIG.4.m as a function of T.




FIG.5.m as a function of T.

The solid lines in both cases correspond to the realistic value $\hat{m}=\hat{m}_{\rm phys}$ whereas the dotted line represents the situation without explicit chiral sym metry breaking, $\hat{m}=0$. The intermediate dashed lines are computed for $\hat{m}=\hat{m}_{\rm phys}=10$. We note that, even for the case of the physical current quark mass, m is to a good approximation a monotonically increasing function of T for all three quark masses. This implies, in particular, that for two light quark avors there is no long pion corre-

lation length in thermal equilibrium. This is interesting in view of recent speculations [23,24] that such long correlation lengths might lead to spectacular experimental signatures in heavy ion collision experiments due to the form ation of large regimes of a disoriented chiral condensate. A further interesting result is the dip in the T {dependence of the sigm a mass. For vanishing tem perature the sigm a decays predom inantly into two pions making it extremely wide through the large scalar self(interaction. From gure 5 we see that for increasing tem perature the phase space for this decay decreases until at tem peratures around 100 M eV this decay becomes kinem atically im possible. One would therefore expect to see a strong T (dependence of the sigm a decay widths at least in therm alequilibrium.

V.UNIVERSAL CRITICAL BEHAVIOR

In addition to the non{universal results discussed above also universal properties of the second order phase transition are described accurately by the exact RG method. Using the equation of state allows to substantiate the claim that the chiral transition in the chiral $\lim_{n\to\infty} \frac{1}{n} = 0$ is indeed of second order and to compute the associated critical exponents. Table II shows our results which correspond to the critical exponents of the three{dim ensional 0 (4) {Heisenberg model. Our results are denoted by \ERG " whereas \M C " labels the exponents obtained by lattice simulations [25]. The agreem ent is within a few percent except for the anomalous dimension. The latter deviation can be understood at least qualitatively as a consequence of the rather crude approximation of the momentum dependence of the scalar propagator in (1). In fact, if the rst non{trivial order of the derivative expansion in the scalar sector of the m odel is completed by including in the Ansatz (1) a term

Y ()@ @ the values of the critical exponents for general O (N) {m odels can be seen to im prove [26].

Yet, the exact RG method is even capable of computing the full W idom scaling form of the equation of state. In g. 6 a comparison of our results, denoted by \ERG", with results of other methods for the scaling function of the three{dimensional O (4) Heisenberg model is shown (for notation see [8]). The constants B and D specify non{universal amplitudes of the model. The curve labeled by \MC" represents a to lattice M onte Carlo data [27]. The second order epsilon expansion [28] and mean eld results are denoted by \ " and \MF", respectively. Apart from our results the curves are taken from [27].




FIG .6. The critical equation of state for the 3d O (4) (H eisenberg m odel.

We should emphasize, perhaps, that these universal results by no means prove that two avor QCD is in the universality class of the 3d 0 (4) (sym m etric Heisenberg model. As we pointed out before there is the possibility that the axial U_A (1) sym m etry m ight be e ectively restored at high temperatures in which case one would rather expect a U_L (2) U_R (2) { sym m etric behavior near the chiral transition. Our results rather con m that the exact RG m ethod is capable of com puting highly nonperturbative quantities like critical exponents or the scaling form of the equation of state with good accuracy. Assum ing that the axial U_A (1) sym m etry remains su ciently broken even at high T we would then expect our results to be in good qualitative and quantitative agreem entwith the universal as well as the non {universal properties of the chiralphase transition of full two avorQCD. This is based on the fact that ourm ethod provides a sm ooth link between two tem perature regim es where the properties of strongly interacting matter are well understood:

low tem peratures where chiral perturbation theory is expected to yield a sound description of the dynam ics of the Goldstone modes

tem perature in the vicinity of I where the universal critical behavior of the model sets in and the system becomes independent of almost all the details of the underlying microscopic description.

The plots 1 and 2 demonstrate that the intermediate range of temperature, where in principle sizeable quantitative deviations from full two avor QCD are possible, is not very large.
