PROBING M IN IM AL SUPERGRAVITY AT THE CERN LHC FOR LARGE tan

Abstract

For large values of the m in im al supergravity m odel parameter tan , the tau lepton and the bottom quark Yukawa couplings become large, leading to reduced m asses of -sleptons and b-squarks relative to their rst and second generation counterparts, and to enhanced decays of charginos and neutralinos -leptons and b-quarks. We evaluate the reach of the CERN LHC pp collider for supersym m etry in the m SUGRA m odelparam eter space. We nd 2000 GeV can be probed with just 10 fb 1 of 1500 integrated lum inosity for tan values as high as 45, so that m SUGRA cannot escape the scrutiny of LHC experiments by virtue of having a large value of tan . We also perform a case study of an m SUGRA model at tan = 45 \sim_1 and ψ_1 ! \sim_1 with 100% branching fraction. In this case, at least within our simplistic study, we show that a di-tau mass edge, which determines the value of m $_{\mathfrak{S}}$ m $_{\mathfrak{S}}$, can still be reconstructed. This inform ation can be used as a starting point for reconstructing SUSY cascade decays on an event-by-event basis, and can provide a strong constraint in determining the underlying model parameters. Finally, we show that for large tan there can be an observable excess of leptons, and argue that signals m ight serve to provide new information about the underlying model fram ework.

I. IN TRODUCTION

The minimal supergravity model (mSUGRA) [1] provides a well-motivated and economical realization the M inim al Supersymmetric Standard Model [2], or MSSM. In mSUGRA, supersymmetry is broken in the \hidden sector" which consists of elds which couple to the elds of the MSSM only gravitationally. Thus, SUSY breaking is communicated to the visible sector M SSM elds via interactions of gravitational strength. The technical assum ption of m in im ality im plies that kinetic terms for matter elds take the canonical form; this assumption, which is equivalent to assuming an approximate global U (n) symmetry between n chiral multiplets, leads to a common mass squared m $_0^2$ (de ned at a high scale M_{GUT} $M_{P lanck}$) for all scalar elds, and a com m on trilinear scalar coupling A_0 for all A param eters. These param eters, which determ in ethe sparticle-particle mass splitting in the observable sector, are taken to be of similar magnitude as the weak scale, M $_{\rm weak}$. In addition, m otivated by the apparently successful gauge coupling unication in the MSSM, one usually adopts a com m on value m $_{1=2}$ for all gaugino m asses at the scale M $_{\rm G\,U\,T}$ ' 2 10^{6} G eV . For sim plicity, it is commonly assumed that in fact the scalar masses and trilinear terms unify at M $_{\rm GUT}$ as well. The resulting elective theory, valid at energy scales E < M $_{\rm GUT}$, is then just the M SSM with the usual soft SU SY breaking term s uni ed at M $_{\rm G\,U\,T}$. The soft SU SY breaking scalar and gaugino mases, the trilinear A terms and in addition a bilinear soft term B, the gauge and Yukawa couplings and the supersymmetric term are all then evolved from M $_{\rm G\,U\,T}$ to some scale M ' M $_{\rm w\,eak}$ using renormalization group equations (RGE's). The large top quark Yukawa coupling causes the squared mass parameter of one of the Higgs elds H_u to be reduced. For phenom enologically viable choices of param eters, $m_{H_u}^2$ becomes negative so that electroweak symmetry is spontaneously broken, and 2 can be determined in term s of M $\frac{2}{2}$. It is custom any to trade the param eter B for tan , the ratio of H iggs eld vacuum expectation values. Finally, it is assumed that superpotential interactions conserve R-parity. The resulting weak scale spectrum of superpartners and their couplings can thus be derived in terms of four continuous plus one discrete param eters

in addition to the usual param eters of the Standard M odel (SM).

The implications of the m SUGRA model for supersymmetry searches at the CERN Large H adron Collider (LHC) have been examined by several groups in Refs. [3]. In Refs. [4] the reach of the LHC for SUSY via a variety of search channels has been obtained. These studies, using the event generator ISA JET [9], were at the time limited to low values of the parameter tan E_T plus 0-3 isolated leptons, in Refs. [4]

For higher values of the parameter tan , the b-quark and —lepton Yukawa couplings can become large. This can a ect SUSY phenomenology in several ways.

Large b and Yukawa couplings cause the $m_{L_{R}}^2$ and $m_{B_{L_{R}}}^2$ soft SUSY breaking masses to run to weak scale values that are lower than the corresponding mass terms for rst and second generation squarks and sleptons. Also, for large values of tan, there can be large o-diagonal mixing in sbottom and stau mass matrices. Together, these exists can make the physical stau and sbottom mass eigenvalues signicantly lower than their rst and second generation squark and slepton counterparts [10].

Contributions to the RGE proportional to the squared b and Yukawa couplings reduce the mass of the CP {odd Higgs boson m_A, which in turn reduces the masses of the CP {even Higgs boson H and of the charged Higgs boson [10]. The upper bound on tan is often determined by the experimental lower bound on m_A.

The relatively lower stau and sbottom masses result in larger production cross sections for third generation SUSY particles compared to rst and second generation SUSY particles.

The large and b Yukawa couplings, along with relatively light values of δ_i and γ_i m asses can yield enhanced decays of gluinos to b-quarks [10,11] and of charginos and neutralinos to leptons and b quarks [12,13].

As a result, for large values oftan , we expect SUSY events to contain m any m ore b-quarks and —leptons than anticipated in earlier studies that were mostly carried out for relatively low values oftan . Recently, a number of improvements [12] have been made to the event generator ISAJET [9] to allow realistic event generation in supersymmetric models even if tan is large.

The consequences of the m SUGRA model at large tan for the Fermilab Tevatron collider have been exam ined in Ref. [13]. In this study, it was found that for large tan , signi cantly fewer hard isolated e's and 's are produced in SUSY events, so that the reach for SUSY in various isolated lepton channels is greatly reduced compared to the corresponding reach at low tan . For instance, much of the reach of the Ferm ilab M ain Injector (and possible lum inosity upgrades thereof) com es from $\sqrt[4]{2}$! 3' production [14], where '= e or , if tan is small. However, for high tan values, decays such as Ψ_1 ! \mathcal{Z}_1 and \mathcal{Z}_2 ! can become dominant so that far fewer hard isolated leptons are produced, and the reach for SUSY is considerably dim in ished. In fact, in Ref. [13], it was found that for tan = 45, there would be no reach of the Fermilab Tevatron M ain Injector ($^{\circ}$ Ldt = 2 fb 1) for m SUGRA beyond the current existing bounds from LEP2 experiments. More recently, the authors of Ref. [15] found that some reach might be recovered in the three lepton channel if one can use leptons with p_T as small as 5 GeV. Potentially worrisom e physics backgrounds from heavy avor production (which are very e ectively reduced with harder lepton cuts), as well as instrum ental backgrounds from lepton m is-identication are thought to be under control [16]. Nevertheless it is then natural to ask if the CERN LHC reach for m SUGRA at large tan is also dim in ished, and if in fact SUSY could hide from LHC searches if the parameter tan happens to be large.

We have several goals for this paper.

1. We wish to establish the range of parameter space of the mSUGRA model that can be probed by CERN LHC experiments. In particular, is the reach of the LHC su cient

to discover or rule our m SUGRA at large tan , or could m SUGRA e ectively hide from SUSY searches? This issue is addressed in Sec. 2.

- 2. If a SUSY signal can be established at large tan , is it still possible for LHC experim ents to make precision measurements of (dierences of) sparticle masses and model parameters? In Sec. 3, we perform a case study for the parameter space point (m₀; m₁₌₂; A₀; tan) = (200 GeV; 200 GeV; 0; 45), where $\sqrt[6]{1}$ and $\frac{2}{1}$ decay almost exclusively to leptons, to answer this question. For this case, we not that an edge is reconstructable in the invariant mass distribution which gives information on m₂ m₂. Combining the 's with jets to form an invariant mass can also give an estimate of the mass of any squarks produced in SUSY events.
- 3. In Sec. 4, we exam ine the extent to which the lepton multiplicity exceeds the electron multiplicity in SUSY events if tan is large. We discuss various complications for such a measurement, and point out that signals could provide a novel diagnostic for SUSY analysis, and that these signals could provide an alternative handle on the magnitude of tan.

We end with a sum mary of our results and some general remarks in Sec. 5.

II. THE REACH OF THE CERN LHC FOR M SUGRA AT LARGE tan

We evaluate the m SUGRA signal using the ISA JET 7.37 event generator program, which is described in more detail in Ref. [9]. We use the same toy detector simulation as in Ref. [4]. For mg; mq < 1 TeV, gg, gq and qq production are the dominant sources of SUSY events at the LHC. These production mechanisms, together with g and q cascade decays, naturally lead to events with n-leptons + m-jets + E/T, where typically n = 0 { 4 and m 2. In our simulation, we generate all SUSY processes using ISA JET. However, our cuts are designed to selectively pick out gluino and squark events, whose characteristics are high transverse momentum jets and large missing transverse energy. Furthermore, the pT of the primary jets from gluinos as well as the E/T are expected to scale with mg. In contrast, the momenta of leptons, produced far down in the cascade decay chain from chargino and neutralino daughters, will in general be much softer than the jets and E/T, which can be produced in the rst step of the cascade decay. Thus, following Refs. [4] for the multilepton plus multijet signals for SUSY, we vary the missing-energy and jet ET cuts using a parameter ET but x the lepton cuts:

We classify the events by the multiplicity of isolated leptons, and in the case of dilepton events, we also distinguish between the opposite sign (OS) and same sign (SS) samples as these could have substantially dierent origins. For the leptons we require,

The SM background to the various multilepton plus multilet plus E_T signal events was calculated in Refs. [4] for the processes tt production, W or Z plus jets production, W W, Z Z and W Z production and QCD jet production (where leptons can arise from decays of heavy avors produced directly or via gluon splitting). We use these numerical results for our background estimates. For each point in mSUGRA parameter space, we require that, for 10 fb 1 of integrated luminosity, the number of signal events S exceed 5 B, where B is the number of background events, for some value of the cut parameter E_T^c . We also require S 6 0.2B, and further, that S 6 5 as the minimum number of events in 10 fb 1 .

Our results for the reach of the LHC are presented in Fig. 1 in the m $_0$ vs: m $_{1=2}$ plane, for A $_0$ = 0, > 0 and a) tan = 2, b) tan = 20, c) tan = 35 and d) tan = 45. We take m $_t$ = 170 GeV. The bricked regions are excluded by lack of appropriate radiative electroweak sym m m etry breaking, or (form $_0^2$ m $_{1=2}^2$) if the lightest neutralino \mathcal{E}_1 is not the lightest SUSY particle (the LSP). The shaded region is excluded by experimental searches for supersym metry, and mainly corresponds to the LEP2 bound m $_{\text{MP}_1}$ > 85 GeV, or the SUSY translation of the LEP2 bound that m $_{\text{H}}$ > 88 GeV for a SM Higgs boson. Mass contours for a 1000 GeV gluino and 1000 GeV rst generation squark are shown to orient the reader.

The results shown in Fig.1a fortan = 2 are updated versions of similar results presented in Ref. [4], and are useful for comparison with the higher tan cases shown in frames b), c) and d). The largest reach is generally obtained in the single isolated lepton plus jets plus E_T channel (labelled 1') or in the jets plus E_T channel with no isolated leptons (labelled E_T). For 10 fb 1 of integrated luminosity, values of E_T plus two opposite sign isolated leptons (labelled 0 S), or two same sign leptons (labelled SS) or three isolated leptons (labelled 3') are also shown. Each of these multilepton channels also gives a signicant reach for m SUGRA, so that for much of the parameter space shown, a SUSY signal ought to be visible in several different channels.

In the case of reach projections for the Fermilab Tevatron, as tan increased, it became more dicult to obtain high p_T isolated leptons since chargino and neutralino branchings to 's and b's increased at the expense of e's and 's. Consequently, as tan increased, the Fermilab Tevatron reach for m SUGRA decreased, and in fact for tan = 45, there was no reach for Tevatron Run 2 (2 fb 1) beyond the region already excluded by LEP2 [13]. As mentioned, if it is possible to use softer cuts on the leptons, the situation might be somewhat ameliorated [15].

The corresponding situation for the CERN LHC is shown in frames b), c) and d) of Fig. 1. For large tan , we see rst of all that the theoretically excluded region increases substantially at large m $_{0}$. This region actually depends som ewhat sensitively on the assumed value of the top mass (and on which higher order corrections are included in the program used). This excluded region also increases at low m $_{0}$ and large m $_{1=2}$ when m $_{\sim_{1}}$ becomes lighter than m $_{\approx_{1}}$.

Next, as tan increases from 2 to 20, 35 and 45, we see that the ultimate reach for m SUGRA only decreases slightly in the 1 and $\rm E/_T$ channels, and only for low values of m₀. If m₀ is large, for m₁₌₂ close to the LHC reach in framea), charginos and neutralinos mainly decay to real W₁, Z₂ and Higgs bosons, and leptonic signals from these decays, and hence the

LHC reach, are only weakly dependent on tan . For low values of m $_0$, however, the decays \pounds_2 ! $^{}_1$ and $\vec{\mathbb{W}}_1$! $^{}_1$ (bars are om itted), and possibly, those to other sleptons are also kinem atically accessible. The decays to stau dom inate for high values of tan , while for low tan and low m $_0$, \pounds_2 ! \pounds_1 h or ''and $\vec{\mathbb{W}}_1$! W \pounds_1 or ' or '~. It is easier to get hard isolated leptons from the subsequent W or 'decays than from a $^{}_1$! \pounds_1 ! ' \pounds_1 decay, which accounts for the som ewhat higher reach in the 1' channel at low tan . Similarly, the reach for m SUGRA in the multilepton channels decreases as tan increases, but again only for low m $_0$.

Although the LHC reach form SUGRA is somewhat reduced at large tan , the contours still lie far beyond parameter space preference curves due to \naturalness" considerations [17], which tend to lie below the m $_{\rm g}$; m $_{\rm q}$ = 1000 GeV contours. It is worth noting that the selection criteria designed to extract the SUSY signal for the low tan regime succeeven if tan is large; i.e. no new analysis is necessary. The large reach form SUGRA at large tan is due in part to the large squark and gluino production cross sections, and the fact that for very large sparticle masses, leptons occurring very far down the cascade decay chain can still have substantial $p_{\rm T}$. From these reach contours, we conclude that it would be dicult for m SUGRA to hide from detection at the LHC by virtue of having a large value of tan. This is in sharp contrast to the corresponding situation for the Fermilab Tevatron pp collider [13].

III.A LARGE tan M SUGRA M ODEL CASE STUDY

In Refs. [5,6], we m SUGRA parameter space points were adopted for detailed case studies. It was found that in fact precision measurements of (dierences of) SUSY particle masses and model parameters could in many instances be made at LHC experiments. We brie y summarize the results of Refs. [5,6] as follows.

A global variable

(scalar sum) for events with 4-jets + E_T was de ned. D istributions in M $_{\rm eff}$ were shown to be dominated at low values by SM backgrounds, but were dominated by the m SUGRA signal at high values of M $_{\rm eff}$. The peak in the M $_{\rm eff}$ distribution scaled with m in (m $_{\rm g}$; m $_{\rm q}$) and provided a good rst estimate of the strongly interacting SUSY particle m asses involved in the signal events.

Gluino and squark cascade decay events involving \mathcal{E}_2 were found to be very useful for reconstructing the cascade decay chain whenever the branching fraction for the decay \mathcal{E}_2 ! $h\mathcal{E}_1$ or the decay \mathcal{E}_2 ! $h\mathcal{E}_1$ is substantial. In the case that \mathcal{E}_2 ! $h\mathcal{E}_1$ followed by h! bb, the bb mass could be reconstructed to yield m_h ; then by combining with other hard jets present in the events, mass estimates could be made of other SUSY particles occurring earlier in the cascade decay sequence. In the \mathcal{E}_2 ! \mathcal{E}_1 case, the endpoint of the m ('') distribution leads to a precise determination of $m_{\mathcal{E}_2}$ $m_{\mathcal{E}_1}$ (or if the decay is mediated by an on-shell slepton, yields information about m_*); again, by combining dilepton masses with various jets, other sparticle mass estimates could be obtained. These reconstructed decay chains thus yield information of several sparticle masses which can then be used to constrain the underlying model parameters.

Finally, a global tof event characteristics and/or mass measurements to various SUSY model parameters could be made. An overconstrained tallowed rejection of many possible SUSY models, while honing in on possible choices for underlying model parameters.

The m SUGRA parameter space choices made in Ref. [5,6] were necessarily restricted to values of tan 10, since ISAJET was at the time only valid for that parameter space regime.

We expect that the M $_{\rm eff}$ distribution will continue to yield a measure of the SUSY mass scale regardless of the magnitude of tan . However, any sparticle mass reconstruction strategies involving \mathcal{Z}_2 decays are in need of re-analysis since at large tan , \mathcal{Z}_2 ! \mathcal{Z}_1 can be the dom inant decay mode of \mathcal{Z}_2 . For this reason, we select an additional case study point, \LHC point 6", with m SUGRA parameter values (m $_0$; m $_{1=2}$; A $_0$; tan ; sign ()) = (200; 200; 0; 45; 1), as suggested in [18], where mass parameters are in units of GeV. In this case, m $_{g}$ = 540 GeV, m $_{q}$ = 498 517 GeV, m $_{b_1}$ = 390 GeV, m $_{c_2}$ ' m $_{we_1}$ = 152 GeV, m $_{c_1}$ = 81 GeV, m $_{a}$ = 131 GeV and m $_{c_1}$ = 219 GeV. In this case, \mathcal{Z}_2 ! \mathcal{Z}_1 at 99.8% and \mathcal{W}_1 ! \mathcal{Z}_1 at 99.6%. In addition, \mathcal{Z}_2 ! \mathcal{Z}_1 boccurs at 55%. The SUSY signal events in this case are expected to be rich in b-jets and —leptons.

A signal sample of 500 k events (corresponding to an integrated luminosity of about 5 fb 1) was generated, along with 250 k event background samples each for W + jets, Z + jets, tt production as in R ef. [6]. Q C D backgrounds are expected to be small after basic selection cuts discussed below. Hadronic 's were found using generator information rather than selecting narrow jets. In addition, hadronic 's were required to have visible $p_T > 20 \text{ GeV}$ and j j < 2:5. We used the CDF rate 1 for jets to fake 's, namely, 0.5% at p_T (jet) = 20 G eV and 0.1% for p_T (jet) > 50 G eV, with a linear interpolation in between [19]. The following standard cuts were made:

at least four jets were required (using the ISA JET GET JET routine) with $p(j_1) > 100$ GeV and $p_T(j_{2;3;4}) > 50$ GeV (leptons and taus are counted as jets),

E/ > 100 GeV,

transverse sphericity $\S > 0.2$,

 $M_{eff} > 500 \text{ GeV}$.

E ciencies of 60% for b-tagging and 90% for lepton and (hadronically decaying) identi-cation were assumed. (The e ciency is too optim istic, but studying it requires more than a toy detector simulation.) With these cuts, the event sample was already dominated by signal so that errors in the mis-identication rate of b's and 's are not expected to be a problem.

The distribution in M $_{\rm eff}$ is shown in Fig. 2. The signal is shown by the solid histogram, while background is shown by the dashed histogram. The signal easily dom in ates background as expected for large values of M $_{\rm eff}$ 650 G eV . At low tan the ratio of M $_{\rm eff}$ where signal

just exceeds background to M $_{\text{SUSY}}$ is noted [6] to be 1.5 1.6, and provides an estim ate of M $_{\text{SUSY}}$. In this case, the ratio is 1.3, which is due mainly to the larger mass splittings of squarks (m $_{\text{B}_{1}}$; m $_{\text{B}_{1}}$, m $_{\text{B}_{1}}$, at large tan .

For events with at least two hadronic taus, we plot in Fig. 3 the visible — mass for the two highest p_T tau leptons. The distribution shown exhibits an edge near the endpoint for \hat{Z}_2 ! \hat{Z}_1 , but the signal to SUSY background ratio is poor since a large fraction of the mass is lost to neutrinos; i.e. a substantial number of SUSY events with the \real mass" beyond the end point appear below the end point because of the mass carried o in neutrinos. The rate is very much larger than the SM background shown as the hatched histogram, so observing a signal in this distribution would be trivial. The end point of the neutralino decay appears as a kink in the m distribution. The visible — mass is calculated using generator inform ation and so does not include the e ects of calorim eter and/or tracker resolution.

A more faithful mass distribution can be obtained by selecting multiparticle hadronic decays with a visible mass close to the mass to reduce the mass carried o by neutrinos. The mass distribution for 3-prong decays from the signal and SM background is shown in Fig. 4 for events with exactly two opposite sign hadronic 's and no additional isolated leptons. The requirement of exactly two 's was imposed to remove combinatorial background. There is very little real SM background after cuts, but there still is a substantial contamination from other SUSY sources. Since most of the SUSY events contain at least one gluino, which is a Majorana fermion and has equal branching ratios to mand the background from two independent chargino decays can be estimated from the

The subtracted distribution, shown in Fig. 5, has a clear low mass enhancement with an endpoint near but slightly below the limit for two body decays neglecting the mass:

distribution, which is also shown as the dashed histogram in Fig. 4.

The contribution to this distribution of events with exactly one \mathcal{Z}_2 and no $\tilde{\mathbb{W}}_1$ is shown as the dashed curve in the gure and clearly accounts for most of the low mass enhancement. There is also a contribution from events containing at least one \mathcal{Z}_3 or \mathcal{Z}_4 , the dash-dot curve in Fig. 5, which accounts for the excess of pairs at higher mass. Many channels contribute to these decays; the branching ratio for \mathcal{Z}_4 ! is only 8.8%, so the distribution appears to end before the kinematic limit,

Thus, from these distributions, it should be possible to extract information not only on $m_{\mathfrak{L}_2}$ $m_{\mathfrak{L}_1}$, but perhaps also information on heavier neutralino masses as well, although this will probably be very dicult.

We should point out that while focussing on taus with three charged prong decays indeed gives us a truer ditau mass distribution, it also leads to a reduction in event rate by more than an order of magnitude. We have not attempted to exam ine whether the end point

is better determ ined from this \truer" distribution or from the kink in the distribution in Fig. 3 which includes an order of magnitude larger data sample. Our study here should be regarded as a rst look at the sort of measurements that might be possible when charginos and neutralinos dominantly decay to taus.

Most of the \pounds_2 's originate from squark cascade decays in this case study. It is then interesting to see if an estimate can be made of the squark masses as well as the neutralino masses. In Fig. 6, we have required events with exactly two 's, each decaying into three prongs, and then have constructed the invariant mass of the pair with each of the two fastest jets; nally, we plot the minimum of these two masses. Since the hardest jets typically come from q! $q\pounds_1$ decay, this distribution should be approximately bounded by the squark mass. This is verified in Fig. 6, where the bulk of the m j distribution is in fact bounded by m $_{\mathfrak{q}}$ ' 500 GeV.

A sim ilar calculation can be performed using only identied b-jets, to try to extract the B_1 mass from B_1 ! bE_2 decays. In Fig. 7, we plot the distribution for M $_b$ using again the smaller of the two mass combinations. The bulk of the distribution is bounded by m $_{B_1}$ = 390 GeV, although a tail extends to higher mass values. This is due in part to contributions from B_2 decays, where m $_{B_2}$ = 480 GeV. It might also be interesting to see whether it is similarly possible to isolate the decay chain g! bE_1 ! bbE_2 ! bb E_1 by looking at the M $_{bb}$ which should be bounded by m $_{g}$.

IV.LEPTON NON-UNIVERSALITY AT LARGE tan

O ver a signi cant portion of m SUGRA parameter space it is expected that the multiplicity of leptons should be enhanced relative to es or s at large tan. This suggests that if it is possible to conclusively establish tau lepton non-universality in SUSY events, we may be able to interprete it as an indicator of a sizeable tau Yukawa interaction, at least within the m SUGRA fram ework. It should, of course, be kept in m ind that within the m ore general M SSM fram ework, SUSY events may exhibit lepton non-universality even if Yukawa couplings are negligible, as long as m -1 di ers from selectron and sm uon m asses. The observation of universality between e and in a SUSY event sample would strongly tempt us to suggest [20] that an observed tau non-universality indeed originates in a sizeable tau Yukawa coupling.

While the principle is simple, its implementation poses a challenge. Even in a sample of purely SM events, there should be a super cial non-universality of e: simply due to the dierent acceptance cuts and e ciencies for identifying each species of lepton. It should be possible to determ ine these directly from a data sample rich in SM events. However, these e ciencies will also change somewhat with the cuts used to select out SUSY events, but this can presumably be taken into account, again using the data; e.g. by using selection cuts that smoothly interpolate between SM and signal samples. Hadronically decaying taus pose yet another challenge since the visible energy spectrum in their decays, and hence, the tau detection e cency, is sensitive to their polarization [22]. Moreover, for a data sample enriched in New Physics (in our case SUSY) events, the tau polarization is not known a priori, but may be possible to determ ine from the data.

A complete quantitative analysis of lepton non-universality is beyond the scope of this

study. For one, it would entail a correct simulation of tau decays (including e ects of tau polarization) both for SM backgrounds and the SUSY sample. These e ects are not yet completely included in ISAJET.Our study should, therefore, be regarded as exploratory, and simply indicative of the magnitude of asymmetries that we will have at our disposal for future studies.

To illustrate this with a direct computation, we exam ine three di erent m SUGRA param eter space points with m $_0$ = 225 GeV, m $_{1=2}$ = 250 GeV, A $_0$ = 0, > 0 and A) tan = 2, B) tan = 35 and C) tan = 45, along with the SM background. We impose a simple set of cuts:

We show the total signal and background as a function of $E_{\rm T}^{\rm c}$ in Fig. 8a. For low values of E_T^c , the resulting event sample is background dom inated, while for high E_T^c , the sample is signal dom inated. In Fig. 8b, we plot the average lepton multiplicity in the surviving signal plus background event sample of e's and 's, denoted by hnei (dashed) and hn i (solid). For case A, with low tan = 2, the multiplicity is roughly constant versus E_T^c , and would correspond to a measured lepton universality after accounting for acceptances and e ciencies. For this case, the quantity $hn_{e}i$ decreases somewhat with E_{τ}^{c} since jetty gluino and squark cascade decay events are more likely to pass our simple cuts listed above. For case B with tan = 35, $\sqrt[6]{1}$! W $2\sqrt[6]{1}$ with a branching fraction of 98% while $2\sqrt[6]{2}$! $2\sqrt[6]{1}$ 27% of the time, so that some violation of universality is expected. This is seen in Fig. 8b where the e and multiplicity is nearly that of case A for low E_T^c , while for high E_T^c , which is signal dom inated, there is a distinct increase in multiplicity compared to emultiplicity. This can be seen more easily in Fig. 8c where we plot the ratio hn i= hn_ei versus E_{τ}^c . For case C , we have B ($\sqrt[6]{1}$! \sim_1) = 93% and B ($\sqrt[6]{2}$! \sim) = 99% , so large deviations from universality should be expected at high E $_{\rm T}^{\rm c}$. For this case, we see in F ig. 8b that in fact hn i surpasses h_{e} i for all $E_{c}^{r} > 50$ G eV, and F ig. 8c shows the huge deviations from universality that would be expected for very large tan and small m $_0$.

While we recognize that our results should be regarded as qualitative, we are encouraged to see that the magnitudes of asymmetries in the three cases are quite dierent. As more complete simulations become available, it would be instructive to study the extent to which leptons may serve as a diagnostic of any new physics that might be discovered. Such analyses will have to be interpreted with care since, as we have said, the tau detection e ciency, and hence the expectation for tau multiplicity, depends on the unknown polarization (which may be possible to measure) in the new physics sample. Well-de ned fram eworks such as mSUGRA would, however, make unambiguous predictions for hi, so that this measurement could serve as an independent test, and possibly even provide a measure of tan (especially if it happens to be large). Indeed in the future, it may prove worthwhile to examine the multiplicity of taus separately in various event toplogy samples (1'; ''; '; '; 3'etc.) since these generally have dierent SUSY origins.

V.SUM MARY AND CONCLUSIONS

In this paper we have studied SUSY signals at the CERN LHC collider as predicted by the m inim alsupergravity model for large values of the parameter tan. We found that increasing this parameter to values near its upper bound has little in pact on the SUSY discovery reach of the LHC, in stark contrast to the Tevatron, whose reach is greatly diminished in this region of parameter space. The main reason for this dierence is that increasing tan can change the qualitative pattern of neutralino and chargino decays only for relatively small sparticle masses, where their decays into real W and Z bosons are kinematically disallowed. Even though in this region of parameter space the eciency for detecting SUSY through events containing hard leptons is low also at the LHC, the huge event rate guarantees that SUSY will still be seen in several dierent channels. Once decays into real gauge or Higgs bosons become possible, decay patterns become less sensitive to tan; in particular, except when more is very small, many hard leptons now come from the decay of on {shell Wand Z bosons, independent of the value of tan.

A part from discovering SUSY, one would also like to determ ine its parameters, so as to eventually pin down the supersymm etricm odel that describes nature at a more fundamental level. Most previous studies that attempted to reconstruct some (dierences of) SUSY m asses at the LHC used events with hard isolated leptons. Unfortunately, for large values oftan and not too heavy sparticles SUSY events are expected to contain leptons rather than electrons orm uons. While leptonically decaying 's still produce su ciently many hard electrons and m uons to ensure that SUSY will be discovered, the presence of m any additional neutrinos would make mass reconstruction using electrons and muons all but impossible in this part of parameter space. In Sec. 3 we instead used hadronic 3 (prong decays of 's to determ ine the di erence between the masses of the lightest and next (to (lightest neutralino; we focussed on this decay mode since here the simultaneously produced s (which smear out the end point) are forced to be relatively soft, which m in im izes their im pact on kinem atic event reconstruction. While the precision of this measurement will be worse than that of the analogous measurement based on ete pairs at smaller tan , it should still be su cient to greatly constrain the SUSY model. We also showed how combining pairs with a hard jet m ight yield inform ation about the overall scale of the squark m asses or, if this jet contains a tagged b, the mass of bottom squarks.

Finally, the presence of many leptons also o ers new opportunities to glean information about the underlying SUSY parameters. As a rst attempt in that direction we studied in Sec. 4 the violation of lepton universality that can be expected in SUSY events if tan is large. In order to make this fully quantitative, a careful analysis of the dierent detection e ciencies for the three avors of leptons is mandatory, which requires detailed understanding about the performance of LHC detectors as well as detailed simulation of decays. Here we instead simply showed corresponding results for event samples dominated by Standard Model contributions, where lepton universality is known to hold to very good approximation; this serves as a normalization for other event samples dominated by SUSY contributions. Some caution is advised when interpreting these results. For example, the average polarization is expected to change when going from the SM (dominated sample to the SUSY (dominated sample; this will change the E_T spectrum of the visible decay products, and hence their detection e ciency. However, our results clearly show that at

least for the extrem e case where $\sqrt[4]{1}$ and 2^{6} almost exclusively decay into real \sim_{1} sleptons, a gross violation of lepton universality should be expected.

One can envision other, more ambitious studies of SUSY events containing hadronically decaying leptons. For example, a comparison of the visible spectra of events with 1 {prong and 3 {prong decays should allow to determ ine the polarization, which in turn would yield information on the γ_L γ_R mixing angle, as well as the decomposition of the $\sqrt[R]{1}$ and/or $\sqrt[R]{2}$ mass eigenstates in terms of gaugino and higgsino current states. Copious production of leptons, a bane for SUSY searches at the Tevatron, could therefore well turn out to be a boon for the LHC.




FIG.1. A plot of the reach of the CERN LHC for various n-lepton plus multijet plus m issing E_T events from m SUGRA in the m $_0$ vs: m $_{1=2}$ plane for $A_0=0$, > 0 and a) tan = 2, b) tan = 20, c) tan = 35 and d) tan = 45. We take m $_t=170~{\rm GeV}$.




FIG .2. D istribution in M $_{\rm eff}$ for the case study of Sec. 3. The signal is the solid histogram , while the dashed histogram represents background.




FIG.3. Visible mass for all hadronic decays.




FIG. 4. V isible $\,$ m ass with 3-prong decays (solid), SUSY background estimate from (dashed), and SM background (shaded).




FIG.5. V isible m ass distribution for the di erence of $^+$ and (solid). The contribution of \mathcal{E}_2 events (dashed), and \mathcal{E}_3 + \mathcal{E}_4 events (dashed-dotted) are also shown.




FIG.6. Visible jet mass distribution for the smaller of two combinations. The shaded histogram is the SM background.




FIG.7.V is ible b m ass distribution for the smaller of two possible combinations. The shaded histogram is the SM background.




FIG. 8. A plot of a) background (BG) and 3 signal cases A, B and C given in the text after modest cuts. In b), we plot the average e and multiplicities in the signal plus background sample of events that survive cuts. In c), the ratio of to e multiplicities is plotted versus E_T^c for the three cases of signal plus background.
