Dijet Mass Spectrum Limits on Flavor-Universal Colorons

A bstract

U sing recent D data on the dijet mass spectrum, we present a limit on avor-universal colorons. At 95% CL we nd $M_{\rm c}=\cot$ > 837 GeV. We discuss the implications of this limit for models of quark compositeness, non-standard gluon interactions, and dynamical electroweak symmetry breaking. In addition, we place a lower bound $_{\rm A\,8}$ > 2:1 TeV on the scale of color-octet axial-vector contact interactions among quarks which could arise in models of quark compositeness.

1 Introduction

The avor-universal coloron model [1] was originally proposed to explain the apparent excess of high- $E_{\rm T}$ jets in the inclusive jet spectrum measured at the Fermilab Tevatron by the CDF Collaboration [2]. This model is a avor-universal variant of the coloron model of H ill and Parke [3] which involves a minimal extension of the standard description of the strong interactions, including the addition of one gauge interaction and a scalarm ultiplet, but no new fermions. The avor-universal coloron model of the strong interactions can be grafted onto the standard one-H iggs-doublet model of electroweak physics, yielding a simple, complete, and renormalizable theory. A Itematively, it can provide the basis for dynamical generation of electroweak symmetry breaking and the generation of the top quark's mass in models [4, 5] akin to top-color-assisted technicolor [6].

Previous work on the phenom enology of the colorons has considered e ects on the parameter [1, 4], the inclusive jet spectrum [1], the dijet spectrum and angular distributions [7, 8, 9], and b-tagged dijets [8]. The most recent of these analyses [9] put a lim it M $_{\rm c}$ =cot > 759 G eV on the the coe cient of the four-ferm ion contact interaction to which heavy coloron exchange would give rise.

This letter explores the e ects colorons would have on the dijet mass spectrum measured at the Tevatron by the D Collaboration [10] and establishes a still stronger limit on contact interactions arising from colorons: $M_c = \cot > 837$ GeV at 95% CL. In Section 2, we brie y review the model. Section 3 explains how our limit was derived. Section 4 discusses our conclusions and the implications form odels of quark compositeness, non-standard gluon interactions, and dynamical electroweak symmetry breaking. We also present a separate limit on the scale of color-octet axial-vector contact interactions among quarks.

2 The model

In the avor-universal coloron model [1], the strong gauge group is extended to $SU(3)_1$ $SU(3)_2$. The gauge couplings are, respectively, $_1$ and $_2$ with $_1$ $_2$. Each quark transforms as a (1,3) under this extended strong gauge group.

The model also includes a scalar boson transforming as a (3;3) under the two SU (3) groups. For a range of couplings in the scalar potential, develops a vacuum expectation value h i = diag(f;f;f) which breaks the two strong groups to their diagonal subgroup [1]. We identify this unbroken subgroup with QCD.

When the extended color symmetry breaks, the original gauge bosons m ix to form an octet of massless gluons and an octet of massive colorons. The gluons interact with quarks through a conventional QCD coupling with strength g_3 . The

colorons (C a) interact with quarks through a new QCD-like coupling

$$L = q \cot J^a C^a ; (2.1)$$

where Ja is the color current

and $\cot = 2 = 1 > 1$. The mass of the colorons may be written

$$M_{C} = \frac{g_3}{\sin \cos} f \qquad (2.3)$$

in term s of the param eters of the model.

Below the scale M $_{\rm C}$, coloron-exchange m ay be approxim ated by the e ective four-ferm ion interaction

$$L_{eff} = \frac{g_3^2 \cot^2}{2M_c^2} J^a J^a : \qquad (2.4)$$

This can be re-written in the form commonly used in studies of quark compositeness [11]

$$L_{eff} = \frac{4}{2! {}_{V8}^2} J^a J^a : \qquad (2.5)$$

where the scale $_{V\,8}$ is de ned by $_{V\,8}$ p $_s$ = M $_c$ =cot . Contact interactions of this kind tend to increase quark-quark scattering at high invariant m ass above the standard QCD prediction.

3 E ects on the Dijet Spectrum

The D Collaboration recently [10] measured the inclusive dijet mass spectrum at $\stackrel{p}{=}=1.8\,\text{TeV}$ for dijet masses above 200 GeV and jet pseudorapidity j jet j< 1.0. The collaboration also measured the ratio of spectra at j jet j< 0.5 and 0.5 < j jet j< 1.0 and used this to place a limit on certain models of quark compositeness. We use this same ratio of spectra to place limits on the elects of avor-universal colorons.

We calculated the leading-order (LO) dijet spectrum

in terms of the jets' pseudorapidities (1, 2; m 0.5(1 2)), combined invariant mass (M) and momentum fractions $(x_a; x_b)$; the parton distribution functions $(f_{a=A}; f_{b=B})$; and the two-body parton scattering cross section

The leading QCD contributions to (ab! cd) may be found in [12] and the contributions from heavy coloron exchange are given in [1]. Note that we included only production of gluons and light quarks in our calculations since produced top quarks would not contribute appreciably to the D dijet sam ple?




Figure 1: The ratio of cross sections, $(j_{jet}j < 0.5) = (0.5 < j_{jet}j < 1.0)$, as measured by D [10] compared to theory for dierent values of $M_c = \cot$ (see text for details on how the coloron distributions are calculated). The error bars show the statistical and system atic uncertainties of the data added in quadrature, and the crossbar shows the size of the statistical error.

Taking a series of dierent values for the coloron interaction strength $\rm M_{\rm c}=\cot$, we then determined the ratio $\rm (j_{\rm jet}j<0.5)=(0.5<\rm j_{\rm jet}j<1.0)$ at values of M corresponding to the weighted center of each m ass bin³ m easured by D $\rm in$ ref.[10]. We evaluated the fractional dierence between the dijet spectra for pure QCD and for the various values of M $\rm _c=\cot$. To simulate a next-to-leading order (NLO) prediction of the elects of colorons, we multiplied a NLO QCD prediction obtained using the jet rad program [14] by the LO fractional dierences. The results are illustrated in Figure 1.

We extract a limit on the coloron interaction strength from the D data [10] using Bayesian techniques with a Gaussian likelihood function

where d is the vector of data points for the dierent mass bins, f (x) is the vector of theory points for the dierent masses at dierent values of x $1=^n$, and S is the covariance matrix. M otivated by the form of $L_{\rm eff}$ (eqn. (2.5)), the prior probability is assumed to be at when $x=1=^2$. Since the ratio of spectra at NLO is sensitive to the choice of and parton distribution function, each possible choice is treated as a dierent theory. The 95% condence limit (CL) on is calculated by requiring that

The lim it in x is then transformed back into a lim it on $\,$ and thence into a lim it on M $_{\rm c}{=}\cot$.

 $^{^2}$ The number of top quarks produced is relatively small and a decaying top quark does not generally resemble a single high- $\mathbb{E}_{\mathbb{T}}$ jet.

 $^{^3}$ A s a check, we re-calculated the ratio for the very wide highest m ass bin by integrating over M for 800 G eV < M < 1400 G eV; this yielded the same ratio as keeping M xed at the weighted center value of 873 2 G eV.




Figure 2: The probability distribution (solid curve) Q (x)=Q (1) for the theoretical (jetrad) prediction with = 1:0 E $_{\rm T}^{\rm max}$. The dashed curve shows the integral of the probability distribution and the dotted line shows the 95% CL on M $_{\rm C}=$ cot , i.e., 837 G eV .

The most conservative lower bound we obtain at the 95% CL is M $_{\rm c}$ =cot > 837 GeV for the CTEQ 3M pdf and = E $_{\rm T}^{\rm max}$ (where E $_{\rm T}^{\rm max}$ is the maximum jet E $_{\rm T}$ in the event) as illustrated in Figure 2. This lim it is incompatible with the suggestion of a coloron interaction strength of order 700 GeV [1] in earlier measurements of the high E $_{\rm T}$ jet inclusive cross-section [2].

4 Discussion




Figure 3: Lim its on the coloron param eter space: coloron m ass M $_{\rm C}$ vs. m ixing param eter cot . The dark shaded region shows the 95% CL exclusion region for the D $_{\rm C}$ m easurem ent of the ratio of cross sections (M $_{\rm C}$ =cot > 837 G eV $/c^2$). The lightly shaded region shows the area excluded by the D $_{\rm C}$ dijet angular distribution [9] (M $_{\rm C}$ =cot > 759 G eV $/c^2$). The horizontally hatched region at large cot $_{\rm C}$ is not allowed in this phase of the model [1, 8]. The diagonally hatched region is excluded by the value of (M $_{\rm C}$ =cot > 450 G eV $/c^2$) [1]. The cross{hatched region at low cot 2 is excluded by the CDF search for new particles decaying to dijets [7].

Our lim it places a new exclusion bound in the M $_{\rm C}$ vs. cot parameter space of the avor-universal coloron m odel. As shown in Figure 3, this improves on the recent D lim it based on the dijet angular distribution [9]. Note that the region at cot 1 where our lim it appears to provide a direct lower bound on M $_{\rm C}$ has already been excluded by CDF's search for new particles decaying to dijets [16]. This is fortunate, because our lim it actually becomes less reliable here: the condition M $_{\rm C}$ > $\frac{1}{8}$, under which (2.4) is a reasonable approximation to coloron exchange, would no longer hold for the highest-energy data point. An updated search for new resonances decaying to dijets would be a useful complement to the bounds we report here.

In the context of the dynam ical electroweak sym m etry breaking m odel of [4] in which avor-universal colorons help produce the m ass of the top quark, the value of cot is approxim ately 4. In other words, the interaction strength is near its upper lim it for the H iggs phase of the m odel [1, 8]. Our bound in plies that M $_{\rm c} > 3:4$ TeV in such m odels, placing them at the upper right of the allowed region in Figure 3.

Our ndings also set a lim it on a broader array of new strong interaction physics. Writing eqn.(2.4) in the more conventional form for compositeness studies (2.5) shows that our lim it is equivalent to a lower bound $_{\rm V\,8}$ > 2.4 TeV on the scale of new color-octet vectorial current-current interactions. Such interactions could arise from quark compositeness or from non-standard gluon interactions (e.g. gluon compositeness) [17].

Finally, we have used the same methods to set a limit on a color-octet axial-vector current-current interaction among quarks. This has the form

$$L_{eff} = \frac{4}{2! {2 \atop A8}} J_5^a J_5^a : \qquad (4.1)$$

where J_5^a $f = g = 5\frac{a}{2}g_f$. The contributions of this contact interaction to parton

scattering are given in [1]. The most conservative bound we nd is $_{A\,8} > 2:1$ TeV at 95% CL. Note that we cannot self-consistently interpret this as providing a lower bound on the mass of an axigluon [18, 19] whose exchange underlies the contact interaction (4.1). The relation $_{A\,8}$ $_{s}$ = $_{axigluon}$ (since cot = 1 for axigluons) shows that the mass of the supposed axigluon would not satisfy the condition M $_{axigluon}$ > $_{s}$. Instead, our limit should be interpreted as bounding the scale of contact interactions arising in models of quark compositeness.
