The Pinch Technique Beyond One Loop: The Gauge-Independent Two-Loop Quark Self-Energy

A bstract

It is shown how the pinch technique algorithm may be consistently extended beyond the one-loop level to obtain the gauge-independent two-loop ferm ion self-energy $i^{(2)}(p)$ in QCD in the pinch technique approach. The starting point for the construction is the general diagram m atic representation of the two-loop quark self-energy in terms of renorm alized one-bop two- and three-point function and tree level Bethe-Salpeter-type quark-gluon scattering kernel insertions in the one-loop quark self-energy. Using factors of longitudinal gluon four-momentum only from lowest order gauge eld propagators and triple gauge vertices to trigger the relevant W and identities, the function $i^{(2)}(p)$ is explicitly constructed from the consideration of the two-loop QCD corrections to the C om pton scattering of a photon o a quark. It is shown that the resulting pinch technique self-energy $i^{(2)}(p)$ is gauge-independent at all m om enta, does not shift the position of the propagator pole and is multiplicatively renorm alizable by local counterterm s. The dem onstration of the gauge independence is based on an e cient diagram m atic m ethod to dealwith the several dozen two-loop diagram s involved. It is explicitly shown by this exam ple that the general correspondence between the pinch technique n-point functions and those obtained in the background eld m ethod in the Feynm an quantum gauge $_0 = 1$ does not persist beyond one loop.

1 Introduction

The pinch technique (PT) [[{7] is a well-de ned algorithm for the rearrangement of contributions to conventional one-loop n-point functions in gauge theories to obtain one-loop \e ective" n-point functions which, m ost notably, are entirely independent of the particular gauge xing procedure used (covariant, non-covariant, background eld etc). This rearrangement of one-loop perturbation theory is based on the system atic use of the tree level W and identities of the theory to cancel am ong Feynm an integrands all factors of longitudinal four-m om entum associated with gauge elds propagating in loops. In addition to being gauge-independent, the PT n-point functions display a wide range of further desirable theoretical properties. In particular, they satisfy sim ple tree-level-like W and identities corresponding to the gauge invariance of the classical lagrangian. As a result of these properties, the PT has been advocated as the appropriate theoretical fram ework for a broad range of applications in which one is forced to go beyond the strictly order-by-order com putation of S-m atrix elements, or to consider am plitudes for explicitly o -shell processes [4{8].

A fundamental criticism of the PT approach, however, is that, to date, it has remained restricted to the one-loop level: it has yet to be shown how the PT algorithm may be consistently extended beyond the one-loop level to obtain one-particle-irreducible (1PI) multi-loop n-point functions with the same desirable properties as at one loop. From a theoretical point of view, this extension is clearly essential if it is to be shown that the PT is more than just an artefact of the one-loop approximation. In particular, one would like to know whether the correspondence [9] between the PT gauge-independent n-point functions and those obtained in the background eld method (BFM) [10,11] in the Feynman quantum gauge $_{Q} = 1$ persists beyond one loop.² From a phenomenological point of view, many of the applications of the PT increasingly dem and accuracy beyond the one-loop level.

In attempting to extend the PT beyond the one-loop approximation, two basic problems arise:

(1) How to deal consistently with triple gauge vertices all three legs of which are associated with gauge elds propagating in loops? In the PT at the one-loop level, the factors of longitudinal fourm on entum associated with gauge elds propagating in loops originate from tree level gauge eld propagators and triple gauge vertices. In particular, the triple gauge vertices which occur in one-loop diagram s always have one external leg A^{a} (q) and two internal legs A^{r} (k_{1}), A^{s} (k_{2}). It is then possible to decom pose such vertices so as to isolate unam biguously the longitudinal factors k_{1} , k_{2} associated with the internal gauge elds. Beyond one loop, how ever, there occur triple gauge vertices for which all three legs are internal. It is thus unclear how to decom pose such vertices in order to identify the associated longitudinal factors which then trigger the PT rearrangem ent.

(2) How to deal consistently with the \induced" factors of bogitudinal internal gauge eld four-momentum which originate from internal bop corrections? Beyond the one-bop level, in addition to the factors of longitudinal internal gauge eld four-momentum from tree level

gauge eld propagators and triple gauge vertices, there occur further such factors originating from the invariant tensor structure of internal loop corrections. A simple example are the longitudinal factors occurring in the transverse structure of the gluon self-energy in QCD. It is thus unclear whether or not such \induced" factors should also be used to trigger the PT rearrangem ent; and, if so, how this may be done consistently.

In addition to these two problems of principle, one is also faced at the diagram matic level with the algebraic complexity of attempting to implement the PT rearrangement among multi-loop n-point functions starting from arbitrary gauges.

The purpose of this paper is to take the rst step towards solving the rst of the above problem s. At the two-loop level to be considered here, the two problem s are uncoupled and so can be investigated separately and successively: one has rst of all to solve (1) in order to identify the one-loop internal corrections needed before one can address (2). By investigating here only the rst problem, we e ectively assume that the correct approach will turn out to be not to use the \induced" longitudinal factors to trigger further the PT rearrangem ent. In particular, throughout this paper, \the PT " will be understood to m ean the PT algorithm in plem ented using only the longitudinal factors from lowest order gauge eld propagators and triple gauge vertices. The possibility that one should in fact then go on to use the \induced" longitudinal factors to trigger ent will be brie y discussed in the conclusions.

We consider the construction in the PT approach of the two-loop ferm ion self-energy in QCD. On the one hand, this example is non-trivial in that it involves diagrams with triple gauge vertices all three legs of which are internal. On the other hand, the quark selfenergy is simpler than, e.g., the two-loop gluon self-energy in the PT approach, since (i) the construction of the corresponding PT one-loop function is alm ost trivial, and (ii) the PT twoloop quark self-energy may be obtained from two-loop processes involving no diagram s with tree level four-point functions (quadruple gauge vertices or, possibly, gauge-ghost vertices). The starting point for the construction is the general diagram matic representation of the two-loop quark self-energy in terms of renormalized one-loop two- and three-point function and tree level Bethe-Salpeter-type quark-gluon scattering kernel insertions in the one-loop quark self-energy. In terms of this diagram matic representation, the rst problem above m ay be recast as: how to reorganize consistently the contributions to the two-loop Feynm an integrands involved so as to isolate, rst, the PT one-loop n-point functions occurring as internal corrections, and thence the corresponding PT tree level Bethe-Salpeter-type kernel insertion? It will be shown here how, for the case of the two-loop ferm ion self-energy, this rst problem may be consistently solved and that the solution turns out to be remarkably sim ple.

The paper is organized as follows. In section 2, the construction of the PT gaugeindependent one-loop quark self-energy $i^{(1)}(p)$ is reviewed. In section 3, the general diagram matic representation which provides the basis for the construction of the PT twoloop quark self-energy $i^{(2)}(p)$ is described. In section 4, it is shown how the problem of purely internal triple gauge vertices in the PT is solved for the case in hand, enabling the consistent construction of $i^{(2)}(p)$ starting from the ordinary Feynm an gauge. In section 5, the construction is generalized to the class of arbitrary linear covariant gauges in order to demonstrate explicitly the gauge independence of $i^{(2)}(p)$. In section 6, it is shown that the resulting two-loop function is renormalizable via the explicit calculation of the required two-loop counterterms. It is also shown that the PT two-loop quark self-energy leaves unchanged the position of the pole in the Dyson-summed fermion propagator (to two-loop order), and does not coincide with the self-energy obtained in the BFM at $_Q = 1$. A discussion and conclusions are given in section 7.

2 The pinch technique one-loop quark self-energy

W e begin by review ing the construction of the PT quark self-energy at the one-loop level [3]. This is worthwhile since the technique used here for the rather trivial one-loop case will be extended to the non-trivial two-loop case in the subsequent sections.

W e work in the class of ordinary linear covariant gauges with QCD gauge parameter (= 0 is the Landau gauge). The free gluon and quark propagators are thus given by

respectively, where m is the renorm alized mass of the given quark.³

It will be convenient to introduce transverse and longitudinal projection operators as follow s:

(we work always in d = 4 2 dimensions with thooft mass scale).

In the conventional perturbation theory approach, the renorm a lized one-loop ferm ion selfenergy (two-point function) in QCD is specified by the diagram s shown in Fig. 1:

where C_F is the quadratic Casim ir coe cient for the fundamental representation ($C_F = (N^2 - 1)=2N$ for SU (N)) and g is the renormalized QCD gauge coupling ($_s = g^2=4$). In Eq. (2.5), Z_2 and Z_m are the quark wavefunction and mass renormalization constants,

respectively ($_0 = Z_2^{1=2}$ and $m_0 = Z_m m$, where the subscript 0 denotes bare quantities); the subscript indictes the class of linear covariant gauges, while the superscript (1) denotes the O ($_s$) term in the perturbative expansion. Carrying out the integration, the one-loop functions $\begin{pmatrix} 1 \\ 1 \end{pmatrix}$ and $\begin{pmatrix} 2 \\ 2 \end{pmatrix}$ are given by (cf. e.g. Ref. [12])

where $C_{UV} = 1 + \ln (4)$ _ E, with E Euler's constant, and $L = 1 + (m^2 = p^2) \ln [1 (p^2 = m^2)]$.

In general, and as exemplied by Eqs. (2.7) and (2.8), the conventional self-energy (p;) depends on the particular choice of gauge for all values of the ferm ion four-m om entum p except at p = M where M is the pole mass, de ned from the solution of the transcendental equation

The gauge-independent [13] (and infrared – nite [14]) pole mass M is related in perturbation theory to the gauge-independent renormalized mass m by

where the coe cients c_i are renorm alization scheme- and scale-dependent. For example, in the modi ed m inimal subtraction (\overline{MS}) scheme, from Eq. (2.7), $c_1 = C_F [4 + 3 \ln (2 - M^2)]$, while c_2 may be found in Refs. [15,16].

In the PT approach, the conventional self-energy (2.5) is considered as just one particular correction to a given tree level process 1+2! 3+4 involving the ferm ion as virtual interm ediate state. The construction of the PT ferm ion self-energy is then based on the recognition that the integrands for the conventional vertex and box corrections to this process have well-de ned components with exactly the same estructure as that of the conventional self-energy. These components occur as a result of the presence in the integrands of factors of longitudinal four-m om enture k associated with the gluons A^r (k) propagating in loops. When contracted with the adjacent tree level vertices, these longitudinal factors trigger the associated elem entary W and identities. The triggering of these W and identities results in the rearrangem ent of the propagator and vertex structure of the integrand. A fter system atically contracting all

such longitudinal factors, the contributions to the PT ferm ion self-energy (\e ective" twopoint function) are identied from the resulting integrands by their naive self-energy-like propagator structure.

In order to construct the PT one-loop quark self-energy, we consider the O ($_{\rm s}$) QCD corrections to the lowest order C ompton scattering q ! q of a photon o a quark with electrom agnetic charge Q. The kinem atics of this process are shown in Fig. 2. G iven that the gluons only couple directly with the quark, this is the very simplest process from which to construct the PT quark self-energy. Indeed, the fact that the non-abelian character of the gluons plays essentially no role at the one-loop level in this process willm ake the construction alm ost trivial (one could use more complicated one-loop process involving also purely non-abelian interactions, e.g. the C ompton-like scattering qg ! qg of a gluon o a quark as in [3]). For convenience, the quarks are taken to be on-shell, although this need not be so [6].

The set of six diagrams specifying the one-loop QCD corrections to the tree level scattering process are shown in Figs. 3a{f (the corresponding set of diagram s with crossed external photon legs are not shown, nor are the counterterm insertion diagram s). The QCD contribution to the PT renormalized one-loop quark self-energy (\e ective" two-point function) $i^{(1)}(p)$ is de ned from the coe cient $^{0(1)}(p;k)$ of the component of the integrands for the diagram s in Figs. 3a{f which, after the system atic contraction of all factors of longitudinal internal gluon four-momentum, has the follow ing self-energy-like structure:

In the above expression, Z_2 and Z_m are the quark wavefunction and mass renormalization constants in the PT framework, determined at O ($_{\rm s}$) from the divergence structure of the integral in Eq. (2.13) as d ! 4. It is emphasized that the de nition of the PT \e ective" two-point function is in terms of the Feynman integrands corresponding to the diagrams for the interactions: all rearrangements in the PT are carried out under the integral sign (s).

We rst consider the four diagram s shown in Figs. 3a{d. In order to deale ciently with these one-loop diagram s (and, in later sections, with various two-loop diagram s too) it is convenient to de ne the connected four-point function G^r ($q_1; q_2; q_3; q_4$) specifying the tree level coupling of a gluon A^r (q_1) and a photon A (q_2) to a quark with electrom agnetic charge Q. The two relevant diagram s are shown in Fig. 4:

As indicated in Fig. 3, the sum of the four diagram s $3a\{d m ay be expressed as the sum of all possible contractions of the diagram s 3g and 3h with the diagram s 3i and 3j where the straight (curly) line between these diagram s represents the propagator for the ferm ion (gluon) propagating in the loops. The sum s of the diagram s 3g+ 3h and 3i+ 3j are each just the connected four-point function de ned in Eq. (2.15). Thus, the sum of the four one-loop diagram s <math>3a\{d \text{ for arbitrary} m ay be written as$

(spinors for the on-shell external ferm ions have been om itted). In order to identify the PT e ective" two-point component of these diagram s, it is then necessary to contract system atically the factors of longitudinal gluon four-m om entum occurring in the integrand in Eq. (2.18), triggering the tree level W and identities. U sing the W and identity (2.17), together with the fact that S¹ (p₂) = S¹ (p₄) = 0 for the on-shell external ferm ions, we easily obtain

U sing the elementary W and identity (2.16) for the longitudinal factors k , k $^{\circ}$ occurring in Eq. (2.20), together with S 1 (p₂) = S 1 (p₄) = 0 for the on-shell external ferm ions, we obtain

Having thus contracted all longitudinal factors appearing in the integrands in Eqs. (2.18) and (2.20), the expressions for the two four-point functions may now be substituted into the resulting Eq. (2.22). The PT \e ective" two-point component of the integrand may then be isolated according to the de nition (2.11):

where the + i prescription has been restored in the gluon propagator.

Several rem arks are in order:

(1) In the contribution to the PT self-energy Eq. (2.24) from the diagram s $3a\{d, an elementary cancellation has occurred between (i) the component of the diagram <math>3i$ in which the internal ferm ion propagator S (p) has been cancelled (pinched) by the action of the - dependent longitudinal factor k from the gluon propagator, and (ii) the entire contribution

of the diagram 3j in which the internal ferm ion propagator S (p_4 k) has been cancelled (pinched) by the action of the same factor. This cancellation is illustrated in Fig. 5, and is encoded in the W and identity (2.17) for the four-point function G^r in Eq. (2.18). An identical cancellation takes place for the diagram s 3g and 3h when contracted with the factor k⁰. By dealing with the set of diagram s 3a{d, as opposed to individual diagram s, we have been able to m ake these cancellations among the conventional self-energy, vertex and box functions sim ply and in m ediately. These cancellations have just the tadpole-like term proportional to (1)k⁴ in Eq. (2.19), which is then cancelled algebraically by a sim ilar term in Eq. (2.21) for the external leg corrections.⁴ W hile elementary in the one-loop case, this approach, involving the sim ultaneous consideration of subsets of diagram s, when extended to the two-loop case will greatly facilitate the construction of the PT two-loop quark self-energy in the following sections, in particular the dem onstration of its gauge independence.

(2) Here we have chosen to work in the class of ordinary linear covariant gauges. However, we could have started in any gauge, i.e. with gluon propagator

For example, in the class of non-covariant gauges de ned by adding to the classical lagrangian the gauge- xing term $L_{gf} = (n - A^2)^2 = 2$ for some four-vector n and constant, one has a (q) = n = n - q and $b(q) = (n^2 + q^2) = (n - q^2)$. In all cases, an exactly similar algebraic cancellation takes place among contributions to the PT \e ective" two-point component of the interaction. In particular, all integrands involving terms $(n - k)^1$, $(n - k)^2$ cancel algebraically, and so present no di-culties. Thus, the PT self-energy Eq. (2.24) is fully gauge-independent.

(3) The PT gauge-independent one-loop quark self-energy coincides with that obtained in the conventional Feynm an gauge = 1, which in turn coincides with that obtained in the BFM in the Feynm an quantum gauge $\varrho = 1$ [3]:

This is in fact obvious: in the integrands for the one-loop corrections to the process q ! q, the only sources of factors of longitudinal internal gluon four-m om entum are the gluon propagators. Starting from the gauge = 1, these factors are not present. Thus, for this particular process in this particular gauge, no W and identities are triggered (there is \no pinching"), and one obtains the PT one-loop quark self-energy directly from the conventional self-energy.

(4) The above construction of $^{(1)}$ (p) involved the process q ! q. However, we could have used any one-loop process involving the quark as interm ediate virtual state, i.e. the self-energy Eq. (2.24) is universal.

3 The pinch technique two-loop quark self-energy

We now turn to the 1PI two-bop quark self-energy in the PT approach. In this section, the general diagram matic representation of the two-bop quark self-energy in terms of one-bop two- and three-point function and tree level B ethe-Salpeter-type kernel insertions in the one-loop quark self-energy is described. It is this diagram matic representation which will provide the basis for the explicit construction of the PT two-loop quark self-energy in the subsequent sections.

In order to gain insight, it is instructive to consider rst the renormalized two-loop photon self-energy (vacuum polarization) i ⁽²⁾ (p) in QED. The diagrams which contribute to this function are shown in Fig. 6. In Figs. 6b (g, the two-loop vacuum polarization has been written in terms of renormalized one-loop two- and three-point functions, represented by the grey blobs, inserted in all possible ways in the diagram for the one-loop vacuum polarization is ⁽¹⁾ (p), m inus a contribution involving the lowest order term in the perturbative expansion of the electron-positron scattering kernel K, represented by the grey box, inserted in the diagram for i ⁽¹⁾ (p). The kernel K is characterized by the fact that it has no contributions involving annihilation into a one-particle (photon) intermediate state and is 2P I with respect to the electron-positron pair of lines (cf. e.g. chapter 19 of R ef. [17]). The contribution in Fig. 6g is the two-loop counterterm required nally to renorm alize the two-loop function. The representation in Figs. 6b (g involving the electron-positron scattering kernel for 0 positron scattering kernel follows from the pyson-Schwinger equations for Q ED (cf. in particular Fig. 19.45 of R ef. [17]; for a review of the applications of D yson-Schwinger equations, see R ef. [18]). The diagram s which contribute to the one-loop internal corrections and at low est order to the scattering kernel are in turn

shown in Fig. 7. Substituting the diagram s of Fig. 7 into the representation in Figs. 6b {g, we recover the usual two-loop perturbation theory diagram s for the vacuum polarization as shown in Figs. 6h {o. In particular, in the language of individual two-loop Feynm an diagram s, the e ect of the kernel insertion contribution of Fig. 6f is to compensate for the overcounting which would otherw ise occur due to the two vertex insertion contributions of Figs. 6d and 6e.

For the case of the conventional renormalized two-loop ferm ion self-energy i $^{(2)}(p;)$ in QCD, the diagram s which contribute to this function are shown in Fig. 8. In Figs. 8b{q, the two-loop ferm ion self-energy has been written in terms of renormalized one-loop twoand three-point functions, represented by the grey blobs, inserted in all possible ways in the diagram for the one-loop ferm ion self-energy i (1) (p;), m inus the contribution shown in Fig. 8f involving the grey box inserted in the diagram for $i^{(1)}(p;)$. The representation of the two-loop QCD ferm ion self-energy in Figs. 8b {q is the exact analogue of the representation of the two-bop QED photon self-energy in Figs. 6b {g. In particular, the component represented by the grey box in Fig. 8f consists of all possible ways of coupling an incom ing and an outgoing quark-gluon pair (with external legs truncated) at tree level, except for the contribution involving annihilation into a one-particle (quark) intermediate state. The box in Fig. 8f is thus the lowest order contribution to a Bethe-Salpeter-type kernel V, the analogue for the quark-gluon pair of the lowest order QED electron-positron kernel appearing in Fig. 6f. The contribution in Fig. 8g represents the two-loop counterterm s required nally to renorm alize the two-loop function. The diagram swhich contribute to the one-loop internal corrections in Figs. 8b {e and the tree level Bethe-Salpeter-type quark-gluon kernel in Fig. 8f

are in turn shown in Fig. 9.⁵ Substituting the diagram s of Fig. 9 into the representation in Figs. 8b {g, we recover the usual two-loop perturbation theory diagram s for the conventional quark self-energy as shown in Figs. 8h {r. Just as in the case of the two-loop vacuum polarization, when the representation in Figs. 8b {g is written in term s of individual two-loop Feynm an diagram s, the e ect of the kernel insertion contribution in Fig. 8f is to compensate for the overcounting which would otherwise occur due to the two vertex insertion contributions in Figs. 8d and 8e.

From the point of view of the PT, the signi cance of the diagram matic representations shown in Figs. 6b{g and 8b{g lies in the fact that they provide an entirely general representation of the respective two-loop two-point functions which is: (i) explicitly in terms of renorm alized one-loop corrections to the tree level propagators and vertices occurring in the corresponding one-loop two-point function, these corrections being just those obtained in perturbation theory at the one-loop level; and (ii) symmetric, in the sense that the internal corrections appear inserted in all possible ways in the corresponding one-loop two-point function, so that no orientation of the overall set of diagram s is preferred.⁶ In the case of the two-loop fermion self-energy in the PT framework, it is this symmetric property of the

⁵For the one-loop gluon self-energy in Fig. 9d, the diagram involving the quadruple gauge vertex has been om itted since it vanishes in dimensional regularization.

⁶ It should be pointed out that the symmetric organisations shown in Figs. 6b{g and 8b{g of the contributions to the two-loop photon and quark self-energies di er from the asymmetric organisations obtained directly from the D yson-Schwinger equation for the respective self-energies, expanded out to two-loop order in terms of renormalized one-loop internal corrections (cf. e.g. R ef. [18]). It is precisely the introduction of the kernel insertion contributions which enables the self-energies to be represented in the symmetric way shown in Figs. 6b{g and 8b{g.

representation which will enable the consistent solution of the st problem described in the introduction.

In the above examples, the renormalized one-loop corrections and the tree level kernels, the one-loop diagrams into which they are inserted and the two-loop counterterms are each the gauge-dependent functions obtained in conventional perturbation theory. If the extension of the PT beyond one loop to construct the PT 1PItwo-loop ferm ion self-energy $i^{(2)}(p)$ in QCD is to be consistent, then clearly the one-loop corrections to the tree level propagators and vertices appearing in the contributions to $i^{(2)}(p)$ analogous to Figs. 8b (e must consist of the PT renormalized gauge-independent one-loop corrections inserted in the diagram for the PT gauge-independent one-loop ferm ion self-energy $i^{(1)}(p)$. It then remains to determ ine the PT tree level quark-gluon kernel $\hat{V}^{(0)}$ which appears in the contribution analogous to that in Fig. 8e; and also the required PT two-loop counterterm contributions, analogous to those

⁷ In the case of the vacuum polarization in QED, the corresponding requirement is trivial to satisfy: the PT one-loop n-point functions in QED coincide with those obtained in the ordinary Feynman gauge, so that one has simply to set = 1 in Figs. 6b{f (recall that the vacuum polarization in QED is gauge-independent to all orders).

in Fig. 8f. The contributions to $i^{(2)}(p)$ are thus as illustrated in Fig. 10, in which the hats denote the PT n-point functions, the as-yet-undeterm ined PT quark-gluon kernel and the as-yet-undeterm ined PT two-loop counterterm s.

It is at this point that we encounter the rst problem described in the introduction, concerning purely internal triple gauge vertices in the PT approach. In the PT at the one-loop level, the factors of longitudinal four-m om entum k_1 , k_2 originating from the tree level interaction of an external gluon A^a (q) and two internal gluons A^r (k_1), A^s (k_2) are isolated using the now-familiar decomposition of the triple gauge vertex:

with $q + k_1 + k_2 = 0$. The component ^F by de nition contributes no factors of longitudinal internal four-momentum k_1 , k_2 , and obeys a W and identity $q = (q;k_1;k_2) = (k_2^2 = k_1^2)q$ involving the dimension of two inverse gluon propagators in the Feynman gauge. The terms in ^F have simple interpretations: the term $(k_1 = k_2) = (k_2 = k_1^2)q = k_2 = k_1^2 = k_1^$

The decomposition (3.1) { (3.3) is represented diagram matically in Fig. 11. Using the representation of Fig. 11, the diagram s contributing to the PT one-loop quark self-energy, gluon self-energy and quark-gluon vertex are shown in Fig. 12 (all gluon propagators in Fig. 12 are as in the Feynm an gauge).

In the case of the PT two-bop quark self-energy $i^{(2)}(p)$, the rst problem of section 1 therefore becomes that of how to decompose the triple gauge vertices involved so as to obtain, rst of all, and starting from an arbitrary gauge, the internal one-bop pinch parts required to construct the PT gauge-independent one-bop self-energy and vertex functions of Fig. 12 as the internal corrections shown in Figs. 10b {e. The key to the required rearrangement will turn out to be a second, new decomposition of the triple gauge vertex:

U sing the de nitions (3.2) and (3.3), it is easily veri ed that the above identity indeed holds. This identity is to be compared with the trivial identity relating the diagram in Fig.8m to

the triple gauge vertex contributions to the one-loop vertex corrections in Figs. 8d and 8e and the kernel in Fig. 8f for the case of the conventional two-loop quark self-energy:

In the context of the process q ! q, the construction of the PT renormalized two-loop quark self-energy $i^{(2)}(p)$ may thus be broken down into three steps:

- 1. The rearrangement of the integrands for the conventional two-loop QCD corrections to q ! q to obtain as self-energy-like (\e ective" two-point) components the integrands for the contributions to $i^{(2)}(p)$ involving the PT one-loop n-point functions as internal corrections shown in Figs. 10b {e.
- 2. The isolation of the remaining self-energy-like component of the two-loop corrections to q ! q in order to determ ine the PT tree level quark-gluon kernel $\hat{V}^{(0)}$ appearing in the contribution to $i^{(2)}(p)$ shown in Fig. 10f.
- 3. The calculation of the ultraviolet-divergent part of the contributions in Figs. 10b {f in order to determ ine the PT O ($_{s}^{2}$) renorm alization constants (Z₂ 1) $_{PT}^{(2)}$ and (Z_m 1) $_{PT}^{(2)}$ required nally to renorm alize i⁽²⁾ (p), and show n in Fig. 10g.

We see that, assuming the rst step can be successfully made, the construction of the PT two-loop quark self-energy reduces to obtaining the PT tree level quark-gluon kernel and the required PT two-loop counterterm s.

At this point, it is important to remark that it is by no means clear that, having made the rst of the above steps, the second and third steps can be consistently carried out too. Thus, in the second step, it is not clear that the resulting PT kernel $\hat{V}^{(0)}$ appearing in the diagram 10fw ill, for example, indeed have no contributions involving annihilation into a one-particle (quark) intermediate state. And in the third step, it is not clear that the result in no divergences of the two-bop contributions required in the rst two steps will result in no divergences of the form, for example, 1 ln ($p^{2}=^{2}$) which then cannot be renormalized by local counterterm s.

In the remainder of this paper, it is shown how the construction outlined above can indeed be consistently carried out to obtain the two-loop quark self-energy $i^{(2)}(p)$ in the PT approach. In particular, it is demonstrated that the contributions to the PT tree level quark-gluon kernel $\hat{V}^{(0)}$ are as shown in Fig.13, i.e. exactly those of the conventional Feynm an

gauge quark-gluon kernel except that the triple gauge vertex involves just the component $^{\rm F}$. Thus, when inserted in some diagram, e.g. as in Fig. 10f, the PT kernel provides no factors of longitudinal gluon four-momentum to trigger the W and identities for the adjacent vertices. It is explicitly shown that the PT self-energy i⁽²⁾ (p) thus obtained is gauge-independent at all momenta, is multiplicatively renormalizable by local counterterms and does not shift the propagator pole position (to O ($\frac{2}{s}$)). Furthermore, it is shown that the PT two-loop quark self-energy di ers from that obtained in the BFM at $_{\rm O} = 1$.

4 Construction of i⁽²⁾ (p)

In this section, we consider the nst two steps in the construction of $i^{(2)}(p)$ just outlined. To this end, we consider the O $\binom{2}{s}$ corrections to q ! q consisting of \genuine" two-bop diagram s, i.e. involving two d-dimensional bop momentum integrals. In order to make the required rearrangements, it will be convenient to divide these two-bop diagram s into three distinct classes. Furthermore, for simplicity, we choose here to start from the Feynman gauge = 1; the generalization of the construction to arbitrary will be presented in section 5. We note immediately that in the Feynman gauge the conventional self-energy diagram s 8b and 8h provide directly the required contribution to $i^{(2)}(p)$ of the diagram 10b, involving the renormalized PT one-bop quark self-energy as an internal correction to, in turn, the PT one-bop quark self-energy.

4.1 Two-loop corrections involving one-loop gluon self-energy insertions

We rst consider the two-loop QCD corrections to the process q ! q which consist of one-loop gluon self-energy insertions in the one-loop QCD corrections. The conventional renorm alized one-loop covariant gauge gluon self-energy is specified by the diagram s shown in Figs.9d{h:

In the above expression, ⁰⁽¹⁾ (q;k;) is the gauge-dependent integrand, given directly by the usual covariant gauge Feynm an rules for the diagram s 9e{g, while the last term is the O ($_{\rm s}$) contribution of the covariant gauge counterterm diagram 9h, where Z₃ is the gluon wavefunction renorm alization constant ($A_0^{\rm a} = Z_3^{1=2} A^{\rm a}$). The integrand in Eq. (4.1) may be written as the di erence between the integrand $^{0(1)}$ (q;k) for the PT gauge-independent one-loop gluon self-energy and the integrand $^{0(1)}$ (q;k;) for the gauge-dependent \pinch part" of the conventional self-energy:

The pinch part $^{0(1)}(q;k;)$ of the conventional self-energy is that which is cancelled by the gauge-dependent self-energy-like pinch part + $^{0(1)}(q;k;)$ of the integrands for one-loop vertex and box diagrams in the PT at the one-loop level. This cancellation leaves $^{0(1)}(q;k)$

as the integrand for the unrenormalized PT gauge-independent one-loop gluon \e ective" two-point function. The PT integrand $^{0(1)}(q;k)$ coincides [9] with that obtained using the Feynman rules of the BFM [10] with $_{Q} = 1$.

In the particular case of the Feynman gauge = 1, the pinch part of the self-energy integrand (4.1) is given by⁹

In the above expressions, C_A is the quadratic C asim ir coe cient for the adjoint representation $(C_A = N \text{ for SU } (N))$. We note that the integrand (q;k;1) is explicitly transverse.

The set of two-loop diagrams for the O ($\frac{2}{s}$) QCD corrections to q ! q which involve the unrenormalized one-loop gluon self-energy as internal corrections are shown in Figs. 14a {f (the corresponding set of diagrams with crossed photon legs are not shown). Just as in the case of the one-loop QCD corrections to q ! q discussed in section 2, and as indicated in Fig. 14, the sum of the four diagram s 14a {d m ay be expressed as the sum of all possible contractions of the diagram s 14g and 14h with the diagram s 14i and 14j, where the curly line with the grey blob between these diagram s represents the unrenormalized one-loop-corrected covariant gauge gluon propagator. The sum s of the diagram s 14g+ 14h and 14i+ 14j are again each just the connected four-point function de ned in Eq. (2.15). Thus, the sum of the four two-loop diagram s 14a {d for arbitrary m ay be written

Eq. (4.6) is precisely the two-bop analogue of Eq. (2.18); the two expressions di er only by the fact that, instead of the tree level gluon propagator in (2.18), there appears the one-bop-corrected gluon propagator in (4.6).

Substituting in (4.6) the decomposition (4.2) of the gluon self-energy integrand, and then using the expression (4.4) for the case of the Feynman gauge gives

We now contract the longitudinal factors k_1 , k_1° which appear explicitly in the transverse tensor t^o(k_1) in (4.7), triggering the W and identity (2.17) obeyed by the four-point functions G^r , G^r_{\circ} . Using this W and identity, together with the fact that S^1 (p_2) = S^1 (p_4) = 0 for the on-shell external ferm ions, one obtains

W e again substitute the decom position (4.2) for the gluon self-energy integrand, and then the expression (4.4) for the particular case of the Feynm an gauge. The rst term in Eq. (4.12) is the two-loop integrand required for the contribution to $i^{(2)}(p)$ of the diagram 10c, involving the PT one-loop gluon self-energy insertion in the PT one-loop ferm ion self-energy, here embedded in the process q ! q. The second term in Eq. (4.12) is the $g \circ com$ ponent of the pinch part $0 \circ 0$ of the conventional = 1 self-energy, the $k_1 k_1 \circ 0$ com ponent having exactly cancelled am ong the diagram s 14a{f as just described. In the next subsection, it will be shown how this second term is exactly cancelled by pinch contributions from the two-loop diagram s involving a single triple gauge vertex.

4.2 Two-loop corrections involving one triple gauge vertex

We next consider the O ($\frac{2}{s}$) QCD corrections to q ! q consisting of two-loop diagrams involving a single triple gauge vertex. Eight of the set of ten such corrections are shown in Figs. 15a{h (the remaining two are external leg corrections which, in the Feynman gauge, make no contribution to the \e ective" two-point component of the interaction; as before, there is also a corresponding set of diagram s with crossed external photon legs). A sindicated in Fig. 15, the sum s of the diagram s 15a{d, 15e+ 15f and 15g+ 15h m ay be written in term s of the tree level four-point function de ned in Eq. (2.15). It is for these two-loop diagram s that we shall use the decom position of the triple gauge vertex given in Eq. (3.4).

where $(k_1;k_2;k_3)$ is the triple gauge vertex appearing in Fig. 15k, with $k_1 + k_2 + k_3 = 0$. The decomposition (3.4) substituted directly into the expression (4.13) for Figs. 15a{d is represented diagram matically in Fig. 16. In particular, the four terms on the right hand side of Eq. (3.4) are shown in Figs. 16c{f, respectively. We now consider the contraction of the diagram s 16a+16b and 16g+16h with each of the four diagram s 16c{f in turn (the contractions will be represented by the symbol).

The rst term 2 ^{P;} $(k_3;k_1;k_2) = 2k_1g$ $2k_2g$ from the decomposition (3.4) is shown in Fig. 16c. Substituting this term into the expression (4.13), then using the W and identity (2.17), together with S¹ $(p_2) = S^1 (p_4) = 0$ for the on-shell external ferm ions, and also f^{rst}T^sT^tT^r = $\frac{1}{2}iC_AC_F$, one obtains

The four terms on the rhs. of Eq. (4.14) are represented in Figs. 16i, 16j, 16n and 16r, respectively. Each of these four terms involves an internal one-bop gluon self-energy-like pinch part: the rst two terms, shown in Figs. 16i and 16j, are internal pinch contributions to the conventional one-bop gluon self-energy insertion in the quark self-energy correction shown in Fig. 14a, i.e. they are contributions to the PT two-bop \e ective" two-point com ponent of the interaction; and the third and fourth terms, shown in Figs. 16n and 16r, are internal pinch contributions to the conventional one-bop gluon self-energy insertion in the vertex corrections shown in Figs. 14b and 14c, respectively. Isolating just the rst two terms from Eq. (4.14), m aking the change of variables $k_1 \leq k_2$ in the second and then using Eq. (4.5) gives the \e ective" two-point com ponent of the integrand:

We immediately see that the contribution Eq. (4.15) exactly cancels the g \circ component of the pinch part ${}^{0(1)}_{0}$ of the conventional Feynman gauge one-loop gluon self-energy in Eq. (4.12). This cancellation leaves in Eq. (4.12) precisely the required integrand ${}^{0(1)}_{0}$ (k₁;k₂) for the unrenormalized PT gauge-independent one-loop gluon self-energy insertion. Adding the diagram 8i, with the PT one-loop renormalization constant (Z₃ 1)⁽¹⁾_{PT} as the gluon self-energy counterterm insertion, we have therefore succeeded in obtaining the contribution to the PT two-loop quark self-energy in ${}^{\circ(2)}$ (p) of the diagram 10c, involving the renormalized PT one-loop gluon self-energy, embedded in the process q ! q.

The second and third terms ^F $(k_1;k_2;k_3)$ and ^F $(k_2;k_3;k_1)$ from the decomposition (3.4) are shown in Figs. 16d and 16e. The corrections to q ! q from these two components of the triple gauge vertex in Eq. (4.13) are represented diagram matically in Figs. 16k, 16o, 16t and 16v and Figs. 16l, 16p, 16s and 16w, respectively. The contributions represented in Figs. 16k and 16lare self-energy-like (\e ective" two-point) corrections to the process. We see in mediately that they give precisely the contribution of the diagram 14c to the PT one-loop quark-gluon vertex insertions appearing in the diagram s 10d and 10e, respectively, for the PT two-loop quark self-energy i⁽²⁾ (p), embedded in the process q ! q . The contributions represented in Figs. 16o, 16p, 16s and 16t are vertex-like corrections to q ! q, while those in Figs. 16v and 16w are box-like corrections.

The last term ^F $(k_3;k_1;k_2)$ from the decomposition (3.4) is shown in Fig. 16f. The corrections to q ! q from this component of the triple gauge vertex in Eq. (4.13) are represented in Figs. 16m, 16q, 16u and 16x, including explicitly in each case the associated m inus sign. The contribution in Fig.16m is a self-energy-like correction; those in Fig.16q and 16u are vertex-like corrections; and that in Fig.16x is a box-like correction. Having obtained, as just described, the required contributions from the diagram s of Fig. 15, thence Fig. 16, to the diagram s 10b {e for the PT two-loop ferm ion self-energy i⁽²⁾ (p), the self-energy-like contribution of Fig.16m is a contribution to the diagram 10f involving the PT quark-gluon kernel $\hat{V}^{(0)}$, all embedded in the process q ! q. The contribution of Fig.16m thus gives the component of the PT kernel shown in Fig.13b, involving just the component ^F of the triple gauge vertex.

There remain from Fig.15 the diagram $s 15e\{h. In the Feynman gauge, the sum of these diagram s m ay be written$

with $k_1 + k_2 + k_3 = 0$. For these diagrams, we again use the decomposition (3.4) for the triple gauge vertex in Eq. (4.16). It is found that, in the Feynman gauge, the diagrams 15e{h make no contribution to the PT self-energy-like (\e ective" two-point) component of the process q ! q. Instead, the rst term 2^{P_i} ($k_3;k_1;k_2$) from Eq. (3.4) results in a pair of two-bop vertex corrections sim ilar and identical in magnitude to the diagrams 16n and 16r involving internal one-bop gluon self-energy-like pinch parts, together with a pair of two-bop external leg corrections, also involving internal one-bop gluon self-energy-like pinch parts. The rem aining three terms from the decom position Eq. (3.4) of the triple gauge vertex in Eq. (4.16) produce twelve diagram s, corresponding to the three di erent F components from Eq. (3.4) substituted for the triple gauge vertices in the diagram s 15e{h (the orientations and signs should be clear).

4.3 Two-loop gluonic corrections involving no triple gluon vertices

Finally, we consider the O ($\frac{2}{s}$) gluonic corrections to q ! q consisting both of one-particleirreducible and one-particle-reducible two-loop diagram s with no triple gauge vertices. The set of such QED-like diagram s are shown in Fig. 17 (the diagram s from this set which are purely external leg corrections are not shown; nor, as always, are the corresponding diagram s involving crossed external photon legs). In the Feynm an gauge = 1, there appear no factors of longitudinal gluon four-momentum in the corresponding two-loop integrands for these diagram s. Thus, in this gauge, no W ard identifies are triggered (there is \no pinching"), and the diagram s in Fig. 17 contribute directly to the PT two-loop self-energy, vertex and box corrections to q ! q as shown. In particular, the only two contributions to the PT 1PI two-loop quark self-energy (\e ective" two-point) correction are from the diagram s 17a and 17b (the diagram $17a^0$ gives the one-particle-reducible chain of two PT one-loop quark self-energies).

From the diagram 17a, adding the corresponding diagrams involving the PT one-loop ferm ion self-energy counterterms $(Z_2 \ 1)_{PT}^{(1)}$ and $(Z_m \ 1)_{PT}^{(1)}$, we immediately obtain the required contribution to the PT two-loop ferm ion self-energy i⁽²⁾(p) of Fig. 10b, involving the renormalized PT one-loop quark self-energy as an internal correction to, in turn, the PT one-loop quark self-energy, all embedded in the process q ! q. This is as remarked at the beginning of this section.

From the diagram 17b, however, we rst have to add and subtract another identical such contribution. In this way, we obtain from twice the diagram 17b the required contribution of the diagram 12j to the PT one-loop quark-gluon vertex insertions appearing in the diagram s 10d and 10e, respectively, for i⁽²⁾ (p), allem bedded in the process q ! q. It then remains to subtract again the contribution of the diagram 17b to avoid overcounting. Having now obtained all of the required contributions to the diagram s 10b {e, this subtracted contribution to i⁽²⁾ (p) is a contribution to the the diagram 10f involving the PT quark-gluon kernel $\hat{V}^{(0)}$, again all embedded in the process q ! q. The contribution of m inus Fig. 17b thus gives the component of the PT kernel shown in Fig. 13c.

4.4 Remarks

The analysis presented in this section m ay be sum m arized and com m ented upon as follows:

(1) In section 4.1, the longitudinal $k_1 k_1 \circ component of the pinch part <math>\binom{0(1)}{0} (k_1; k_2; 1)$ of the Feynm an gauge one-loop gluon self-energy insertion exactly cancelled among the integrands in Eqs. (4.6) and (4.9) for the diagram s 14a {f. This algebraic cancellation is identical to the cancellation of the longitudinal k k \circ component of the lowest order gluon propagator among the integrands in Eqs. (2.18) and (2.20) for the diagram s 3a {f, described in section 2 for the construction of the PT one-loop quark self-energy.

(2) In section 4.2, the elementary decomposition Eq. (3.4) of the triple gauge vertex, substituted into Eq. (4.13) for the diagram s 15a{d, provided precisely the required contributions to $i^{(2)}(p)$ of the diagram s 10c{e involving the PT one-loop gluon self-energy and quarkgluon vertex internal corrections, and also a contribution to the diagram 10f involving the PT quark-gluon kernel insertion:

The rst term 2^{P} $(k_3;k_1;k_2)$ provided the longitudinal factors which gave the twoloop self-energy-like (\e ective" two-point) contributions shown in Figs. 16i and 16j involving internal one-loop gluon self-energy-like pinch parts. These contributions exactly cancelled the g \circ component of the pinch part $\binom{0(1)}{\circ}(k_1;k_2;1)$ of the Feynm an gauge one-loop gluon self-energy appearing in Fig. 14a. This cancellation, together with that described in section 4.1, left just the required contribution to $i^{(2)}(p)$ of the diagram 10c, involving the PT one-loop gluon self-energy insertion.

The second and third terms ^F $(k_1;k_2;k_3)$, ^F $(k_2;k_3;k_1)$ gave the two-bop selfenergy-like contributions shown in Figs. 16k and 16l. These contributions provided just the required triple gauge vertex component of the contribution to $i^{(2)}$ (p) of the diagram s 10d and 10e, involving the PT one-bop quark-gluon vertex insertions.

The last term ^F $(k_3;k_1;k_2)$ gave the two-loop self-energy-like contribution shown in Fig. 16m. Having obtained the required terms involving triple gauge vertices in the contributions to $i^{(2)}(p)$ of the diagram s 10c{e, this term provided a contribution to the diagram 10f, involving the PT tree level quark-gluon kernel insertion. This contribution to the PT quark-gluon kernel is shown in Fig. 13b.

It is remarkable that the elementary decomposition Eq. (3.4) of the triple gauge vertex not only results in the required components of the diagram s 10c{e, but also that the remaining two-loop ferm ion self-energy-like contribution, allocated to the PT kernel insertion diagram 10f, involves just the component ^F of the triple gauge vertex, and appears autom atically with the appropriate m inus sign. Thus, as in the PT at one loop, all tree level triple gauge vertices which occur in the PT two-loop quark self-energy i⁽²⁾ (p) involve only the component ^F of the triple gauge vertex, given in Eq. (3.2).

(3) In section 4.3, the diagram s 17a and 17b provided just the required QED -like components of the contributions to $i^{(2)}(p)$ of the diagram s 10b, 10d and 10e involving the PT one-loop ferm ion self-energy and quark-gluon vertex internal corrections, and also a second

contribution to the diagram 10f involving the PT quark-gluon kernel insertion. This contribution to the PT quark-gluon kernel is shown in Fig. 13c. G iven that in the Feynman gauge there occur no longitudinal factors in the integrands for the diagram s of Fig. 17, this was trivial.

(4) The resulting PT tree level Bethe-Salpeter-type quark-gluon kernel thus corresponds, as stated in section 3, to the diagram s shown in Fig. 13:

It is emphasized that, having obtained the required contributions to $i^{(2)}(p)$ shown in Figs. 10b {e, the PT kemel insertion contribution shown in Fig. 10f emerged immediately as the remaining self-energy-like component of the two-loop diagrams, without any further rearrangement. It is seen from Fig. 13 that the PT kemel indeed has no contributions involving annihilation into a one-particle (quark) intermediate state. Furthermore, and as already stated in section 3, the fact that the diagram 13b involves only the component ^F of the triple gauge vertex, with the internal gluon propagator as in the Feynman gauge, means that the PT tree level quark-gluon kemel $\hat{V}^{(0)rs}(p;k_1;k_2)$ provides no factors of longitudinal gluon four-momentum k_1 , k_2 associated with the external gluon legs $A^r(k_1)$, $A^s(k_2)$. When inserted in some diagram, e.g. as in Fig. 10f, the PT kemel therefore does not trigger any W ard identifies, and so does not cause any further PT rearrangement (it triggers no \pinching").

W ith hindsight, this is seen to be crucial for the consistency of the PT algorithm at the two-loop level. For if, having obtained the required contributions to $i^{(2)}(p)$ shown in Figs. 10b (e, thus accounting for the rst three terms on the rh.s. of the decom position (3.4) of the triple gauge vertex appearing in Fig. 15k, the remaining term in (3.4) had involved further longitudinal factors k_1 , k_2 , then these factors would have produced further internal one-loop pinch parts. The allocation of the contributions to Figs. 10c (e would then have been am biguous.

(5) The conventional tree level quark-gluon kernel shown in Figs. 9m (o can be written in term softhe PT kernel as

Thus, for the case of tree level quark-gluon scattering in which both the incoming and outgoing gluons are on-shell, the amplitudes given by the PT and conventional kernels for the contributions not involving a one-particle (quark) intermediate state exactly coincide. (6) A lthough not explicitly considered here, it requires only a little more e ort to obtain the two-loop QCD contributions to the PT quark-photon vertex (\e ective" three-point function), quark-photon box (\e ective" four-point function) and quark external leg corrections to q ! q . In contrast to the case of the self-energy component, some or all of the external legs of these functions are on-shell. In the particular case of the QCD contribution to PT two-loop quark-photon vertex $^{(2)}$, this function is given by attaching an external photon leg in all possible ways to the internal ferm ion lines occurring in the diagram s for the PT two-loop quark self-energy $i^{(2)}$. It is then straightforward to verify the sim ple QED-like W ard identity for these two-loop functions:

where $q + p_1 = p_2$. Furthermore, the two-bop external quark leg corrections are given by precisely the same self-energy function $i^{(2)}$ as that just obtained from the \e ective" two-point component of the process. These two facts are also essential for the consistency of the PT approach.

5 Gauge independence of $i^{(2)}(p)$

In this section, we again consider the rst two steps in the construction of $i^{(2)}(p)$ outlined at the end of section 3, but now starting from an arbitrary linear covariant gauge, i.e. arbitrary . It is explicitly shown that the PT two-loop quark self-energy constructed in the previous section starting from the Feynman gauge = 1 is in fact -independent. The strategy is to show that the additional contributions to the PT self-energy-like (\e ective" two-point) component of the interaction q ! q which occur when one moves away from the Feynman gauge exactly cancel among them selves. This cancellation takes place at the level of the two-loop integrands. In order to demonstrate this cancellation, it will again be convenient to deal separately with the three classes of two-loop QCD corrections to q ! q considered in sections 4.1, 4.2 and 4.3, respectively.

5.1 Two-loop corrections involving one-loop gluon self-energy insertions

The set of diagram s for the two-loop corrections to q ! q involving unrenorm alized one-loop gluon self-energy insertions are as shown already in Figs. 14a{f. Using the usual covariant gauge Feynm an rules for the diagram shown in Fig. 9e, the integrand in Eq. (4.1) for the conventional one-loop covariant gauge gluon self-energy may be written

In Eq. (5.4), the contributions to $^{0(1)}$ (q;k;), hence $^{0(1)}$ (q;k;), which occur for € 1 have been written as three distinct components. In the construction of the PT one-loop gauge-independent gluon self-energy starting from a four-ferm ion process, these terms are distinguished as follows: the component $^{0(1)}_{1;}$ (q;k;) is that which is cancelled by the € 1 self-energy-like pinch parts of the conventional one-loop vertex diagram s involving the $^{0(1)}_{1;}$

triple gauge vertex; the component ${}^{0(1)}_{2;}$ (q;k;) is that which is cancelled by the \pounds 1 selfenergy-like pinch parts from the conventional one-loop box diagram s plus the conventional one-loop vertex diagram s not involving the triple gauge vertex (i.e. the QED -like diagram s); and the remaining component ${}^{0(1)}_{3;}$ (q;k;), purely longitudinal i.e. proportional to q q, vanishes when the external ferm ions are on-shell, as is the case in the S-m atrix PT. For the purely longitudinal pinch part term ${3 \atop 3}^{0(1)}$ $(k_1;k_2;)$ in Eq. longitudinal factors from the pinch part $k_1^2 t (k_1) = 0(1) (k_1; k_2; 1)$ of the one-loop-corrected gluon propagator in Eq. (4.7) for Figs. 14a{d in the Feynm an gauge. Thus, using the W and identity Eq. (2.17), the i = 3 term in Eq. (5.10) results in a p-independent contribution which is cancelled algebraically by two corresponding contributions from the expression Eq. (4.9) for Figs. 14e and 14f. The term $\binom{0(1)}{3} (k_1; k_2;)$ therefore m akes no net contribution to the process q ! q.

The remaining i = 1;2 pinch part terms in Eq. (5.10) are neither purely longitudinal nor purely proportional to g^{\circ}. At this point, we could project out the $k_1 k_1^{\circ}$ and g^{\circ} components $k_1; k_2;$), i = 1;2. The purely longitudinal components would then each give no of $_{3}$ $(k_{1};k_{2};$). This would leave just the g $^{\circ}$ components net contribution, as in the case of in Eq. (5.10). In Fig. 14a, these latter are then a contribution to the PT self-energy-like component of the process, in Figs. 14b and 14c they are contributions to the PT vertexlike component of the process and in Fig. 14d they are a contribution to the PT box-like component of the process. The task would then be to show that these g $^{\circ}$ components are cancelled by corresponding terms from the remaining two-loop diagrams in Figs. 15 and 17. $_{i}^{0(1)}$ (k₁;k₂;), However, we shall show in the next two subsections that the full functions i = 1;2, in fact emerge naturally from the remaining two-loop diagrams in exactly the form of Eq. (5.10) but with the opposite sign. The cancellation of the one-loop gluon self-energy $k_1; k_2;$), i = 1; 2, therefore occurs in mediately, and there is thus no pinch parts need to do make this projection.

5.3 Two-loop diagram s involving no triple gauge vertices

Finally, we consider the two-loop gluonic corrections to q ! q consisting of diagram s with no triple gauge vertices. The sets of one-particle-irreducible and one-particle-reducible such diagram s are as shown already in Figs. 17a{z and 17a⁰{1⁰</sup>, respectively.

In order to deal e ciently with the diagram s $17a\{z, \text{ it is very convenient to de ne the connected \abelian-like" ve-point function G^{rs} (q₁;q₂;q₃;q₄;q₅), specifying the tree level coupling of a pair of gluons A^r(q₁), A^s(q₂) and a photon A^r(q₃) to a quark with electrom agnetic charge Q via quark-gauge boson vertices only, i.e. excluding triple gauge vertices. The six relevant diagram s are as shown in Fig. 18:$

We have thus succeeded in showing (i) that in the integrands for each of the two-bop QCD corrections to q ! q shown in Figs. 14a{d, the additional pinch parts of the conventional one-bop gluon self-energy insertion which occur for \notin 1 are each exactly cancelled by corresponding pinch terms from the remaining two-bop corrections shown in Figs. 15a{h and 17a{1⁰, and (ii) that this cancellation exhausts the additional terms from the corrections shown in Figs. 15 and 17 which occur for \notin 1 (for sim plicitly, this latter was only shown explicitly up to term s which are two-bop external leg corrections).

In the particular case of the PT self-energy-like component of the process q ! q, we have thus explicitly demonstrated the gauge independence of the contributions of the two-loop diagram s in Figs. 14, 15 and 17 to the PT two-loop quark self-energy $i^{(2)}(p)$.

5.4 Remarks

We nish this section with two remarks:

(1) At the one-loop level, the simple technique used in section 2 to implement the PT simultaneously among subsets of diagrams, rather than individual diagrams, lead to little saving of e ort. At the two-loop level, by contrast, with several dozen diagrams and more factors of longitudinal gluon fourmomentum to deal with, this technique enormously facilitated the implementation of the PT. Furthermore, by grouping the diagrams for the two-loop QCD corrections to q ! q as in the above three subsections, the gauge cancellation mechanism which results in the gauge independence of the PT two-loop quark self-energy in $^{(2)}$ (p)

is seen to be essentially the same as that which results in the gauge independence of the PT one-loop gluon self-energy $i^{(1)}(p)$; only here, the PT one-loop gluon self-energy occurs as internal corrections in a two-loop process. This fact is consistent with the analysis of R ef. [6], where it was shown that the PT one-loop gluon self-energy may be obtained from one-loop processes in which the \external" elds are explicitly o -shell, i.e. the process does not constitute a one-loop S-m atrix element, as in the S-m atrix PT [2]. Indeed, the diagram matic technique used here is the extension to two loops of that used in R ef. [6].

(2) In the above analysis, we did not consider the O ($\frac{2}{s}$) QCD corrections to q ! q consisting of one-loop diagram s with one-loop counterterm insertions. These counterterm insertions are, of course, those obtained in the PT at one loop. For the diagram s involving the one-loop quark-gluon vertex, quark wavefunction or quark m ass renorm alization constants $(Z_1 \ 1)_{PT}^{(1)}$, $(Z_2 \ 1)_{PT}^{(1)}$ and $(Z_m \ 1)_{PT}^{(1)}$, respectively. the in plem entation of the PT algorithm, in particular the gauge cancellation m echanism, is precisely as for the O ($_s$) QCD corrections to q ! q described in section 2. However, the counterterm corresponding to the one-loop gluon wavefunction renorm alization has the form

i.e. it is transverse. This follows from the fact that the PT one-loop gluon self-energy is transverse. When the counterterm (5.24) is contracted with a pair of tree level gluon propagators, the gauge-dependent longitudinal parts of the propagators thus vanish.¹¹ There remain, how ever, the longitudinal factors from the counterterm itself. If, as here, the \induced" longitudinal factors from the PT one-loop gluon self-energy insertions are not to be used to trigger the PT rearrangement, then clearly the corresponding longitudinal factors from the counterterm (5.24) m ust not be used either; for to do so would spoil the renorm alizability of the PT two-loop quark self-energy (cf. section 6).

6 Renormalization of $i^{(2)}(p)$

Finally, we consider the third and last step outlined in section 3, viz. the calculation of the O ($_{s}^{2}$) renorm alization constants (Z₂ 1) $_{PT}^{(2)}$ and (Z_m 1) $_{PT}^{(2)}$ required to renorm alize the PT two-bop quark self-energy. For this task, we shall make use of Z₁, Z₂, Z₃ and Z_m to O ($_{s}^{2}$) in both the class of linear covariant gauges and the PT, and also Z₂ and Z_m to O ($_{s}^{2}$) in the class of linear covariant gauges. In the minimal subtraction (M S) scheme, with n_f active avours of ferm ion, the O ($_{s}^{2}$) terms are given by [2,20]

However, having explicitly constructed $^{(2)}$ (p) in the previous sections directly from subsets of diagram s, rather than via the consideration of the pinch parts of individual vertex and box diagram s, we will here obtain ⁽²⁾ (p) simply as the di erence between the PT and conventional self-energies. Given the above renorm alization constants, together with the fact that the renorm alized function ⁽²⁾ (p;) is nite, it is then su cient to determ ine the counterterm contributions required to make nite the function

This is just the cancellation described in section 4.2. Carrying out the k₂ integration in Eq. (6.6), and substituting the expressions (6.1) for the O ($_{s}$) renorm alization constants, the sum of the expressions (6.6) { (6.9) m ay be written

U sing Eqs. (6.4) and (6.13), the PT renorm alized gauge-independent two-loop quark selfenergy $i^{(2)}(p)$ in the MS schemer may be written in terms of the corresponding conventional Feynman gauge self-energy as

The integral expression Eq. (6.16) is our nal result.

We nish this section with three remarks:

(1) In this section, we have shown by explicit calculation that the two-loop quark selfenergy obtained in the PT is multiplicatively renormalizable by local counterterms. It is emphasized that this result was not obvious a priori. In particular, the worry was that the rearrangements which gave the contributions to $i^{(2)}(p)$ shown in Figs. 10b{fwould result in divergent term softhe form, e.g., $1 \ln (p^2 = 2)$ which then could not be cancelled by local counterterms, shown in Fig. 10g.

(2) From Eq. (6.16), given that S¹ (p) vanishes at p = m, it is immediately clear that the PT two-loop quark self-energy does not shift the position of the propagator pole (to 0 ($\frac{2}{s}$)):

This is an essential requirement for the consistency of the PT approach, and is in fact expected on rather general grounds [4].

(3) The quark self-energy obtained in the BFM with quantum gauge parameter $_{Q}$ coincides with that obtained in the class of linear covariant gauges with gauge parameter = $_{Q}$

to all orders¹² in perturbation theory: $i_{BFM}^{(n)}(p; Q) = i_{Q}^{(n)}(p; = Q)$. At the two-loop level, we therefore obtain im mediately from Eq. (6.16)

We thus conclude that the correspondence between the PT gauge-independent n-point functions and those obtained in the BFM in the Feynm an quantum gauge $_Q = 1$ does not persist beyond one loop.

7 Summary and Conclusions

The extension of the pinch technique (PT) beyond the one-loop approximation requires the solution of the two problems described in the introduction: (1) how to deal consistently with triple gauge vertices all three legs of which are associated with gauge elds propagating in loops; and (2) whether or not to use the \induced" longitudinal factors from internal loop corrections to trigger further the PT rearrangement, and, if so, how. In this paper, it has been shown how the rst of these problems is consistently solved for the simplest non-trivial case, viz. the construction in the PT approach of the 1PI two-loop fermion self-energy in $^{(2)}$ (p) in QCD.

We began (section 2) by reviewing the construction of the PT gauge-independent one-loop quark self-energy $i^{(1)}(p)$ [3]. This function was obtained from the \e ective" two-point component of the integrands for the one-loop QCD corrections to the C ompton scattering q ! q of a photon o a quark. The fact that gluons do not couple directly to the photons meant that, for the construction of $i^{(1)}(p)$, this process was considerably simpler than, e.g., the C ompton-like scattering qg ! qg of a gluon o a quark. A though the one-loop case was almost trivial, this review was useful in order to introduce the simple technique used subsequently at two loops to implement the PT simultaneously among subsets of diagram s, rather than individual diagram s.

We then turned to the construction of the 1PI two-loop quark self-energy $i^{(2)}(p)$ in the PT approach. By investigating here only the rst of the above problem s, it was e ectively assumed that the correct approach to the second problem will turn out to be not to use the \induced" longitudinal factors to trigger further the PT rearrangement. Thus, \the PT " here referred to the PT algorithm implemented using longitudinal factors only from lowest order gauge eld propagators and triple gauge vertices.

The starting point for the construction (section 3) was the general diagram m atic representation of the renorm alized two-loop quark self-energy in terms of renorm alized one-loop twoand three-point function and tree level B ethe-Salpeter-type quark-gluon scattering kernel insertions in the one-loop quark self-energy, shown in F igs. 8b {g for the case of the conventional self-energy. This representation is precisely analogous to the fam iliar representation [17] of the renorm alized two-loop QED photon self-energy (vacuum polarization) in terms of renormalized one-loop two- and three-point function and tree level electron-positron scattering

kernel insertions in the one-loop photon self-energy, shown in Figs. 6b {g. The signi cance of these representations is two-fold: rst, they are explicitly in terms of renormalized one-loop n-point functions obtained in perturbation theory at the one-loop level; and second, they are symmetric, in the sense that no orientation of the overall sets of diagrams is preferred. This latter property, m ade possible by the introduction of the kernel insertion contributions, would appear to be essential for the consistent solution of the rst problem for the case of the two-loop quark self-energy in the PT approach.

In order for the PT approach to be consistent, it was not of all required that the contributions to $i^{(2)}(p)$ analogous to those shown in Figs. 8b (e for the conventional case consist of the PT renorm alized gauge-independent one-loop n-point functions appearing as internal corrections in the PT gauge-independent one-loop quark self-energy $i^{(1)}(p)$. It then remained to determ ine the PT analogue of the contribution in Fig. 8f involving the tree level quark-gluon kernel; and nally the PT analogue of the two-loop counterterm insertions shown in Fig. 8g. The contributions to $i^{(2)}(p)$ are thus as shown in Figs. 10b (g.

In order to carry out the explicit construction of $i^{(2)}(p)$ (section 4), we considered the two-loop QCD corrections to q ! q, starting from the Feynman gauge. The key to the construction was the elementary decomposition Eq. (3.4) of the triple gauge vertex which occurs in the two-loop diagrams shown in Figs. 15a{h. It was shown that this decomposition not only results in precisely the internal one-loop gluon self-energy-like pinch parts and triple gauge vertex components ^F required to obtain the contributions to $i^{(2)}(p)$ shown in Figs. 10c{e, involving the PT one-loop internal corrections; but also the contribution to the PT quark-gluon kernel, obtained from the remaining two-loop self-energy-like component of Figs.15a{h, involves just the component ^F of the triple gauge vertex which occurs in the PT one-loop functions. The resulting PT tree level kernel, shown in Fig. 13, thus provides no factors of longitudinal fourm om entum associated with the external gluon legs. As explained at the end of the section (fourth remark), this is crucial to the consistency of the PT construction.

In order to demonstrate the gauge independence of $i^{(2)}(p)$ (section 5), we again considered the two-loop QCD corrections to q ! q, but now starting from arbitrary . W ith ϵ 1, there then occurred m any further factors of longitudinal gluon four-m on entum in the corresponding Feynman integrands. In the case of the forty-six two-loop diagram s shown in Figs. 15 and 17, these factors were e ciently dealt with by writing the diagram s in terms of tree level four- and ve-point functions contracted together via quark and gluon propagators. U sing the W and identities for these tree level n-point functions, we were then able to im plement the PT directly am ong entire subsets of these diagram s, rather than diagram -by-diagram . In this way, we were able to demonstrate the algebraic cancellation of the additional contributions which occur for ϵ 1 not only to the 1PI two-loop self-energy-like com ponent of the process, but also the vertex-like and box-like com ponents. The gauge independence of $\Delta(n)$

 $i^{(2)}$ (p) was thus explicitly demonstrated in the class of linear covariant gauges.

In order to obtain the two-loop renorm alization constants required nally to renorm alize $i^{(2)}(p)$ (section 6), rather than evaluating the divergent part of the diagram s in Figs. 10b{f directly, we computed only the di erence between the divergent part of these diagram s and

that of the corresponding conventional self-energy diagrams in Figs. 8b{f in the Feynman gauge. Knowing the two-loop Feynman gauge counterterms, we were then able to obtain the required two-loop PT counterterms. In this way, it was explicitly shown that the PT two-loop quark self-energy $i^{(2)}(p)$ is renormalizable.

Before nishing, we brie y turn to the second problem outlined in the introduction. It is clear from the analysis in sections 2 and 4 that if the integrand ${}^{0(1)}{}^{\circ}(k_1;k_2;)$ for the conventional one-loop gluon self-energy insertions shown in Figs. 14a{fand given in Eqs. (4.6) and (4.9) is explicitly written in terms of the transverse tensor $k_1^2 g {}^{\circ} k_1 k_1^{\circ}$, then the entire longitudinal $k_1 k_1^{\circ}$ component exactly cancels among the integrands for the six diagrams. This cancellation is identical to that of the longitudinal component of the træe level gluon propagators described in section 2, and the longitudinal component of the pinch part of the Feynm an gauge one-loop gluon self-energy described in section 4.1.

Regarding the role of the longitudinal component of the gauge eld propagator, it was shown some years ago in an elegant paper by Llewellyn Sm ith [23] that the covariant gauge xing parameter in QCD may legitim ately be replaced in the lagrangian by an operator (Q^2) . This operator may then in principle be chosen so that the radiatively-corrected gauge eld propagator i (q;) is proportional to g to all orders in perturbation theory. In this way, it was shown that the longitudinal component of the radiatively-corrected covariant gauge eld propagator in QCD makes no contribution to S-m atrix elements to all orders (a result which is relatively obvious in QED). The cancellation described above among the diagram s of Fig. 14 is just an explicit two-loop example of this.

From the point of view of the PT, it therefore seems plausible that the \induced" factors of longitudinal gauge eld four-m on entum from internal corrections should indeed be used to trigger further the PT rearrangement. However, in order that the resulting n-point functions continue to satisfy simple QED -like W and identities, it is necessary to use such factors not only from the gauge eld self-energies, but also the gauge eld vertices. For these latter, it is thus necessary to use the associated invariant tensor decom positions (cf. e.g. Refs. [24,25]) to isolate the longitudinal factors. The way in which this works for the case of the O ($\frac{2}{s}n_{f}$) i.e. m ixed ferm ionic-bosonic contribution to the two-loop gluon self-energy has been described in Ref. [26].

There are two reasons, however, to believe that the correct approach will turn out to be not to use the \induced" longitudinal factors to trigger further the PT rearrangem ent as was the elective assumption in this paper. First, it turns out that the longitudinal factors from internal vertex corrections, if used to trigger the PT rearrangement, make non-vanishing contributions to the n-point functions which, in contrast to the case at one loop, do not have a simple interpretation in terms of ghosts [2,6]. The role of the \induced" longitudinal factors is therefore qualitatively dierent from that of the lowest order longitudinal factors which appear in the PT at the one-loop level. Second, it is hard to see how such an approach could ever be obtained from a formulation at the level of the path integral essential if the PT is to be put on a medi-theoretic footing. In particular, the required tensor decompositions of the internal corrections are complicated for all but the self-energy function; and such an approach clearly precludes a set of Feynm an rules. To conclude, the analysis presented in this paper represents the rst, non-trivial step towards extending the pinch technique beyond the one-bop level. It is emphasized that, although the analysis has been complicated, the result | expressed essentially in the diagram s shown in Figs. 10 to 13 | is remarkably simple. It remains to be seen if this extension can be generalized beyond the case considered here.
