A b s t r a c t

1 Introduction

Electron-positron annihilation provides a clean environment for studying jet physics, as strong interaction effects occur only in the final state. We thus avoid the complications of parton distribution functions and their associated uncertainties. Perturbative QCD corrections to jet variables can nonetheless be sizeable. The most recent addition to the list of known one-loop amplitudes are those for $e^+e^- \rightarrow 4$ partons, which have been calculated by two groups independently. Our group obtained analytic expressions for the amplitudes [1] by calculating helicity amplitudes using the cut technique. The Durham group performed a conventional calculation and provided computer code [2]. The two sets of expressions have been shown to agree numerically. Here we report on the implementation of the one-loop amplitudes into a numerical program `Mercutio`, which can be used to calculate any infrared safe four-, three- or two-jet quantity at next-to-leading order (and n -jet quantities at leading order). It is similar to `Menlo Parc` [3], `Debrecen` [4] and `eerad2` [5]. The main difference among the programs is the technique used for the cancellation of real and virtual singularities. `Menlo Parc` uses the subtraction method of ref. [6], `Debrecen` the dipole method [7], while `eerad2` uses a hybrid of the phase-space slicing [8, 9] and subtraction methods. `Mercutio` also uses the dipole formalism, but with a remapping of phase space. A naive implementation of the dipole formalism will give large statistical errors when performing a Monte Carlo integration over the real corrections with dipole factors subtracted. In order to improve the efficiency of the Monte Carlo integration we remap the phase space in order to make the integrand more flat.

With the resulting numerical program, we first compute results for several observables studied previously in the literature. We present results for the four-jet fraction and the D -parameter, which agree with the results from the other programs. We also present results for quantities describing the internal structure of three-jet events. We give numerical results for the jet broadening and the softest-jet planarity.

The paper is organized as follows: in section 2 we explain the implementation of the dipole formalism and the remapping of phase space. Section 3 deals with technical details concerning various dimensional regularization schemes. Section 4 is devoted to phenomenology, and contains our numerical results. The conclusions are given in section 5.

2 Cancellation of Infrared Divergences

The NLO cross section receives contributions both from virtual corrections and from real emission. For $e^+e^- \rightarrow 4$ jets the virtual part consists of the interference terms between the tree amplitudes and the one-loop amplitudes for $e^+e^- \rightarrow q\bar{q}gq$ and $e^+e^- \rightarrow q\bar{q}q\bar{q}$. The real emission part consists of the squared tree-level amplitudes with one additional parton, namely $e^+e^- \rightarrow q\bar{q}ggq$ and $e^+e^- \rightarrow q\bar{q}q\bar{q}g$, which were computed long ago [10]. Both the virtual and the real emission contributions contain infrared divergences, arising when one particle becomes soft or two particles collinear. Only the sum of the virtual corrections and the real emission part is finite. Because the virtual part is integrated over n -particle phase-space, whereas the real emission part is integrated over the $(n+1)$ -particle phase

space, it is not possible to integrate the divergent contributions numerically and to cancel the divergences after the (numerical) integration. The cancellation of infrared singularities has to be performed before any numerical integration is done. There are basically two approaches to overcome this obstacle: phase-space slicing [9] and the subtraction method. (Within the subtraction method there are two variants: the subtraction method by Frixione, Kunszt and Signer [6] and the dipole formalism of Catani and Seymour [7].) As mentioned above, Mercutio uses the dipole formalism in order to handle infrared divergences.

Throughout this paper the conventional normalization of the color matrices is used: $\text{Tr} T^a T^b = \frac{1}{2} \delta^{ab}$.

2.1 The dipole formalism

The dipole formalism [7] is based on the subtraction method. The NLO cross section is written as

$$\begin{aligned} \sigma^{\text{NLO}} &= \int d^R + \int d^V \\ &= \int_{n+1} d^R - \int_n d^A + \int_n d^0 + \int_1 d^{AA}; \end{aligned} \quad (1)$$

where in the last line an approximation term d^A has been added and subtracted. The approximation d^A has to be a proper approximation of d^R such as to have the same pointwise singular behaviour in D dimensions as d^R itself. Further d^A has to be analytically integrable in D dimensions over the one-parton subspace leading to soft and collinear divergences. According to Catani and Seymour the approximation term is written as the n -parton Born term d^B times the dipole factors,

$$d^A = \int_{\text{dipoles}} d^B dV_{\text{dipole}}; \quad (2)$$

The integration over the $(n+1)$ -parton phase space yields

$$\int_{n+1} d^A = \int_{\text{dipoles}_n} d^B \int_1 dV_{\text{dipole}} = \int_n d^B I; \quad (3)$$

where the universal factor I is defined by

$$I = \int_{\text{dipoles}_1} dV_{\text{dipoles}}; \quad (4)$$

For the explicit formulae we refer to the paper of Catani and Seymour [7]. Here, we discuss the implementation of the dipole formalism when using helicity amplitudes. Let A denote the n -parton amplitude, where the polarization vector ϵ of the emitter gluon has been amputated. Using

$$(\epsilon_+)_+ \epsilon_+ + (\epsilon_-)_- \epsilon_- = g + \frac{\epsilon_{ij} q_i + \epsilon_{ij} q_j}{\epsilon_{ij} q}; \quad (5)$$

where q is an arbitrary reference momentum, we obtain

$$(A) \cdot (g)A = A_+ A_+ + A_- A_- \quad (6)$$

where A_{\pm} denotes the helicity amplitude where the emitted gluon has positive or negative helicity. The dependence on the reference momentum q drops out, since $(\epsilon_{ij}) \cdot A = 0$ (gauge invariance), $q^2 = 0$ (property of the polarization vectors) and $(\epsilon_{ij})^2 = 0$ (the gluon is on mass-shell). For the spin correlation we obtain

$$(A) \cdot z_i p_i \cdot z_j p_j \cdot z_i p_i \cdot z_j p_j A = E A_+ + E A_-^2; \quad (7)$$

where

$$E = \frac{hq + \frac{z_i p_i \cdot z_j p_j \cdot p_{ij} + i}{p_{ij}}}{2 [p_{ij}]} \quad (8)$$

Using the fact that the spin correlation tensor is orthogonal to p_{ij} one shows again that the dependence on the reference momentum drops out. As reference momentum one may choose $q = p_j$, in that case E reduces to

$$E = \frac{z_i [p_j p_i] [p_i p_{ij}]}{2 [p_j p_{ij}]} \quad (9)$$

2.2 Improving the Dipole Formalism

Within the dipole formalism we have to evaluate the terms

$$\sum_n d^V + d^B \quad I \quad \text{and} \quad \sum_{n+1} d^R \quad d^A : \quad (10)$$

The first term is most efficiently integrated by splitting it into leading-color and subleading-color pieces. The leading-color piece gives the numerically dominant contribution. The leading-color one-loop amplitudes are relatively simple and can therefore be integrated without further problems. The subleading-color one-loop amplitudes are more complicated and therefore need more computer time. On the other hand, they will yield contributions which are numerically smaller. We can thus evaluate them using fewer integrand evaluations. Although the second term $d^R \quad d^A$ usually gives only a modest numerical contribution, a naive Monte Carlo integration will give large statistical errors. Due to the large number of dipole factors involved, it is also very computationally intensive. We first deal with the fact that we have to reproduce logarithms numerically. This is solved by a remapping of phase-space. In a second stage we use color decomposition in order to reduce the number of dipole factors that have to be evaluated.

A simplified model for the term $d^R \quad d^A$ would be

$$F = \int_0^1 dx \frac{f(x)}{x} \frac{g(x)}{x} \quad (11)$$

where $f(0) = g(0)$ is assumed. The integral can be rewritten as

$$F = \int_0^{y_{\text{min}}} dx \frac{f(x) - g(x)}{x} + \int_{\ln y_{\text{min}}}^{Z^0} dy (f(e^y) - g(e^y)) ; \quad (12)$$

where y_{min} is an artificial parameter separating a numerically dangerous region from a stable region. Using the Taylor expansion for $f(x) - g(x)$, one sees that the first term gives a contribution of order $O(y_{\text{min}})$. In the second term the $1=x$ behaviour has been absorbed into the integral measure by a change of variables $y = \ln x$, and the integrand tends to be more flat. This should reduce the statistical error in a Monte Carlo integration.

The precise remapping of phase space for the term $d^R d^A$ is done as follows: Consider a set of products of invariants, including all the invariants in which the (unsubtracted) matrix elements has poles (and which may give rise to logarithms therefore). The relevant set of products of invariants for the two-quark, three-gluon final state consists of the pairs

$$\begin{aligned} S_g = & \{ s_{q_1 s_{12}}; s_{q_1 s_{13}}; s_{q_2 s_{21}}; s_{q_2 s_{23}}; s_{q_3 s_{31}}; s_{q_3 s_{32}} \\ & s_{23 s_{3q}}; s_{32 s_{2q}}; s_{13 s_{3q}}; s_{31 s_{1q}}; s_{12 s_{2q}}; s_{21 s_{1q}} \\ & s_{12 s_{23}}; s_{13 s_{32}}; s_{21 s_{13}} \\ & s_{q_1 s_{1q}}; s_{q_2 s_{2q}}; s_{q_3 s_{3q}} \} \end{aligned} \quad (13)$$

where we have labelled the gluons from 1 to 3, q corresponds to a quark and q to the anti-quark. Singularities associated with the last three pairs appear only in the color-subleading part. The corresponding set for the four-quark, one-gluon final state consists of the pairs

$$\begin{aligned} S_q = & \{ s_{qq} s_{gq}; s_{q^0 g} s_{gq^0}; s_{qg} s_{gq^0}; s_{q^0 g} s_{gq} \\ & s_{qq} s_{qq^0}; s_{qq^0} s_{q^0 q^0}; s_{qg} s_{qq^0}; s_{q^0 g} s_{q^0 q^0} \\ & s_{qg} s_{gq^0}; s_{qg} s_{gq^0} g \} \end{aligned} \quad (14)$$

The second line takes care of the collinear singularities when two quarks become collinear. The phase space is then partitioned according to

$$d_{n+1}^X = \sum_S (a; b; c)_{n+1} \quad (15)$$

where $(a; b; c) = 1$ if $s_{ab} s_{bc}$ is the smallest product in the set S , and $(a; b; c) = 0$ otherwise. The sum is over all products in the set S . We may use the symmetries under permutations in order to reduce the number of summands which need to be evaluated. For the two-quark, three-gluon case we have to evaluate the terms with $(q; 1; 2)$ and $(2; 3; q)$ with weight 6, as well as the terms with $(1; 2; 3)$ and $(q; 3; q)$ which are weighted by a factor of 3. For the four quark, one gluon case we evaluate the terms with $(q; g; q)$, $(q; g; q)$, $(q; q; q)$ and $(q; q; q)$, which are weighted by a factor 2, and the terms with $(q; g; q^0)$ and $(q; g; q)$ with unit weight.

Next, introduce a parameter s_{min} which separates numerically stable and unstable regions. (It is analogous to the s_{min} parameter in the phase-space slicing method, but

plays a somewhat different role here.) Using this parameter, define two regions as follows. Suppose $s_{as}s_{sb}$ is the smallest product in the set. Then the first region is defined as the region where $s_{as} > s_{min}$ and $s_{sb} > s_{min}$. In this region we perform a remapping of the phase space as explained in detail in the next subsection.

The second region is the complement of the first: $s_{as} < s_{min}$ or $s_{sb} < s_{min}$. In this region the integration is performed without any phase space remapping.

In summary, the numerical computation of the term $d^R d^A$ goes as follows,

$$d^R d^A = \int_{S_{min}}^X d^R d^A (s_{as} > s_{min}) (s_{sb} > s_{min}) (a; s; b) + \int_S^S d^R d^A (1 - (s_{as} > s_{min}) - (s_{sb} > s_{min})) (a; s; b) : \quad (16)$$

Note that this separation into two regions does not involve any approximations and is exact whatever value s_{min} might take. The aim is of course to choose s_{min} so as to reduce the statistical errors. It turns out that choosing s_{min} small enough makes the contributions of the second region negligible. The contribution of the first region has a statistical error reduced by roughly a factor of ten compared to the result without any remapping and the same number of integrand evaluations. Empirically

$$= \frac{s_{min} = Q^2}{Y_{cut}} = 10^{-5} \quad (17)$$

is a good value, where y_{cut} is the jet-defining parameter.

2.3 Remapping of Phase Space

The remapping of phase space we describe here was originally intended for use with the phase space slicing method, and was used in prior jet programs of one of the authors. The idea is to generate an $(n+1)$ -parton configuration that is "hard" the hard n -parton configuration corresponding to the leading-order calculation. We want to do this in a way that makes the $(n+1)$ -parton configuration approach the hard configuration in singular limits.

Suppose we have a set of product of invariants S such that $s_{as}s_{sb}$ is the smallest product in the set. In this region we remap the phase space as follows. Let k_a^0 , k_s and k_b^0 be the corresponding momenta such that $s_{as} = (k_a^0 + k_s)^2$, $s_{sb} = (k_b^0 + k_s)^2$ and $s_{ab} = (k_a^0 + k_s + k_b^0)^2$. We want to relate this $(n+1)$ particle configuration to a nearby "hard" n -particle configuration with $(k_a + k_b)^2 = (k_a^0 + k_s + k_b^0)^2$, where k_a and k_b are the corresponding "hard" momenta. Using the factorization of the phase space, we have

$$d_{n+1} = d_{n-1} \frac{dK^2}{2} d_3(K; k_a^0; k_s; k_b^0) : \quad (18)$$

The three-particle phase space is given by

$$d_3(K; k_a^0; k_s; k_b^0) = \frac{1}{32(2)^5 s_{ab}} ds_{as} ds_{sb} d_b^0 d_s = \frac{1}{4(2)^3 s_{ab}} ds_{as} ds_{sb} d_s d_2(K; k_a; k_b) \quad (19)$$

and therefore

$$d_{n+1} = d_n \frac{ds_{as} ds_{sb} ds}{4(2)^3 s_{ab}} \quad (20)$$

The region of integration for s_{as} and s_{sb} is $s_{as} > s_{min}$, $s_{sb} > s_{min}$ (either from the δ -functions of phase space slicing method, or else from the δ -functions separating the two regions above) and $s_{as} + s_{sb} < s_{ab}$ (Dalitz plot for massless particles). In order to get a flat integrand we want to absorb poles in s_{as} and s_{sb} into the measure. This is done by changing the variables according to

$$s_{as} = s_{ab} \frac{s_{min}}{s_{ab}} u_1 \quad ; \quad s_{sb} = s_{ab} \frac{s_{min}}{s_{ab}} u_2 \quad (21)$$

where $0 < u_1, u_2 < 1$. Note that $u_1, u_2 > 0$ enforces $s_{as}, s_{sb} > s_{min}$. Therefore this transformation of variables may only be applied to invariants s_{ij} where the region $0 < s_{ij} < s_{min}$ is cut out. The phase space measure becomes

$$d_{n+1} = d_n \frac{1}{4(2)^3} \frac{s_{as} s_{sb}}{s_{ab}} \ln^2 \frac{s_{min}}{s_{ab}} (s_{as} + s_{sb} < s_{ab}) du_1 du_2 ds \quad (22)$$

This suggests the following algorithm for generating a $(n+1)$ -parton configuration:

Take a "hard" n -parton configuration and pick out two momenta k_a and k_b . Use three uniformly distributed ("random") numbers u_1, u_2, u_3 and set

$$\begin{aligned} s_{ab} &= (k_a + k_b)^2 ; \\ s_{as} &= s_{ab} \frac{s_{min}}{s_{ab}} u_1 \quad ; \\ s_{sb} &= s_{ab} \frac{s_{min}}{s_{ab}} u_2 \quad ; \\ s &= 2 u_3 : \end{aligned} \quad (23)$$

If $(s_{as} + s_{sb}) > s_{ab}$, reject the event.

If not, solve for k_a^0, k_b^0 and k_s . If $s_{as} < s_{sb}$ we want to have $k_b^0 \neq k_b$ as $s_{as} \neq 0$. Define

$$E_a = \frac{s_{ab}}{2} \sqrt{\frac{s_{sb}}{s_{ab}}} ; \quad E_s = \frac{s_{as} + s_{sb}}{2} \sqrt{\frac{s_{sb}}{s_{ab}}} ; \quad E_b = \frac{s_{ab}}{2} \sqrt{\frac{s_{as}}{s_{ab}}} ; \quad (24)$$

$$\theta_{ab} = \arccos \left[1 - \frac{s_{ab} s_{as} s_{sb}}{2E_a E_b} \right] ; \quad \theta_{sb} = \arccos \left[1 - \frac{s_{sb}}{2E_s E_b} \right] ; \quad (25)$$

It is convenient to work in a coordinate system which is obtained by a Lorentz transformation to the center of mass of $k_a + k_b$ and a rotation such that k_b^0 is along the positive z -axis. In that coordinate system

$$\begin{aligned} p_a^0 &= E_a (1; \sin \theta_{ab} \cos(\theta_s + \theta_{sb}); \sin \theta_{ab} \sin(\theta_s + \theta_{sb}); \cos \theta_{ab}); \\ p_s &= E_s (1; \sin \theta_{sb} \cos \theta_s; \sin \theta_{sb} \sin \theta_s; \cos \theta_{sb}); \\ p_b^0 &= E_b (1; 0; 0; 1); \end{aligned} \quad (26)$$

The momenta p_a^0, p_s and p_b^0 are related to the momenta k_a^0, k_s and k_b^0 by a sequence of Lorentz transformations back to the original frame

$$k_a^0 = \text{boost}_{xy}(\alpha) \text{zx}(\beta) p_a^0 \quad (27)$$

and analogous for the other two momenta. The explicit formulae for the Lorentz transformations are obtained as follows:

Let $K = \frac{q}{(k_a + k_b)^2}$ and denote by p_b the coordinates of the hard momentum k_b in the center of mass system of $k_a + k_b$. p_b is given by

$$p_b = \left(\frac{Q^0}{K} k_b^0 + \frac{k_b \cdot Q}{K}; k_b + \left(\frac{k_b \cdot Q}{K(Q^0 + K)} + \frac{k_b^0}{K} \right) Q^A \right) \quad (28)$$

with $Q = k_a + k_b$. The angles are then given by

$$\begin{aligned} \beta &= \arccos \left(1 - \frac{p_b^0 p_b^0}{2 p_b^x p_b^x} \right); \\ \alpha &= \arctan \frac{p_b^y}{p_b^x} \end{aligned} \quad (29)$$

The explicit form of the rotations is

$$\begin{aligned} \text{zx}(\beta) &= \begin{pmatrix} 1 & 0 & 0 & 0 \\ 0 & \cos \beta & 0 & \sin \beta \\ 0 & 0 & 1 & 0 \\ 0 & \sin \beta & 0 & \cos \beta \end{pmatrix}; \\ \text{xy}(\alpha) &= \begin{pmatrix} 1 & 0 & 0 & 0 \\ 0 & \cos \alpha & \sin \alpha & 0 \\ 0 & \sin \alpha & \cos \alpha & 0 \\ 0 & 0 & 0 & 1 \end{pmatrix} \end{aligned} \quad (30)$$

The boost $k^0 = \text{boost}_q$ is given by

$$k^0 = \left(\frac{Q^0}{K} q^0 + \frac{q \cdot Q}{K}; q + \left(\frac{q \cdot Q}{K(Q^0 + K)} + \frac{q^0}{K} \right) Q^A \right) \quad (31)$$

with $Q = k_a + k_b$ and $K = \frac{q}{(k_a + k_b)^2}$.

If $s_a > s_b$, exchange a and b in the formulae above.

The "soft" event has then the weight

$$W_{n+1} = \frac{1}{2} \frac{s_a s_b}{(s_{ab})^3} \ln^2 \frac{s_{in}}{s_{ab}} W_n \quad (32)$$

where W_n is the weight of the original "hard" event.

2.4 Color decomposition and soft or collinear limits

We now turn our attention to the color decomposition of the five-parton tree amplitudes. Singling out the numerically dominant contribution, e.g. the leading color part, allows us to evaluate this part with fewer dipole factors as subtraction terms. This approach is similar to the one followed within the phase-space slicing method. In fact, we have also implemented phase-space slicing for the leading color contributions and checked that both methods, the dipole formalism and phase-space slicing, give the same numerical results. As a side-result we will give the relevant formula for the contributions from unresolved phase-space needed for the phase-space slicing method.

The color decomposition of the tree-level amplitude for $e^+e^- \rightarrow q\bar{q}g_1g_2g_3$ is

$$\begin{aligned} A_5(q;g_1;g_2;g_3;q) &= (T^1T^2T^3)_{q\bar{q}}A_5^{(1)}(q;1;2;3;q) + (T^1T^3T^2)_{q\bar{q}}A_5^{(2)}(q;1;3;2;q) \\ &+ (T^2T^3T^1)_{q\bar{q}}A_5^{(3)}(q;2;3;1;q) + (T^2T^1T^3)_{q\bar{q}}A_5^{(4)}(q;2;1;3;q) \\ &+ (T^3T^1T^2)_{q\bar{q}}A_5^{(5)}(q;3;1;2;q) + (T^3T^2T^1)_{q\bar{q}}A_5^{(6)}(q;3;2;1;q); \end{aligned} \quad (33)$$

The index i of $A_5^{(i)}$ labels the permutation of the gluons. Explicit formula for the partial amplitudes are given in ref. [10].

The tree-level amplitude for $e^+e^- \rightarrow q\bar{q}q\bar{q}q$ can be written as

$$A_5(g;q;q;\bar{q};\bar{q}) = \frac{1}{2} {}_{14}T_{32}D_1 + \frac{1}{2} {}_{32}T_{14}D_2 - \frac{1}{2} {}_{12}T_{34}D_3 - \frac{1}{2} {}_{34}T_{12}D_4 \quad (34)$$

where the factor $1/2$ is due to the conventional normalization of T^a and

Explicit formula for the partial amplitudes B_i are again given in ref. [10]. In this equation, $c_0(j)$ denotes a factor from the electro-weak coupling and depends explicitly on the flavor of the quark q_j ,

The electron-positron pair can either annihilate into a photon or a Z-boson. The first term in the expression for c_0 corresponds to an intermediate photon, whereas the last

term corresponds to a Z-boson. The left- and right-handed couplings of the Z-boson to fermions are given by

2.7 Color Correlation

The color correlation matrices may be obtained by two ways. The first approach is the one given by Catani and Seymour. Within this approach one acts with the color charge

$q \rightarrow gq$. The relevant color correlation matrices for the first case were already given above. The color correlation matrices for the latter case are

We can now pick out partial amplitudes corresponding to one specific color factor. This subset will in general require fewer dipole factors as subtraction terms. In practise it is enough to single out the leading color contribution for the matrix element $e^+e^- \rightarrow q\bar{q}g_1g_2g_3q$. Using the symmetry under the permutation of the gluons it is sufficient to evaluate one partial amplitude, which we may take to be

which requires only the evaluation of one partial amplitude of the four-parton tree-level amplitude. We may further restrict the set of products of invariants to

$$S_q = fs_{q1}s_{12};s_{12}s_{23};s_{23}s_{3q}g; \quad (86)$$

since we can only have poles in s_{q1} , s_{12} , s_{23} or s_{3q} . Singling out the leading color contributions for $e^+e^- \rightarrow q\bar{q}g_1g_2g_3q$ together with the remapping of phase space discussed in section 2.3 improves the efficiency of the Monte Carlo integration of the term $d^R \rightarrow d^A$ sufficiently so that most of the computer time is spent on the evaluation of the virtual one-loop amplitudes.

We finally remark that Z. Nagy and Z. Trocsanyi [4] have chosen a different approach in order to improve the efficiency of the dipole formalism: They introduce an additional parameter and constrain the phase space over which the dipole factors are subtracted:

$$d^A = \sum_{\text{dipoles}}^X d^B \quad dV_{\text{dipole}} \quad (y_{ij;k} < \epsilon) \quad (87)$$

where the dimensionless variable y_{ijk} is given by

$$Y_{ijk} = \frac{p_i p_j}{p_i p_j + p_j p_k + p_i p_k} \quad (88)$$

The three methods (remapping of phase space, color decomposition and restriction of the phase space for the dipole factors) could be combined, if there is any need for further improvement in the efficiency.

3 Regularization Schemes and Splitting Functions

Theoretical calculations of infrared-safe quantities in QCD should lead to unambiguous results, independent of the chosen regularization scheme. Terms sensitive to the precise definition of the regularization scheme enter the calculation usually in the virtual part through tensor loop integrals, and in the real emission part through the splitting functions [12], which enter the dipole factors (in the dipole formalism) or the contribution from unresolved phase space (within phase space slicing). Within dimensional regularization the most commonly used schemes are the conventional dimensional regularization scheme (CDR) [13], where all momenta and all polarization vectors are taken to be in D dimensions, the 't Hooft-Veltman scheme (HV) [14], where the momenta and the helicities of the unobserved particles are D dimensional, whereas the momenta and the helicities of the observed particles are 4 dimensional, and the four-dimensional helicity scheme (FDH) [15], where all polarization vectors are kept in four dimensions, as well as the momenta of the observed particles. Only the momenta of the unobserved particles are continued to D dimensions.

The procedure adopted in the numerical program is as follows. The one-loop amplitudes, calculated in the four-dimensional helicity scheme, were converted to the HV scheme, using the transition rules [16],

$$A_{FDH}^{\text{one loop}} = A_{HV}^{\text{one loop}} = c g^2 A^{\text{tree}} \left[\frac{N_c}{3} \frac{n_q}{4N_c} + \frac{n_q N_c}{12} \right] \quad (89)$$

where n_q is the number of quarks. The one-loop amplitude for $e^+ e^- \rightarrow q \bar{q} g g$ is converted into the 't Hooft-Veltman scheme by

$$A_{HV}^{\text{one loop}} = A_{FDH}^{\text{one loop}} + c \frac{1}{2} g^2 N_c \left[1 - \frac{1}{N_c^2} \right] A^{\text{tree}}; \quad (90)$$

whereas the one-loop amplitude for $e^+ e^- \rightarrow q \bar{q} q \bar{q}$ is converted by

$$A_{HV}^{\text{one loop}} = A_{FDH}^{\text{one loop}} + c g^2 N_c \left[\frac{2}{3} - \frac{1}{N_c^2} \right] A^{\text{tree}}; \quad (91)$$

The splitting functions entering the contribution from the integrals over the dipole factors have then to be taken in the 't Hooft-Veltman scheme as well. We take the formula for the splitting functions in the HV-scheme from Catani, Seymour and Trocsanyi [17]. They

are given by

$$\begin{aligned}
 P_{g! \text{ gg}} &= 2C_A \left[\frac{z}{1-z} + \frac{1-z}{z} + z(1-z) \right]; \\
 P_{q! \text{ qq}} &= 2C_F \left[\frac{2z}{1-z} + (1-z)(1-z) \right]; \\
 P_{g! \text{ qq}} &= 2T_R N_f \left[\frac{2}{1-z} z(1-z) \right]
 \end{aligned} \tag{92}$$

A statistical factor of $1/2!$ for two identical particles is included in the $g! \text{ gg}$ case.

4 Phenomenology

The numerical program `Mercutio` developed in this work is a general purpose program for calculating any infrared safe four-, three- and two-jet observable to next-to-leading order in s (and n -jet quantities at leading order). It is written in the language C++. The only approximations which have been made are the neglect of the light quark masses and terms which are suppressed by $1/m_{\text{top}}^4$ or higher powers of the top quark mass. `Mercutio` calculates the quantities in fixed order in s , no resummation of terms of $\ln^2 y_{\text{cut}}$ or $\ln y_{\text{cut}}$ has (yet) been implemented. Therefore our results are reliable only for values of y_{cut} which are not too small. The program calculates the jet quantities at the partonic level, and no hadronization is done.

The distribution for an infrared-safe variable O at the center-of-mass energy Q at next-to-leading order is given by two coefficients, B_0 and C_0 , which represent the leading and next-to-leading order perturbative contributions:

$$\frac{1}{\sigma_{\text{tot}}} \frac{d\sigma}{dO} = \frac{s}{2} B_0 + \frac{s}{2} C_0 + 2 \ln \frac{s}{Q^2} B_0 \tag{93}$$

We normalize all distributions to the total hadronic cross section σ_{tot} at $O(s)$, given by

$$\sigma_{\text{tot}} = \frac{\sigma_{\text{jet}}^{\text{Born}}}{2} \left(1 + \frac{s}{Q^2} \right) \tag{94}$$

We further normalize each variable such that it takes values between 0 and 1. The average of the variable is then defined as

$$\langle O \rangle = \frac{1}{\sigma_{\text{tot}}} \int_0^1 O \frac{d\sigma}{dO} dO \tag{95}$$

As our nominal choice of input parameters we use $N_c = 3$ colors and $N_f = 5$ massless quarks. We take the electromagnetic coupling to be $(\alpha_s(m_Z)) = 1/127.9$ and the strong coupling to be $(\alpha_s(m_Z)) = 0.118$. The numerical values of the Z^0 -mass and width are $m_Z = 91.187 \text{ GeV}$ and $\Gamma_Z = 2.490 \text{ GeV}$. For the top mass we take $m_t = 174 \text{ GeV}$ and for the weak mixing angle $\sin^2 \theta_w = 0.230$. We take the center of mass energy to be $\sqrt{Q^2} = m_Z$ and we set the renormalization scale equal to $\mu^2 = Q^2$.

4.1 Four-Jet Fraction

The four-jet fraction has been calculated by each group which has provided a numerical NLO four-jet program and serves as a cross-check. The four-jet fraction is defined as

$$R_4 = \frac{4_{\text{jet}}}{\text{tot}} : \quad (96)$$

The values obtained for the four-jet fraction for different jet algorithms (JADE [18], DURHAM [19] and GENEVA [20]) and varying y_{cut} are given in table 1, together with the corresponding values from the programs MENLO PARC by L. Dixon and A. Signer [3], DEBRECEN by Z. Nagy and Z. Trocsanyi [4] and EERAD 2 by J.M. Campbell, M.A. Cullen and E.W.N. Glover [5].

4.2 The D-Parameter

Global event shape variables describe the topology of an event. They may be calculated without reference to a jet defining algorithm. Like jet algorithms they have to be infrared safe. An example of a global event shape variable is the D-parameter [21] which is derived from the eigenvalues of the momentum tensor

$$D_{ij} = \frac{\sum_a \frac{p_a^i p_a^j}{E_a}}{\sum_a \frac{p_a^k p_a^k}{E_a}} \quad (97)$$

where the sum runs over all final state particles and p_a^i is the i -th component of the three-momentum \vec{p}_a of particle a in the c.m. system. The tensor D_{ij} is normalized to have unit trace. In terms of the eigenvalues of the tensor, $\lambda_1, \lambda_2, \lambda_3$, with $\lambda_1 + \lambda_2 + \lambda_3 = 1$, one defines

$$D = 27 \lambda_1 \lambda_2 \lambda_3 = 27 \det D_{ij} \quad (98)$$

The range of values is $0 \leq D \leq 1$. The D-parameter measures aplanarity, since one needs at least four final-state particles to obtain a non-vanishing value.




Figure 1: The D -parameter distribution at NLO (diamonds) and LO (crosses).

The values for the functions B_D and C_D are given in table 2. Figure 1 shows the D-parameter distribution. We remark that we have chosen to normalize the distribution to the total hadronic cross-section at $O(\alpha_s)$. The average of the shape variable is defined as

$$\langle D \rangle = \frac{1}{\sigma_{\text{tot}}^{Z^1}} \int D \frac{d\sigma}{dD} dD \quad (99)$$

For the average we obtain

$$\langle D \rangle = \frac{\sigma^2}{2} (5.82 \pm 0.01) \cdot 10^{-2} + \frac{\sigma^3}{2} (2.43 \pm 0.06) \cdot 10^{-3} \quad (100)$$

These numbers agree with the ones given by Nagy and Trocsanyi as published in ref. [4] after taking care of different normalizations (σ_{tot} in our case and $\sigma_{2\text{-jet}}^{\text{Born}}$ in ref. [4]). The D-parameter distribution has also been calculated by Campbell, Cullen and Glover [5].

4.3 The Jet Broadening Variable

With the numerical program for $e^+e^- \rightarrow 4$ jets one may also study the internal structure of three-jets events. One example is the jet broadening variable defined as [22]

$$B_{\text{jet}} = \frac{1}{n_{\text{jets}}} \sum_{\text{jets } a} \frac{p_a^2}{E_a} \quad (101)$$

Here p_a^2 is the momentum of particle a transverse to the jet axis of jet J , and the sum over a extends over all particles in the jet J . The jet broadening variable B_{jet} considered here shall not be confused with the narrow jet broadening B_{min} , which is defined differently. The later one has been recently calculated to NLO by Campbell, Cullen and Glover [5].

The jet broadening variable is calculated for three-jet events defined by the DURHAM algorithm and $y_{\text{cut}} = 0.1$. This choice is motivated by a recent analysis of the ALPH collaboration [22]. For the average we obtain

$$\langle B_{\text{jet}} \rangle = \frac{s}{2}^2 (1.79 \pm 0.01) \ln + \frac{s}{2}^3 (4.87 \pm 0.31) \ln^2 \quad (102)$$




Figure 2: The B_{jet} distribution at NLO (diamonds) and LO (crosses).

The values for the functions $B_{B_{\text{jet}}}$ and $C_{B_{\text{jet}}}$ are given in table 3. Figure 2 shows the distribution of the jet broadening variable.

4.4 The Softest-jet Explanarity

For three jet events we define the softest-jet explanarity as follows:

$$E_{3\text{jet}} = \frac{\sum_a^P \mathbf{p}_a \cdot \mathbf{P}_1 \cdot \mathbf{P}_2}{\sum_a^P \mathbf{p}_a^2 \mathbf{P}_1 \cdot \mathbf{P}_2} \quad (103)$$

where \mathbf{p}_a is the three-momentum of particle a inside the softest jet and the sum runs over all particles in the softest jet. \mathbf{P}_1 and \mathbf{P}_2 denote the three-momenta of the remaining two jets in the event. The explanarity measures the degree to which the shape of the softest jet lies out of the event plane. The definition is motivated by the fact, that the explanarity will be sensitive to the color factors of QCD.

The softest-jet explanarity is calculated for three-jet events defined by the DURHAM algorithm and $y_{\text{cut}} = 0.1$. For the average we obtain

$$\langle E_{3\text{jet}} \rangle = \frac{s}{2}^2 (1.29 \pm 0.01) \ln + \frac{s}{2}^3 (3.33 \pm 0.22) \ln^2 \quad (104)$$




Figure 3: The E_{3jet} distribution at NLO (diamonds) and LO (crosses).

The values for the functions $B_{E_{3\text{jet}}}$ and $C_{E_{3\text{jet}}}$ are given in table 4. Figure 3 shows the distribution of the softest-jet explainarity.

5 Conclusions

In this paper we reported on the general purpose numerical program "Mercurio", which can be used to calculate any infrared safe four-jet quantity in electron-positron annihilation at next-to-leading order. The program is based on the dipole formalism and uses a remapping of phase-space in order to improve the efficiency of the Monte Carlo integration. We presented numerical results for the four-jet fraction and the D -parameter. These results agree with the results from other groups. The program can also be used to investigate the internal structure of three-jet events at NLO. We also presented results for previously uncalculated observables: the jet broadening variable and the softest-jet explainarity.
