RENORMALIZABILITY AND THE MODEL INDEPENDENT OBSERVABLES FOR ABELIAN Z⁰SEARCH

The observables useful for the model independent search for signals of the abelian Z⁰ in the processes e⁺ e ! ff are introduced. They are based on the renorm alization group relations between the Z⁰ couplings to the Standard M odel particles developed recently and extend the variables suggested by O sland, P ankov and P aver. The bounds on the values of the observables at the center-ofm ass energy $\frac{P}{s} = 500$ GeV are derived.

I. IN TRODUCTION

The abelian Z⁰-boson with the mass much larger than the W-boson mass (m_{Z⁰} m_W) is predicted by a number of extensions of the Standard M odel (SM) of elementary particles [1]. At the current energies m_W the Z⁰ is decoupled. It can be described by the model based on the elective gauge group SU(2)_L U(1)_k U(1) which is assumed to be a low energy remnant of some unknown underlying theory (GUT, for example). How ever, the Z⁰ would be light enough to give the rst signal in future experiments.

D ue to the low erm ass lim it from the Tevatron, m $_{Z^{\,0}} > 0$ (500)G eV, only the 'indirect' Z⁰ m anifestations caused by virtual heavy states can be searched for at the energies of the present day accelerators. In general, one is not able to estim ate the m agnitude of the Z⁰ signal because of the unknown couplings and the m ass. How ever, num erous strategies to evidence m anifestations of the Z⁰ in experiments at high energy e⁺ e and hadronic colliders have been developed. The analysis can be done with or without assumptions on the speci c underlying theory containing the Z⁰. Hence, there are model dependent and m odel independent variables allow ing to detect the Z⁰.

O ne of the model independent approaches useful in searching for the Z 0 signal in the leptonic processes $e^+e~!~^{v+v}$ has been proposed in Ref. [2]. The basic idea was to replace the standard observables, the total cross section $_T$ and the forward-backward asymmetry $A_{\rm F\,B}$, by the new set of variables de ned as the di erences of the cross sections integrated over suitable ranges of polar angle

Due to the SM values of the leptonic charges and the kinem atic properties of the ferm ionic currents they have chosen the value $z=2^{2=3}-1=0.5874$ to make the leading order deviations from the SM predictions dependent on the combinations $v_{z}^{e} \circ v_{z}^{*} \circ = d_{z}^{e} \circ a_{z}^{*} \circ$, where $v_{z}^{f} \circ$ and $a_{z}^{f} \circ$ parameterize the vector and the axial-vector coupling of the Z 0 to the ferm ion f. Therefore, assum - ing the lepton universality one obtains the sign de nite observable $_{+}$.

U sually, the param eters describing at low energies the Z 0 coupling to the SM fermions (like $v_{\rm Z}^{\rm f}{}_{\,0}$ and $a_{\rm Z}^{\rm f}{}_{\,0}$) are assumed to be arbitrary numbers which must be xed in experiments. However, this is not the case if the renormalizability of the underlying theory is taken into account. In Refs. [3], [4] it has been shown that, if one uses the principles of the renormalization group (RG) and the decoupling theorem the correlations between the parameters describing interactions of light particles with heavy virtual states of new physics beyond the SM, can be derived. M ost in portant that the relations obtained, being the consequence of the renormalizability formulated in the fram ework of scattering in the external eld, are independent of the speci c underlying (G U T) m odel.

In R ef. [4] the m ethod was applied to nd signals of the heavy abelian Z⁰ in the four-ferm ion scattering processes. It was found that the renorm alizability of the theory is resulted in the following constraints on the Z⁰ couplings to the SM ferm ions:

where f^0 denotes the iso-partner of $f(v^0 = v, v^0 = v)$, $q_{i1}^0 = q_{i1}, q_{i1}^0 = q_{i1}$, where v = e; ; stands for leptons), f_5^f is the third component of the weak isospin and Y is the hypercharge param eterizing the Z⁰ coupling to the SM scalar doublet. Since the param eters of various ferm ionic processes are appeared to be correlated, one could expect that it is possible to introduce the speci c observables sensitive to the Z⁰ m anifestations. In the present paper we propose such the observables which generalize the variables (1).

The content is as follows. In Sect. II the structure of neutral currents induced by the Z^{0} -boson as well as the $Z-Z^{0}$ m ixing is brie y discussed. Employing the relations (2) between the Z^{0} parameters the optimal observables for searching for signals of the heavy abelian Z^{0} are

constructed in Sect. III. In Sect. IV the experimental bounds on the observables are predicted. The obtained results are summarized in Sect. V.

II.NEUTRAL CURRENTS AND VECTOR BOSON M IX ING

Considering the interactions of the Z⁰ with the SM particles, one has to conclude that at low energies, E m_{Z⁰}, the renorm alizable interactions are to be dom inant. The terms of the non-renorm alizable type (for example, ($Q Z^0 Q Z^0$)), being generated at GUT (or some intermediate $^{GUT} > ^{0} > m_{Z^0}$) mass scale, are

suppressed by the factors $1 = {}^{G UT}$, $1 = {}^{0}$ and can be neglected. Thus, the interaction of the Z 0 boson with the ferm ionic currents can be specified by the elective Lagrangian

where A; Z; Z⁰ are the photon, the Z - and Z⁰-bosons, respectively, e = 4, $g_Z = e = \sin_W \cos_W$, and $g_Z \circ$ stands for the U (1) coupling constant. W denotes the SM value of the W einberg angle (tan $W = g^0 = g$, where the charges g; g^0 correspond to the gauge groups SU (2)_L, U (1)_Y, respectively). The neutral currents can be param eterized as

where Q_f is the ferm ion charge in the positron charge units. The constants Y_f^v and Y_f^a parameterize the vector and the axial-vector coupling of the ferm ion f to the U (1) symmetry eigenstate, whereas $_0$ is the mixing angle relating the mass eigen states Z ;Z⁰ to the massive neutral components of the SU (2)_L U (1)_r and the U (1) gauge elds, respectively. Its value can be determined from the relation [5]

Because of the mixing between the Z and Z⁰ bosons the mass m_Z diers from the SM value m_W = \cos_W by the small quantity of order m²_W = m²_Z [4]

and, as a consequence, the parameter $m_W^2 = m_Z^2 \cos^2 w > 1$. Therefore, the mixing angle 0 is also small 0' tan 0' sin 0 $m_W^2 = m_Z^2 o$. The di erence $m_Z^2 = m_W^2 = \cos^2 w$ is negative and com -

pletely determ ined by the Z^{0} coupling to the scalar doublet. Thus, constraints on the Z^{0} interaction with the scalar eld can be obtained by experimental detecting this observable:

A s it has been proven in R ef. [4], the follow ing relations hold for the constants $Y_{\rm f}^{\,\,v}$ and $Y_{\rm f}^{\,\,a}$

where $Y_f^L = Y_f^v = Y_f^a$, $Y_f^R = Y_f^v + Y_f^a$, and Y is the hypercharge param eterizing the coupling of the SM scalar doublet to the vector boson associated with the \mathcal{O} (1) symmetry. As it is noted in Sect. I, the notation f^0 stands for the iso-partner of f.

In fact, the relation (11) m eans that the Z 0 couplings to the SM axial currents have the universal absolute value, if a single light scalar doublet exists. Am ong the four values Y_{f}^{v} , Y_{f}^{a} , $Y_{f^{0}}^{v}$, $Y_{f^{0}}^{a}$ param eterizing interaction of the Z⁰-boson with the SU (2) ferm ionic isodoublet only one is independent. The rest ones can be expressed through it and the hypercharge Y of the Z^{0} coupling to the SM scalar doublet. If the hypercharges are treated as unknown parameters these relations are to be taken into account in order to preserve the gauge sym m etry [4]. The relations (11) also show that the ferm ion and the scalar sectors of the new physics are strongly connected. As a result, the couplings of the Z⁰-boson to the SM axial currents are completely determined by its interaction with the scalar elds. Therefore, one is able to predict the Z⁰ coupling to the SM axial currents by measuring the

param eter. W hen the Z^0 does not interact with the scalar doublet, the Z-boson m ass is to be identical to its SM value. In this case the Z^0 couplings to the axial currents are produced by loops and to be suppressed by the additional sm all factor $g^2=16^{-2}$.

III. THE OBSERVABLES

In the present section we consider the electron-positron annihilation into ferm ion pairs e^+e ! V ! ff for

energies ${}^{p}\overline{s}$ 500G eV. In this case all the ferm ions except for the t-quark can be treated as massless particles m_f 0. The Z⁰-boson existence causes the deviations $(m_{Z_{0}}^{2})$ of the cross section from its SM value:

where T_V denotes the Born amplitude of the process e^+e ! V ! ff with the virtual V-boson (V = A;Z;Z⁰) state in the s-channel (the corresponding diagram is shown in Fig. 1).

The quantity d =d can be calculated in the form

To discuss the physical e ects caused by the relation (11), let us introduce the observable (Z) de ned as the di erence of cross sections integrated in suitable ranges of cos

The value of Z will be chosen later. A ctually, this observable is the generalized $_+$ of Ref. [2] ($_+$ = (z)). The two conventionally used observables, the total cross section $_{\rm T}$ and the forward-backward asymmetry $A_{\rm FB}$, can be obtained by special choice of Z ($_{\rm T}$ = (1), $A_{\rm FB}$ = (0)= $_{\rm T}$). In fact, one can express (Z) in terms of $_{\rm T}$ and $A_{\rm FB}$

The functions $F_i^f(Z;s)$ depend on the fermion type through the \mathfrak{Y}_f ; only. In Figs. 2-4 they are shown as the functions of Z for $\overline{s} = 500$ GeV. The leading contributions to $F_i^f(Z;s)$

are given by the Z⁰ exchange diagram (the rst term of Eq.(15)), since the contribution of the Z exchange diagram to T (the second term of Eq.(15)) is suppressed by the factor $m_Z^2 = s$.

From the Eqs. (19) one can see that the leading contributions to the leptonic factors F_1 , F_2 , F_3 are found to be proportional to the same polynom ial in Z. This is the characteristic feature of the leptonic functions F_1 originated due to the kinem atic properties of ferm ionic currents and the speci c values of the SM leptonic charges. Therefore, it is possible to choose the value of Z = Zwhich switches o three leptonic factors F_1 , F_2 , F_3 sim ultaneously. M oreover, the quark function $F_3^{\rm q}$ in low er order is proportional to the leptonic one and therefore is switched o, too. As is seen from Figs. 2-4, the appropriate value of Z is about 0:3. By choosing this value of Z one can simplify Eq.(18). It is also follows from Eq. (18) that neglecting the factors F_1 , F_2 , F_3 one obtains the sign de nite quantity (Z).

C om paring the observable (Z) with $_{+} = (0.5874)$ or = (0.5874) one can to conclude that the sign of the variables is completely undetermined in the case of arbitrary leptonic couplings Y_{-}^{L} . Therefore, in order to predict the sign of the observables one has to assume the additional restriction such as the lepton universality.

Let the value of Z in Eq.(16) is determined from the relation

The solution Z (s) is shown in Fig 5. As is seen, Z decreases from 0.3170 at $\bar{s} = 500 \text{GeV}$ to 0.3129 at $\bar{s} = 700 \text{GeV}$. Table I demonstrates the corresponding behavior of the functions F_i^f (Z ;s). Since F_i^f (Z ;s) depend on the center-ofm ass energy through the sm all quantity m $_z^2$ =s, the order of the shifts is about 3%. Therefore, in what follows the value of \bar{s} is taken to be 500G eV.

Assuming $Y_e^L = Y_v^L = Y = Y_u^L$ 1, one can derive

Hence it is seen, that the observable (Z) is negative. Moreover, it can be written in terms of the param eter using Eq.(10):

O ne also can construct the sign de nite observable for quarks of the sam e generation. As it follows from Eq. (21),

Hence it follows, that the values of $_{q_u}(Z)$ and $_{q_d}(Z)$ in the $_{q_u}(Z)$ { $_{q_d}(Z)$ plane have to be at the line crossing axes at the points $_{q_u}(Z) = 2.45$ (Z) and $_{q_d}(Z) = 4.9$ (Z), respectively. It also follows from Eq.(22) that the observable $_{q_u}(Z) + 0.5$ $_{q_d}(Z)$ is negative.

Thus, the dependencies (2) between the Z⁰ couplings to SM fermions allows to construct three negative valued observables, (Z), 1 and $q_{i}(Z) + 0.5 = q_{i}(Z)$, which are correlated by Eqs. (22)-(23). These observables are the most general model independent ones which can be introduced without any assumptions such as the lepton or quark universality.

IV . THE EXPER IM ENTAL CONSTRAINTS ON THE OBSERVABLES

The present day experimental data constrain the magnitude of the four-ferm ion contact interactions allowing to derive bounds on the Z⁰ coupling to the axial currents and, consequently, on the observables introduced in the previous section. Our analysis is based on the data presented in Refs. [6] where the study of the experimental bounds on the lepton-quark four-ferm ion contact couplings has been performed. In general, the contributions of new physics beyond the SM to the considered therein processes (the atom ic parity violation experiment as well as the electron-nucleus, m uon-nucleus and -nucleon scattering experiments) are described by 20 parameters, namely,

where `= e; ; q = u;d and ; = L;R. In order to reduce the num ber of independent ^{`q} one usually assumes the SU (2)_L invariance and the lepton universality. As a result, six variables (for example, ${}^{'u}_{LL}$, ${}^{'u}_{LR}$, ${}^{'u}_{RR}$, ${}^$

How ever, the number of independent $^{'q}$ can be further decreased by employing the correlations (2). In this case it is useful to introduce the couplings $^{'q}_{AA}$, $^{'q}_{LA}$, $^{'q}_{AL}$ parameterizing the four-ferm ion interactions between the left-handed and the axial-vector currents. These couplings are the linear combinations of the variables (24):

As it follows from Eq. (2), one has six independent param eters

which can be used as the basis.

The experiment constrains the specic linear combinations of the variables $^{'q}$ (see Ref. [6]). Introducing the normalized couplings:

Eqs. (28)-(33) represent the results of SLAC e D, CERN C, Batese C, Mainze Be, the atom ic parity violation and the -nucleon scattering experiments, respectively [6]. They determ ine the allowed region in the space of -parameters.

By employing Eqs. (25), (28)-(33) it is easy to obtain the bounds on the quantities (26):

The rst of the relations (34) gives possibility to determine the allowed magnitude of the observables (Z) and (Z) + 0.5 = (Z)

T hus, the signals of the abelian Z $^0\,m$ ust respect the above relations if the low energy physics is described by the m inim al SM .

It is worth to compare the rst of Eqs. (35) based on the analysis of the lepton-quark interactions with the direct constraints derived from the experiments on the e^+e ! ", scattering. Introducing the norm alized Z⁰ coupling to the axial leptonic current:

one can write down the bounds obtained from the processes e^+e ! $*^+$ as follows $A \cdot j < 0.025$ (see Fig. 2.7 of Ref. [1]). However, the relations (35) lead to the constraint $A \cdot j < 0.0087$. Thus, the bounds (35) are about nine times stronger than ones derived from the analysis of the pure leptonic interactions.

V.DISCUSSION

In the lack of reliable inform ation on the model describing physics beyond the SM and predicting Z⁰ boson it is of great importance to nd the model independent variables to search for this particle. In this regard, it could be useful to employ the method of Ref. [4] which gives possibility to reduce the number of unknown numbers parameterizing e ects on new heavy virtual particles.

In Ref. [2] the observables alternative to the familiar $_{\rm T}$ and $A_{\rm FB}$ and perspective in searching for the abelian Z ⁰ signal in the leptonic processes e⁺ e ! ⁺ ⁺ were proposed. It was pointed out that the sign of the $_+$ deviation from the SM value can be uniquely predicted when the lepton universality is assumed. The sign remains to be unspecied in the case of an arbitrary interaction of Z ⁰ with leptons.

The observables introduced in the present paper are the extension of that in Ref. [2] with the speci ed above choice of the boundary angle. The observable (Z) is the negative de ned quantity even in the case when the lepton universality is not assumed. Moreover, the observable $_{q_u}(Z) + 0.5_{q_d}(Z)$ constructed for the quarks of the same generation is proportional to the leptonic one (Z) being negative, too.

As it was mentioned in section III, the magnitude of the leptonic observable $\$ $(Z \)$ is determined by means of the parameter. Thus, the Z 0 contributions to the quantities 1 = 1 $m_W^2 = m_Z^2 \cos^2 w$, $\$ $(Z \)$ and $_{q_u} (Z \) + 0.5 ~_{q_d} (Z \)$ have to be negative allowing to detect the Z 0 signal.

As the corollary of our analysis we note that the introduced observables allow one to identify (or to discard) the abelian Z⁰ e ects when the low energy physics is described by the minimal SM. Therefore, they can usefully complement the conventional analysis of Z⁰ couplings based on the observables $_{\rm T}$ and $A_{\rm FB}$.
