# Large\{ $\mathrm{N}_{\mathrm{c}}$ Q CD and W eak M atrix E lem ents

#### Abstract

I report on recent progress [1, 2] in calculating electrow eak processes $w$ thin the fram ew ork of $Q C D$ in the $1=\mathrm{N}_{\mathrm{C}}$ expansion.


## 1. Introduction

In the Standard M odel, the physics of non \{leptonic K \{decays is described by an e ective Lagrangian which is the sum of four\{quark operators modulated by c\{num ber coe cients ( W ilson coe cients). This e ective Lagrangian results from integrating out the elds in the Standard M odelw ith heavy $m$ asses ( $Z^{0}$; $W \quad ; \quad t$; $b$ and $\left.C\right)$, in the presence of the strong interactions evaluated in perturbative QCD ( PQCD ) down to a scale below the $m$ ass of the charm quark $M_{c}$. The scale has to be large enough for the $P Q C D$ evaluation of the c\{num ber coe cients to be valid and, therefore, it is m uch larger than the scale at which an e ective Lagrangian description in term sof the N am bu G oldstone degrees of freedom ( K , and ) of the spontaneous SU (3) $L$ SU (3) ${ }_{R}$ sym $m$ etry breaking ( $S S B$ ) is appropriate. Furtherm ore, the evaluation of the coupling constants of the low \{energy e ective chiral Lagrangian cannot be made w ithin PQ CD because at scales $<1 \mathrm{GeV}$ we enter a regim e where $S$ SB and con nem ent take place and the dynam ics of QCD is then fully govemed by non \{perturbative phenom ena.

The structure of the low \{energy e ective Lagrangian, in the absence of virtual electrow eak interactions, is well (known [3]

Here the unitary $m$ atrix $U$ collects the $m$ eson elds ( $K$, and ) and $F_{L},\left(F_{R}\right)$ denote eld\{strength tensors associated to extemal gauge eld sources. T he dots indicate other term $\mathrm{s} w$ ith the sam e chiralpow er counting $O\left(p^{4}\right)$ as the $L_{10}$ term and higher order term $s$. The im portant point that

I wish to em phasize here is that the coupling constants of this e ective Lagrangian，correspond to coe cients of the Taylor expansion in powers of $m$ om enta（and quark $m$ asses），of speci c QCD G reen＇s functions of cobur singlet quark \｛currents．Let us consider as an exam ple，and in the chiral lim it where the light quark $m$ asses are set to zero，the two\｛point function

For $Q^{2}$ small，$Q^{2}$ ir $\left(Q^{2}\right)=f^{2}+4 L_{10} Q^{2}+O\left(Q^{4}\right)$ ，clearly show ing the correspondence stated above．

In the presence of virtual electrow eak interactions there appear new couplings in the low \｛energy e ective Lagrangian，like e．g．the term

where $Q_{R}=Q_{L}=\operatorname{diag}[2=3 ; 1=3 ; 1=3]$ ，show ing that，in the presence of the electrow eak interactions，the charged pion and kaon elds becom e m assive．The basic com plication in evaluating coupling constants like C in Eq．（⿴囗⿱一一⿴囗十一 ），which originate in loops w ith electrow eak gauge elds，is that they correspond to integrals over all values of the euclidean $m$ om enta of speci $c$ com binations of Q CD G reen＇s functions of colour singlet quark \｛currents． In our particular exam ple，it can be shown［8，（1］that

$w$ ith $Q$ the euclidean $m$ om entum of the virtual gauge eld；the rst term in the parenthesis is the well known［7］contribution from electrom agnetism； the second term is the one induced by the weak neutral current［1］．It is clear that the evaluation of coupling constants of this type represents a rather form idable task．A s we shall see below，it is possible，how ever，to proceed further $w$ thin the fram ew ork of the $1=\mathrm{N}_{\mathrm{C}}$ \｛expansion in $Q C D$ 目］．

2．Large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ QCD and the OPE
In the lim it where the num ber of colours $N_{C}$ becom es in nite，with $s N_{C}$ xed，the QCD spectrum reduces to an in nite number of zero\｛w idth $m$ esonic resonances，and the leading large\｛ $\mathrm{N}_{\mathrm{c}}$ contribution to an n \｛point correlator is given by all the possible tree\｛level exchanges of these reso－ nances in the various channels．In this lim it，the analytical structure of an n \｛point function is very simple：the singularities in each channel consist only of a succession of sim ple poles．For exam ple，in the case of Lr in Eq．（2），

where the sum s extend over all vector ( $V$ ) and axial\{vector (A) states. Furtherm ore, in the chiral lim it, the operator product expansion (OPE) applied to the correlation function $\mathrm{Lr}\left(\mathrm{Q}^{2}\right)$ implies

The rst two relations result in the two W einberg sum rules

There is in fact a new set of constraints that em erge in the large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ lim it which relate order param eters of the OPE to couplings and $m$ asses of the narrow states. In our exam ple, we have from Eqs. [5) and 7), that

On the other hand, the coupling constants of the low \{energy Lagrangian in the strong interaction sector are also related to couplings and $m$ asses of the narrow states of the large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ Q CD spectrum ; e.g.,

It is to be rem arked that the convergence of the integral in Eq. (4) in the large $\left\{\mathrm{N}_{\mathrm{C}} \lim\right.$ it is guaranteed by the two W einberg sum rules in Eqs. (g). H ow ever, in order to obtain a num erical estim ate, and in the absence of an explicit solution of $Q C D$ in the large\{ $\mathrm{N}_{\mathrm{c}} \lim$ it, one still needs to m ake further approxim ations. P artly inspired by the phenom enological successes of \vectorm eson dom inance" in predicting e.g., the low \{energy constants of thee ective chirallagrangian D], we have recently proposed [] to consider the approxim ation to large $\left\{N_{c}\right.$ Q CD , which restricts the hadronic spectrum to a m inim al pattem, com patible $w$ ith the short\{distance properties of the QCD G reen's functions which govem the observable(s) one is interested in. In the channels $w$ ith $J^{P}$ quantum numbers 1 and $1^{+}$this $m$ inimal pattem, in the cases which we have discussed so far, is the one with a spectnum which consists of a hadronic low est energy narrow state and treats the rest of the narrow states as a large $\left\{\mathrm{N}_{\mathrm{c}} \mathrm{PQCD}\right.$ continuum ; the onset of the continuum being xed by consistency constraints from the OPE, like the absence of dim ension $d=2$ operators. $W$ e call this the lowest meson dom inance (LM D) approxim ation to large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ Q CD . The basic observation
here is that order param eters of $S \mathrm{SB}$ in $Q C D$ have a sm ooth behaviour at short distances. For exam ple, in the case of the function $L R$ and, therefore, the coupling $C$, this is re ected by the fact that (in the chiral lim it) the PQCD continuum contributions in the $V$ \{sum and the $A$ \{sum in Eq. (5) cancl each other. The evaluation of the constant $C$ in $E q$. (4) in this approxim ation, corresponds to a $m$ ass di erence $m=4: 9 \mathrm{MeV}$, rem arkably close to the experim ental result: m jexp. $=4: 59 \mathrm{M} \mathrm{eV}$.
3. E lectrow eak $P$ engu in $O$ perators.

W thin the fram ework discussed above, we have also shown [1] that the K ! m atrix elem ents of the four\{quark operator

generated by the electrow eak penguin \{like diagram s ofthe Standard M odel, can be calculated to rst non\{trivial order in the chiral expansion and in the $1=\mathrm{N}_{\mathrm{c}}$ expansion. $W$ hat is needed here is the bosonization of the operator $Q_{7}$ to next\{to\{leading order in the $1=\mathrm{N}_{\mathrm{c}}$ expansion. The problem tums out to be entirely analogous to the bosonization of the operator $Q_{L R} \quad\left(q_{L} \quad Q_{L} q_{I}\right)\left(q_{R} Q_{R} q_{R}\right)$ which govems the electrow eak ${ }^{+} 0$ $m$ ass di erence discussed above. Because of the LR structure, the factorized com ponent of $Q_{7}$, which is leading in $1=\mathrm{N}_{\mathrm{c}}$, cannot contribute to order $O\left(p^{0}\right)$ in the low \{energy e ective Lagrangian. The rst $O\left(p^{0}\right)$ contribution from this operator is next\{to\{leading in the $1=\mathrm{N}_{\mathrm{c}}$ expansion and is given by an integral, $\left[{\underset{\mathrm{L}}{\mathrm{L}} \mathrm{(23)}}_{\mathrm{ij}}=\mathrm{i} 2 \mathrm{j}(\mathrm{i} ; j=1 ; 2 ; 3)\right.$, $]$

involving the same two\{point function as in Eq. (2). A though the resulting $B$ factors of $I=1=2$ and $I=3=2$ transitions are found to depend only logarithm ically on the m atching scale , their actual num erical values tum out to be rather sensitive to the precise choice of in the GeV region. Furtherm ore, because of the nom alization to the vacuum saturation approxim ation (VSA) inherent to the (rather disgraceful) conventional de nition of B \{factors, there appears a spurious dependenœe on the light quark $m$ asses as well. In $F$ ig. 1 we show our prediction for the ratio

versus the $m$ atching scale de ned in the $\overline{\mathrm{MS}}$ scheme. This is the ratio considered in recent lattice QCD calculations 回]. [In fact, the lattice
de nition of $\mathrm{B}_{7}^{(3=2)}$ uses a current algebra relation between the K ! and the $K$ ! $m$ atrix elem ents which is only valid at order $O\left(p^{0}\right)$ in the chiral expansion.] In Eq. (13), the $m$ atrix elem ent in the denom inator is evaluated in the chiral lim it, as indicated by the subscript $\backslash 0$ ".

The processes ! $e^{+} e$ and ! $\ddagger 1(l=e ;)$ are dom inated by the exchange of two virtual photons. It is then useful to consider the ratios ( $\mathrm{P}={ }^{0}$; )

To low est order in the chiral expansion, the unknown dynam ics in the am plitude $A\left(M_{P}^{2}\right)$ depends entirely on a low $\{$ energy coupling constant. $W$ e have recently shown [2] that this constant can be expressed as an integral over the three\{point function

involving the electrom agnetic current $j^{\mathrm{em}}$ and the density current $\mathrm{P}^{3}=$ $\frac{1}{2}$ (ui ${ }_{5} \mathrm{u}$ di ${ }_{5} \mathrm{~d}$ ). M ore precisely, ( $\mathrm{d}=$ spaœ\{tim e dim ension,

The evaluation of this coupling in the LM D approxim ation to large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ QCD which we have discussed above, leads to the result $\mathrm{LMD}\left(=\mathrm{M}_{\mathrm{V}}\right)=$ 2.2 0:9. The corresponding branching ratios are shown in Table 1 .

It was shown in ref. [12] that, when evaluated w ithin the chiral U (3) fram ew ork and in the $1=\mathrm{N}_{\mathrm{C}}$ expansion, the $j \mathrm{Sj=} 1 \mathrm{~K} \underset{\mathrm{~L}}{0}$ ! + , transitions can also be described by an expression like in Eq. 14) w ith an e ective constant $k 0$ containing an additional piece from the short\{distance contributions [13]. The m ost accurate experim ental determ ination [14] gives: $\operatorname{Br}\left(K_{L}^{0}!+\quad\right)=(7: 18 \quad 0: 17) \quad 10^{9}$. In the fram ew ork of the $1=\mathrm{N}_{\mathrm{C}}$ expansion and using the experim entalbranching ratio 11] Br( $\mathrm{K}_{\mathrm{L}}^{0}$ !
$)=(5: 92 \quad 0: 15) \quad 10^{4}$, this leads to a unique solution for an e ective
 where $N=\left(3: 6=g_{8} C_{\text {red }}\right)$ nom alizes the $K_{L}^{0}$ ! am plitude. The coupling $g_{8}$ govems the $I=1=2$ rule, the constant $c_{\text {red }}$ is de ned in $R$ ef. 12] and
${ }_{S D}^{\text {Standard }}=(+1: 8 \quad 0: 6)$ is the short\{distance contribution in the Standard M odel 13]. Therefore, a test of the short\{distance contribution to this process com pletely hinges on our understanding of the long\{distance constant $N$ and therefore of the $I=1=2$ rule in the $1=N$ c expansion. $M$ oreover, $\mathrm{C}_{\text {red }}$ is regrettably very unstable in the chiral and large $\left\{\mathrm{N}_{\mathrm{c}}\right.$ lim its, a behaviour that surely points tow ards the need to have higher order corrections under control. The analysis of $R$ ef. [12] uses $C_{r e d}{ }^{\prime}+1$ and $g_{8}{ }^{\prime}$ 3:6,where these num bers are obtained phenom enologically by requiring agreem ent w ith the two\{photon decay of $K_{L}{ }^{0} ;{ }^{0}$; and ${ }^{0}$ as well as K ! $2 ; 3$. Should we use these values of $\mathrm{c}_{\text {red }}$ and $g_{8} w$ ith our result LM D $\left(=M_{V}\right)=2 \cdot 2 \quad 0: 9$ we would obtain $K_{\mathrm{L}}^{0}=0: 4 \quad 1: 1$, corresponding to a ratio $R\left(K_{L}^{0}!+\quad\right)=(2.240: 41) \quad 10^{5} \mathrm{which}$ is $2: 5$ above the experim ental value $R\left(K_{L}^{0}!+\quad+\quad=\left(\begin{array}{lll}1: 21 & 0: 04\end{array}\right) \quad 10{ }^{5}\right.$.
