# Large {N c Q C D and W eak M atrix E lam ents

#### Abstract

I report on recent progress [1, 2] in calculating electroweak processes within the framework of QCD in the 1=N c expansion.

### 1. Introduction

In the Standard M odel, the physics of non { leptonic K { decays is described by an e ective Lagrangian which is the sum of four{quark operators modulated by c{number coe cients (W ilson coe cients). This e ective Lagrangian results from integrating out the elds in the Standard M odelwith heavy m asses ( $\mathbb{Z}^{0}$ ;  $\mathbb{W}_{i}$ ; t; b and c), in the presence of the strong interactions evaluated in perturbative QCD (pQCD) down to a scale below the mass of the charm quark M<sub>c</sub>. The scale has to be large enough for the pQCD evaluation of the c{num ber coe cients to be valid and, therefore, it is much larger than the scale at which an e ective Lagrangian description in term s of the N am bu {G oldstone degrees of freedom (K, and ) of the spontaneous SU (3)<sub>L</sub>  $SU (3)_R$  sym m etry breaking (S SB) is appropriate. Furtherm ore, the evaluation of the coupling constants of the low (energy e ective chiral Lagrangian cannot be m ade within pQCD because at scales < 1 GeV we enter a regime where S SB and con nement take place and the dynamics of QCD is then fully governed by non {perturbative phenom ena.

The structure of the low {energy e ective Lagrangian, in the absence of virtual electroweak interactions, is well{known [3]

Here the unitary matrix U collects the meson elds (K, and ) and  $F_L$ , ( $F_R$ ) denote eld{strength tensors associated to external gauge eld sources. The dots indicate other term s with the same chiral power counting O ( $p^4$ ) as the  $L_{10}$  term and higher order term s. The important point that

I wish to emphasize here is that the coupling constants of this e ective Lagrangian, correspond to coe cients of the Taylor expansion in powers of momenta (and quark masses), of speci cQCD G reen's functions of colour singlet quark (currents. Let us consider as an example, and in the chiral limit where the light quark masses are set to zero, the two (point function  $(Q^2 = q^2; L = q \frac{1}{2}(1 \ _5)q; R = q \frac{1}{2}(1 + _5)q)$ Z $L_R (q) = 2i d^4x e^{iq} hojT L (x)R (0)^Y jDi = (q q g q^2) L_R (Q^2): (2)$ 

For Q<sup>2</sup> sm all, Q<sup>2</sup>  $_{LR}$  (Q<sup>2</sup>) = f<sup>2</sup> + 4L<sub>10</sub> Q<sup>2</sup> + 0 (Q<sup>4</sup>), clearly showing the correspondence stated above.

In the presence of virtual electroweak interactions there appear new couplings in the low (energy e ective Lagrangian, like e.g. the term

where  $Q_R = Q_L = \text{diag}[2=3; 1=3; 1=3]$ , showing that, in the presence of the electroweak interactions, the charged pion and kaon elds become m assive. The basic complication in evaluating coupling constants like C in Eq. (3), which originate in bops with electroweak gauge elds, is that they correspond to integrals over <u>all values</u> of the euclidean m om enta of speci c com binations of QCD G reen's functions of colour singlet quark{currents. In our particular example, it can be shown [4, 1] that

with Q the euclidean momentum of the virtual gauge eld; the rst term in the parenthesis is the well known [4] contribution from electrom agnetism; the second term is the one induced by the weak neutral current [1]. It is clear that the evaluation of coupling constants of this type represents a rather form idable task. As we shall see below, it is possible, however, to proceed further within the fram ework of the 1=N  $_{\rm c}$  (expansion in QCD [5].

#### 2. Large { $N_c$ QCD and the OPE

In the limit where the number of colours N<sub>c</sub> becomes in nite, with  $_{\rm s}$  N<sub>c</sub> xed, the QCD spectrum reduces to an in nite number of zero{width m esonic resonances, and the leading large{N<sub>c</sub> contribution to an n{point correlator is given by all the possible tree{level exchanges of these resonances in the various channels. In this limit, the analytical structure of an n{point function is very simple: the singularities in each channel consist only of a succession of simple poles. For example, in the case of  $_{\rm LR}$  in Eq. (2),

where the sum s extend over all vector (V) and axial{vector (A) states. Furthermore, in the chiral limit, the operator product expansion (OPE) applied to the correlation function  $_{LR}$  (Q<sup>2</sup>) in plies

The rst two relations result in the two W einberg sum rules

There is in fact a new set of constraints that emerge in the large{N<sub>c</sub> limit which relate order parameters of the OPE to couplings and m asses of the narrow states. In our example, we have from Eqs. (5) and (7), that

On the other hand, the coupling constants of the low (energy Lagrangian in the strong interaction sector are also related to couplings and m asses of the narrow states of the large( $N_c QCD$  spectrum; e.g.,

It is to be rem arked that the convergence of the integral in Eq. (4) in the  $large{N_c}$  lim it is guaranteed by the two W einberg sum rules in Eqs. (8). However, in order to obtain a numerical estimate, and in the absence of an explicit solution of QCD in the large  $\{N_{c} \text{ lim it, one still needs to make}\}$ further approxim ations. Partly inspired by the phenom enological successes of vectorm eson dom inance" in predicting e.g., the low (energy constants of the elective chiral Lagrangian [7], we have recently proposed [8] to consider the approximation to  $large{N_{c} Q C D_{r}}$  which restricts the hadronic spectrum to a m inim alpattern, com patible with the short{distance properties of the QCD Green's functions which govern the observable (s) one is interested in. In the channels with  $J^P$  quantum numbers 1 and  $1^+$  this minimal pattern, in the cases which we have discussed so far, is the one with a spectrum which consists of a hadronic lowest energy narrow state and treats the rest of the narrow states as a  $large{N_c pQCD continuum}$ ; the onset of the continuum being xed by consistency constraints from the OPE, like the absence of dimension d = 2 operators. We call this the lowest meson dom inance (LM D) approximation to large {N c Q C D . The basic observation

here is that order parameters of S SB in QCD have a smooth behaviour at short distances. For example, in the case of the function  $_{\rm LR}$  and, therefore, the coupling C, this is rejected by the fact that (in the chiral limit) the pQCD continuum contributions in the V (sum and the A (sum in Eq. (5) cancel each other. The evaluation of the constant C in Eq. (4) in this approximation, corresponds to a mass difference m = 4:9 M eV, remarkably close to the experimental result: m  $j_{\rm exp.}$  = 4:59 M eV.

3. E lectrow eak Penguin Operators.

W ithin the framework discussed above, we have also shown [1] that the K ! matrix elements of the four{quark operator

generated by the electroweak penguin { like diagram softhe Standard M odel, can be calculated to rst non { trivial order in the chiral expansion and in the 1=N<sub>c</sub> expansion. W hat is needed here is the bosonization of the operator Q<sub>7</sub> to next{to{leading order in the 1=N<sub>c</sub> expansion. The problem turns out to be entirely analogous to the bosonization of the operator Q<sub>LR</sub> (q<sub>L</sub> Q<sub>L</sub>q<sub>L</sub>) (q<sub>R</sub> Q<sub>R</sub>q<sub>R</sub>) which governs the electroweak <sup>+ 0</sup> m ass di erence discussed above. Because of the LR structure, the factorized component of Q<sub>7</sub>, which is leading in 1=N<sub>c</sub>, cannot contribute to order 0 (p<sup>0</sup>) in the low {energy e ective Lagrangian. The rst 0 (p<sup>0</sup>) contribution from this operator is next{to{leading in the 1=N<sub>c</sub> expansion and is given by an integral, [  $L_{L_{ij}}^{(23)} = L_{23j}^{(23)}$  (i; j = 1;2;3),]

involving the <u>same</u> two{point function as in Eq. (2). A lthough the resulting B factors of I = 1=2 and I = 3=2 transitions are found to depend only logarithm ically on the matching scale , their actual numerical values turn out to be rather sensitive to the precise choice of in the GeV region. Furtherm ore, because of the norm alization to the vacuum saturation approximation (VSA) inherent to the (rather disgraceful) conventional de nition of B {factors, there appears a spurious dependence on the light quark masses as well. In Fig. 1 we show our prediction for the ratio

versus the matching scale de ned in the  $\overline{MS}$  scheme. This is the ratio considered in recent lattice QCD calculations [9]. [In fact, the lattice

de nition of  $\mathbb{B}_{7}^{(3=2)}$  uses a current algebra relation between the K ! and the K ! matrix elements which is only valid at order O ( $p^{0}$ ) in the chiral expansion.] In Eq. (13), the matrix element in the denominator is evaluated in the chiral limit, as indicated by the subscript 0".

4. Decay of P seudoscalars into Lepton Pairs.

The processes !  $e^+e$  and ! It ( $l = e_i$ ) are dominated by the exchange of two virtual photons. It is then useful to consider the ratios ( $P = {}^0$ ; )

with  $(s) = 1 4m_2^2 = s$ . To lowest order in the chiral expansion, the unknown dynamics in the amplitude A (M  $_P^2$ ) depends entirely on a low { energy coupling constant . We have recently shown [2] that this constant can be expressed as an integral over the three{point function Z Z Z

involving the electrom agnetic current  $j^{em}$  and the density current  $P^3 = \frac{1}{2}$  (ui  $_5$ u di  $_5$ d). More precisely, (d= space{tim e dimension,)

The evaluation of this coupling in the LMD approximation to large{N<sub>c</sub> QCD which we have discussed above, leads to the result  $^{\text{LMD}}$  (= M<sub>V</sub>) = 2.2 0.9. The corresponding branching ratios are shown in Table 1.

It was shown in ref. [12] that, when evaluated within the chiral U (3) fram ework and in the 1=N<sub>c</sub> expansion, the  $jSj = 1 K_{L}^{0}$  ! \*\* transitions can also be described by an expression like in Eq. (14) with an electrive constant  $K_{L}^{0}$  containing an additional piece from the short{distance contributions [13]. The most accurate experimental determination [14] gives: Br( $K_{L}^{0}$  ! \* ) = (7:18 0:17) 10 °. In the fram ework of the 1=N<sub>c</sub> expansion and using the experimental branching ratio [11] Br( $K_{L}^{0}$  !

) =  $(5.92 \quad 0.15) \quad 10^4$ , this leads to a unique solution for an e ective  $_{K_{\tau}^{0}}$  = 5:17 1:13. Furtherm ore, following Ref. [12],  $_{K_{\tau}^{0}}$  = Ν SD where N =  $(3:6=g_8c_{red})$  norm alizes the K  $_{L}^{0}$ ! am plitude. The coupling  $g_8$  governs the I = 1=2 rule, the constant  $c_{red}$  is de ned in Ref. [12] and  $\frac{Standard}{SD}$  = (+1:8 0:6) is the short{distance contribution in the Standard M odel [13]. Therefore, a test of the short{distance contribution to this process completely hinges on our understanding of the long{distance constant N and therefore of the I = 1=2 rule in the  $1=N_{c}$  expansion. M oreover,  $c_{red}$  is regrettably very unstable in the chiral and large{N  $_{c}$  lim – its, a behaviour that surely points towards the need to have higher order corrections under control. The analysis of Ref. [12] uses  $c_{red}$  ' +1 and  $g_8$  ' 3:6, where these numbers are obtained phenom enologically by requiring agreem ent with the two{photon decay of  $K_{L}^{0}$ ;  $^{0}$ ; and  $^{0}$  as well as K ! 2 ;3 . Should we use these values of  $q_{\rm red}$  and  $g_8$  with our result  $^{\text{LMD}}$  (=  $M_{V}$ ) = 22 0.9 we would obtain  $_{K_{L}^{0}}$  = 0.4 1.1, corresponding to a ratio R (K  $_{\rm L}^0$  ! + ) = (2:24 0:41) 10 <sup>5</sup> which is 2:5 above the experimental value R (K  $_{L}^{0}$  ! + ) = (1.21 0.04) 10<sup>5</sup>.
