B Decays in the Upsilon Expansion

A bstract

Theoretical predictions for B decay rates are rewritten in terms of the Upsilon m eson m ass instead of the b quark m ass, using a m odi ed perturbation expansion. The theoretical consistency is shown both at low and high orders. This method in proves the behavior of the perturbation series for inclusive and exclusive decay rates, and the largest theoretical error in the predictions coming from the uncertainty in the quark mass is eliminated. Applications to the determination of CKM matrix elements, moments of inclusive decay distributions, and the B ! X_s photon spectrum are discussed.

1. Introduction

description of quark mixing and CP violation is a $X_u e$ decay rate. At the scale = m_b, large part of the high energy experim ental program in the near future. The goal is to overconstrain the unitarity triangle by directly measuring its sides and (some) angles in several decay modes. Inclusive B decay rates can give information on y_{cb} ; y_{ub} ; y_{ts} ; and y_{td} ;

The theoretical reliability of inclusive m easurements can be competitive with the exclusive ones. For example, for the determ ination of y_{cb} jm odel dependence enters at the same order of $2_{QCD} = m_{c;b}^2$ corrections from both the inclusive sem ileptonic B! X_ce width and the B! D e rate near zero recoil. It is then in portant to test the theoretical ingredients of these analyses via other m easurem ents.

The main uncertainty in theoretical predictions for inclusive B decay rates arise from the poorly known quark masses which de ne the phase space, and the bad behavior of the series of perturbative corrections when it is written in terms of the pole mass. Only the product of these quantities, the decay widths, are well-de ned physical quantities; while perturbative multi-loop calculations are most conveniently done in terms of the pole mass. Of course, one would like to elim inate any quark mass from the predictions in favor of physical observables. Here we present a new method of elim inating m b in term s of the (1S) m eson m ass [2].

2. U psilon Expansion

Testing the Cabibbo {Kobayashi{Maskawa (CKM) Let us consider, for example, the inclusive B !

The variable 1 denotes the order in the modi ed expansion, and $_0 = 11 2n_f = 3$. In comparison, the expansion of the (1S) mass in term s of m $_{\rm b}$ has a di erent structure,

where $' = \ln [= (m_{b} SC_{F})]$ and $C_{F} = 4=3$. In this expansion we assigned to each term one less power than the power of s. It is also convenient of to choose the same renorm alization scale . The prescription of counting n = n in B decay rates as order n, and s in m as order n^{1} is the upsilon expansion. It combines di erent orders in the s perturbation series in Eqs. (1) and (2), but as it is sketched below, this is the consistent way of combining these expressions.

At large orders in perturbation theory, the coe cient of n_s in Eq. (1) has a part which grows as $Cn!_0^{n-1}$. For large n, this divergence is cancelled by the $^{n+1}_{s}$ term in Eq. (2), whose coe cient behaves as $(1 = s) (C = 5)n!_0^{n-1} [\beta \{5].$ The crucial1= s factor arises because the coe cient of s^{n+1} in Eq. (2) contains a series of the form

Linear infrared sensitivity (terms of order are a signal of QCD e ects, quadratic sensitivity (term soforder ${}^{2} \ln {}^{2}$) are a signal of ${}^{2}_{OCD}$ e ects, etc. From Refs. [5,6] it follows that the linear infrared sensitivity cancels in the upsilon expansion to order 2 (probably to all orders as well, but the dem onstration of this appears highly non-trivial).

Thus, the upsilon expansion is theoretically consistent both at large orders for the terms containing the highest possible power of $_0$, and to order² including non-Abelian contributions.

The most important uncertainty in this approach is the size of nonperturbative contributions to m other than those which can be absorbed into m_b. If the mass of heavy quarkonia can be com puted in an operator product expansion then this correction is of order ${}^{4}_{OCD} = ({}_{s}m_{b})^{3}$ by dimensional analysis. O uantitative estimates, however, vary in a large range, and it is preferable to constrain such e ects from data. W e use 100 M eV to indicate the corresponding uncertainty. Finally, if the nonperturbative contribution to mass, , were known, it could be included by replacing m by m on the left hand side of Eq. (2).

There are three surprising facts that are either accidental or indicate that the nonperturbative contributions may be small: 1) applications in term s of the (2S) m ass give consistent results [2]; 2) the D! Xe rate in term softhe massworks (un) reasonably well [2]; 3) sum rule calculations for e⁺e ! bb nd that the 1S b quark m ass (de ned as half of the perturbative part of m (15) is only 20 M eV dierent from m (15)=2 [7].

The rst error is obtained by assigning an uncertainty in Eq. (3) equal to the value of the 2 term and the second is from assuming a 100 MeV uncertainty in Eq. (2). The scale dependence of V_{ub} j due to varying in the range m b=2 < < 2m b is less than 1%. The uncertainty in 1 makes a negligible contribution to the total error. A lthough B (B ! X ue) cannot be measured without signi cant experim ental cuts, for exam ple, on the hadronic invariant mass, this method will reduce the uncertainties in such analyses as well.

The B ! $X_{c}e$ decay depends on both m $_{b}$ and m c. It is convenient to express the decay rate in term s of m and 1 instead of m_b and m_c , using Eq.(2) and

where the phase space factor has also been expanded in , and the BLM [9] subscript indicates that only the corrections proportional to $_0$ have been kept. For com parison, the perturbation series in this relation written in terms of the pole mass is 1 0:12 0.07_{BLM} ² [10]. Including the terms proportional to $_{1:2}$, Eq. (6) in plies [2]

assuming an error in Eq. (6) equal to the 2 term, a $0.25 \,\text{GeV}^{2}$ error in $_{1}$, and a 100 MeV error in Eq. (2), respectively. The second uncertainty can be reduced by determining $_{1}$ (see below).

The theoretical uncertainty hardest to quantify in the predictions for inclusive B decays is the size of quark-hadron duality violation. This was neglected in Eqs. (4) and (7). It is believed to be exponentially suppressed in the m b ! 1 limit, but its size is poorly known for the physical b quark mass. Studying the shapes of inclusive decay distributions is the best way to constrain this experimentally, since duality violation would probably show up in a comparison of di erent spectra. The shape of the lepton energy [11{14] and hadron invariant mass [15,16,14] spectra in sem ileptonic B ! X_ce decay, and the photon spectrum in B ! X_s [17] 21] can also be used to determ ine the heavy quark e ective theory (HQET) parameters and 1. The extent to which these determinations agree with one another will indicate at what level to trust predictions for inclusive rates.

Last year CLEO measured the rst two moments of the hadronic invariant mass-squared (s_H) distribution, hs_H \overline{m}_D^2 i and h(s_H \overline{m}_D^2)²i, subject to the constraint $E_e > 1:5 \text{ GeV}$ [22]. Here $\overline{m}_D = (m_D + 3m_D)=4$. Each of these measurements give an allowed band on the 1 plane. Their intersection gives (at order s) [22]

This agrees well with the analysis of the lepton energy spectrum in Ref. [12], although the order ${}^{3}_{QCD} = m_{b}^{3}$ corrections not included in these analyses introduce large additional uncertainties [14,16].y

In the upsilon expansion is not a free param – eter, so we can determ ine $_1$ directly with smaller gnoertainty. Considering the observable [12] R₁ = $_{1:5G \text{ eV}} \text{ E}_{e} (d = dE_{e}) dE_{e}$ $_{1:5G \text{ eV}} (d = dE_{e}) dE_{e}$, a t to the same data yields [2]

This is in perfect agreement with the value of $_1$ in plied by the CLEO result for $h_{\rm SH} = \overline{m}_D^2$ i in the upsilon expansion. The central value in Eq. (9) includes corrections of order $_{\rm S}^2$ 0 [13], but the result at tree level or at order $_{\rm S}$ changes by less than 0:03 GeV². The rest error is dominated by

y CLEO studied m om ents of the lepton spectrum [22], but the band corresponding to $H_{ei} = (1:36 \quad 0:01 \quad 0:02) \text{ GeV}$ on the CLEO plot cannot be reproduced using the form ulae in Ref. [11]. So I consider only the result in Eq. (8) from Ref. [22]. (I thank Iain Stewart for checking this calculation.)




Figure 1. Prediction for $(1 \ x_B)_{j_{k_B}>1}$ in the upsilon expansion at order $(2)_{BLM}$ (thick solid curve) and (thick dashed curve). The thin curves show the contribution of the 0_7 operator only. (From Ref. [18].)

 $1=m_b^3$ corrections [14] not included in Eq. (8). We varied the dimension-six matrix elements between

 $(0.5 \text{ GeV})^3$, and combined their coe cients in quadrature. The second error is from assuming a 100 MeV uncertainty in Eq. (2).

Another way to test the upsilon expansion, or determ ine the nonperturbative contribution to m , is from B ! X_s . Possible contributions to the total rate from physics beyond the standard m odel are unlikely to signi cantly a ect the shape of the spectrum . The upsilon expansion yields parameter free predictions for m om ents of this distribution. Experimentally one needs to make a lower cut on E , so it is most convenient to study

where $x_B = 2E = m_B$. The parameter = 1 $2E^{m in} = m_B$ has to satisfy > $_{QCD} = m_B$, otherwise nonperturbative e ects are not under control. Order $\frac{2}{s}_{0}$ corrections to the photon spectrum away from its endpoint were computed recently [18]. Fig. 1 shows the prediction for $(1 = x_B)j_{x_B>1}$ as a function of , both at order and $\binom{2}{BLM}$, neglecting nonperturbative contributions to m A + 100M eV contribution would increase $(1 = x_B)$ by 7%, so measuring $(1 = x_B)$ with such accuracy will have in portant in plications for the physics of quarkonia as well as for B physics.

For E > 2:1 GeV Fig. 1 gives $(1 x_B) = 0:111$, whereas the central value from CLEO [23] is around 0.093. Interestingly, including the CLEO data point in the 1:9GeV < E < 2:1 GeV bin, the experimental central value of $(1 x_B)$ over the

region E > 1:9G eV is 0.117, whereas the upsilon expansion predicts 0.120. Ultimately, one would like to see whether prediction and data agree over some range of the cut E^{m in}. One can also evaluate $(1 \ x_B)$ in terms of and 1 without using the upsilon expansion. The CLEO data [23] in the region E > 2:1G eV implies the central values ' 390M eV and '2 0' 270M eV at order s and '2 0, respectively [18]. The BLM terms may not dominate at order '2 [21], so it is important to

calculate the complete two-loop correction to the O_7 contribution to $(1 \quad x_B)$. The upsilon expansion has been applied to form

factor ratios in exclusive sem ileptonic B decays, as well as nonleptonic decays [2], where it also improves the perturbation series (see Table 1). However, the sem ileptonic B branching fraction or the average number of charm quarks in B decay agree with other predictions in the literature. Applications of similar ideas for e⁺ e ! tt are reviewed by Teubner at this Conference [24].

4. Conclusions

Using m and the upsilon expansion, i.e., assigning order n to the order $^{n}_{s}$ term in B decay rates and $^{n-1}$ to the $^{n}_{s}$ term in the perturbative expression for m , is equivalent to using a short distance b quark m ass.

It in proves the behavior of perturbation series for inclusive B decays, and eliminates m_b altogether from the theoretical predictions in favor of m in a simple and consistent manner. It may lead to smaller nonperturbative e ects (to the extent this is rejected in the behavior of perturbation series). The biggest uncertainty is the nonperturbative contribution to m unrelated to the quark m ass. It will be possible to estimate / constrain this from data in the future.
