Seeds of Large Scale Anisotropy in Pre-Big-Bang Cosmology Proceedings of the Spanish Relativity Meeting Bilbao, 1999

Abstract

W ithin a string cosm ology context, the large scale tem perature anisotropies m ay arise from the contribution of seeds to the metric uctuations. We study the cases of electrom agnetic and axion seeds. We methat massless or very light axions can lead to a stor slightly tilted blue spectrum, that to current data.

1 Introduction

I will brie y present some results^{1,2} on the seeds of large scale anisotropy in the context of string cosm ology. I work on the pre-big-bang scenario³ (PBB), de ned as a particular model of in ation inspired by the duality properties of string theory. The question which I address is whether we can reproduce the observed am plitude and slope of the large scale tem perature anisotropy and of large scale density per-turbations within the PBB scenario.

F irst-order scalar and tensorm etric perturbations lead to prim ordial spectra that grow with frequency 4 , with a norm alization in posed by the string cut-o at the shortest ampli ed scales. These blue spectra have too little power at scales relevant for the observed anisotropies in the cosm icm icrow ave background radiation (CM BR). In contrast, the axion energy spectra where found to be logarithm ically diverging, leading to red spectra of CM BR anisotropies which are in con ict with observations. These results already nuled out four dimensional PBB cosm ology.

However, if one allows for internal contracting dimensions in addition to the three expanding ones, the supersymmetric partner of the dilaton (the universal axion of string theory) can lead to a the arrison-Zel'dovich (HZ) spectrum of uctuations for an appropriate relative evolution of the external and the compacties of internal dimensions⁵. Thus, the PBB scenario may contain a natural mechanism for generating large scale anisotropy via the seed mechanism⁶ (i.e., uctuations of one-component of the energy momentum tensor can feed back on the metric through Einstein's equations).

In what follows, I consider the possibility that vacuum uctuations of the electrom agnetic and of the axion eld m ay act, at second order, as scalar seeds of large scale structure and CM BR anisotropies. The induced perturbations are isocurvature perturbations. M ore precisely, I exam ine whether the metric perturbation spectrum triggered by these seeds can be at enough to match present measurements, consistently with the COBE normalization of the amplitude on large scales, and with the normalization in posed by the string cut-o at the shortest amplied scales.

2 Large scale perturbations in the presence of seeds

I will derive a general formula for large scale CMBR anisotropies in models where perturbations are triggered by seeds. I consider the case of scalar perturbations.

2.1 Cosm ological perturbation theory with seeds

W e express the Fourier components of the energy momentum tensor of the seeds, T , in terms of four scalar \seed functions" 7 f , f_p , f_v and f :

Here M denotes an arbitrary mass scale, introduced for dimensional reasons; denotes conform altime and represents a metric of constant curvature.

The perturbed E instein's equations read⁷

where 4 GM^2 , a is the scale factor and dot denotes derivative with respect to . is the anisotropic stress potential, V is the peculiar velocity potential, D (and D_g which I will use later) is a gauge-invariant density perturbation variable. ; are two geom etric quantities, called the Bardeen potentials. Since large scale CM BR anisotropies are induced at recombination and later, we set = 0.

The large scale an isotropies of CMBR are determined by the combination

2.2 The seed contribution to CMBR an isotropies

I calculate the CMBR anisotropies and their contribution to T=T via the Sachs-W olfe e ect⁸. The temperature perturbation reads⁷

where $x() = x_0$ (0) is the unperturbed photon position at time for an observer at x_0 , 0 is the conform altime today, and $x_{dec} = x(_{dec})$.

The angular power spectrum of CM BR anisotropies is expressed in terms of the dimensionless coe cients C_{ν} , which appear in the expansion of the angular correlation function in terms of the Legendre polynomials P_{ν} :

Here the brackets denote spatial average, or expectation values if perturbations are quantized. To determ ine the C_{ν} we Fourier-transform Eq. (7), de ning

For the coe cients $C \cdot of Eq. (8)$ we obtain:

and j_{ν}^{0} stands for the derivative of j_{ν} with respect to its argument. On large angular scales, k _{dec} 1, the SW contribution dom inates and we obtain²:

We approximate² the Bardeen potentials ; on super-horizon scales by a power-law spectrum: hj $^{2}ji = C^{2}$ (k) (k)² : Furtherm ore, we consider² m odels where the seed contribution does not grow in time on sub-horizon scales. Thus,

W e further assume 2 that also C (k) is given by a simple power law . Thus, we have

where N is a dimensionless constant, and k_1 denotes a comoving cuto scale. Inserting Eq. (14) in Eq. (12), we obtain²

We compare $C_{,v}^{SW}$ with the in ationary result: $C_{,v}^{SW}$ / (' 1=2+ n=2)= ('+ 5=2 n=2), where n denotes the spectral index. The scale-invariant spectrum, as it has been found by the DMR experiment⁹, requires 0:9 n 1:5 : Thus, we get

3 Seeds from string cosm ology

In this section we compute the seed functions f $;f_v;f$, and we estimate the Bardeen potentials for electrom agnetic and axion perturbations.

3.1 Electrom agnetic seeds

C onsider a stochastic background obtained by amplifying the quantum electrom agnetic uctuations of the vacuum . For purely magnetic seeds (the electric component of the stochastic background is rapidly dissipated, due to the conductivity of the cosm ic plasm a), on super-horizon scales we obtain f_v = 0, f 2 f, leading to 2

(< 3=2 to avoid photon overproduction.) H $_1$ is the physical cut-o $\,$ scale at which the universe becomes immediately radiation-dom inated, and M $_p$ is the P lanck mass.

Since, in both cases + 1 < 0, the seeds decay fast enough outside the horizon. However, in both cases + = 0.5, which implies n = 2. Such a spectrum grows s too fast with frequency to the COBE m easurements. The quadrupole amplitude¹⁰ $Q_{\text{rm sPS}} = (5=4)C_2T_0 = (18 \ 2)$ K leads to $C_2 = (1.09 \ 0.23) \ 10^{10}$: Thus, compatibility with the COBE norm alization implies²

This constraint is easily satisfied by a growing seed spectrum, > 2. Even in the limiting case = 2, this condition is marginally compatible even with the maximal expected value $H_1 = M_s = 5 = 10^7 \text{ GeV}$.

3.2 A xionic seeds

We consider pseudo-scalar vacuum uctuations amplied by the time evolution of a higher dimensional background. We rst consider massless axions. If < 3=4, the situation is like for electrom agnetic seeds. The induced CMBR uctuations have the wrong spectrum, but their amplitude is su ciently low to avoid con ict with observations. However, if 3=4 3=2, we obtain¹;²

For = $3=2 \text{ we obtain a Harrison-Zel'dovich spectrum with am plitude N ' (H₁=M_p)². The non-conform all coupling of the axions to the metric leads to an additional am – pli cation of perturbations after the matter-radiation equality. The normalization of the axion spectrum to the COBE am plitude in poses the constraint¹²$

This condition is perfectly compatible with H $_1$ $\,$ M $_{s}$ $\,$ 5 $\,10^7$ GeV .

Let us now turn to the case of massive axions. In this case, the f contribution to ; is negligible when the super-horizon modes are already non-relativistic at the time of decoupling, and we obtain 2 constant B ardeen potentials with

where m denotes the axion mass. For = 3=2 we obtain a at Harrison-Zel'dovich spectrum. The amplitude of perturbations is enhanced by the factor $(m = H_{eq})^{1=2}$. Thus, the axion mass, m, has to be bounded to avoid conicting with the COBE normalization C₂ 10¹⁰. In addition, we impose 1:4 < < 1.5, m > H_{dec} H_{eq}, and we require that the present axion energy density is constrained by the critical energy density. We not that for a typical scale H₁ M_s (10¹ 10²) M_p, the maxim al allow ed axion mass window is²:

4 Conclusions

In this talk, I brie y discussed, in the context of the PBB scenario, the possibility that the large scale tem perature anisotropiesm ay arise from the contribution of seeds to the metric uctuations. In particular, I considered the cases in which the seed inhom ogeneity spectrum is due to vacuum uctuations of the electrom agnetic eld and of the (K alb-R am ond) axion eld.

In the rst case, I showed that extrom agnetic uctuations lead to a spectrum that grow s too fast with frequency to be compatible with COBE observations. Since the contribution of electrom agnetic seeds to the large scale anisotropy is negligible, there are no constraints from the COBE norm alization to the production of seeds for generating the galactic m agnetic elds, via the amplic cation of electrom agnetic vacuum uctuations due to a dynam ical dilaton background¹².

In the second case, I discussed how a stochastic background of m assless axions, produced within the context of the PBB scenario, is a possible candidate for an explanation of the large scale anisotropy m easured by COBE satellite. Regarding m assive axions, I showed that if the axion m ass is such that all m odes outside the horizon at decoupling are already non-relativistic, then a slightly tilted blue spectrum is still com patible with the am plitude and slope m easured by COBE satellite, provided the axion m ass is inside an appropriate window, in the ultra-light m ass region.

A sanext step, one has to study the predictions of thism odel regarding the acoustic peaks in the CM BR anisotropy power spectrum and the linear dark matter power spectrum and compare them with currently available experimental and observational data. Some preliminary results are discussed in Ref. [11]. The authors found ¹¹ a strong dependence of their predictions on the overall evolution of extra dimensions during the PBB phase. In other words, further experimental and observational data coming from the CM BR anisotropies and the galaxy distribution, may provide some information about the evolution of string theory's extra dimensions.
