Brane world from IIB matrices

We have recently proposed a dynam ical mechanism that may realize a at four-dimensional space time as a brane in type IIB superstring theory. A crucial rôle is played by the phase of the chiral ferm ion integral associated with the IKKT Matrix Theory, which is conjectured to be a nonperturbative de nition of type IIB superstring theory. We demonstrate our mechanism by studying a simplied model, in which we nd that a lower-dimensional brane indeed appears dynam ically. We also comment on some implications of our mechanism on model building of the brane world.

Introduction. The idea that our four-dimensional space time is realized as a brane in a non-com pact higherdim ensional space time has recently attracted much attention. Through m any works during the last few years, it is expected to provide natural resolutions to m any longstanding problem s in the Standard M odel. The hierarchy problem is transmuted into a geometrical one [1], and it was further argued that the exponential dependence of the \warp" factor in the extra directions reduces the problem to a ne-tuning of order 50 [2]. The cosm ological constant problem may also be resolved in such a setup [3]. It has been argued that any nonzero higher-dim ensional cosm ological constant is absorbed into the warp factor, and that the four-dimensional cosm ological constant is autom atically tuned to zero (or to a very sm all num ber). A possible obstruction to the idea (as opposed to a more conventional idea using Kaluza-Klein com pacti cations) is that gravity may propagate in higher dimensions and thereby contradicts the 4D New ton's law observed in the low energy scale. How ever, the particular AdS-type background m etric that arises naturally in such a setup allow s a norm alizable zero mode of the graviton bound to the brane [4]. A sm all correction to the 4D New ton's law due to the continuum spectrum of massive modes is argued to be small enough to be compatible with the experimental bound. All these attractive features of the idea lead us to hope that there is a natural string-theory realization of the brane world scenario.

In Ref. [5], we have proposed a dynam ical mechanism which may realize a at four-dimensional space time as a brane in type IIB superstring theory. O by jously, such a mechanism should inevitably be of nonperturbative nature. Indeed, our mechanism was based on the IKKT version [6] of the M atrix Theory [7], namely the IIB m atrix model, which is conjectured to be a nonperturbative de nition of type IIB superstring theory. The model is a supersymmetric matrix model composed by ten N Ν herm itian bosonic matrices and sixteen N N hem itian ferm ionic matrices. The space time is represented by the eigenvalues of the bosonic matrices. The model has manifest ten-dimensional Lorentz invariance, where the bosonic and ferm ionic matrix elements transform as a

vector and a M a jorana-W eylspinor, respectively. The integral over the ferm ionic matrices yields a pfa an which is complex in general. This poses a technical di culty known as the bom plex action' problem in studying the IIB matrix model by M onte Carlo simulation. M onte Carlo studies incorporating only the modulus of the pfaf-

an (and om itting the phase by hand) showed that the space-time becomes isotropic in ten dimensions in the large-N limit [8] [9]. This result suggests that the phase of the pfa an must play a crucial rôle if a brane world naturally arises in the type IIB superstring theory. The e ect of the phase is to favour con gurations for which the phase becomes stationary. Such an e ect has been studied within a saddle-point approximation and found to enhance lower-dimensional brane-like con gurations considerably [5].

In this Letter, we demonstrate our mechanism more explicitly by studying a simpli ed model using Monte Carlo simulation. In this case, we nd that the dominant saddle-points are given by con gurations with only threedimensional extent.

The mechanism. The IIB matrix model [6] is formally a zero-volume limit of D = 10, N = 1, pure super Yang-M ills theory. The partition function of the IIB matrix model (and its generalizations to D = 4 and D = 6) can be written as

where $S_b = Tr(A; A \hat{f}^2)=4$, and $A = \ln Z_f A$ represents the electric action induced by integration over the ferm ionic matrices. The dynamical variables A = (A = B); D = B = B are D = B and D = B

The ferm ion integral $Z_f [A]$ is complex in general for D = 10, N 4 and for D = 6, N 3 [5] [11]. We restrict ourselves to these cases in what follows. In the D = 10 case, the ferm ion integral $Z_f [A]$ is given by the pfa an PfM, where M is a $16 (N^2 1) = 16 (N^2 1)$

regarding each of (a) and (b) as a single index. Here,

(= 1; :::; 10) are ten-dimensional W eyl-projected 16 16 gam m a m atrices, satisfying C $C^{y} = ()^{>}$ with $C = C^{>}$ being the unitary charge conjugation matrix. Similarly in the D = 6 case, the ferm ion integral $Z_f[A]$ is given by the determ inant det M $^{(6)}$, where M $^{(6)}$ is a $4 (N^2 1) 4 (N^2 1)$ complex matrix de ned by

regarding each of (a) and (b) as a single index. Here, ⁽⁶⁾ (= 1;:::;6) are six-dimensional W eyl-projected 4 4 gam m a m atrices.

Since the ferm ion integral Z_f [A] is a complex quantity for the cases under consideration, let us write it as $Z_{f}[A] = \exp(((r))$ i⁽ⁱ⁾). In Ref. [5], the e ect of the phase ⁽ⁱ⁾ in the path integral (1) has been studied using a saddle-point approximation, whose validity has been also discussed. The saddle-point equation for (i) is given by

It is useful to introduce the following classi cation of \brane" con gurations

where $n^{(i)}$ (i = 1; ;Dd)are(D d) linearly independent D -dim ensional real vectors. Namely, d represents a set of con gurations with less than d-dimensional extent. Note that 1 2 p, where p is nothing but the whole con guration space of the model. In Ref. [5] we proved that all con gurations in D_2 are solutions to the saddle-point equation (4). A ssum ing that the con gurations in $_{\rm D}$ ₂ are the dom inant saddle-point con gurations, we still have to integrate over those con-

gurations to determ ine the actual dimensionality of the space-time. In fact, the gaussian uctuation of the phase ⁽ⁱ⁾ around the saddle-points gives a huge enhancem ent to the brane con gurations with lower dimensionality, and this enhancem ent cancels exactly the entropical barrier against having such con gurations. In the D = 10case, this provides a dynam icalm echanism for the possible appearance of four-dim ensional space tim e as a brane in ten-dim ensional space time.

A simpli ed model. In order to investigate how our mechanism works, we consider a simpli ed model describing an integration over the saddle-point con gurations. Speci cally, we consider the integral

where the functions F A] and f A] are de ned as

Since the function F [A] vanishes if and only if the conquration fA q satis es the saddle-point equation (4),

the integral (6) is dominated by the saddle-point con qurations in the large- lim it. The function f [A] makes the integral (6) convergent as long as the coe cient is xed to be a real positive number. In fact, the parameter can be absorbed by an appropriate rescaling of A^a and . Therefore we take = 1=2 in what follows without loss of generality. Note also that the simplied m odel (6) is invariant under a SO (D) transform ation 2 SO (D), and a SU (N) trans-A 7 A ,where formation A 7 gA g^y, where g 2 SU (N), which are the sym m etries of the originalm odel (1).

U sing the invariance of the partition function (6) under the change of variables A^a 7 A^a , one can obtain an exact relation

where the ensemble average h i is de ned with the partition function (6). Assuming that hfi goes to a constant c for ! 1, we obtain the asymptotic behavior of hFi for large as

where the coe cient b is given as b = c=2 D (N²) 1)=2. This con m s the above claim that the integral (6) is dominated by the saddle-point con gurations in the large-limit.

A quantity which fully characterizes the dimensionality d of a given con guration can be given by the moment of inertia tensor T de ned by the D D real sym m etric matrix [10]

A con guration fA g belongs to d, if and only if the num ber of zero eigenvalues of the matrix T is more than or equal to (D d). Let us denote the eigenvalues of the matrix T as i (i = 1; ;D), where 2

0. We can determ ine the dimensionality of the D

dom inant saddle-point con gurations from the ensemble average of the eigenvalues h_i in the ! 1 limit.

We address this issue by performing M onte Carlo simulation using a M etropolis algorithm. We create a trial con guration fA^0g by replacing an element A^a of the previous con guration fA g with a new one generated with the probability distribution $\frac{p_1}{2} \exp[\frac{1}{2}(A^a)^2]$. The trial con guration is accepted with the probability min(1;exp(F)), where $F = F[A^0] = F[A]$. This procedure is repeated for all the elements of the con-

guration. The computational e ort required for the above algorithm is of order 0 (N⁸) per one sweep, which is much larger than that for the simulation encountered in Refs. [8,12]. Due to this, results with high statistics are obtained only for the case of D = 6 and N = 3 (we have m ade 192,000 accepted updates for each 384 and 768,000 for = 512).

Results. In the upper part of Fig. 1 we plot the left hand side of (9), which demonstrates the validity of our simulation. In the low erpart of Fig. 1 we plot the average hF A li against in a log-log scale. The straight line represents the t of the data for 16 to the predicted large- behavior (10) with b = 1:7(1).

Fig. 2 shows the six eigenvalues of the moment of inertia tensor T as a function of . We nd that the three smallest eigenvalues h_ii (i = 4;5;6) are monotonously decreasing with a pronounced power law behavior. Fitting the data for 16 to the power law behavior, we extract the powers 0:040(4), 0:199(2) and 0:450(6), respectively. Similarly, the powers for N = 4 are extracted to be 0:11(1), 0:26(2) and 0:36(2). Thus we conclude that the dom inant saddle-point con gurations of the simpli ed model (6) has only three-dimensional extent. Prelim inary results for D = 10, N = 4 suggest that this is the case also for D = 10.

Discussion. The results presented in the previous section shows clearly that the stationarity of the phase

 $^{(i)}$ indeed enhances low er-dimensional brane congurations considerably, thus demonstrating our mechanism. In particular, while the existence of saddle-point congurations other than the congurations in $_{\rm D}$ $_2$ is not excluded, our results suggest that such congurations, even if they exist, can safely be neglected on statistical grounds. Given this observation, the reason why we obtain the dimensionality three' from the dominant saddle-point congurations of the simplified model (6) can be understood analytically. As has been done in Ref. [5] for the IIB matrix model, we can rewrite the

! 1 lim it of the simpli ed model (6) as an integral over the con gurations in $_{\rm D}$ 2. The gaussian uctuation of the phase ⁽ⁱ⁾ should be taken into account by the corresponding Hesse matrix, which is, in the present case, just the square of the one for the IIB matrix model (or its D = 6 version). Due to this, the gaussian uctuation enhances lower-dimensional brane con gurations even more strongly than in the IIB matrix model and overwhelm s the entropical barrier against having those con gurations.

The fact that the lowering of the dimensionality stops at three instead of continuing further down can be understood as follows. We rst note that the ferm ion integral $Z_f [A]$ vanishes for con gurations in ₂ [5]. Therefore, the phase ⁽ⁱ⁾ is actually ill-de ned for con gurations in ₂. Still, we can consider con gurations with A_1 , A_2 being generic and A_i (i = 3; ;D) being of order O ne can easily see that the function F [A] is diverging as ² for ! 0. Therefore, the term in (6) suppresses con gurations in $_2$ strongly. (In other words, con gurations in $_2$ are not saddle-point con gurations, although $_2$ D 2 \cdot)

As is clearly shown in the present work, the enhancement occurs precisely when the space-time becomes a

at low er-dim ensional hyperplane, which we consider as a very attractive feature of our mechanism . N amely, our mechanism has a built-in structure in which the brane that appears as a result of the nonperturbative string dynamics is very likely to be at. A coording to our mechanism, scenarios with two separated branes (i.e. our world and the so-called P lanck' brane as in Ref. [2]), their extensions to many branes [13], and scenarios with mutually intersecting branes [14] seem to be unnatural.

Let us also comment on a connection of our mechanism to the brane world scenario. In Ref. [15], the IIB matrix model is expanded around a D 3-brane conguration perturbatively and four-dimensional noncommutative Y ang-Mills theory has been obtained [16]. The (perturbatively stable) theory, which is obtained in this way from the IIB matrix model, has been recently identied [18] with a type IIB superstring theory in AdS_5 S^5 with an in-

nite B - eld background. Remarkably the metric that appears in the corresponding supergravity solution takes the form of Randall-Sundrum's type [4], and thereby allows for a four-dimensional Newton's law. We expect that brane congurations similar to the D3-brane con-

guration considered above as a background in the IIB m atrix m odel should appear dynam ically as a result of our m echanism. Thus our m echanism is rather directly related to the brane world scenario.

In the IIB m atrix m odel, the enhancement and the entropical barrier are exactly balanced and the actual dim ensionality of the brane is expected to be determ ined as a result of large N dynamics. In this regard, we recall that the low-energy e ective theory of the IIB m atrix m odel has been shown to be described by a branchedpolymer like system in R ef. [19]. There it was further argued that a typical double-tree structure that appears in the e ective theory m ight cause a collapse of the con-

guration to a lower-dimensional manifold. Whether the actual dimensionality of the brane turns out to be four or not can be investigated directly by performing the integration over the saddle-point congurations as form ulated in Ref. [5]. We hope that M onte C arb techniques developed in Ref. [8] will enable us to address such an issue in near future.
