## B rane world from IIB m atrices

#### Abstract

W e have recently proposed a dynam icalm echanism that $m$ ay realize a at four－dim ensional space tim e as a brane in type IIB superstring theory．A crucial role is played by the phase of the chiral ferm ion integral associated w ith the IK K T M atrix Theory，which is con jectured to be a nonper－ turbative de nition of type IIB superstring theory．W e dem onstrate our m echanism by studying a sim pli ed model，in which we nd that a low er－dim ensionalbrane indeed appears dynam ically．W e also com $m$ ent on som $e$ im plications of our $m$ echanism on $m$ odel building of the brane w orld．

Introduction．｜The idea that our four－dim ensional space tim e is realized as a brane in a non－com pact higher－ dim ensional space tim e has recently attracted much at－ tention．Through $m$ any works during the last few years， it is expected to provide naturalresolutionsto $m$ any long－ standing problem $s$ in the Standard $M$ odel．T he hierarchy problem is transm uted into a geom etrical one 1］］，and it was further argued that the exponential dependence of the \warp＂factor in the extra directions reduces the problem to a ne－tuning oforder 50 ［每］．The cosm ological constant problem $m$ ay also be resolved in such a setup 3］． It has been argued that any nonzero higher－dim ensional cosm ological constant is absorbed into the warp factor， and that the four－dim ensional cosm ological constant is autom atically tuned to zero（or to a very sm allnum ber）． A possible obstruction to the idea（as opposed to a m ore conventional idea using $K$ aluza－K lein com pacti cations） is that gravity $m$ ay propagate in higher dim ensions and thereby contradicts the 4D N ew ton＇s law observed in the low energy scale．H ow ever，the particular A dS－type back－ ground $m$ etric that arises naturally in such a setup allow s a norm alizable zero $m$ ode of the graviton bound to the brane 解．A sm allcorrection to the 4D N ew ton＇s law due to the continuum spectrum ofm assivem odes is argued to be sm allenough to be com patible $w$ ith the experim ental bound．All these attractive features of the idea lead us to hope that there is a natural string－theory realization of the brane w orld scenario．

In Ref．5］，we have proposed a dynam icalm echanism which $m$ ay realize a at four－dim ensional space tim e as a brane in type IIB superstring theory．O bviously，such a m echanism should inevitably be of nonperturbative na－ ture．Indeed，our m echanism was based on the $\mathbb{K} K T$ version［6］of the $M$ atrix $T$ heory［7］，nam ely the IIB ma－ trix $m$ odel，which is con jectured to be a nonperturbative de nition of type IIB superstring theory．$T$ he $m$ odel is a supersym $m$ etric $m$ atrix $m$ odel com posed by ten $N \quad N$ herm itian bosonic $m$ atrices and sixteen $N \quad N$ herm i－ tian ferm ionic $m$ atrices．The space tim e is represented by the eigenvalues of the bosonic $m$ atrices．The $m$ odel has $m$ anifest ten－dim ensional Lorentz invariance，where the bosonic and ferm ionicm atrix elem ents transform as a
vector and a M a jorana－W eylspinor，respectively．The in－ tegral over the ferm ionic $m$ atrices yields a pfa an which is complex in general．This poses a technical di culty known as the complex action＇problem in studying the IIB $m$ atrix $m$ odel by $M$ onte $C$ arlo simulation．$M$ onte C arlo studies inconporating only the m odulus of the pfaf－
an（and om itting the phase by hand）showed that the space－tim e becom es isotropic in ten dim ensions in the large N lim it［ G］［9］．This result suggests that the phase of the pfa an must play a crucial role if a brane world naturally arises in the type IIB superstring theory．T he $e$ ect of the phase is to favour con gurations for which the phase becom es stationary．Such an e ect has been studied within a saddle－point approxim ation and found to enhance low er－dim ensional brane－like con gurations considerably 目］．

In this Letter，we dem onstrate our $m$ echanism $m$ ore explicitly by studying a sim pli ed model using $M$ onte carlo sim ulation．In this case，we nd that the dom inant saddle－points are given by con gurationsw th only three－ dim ensional extent．

The mechanism ．｜The IIB m atrix model［］is for－ $m$ ally a zero－volum e lim it of $D=10, N=1$ ，pure super Yang－M ills theory．The partition function of the IIB ma－ trix m odel（and its generalizations to $\mathrm{D}=4$ and $\mathrm{D}=6$ ） can be w ritten as

$T$ he ferm ion integral $Z_{f}[A]$ is complex in general for $\mathrm{D}=10, \mathrm{~N} 4$ and for $\mathrm{D}=6, \mathrm{~N} 3$ 团 11］．We restrict ourselves to these cases in what follow s．In the $D=10$ case，the ferm ion integral $Z_{f}[\mathbb{A}]$ is given by the pfa an P $\mathbb{M}$ ，where $M$ is a $16\left(\mathbb{N}^{2} \quad 1\right) \quad 16\left(\mathbb{N}^{2} \quad 1\right)$

Since the ferm ion integral $Z_{f}[A]$ is a complex quantity for the cases under consideration, let us write it as $Z_{f}[\mathbb{A}]=\exp \left({ }^{(r)} \quad i^{(i)}\right)$. In Ref. 可], the e ect of the phase (i) in the path integral (1) has been studied using a saddle-point approxim ation, whose validity has been also discussed. The saddle-point equation for ${ }^{(i)}$ is given by

where ${ }^{(i)} \quad(i=1 ; \quad$;D $\quad$ d) are ( $D \quad$ d) linearly independent D -dim ensional real vectors. Nam ely, a represents a set of con gurations w ith less than d-dim ensional extent. N ote that $1 \quad 2 \quad D$, where $D$ is nothing but the whole con guration space of the m odel. In
 lutions to the saddle-point equation (4). A ssum ing that the con gurations in $D 2$ are the dom inant saddle-point con gurations, we still have to integrate over those con-
gurations to determ ine the actualdim ensionality of the space-tim e. In fact, the gaussian uctuation of the phase
${ }^{(i)}$ around the saddle-points gives a huge enhancem ent to the brane con gurations w ith lower dim ensionality, and this enhancem ent cancels exactly the entropicalbarrier against having such con gurations. In the $D=10$ case, this provides a dynam icalm echanism for the possible appearance of four-dim ensionalspace tim e as a brane in ten-dim ensional space tim e.

A sim pli ed model.| In order to investigate how our m echanism works, we consider a sim pli ed modeldescribing an integration over the saddle-point con gurations. Speci cally, we consider the integral

Since the function $F \mathbb{A}]$ vanishes if and only if the conguration $\mathrm{fA} g$ satis es the saddle-point equation (1), the integral (G) is dom inated by the saddle-point con $g$ urations in the large- lim it. The function $f \mathbb{A}] m$ akes the integral (6) convergent as long as the coe cient
is xed to be a real positive num ber. In fact, the para$m$ eter can be absorbed by an appropriate rescaling of $A^{a}$ and. Therefore we take $=1=2$ in what follow s w ithout loss of generality. N ote also that the sim plied model ( $\beta$ ) is invariant under a SO (D) transform ation A 7 A , where $2 S O(D)$, and a $S U(\mathbb{N})$ transformation A 7 gA $g^{y}$, where $g 2 S U(\mathbb{N})$, which are the sym $m$ etries of the originalm odel (1).

U sing the invariance of the partition function (G) under the change of variables $A^{a} 7 \quad A^{a}$, one can obtain an exact relation

$1)=2$. $T$ his con m sthe above claim that the integral ( $(\bar{F})$ is dom inated by the saddle-point con gurations in the large- lim it.

A quantity which fully characterizes the dim ensionality $d$ of a given con guration can be given by the $m$ om ent of inertia tensor $T$ de ned by the D D realsymmetric m atrix 10]

A con guration fA $g$ belongs to $d$, if and only if the num ber of zero eigenvalues of the $m$ atrix $T$ is $m$ ore than or equal to (D d). Let us denote the eigenvalues of the $m$ atrix $T$ as $i(i=1 ; \quad$; $)$, where 2

0. W e can determ ine the dim ensionality of the
dom inant saddle－point con gurations from the ensemble average of the eigenvalues $h_{i} i$ in the ！ 1 lim it．

W e address this issue by perform ing M onte C arlo sim ulation using a $M$ etropolis algorithm ．W e create a trial con guration $f A^{0} g$ by replacing an elem ent $A^{a}$ of the previous con guration fA $g w$ ith a new one gener－ ated w th the probability distribution $\frac{1}{2} \exp \left[\frac{1}{2}\left(A^{a}\right)^{2}\right]$ ． The trial con guration is accepted w the probability $m$ in $(1 ; \exp (F))$ ，where $\left.F=F\left[A^{0}\right] F \mathbb{A}\right]$ ．This procedure is repeated for all the elem ents of the con－ guration．The computational e ort required for the above algorithm is of order $O\left(\mathbb{N}^{8}\right)$ per one sweep，which is $m$ uch larger than that for the sim ulation encountered in Refs．8［12］．D ue to this，results with high statistics are obtained only for the case of $D=6$ and $N=3$（we have $m$ ade 192，000 accepted updates for each 384 and 768,000 for $=512$ ）．

Results．In the upper part off ig． 1 w e plot the left hand side of（9），which dem onstrates the validity of our sim ulation．In the low erpart ofF ig．目we plot the average hF ® ］i against in a log－log scale．The straight line represents the $t$ of the data for 16 to the predicted large－behavior（10）w ith $\mathrm{b}=1: 7$（1）．

F ig． B show s the six eigenvalues of the m om ent of in－ ertia tensor $T$ as a function of.$W e$ nd that the three sm allest eigenvalues $h_{i} i \quad(i=4 ; 5 ; 6)$ are $m$ onotonously decreasing with a pronounced power law behavior．Fit－ ting the data for 16 to the power law behavior，we extract the powers $0: 040(4), 0: 199(2)$ and $0: 450(6)$ ， respectively．Sim ilarly，the powers for $N=4$ are ex－ tracted to be $0: 11(1), 0: 26(2)$ and $0: 36(2)$ ．T hus we conclude that the dom inant saddle－point con gurations
of the sim pli ed model（p）has only three－dim ensional extent．P relim inary results for $\mathrm{D}=10, \mathrm{~N}=4$ suggest that this is the case also for $D=10$ ．

D iscussion．The results presented in the previous section show s clearly that the stationarity of the phase
（i）indeed enhances low er－dim ensionalbrane con gura－ tions considerably，thus dem onstrating our m echanism． In particular，while the existence of saddle－point con $g-$ urations other than the con gurations in $D 2$ is not excluded，our results suggest that such con gurations， even if they exist，can safely be neglected on statisti－ cal grounds．G iven this observation，the reason why we obtain the dim ensionality three＇from the dom inant saddle－point con gurations of the simpli ed model（6） can be understood analytically．A s has been done in Ref．目］for the IBB $m$ atrix $m o d e l$ ，we can rew rite the
！ 1 lim it of the simpli ed model（ $(\beta)$ as an integral over the con gurations in $D 2$ ．The gaussian uctua－ tion of the phase ${ }^{(i)}$ should be taken into account by the corresponding $H$ esse $m$ atrix，which is，in the present case，just the square of the one for the IIB $m$ atrix $m$ odel （or its $D=6$ version）．Due to this，the gaussian uc－ tuation enhances low er－dim ensionalbrane con gurations even $m$ ore strongly than in the IIB $m$ atrix $m$ odel and overw helm s the entropical barrier against having those con gurations．

The fact that the low ering of the dim ensionality stops at three instead of continuing further dow $n$ can be under－ stood as follow s．W e rst note that the ferm ion integral $Z_{f}[\mathbb{A}]$ vanishes for con gurations in 2 目］．Therefore， the phase ${ }^{(i)}$ is actually ill－de ned for con gurations in 2．Still，we can consider con gurations w th $A_{1}, A_{2}$ being generic and $A_{i}(i=3 ; \quad$ ；$)$ being of order O ne can easily see that the function $F[A]$ is diverging as

2 for ! 0. Therefore, the term in ( $(\mathbf{)}$ ) suppresses con gurations in 2 strongly. (In otherwords, con gurations in 2 are not saddle-point con gurations, although 2 D 2 .)
A $s$ is clearly shown in the present work, the enhance$m$ ent occurs precisely when the space-tim e becom es a at low er-dim ensional hyperplane, which we consider as a very attractive feature of our m echanism. N am ely, our $m$ echanism has a built-in structure in which the brane that appears as a result of the nonperturbative string dynam ics is very likely to be at. A ccording to ourm echanism, scenariosw ith tw o separated branes (i.e. ourw orld and the so-called P lanck' brane as in Ref. 目]), their extensions to $m$ any branes 13], and scenarios $w$ ith $m$ utually intersecting branes 14] seem to be unnatural.

Let us also com $m$ ent on a connection ofourm echanism to the brane world scenario. In Ref. 15], the IIB m atrix m odel is expanded around a D 3-brane con guration perturbatively and four-dim ensionalnoncom $m$ utative $Y$ ang$M$ ills theory has been obtained 16]. T he (perturbatively stable) theory, which is obtained in this way from the IIB $m$ atrix $m$ odel, has been recently identi ed [13] with a type IIB superstring theory in $A d S_{5} \quad S^{5} w$ ith an in-
nite B - eld background. Rem arkably the $m$ etric that appears in the corresponding supergravity solution takes the form of $R$ andall-Sundrum 's type [4] , and thereby allows for a four-dim ensional $N$ ew ton's law. W e expect that brane con gurations sim ilar to the D 3-brane conguration considered above as a background in the IIB $m$ atrix $m$ odel should appear dynam ically as a result of our $m$ echanism. T hus our $m$ echanism is rather directly related to the brane w orld scenario.

In the IIB $m$ atrix $m$ odel, the enhancem ent and the entropicalbarrier are exactly balanced and the actualdi$m$ ensionality of the brane is expected to be determ ined as a result of large $N$ dynam ics. In this regard, we recall that the low-energy e ective theory of the IBB $m$ atrix m odel has been show $n$ to be described by a branchedpolym er like system in $R$ ef. 19]. There it was further argued that a typical double-tree structure that appears in the ective theory $m$ ight cause a collapse of the con-
guration to a low er-dim ensionalm anifold. W hether the actual dim ensionality of the brane tums out to be four or not can be investigated directly by perform ing the integration over the saddle-point con gurations as form ulated in Ref. [5]. W e hope that $M$ onte $C$ arlo techniques developed in Ref. [8] w ill enable us to address such an issue in near future.
