Vacuum condensate of mass dimension 2

as the origin of mass gap and quark con nement

A bstract

We propose a vacuum condensate of mass dimension 2 consisting of gluons and ghosts in the framework of the manifestly covariant gauge xing of the SU (N) Yang-Mills theory. This quantity is both BRST and anti-BRST invariant for any gauge. It includes the ghost condensation C^aC^a proposed ret in the modied Maximal Abelian gauge and reduces to the gluon condensates (A)² of mass dimension 2 proposed recently in the Landau gauge of the Lorentz gauge xing. The vacuum condensate of dimensions 2 can provide the elective mass for gluons and ghosts. The possible existence of such condensations is demonstrated by calculating the operator product expansion of the gluon and ghost propagators in both gauges. Its implications to quark connement are also discussed in consistent with the previous works.

1 Introduction

It is widely believed that the QCD vacuum is characterized by the vacuum condensate and that the vacuum condensate is a key object to understand the non-perturbative dynamics of QCD. The most famous example is the quark condensate for light quarks (u or d):

The quark condensate has the canonical dimension 3. A nonvanishing value of the quark condensate signals the spontaneous breaking of chiral sym metry.

Now we raise a question as to whether there is a vacuum condensate which is able to signal the quark con nem ent. Indeed, in the gluon sector, the gluon condensate of dim ension 4:

has played the crucial role for suggesting the existence of nonperturbative vacuum in the fram ework of the QCD sum rule [1]. Here the Capital index A runs over A=1; N1 for the gauge group G=SU(N). The gluon condensate of dimension 4 (2) has something to do with the quark con nement, since quark con nement is believed to be caused by a nonperturbative dynam ics among gluons.

Recently, a novel type of a vacuum condensate of dimension 2, i.e., ghost condensation (more precisely, ghost (anti-ghost condensation)¹ [2,3] of the type,

has been proposed as a signal of quark con nement [4,5]. Here the italic index a runs over the same range as the Capital index A but the indices i of the Cartan subalgebra (We call the eld with the index a the o-diagonal component, while the eld with the index i of the Cartan subalgebra the diagonal component hereafter. For G = SU(2), we choose a = 1;2 and i = 3.) The unequal treatment of the o-diagonal and diagonal components is a consequence of the Maximal Abelian gauge (MA) gauge. The MA gauge is a covariant (partial) gauge xing which restrict the original non-Abelian gauge group G = SU(N) to the maximal torus group $H = U(1)^{N-1}$. After the MA gauge xing for the o -diagonal gluon components Aa, the theory has the residual H local gauge sym m etry. In particular, we have adopted a modi ed version of the M A gauge (the modied M A gauge [6]) which has several advantages compared with the naive MA gauge [5]. The MA gauge is a unique gauge which is able to realize the dual superconductivity [7,8] of the QCD vacuum in the sense that it leads to the infrared Abelian dominance [9,10] and that it allows us to derive the dual G inzburg-Landau theory and the other equivalent theories, e.g., antisym m etric tensor theory, the magnetic monopole theory, a conning string theory as low-energy e ective theories of QCD, see [4]. However, the analyses carried out so far for the ghost condensation were in the rather heuristic level.

¹ If we allow the spontaneous breaking of the ghost number Q_C to take place, the ghost and anti-ghost condensations are not prohibited [3]. In this paper, we assum e Q_C Di = 0.

Soon after the works [2,3] (but independently), the existence of another vacuum condensate of dim ension 2:

has been stressed by Boucaud et al. [12] and Gubarev, Stodolsky and Zakhaharov [13]. Their studies are based on the conventional covariant gauge xing of the Lorentz type, especially they have chosen the Landau gauge = 0 for the gauge xing param eter. The physical meaning of the gauge non-invariant condensate h(A A)2 i has been nicely explained by Gubarev and Zakharov [14] and a close connection to the topological defects, i.e., magnetic monopole has been suggested. A lthough the quantity h(A A)2i is gauge non-invariant, the m in im al value of the integrated squared potential A_{min}^2 has a de nite physical meaning. This was demonstrated by the numerical simulation of com pact U (1) lattice gauge theory where A $_{\rm m}^{2}$ signals the quark con nem ent in the sense that it is non-zero only in the strong coupling region $e > e_c$ where quark connem ent occurs due to monopole condensation. Monopole condensation is believed to be an essential mechanism of quark con nement also in QCD. In fact, the maqnetic monopole dominance in the MA gauge for quark con nement (i.e., saturation of the string tension by the magnetic monopole con guration) has been con rmed by num erical simulation on a lattice [11]. Therefore, these results strongly suggest the im portance of dimension 2 vacuum condensates in understanding the quark con nement also in OCD.

One of the purposes of this paper is to announce the results of more systematic investigations (along the idea [3]) performed based on the operator product expansion (OPE) [15] and the elective action derived from the Wilson renormalization group (RG) [16], although the details will be published in a subsequent long paper [17]. The results of these analyses show that in the MA gauge another vacuum condensate of dimension 2, i.e.,

together with (3) must exist in the Yang-M ills theory and that both condensates can be responsible for quark con nement in QCD. In fact, we can show that the existence of two kinds of the vacuum condensates of dimensions 2, i.e., (3) and (5), are consistent with the OPE and RG. In fact, the RG analysis show that the linear combinations of two condensates behaves as the nonvanishing masses for the o-diagonal gluons and o-diagonal ghost (and anti-ghost) and that the masses are the invariants under the RG. This result strongly supports the infrared Abelian dominance which has been con med by numerical simulations on a lattice in the last decade. Thus both condensates constitute basic ingredients for deriving the dual superconductor picture of the QCD vacuum, as demonstrated in a previous paper [4].

As is well known, the Yang-M ills theory with the gauge xing has a global sym-metry, i.e., the Becchi-Rouet-Stora-Tyutin (BRST) symmetry and the anti-BRST symmetry [18,19] which play the role of the substitute of the gauge symmetry which was lost by the gauge xing procedure. The original Yang-M ills Lagrangian does not involve both the gluon bilinear term, A A and the ghost bilinear term C C, since

the inclusion of such terms in the Lagrangian breaks the gauge invariance and the BRST invariance. Therefore, they should be generated dynam ically as a quantum e ect. The vacuum condensates of dimension 2 (which is gauge dependent) does not appear in the OPE of the gauge invariant quantity, e.g., the spectral function $(Q^2) := i^R d^4 x e^{iqx} h 0 \text{ T} [j(x); j(0)] j 0;$ where $q^2 = Q^2$ and j(x) are local currents constructed on the quark and gluon elds. This is a reason why the dimension 2 vacuum condensate has not been seriously discussed so far. However, the OPE of the gauge non-invariant quantity, e.g., the propagator and the vertex function, can involve the gauge (parameter) dependent and gauge non-invariant vacuum condensate of dimension 2. Each composite operator providing the vacuum condensate, (3) and (5), is not BRST invariant. In view of these, we guess that two types of vacuum condensates of dimension 2 m ight be related to each other so that an appropriate combination of two condensates may give a BRST invariant quantity. A nother purpose of this paper is to show that this is indeed the case: we propose a BRST and anti-BRST invariant combination of dimension 2 vacuum condensates, 2

where $^{\mathbb{D}\,\, 1}$ is the volume of the D-dimensional spacetime. Here the trace is taken over the broken generators of the Lie algebra of the original group G, i.e, G itself for the Lorentz gauge and G=H for the partial (MA) gauge (i.e., o-diagonal components). The BRST invariance of O is shown in Appendix. The existence of a linear combination of a number of operators with the same mass dimension and the same symmetry is very natural from the viewpoint of the operator mixing. Moreover, we suggest that it is an order parameter for quark connement in the general formulation of the Yang-Mills theory in the manifestly covariant gauge xing. This criterion should be compared with the well-known gauge-invariant criterion of quark connement, i.e., the area law decay of the Wilson loop. It is clear that O reduces to the A $_{\rm min}^2$ in the Landau gauge = 0. Therefore, the Landau gauge turns out to be a rather special case in which we do not need to consider the ghost condensation.

If he expectation value of 0 in the translational invariant vacuum yields hO i = htr $\frac{1}{2}$ A (0) A (0) iC (0) C (0) i: In the elective potential approach, this value is obtained as the stationary point ($_0$; $_0$) which gives the minimum of the elective potential U (;) written in term softhe auxiliary elds and corresponding to the composite operators, tr $\frac{1}{2}$ A A and tr iC C, respectively. In the MA gauge, it is shown that an additional ghost condensation hi ab C a C b i is necessary and hence we need to consider three composite operators: A a A a , iC a C a and i ab C a C b . Hence the analysis becomes rather complicated, for details see [17].

2 OPE of the gluon and ghost propagators

 $^{^2}$ Note that there is a freedom of choosing a overall factor. Therefore, only the ratio of two coe cients in the linear combination (6) is xed from the requirement of the BRST and anti-BRST invariance.

2.1 The Lorentz gauge

First, we consider the question: What is the most general Lagrangian that is a local function of the elds, A A; B A; C A; C A and satis es the following conditions? (1) of mass dimension 4, (2) Lorentz invariant, (3a) BRST invariant, (3b) anti-BRST invariant, (4) Hem itian, (5) zero ghost number (6) global gauge invariant, (7) (multiplicative) renormalizable. Here it is implicitly assumed that the Lagrangian is restricted to a polynomials of the elds, and that there is no higher derivative terms, since there is no intrinsic mass scale in the Yang-Mills theory. The answer was given by Baulieu and Thierry-Mieg [20,21]: The Lagrangian is given by

where $_{i}$ (i=1;2;3;4) are arbitrary constant, and $_{B}$ and $_{B}$ are the BRST and anti-BRST transform ations. The rst term is the Yang-M ills Lagrangian, the second term is the topological term which is not discussed in this paper. The rst and the second term s are gauge invariant. On the other hand, the third and the fourth term s are identified with the gauge xing term, since they break the gauge invariance of the Lagrangian. A first the rescaling of the parameters into the eld rede nitions, the above result leads to the GF+FP term [22]:

The nal term is allowed for the renormalizability of the total Lagrangian and is written in the BRST exact or anti-BRST exact form, B^BA = i_B (C^BB^) = i_B (C^BB^). By performing the BRST and anti-BRST transformations, we obtain

If we im pose one more condition, i.e., the FP conjugation invariance,

the second term of (8) is excluded, i.e., 0 = 0.

When = 0, this theory reduces to the usual Yang-M ills theory in the Lorentz type gauge xing with the gauge xing parameter 0:

This is consistent with the FP prescription.

For 60, a quartic ghost interaction exists. Therefore we must go beyond the FP prescription. Elim inating the Nakanishi-Lautrup eld B, we obtain

where we have de ned = + 0 and = $\frac{=2}{+}$: When = 0 or = 1, the quartic ghost interaction disappears and the Lagrangian reduces to the usual FP Lagrangian. It is shown that = 0 and = 1 are xed point of the renormalization group. Once = 0 or = 1 is chosen, therefore, is not renormalized by quantum corrections. Then we recover the FP Lagrangian. The FP conjugation invariance is broken in the usual FP Lagrangian where the ghost and anti-ghost are not treated on equal footing. In other words, the FP conjutation is recovered for 0 = 0 (or = 1=2 and =) by including the quartic ghost interaction even for = 0.

We would like to point out that in the Landau gauge = 0 (i.e., = 0) which was adopted in the works [12,13] claim ing the existence of mass dimension 2 gluon condensate, the ghost condensation can not occur. There is a fact that the Landau gauge is a xed point of the theory and hence we do not need to consider the ghost condensation as far as the theory is kept on the Laudau-gauge xed point. This is a reason why we do not need to consider a possibility of the ghost condensation in the Landau gauge supporting the claim of the existence of the gluon condensate (4) alone. In the non-Landau gauges 6 0, the quartic ghost interaction is necessary for renorm alizability. This ghost self-interaction may cause the ghost condensation and hence, even in the Lorentz type gauge xing, the ghost condensation

is possible in gauges 6 0 other than the Landau gauge. In this way, we can understand that two kinds of mass dimension 2 vacuum condensate exist in general in the Yang-Mills theory (and that one of them was claimed to exist earlier in the heuristic works [2,3]), providing a thorough understanding of this phenomena.

In the Landau gauge, the OPE of the gluon and ghost propagators have been evaluated, see [23{27}]. First, the gluon propagator D AB (p) = h0 f [A A (p)A B (p)]j0i has the OPE:

where the global SU(N) invariance is assumed in addition to the Lorentz invariance. A coording to the method [23,28], the W ilson coe cient can be calculated in perturbation theory by equating a (2 + n)-point one-particle irreducible (1PI) G reen's function { where two of the external legs have hard momentum and the remaining

n external legs are assigned zero m om entum { with the coe cient times an n-point G reen's function with an insertion of the operator under study at zero m om entum . It should be remarked that the ghost condensate hC C i can not appear in this expression, since the ghost{anti-ghost{gluon vertex $gf^{ABC}p$ is proportional to the outgoing ghost m om entum p . Hence we obtain

(This is not the case in the Lorentz gauge with 60 and in the MA gauge where the ghost condensation is expected to occur.) The result of investigations [23,24,26,27] shows that the SU (N_c) Yang-M ills theory in the D-dimensional spacetime has

In order to satisfy the Slavnov-Taylor identity, the vacuum polarization tensor AB m ust be transverse. This is indeed the case. Here, the order $1=p^2$ term includes the ghost condensation $h(F^A)^2$ i and the gluon condensation $h(F^A)^2$ i of m ass dimensions 4.

Next, the ghost propagator (G^{AB}) (p) = h0+T [C A (p)C B (p)] f i has the OPE:

By the same reason as the above, a W ilson coe cient vanishes:

and hence the ghost condensation h0½ $^{\rm C}$ C $^{\rm C}$ j0i does not apper in the 0PE in this gauge. The explicit calculation of the W ilson coe cient yields

Owing to gluon condensation of mass dimension 2, we not that all the gluons acquire the nonvanishing elective mass as

whereas all the ghost acquire the elective mass as

Rem arkably, the nonvanishing mass obtained for = 0 in this way does not break the BRST symmetry, since the vacuum polarization tensor is transverse and the ST identity is always satis ed. However, the elective mass is gauge parameter dependent.

Recent num erical simulations suggest the existence of such a 1= p^2 ultraviolet (UV) correction [29]. The num erical simulations suggest the value $g_R^2 hA^2 i_R = (2.76 \, {\rm GeV})^2$ for SU (3). This value should be compared with the value h— (F A) 2i . Moreover, the OPE of the three-gluon vertex show that the vacuum condensate of mass dimension 2 yields the UV corrections 2 = Q^2 in the QCD running coupling constant $_s(Q^2)$:

Such a correction for the coupling constant [30,31] leads to a piece of the linear potential $_{\rm S}r$ at short distances r! 0 in addition to the usual C oulom b-like potential $C_{\rm F} \, \frac{s\,(r)}{r}$ with $C_{\rm F} \, = \, \frac{N\,_{\rm c}^{\,2} \, 1}{2N\,_{\rm c}}$. Here the string tension of the short-distance linear potential is proportional to the the gluon condensate of m ass dimension 2:

The right hand side of this equation is BRST and anti-BRST invariant (A special case = 0 of the operator O). So is the left hand side, i.e., the string tension of the short string. This argument suggests that the quark con nement is already intertwined in the UV region of QCD. Thus it is expected that the linear potential or the area law of the Wilson loop at short distances r 1 could well be extrapolated to large distances r 1 by including higher-order corrections up to a desired order. In the case of 60, it is easy to understand (by repeating the OPE calculation to the lowest non-trivial order g²) that the quartic ghost interaction induces the ghost condensation of m ass dimension 2 in the OPE and hence shifts the elective m ass by this contribution. However, it is not yet checked whether the combination of two condensations of m ass dimension 2 obtained from the OPE agrees with the BRST and anti-BRST invariant combination (6). In this sense, the Landau gauge is the most economical gauge in the Lorentz type gauge xing, since we do not need to worry about this issue.

2.2 The modied M A gauge

Now we turn our attention to the modied MA gauge [6],

A characteristic feature of the M A gauge is that it breaks the global SU (N) sym m etry explicitly as well as the local SU (N) sym m etry. However, the global gauge sym m etry is broken by the BRST-exact term, since the breaking is caused by the gauge xing plus Faddeev-Popov term of the form, (29). In this sense, the M A gauge resembles the renormalizable R gauge in the gauge-Higgs theory where the would-be Nambu-Goldstone mode in the GF+FP term breaks explicitly the original global gauge sym metry and hence the massless Nambu-Golstone particle does not appear. For more details of the modied MA gauge, see [3,4,6,33] [40].

In the SU (2) Yang-M ills theory in the D-dimensional spacetime, the OPE of the propagator in the modi ed MA gauge is obtained as follows (The full details including higher order terms will be given in a forthcoming paper [17]). According to the standard method [23,28] and the Feynman rules [37,38], it is shown that the o-diagonal gluon propagator D ab (p) \Rightarrow hOJT [A a (p)A b (p)]Di has the OPE:

where is the gauge xing parameter of the Lorentz type gauge xing for the diagonal gluon. It is shown that $C^{[^{cd}C^{c}C^{d}]ab}(p) = 0$ up to $O(g^2)$. Hence the mixed o-diagonal condensation hi $^{cd}C^{c}C^{d}$ i does not appear in the OPE and hence in the excive mass

of the o -diagonal gluons at least to this order.⁴ This result agrees with that of the elective potential approach which will be reported later [17]. In the MA gauge, the vacuum polarization of the o -diagonal gluon is not transverse, whereas that of the diagonal-gluon is transverse owing to the residual U (1) symmetry. In other words, the o -diagonal gluon eld A a and the gauge xing parameter receive the dierent renormalization, as explicitly evaluated in [2] for SU (2) and [37] for SU (N) at one-loop level.

Theo -diagonal ghost propagator (G^{ab}) (p) = h0 f [C^{a} (p) C^{b} (p) f i has the OPE:

Thus we can identify the elective mass of the ordiagonal gluon with a linear combination of two vacuum condensates of mass dimension 2 as

Sim ilarly, the o -diagonal ghost has the e ective m ass given by

These values should be compared with those in the previous work [3].

Although we can give the arguments which are similar to those in the Lorentz gauge given above, we do not repeat them here. Nevertheless, we shall give a comment on the relationship of this result with quark connement. In the previous paper [4], we have claimed that the string tension is proportional to the o-diagonal gluon mass (up to a logarithmic correction):

If the e ective mass of the o-diagonal gluon was extrapolated to the infrared (IR) region so the the pole mass was obtained in the gauge invariant combination, i.e., m_A^2 ghO i from the proposed operator O of mass dimension 2, the above relation (36) could lead to the BRST invariant string tension in the gauge xed formulation of the Yang-M ills theory. The RG approach to this issue will be given elsewhere.

3 Conclusion and discussion

In this paper we have investigated a possibility of gluon and ghost condensation of mass dimension 2 in the Yang-Mills theory with the manifestly covariant gauge

xings, i.e., the Lorentz gauge and the modi ed M A gauge. We have discussed that the condensation of mass dimension 2 provides a mechanism of elective mass generation of the gluons and ghosts by demonstrating their existence in the OPE of the gluon and ghost propagators. Especially, we have proposed a BRST-invariant combination of two vacuum condensates of mass dimension 2, which reduces in the Landau gauge = 0 of the Lorentz gauge to the gluon condensates of mass dimension 2 proposed recently by several authors [12,13] and include the ghost condensation in the modi ed M A gauge claimed in [2,3].

However, the gluon and ghost propagators are not BRST invariant. Therefore, there is no guarantee as to whether a linear combination of the vacuum condensates derived by the OPE can be BRST invariant or not. The RG approach can connect the UV region to the infrared (IR) region by successive integration of high-energy modes in a systematic way. Anyway, this point clearly warrants further studies.

The existence of mass dimension 2 vacuum condensate can shed more light on clarifying the mechanism of color con nement from a nonperturbative point of view. The interplay between the chiral symmetry breaking and the quark con nement can also be discussed by including the quarks into the above formalism. The OPE result obtained in this paper can provide a good starting point for the Schwinger-Dyson equation approach to clarify a non-perturbative features of QCD.

A BRST invariance of the proposed operator O

For the Yang-Mills gauge theory, the BRST transformation is given by

where A; B; C and C are the gauge eld, the Nakanishi-Lautrap (NL) auxiliary eld, the Faddeev (Popov (FP) ghost and anti-ghost elds respectively. A nother BRST transform ation, say anti-BRST transform ation [19]), is given by

Here we have used the following notation:

where f^{ABC} are the structure constants of the Lie algebra G of the gauge group G.

A .1 Lorentz gauge

We consider only the 0 = 0 case. By elim inating the Nakanishi-Lautrap eld B, the on-shell BRST and anti-BRST transform ations are obtained as

The anti-BRST invariance is also shown in the sim ilar way. Moreover, the vacuum expectation value of $_{\rm B}$ O is zero owing to the translational invariance of the vacuum,

in agreem ent with Q_B j0i = 0.

A 2 M odied M A gauge

In the modied MA gauge, the on-shell BRST and anti-BRST transform ation is given by

where $D^{ab}[a] := 0$ ab $gf^{abi}a^i$: If we calculate the BRST transform ation of the operator O, all the trilinear terms in the eld coming from the BRST transform ation cancel to obtain a simple result,
