Conform al Field Theory Interpretation of Black Hole Quasi-norm al Modes

W e obtain exact expressions for the quasi-norm alm odes of various spin for the BTZ black hole. These modes determ ine the relaxation time of black hole perturbations. Exact agreement is found between the quasi-norm al frequencies and the location of the poles of the retarded correlation function of the corresponding perturbations in the dual conform al eld theory. This then provides a new quantitative test of the AdS/CFT correspondence.

The problem of how a perturbed therm odynam ical system returns to equilibrium is an important issue in statisticalm echanics and nite tem perature eld theory [1]. For a sm all perturbation, this process is described by linear response theory [1,2]. The relaxation process is then completely determined by the poles, in the momentum representation, of the retarded correlation function of the perturbation. On the other hand, black holes also constitute a therm odynam ical system . At equilibrium , the various therm odynam ical quantities, such as the tem perature and the entropy, are determined in terms of the mass, charge and angularm om entum of the black hole. The decay of sm all perturbations of a black hole at equilibrium are described by the so-called quasi-norm alm odes [3]. For asymptotically at black hole space-times, quasinorm alm odes are analysed by solving the wave equation form atter or gravitational perturbations, sub ject to the conditions that the ux at the horizon is ingoing, with out-going ux at asymptotic in nity. The wave equation, subject to these boundary conditions, admits only a discrete set of solutions with complex frequencies. The im aginary part of these quasi-norm al frequencies then determ ine the decay time of small perturbations, or equivalently, the relaxation of the system back to therm al equilibrium .

On another front, over the last few years increasing evidence has accumulated that there is a correspondence between gravity and quantum eld theory in at space-time (for a review, see [4]). In particular, this duality has led to important progress in our understanding of the microscopic physics of a class of near-extrem al black holes. The purpose of this letter is to analyse whether such a correspondence exists between quasi-norm alm odes in anti-de Sitter (AdS) black holes and linear response theory in scale invariant nite tem perature eld theory. A correspondence between quasi-norm almodes and the decay of perturbations in the dual conform al eld theory (CFT) was rst suggested in [5]. The analysis of [5] is based on the num erical com putation of quasi-norm alm odes for AdS-Schwarzschild black holes in four, ve, and seven dimensions. Further numerical computations of quasi-norm alm odes in asymptotically AdS space-

tim es have been presented in [6]- [11]. For related discussions in the context of black hole form ation see [12]. Qualitative agreement was found with the results expected from the conformal eld theory side. However, a quantitative test of such a correspondence between quasi-norm alm odes and the linear response of the dual conform al eld theory is lacking so far. In this paper, we consider the $2 + 1 \dim ensional A dS$ black hole [13], and show that there is a precise quantitative agreem ent between its quasi-norm al frequencies and the location of the poles of the retarded correlation function describing the linear response on the conformal eld theory side. Both computations are performed analytically. As a result, we can identify not just the lowest, but the complete (in nite) set of frequencies on both sides of the AdS/CFT correspondence. In spite of its simplicity, this model plays an important role also for black holes in higher dimensions whose near-horizon geometry is $A dS_{2+1}$ (see e.g. [14] for a review and references).

The metric of the BTZ black hole is given by

The angular coordinate has period 2, and the radii of the inner and outer horizons are denoted by r_+ and r, respectively. We have also set to unity the radius of the anti-de Sitter space, '1. The dual conform all eld theory on the boundary is 1 + 1 dimensional, the conform all symmetry being generated by two copies of the V irasoro algebra acting separately on left- and right-moving sectors. Consequently, the conform all eld theory splits into two independent sectors at therm all equilibrium with temperatures

A coording to the $A dS_3/CFT_2$ correspondence, to each eld of spin s propagating in $A dS_3$ there corresponds an operator 0 in the dual conform al eld theory characterised by conform alweights (h_L ; h_R) with [4]

and is determined in terms of the mass m of the eld. In particular, we have

for scalar elds, and

for both fem ionic and vector elds. For a small perturbation, the manner in which the eld theory relaxes back to thermal equilibrium can then be analysed within linear response theory [2]. One expects that at late times the perturbed system will approach equilibrium exponentially with a characteristic timescale. This time-scale is inversely proportional to the imaginary part of the poles, in momentum space, of the correlation function of the perturbation operator 0. In the present case, according to our proposal, the relevant correlation function is the retarded real time correlation function

where D $(x;x^0) = D_+ (x;x^0)$ D $(x;x^0)$ is the commutator evaluated in the equilibrium canonical ensemble. For a conformal eld theory at zero temperature, the 2-point correlation functions can be determined, up to a normalisation, from conformal invariance. At nite temperature T, one has to take into account the in - nite sum over in ages to render the correlation function periodic in in aginary time, with period 1=T. The result of this summation in two dimensions has been determined in [15], and depends only on the conformal dimensions (h_L; h_R) of the perturbation operator. We have (x = t),

and a similar expression for D (x) with ! . In order to determ ine the location of the poles, we need to compute the Fourier transform of (6). This is com – plicated by the presence of the function. We can, how ever determ ine the location of the poles indirectly. For this we rst consider the Fourier transform of the commutator D (x). This integral can be evaluated using contour techniques, leading to [16]

where $p = \frac{1}{2}$ (! k). This function has poles in both the upper and lower half of the !-plane. The poles lying in the lower half-plane are the same as the poles of the retarded correlation function (6). Restricting the poles of (7) to the lower half-plane, we nd two sets of poles

Here, and in the following, n takes the integer values (n = 0;1;2;:::). This set of poles characterises the decay of the perturbation on the CFT side, and coincides precisely with the quasi-norm al frequencies of the BTZ black hole, as we shall now show for elds of various spin.

<u>Scalar Perturbation</u> (s = 0). Scalar perturbations are described by the wave equation

W e use the ansatz

Here, ! and k are the energy and angular momentum of the perturbation. Changing variables to $z = \tanh^2$, we end up with the hypergeom etric equation

The solution which is in-going at the horizon is given by

The quasi-norm alm odes for the scalar perturbations were found in [17] by imposing the vanishing D irichlet condition at in nity. Here, we re-evaluate these m odes using the condition that the ux given by

vanishes at asymptotic in nity. For $m^2 > 0$, the asymptotic ux has a set of divergent term s, with the

leading term of order $(1 z)^2 ext{ s}$. Each of these term s is proportional to [18]

Thus, the asymptotic ux vanishes if $c_s = n$, or $c_s = b_s = n$, i.e.

U sing (11), one sees that these are the quasi-normal modes found in [17]. For the scalar bulk eld, we have $h_L = h_R = \frac{1}{2} \ 1 + \frac{1}{1 + m^2}$. Thus, we observe that (17) exactly reproduces (8).

In AdS space-time, a negative mass squared for a scalar eld is consistent, as long as $1 < m^2 < 0$. A detailed analysis shows that in this case there is a second set of modes with $a_s = n$, or $b_s = n$, that is $h_L = h_R = \frac{1}{2} \ 1 \ 1 + m^2$. This is in fact expected as for $1 < m^2 < 0$ there are two sets of dual operators with $+ = 1 + \frac{1}{1 + m^2}$ and $= 1 \ 1 + m^2$, respectively [4]. The second set of quasinom al frequencies in this range then m atches exactly the dual operators with = . We note in passing that the D irichlet boundary condition suggested in [5] leads to the same quasi-norm alm odes form $^2 < 0$.

<u>Ferm ion Perturbation</u> (s = 1=2). In [9], the quasinorm alferm ionic perturbation in the BTZ background has been analyzed num erically. However, as expected, it is possible to nd analytic solutions in this simple case [19]. We begin with the D irac equation

Following [19], we make the substitutions

and a similar equation where 0_1 , 0_2 , and k and k are interchanged. The solutions of these equations with in-going ux at the horizon are given by

where $= \frac{ik_{+}}{2}$, $f = \frac{1}{2}(m + \frac{1}{2})$, $c_{f} = \frac{1}{2} + 2$, and $a_{f} = \frac{k_{+}}{2i} + \frac{k}{f} + \frac{1}{2}$; $b_{f} = \frac{k_{+} + k}{2i} + f$: (22)

The asymptotic form (z ! 1) of $_1$ and $_2$ can now be determined explicitly. In analogy with the scalar perturbations, we then in pose the condition that the ux [19]

vanishes at in nity. The resulting quasi-norm alm odes are then obtained as follows. For m > 0, the leading divergent term in the asymptotic ux is of order $(1 z)^{2 + 1}$. Vanishing ux then requires that the coe cient

vanishes, that is,

The above conditions imply that all coe cients of the sub-leading, asymptotically non-vanishing, contributions to the ux also vanish. Thus, we have precise agreem ent with (8), where the left and right conform alweights are given by $h_{L} = \frac{1}{4} + \frac{1}{2}m$, and $h_R = \frac{3}{4} + \frac{1}{2}m$. For m < 0, one obtains a similar result with $h_L = \frac{3}{4} - \frac{1}{2}m$, and $h_R = \frac{1}{4} - \frac{1}{2}m$. Note again that in posing D irichlet boundary conditions for 1 and 2 at in nity would lead to the absence of quasi-norm alm odes for 1 < m < 1. We can think of no physical reason for the absence of quasi-norm al modes in this range of masses. Thus, we take this as another motivation for imposing vanishing ux at in nity, rather that D irichlet conditions for asymptotically AdS space-times. One should also note that for positive mass the spinor perturbation is asymptotically left-handed, whereas it is right-handed for negative m ass (see also [4]).

<u>Vector Perturbation</u> (s = 1). The massive M axwell eld in $A dS_3$ is described by the storder equation

where $A_{1,2} = A_+$ A . Then, after changing variables as before, we recover the scalar equation (12) for A_1 and A_2 [19], where the scalar mass squared is replaced by $m^2 + 2"_im$, with $"_1 = "_2 = 1$. As in the scalar case, the solutions with in-going ux at the horizon are then given by

Note that the two $\scalarmodes"$ in (27) are not independent. The storder equation (26) relates the two coe cients e $_1$ and e_2 by

The remaining component A is related to A by

For a real vector eld, the particle ux is not de ned. O ne way to avoid this di culty is to consider a com – plex vector eld. A lternatively, one can consider the energy ux divided by the red-shifted frequency [16]. B oth approaches lead to the same conditions, namely that A_1 and A_2 vanish at in nity. Thus, we impose D irichlet boundary condition for $A_{1;2}$. U sing (30), one nds the leading asymptotic behaviour (z ! 1) of the

solutions (28) for positive m is given by

By imposing the vanishing D irichlet condition at in nity for the components A_1 and A_2 , we not the quasinorm alm odes $a_v + 1 = n$, or $b_v = n$, i.e.

Now, for spin s = 1, the conform alweights are either $jn \not j=2$ or $1+jn \not j=2$. Thus, we again nd agreement with (8), where the left and right conform alweights are given by $h_L = \frac{1}{2}m$, and $h_R = 1+\frac{1}{2}m$. For negative m, the situation is analogous to the fermionic perturbations. One nds the same conditions with $h_L = 1 - \frac{1}{2}m$, and $h_R = -\frac{1}{2}m$.

In conclusion, we have shown that there is a quantitative agreem ent between the quasi-norm al frequencies of the BTZ black hole and the poles of the retarded correlation function of the corresponding perturbations of the dual conform al eld theory. The relaxation tim e for the decay of the black hole perturbation is determ ined by the in aginary part of the low – est quasi-norm alm ode. Our analysis thus establishes a direct relation between this relaxation tim e and the tim e-scale for return to equilibrium of the dual conform al eld theory. This result also provides a new quantitative test of the AdS/CFT correspondence.
