W arped Solitonic D eform ations and P ropagation of B lack H oles in 5D Vacuum G ravity

Abstract

In this paper we use the anholonom ic fram es m ethod to construct exact solutions for vacuum 5D gravity with m etrics having o {diagonal components. The solutions are in general anisotropic and possess interesting features such as an anisotropic warp factor with respect to the extra dimension, or a gravitational scaling/running of some of the physical parameters associated with the solutions. A certain class of solutions are found to describe Schwarzschild black holes which \solitonically" propagate in spacetime. The solitonic character of these black hole solutions arises from the embedding of a 3D soliton con guration (e.g. the soliton solutions to the K adom tsev{Petviashvily or sine{G ordon equations}) into certain ansatz functions of the 5D metric. These solitonic solutions may either violate or preserve local Lorentz invariance. In addition there is a connection between these solutions and noncommutative eld theory.

I. IN TRODUCTION

Recent work in string theory and brane physics has suggested new paradigms for solving things like the hierarchy problem using novel treatments of the extra dimensions that occur in these theories [1]. One approach is to view the extra dimension (s) as compactiled, but

at a size much larger than the P lanck length. This is the \large extra dimension" scenario [2]. Another approach is to postulate that most particles and elds are suppressed from moving into the extra dimension (s) by a exponential \arger factor with respect to the extra dimension (s). This is the R and all-Sundrum (R S) model [3].

The RS model in particular has gained considerable popularity in high energy physics, cosm ology and black hole physics [4{8]. Recently, it was shown [9,10] that by considering o {diagonal metrics, which are diagonalized using anholonom ic frames, that the RS and Kaluza{K lein theories become locally anisotropic and exhibit a variation or \nunning" of some of the constants associated with these metrics. This variation of the elective 4D constants occurred with respect to either the extra dimension coordinate or one of the angular coordinates. These anisotropic solutions also exhibited RS style warp factors, but without the need for any speci c brane energy-momentum tensor { the warp factor arose from anisotropic, vacuum solutions in 5D gravity.

In refs. [11] the anholonom ic fram es m ethod was used to construct 4D and 5D vacuum solutions w ith one orm ore of the ansatz functions which param eterized the o {diagonalm etric being taken as a solitonic solution to some nonlinear equation. The two cases considered were the solitonic solutions of the 3D K adom tsev {Petviashvili and sine{G ordon equations. (2D solitonic solutions in 4D general relativity were originally introduced in ref. [12]. A recent discussion can be found in ref. [13]. G eneralizations to 3D are given in refs. [14]). These 3D solitons, embedded in the 5D spacetime, could be seen as solitonic, traveling pulses which m ight have a larger cross section for being detected as compared to standard gravitational waves.

In the present work we exam ine how black hole solutions are modiled when combined with the anisotropic/warped/solitonic congurations of refs. [11]. We begin by param eterizing a 5D spacetime with many o {diagonal metric components. Into this o { diagonal metric we then embed a 4D Schwarzschild solution. Adding to this various anisotropic/warped/solitonic congurations it is found that the black hole solution can be modiled in a number of interesting ways. First, the horizon can be anisotropically deformed. A long with the deformation of the horizon we nd that some of the \constants" of the original Schwarzschild solution become dependent on one or more of the coordinates (e.g. the mass of the solution becomes dependent on the 5th coordinate. Second, the 3D solitonic congurations can move or propagate the black hole either in the normal uncompactied spatial dimensions, or in the extra, compactied spatial dimension.

In this paper use the term \locally anisotropic" spacetime or \anisotropic' spacetime" for a 5D pseudo-Riem annian spacetime with an anholonomic frame structure with mixed holonomic and anholonomic variables. The anisotropy of the gravitational interactions arises as a result of the o {diagonal metrics, or, equivalently, by their diagonalized versions given with respect to anholonomic frames.

The paper has the following structure: in section II we present the theoretical fram ework of the anholonomic frames method. We then introduce the 5D metric ansatz form and write down the corresponding vacuum Einstein equations. We show that it is possible to embed the K adom two-Petviashvili and sine-G ordon solitons into this system through one of the ansatz functions. This creates a 3D gravitational soliton. In section III a 4D Schwarzschild solution is embedded in the 5D spacetime and deformed in various ways. These deform ations lead to some of the \constant" parameters of the original 4D Schwarzschild solution scaling

with respect to some of the coordinates. In section IV we focus on three classes of solutions with small deform ations of the horizon. The deform ation of the horizons come from the 3D soliton solutions of section II. In section V we exam ine solitonic black hole solutions which m ove in the bulk 5D spacetime. These moving black hole solutions can be given with either spherical or deform ed horizons. In section V I we discuss the physical features of the various solutions and give our conclusions.

II.OFF {D IAGONAL M ETRICS AND 3D SOLITONS

The Schwarzschild solution in isotropic spherical coordinates [16] is given by

The re{scaled isotropic radial coordinate is $b = = a_{q}$; with $a_{q} = r_{q} = 4$; is connected with the usual radial coordinate r by $r = (1 + r_q = 4)^2$; $r_q = 2G_{[4]}m_0 = c^2$ is the 4D Schwarzschild radius of a point particle of m ass m₀; G_[4] = $1=M_{P_{[4]}}^{2}$ is the 4D N ew ton constant expressed via the Planck mass M_{P[4]} (M_{P[4]} may be an elective 4D mass scale which arises from a more fundam ental scale of the full, higher dimensional spacetime). In the rest of the paper we set c = 1: The system of coordinates is (t; ; ;'); where t is the time like coordinate and (; ;') are 3D spherical coordinates. The metric (1) is a vacuum static solution of 4D Einstein equations with spherical symmetry describing the gravitational eld of a point particle of m ass m₀: It has a singularity for r = 0 and a spherical horizon at $r = r_{a}$; or at b = 1 in the re{scaled isotropic coordinates. This solution is parametrized by a diagonal metric given with respect to holonom ic coordinate frames. This spherically symmetric solution can be deformed in various interesting ways using the anholonom ic frames method. Writing down a general o {diagonal metric ansatz we rst embed the above form of the Schwarzschild solutions into the metric. Then this o {diagonalmetric with the embedded Schwarzschild solution is diagonalized with respect to the anholonom ic frames. The resulting eld equations are of a form that is relatively simple, and allows for analytical solutions which represent anisotropic deform ations of the original Schwarzschild solution.

A.O {diagonalm etric ansatz

The simplest way to compute the nontrivial coe cients of the Ricci tensor for the (4) is to do this with respect to anholonom ic bases (5) and (6), which reduces the 5D vacuum E instein equations to the following system :

The various partial derivatives are denoted as $\underline{a} = @a = @x^1; a = @a = @x^2; a^0 = @a = @x^3; a = @a = @v: The details of the computations leading to this system are given in refs. [9,10].$

This system of equations (7) { (10), (11) and (12) can be solved by choosing one of the ansatz functions (e.g. h_4 (xⁱ;v) or h_5 (xⁱ;v)) to take some arbitrary, but physically interesting form. Then the other ansatz functions can be analytically determ ined up to an integration in terms of this choice. In this way one can generate m any solutions, but the requirement that the initial, arbitrary choice of the ansatz functions be \physically interesting" m eans that one wants to make this original choice so that the nal solution generated in this way yield a well behaved solution. To satisfy this requirement we start from well known solutions of E instein's equations and then use the above procedure to deform this solutions in a number of ways.

The Schwarzschild solution is given in terms of the parameterization in (3) by

which represents a trivial embedding of the 4D Schwarzschild metric (1) into the 5D spacetime. We now want to anisotropically deform the coe cients of (17) in the following way

The factors $_{i}$ and $_{[l]}^{2}$ can be interpreted as re-scaling or renormalizing the original ansatz functions. These gravitational \polarization" factors { $_{4;5}$ and $_{[l]}^{2}$ { generate non{trivial values for $w_{i}(x^{i};v);n_{i}(x^{i};v)$ and $_{i}(x^{i};v);v$ is the vacuum equations (7) { (12). We shall also consider more general nonlinear polarizations which can not be expresses as h h_{0} : In the next section we show how the coe cients a() and b() of the Schwarzschild metric can be polarized by choosing the original, arbitrary ansatz function to be some 3D soliton con guration.

B.3D soliton deform ation of metric coe cients

Vacuum gravitational 2D solitons in 4D E instein vacuum gravity were originally investigated by Belinski and Zakharov [12]. In ref. [11] 3D solitonic con gurations in 4D gravity were constructed on anisotropic Taub-NUT backgrounds. Here we show that 3D solitonic con gurations can be embedded into 5D vacuum gravity.

The simplest way to construct a solitonic deformation of the o {diagonal metric in equation (3) is to take one of the \polarization" factors $_4$, $_5$ or the ansatz function n_i as a solitonic solution of some particular non-linear equation. The rest of the ansatz functions can then be found by carrying out the integrations of equations (7) { (12).

As an example of this procedure we take $_5$ (r; ;) to be a soliton solution of the K adom tsev{Petviashvili (K dP) equation or (2+1) sine-G ordon (SG) equation (R efs. [14] contain the original results, basic references and m ethods for handling such non-linear equations with solitonic solutions). In the K dP case $_5$ (v; ;) satisfies the following equation

We can also consider less general versions of the SG equation where $_5$ depends on only one (e.g. v and x_1) variable. We will use the notation $_5 = \frac{K}{5}^P$ or $_5 = \frac{SG}{5}$ ($h_5 = h_5^{KP}$ or $h_5 = h_5^{SG}$) depending on if ($_5$) (h_5) satisfies equation (18), or (19) respectively.

Having chosen a solitonic form for $h_5 = h_5^{KP;SG}$; h_4 can be found from

where $h_{[0]}$ is a constant. By direct substitution it can be shown that equation (20) solves equation (8) with given by (13) when $h_5 \notin 0$. If $h_5 = 0$; then h_4 is an arbitrary function h_4 (xⁱ;v). In either case we will denote the ansatz function determ ined in this way as $h_4^{KP;SG}$ although it does not necessarily share the solitonic character of h_5 . Substituting the values $h_4^{KP;SG}$ and $h_5^{KP;SG}$ into from equation (13) gives, after two v integrations of equation (10), the ansatz functions $n_i = n_i^{KP;SG}$ (v; ;). Here, for simplicity, we set $g_{i,3} = -1$ so that the holonom ic 2D background is trivial. In ref. [11] it was shown how to generate solutions using 2D solitonic con gurations for g_2 or g_3 .

In addition to imposing a solitonic form on h_5 it is possible to carry out a similar procedure starting with h_4 or n_i (i.e. choose $_4$ or n_i to satisfy equation (18) or equation (19) and then use equations (7) { (12), (13) and (20) and to determ ine the other ansatz functions).

The main conclusion of this subsection is that the ansatz (3), when treated with anholonom ic frames, has a degree of freedom that allows one to pick one of the ansatz functions ($_4$, $_5$, or n_i) to satisfy some 3D solitonic equation. Then in terms of this choice all the other ansatz functions can be generated up to carrying out some explicit integrations and di erentiations. In this way it is possible to build exact solutions of the 5D vacuum E instein equations with a solitonic character.

In this section exact 5D vacuum solutions are constructed by rst embedding the 4D spherically symmetric Schwarzschild solution into the 5D metric (2). These solutions are then deformed by $xing h_4 or h_5$ to be of the K dP or SG form discussed in the last subsection (in our example we take h_5 to be of the solitonic form). This \renormalizes" the gravitational constant, making it develop a coordinate dependence

The polarization, ! $(x^{i};v)$, is induced by the solitonic character of h_{4} or h_{5} (in our example h_{5}). For simplicity, we shall om it the indices K P or SG for the coe cients of metric, since this will not result in ambiguities.

A . Solutions with trivial conform alfactor = 1

A particular case of metric (4) with trivial conform al factor is given by

The vacuum 5D metric (22) constructed in this way is a particular case of (3) with = 1;w_i = 0; _i = 0; but with non{trivial values of $h_{4;5} = h_{4;5}$ (a;b;!) and $n_k = n_k$ (xⁱ;a;b;!). These non-trivial $h_{4;5}$ and n_k give a renorm alized gravitational constant of the form $_g$! $-_g = !_g$: In the trivial limit !! 1; n_k ! 0; $h_{4;5}$! $h_{4;5(0)}$ (xⁱ) we recover not just the trivial embedding of the Schwarzschild metric into the 5D spacetime (17), but also the following metric

This metric is related to the metric in equation (17) by the multiplication of the 4D part of the metric by the conform al factor a 1 () and a further extension to 5D. This metric does not satisfy the vacuum 5D equations. Nevertheless, it is possible to deform such a metric, by introducing self{consistently some o {diagonalmetric coe cients which make the resulting metric into a solution of the vacuum E instein equations. The treatment of such o {diagonal metrics is that a 3D solitonic wave (satisfying the equation (18), or (19)) may polarize the constants of the conform ally transform ed solution of equation (26) to generate a 5D vacuum solution.

The metric in equation (22) still has the same horizon and singularities as the 4D Schwarzschild metric of equation (17), but it has the new feature that the gravitational constant is coordinate dependent. This coordinate dependence comes from the coordinate dependence of $(x^{i};v)$.

There are two types of solutions which give an anisotropic renorm alization of the gravitational constant: one where the anholonom ic coordinates are chosen as (v = '; p = t), and ! = ! (;;'), $_5 = !^2$ (;;'), $h_{4[0]} = sir^2$ and $h_{5[0]} = b=a$. These are called the '-solutions. The second form is with the anholonom ic coordinates taken as (v = t; p = '), and ! = ! (;;t), $_5 = !^2$ (;;t), $h_{4[0]} = b=a$ and $h_{5[0]} = sir^2$). These are called the t-solutions. The form of each of these solutions when ! € 0 is:

An almost identical solution can be constructed for the t-solutions, but with $_4$ having the form of the SG solution in equation (29).

If the internal coordinate is taken to be compactified as in the standard K aluza-K lein approach so that = 0 is equivalent to = 2 then the SG form for $_5$ or $_4$ has the problem of not being single valued (i.e. $_5(=0) \notin _5(=2)$). If one considers the extra dimension to be uncompactified then one has the interesting feature that (via equation (21) { $-g = -g(4 \tan^{-1} [e])^{-1=2}$) the strength of the gravitational coupling decreases as one moves of the 3D brane (= 0) into the extra dimension ($\notin 0$) for the + solution in equation (29); the gravitational coupling increases as one moves of the 3D brane for the needs an overall RS-type [3] exponential suppression as one moves in the extra dimension. We show that this is possible in the next subsection.

B.Solutions with non-trivial conform al factor 61

It is straight forward to incorporate the special case solution given in equation (30) of the last subsection to the form in equation (33). The only change is that the metric in equation (30) is multiplied by an overall factor of exp [2kj j], which exponentially connes all elds and particles (except gravity) to the 3D brane. Thus one has the variation of the gravitational coupling discussed in the last subsection along with a non-compact extra dimension. Because of the simply form for $_5$ for this special solution the $_i$ functions are arbitrary functions rather than being given by the forms in equation (33). The t-solution of the last subsection can also be extended to the form given in equation (34). Now the solitonic form for $_4$ ($_4 = 4 \tan^1 k$]) has an elect not only on the strength of the gravitational coupling, but also on the overall conform al factor since $^2 / _4$ from equation (28). For the $_4 = 4 \tan^1 k$] solution this just enhances the exponential suppression as one moves away from = 0. For the $_4 = 4 \tan^1 k$] solution the solitonic $_4$ factor can initially dom inate over the e $^{2kj j}$ factor as one move away from = 0.

The solutions of this section were generated by starting with a 4D Schwarzschild metric and trivially embedding it into a 5D metric. It was found that by xing certain ansatz functions of the metric to take the form of either the 3D K dP or SG soliton that the gravitational constant in 4D and various other parameters of the metric became \solitonically" renorm alized. In addition these 3D soliton con gurations could propagate in the 5D metric in such a manner so as to give a solitonic gravitational wave.

IV . SOLITON IC DEFORM AT IONS OF HOR IZONS

By considering o {diagonal metrics and using the anholonom ic frames method it is possible to construct 4D and 5D black holes with non{spherical horizons (In refs. [9,11,10] solutions with ellipsoidal, toroidal, disk like, and bipolar horizons are discussed). In this section we demonstrate that it is possible to deform spherical horizons by the solitonic con gurations of the last section.

We begin with the case oft{solutions which have a trivial polarization, $_5 = 1$, but with $_4 = _4$ (xⁱ;t), so that $_4 \in 0$. This will lead to solutions with a trivial renorm alization of constants, but with a sm all deform ation of the spherical horizon.

The spherical horizon of non {deform ed solutions is de ned by the condition that the coe cient b() from equation (16) vanish. This occurs when = 0:A small deform ation of the horizon can be induced if $e = e^{e(x^i;t)} \cdot 1 + e(x^i;t)$; for a small parameter 1: This renorm alizes b! $\mathfrak{B} = \mathfrak{b}[1 + (x^i;t)]$: Setting $\mathfrak{s} = 1$ and $\mathfrak{a} = 1 + (x^i;t)$ we require that the pair $\mathfrak{a}h_{\mathfrak{a}(0)}$; $\mathfrak{h}_{\mathfrak{s}(0)}$ satisfy equation (8). The $_4(t) = 1 + 4 \tan^1 [e^t]$ solution starts at t = 0 with the nite value 1 + and goes to 0 as t ! 1. Thus the horizon is initially deformed, but approaches the Schwarzschild form as tincreases. The $_4(t) = 1 + 4 \tan^1 [e^{t+t}]$ solution also starts at t = 0 with the value 1 + a, but approaches the value 1 + 4. The deform ation of the horizon increases as t increases.

Since $h_5 = 0$ the function $(x^i;t)$ is arbitrary and so m any dimensional event possible scenarios exist for generating small deformations of the horizon. Here we have taken $(x^i;t)$ as being a 3D soliton con guration, leading to small, solitonic deformations of the horizon. In appendix A we give the general forms for these deformed horizon solutions with $! \notin 1$ and/or $\notin 1$.

The solutions de ned in this section and appendix A illustrate that extra dimensional, anholonom ic gravitational vacuum interactions can induce two types of e ects: renorm alization of the physical constants and sm all deform ations of the horizons of black holes.

V.MOVING SOLITON (BLACK HOLE CONFIGURATIONS

There is another class of vacuum solutions based on the 4D black hole embedded into the 5D spacetime. It is possible to combine the solitonic characteristics of the solutions discussed in section IIB with the embedded 4D black hole to generate a con guration which describes a 4D black hole propagating in the 5D bulk. These solutions can be set up so as to have the renorm alization of the parameters of the metric and/or have deform ed horizons.

A. The Schwarzschild black hole propagating as a 3D Soliton

The horizon is defined by the vanishing of the coefficient b() from equation (16). This occurs when e = 1. In order to create a solitonically propagating black hole we define the function $= _0$ (;v), and let $_0$ (;v) be a soliton solution of either the 3D K dP equation (18), or the SG equation (19). The simplest version q_f the above class of solutions are the t{solutions, de ned by a pair of ansatz functions, B (xⁱ;t); h₅₍₀₎, with h₅ = 0 and B (xⁱ;t) being a 3D solitonic con guration. Such solutions have a spherical horizon when h₄ = 0 i.e. when = 0. This solution describes a propagating black hole horizon. The propagation occurs via a 3D solitonic wave form depending on the time coordinate, t, and on the 5th coordinate . The form of the ansatz functions for this solution (both with trivial and non-trivial conform al factors) is

To obtain the simplest form of this solution we also take $n_{k[1]}(x^i) = n_{k[2]}(x^i) = 0$ as in our previous examples. This example can be easily extended to the solution in equation (41) with a non-trivial conform al factor that gives an exponentially suppressing factor, $\exp[2kj]$. In this manner one has an elective 4D black hole which propagates from the 3D brane into the non-compact, but exponentially suppressed extra dimension,

In appendix B we give the forms for two classes of solutions with = 1 and for two classes with $\neq 1$. These solutions contain various combinations of the previous solutions: solitonically propagating horizons; deformed horizons; renormalized constants.

The solutions constructed in this section and appendix B describe propagating 4D Schwarzschild black holes in a bulk 5D spacetime. The propagation arises from requiring that certain of the ansatz functions take a 3D soliton form. In the simplest version of these propagating solutions the parameters of the ansatz functions are constant, and the horizons are spherical. It was also shown that such propagating solutions could be form ed with a renorm alization of the parameters and/or deform ation of the horizons.

VI.CONCLUSIONSAND DISCUSSION

In this work, we have addressed the issue of constructing various classes of exact solutions which generalize the 4D Schwarzschild black hole metric to a bulk 5D vacuum spacetime.

Throughout the paper the m ethod of anholonom ic fram es was applied to a general, o { diagonal 5D m etric ansatz in order to integrate the E instein equations and determ ine the ansatz functions. In this way a host of di erent solutions were investigated which had a number of interesting features such as a \renorm alization" of the parameters of the ansatz, deform ation of the horizons, and self(consistent solitonic propagation of black holes in the bulk 5D spacetime. The essential features of each of these solutions would remain unchanged even if we had started with ellipsoidal or toroidal rather than spherical horizons (see ref. [9] for discussions on black holes with ellipsoidal or toroidal horizons), introduced m atter sources, considered cosm ological constants, or used an anisotropic Taub NUT background [11,10].

In the rst part of the paper, we considered solutions with renormalized \constants" { g = g = 1 g where $g = r_g=4$ and r_g is the Schwarzschild radius. The induced coordinate dependence of g was connected with the extra dimension and/or the anholonom ic gravitational interaction. Since g depends on Newton's constant, the value of the point mass, and the speed of light one could interpret this induced coordinate dependence as a variation of Newton's constant, an anisotropic mass, or a variation in the speed of light/gravity waves. In the rst case we obtain a Randall-Sundrum like correction of Newton's force law [9,10]. In our case this arises from the use of anholonom ic fram es instead of a brane con gurations. In the second case, we obtain an anisotropic gravitational interaction com ing from the anisotropic e ective mass. In the third case, we can have metrics which violate local Lorentz symmetry since light and gravitational waves could have propagation speeds which are not constant [5].

In the second part of the paper, we analyzed congurations where 3D solitons in 5D vacuum gravity induced small \solitonic" deformations of the horizon. The simplest examples were \pure" deformations which did not renormalize the constants. It was possible to combine the horizon deformation elects with the renormalization of the constants considered in

the rst part of the paper. The anisotropy of these con gurations was connected with either an angular coordinate or the time-like coordinate.

The third part of the paper was devoted to solutions which described 4D black holes moving solitonically in the 5D spacetime. The solitonic character of these solutions came from setting the form of one of them etric ansatz functions to either the 3D K dP or SG soliton con guration. It was shown that these propagating black hole solutions could be combined with the elects discussed in the rst to parts of the paper, generating propagating black holes with renorm alized constants and/or deform ed horizons.

M athem atically this paper demonstrates the usefulness of the anholonom ic frames m ethod, developed in refs. [9,11,10], in constructing solutions to the 4D and 5D E instein vacuum eld equations with o {diagonal metrics. By introducing anholonom ic transforms we were able to diagonalize the metrics and simplify the system of equations in term s of the ansatz functions. These solutions describe a generic anholonom ic (anisotropic) dynam ics com ing from the o {diagonal metrics. They also generalize the class of exact 4D solutions with linear extensions to the bulk 5D gravity given in ref. [7].

We emphasize that the constructed solutions do not violate the conditions of the Israel and Carter theorems [17] on spherical symmetry of black hole solutions in asymptotically at spacetimes which were formulated and proved for 4D spacetimes.

Salam, Strathee and Peracci [18] explored the association between gauge elds and the coe cients of o {diagonalm etrics in extra dimensional gravity. In the present paper we have used anholonom ic frames with associated nonlinear connections of 5D and 4D (pseudo) R iem annian spaces [9,11,10], to nd anisotropic solutions with running constants. These solutions may point to Lorentz violations elects in Yang{M ills and electrodynam ic theories induced from 5D vacuum gravity. (Refs. [19] gives a general analysis of the problem for P lanck (scale physics and string theory). In addition the conditions of fram e anholonom y can be associated with a speci c noncommutative relation. This indicates that these solutions with generic anisotropy may mim ic violations of Lorentz symmetry sim ilar to that found in noncommutative eld theories [20].

O ur results should be com pared with the recent work of ref. [8] where the possibility of obtaining localized black hole solutions in brane worlds was investigated. In ref. [8] this was accomplished by introducing a dependence of the 4D line element on extra dimension. It was concluded that for either an empty bulk or a bulk containing scalar or gauge elds that no conventional type of matter could support such a dependence. For a particular diagonal ansatz for the 5D line (element it was found that an exotic, shell{ like, distribution of matter was required. The o {diagonal metrics and anholonom ic fram es considered in the present work are more general and get around the restrictions in [8]. We nd that it is possible to generate warped factors and/or anisotropies in 5D vacuum gravity by taking o {diagonal metrics and using the anholonom ic fram es method. It is not necessary to generate these e ects by som e brane con gurations with speci c energy {momentum tensors.

As a concluding remark, we note that the black hole solutions of the type considered in this work suggest that the localizations to 4D in extra dimension gravity depends strongly not only on the nature of the bulk matter distribution, but also on the type of 5D metrics used: for diagonal metrics one needs exotic bulk matter distributions in order to localize black hole solutions; for o {diagonal metrics with associated anholonom ic frames, one can construct localized black hole solutions with various e ect (renorm alization of constants,

deform ed horizons, solitonically propagating black hole con gurations) by considering an anholonom ic 5D vacuum gravitational dynam ics. Matter distribution, and gravitational and matter eld interactions on an elective 4D spacetime can be modeled as induced by o {diagonalmetrics and anholonom ic frame dynam ics in a vacuum extra dimension gravity.
