$A_2^{(2)}$ Paraferm ions: A New ConformalField Theory

A bstract

A new paraferm ionic algebra associated with the hom ogeneous space $A_2^{(2)}$ =U (1) and its corresponding Z-algebra have been recently proposed. In this paper, we give a free boson representation of the $A_2^{(2)}$ paraferm ion algebra in terms of seven free elds. Free eld realizations of the paraferm ionic energy-momentum tensor and screening currents are also obtained. A new algebraic structure is discovered, which contains a W-algebra type primary eld with spin two.

1 Introduction

The notion of paraferm ions [1] was introduced in the context of statistical models and conform all eld theory [2]. Paraferm ions generalize the M a jorana ferm ions and have found important applications in many areas of physics. From statistical mechanics point of view, paraferm ions are related to the exclusion statistics introduced by Haldane [3]. In particular, the Z_k paraferm ion models of er various extensions of the Ising model which corresponds to the k=2 case [4, 5, 6, 7, 8, 9, 10].

The category for paraferm ions (nonlocal operators) is the generalized vertex operator algebra [11, 12]. The Z_k paraferm ion algebra was referred to as Z-algebra in [11, 12], and it was proved that the Z-algebra is identical with the $A_1^{(1)}$ paraferm ions.

The Z_k paraferm ions proposed in [1] are basically related to the simplest $A_1^{(1)}$ algebra. Various extensions have been considered by many researchers. Gepner proposed a paraferm ion algebra associated with any given untwisted a ne Lie algebra $G^{(1)}$ [13, 14], which has been subsequently used in the study of D-branes. The operator product expansions (OPEs) and the corresponding Z-algebra of the untwisted paraferm ions were studied in [15], and a W 3-algebra was constructed from the SU (3)_k paraferm ions. In [16] a W 5-algebra was constructed by using the SU (2)_k paraferm ions.

M ore recently, C am ino et al extended the Z_k paraferm ion algebra and investigated graded paraferm ions associated with the $osp(1/2)^{(1)}$ Lie superalgebra [17]. The central charge of the graded paraferm ions algebra is $c = \frac{3}{2k+3}$, which implies that for k a positive integer, c is always negative. Thus the graded paraferm ion theory is not unitary.

In [20], we found a new type of nonlocal currents (quasi-particles), which were referred to as twisted paraferm ions. The nonlocal currents take values in the hom ogeneous space $A_2^{(2)}$ =U (1). To distinguish our theory from the twisted versions of [1, 11, 12], in this paper we refer our nonlocal currents to as $A_2^{(2)}$ paraferm ions.

The $A_2^{(2)}$ paraferm ion system contains a boson-like spin-1 eld and six nonlocal elds with fractional spins $1-\frac{1}{4k}$ and $1-\frac{1}{k}$, and leads to a new conform all eld theory which is different from the known ones. Let us remark that, while elds with conformal dimensions of $1-\frac{1}{4k}$ and $1-\frac{1}{k}$ also appeared in the graded paraferm ion algebra [17], our $A_2^{(2)}$ paraferm ion theory is quite different. In particular, our theory is unitary and has a different central charge.

In this paper, we investigate the theory further. We give a free eld representation of the $A_2^{(2)}$ paraferm ion theory in terms of seven free bosons. We also obtain the free eld realization of the highest weight state and screening currents. We discover a new algebraic structure which contains a spin-2 primary eld. This is similar to a W-algebra structure but now the spin is two.

The layout of the paper is as follows. In section 2, we brie y review the $A_2^{(2)}$ paraferm ion algebra obtained in [20], which will be extensively used in this paper. In section 3, we give some results concerning the $A_2^{(2)}$ paraferm ion Hilbert space. In section 4, we give a free eld representation of the $A_2^{(2)}$ paraferm ion currents, highest weight state and screening currents. We present a new W-algebra structure in section 5.

2 Twisted paraferm ions: a brief review

The paraferm ion current algebra proposed in [20] is related to the twisted a ne Lie algebra $A_2^{(2)}$ =U (1). This $A_2^{(2)}$ paraferm ion theory is not an extension of the usual Z_k paraferm ions, but a twisted version of the G epner construction [13]. To begin with, let g be a simple nite-dimensional Lie algebra and be an automorphism of g satisfying $^r = 1$ for a positive integer r, then g can be decomposed into the form [21]:

where g_j is the eigenspace of with eigenvalue e^{2j} i=r, and $[g_i; g_j]$ $g_{(i+j) \mod r}$, then r is called the order of the automorphism. For $A_2^{(2)}$ algebra, we have $g = A_2$ so that

where g_0 is the xed point subalgebra of A_2 under the automorphism and g_1 is the vedimensional representation of g_0 . g_0 and g_1 satisfy $[g_i;g_j] = g_{(i+j) \mod 2}$. We associate a

generating paraferm ion to a vector in the root lattice M m od kM $_{\rm L}$, where M $_{\rm L}$ is the long root lattice and k is a constant identi ed with the level of the corresponding twisted a ne algebra. Generating paraferm ions are defined by projecting out the anne currents corresponding to the Cartan subalgebra [13]. Denote by $_{\rm a}$ the A $_{\rm 2}^{(2)}$ generating paraferm ions with a = 0; ; ~; ~2 and ~2 = + ~, where $0^2 = 0$ =0 ~ =0 $_{\rm C} = 0$ and $_{\rm C} = 0$ = 0 ~ =0 $_{\rm C} = 0$ and $_{\rm C} = 0$ = 0 ...; ~; are currents in g_0 and g_0 ; ~; ~; are currents in g_1 . Note that 0 is a "null" root vector in the sense that both its length and its dot product with all other root vectors are zero. So paraferm ion currents associated with A $_{\rm C}^{(2)}$ live in either Ram ond sector (i.e. the currents in g_0) or Neveu-Schwarz sector (i.e. the currents in g_0).

Due to the mutually sem ilocal property between two paraferm ions, the radial ordering products are multivalued functions. So we de ne the radial ordering product of (generating) $A_2^{(2)}$ paraferm ions (TPFs) as

where T is the energy-m om entum tensor of the theory, and $_{a}=1$ $\frac{a^{2}}{4k}$ is the conformal dimension of current $_{a}$. It follows that the conformal dimensions of the A $_{2}^{(2)}$ paraferm ion currents are 1 (a = 0); 1 $\frac{1}{4k}$ (a = $_{1}$; ~) and 1 $\frac{1}{k}$ (a = $_{2}$), for a given level k. The values of the dimensions determine the leading singularity in the OPE of the currents. In fact, we have

From the dimensional analysis, the conformal dimension of $I_0(z)$ on the rhs. of the 2nd equation of (2.6) is zero. It follows that $I_0(z)$ is a constant, which will be set to 1 in the sequel.

We have seen that $_0$ is a spin-1 current in g_1 that corresponds to the \null" root vector 0. Keeping in mind the fact that $2 g_0$ and $_{\sim} 2 g_1$, we have

We see that $_0$ (z) is a spin-1 primary eld which transforms the elds in the Ram ond sector to those in the Neveu-Schwarz sector or vice versa. This is easy to understand from the theory of the A_2 current algebra [22].

Let A_a and B_b be two arbitrary functions of the $A_2^{(2)}$ paraferm ions with charges a and b, respectively. We write their OPEs as

Now the structure constants of the currents can be derived from the (2.15). 3 $A_2^{(2)}$ paraferm ion H ilbert space

we now analyze the structure of the Hilbert representation H space of the paraferm ion theory. For every eld in the paraferm ion theory there are a pair of charges (;), which take values in the weight lattice. We denote such a eld by ; (z;z) [1,13,15]. Let H; be the subspace of H with the indicated charges. Then H is the direct sum of the form:

In the usual Z_k paraferm ion theory, highest weight state $\frac{1}{1}$ exists only if the condition 1 k is satisfied. This is also the unitarity condition of the representation. To obtain the unitarity condition for our theory, we de ne the herm iticity condition:

This requires a 2km for the norm to be positive. Considering that the m in imal value m can take is m = 1=2 in the Neveu-Schwarz sector and m = 1 in the Ram ond sector, we must have a k for the representation to be unitary.

In general, the Verm a module with highest weight and level k contains in nite many singular vectors [18, 19], and thus the representations obtained above are not irreducible. To determ ine irreducible modules, an BRST analysis [18] in the Hilbert space is necessary, which we will not discuss here. Nevertheless, we will in the next section give a free eld realization of screen currents of the paraferm ion theory, which is important ingredient in the BRST method.

4 Free eld representation of the twisted paraferm ions

It was shown in [20] that the twisted a necurrent algebra $A_2^{(2)}$ allows the following representation in terms of the twisted paraferm ionic currents:

On the other hand, we know that the twisted a necument algebra $A_2^{(2)}$ allows a free eld representation in terms of three (;) pairs and one 2-component scalar eld [22]. So to get a free eld representation of the twisted paraferm ionic currents, one need to projecting out a U (1) current, as is seen from (4.1), and regarding the paraferm ion currents as operators in the space $A_2^{(2)}$ =U (1). This implies that seven independent scalar elds are needed to realize the $A_2^{(2)}$ paraferm ion algebra. So, we introduce seven scalar elds, (z) and $_j(z)$, $_j(z)$ (j=0; 1; 2), which satisfy the following relations:

5 Spin-2 Primary eld and novel algebraic structure

In conformal eld theory, primary elds are fundamental objects. The descendant elds can be obtained from primary elds.

It is well know that, the energy-momentum stress is not primary eld (unless the central charge is zero). The lowest spin of the primary eld obtained by the Ham iltonian reduction approach is three [23, 24]. This agrees with the other methods, such as high order Casimir, coset model [25], free eld realization [26], or the paraferm ion construction [15]. For more references about W-algebras see the reviews [24, 27], and their applications in string and gravity theory see [28, 29]. In the following, we use the $A_2^{(2)}$ paraferm ionic currents to construct a primary eld of spin two. Dene the spin-2 currents:

It should be be understood that $\tilde{\mathbb{B}} = \mathbb{b}$ in the rst line of (5.2). This OPE xes the normalization of $w_2(z)$. (5.2) suggests that $w_2(z)$ behaves similar to a energy-momentum tensor except that it transforms b into b and b have the same conformal dimensions. The OPEs of $w_2(z)$ with itself and the stress tensor are

From (5.3), we see that the eld w_2 introduced above is a primary eld with conformal spin two. The modes expansion of w_2 (z) is

So like the spin-1 primary eld $_0$ (z), w_2 (z) lives in the Neveu-Schwarz sector, and it transforms elds in the Ram ond sector into those in the Neveu-Schwarz sector or vice versa. If we regard the spin-2 currents as a neconnections, then the energy-momentum tensor is a project connection that transforms elds in one sector, while eld w_2 (z) is a project connection which transforms a eld in one sector into a eld in a dierent sector. The mode expansions of $_0$ (z) and $_2$ (z) are

From the above, we see that $w_2(z)$, T(z) do not close to an algebra. It can be checked that the eld U(z) with itself also cannot form a closed algebra. But if we decompose the eld U(z) as above, then the algebra generated by $w_2(z)$, T(z), $u_2(z)$, $u_3(z)$ is closed, as can be seen from the following additional OPEs,

The situation here is similar to that in W-algebra, where for instance W₃(z), T(z) are not closed since a spin-4 eld will appear in the OPE of W 3 (z) with itself. The spin-4 eld is also decomposed into two elds which together with T (z) and W $_3$ (z) do close to the so-called W $_3$ algebra [23].

Som e rem arks are in order. To our know ledge, the algebraic structure we found is new . It is similar to a W-algebra structure, but now all the elds have conformal dimension 2. The primary eld $w_2(z)$ is a \spin-2 analog" of W -currents, and it transforms between elds a (elds in Ram ond sector) and a (elds in Neveu-Schwaz sector). In a sense, the primary eld $w_2(z)$, together with the other two spin-2 elds $_1(z)$ and $_2(z)$, \nonabelianizes" the Virasoro algebra generated by T (z). Possible applications of this new algebraic structure are under investigation.

In [30], A.B. Zam olodchikov considered an algebra having N + 1 spin-2 primary elds with OPEs given by

where $T^0 = T$ is the usual energy-momentum tensor. In this algebra there is only one central charge, and T^{i} , i = 0; 1; ; N, are decoupled so that the algebra is reduced to N + 1 copies of the Virasoro algebra. Our algebra is dierent. Firstly, in our theory, there are four (independent) di erent central charges. So our theory is a conform al eld theory with multi-centers. Secondly, the four generators in our algebra are coupled to each other and can not be reduced to copies of the Virasoro algebra.
