Long-distance asymptotics of spin-spin correlation functions for the X X Z spin chain

A bstract

We study asymptotic expansions of spin-spin correlation functions for the XXZ Heisenberg chain in the critical regime. We use the fact that the long-distance elects can be described by the Gaussian conformal eld theory. Comparing exact results for form factors in the XYZ and sine-Gordon models, we determ inecorrelation amplitudes for the leading and main sub-leading terms in the asymptotic expansions of spin-spin correlation functions. We also study the isotropic (XXX) limit of these expansions.

1 Introduction

In the dom ain of two-dim ensional integrable models, it is, in general, still a challenging problem to compute correlation functions in the form of compact and manageable expressions. For lattice systems, a few methods of computation have been developed [1{4}: in particular, it is possible in some cases to obtain exact integral representations of correlation functions. However it is still quite dicult to analyse those expressions, and especially to extract their long-distance asymptotic behavior.

On the other hand, at the critical point, when the gap in the spectrum of the lattice H am iltonian H $_{\rm latt}$ vanishes, the correlation length becomes in nite in units of the lattice spacing. As a result, the leading long-distance e ects can be described by C onform al Field Theory (CFT) with the H am iltonian H $_{\rm CFT}$ [5]. In general, it is expected that the critical lattice H am iltonian adm its an asymptotic power series expansion involving an in nite set of local scaling elds (see e.g. [6,7]):

Here d_k denotes the scaling dimension of the eld O $_k$, and the explicit dependence on the lattice spacing " is used to show the relative smallness of various terms. All elds occurring in (1.1) are irrelevant and the corresponding exponents of " are positive. Such an expansion also involves a set of non-universal coupling constants $_k$ depending on the microscopic properties of the model, and whose values rely on the chosen normalization for O $_k$.

The asymptotic expansion (1.1) is a powerful tool to study the low energy spectrum of lattice theories. At the same time, in order to analyse lattice correlation functions, one should also know how local lattice operators 0_{latt} are represented in terms of scaling elds. Just as the Hamiltonian density, they can be expressed as formal series in powers of the lattice spacing ",

where again the non-universal constants $C_{\,m}$ depend on the normalization of the scaling elds.

The know ledge of the explicit form of (1.1) and (1.2) enables one to obtain the long-distance asymptotic expansion of lattice correlation functions in powers of lattice distances. For example, in the case of a vacuum correlator, the leading term is given by the CFT correlation function of the operator occurring in (1.2) at the lowest order in ", whereas subleading asymptotics come from both higher order terms in (1.2) and from the perturbative corrections to the CFT vacuum toward the lattice ground state. In this expansion, the exact values of the exponents follow from the scaling dimensions of the CFT elds, while the corresponding amplitudes come from the values of the constants appearing in (1.1) and (1.2). Thus, to investigate quantitatively the long-distance behavior of lattice correlation functions, one needs to determ ine (for a xed suitable normalization of the scaling elds) exact analytical expressions for the non-universal constants $_k$ and C_m .

The aim of this article is to study expansions of the type (1.2) in the case of the XXZ spin 1/2 Heisenberg chain. In particular, we calculate the rst constants C_m occurring in the expansion (1.2) of local spin operators.

The article is organized as follows.

In Section 2, we recall the de nition of the XXZ spin chain (see e.g. [8] for details), and discuss its continuous limit, the Gaussian CFT [9{11]. We review in particular how, from the analysis of the global symmetries of the model, one can derive selection rules for the expansions (1.2) of the lattice operators in terms of the scaling elds of the Gaussian model. This enables one to predict the structure of the long-distance asymptotic expansions of the spin-spin correlation functions.

The problem of computing the constants occurring in the expansions (12) of spin operators is the subject of Section 3. There we explain how, moving slightly away from criticality, and comparing exact results obtained for the XYZ and sine-Gordon models, one can quantitatively connect lattice spin operators to scaling elds. This gives us access to the correlation amplitudes of the spin-spin correlation functions. Our predictions are gathered in Section 4, where they are compared to existing numerical data.

In Section 5, we study these spin-spin correlation functions in the isotropic $(X \times X)$ lim it by means of the exact Renormalization Group (RG) approach. This section contains an erratum of Section 5 of [12].

Finally, we conclude this article with several remarks.

2 XXZ spin chain in the continuous lim it

2.1 Prelim inaries [8,11]

To illustrate the problem of the determination of correlation amplitudes, we consider an example, the XXZ H eisenberg chain of spins 1/2. It is dened by the H am iltonian

where the spin operators $^{a}_{1}$ (a = x;y;z) denote the conventional Pauli m atrices associated with the l-th site of the in nite lattice, and is an anisotropy parameter. A s H $_{XXZ}$ (J;) can be obtained from H $_{XXZ}$ (J;) by a unitary transform ation, we choose in the following the coupling constant J to be positive.

The nature of the spectrum of the in nite chain depends on the value of the anisotropy parameter . The study we present here concerns the critical regime of the chain, which corresponds to the domain 1.6 < 1.8 We shall use the parameterizations

To describe leading long-distance (low-energy) e ects, it is useful to consider a continuous lim it of the lattice model. This lim it can be obtained from the representation of (2.1) in terms of lattice fermions,

where the ferm ionic operators are related to the spin operators through the Jordan-Wigner transform ation,

The ground state of the chain has all levels led with kj < =2. Linearizing the dispersion relation in the vicinity of the Ferm i points $k_F = =2$, one can take the continuous lim it of the model in which the lattice operators $_1$ are replaced by two elds, $_R$ (x) and $_L$ (x), varying slow ly on the lattice scale:

A precise relation between the anisotropy parameter—and the four-ferm ion coupling constant g depends on the choice of the regularization procedure for the continuous H am iltonian (2.8) and is not essential for our purposes. W hat is important is that the quantum—eld theory model (2.8) (which is known as the Thirring model [15,16]) is conformally invariant and equivalent to the Gaussian CFT (see the preprint collection [17] for a historical review of bosonization).

2.2 Exponential elds in the Gaussian model

The G aussian model is dened in terms of one scalar eld', which satis es the D'A lem bert equation 1

As is usual in CFT [18], it is convenient to set a class of conform alprim ary elds among all scaling elds. In the case of the Gaussian model, these conform alprim aries include right and left currents,

The regularization parameter , which has the dimension [length] 1 , is introduced in the de nition (2.14) in order to provide a multiplicative renormalization of the elds. Notice that $0_{\rm sin}$ obey the simple Hermiticity relation

To completely de ne these exponential elds, we should also specify some condition which xes their multiplicative normalization. By a proper choice of in (2.14), one can impose the following form of the causal G reen's functions in the Euclidean domain $x^2 + \hat{t} > 0$:

2.3 G lobal sym m etries

To draw a precise link between the Gaussian CFT and the XXZ spin chain, it is important to exam ine and identify their global symmetries.

Let us rst consider the G aussian m odel. The H am iltonian (2.11) is manifestly invariant under the U (1) rotations,

Note that the rejection C can be naturally considered as a charge conjugation in the theory. As usual, C and P are intrinsic automorphisms of the operator algebra, contrary to the anti-unitary transformation T which acts on c-numbers as follows,

Let us now identify the above transform ations with the global sym metries of the spin chain. First of all, it is natural to do not not action of the U (1) rotation on the lattice as follows,

Such an identication has an important consequence. Indeed, as the two rotations of angle 2 and 2 are indistinguishable trivial transformations in the lattice theory, we should set

A coording to (2.24), the sign factor = +1 in Eq. (2.25) occurs for states with an integer eigenvalue of the operator S_z . The corresponding linear subspace of the whole H ilbert space can be constructed from the thermodynamic limit of nite chains with an even number of sites, and will therefore be referred to as the \even sector". Similarly, the condition = 1 de nes another linear subspace which will be called the \odd sector".

The actions of charge conjugation and time reversal can be naturally identied, in the lattice theory, with the following transformations,

Let us recall here that the time reversal is an anti-unitary transform ation, so that C and T correspond to dierent symmetries of the XXZ chain, even thought they act identically on the spin operators.

As for the parity transform ation, its action in the lattice model depends on the choice of the sector speci ed by the sign factor in (2.25). Indeed, = +1 implies that the considered in nite chain is defined as the thermodynamic limit of nite lattices with an even number of sites. Such nite lattices clearly do not possess any invariant site with respect to the parity transform ation. Therefore,

2.4 Selection rules

The global sym m etries and the know ledge of their action on lattice and continuous operators provide selection rules for the set of scaling elds which can occur in expansions (1.1) and (1.2). Here we exam ine what are these selection rules for the conform alprim ary elds in the expansions of the spin operators.

First, since the whole operator content of the Gaussian model is given by the primary elds described above and by their conformal descendants, it is easy to see that 0 $_{1,0}$ are the local elds with the lowest scaling dimension which may occur in the expansions of $_{0}$:

Furtherm ore, assuming that the conjugation in the lattice theory is dened in such a way that a_1 (a = x;y;z) are Herm itian operators, we conclude from (2.16) that the constant C $_0$ in (2.30) is real.

Let us now consider the expansion of the lattice operator $_0^z$. Due to the U (1) invariance, it can contain only the primary elds ($_{\rm x}$ $_{\rm c}$)' and O $_{\rm 0m}$, n 2 Z, along with their conform all descendants. Using de nition (2.14), it is easy to show that the elds O $_{\rm 0m}$ with odd n are not mutually local with respect to O $_{\rm 1;0}$. As the latter are the leading terms in the expansions (2.30) of $_{\rm 0}$, it would contradict the mutual locality of the lattice operators $_{\rm j}$ and $_{\rm 1}^z$ if there were any O $_{\rm 0;2m+1}$, m 2 Z, in the series for $_{\rm 0}^z$. From the C; T invariances and the Herm iticity of $_{\rm 0}^z$, one can moreover predict that the primary elds are allowed to appear only as linear combinations of $_{\rm 0t}$ ' and i (O $_{\rm 0;2m}$ O $_{\rm 0;2m}$) with real coe cients. Finally, let us consider the parity transform ation. A coording to equations (2.20) and (2.25),

Notice that, in the process of bosonization, the ferm ionic elds $_{\rm R}$ and $_{\rm L}$ (2.7) are identified with the exponential elds O $_{\rm 1;\;1}$ and O $_{\rm 1;1}$ respectively. Hence equation (2.38) is indeed consistent with (2.7).

It is not di cult to extend our symmetry analysis to derive the selection rules for expansion (12) of any local lattice operator. This procedure can, in particular, be applied to the case of the Hamiltonian density. As a result, the following form of the low energy elective Hamiltonian for the XXZ spin chain is suggested:

As was mentioned in Introduction, it is necessary to choose the normalization of the scaling elds to give a precise meaning to the couplings in (2.39) as well as to the real

constants C_m ; C_m^z in expansions (2.35) and (2.36). In this paper we adapt the CFT norm alization (2.17). With this normalization condition, the rst coupling constant $_1$ in (2.39) has been obtained in [12], together with the leading contributions of descendant elds (see also Ref. [19] for a qualitative analysis of the descendent eld contributions):

2.5 Vacuum spin-spin correlation functions

At this stage, without the knowledge of the constants occurring in expansions (2.35) and (2.36), it is already possible to predict³ the exact values of the exponents for the vacuum spin-spin correlation functions. They follow immediately from the scaling dimensions of the elds occurring in (2.35), (2.36) and (2.40).

It may be worth recalling at this point, that the vacuum sector of the in nite X X Z chain is in nitely degenerate. In general, the boundary conditions in posed on the nite critical chain do not preserve all the global sym metries discussed above, and they may be spontaneously broken at the therm odynamic limit. Here we consider only translational invariant vacuum swith unbroken parity:

To full these requirements, we shall treat the in nite XXZ chain as the thermodynamic limit of nite chains subject to periodic boundary conditions. Then, dierent vacuum states can be distinguished by means of the operator S_z (2.24):

In the continuous lim it, the vacuum js i ows toward the conformal primary state with right and left conformal dimensions equal to $d_{s;0}=2$, where $d_{s;n}$ is given by (2.15) [20{22]. This

From our previous analysis, one can now predict the following asymptotic expansions for the time-ordered correlation functions:

The coe cients in the asymptotic expansions (2.47) and (2.48) do not really depend on the choice of the vacuum state jsi, thus any nite s 2 Z=2 can be chosen for the averaging h:::i $\frac{hsj:::jsi}{hsisi}$.

In Eqs. (2.47), (2.48), the correlation amplitudes A, A and A_z are simply related to the rst constants occurring in the expansions (2.35) and (2.36):

They will be computed in the next section. At the same time, the constants B; B; Bz and Bz appearing in (2.47) and (2.48) can be determined by methods of conformal perturbation theory [23] based on the elective Hamiltonian (2.40). In particular, the constant B was obtained in Ref. [12] from second order perturbative calculations,

3 Calculation of correlation amplitudes

The purpose of this section is to explain how the local operators $_1$ and $_1^z$ can be quantitatively related to the scaling elds (2.13) and (2.14), that is, how one can compute explicit analytic expressions for the constants C_m and C_m^z occurring in (2.35) and (2.36) for the xed CFT normalization (2.17). We concentrate here on the rst terms of the expansions (2.35), (2.36), which provide the main asymptotic behavior of the spin-spin correlation functions (2.47) and (2.48):

For our purposes, we merely need the explicit form of Vacuum Expectation Values (VEV) and of two-particle form factors. These operators can also be expressed in a form similar to (2.14), in which 'denotes the sine-G ordon eld instead of the G aussian eld obeying the simple D'A lembert equation (2.9) (see e.g. Ref. [31] for details). They moreover coincide with the G aussian elds (2.14) in the conformal limit ! 0. Hence, with some abuse of notation, we will denote such soliton-creating operators in the sine-G ordon model by the same symbol 0 $_{\rm sn}$ 6.

To proceed further, one needs to draw a link between local lattice operators in the XYZ chain and local elds in the sine-G ordon model. Let us note at this point that local expansions of the type (1.2) are based on dimensional analysis and do not necessarily imply the criticality of the original lattice system. Similar expansions are expected to be applicable to describe the near-critical behavior of lattice systems. U sually, the term with the smallest scaling dimension in (1.2) governs the universal scaling behavior of lattice correlators, whereas the next terms produce non-universal corrections. In particular, relations (3.1), (3.2) obtained for the XXZ spin chain can be used to study the leading scaling behavior and rest non-universal corrections of the XYZ correlation functions and form factors. In the XYZ case, the continuous elds which appear in (3.1), (3.2) should be understood as operators in the sine-G ordon model rather than their conformal limits. The numerical constants C_0 , C_1 and C_1^z remain, of course, the same as for the critical XXZ chain.

Let us now discuss the relation between the H ilbert spaces of the XYZ and sine-G ordon m odels. In general, the theory (3.19) adm its a discrete sym m etry '!' + 2 j = 0 (j 2 Z), which is generated by the operator U de ned similarly to (2.19). The sine-G ordon model which governs the scaling behavior of the even sector of the XYZ chain is subject to the additional constraint $U^2=1$. 4 Correlation amplitudes. Comparison with numerical results

The correlation amplitude A was already obtained in [33]. Our computations also con m the conjecture from [34] concerning the amplitude A $_{\rm z}$.




Figure 1: The correlation amplitudes A and A_z as functions of the anisotropy parameter . The points with the error bars represent the numerical data obtained in [35] (see Table 1), and the continuous line follows from Eqs. (4.2) and (4.3).

In [35], numerical values of the spin-spin equal-time correlation functions have been obtained for an open chain of 200 sites by the density-matrix renormalization-group technique [36]. In Table 1, we compare, for dierent values of the anisotropy parameter, the numerical values that follow from (42), (4.3) with those estimated in [35] from the tring of the numerical data. The corresponding plots are represented in Figure 1.

5 Spin-spin correlation functions in the isotropic lim it

5.1 Marginal perturbations of the Wess-Zumino-Witten model

As long as the parameter—is not too close to unity, the—rst terms of the asymptotic expansions (2.47), (2.48) provide a good approximation to the spin-spin correlation functions even form oderate space separations 1. The suitable way to explore the ! 1 lim it is based on the low-energy elective theory defined as a perturbation of the Gaussian model with = 1. As is well known (see e.g. [17]), the Gaussian model coincides in this case with the SU (2) level one Wess-Zum ino-Witten (W ZW) theory. It should be noted that the even coe cients c_0 , c_2 ; ::: in (5.12) are essentially am biguous and can be chosen as one wants. A variation of these coe cients corresponds to a smooth rede nition of the coupling constants which does not a ect the —function. On the contrary, the odd constants c_{2k+1} are unambiguous and precisely specified, once the form of the RG equations is xed. It is possible to show [30,38] that the odd constants vanish in Zam olod-chikov's scheme: $c_{2k+1} = 0$ (k = 0;1:::): Therefore, once the coe cients c_{2k} in (5.12) are chosen, the renormalization scheme is completely specified.

As already mentioned, the perturbation by the marginal operators produces logarithm ic corrections to the scale-invariant correlation functions. We collect in Appendix D the RG improved expansions of the dierent-time two-point correlation functions (5.17) and (5.24).

5.2 Equal-time correlation functions for the X X X spin chain. Comparison with numerical results

U sing expansions (D 1), (D 2), it is easy to perform the isotropic limit. Setting = 0 and $g_2 = g_k = g$, one obtains the following large 1 expansion for the equal-time spin-spin correlation functions⁸:

Let us stress that, if the perturbation series in (5.25) can be sum med, then the correlation function should not depend on the auxiliary parameter c (5.12), (5.21). This, however, is not true if we truncate the perturbative series at some nite order. Thus, when thing the numerical data with (5.25), we may treat c as an optimization parameter, allowing us to minimize the remainder of the series, or at least to develop some feeling concerning the elects of this remainder.




Figure 2: The correlation function W (1) = $\frac{1}{4}$ h $_{1+j}^{x}$ $_{j}^{x}$ i of the XXX spin chain according to the distance 1. The dots represent the num erical data obtained in [43], and the continuous line connects odd and even terms obtained from Eq. (5.25) with c = 1.

The correlation function (5.25) has been computed numerically in [43] for 1.6 1.6 30. The authors used the density-matrix algorithm [36] to study the large-distance decay of the correlation function for XXX spin chains with 14 N 70 sites. To extract the values of the correlation function in the in nite chain case, they adopted the phenomenological scaling relation of Kaplan et al. [41] (see also [42]). The relative error of the interpolation procedure was estimated to be of order 1% for the largest 1 values. In Table 2, we compare those numerical data to the results obtained from (5.25) in the cases c = 1 and c = 2. The corresponding plots (numerical data against RG result for c = 1) are given in Figure 2. It appears that the numerical data are consistent with our prediction within the given errors.

5.3 Erratum of [12]

The spin-spin correlation function in the limit! 0 was previously studied in Section 5 of Ref. [12]. The analysis performed in that paper, along with the numerical results obtained in [43] (see Fig. 2 of [12]), strongly suggested the existence of an additional staggered term of the form

in the large distance asymptotic expansion of the correlation function h_{l+j}^{x} , h_{j}^{x} i. It was argued in [12] that such a term occurs because of the presence of a correction of the type (h_{j}^{1}) h_{j}^{2} 0 in expansions (3.1). However, the RG computation from [12] appears to be erroneous. Indeed, Eqs. (5.6) and (5.7) from [12] have to be replaced respectively by our equations (0.1) and (5.25). Therefore, contrary to what was claimed in [12], the numerical data are consistent (within the numerical errors) with (3.1).

6 Conclusion and further remarks

The purpose of this article is the quantitative study of the long-distance behavior of spin-spin correlation functions for the XXZ Heisenberg chain in the critical regime. Our main result here is the determ ination of analytical expressions for the correlation amplitudes involved in the corresponding asymptotic expansions. To obtain these values, we considered quantumely theory which describes the scaling limit of the lattice model, and compared, in this

lim it, the respective normalizations of the lattice operators and of the corresponding local elds. This comparison was achieved by considering known exact matrix elements (form factors).

We would like to conclude the article with the following remarks.

The m ethod used in this work can be applied to higher order term s in expansion (2.35) or (2.36). For example, we were able to compute (up to sign factors) all constants C_m from (2.36) for odd integers m = 2p + 1:

Eventually, one can wonder if it is possible to con m our predictions from existing integral representations of lattice correlators. Up to now, although explicit expressions for the equal-time spin-spin correlation functions at nite lattice distances are known [4,44], their long-distance behavior was studied only for the so-called \free ferm ion point", = 0. In this case the X X Z spin chain can be mapped onto two non-interacting critical Ising models and the long-distance asymptotics are readily derived from results of works [45{47}].

The approach of this work is actually quite general for lattice solvable models at criticality: from a knowledge of particular form factors of a lattice theory and of its quantum eld theory counterpart at the scaling limit, it is possible to predict the amplitudes which govern the large distance behavior of lattice correlation functions. It would indeed be interesting to obtain elective results for other critical exactly solvable lattice models.
