Integrable aspects of the scaling q-state Potts models I: bound states and bootstrap closure

Abstract

We discuss the q-state Potts models for q 4, in the scaling regimes close to their critical or tricritical points. Starting from the kink S-matrix elements proposed by Chim and Zam olodchikov, the bootstrap is closed for the scaling regions of all critical points, and for the tricritical points when 4 > q 2. We also note a curious appearance of the extended last line of Freudenthal's magic square in connection with the Potts models.

1 Introduction

The q-state Potts models directly generalise the most well-known of all two-dimensional integrable models, the Ising model. They have been much studied, both in their own right as interesting statistical-mechanical systems, and because of their relations with other models { the limit q ! 1, for example, describes bond percolation. How ever, they are by no means completely understood.

In this paper and its sequel we shall discuss the treatm ent of these models in the fram ework of continuum eld theory. Such techniques are expected to be applicable in scaling regimes near to critical points, though for the g-state Potts models some elem ents of the treatm ent will be rather form al, re ecting the nonlocalm anner in which the models are initially de ned on the lattice. In this paper we focus on the description of the models in terms of the on-shell data provided by an exact S-matrix. A number of years ago, Chim and Zam olodchikov proposed a set of am plitudes for the scattering of elementary kink-like excitations in the low-temperature phase of the model [1]. (A di erent treatm ent had previously been suggested by Sm imov [2], based on quantum group reductions of the Izergin-Korepin S-matrix. In this article we shall work from the Chim -Zam olodchikov form ulation, as it more closely releases the continuous nature of the Fortuin-Kasteleyn $[\beta]$ de nition of the theory on a lattice, but we note that the relationship between the two approaches has recently been claried, in [4].) The fundam ental S-m atrix elements form only part of the on-shell description of the m odel, and in order to complete the picture it is necessary to nd out if any further asymptotic states are present. In the exact S-m atrix fram ework this is commonly achieved by an analysis of the pole structure of all S-m atrix elements, a process which is known as closure of the bootstrap. The case of the q-state Potts models turns out to involve a num ber of subtleties, which we attem pt to highlight and resolve in this paper. Since we have not been entirely successful in this enterprise, we also include some details of the problem s that we encountered. They only arose when continuing the S-m atrices far into the regim e of tricritical models, but they may nonetheless be important signals of new behaviour in the bootstrap program me.

In x2, we review Chim and Zam olodchikov's proposal and its background, stressing some of the non-standard features that the models exhibit. Then in x3 we close the bootstrap for the scaling regions of all critical models, nding that we need to invoke the Colem an-Thun mechanism in a novel way in order to explain the fullpole structure of all S-matrix elements. A continuation of Chim and Zam olodchikov's S-matrix is expected to describe the scaling regions of the tricritical models, and this is discussed in x4. Finally, x5 contains our conclusions and some more detailed tables are collected in four appendices.

In a companion paper [5], these models will be discussed from a complementary point of view, using nite-size e ects.

2 Review

2.1 The models on the lattice and their continuum limits

The standard de nition of the lattice q-state Potts model is through the Ham iltonian

where J is a coupling strength and the spin (x) associated with the lattice site x m ay take any of q distinct values. The sum m ation is over all nearest-neighbour pairs of sites hx; yi. In term s of H, the partition function at tem perature T is given by

Notice that H $\,$ is invariant under the group S_q of permutations of the q possible values of $\,$.

This de nition only applies for integer values of q, but a reform ulation due to Fortuin and K asteleyn $[\beta]$ allows the constraint to be lifted. Expanding (2.2) as

they observed that it could be written in the form

where $K = e^{\frac{d}{kT}}$ 1, and the sum is over all graphs G on the lattice, with the number of bonds in G and C the number of connected components (sets of sites joined by bonds). When the model is dened in this way, q is no longer restricted to integer values, and can be taken as a continuous parameter. However, at general values of q, Z cannot be written in terms of a local H am iltonian, and the precise meaning of its S_q' symmetry is not clear. Nevertheless, the partition function is certainly well-dened, and we shall see later that many other features which might be thought special to locally-dened theories also make sense.

The model undergoes a phase transition at $K = K_c = {}^p \overline{q}$, which is second-order for q 4. At these values of q a continuum limit can be taken, and if the limit is taken exactly at the critical point, the resulting eld theory is conformal. Param etrising q as

A generalisation of the basic Potts m odel allows for the existence of vacancies [7]. In addition to the critical points just discussed, these m odels have tricritical points, with the critical and tricritical points coinciding at q = 4. The exponents for the tricritical points can be obtained from those of the critical points by continuing into the range =2 [7] (see also [8,9]). This shifts into the range 1 < 3.

If is rational, the value of c(q) coincides with the central charge c = 1 $6(p^0 p)^2 = pp^0$ of a minimalm odel M_{pp⁰}, $p^0 > p$. More precisely, the relationship is

on the critical branch, and

on the tricritical branch. This coincidence does not mean that the conformal eld theories of the Potts models at rational are minimal models { in particular, the relevant partition functions only agree when q is an integer [10] { but it does mean that connections with minimal models are to be expected at these points.

O ther aspects of the critical and tricritical m odels, and of their relationships with conform all eld theories, are reviewed in [5]. However in this paper we are more concerned with the massive eld theories which arise if a continuum limit is taken with the temperature (and any other parameters) tending to a critical value with the correlation length held nite in physical units. In many interesting cases (including the ones currently under discussion [2,1]) these eld theories turn out to be integrable [11], allowing them to be understood in considerable detail. In turn, this allows the scaling regions of the original lattice m odels near to their second-order transitions to be explored; it is also relevant to the computation of certain universal characteristics of the transitions them selves [12].

In practice, the eld theories are usually found directly in the continuum, either by a consideration of the symmetries that they should inherit from the lattice, or by starting from the continuum conformal eld theories, and then adding to their actions suitable continuum operators to describe the departure from criticality { the basic idea of perturbed conformal eld theory, as put forward by Zam olodchikov [11]. For shifts in temperature, the operator to add is the local energy density, which corresponds to $_{21}$ for the critical Potts models [6], and $_{12}$ for the tricritical models [13]. We shall refer to the massive theories as the scaling Potts models. Strictly speaking, they are not perturbations of minimal conformal eld theories, except at integer values of q. However, in situations where the in nite-volum e ground states of the q-state Potts and minimal models coincide, we expect the two to agree on issues such as mass spectrum and (diagonal) S-matrix elements. We shall say a little more about this issue in later sections and in [5], but since it is not directly relevant to our current discussion of the Potts S-matrices, we leave it to one side for now.

 $\label{eq:linear} Irrespective of whether the unperturbed c < 1 theories are minimal models, Zamolod-chikov's counting argument [11] shows that generic _{21} or _{12} perturbations preserve$

conserved charges with spins s = 1; 5; 7 and 11. By an argument due to Parke [14], the existence of these charges is enough to ensure that, as quantum eld theories de ned in M inkow ski space, the m odels must have factorisable S-m atrices, allowing the full multi-particle S-m atrix to be given in terms of the set of two-particle scattering am plitudes. The main result of Chim and Zam olodchikov [1] was a conjecture for these am plitudes for certain fundamental, kink-like excitations. To nish the story, am plitudes for the scattering of all possible bound states of these kinks must be found, and this is the main goal of the present paper. In the remainder of this section, we shall review the assumptions that went into Chim and Zam olodchikov's initial proposal.

2.2 The fundam ental S-m atrix elem ents

To begin, we discuss the scaling regions of the critical models. The scattering theory is most easily treated by working in the low-tem perature, ordered phase, in which one would expect to nd q degenerate vacua. It is then natural to postulate the existence of a set of particles, or kinks, K_{ab}() (a; b = 1:::q; a f b), dom ain walls which interpolate between di erent vacua. The fact that q is not necessarily an integer m ay appear worrysom e, but follow ing [1] we can decide to treat q form ally, motivated at least in part by the fact that this can be given a precise sense on the lattice through the Fortuin-K asteleyn trick reviewed above. The energy-m om entum of K_{ab}() is param eterized by the rapidity , p = (m cosh ; m sinh), and asymptotic n-particle states interpolating between vacua a₀ and a_n correspond to the products

Scattering of these kinks is completely described by the two-particle amplitudes S_{ac}^{bd} ():

D ue to the S_q symmetry of the model, there are only four independent two-particle amplitudes S^n () (n = 0:::3). These are represented in gure 1.

The S-m atrix must be unitary, crossing symmetric, and satisfy the Yang-Baxter equations. Chim and Zam olodchikov found that the latter implies

In all probability the models actually have conserved charges at all integer spins not multiples of 2 or 3, but just two with spins > 1 are enough for Parke's argument to go through.




Figure 1: The four independent two-particle am plitudes

Together with crossing, this xes the S-matrix as a function of and up to a socalled CDD factor, a 2 i-periodic function f satisfying f()f() = 1, f(i) = f(). To resolve the remaining ambiguities, some further physical input is required, and this comes from an initial consideration of the pole structure.

In general, it should be possible to explain all S-m atrix poles in the physical strip

in terms of the bound-state structure of the model (though, as we shall see, the mechanism can in some cases be quite involved). Conversely, the fundamental S-matrix elements should certainly exhibit poles rejecting the possibility to form an elementary kink as a bound state of two other such kinks. Taking energy-momentum conservation and vacuum structure into account, direct-channel poles should appear in S⁰() and S¹() at $=\frac{2}{3}$, and cross-channel poles in S⁰() and S²() at $=\frac{1}{3}$. These are illustrated in gures 2 and 3.




Figure 2: D irect channel K K ! K bound states in S^0 and S^1

A comparison with (2.11) { (2.13) shows that the common factor R () must therefore have poles at $\frac{i}{3}$ and $\frac{2i}{3}$. On the other hand, the pole at $\frac{2i}{3}$ should be absent from S² and S³, and the pole at $\frac{i}{3}$ absent from S¹ and S³. This can only be achieved by cancellations against zeroes from the sine prefactors in (2.12) { (2.14), which strengthens the previous condition on to = 3 mod 3.




Figure 4: KK ! K bootstrap

The three-kink coupling leads to a set of bootstrap equations, depicted in gure 4. In contrast to the Yang-Baxter equations, these constraints are felt by the CDD factor. C on bining these conditions with a prior know ledge of the solutions for q = 2 and 3 led C him and Zam olodchikov to the sim plest choice = 3, and a minimal solution for the S-m atrix elements which, for the discussions to come, it will be most convenient to rewrite in the following form:

The poles and zeroes of these two functions which can appear in the physical strip for 0 < < 3 are sum marised in tables 1 and 2. Note that $e^{A(\cdot)}$ has no physical strip poles at all for 1.

3 Completing the bootstrap for 0 3=2

W e now return to the discussion of the pole structures of the S-m atrix elements, in order to see if there is any need to introduce further one-particle asymptotic states into the m odel, beyond the elementary kinks. It is convenient to phrase the discussion in terms of the variable

reserved for trather than t. The poles at t = 2=3 in S⁰ and S¹, and at t = 1=3 in S⁰ and S², have already been treated, and are due to the fundam ental kink itself. In [1], Chim and Zam olddhikov noted that extra poles enter the physical strip once passes 1. These they assigned to a new particle B, a breather-like excitation over a single vacuum, appearing as a bound state in the scattering of two kinks. The associated S-m atrix elem ents S_{BK} and S_{BB} also contain physical strip poles. Some of these correspond to the kink and breather already seen, but others were conjectured in [1] to signal the presence of yet further particles. In this section, we re-exam ine this analysis and nd that these further particles do not in fact appear in the spectrum while the critical m odels are considered. The range 3=2 < 3, corresponding to perturbations of the tricriticalm odels, turns out to be farm ore com plicated and we postpone its discussion until section 4.

3.1 The pole structure of the fundam ental kink am plitudes

Table 3 sum marises the physical strip pole structure of the fundamental amplitudes (2.17)-(2.20), for in the range 0 3. Supposing each pole to correspond to a bound state particle in either the direct or the crossed channel, a consideration of the patterns of vacua shown in gure 1 allows them to be classi ed as follows. All four vacua seen by S⁰ are dierent, so all of its poles must correspond to kink type particles. O ne out of each pair of poles in S⁰ appears in S¹, and the other in S². To be consistent with the vacuum structure, the pole also appearing in S¹ must be direct channel, and that also in S² cross channel. Similarly, all poles in S³ must correspond to excitations over a single vacuum (breathers). All poles which also appear in S² must be direct channel. The resulting particle spectrum is summarised in table 4, and the corresponding fusing vertices are




Figure 5: K $_1$ K $_1$ fusing vertices

Restricting to the range 0 3=2, the only bound states signalled in $K_1 K_1$ scattering are the fundamental kink K_1 itself, and, for 1 < 3=2, the breather B_1 .

For 1, the bootstrap closes on the fundam ental kink alone and there is no more to be done, but once increases beyond 1 the breather B_1 appears. This extra particle brings with it two new scattering amplitudes, $S_{B_1K_1}$ and $S_{B_1B_1}$:

The pole structures of these new S-m atrix elements must be examined to see if there are any further bound states. It is at this stage that our analysis diverges from that of [1], since it turns out that variants of the Colem an-Thun mechanism [15] allow some poles to be explained, for certain ranges of , without the need to introduce new particles. We shall treat the two new amplitudes in turn.

3.3 The B_1K_1 scattering am plitude

The relevant S-m atrix element, which is also depicted in appendix D, is

The K₁K₁B₁ vertex allows the poles from the factors $(\frac{1}{2} + \frac{1}{2})$ and $(\frac{1}{2} - \frac{1}{2})$ to be identified with the original kink K₁ appearing as a bound state in the direct and crossed channels respectively. A ssum ing that the poles in $[\frac{1}{6} + \frac{1}{2}]$ also correspond to a bound state, we make an initial hypothesis that the direct channel pole is at $t = \frac{1}{6} + \frac{1}{2}$. The associated particle must be an excited kink of some sort, and calculating its mass we nd

C om paring with the masses listed in table 4, it is natural to identify this with the K $_2$ state already seen in K $_1$ K $_1$ scattering. This implies the existence of a vertex coupling K $_1$, K $_2$ and B $_1$, and the corresponding fusing angles are shown in gure 7.




Figure 7: the K $_1B_1$! K $_2$ vertex

Unlike the K₂ bound state poles in S⁰ and S¹, which only enter the physical strip for $> \frac{3}{2}$, the $(\frac{5}{6} - \frac{1}{2})(\frac{1}{6} + \frac{1}{2})$ poles in S_{B1K1} are already in the physical strip at = 1. This suggests that K₂ should be present in the particle spectrum for all > 1, and indeed this was proposed in [1]. We would like to advocate an alternative scenario, which begins with the observation that, for < 3=2, one would expect the B₁K₁ scattering am plitude to exhibit an anom alous threshold pole exactly at the location of the would-be K₂ bound state pole, since the on-shell diagram shown in gure 8 is geometrically possible.




Figure 8: K₁B₁ scattering: the pole at t = $\frac{1}{6} + \frac{1}{2}$, for $< \frac{3}{2}$




Figure 9: B_1B_1 scattering: the pole at $t = \frac{1}{2} = \frac{1}{3}$, for $< \frac{3}{2}$

The angle between the incoming particles K₁ and B₁ is $t = \frac{1}{6} + \frac{1}{2}$, and the internal scattering angle is $= \frac{1}{2} - \frac{2}{3}$. The diagram closes for $0 < < \frac{1}{3}$, which translates as $1 < < \frac{3}{2}$. However, in two dimensions a diagram of this sort would usually be expected to give rise to a double pole, while S_{B1K1} only has a simple pole at this value of t. The problem is resolved once the contributions of the couplings and S-m atrix elements are taken into account. These are composed of four three-particle couplings multiplying a sum over two-particle amplitudes. This sum, which we shall denote by C, can be computed by considering the possibilities for the internal vacua, and so can take (q 2) values. Once this vacuum has been xed, there are again (q 2) possibilities for the lower vacuum is equal to the upper one (1 possibility), in which case the relevant two-particle amplitude needed to evaluate the diagram is S¹(i). Adding everything up, we have

The vanishing of C reduces the overall singularity associated with the diagram to a simple pole. Thus the pole at $t = \frac{1}{6} + \frac{1}{2}$ in $S_{B_1K_1}$ can be explained without the need to introduce the excited kink K_2 , at least until $= \frac{3}{2}$. Beyond this point, the scattering process shown in gure 8 is no longer geom etrically possible; and at the same time, the presence of K_2 in the spectrum is also signalled by the appearance of its bound state pole in the kink-kink matrix elements S^0 and S^1 .

A very similar phenom enon was observed many years ago by Coleman and Thun in the Sine-Gordon model [15], where the appearance of new breathers is delayed until their poles are seen in the soliton-soliton S-matrix (see section 4 of [16] for a detailed review of this story). It has also played a rôle in the understanding of non self-dual a ne Toda eld theories [17], and crops up in the analysis of boundary scattering [18]. A novel feature here is the form al treatment of the vacua. When working out the com binatorics, q is treated as an integer, and the resulting form ula is then taken to hold for general q. The same spirit guided Chim and Zam olodchikov's original form ulation of the Yang-Baxter equations for the model; it can be interpreted as a way to account for the statistics of the kink states in a way that depends sm oothly on q. In principle it should be possible to phrase the discussion entirely within the more standardly-de ned form ulation of Sm innov [2], but since in this approach the vacuum structure depends in a discontinuous way on q, the arguments are likely to be considerably more involved.

3.4 The B_1B_1 scattering am plitude

To complete the analysis we must consider

The poles from the blocks $\binom{2}{3}$ and $\binom{1}{3}$ can be identified with B₁ bound states in the direct and cross channels respectively. The poles from $\binom{1}{2}$ and $\binom{1}{2}$ m atch direct and cross channel bound states of B₂, while that in $\binom{1}{2}$ $\frac{1}{3}$ is potentially the direct channel pole for a new particle, B₃, with m ass

(This particle was denoted B⁰ in [1].) The poles at $\frac{1}{2}$ and $\frac{1}{3}$ are both located in the physical strip for > 1, when B₁ rst appears.

How ever, the appearance of both B₂ and B₃ can be delayed by invoking the Colem an-Thun mechanism. Most complicated to treat is the would-be B₃ bound state pole. The a-priori third order diagram shown in gure 9 has internal scattering angle = $\frac{1}{2} = \frac{2}{3}$, and thus closes for $<\frac{3}{2}$. Keeping track of all possible combinations we nd that the third-order pole must be multiplied by a factor

We have already seen that S^1 (i) + (q 3) S^0 (i) = 0 for $= \frac{1}{3} \frac{2}{3}$ in the treatment of $S_{B_1K_1}$, and a simple calculation shows that the rest of the function is nite and non-zero at this point. The diagram thus contributes a simple pole, and B_3 need not show up as a bound state until $= \frac{3}{2}$.

Turning to the pole at $t = \frac{1}{2}$, provisionally assigned to B_2 , the relevant diagram is shown in gure 10. The internal scattering angle $= \frac{2}{2}$ 1 is positive (making the diagram geometrically possible) for < 2. Calculating the prefactor C we have

At $= \frac{2}{1}$ 1, the expression in square brackets vanishes and the overall singularity is reduced from a double to a single pole. This means that there is no need to introduce the B₂ breather until passes 2, at which stage it also appears in the K₁K₁ am plitudes S² and S³.




Figure 10: B_1B_1 scattering: $t = \frac{1}{2}$, < 2

3.5 Checks on the spectrum for 0 < 3=2

To sum marise, by invoking the Coleman-Thun mechanism we have seen that the only particles forced to appear for $0 < < \frac{3}{2}$ are the fundamental kink K₁, present for all , and the breather B₁, which appears for > 1. The two bound states K₂ and B₃ proposed by Chim and Zam olodchikov need not appear until $> \frac{3}{2}$. We also saw evidence for a further new particle B₂, but its appearance was postponed until > 2.

W hile we have shown that our proposed spectrum is consistent, strictly speaking the larger spectrum initially suggested by C him and Zam oldchikov has not been completely ruled out { genuine bound state poles could be hiding behind the contributions provided by the C olem an-T hun diagram s. Some reassurance comes from some work by D el no

and C ardy [12]. They calculated a number of universal quantities using the form -factor approach, which is sensitive to the massive particle spectrum. Some of these quantities (for example the central charge) can be compared with known results. While the need to add in the rst breather state at = 1 is clearly signalled, the data up to = 3=2, as illustrated by gure 5 of [12], show s no signs of any further m issing particles.

A nother check com es from the limiting point $=\frac{3}{2}$, q = 4, where the S-m atrix for the minimalD₄ related eld theory discussed in [19] should be reproduced. The spectrum of this model consists of three light particles 1, 1^0 , 1^{00} with the same mass m₁, and one particle h of m ass m_h = $\sqrt[1]{3}m_1$. The m ass ratio m_h : m₁ equals that of m_{B1} : m_{K1}, and h is naturally identied with B1. There are three distinct ways of pairing up the four vacua and each of these may be associated with one of the light particles. This is shown in gure 11, where for example 1 is identied with domain walls 1 \$ 2 and 3 \$ 4 (vacua labeled from 1 to 4). This identication is unique up to permutations of the light particles amongst them selves | also a property of the D₄ S-m atrix. The two-particle amplitudes S_{11} (), $S_{11^{\circ}}$ (), S_{1h} () and S_{hh} () then correspond to S^3 (), S^0 (), $S_{B_1K_1}$ () and $S_{B_1B_1}$ () respectively. Substituting for $\$, a direct comparison can be made with the results of [19]. The S-m atrices m atch, since S¹() and S²() vanish for $=\frac{3}{2}$. Notice that the set of spins of conserved charges for the D₄-related model starts 1, 3, 3, 5::: and is thus larger than the generic $_{21}$ spectrum s = 1; 5; 7; 11::: reported above. Moving from the kink to the particle picture, the 3 property of the S-m atrix is lost, and it is this which allows the enlarged set of conserved charges to be represented locally on the multiparticle states. In the kink basis, the extra charges are also present for = 3=2, but they do not act diagonally.




Figure 11: Dom ain walls particles at q = 4

4 Perturbed tricritical models: 3=2 < < 3

We now move to the region $\frac{3}{2}$ 3, suggested in [1] to describe the scaling tricritical q-state Potts models, and related to 12 perturbations of c < 1 conformal eld theories. The full S-matrix becomes extremely complicated as increases, and we have not completed our analysis for the whole tricritical range of . For this reason we will be a little more sketchy in our descriptions in this section. Some further details are in the appendices, and in [20].

4.1 Four particles: 3=2 < 2

Two new particles, K₂ and B₃, must appear once passes $\frac{3}{2}$. We found that no further particles were needed to explain the pole structure up to = 2. The new S-m atrix elements are as follows:

where t(a) (t) = tan ($\frac{1}{2}$ (t + a)), the blocks [a] were de ned in equation (3.4) above, and S^a are the am plitudes for the scattering of the fundam ental kink K₁. (Note the shift in the argument in the rst formula.) Once again there are four possible am plitudes corresponding to the four di erent vacuum structures for kink-kink scattering. In tables 5 and 6 we sum marise the physical-strip poles of the new kink-kink am plitudes for 3=2 < 3.

The introduction of new particles leads to further bootstrap equations. Here we quickly sketch those for the new kink-kink amplitudes. K₂ appears as a bound state in K₁K₁, K₁B₁, and K₁B₃ scattering. This allows $S_{K_1K_2}^a$ to be obtained via a number of a-priori distinct bootstrap equations. Consider rst the K₁K₁! K₂ fusing. The general kink bootstrap equation illustrated in gure 4 in plies

bootstrap equations for $S^a_{K_1K_1}(+\frac{i}{2})$, leaving it to be checked that the extra factor is equal to $S_{K_1B_1}(-\frac{i}{6})$. The bootstrap equations for $S^a_{K_2K_2}(\cdot)$ can be treated in a sim ilarm anner, and all are found to be satis ed.

W hile we om it the full details here, we have checked that, for 3=2 < < 2, all poles in the S-m atrix elements have a potential eld-theoretical explanation, often via quite elaborate incarnations of the C olem an-T hun mechanism. To give just one example, the triple pole in $S_{B_3B_3}$ at $t = \frac{1}{2}$ can be associated with the diagram shown in gure 12, which closes for $\frac{3}{2} < < \frac{9}{4}$. The fusing angles needed to verify that the diagram does indeed close as claim ed can be found in appendix B.




Figure 12: B_3B_3 scattering: the triple pole at t = $\frac{1}{2}$, for $\frac{3}{2} < < \frac{9}{4}$




Figure 13: $B_5 K_2$ scattering: the double pole at $t = \frac{1}{6}$, for $2 < \frac{9}{4}$

4.2 Six particles: 2 < 9=4

For $2 < < \frac{9}{4}$, the already-advertised B_2 together with a further breather B_5 enter the spectrum. The scattering amplitudes for the new particles become increasingly complicated, and greater reliance must be placed on the Coleman-Thun mechanism to explain the pole structure. The new S-matrix elements in this region are:

The complete mass spectrum is given in appendix A, and the full set of fusings for generic values of q is summarised in appendix B. Appendix D contains a detailed description of the pole structures of all S-matrix amplitudes appearing for $\frac{9}{4}$. C losed scattering diagrams, such as the ones shown earlier, have been constructed for all poles not associated with bound states in this region. In gure 13 we show one particularly-elusive example.

4.3 Problems for > 9=4

For > 9=4, we have not been able to close the bootstrap. The only exception is the point = 5=2, for which q = 1, the kink states decouple, and the breather sector reproduces the m inim al E₈ S-m atrix. A way from this point, our di culties m ay sim ply be due to a failure to spot the necessary C olem an-T hun diagram s; on the other hand, they m ay hint at a genuine breakdown of the bootstrap programme. In the following we shall mention some of the problem s that we encountered, in the hope of contributing to further work on these issues.

M any of the poles in the already-described S-m atrix elements can be explained all the way up to = 3. However, the Coleman-Thun diagrams for some poles do not close for > 9=4, a sign that new particles may need to be introduced. Consider rst the poles in $S_{B_3B_3}$ at $\frac{1}{2}$, in $S_{B_2B_2}$ at $\frac{1}{2}$, and in $S_{B_2B_5}$ at $\frac{1}{3} + \frac{1}{2}$. Once passes 9=4, the residues of these poles do not change sign, and if all are provisionally associated with forward-channel bound states, the m asses of these states as calculated from the form ula

(where u_{ab}^{c} is the fusing angle t at which the pole occurs) all coincide. It is therefore natural to assign these poles to a single new breather state B₆. From (4.9), its mass is $4m \cos(\frac{1}{2} -)\cos(\frac{1}{6} - \frac{1}{2})$. The other fusing angles for this putative particle follow from (4.9) on permuting the labels a, b and c, and all turn out to have simple (constant plus linear) dependencies on $\frac{1}{2}$; they are listed explicitly in appendix C.

A similar story can be told for the poles in $S_{B_1B_5}$ and $S_{B_3B_3}$ at $\frac{2}{2}$, leading us to introduce a further breather B_7 with mass $8m\cos(\frac{2}{2}-2)\cos(\frac{2}{6}-2)\cos(\frac{3}{2}-2)$. However, the (ffh-order) pole in $S_{B_5B_5}$ at $\frac{1}{2}$, which corresponds to B_8 at = 5=2, is more enigmatic. First, we note that it overlaps with an odd-order pole at =12=5, causing its residue to change sign. This might suggest that the identi cation of the direct and cross channel poles should be swapped at this point, though since the pole is of higher order it is not possible to say de nitively that this must happen (cf. the discussions in [21]). As mentioned in appendix D, bound state poles in som e kink scattering am plitudes also have crossovers, but for these the S-m atrix contrives to preserve the signs of the residues. It is also worth noticing that som e of the S-m atrix elements involving B_8 have physical-strip zeroes for < 12=5. There is no a-priori




Figure 14: C losed scattering diagram s without corresponding poles in the S-m atrix

reason why this should not occur, but it breaks the pattern seen for all other S-m atrix elements up to this value of . These two problems together make our identication of the B₈ particle somewhat tentative for 12=5.

The worries about the B₈ particle would probably be resolved if other, m ore serious, di culties could be overcom e. A number of poles remain unexplained for > 9=4 even after the introduction of B_6 , B_7 and B_8 . M any have residues which change sign, suggesting that for at least som e range of they will not correspond to bound states. Of those which don't, the poles at $\frac{2}{3}$ $\frac{3}{2}$ in $S_{K_1K_2}$, $\frac{1}{6}$ in $S_{B_2K_1}$, $\frac{1}{2}$ in $S_{B_3K_1}$, $\frac{1}{6}$ + $\frac{3}{2}$ in $S_{B_5K_1}$, $\frac{1}{6}$ in $S_{B_1K_2}$, and $\frac{1}{3} + \frac{1}{2}$ in $S_{B_3K_2}$ give rise to kinks of the sam em ass. Calling this particle K₄, we could similarly identify another kink K₄⁰ with the poles at $\frac{3}{2}$ in $S_{B_5K_1}$ and in $\frac{3}{2}$ $\frac{1}{3}$ in $S_{B_3K_2}$. However, the introduction of these new particles is problem atic for a number of reasons. Most fundam entally, and in contrast to the situation for B_6 , B_7 and B_8 , some fusing angles involving K_4 and K_4^0 , calculated using (4.9), are not simple functions of $\frac{1}{2}$. As a result, the inclusion of K₄ or K₄⁰ in closed scattering diagram s for already-introduced particles predicts poles which do not appear in their S-m atrix elements. For example, the diagram s shown in gure 14 can be drawn if K_4 is included in the spectrum. In addition, the irrationality of the fusing angles leads to a breakdown of the conserved charge bootstrap, forcing higher-spin charges to be zero. Thism akes it highly unlikely that K $_4$ and K $_4^0$ should be added to the spectrum of the model.

On the other hand, we have not been able to account for the would-be K₄ and K₄⁰ poles in the manner of C olem an and T hun, using the set of particles and fusings that we have already identiced. Take the $\frac{2}{3}$ $\frac{3}{2}$ pole in S_{K1K2} as an example. This pole is simple, so if the C olem an-T hun mechanism is to be invoked, the naive order of poles from the relevant on-shell diagram s must be reduced in some way. One tactic is to search for closed scattering diagram s involving only kinks as internal states, in order to get cancellations in sum s over S-m atrix elements of the sort seen in earlier sections.

Such diagrams must have the form shown in gure 15.




Figure 15: Diculties in nding Coleman-Thun diagrams for S K 1K 2

A quick check of the options for a and b shows that the scattering angle between the outerm ost internal lines $= \frac{4}{3} \frac{3}{2} + a + b$ is always less than zero, and so no closed diagram can be constructed. Sim ilar arguments hold for other poles, in particular those in the $S_{B_{3}K_{1}}$ and $S_{B_{5}K_{1}}$ amplitudes that were mentioned above.

In the absence of a satisfactory explanation for these poles, the closure of the bootstrap is still an open question. There remains one further possibility: new particles m ight enter the spectrum which are not simple bound states of any of the alreadyexisting particles, so that their m asses would not be immediately visible in the existing S-m atrix elements. This would m im ic the situation which would arise in the sine-G ordon m odel if one only knew of the breather particles, and wanted to deduce the presence of the solitons by looking at breather scattering alone. It is very hard to rule this out, but further work will be needed before we can tell whether it o ers a way to escape from the problem s discussed in this section.

4.4 Other work on 12 perturbations

Since our results on $_{12}$ perturbations are incomplete, it is particularly in portant to compare them with other work. We begin by mentioning the points = $2, \frac{9}{4}$ and $\frac{5}{2}$, which correspond to the m inim al $E_6; E_7$ and E_8 S-m atrices. These are rather special, as for these values of , q is an integer. Not only do various poles overlap, but also som e instances of the Colem an-Thun m echanism break down. This is because the total contribution associated with a given on-shell diagram can involve factors of q (integer) (equations (3.7), (3.11) and (3.12) provide som e exam ples of this phenom enon). This m eans that, exceptionally, these poles do not have C olem an-T hun explanations when q hits integer values, and this requires the introduction of exceptional bound states in order to complete the bootstrap at these points. The K $_3$ kink state at the E $_7$ point, and the B_4 breather at the E_8 point, appear to have this evanescent status. In addition, the overlapping of the poles allows a number of extra couplings to appear, and this should be borne in m ind before worrying that the tables of couplings in appendices B and C seems small in comparison with tables for Toda models given in [22]. These subtleties aside, the S-m atrices at the exceptional points are perfectly self-consistent. Their physical-strip pole structures match those of a ne Toda eld theories, and the extensive discussions contained in [22,21] can be borrowed to verify that all higher poles can be described via the Colem an-Thun mechanism.

A way from integer values of q, som e general aspects of the spectrum of $_{12}$ -perturbed m in in alm odels were discussed by Sm imov in [2], while the particular case of M $_{56}$ + $_{12}$ was treated by M artins in [23] and by K oubek in [24]. In none of these papers was a complete analysis of pole structures attempted, but other aspects perm it comparisons to be m ade. In the papers of Sm imov and K oubek, corresponds to -, and !

In [2], Sm innov gave an initial description of the spectrum implied by his S-m atrix, concentrating mainly on points related to perturbations of unitary minimal models. The chief di erence between Sm innov's S-m atrix and that of C him and Zam olodchikov is a matter of kink structure, so one would expect the two to agree on the spectrum of bound states and the diagonal scattering amplitudes. Indeed, while explicit form ulae for the remaining S-m atrix elements were not given in [2], Sm innov comments that the spectrum for $_{12}$ perturbations settles down to four particles for (his) =2. In our notation this is 2, and so this regime of $_{12}$ perturbations corresponds to the range 3=2 < 2 discussed in x4.1, for which we did indeed and four particles. Furtherm ore, the masses are easily checked to agree, and so all is consistent.

Referring to (2.32), the $_{12}$ perturbation of M $_{56}$ discussed in [23] and [24], should correspond to $=\frac{21}{10}$, which lies in the region where we predicted six particles. In [23], M artins m ade a detailed num erical study of the nite-volum e spectrum of M $_{56}$ + $_{12}$ using the truncated conform all space approach. (He also discussed some subtleties relating to the choice of m odular invariant for the unperturbed theory; as mentioned above, we do not expect this to a ect the full spectrum of particle m asses when the theories are considered on the in nite line.) High-m ass states were hard to detect, but he was able to predict the presence of ve particles, which in our notation are K $_1$, B $_1$, K $_2$, B $_2$ and B $_3$, with num erically-obtained values for the m asses which are consistent with predictions from the exact S-m atrix. The remaining particle, B $_5$, has a much higher m ass and so its absence from the num erical data of [23] is no surprise.

This case was further exam ined in [24]. Translating from our notation to that of [24], [a] $(a) = B_2^{(ref. [24])} = B_3^{(us)}$ and $B_4^{(ref. [24])} = B_5^{(us)}$. However, the mass of the breather identied in [24] as $B_3^{(ref. [24])}$ is also equal to that of $B_3^{(us)}$, which is already in the spectrum at < 2. As can be seen from appendix A, the other extra breather to enter the spectrum for > 2, $B_2^{(us)}$, has a mass less than that of $B_3^{(us)}$, which perhaps explains why it was m issed in [24]. As a result of this problem, the spectrum and S-m atrix given in [24] are unfortunately incomplete, but insofar as they go and modulo some further typos, they are otherwise consistent with our results, specialised to $= \frac{21}{10}$.

Finally, we should mention that S-matrices for $_{12}$ perturbations of minimal models M $_{2;2n+1}$ were discussed in [25]. These theories have = 3n in our notation, and hence are a long way from the region $2 [\frac{3}{2};3]$ relevant to tricritical scaling Pottsmodels { in particular, the perturbing operator always has a negative scaling dimension apart from the som ew hat-trivial case of n=1. Perhaps more to the point, they also all correspond form ally to q=0, and the sim plications of the scattering theory at such points [2] make it hard to draw any general lessons. Nevertheless, it is interesting that the bootstrap can be closed at least at som e locations beyond the region that we were able to treat.

5 Conclusions

In this paper we have given what to the best of our know ledge is the rst com plete treatm ent of the pole structure and bootstrap for the critical and tricritical Pottsm odels. For all of the critical m odels, and for the tricritical m odels with 4 > q > 2, we have found a spectrum of particles such that all S-m atrix poles have potential eld-theoretical explanations. This has been achieved by a novel variant of the Colem an-Thun m echanism, taking into account the form all counting of interm ediate vacua at general values of q. The cancellations are at times extrem ely intricate, and we take this success as o ering retrospective justication of our approach, though a rigorous fram ework is still lacking.

O ur calculations have proceeded on a case-by case (or rather, pole-by-pole) basis, which becomes increasingly laborious as the number of particles increases. It is tem pting to suppose that there must be a better way to do all of this, if only the relevant underlying structure could be identified. For the much-simpler examples of the ADE – related diagonal scattering theories, a universal understanding of bootstrap closure has been achieved using a construction of the S-m atrix elements based on the theory of root system s [26,27], and it would be very interesting to have a similar treatment for general q-state Potts models. At present this seem s to be a long way o, though the results of O ota [28], extending the root system s approach to cover the non simply-laced Toda theories, may be a sign that things are not completely hopeless. (Further discussions of the hidden geometry of a ne Toda eld theory can be found in [29,30,16,31].)

The most important outstanding question left by our work concerns the situation for $> \frac{9}{4}$, where we were unable to complete the bootstrap. P roblem s with bootstrap closure have been encountered a couple of times before. In [32], the intricacy of the mass spectrum for general complex $a_2^{(1)}$ Toda theory is discussed. In Sm imov's approach, the Potts S-m atrices are associated with $a_2^{(2)}$; given the relations between $a_2^{(1)}$ and $a_2^{(2)}$ it is reasonable to hope that our results even for $< \frac{9}{4}$ m ay be of some relevance to these issues. However, since the situation for $a_2^{(1)}$ is likely to be at least as complicated as that for $a_2^{(2)}$, this may not be the best place to look for hints as to how to close the bootstrap for $> \frac{9}{4}$. Rather, it seems more promising to investigate further perturbations of m inim alm odels, for which there are at least techniques such as the TCSA to fall back on. In situations where the Potts ground state (generated by the identity operator) and the m in in alm odel ground state (generally generated by som e negative-dim ension operator) become degenerate in in nite volume, we would expect scaling Potts and perturbed m inim alm odel results to be directly related. D i culties with the bootstrap for the models M $_{3;5}$ and M $_{3;7}$ perturbed by $_{12}$ have been remarked by M ussardo and Takacs [33], though as these theories have $=\frac{7}{2}$ and $\frac{11}{2}$, they are not directly relevant to our current concerns. The interval $\frac{9}{4}$ < < 3 corresponds, via (2.32), to $\frac{5}{4} < \frac{p^0}{p} < \frac{3}{2}$, and any information on $_{12}$ perturbations of these m in in alm odels, away from the E₈ point $\frac{p^0}{p} = \frac{4}{3}$, would be extremely interesting, as would any indications of extra pathologies in such cases.

W e end with a curious piece of num erology. Recall that as the param eter runs from

0 to 3, we pass ist through the critical and then the tricritical scaling Potts models. At rational values of , the theories are also associated with $_{21}$ or $_{12}$ perturbations of m inim alm odels. But some points are even more special, in that their m inim alm odels can be realised as diagonal coset conform all eld theories of the form $g^{(1)} = g^{(2)}$, with eld labelled by (1;1;ad) always being the perturbing operator. (See, for example, chapter 18 of [34] and references therein for more on the coset construction.) These points, together with the corresponding values of q and c, are listed in appendix A, and they suggest that the scaling Potts models provide a structure which unit es the following sequence of Lie algebras:

R em arkably, the sam e sequence has appeared in the pure m athem atics literature, in the work of Vogel, D eligne, C ohen and de M an, C vitanovic and others { see [35, 36, 38, 37, 39, 41, 40] for a selection of references. This set of algebras, sometimes referred to as the' exceptional series, is picked out by a number of special properties { for example, the tensor products ad ad decompose in a uniform way (D eligne proposed that this should extend to higher powers ^kad, and conjectured that this could be explained by the existence of som e m ore general class of objects, depending on a parameter t, which specialize to the representations of the m embers of the exceptional series at certain values of t). The algebras also m ake up the extended last line of the Freudenthalm agic square (in this context, it is interesting that an appearance of the m agic square has been noted, on a case-by-case basis, in studies of R – and K – m atrices and the Y ang-B axter equation (see for example [42])). However, the deep sense in which the algebras (5.1) form a fam ily is still ratherm ysterious, and so the fact that they are found in connection with the continuous set of P otts m odels seem s to be quite suggestive. Inspired by this coincidence, we can consider an alternative labelling of the P otts m odels, by setting

This parameter coincides with the dual C oxeter number of the relevant algebra at the special points, where it is also related to the parameter a used in [36,37] by h- = 1=a. Two more interesting properties can now be noted - rst, the hatural' range for , [0;3], is mapped to the range [0;1] for h-. At the Lie algebra related points, h- is in some senses a measure of the complexity of the corresponding scattering theory, so this suggests that = 3 m ay indeed be some sort of natural boundary also from the S-m atrix point of view. Second, there is one more special point for the Potts models, labelled P' in appendix A and corresponding to $= \frac{1}{2}$, which is q = 1 on the critical branch { the percolation point. It is natural to add this point to our list, as it then gives the nice m atch with the exceptional series of Lie algebras, but in [36], D eligne rem arks that it is natural to add the trivial group e to the list (5.1), so long as it is assigned the dual C oxeter number 6=5. This is precisely the value that the Potts models would suggest, if the percolation value $= \frac{1}{2}$ is substituted into (5.2).

In fact, the exceptional series has (at least) one further member: in [38], Deligne and de M an remark that the superalgebra O Sp(1/2), with dual C oxeter number 3=2, can be added between e and A₁. (This to some degree explains the fact, already noted by C ohen and de M an in [37], that for h- = 3=2 various dimension formulae take integer values.) C an we nd a rôle for this superalgebra in the Potts story? The answer turns out to be yes. Inverting (5.2), h- = 3=2 corresponds to = 3=5, q = (5 $\overline{5}$)=2 and c = 8=35. The construction of diagonal coset m odels based on Lie superalgebras seem s to be relatively unexplored territory, but some facts about the relevant a ne superalgebras are known. In particular, the level k O Sp(1/2) central charge is

(see, for example, [43] and references therein). A ssum ing that no subtleties interfere with the usual calculation, we then expect


which is exactly the required value. Note that this is the central charge of a nonunitary minimal model, M $_{7;10}$. This does not contradict its being realised as a coset, since superalgebras are involved. While not all elds of the nonunitary model appear in the corresponding Potts model, the identity and the energy operator are present, and at least in this sense we can claim to have found the superalgebra OSp(1;2) to be embedded into the continuous family of q-state Potts models.

C ohen and deM an [37] found one further point at which integers appear in dimension formulae: translating into our notations it is h = 24, = 12=5. As far as we are aware, no group-theoretical interpretation of this point is known, but from the Potts perspective it should be related to the tricritical model at q = (5 - 5)=2, or the $_{12}$ perturbation of the minimal model M $_{10;13}$ (with central charge 38=65). This is particularly tantalising: lying between the E $_7$ and E $_8$ points, = 12=5 is in the region where we have not been able to close the bootstrap, and any new information might give us the necessary hint to resolve the problem s described in x4.3 above. Furtherm ore, there are independent reasons to think that = 12=5 might be special: as mentioned in x4.3, for > 12=5 the S-matrix elements involving B have no physical-strip zeroes, perhaps signalling that this is the point at which the B particle enters the spectrum.

W hile we do not have any explanation as yet for why the link between the Potts m odels and the exceptional sequence of Lie (super-)algebras should be so neat, we feel that the coincidences are su ciently striking to m erit further investigation. A better understanding m ight shed light both on the structure of the Potts m odel S-m atrices, and on the deeperm eaning of the exceptional series and the D eligne conjecture.

The breather states are labelled so as to be mass-ordered at the E_8 point $=\frac{5}{2}$; note also that the states K_3 and B_4 are only present in the model for $=\frac{9}{4}$ and

 $\frac{5}{2}$ respectively, for reasons that were explained in x4.4. The solid dots indicate the mass spectra of the diagonal scattering theories which occur at integer values of q. For $> \frac{9}{4}$, the mass spectrum is almost certainly incomplete, save for the E₈ point $= \frac{5}{2}$; in addition, as discussed in x4.3, it is possible that the appearance of the B₈ particle should be postponed to $> \frac{12}{5}$. In the list of model identications, P' indicates that the theory at $= \frac{1}{2}$ is related to the percolation problem. The remaining entries are Lie algebras g, and signal that the corresponding model is related to a perturbation of the g⁽¹⁾ $= g^{(2)}$ coset conform all eld theory by its (1;1;adj) operator.

B Fusings and fusing angles for < 9=4

This table sum marises the fusings and fusing angles between particles in the region where we have been able to close the bootstrap. Each entry shows the particles which can be found as bound states of the particles listed along the top and left of the table, together with the angle t at which each fusing occurs. D epending on the value of , some of the bound states m ay be absent from the spectrum. In such cases, the corresponding pole is either o the physical strip, or else has a C olem an-T hun explanation.

As mentioned in x4.4, exceptional couplings appear at the points $= 2;\frac{9}{4};\frac{5}{2}$. Rather than tabulate them here, we refer the reader to [22] for complete listings.

C Extra fusings and fusing angles for > 9=4

O ur results are incomplete for > 9=4, and we cannot be sure that the bootstrap closes at all. However, there is good evidence for the existence of at least three further particles, namely B₆, B₇ and B₈. The rst two we expect to be present for all > 9=4, while B₈ m ay only enter the spectrum for > 12=5. The following table sum marises the additional fusings and fusing angles involving these new particles. Further particles cannot be ruled out (indeed, they are most probably required if the bootstrap is to close) and so we do not claim that this list is exhaustive.


In this appendix we sum marise the bound states of the scattering am plitudes which appear for $\frac{9}{4}$. For the kink-kink am plitudes, the physical strip pole contents of each separate am plitude are given in tables 3, 5 and 6 of the main text; here we show their locations (though not their orders) with a symbol bxc, indicating that the combined set of am plitudes has poles at t = x and at t = 1 x. The poles of the other S-m atrix elements can be read o quite easily from their explicit form ulae { in the following, we add a subscript a to a block [x] to signify that a appears as forward-channel bound state of that scattering process, at = i x. A question mark indicates that, at least for some range of $2 (\frac{9}{4};3]$, the corresponding pole is currently unexplained. In spite of the problem s in completing the bootstrap in the interval $\frac{9}{4} < \frac{5}{2}$, at $= \frac{5}{2}$ (ie.

q = 1) the S-m atrix is well behaved and reduces to that of the E₈ related m odel.


In the plots, $t = \frac{1}{1}$ as in the main text, and l = 0. Double lines denote poles of even order. G rey shading denotes presence of a higher order scattering process for that pole. In general, direct channel poles have solid lines and cross channel poles have dashed lines – for poles with no associated bound states the choice is arbitrary. Forward-channel bound state poles are identified on the graphs by the relevant particle, while dotted grey shading indicates poles for which we have yet to ind a satisfactory explanation. The crossings-over of poles in the K₁K₁ and K₁K₂ scattering am plitudes cause no problem s for the assignment of forward and crossed channels, as the am plitudes a ected { S₁ and S₂ at $= \frac{3}{2}$, and S₃ at = 2 { vanish at these points. This extra zero in the non-scalar factors changes the analytic continuation, preserving the signs of the residues.

In each graph, the value $=\frac{9}{4}$ is indicated by a vertical line. Beyond this point the problem sm entioned in x4.3 set in, and our resultsm ust be considered to be incomplete.




