W e introduce a method to obtain deform ed defects starting from a given scalar eld theory which possesses defect solutions. The procedure allows the construction of in nitely many new theories that support defect solutions, analytically expressed in terms of the defects of the original theory. The method is general, valid for both topological and non-topological defects, and we show how it extends to quantum mechanics, and how it works when the scalar eld couples to fermions. W e illustrate the general procedure with several examples, which support kink-like or lum p-like defects.

D effects play in portant role in m odern developments of several branches of physics. They may have topological or non-topological prole, and in Field Theory the topological defects usually appear in m odels that support spontaneous symmetry breaking, with the best known examples being kinks and domain walls, vortices and strings, and m onopoles [1]. D om ain walls, for example, are used to describe phenomena having rather distinct energy scales, as in high energy physics [1, 2] and in condensed matter [3].

The defects that we investigate in this letter are topological or kink-like defects, and nontopological or lum plike defects. They appear in models involving a single real scalar eld, and are characterized by their am plitude and width, the width being related to the region in space where the defect solution appreciably deviates from vacuum states of the system. Interesting models that support kink-like defects involve polynom ial potentials like the ⁴ model, periodic potentials like the sine-G ordon model, and even the vacuum less potential recently considered in [4, 5]. We shall investigate defects by examining their solutions and the corresponding energy densities, to provide quantitative pro le for both topological and nontopological defects.

W e introduce a general procedure to create deform ed defects, starting from a known solvable model in one spatial dimension. We start with topological defects, and we show below that the proposed scheme generates, for each given model having topological solutions, in nitely many new solvable models possessing deform ed topological defects. We exam ine stability of kink-like defects, to extend the procedure to quantum mechanics. We also investigate lump-like defects, to generalize the procedure to both topological and non-topological defects. Finally, we couple the scalar eld to ferm ions, to show how the procedure works for the Yukawa coupling.

The interest in kink-like defects is directly related to the role of sym m etry restoration in cosm ology [1, 2] and in condensed m atter [3]. A lso, they are particularly in – portant in other scenarios, where they may induce interesting e ects. A signi cant example concerns the be-

havior of ferm ions in the background of kink-like structures [6]. The main point here is that symmetry breaking induces an elective mass term for ferm ions. In the background of the kink-like structure the ferm ionic mass varies from negative to positive values, and this fractionalizes the ferm ion number [6]. The topological behavior of the kink-like defect is central to ferm ion number fractionalization [6, 7]. In the language of condensed m atter, spontaneous symmetry breaking may be interpreted as the opening of a gap, and may be of good use in several situations { see for instance [8, 9, 10] and references therein for applications. A nother possibility concerns the role of kink-like defects as seeds for the form ation of nontopological structures [11, 12]. This line of investigation has been in plem ented in the case the discrete sym m etry is changed to an approxim ate sym m etry [13, 14], and also when the sym m etry is biased to m ake dom ains of distinct but degenerate vacua spring unequally [15].

In ourprocedure to create deform ed defects, we deform the system in a way such that one increases or decreases the am plitude and width of the defect, without changing the corresponding topological behavior. Within the condensed matter context, one provides a way to increase or decrease the mass gap for fermions, introducing an im portant mechanism to tune the gap for practical purpose.

The interest in lum p-like defects renews with the expressive number of recent investigations on issues related to tachyons in String Theory, since there are scenarios where branes may be seen as lum p-like defects which engender tachyonic excitations [16, 17, 18, 19, 20, 21, 22, 23, 24, 25].

We consider a single real scalar eld. The equation of motion for static solutions = (x) is given by

Here V = V () is the potential, and the prime stands for derivative with respect to the argument. We search for eld con gurations which \start" in a given minimum of V (), with zero \velocity", that is, which obey the boundary conditions: $\lim_{x \ge 1} |x||$ and $\lim_{x\,!}\ _1\ d\ =\!\!dx\,!$ 0. Thus, we use the equation of motion to get

$$\frac{d}{dx} = \frac{p}{2V(x)}$$

The energy associated with these solutions are equally shared between gradient and potential portions

W e now deal with topological or kink-like defects. In this case we consider

$$V = \frac{1}{2} \left[W^{0}() \right]^{2}$$
 (5)

where W () is a smooth function of the eld . We assume that there exist v_i ; i = 1; ...; n such that W $^0(v_i) = 0$. These singular points of W () are absolute m inim a of the potential. In such a large class of m odels the equation of m otion becomes $d^2 = dx^2 = W ^0$ () W 00 (). The energy associated to (x) can be m inim ized to

$$E_{BPS} = \int_{1}^{2} dx W^{0}(x) \frac{d}{dx}$$

if the eld con guration obeys

$$\frac{\mathrm{d}}{\mathrm{d}x} = \mathrm{W}^{0}(\mathrm{)} \tag{7}$$

Their solutions are named BPS states [26, 27]. As we know, for kink-like defects the equation of motion exactly factorizes [28] into the two rst-order equations (7). Thus, we can introduce the topological current

$$J = 0 W ()$$
 (8)

which makes the topological charge equal to the energy of the topological solution.

Let us now consider a well-de ned bijective function f = f() with non-vanishing derivative. This function allows introducing a new theory, de ned by the f-deform ed potential

$$\boldsymbol{\mathcal{P}}\left(\boldsymbol{\boldsymbol{\mathcal{P}}}\right) = \frac{\boldsymbol{\boldsymbol{\mathcal{V}}}\left[\boldsymbol{\boldsymbol{\mathcal{F}}}\left(\boldsymbol{\boldsymbol{\mathcal{P}}}\right)\right]}{\left[\boldsymbol{\boldsymbol{\mathcal{F}}}^{0}\left(\boldsymbol{\boldsymbol{\mathcal{P}}}\right)\right]^{2}} = \frac{1}{2} - \frac{\boldsymbol{\boldsymbol{\mathcal{W}}}^{0}\left[\boldsymbol{\boldsymbol{\mathcal{F}}}\left(\boldsymbol{\boldsymbol{\mathcal{P}}}\right)\right]}{\boldsymbol{\boldsymbol{\mathcal{F}}}^{0}\left(\boldsymbol{\boldsymbol{\mathcal{P}}}\right)} \overset{2}{=} (9)$$

In this case $\mathbf{e}_i = f^{-1}(v_i)$; i = 1;2; :::;n are minima, and the new theory possesses topological defects which are obtained from the solutions (x) of the previous theory through the relation

$$e(x) = f^{1}[(x)]$$

To prove this statement we notice that the rst-order equations of the new theory are

$$\frac{d}{dx} = \bar{W}^{0}() = \frac{W^{0}(f())}{f^{0}()}$$

Thus, the solutions satisfy f[e(x)] = (x), or better $e(x) = f^{-1}[(x)]$, as written in Eq. (10).

We notice that the deform ed defects $e^{(x)}$ connect m inim a corresponding to those interpolated by the solutions (x) of the original potential. The energy of the deform ed defects depends on the deform ation one introduces. It can be written as

$$= \begin{bmatrix} Z_{1} & & \frac{df^{2}}{dx} \end{bmatrix}^{2} \frac{d}{dx} \begin{bmatrix} 1 & 2 & \frac{d}{dx} \end{bmatrix}^{2}$$

We see that for the class of deforming functions f() satisfying $jf^{0}()j = 1$ (1), the energy is decreased (increased) relative to the undeformed defect. In particular, the deformation f() = r leads to trivial modi cations of parameters of the potential, decreasing (jrj > 1) or increasing (jrj < 1) the energy of the defect.

At this point, two important remarks are in order: rstly, by taking f⁻¹ instead of f one de nest the inverse deform ation, that is the f⁻¹-deform ation of \P () recovers the potential V (). Secondly, the f- (or the f⁻¹-) deform ation can be applied repeatedly leading to an innitely countable number of solvable problems for each known potential bearing topological solutions. In fact, each pair (V;f) de nes a class of solvable problems related to each other through repeated applications of the f- (or f⁻¹-) deform ation prescription.

We concentrate on investigating stability of defects. This leads us to quantum mechanics, where the Schrodinger-like Ham iltonian has the form

Here the quantum mechanical potential U (x) is given by

$$U(x) = \frac{d^2 V(x)}{d^2} = 0$$

where (x) is the defect solution under investigation. In the case of kink-like defects the potential is written as V () = (1=2) $\mathbb{N}^{0}()^{2}$, and the H am iltonian can be factorized [29, 30] as H = S^YS, where the rst-order operator S has the form

and $u(x) = d^2 W = d^2$, to be calculated at the kink-like solution = (x). We use this to obtain the (bosonic)

zeromode in the form

We now use f() to deform the model. The modied H am iltonian can be written as $\mathbf{P} = \mathbf{S}^{\mathbf{y}}\mathbf{S}$, where \mathbf{S} is now given by $\mathbf{S} = d=d\mathbf{x} + \mathbf{e}(\mathbf{x})$, with

$$\mathbf{e}(\mathbf{x}) = \mathbf{W}^{(0)}(\mathbf{f}(\cdot)) - \frac{\mathbf{W}^{(0)}(\mathbf{f}(\cdot))}{\mathbf{f}^{(0)}(\cdot)} \frac{\mathbf{f}^{(0)}(\cdot)}{\mathbf{f}^{(0)}(\cdot)}$$
(17)

to be calculated at the kink-like solution (x). Thus, the deform ed bosonic zero m ode is given by

$$e_{0}(\mathbf{x}) e^{\mathbf{R}_{x}} e^{(\mathbf{y})}$$
(18)

Let us now consider som e examples. Firstly, we consider $f() = \sinh$, in which case the f-deformation is referred to as the sinh deform ation. For this choice, equations (9), (10) and (12) are easily rewritten and one sees that the Bogom ol'nyi bound is low ered by the deform ation. On the other hand, if one considers the inverse deform ation, taking $f() = \operatorname{arcsinh}$, the energy of the deform ed defects is greater than that of the original potential. Speci cally, let us discuss the ⁴ theory, for which the potential is given by V () = (1=2)(1²)² (we take the rescaled theory with dimensionless eld and coordinates). The kink-like topological defects for this model are well-known: (0) (x) = tanh x (using the translation invariance, we $x x_0 = 0$). They have energy $E_{B}^{(0)} = 4=3$, distributed around the origin with density $"_0(x) = \operatorname{sech}^4(x)$. In quantum m echanics, the related problem is described by the modi ed Posch-TellerpotentialU (x) = 4 $6 \operatorname{sech}^2(x)$, which supports the norm alized zero-mode $_0(\mathbf{x}) = \frac{1}{3-4} \operatorname{sech}^2(\mathbf{x})$ (at zero energy) and another bound state, with higher energy.

The sinh-deform ed ⁴ m odel has potential given by

$$\mathfrak{F}() = \frac{1}{2} \operatorname{sech}^2 (1 \sinh^2)^2$$
(19)

for which the deform ed defects connecting the m inim a at arcsinh (1) are

$$e^{(1)}(\mathbf{x}) = \operatorname{arcsinh}[\operatorname{tanh}(\mathbf{x})]$$
 (20)

See Fig. [1] for a plot of the topological defects.

The $\overline{\mathbb{M}}$ -function for this example is given by

$$\overline{\Phi}$$
 () = 4 arctan (e) sinh (21)

The deformed defects (20) have energy $E_B = (2)$, which is slightly smaller than the energy of the defects of the 4 potential. The energy density of the deformed defects is given by

$$\mathbf{\mathfrak{E}}_{1}(\mathbf{x}) = \frac{\operatorname{\mathfrak{sech}}^{4}(\mathbf{x})}{1 + \operatorname{tanh}^{2}(\mathbf{x})}$$
(22)

which is more concentrated around the origin than the related quantity, in the 4 case, as expected. See Fig. [2] for a plot of the energy density of the topological defects.

Consider now the $\ ^4$ potential deformed with f () = arcsinh , that is, take the potential

$$\mathfrak{F}() = \frac{1}{2}(1+2) 1 \operatorname{arcsinh}^{2} : (23)$$

This is the potential which, by performing the deformation with sinh as discussed above, leads to the undeformed 4 model. The BPS solutions, in this case connecting minima at sinh(1), are given by

$$e^{(1)}(x) = \sinh[\tanh(x)]$$
 (24)

These are deform ed defects; see Fig. [1].

The corresponding W -function is given by

$$\vec{\Psi}^{(1)} = \frac{1}{6} \operatorname{arcsinh}^{3} + \frac{3}{4} + \frac{1}{2}^{2} \operatorname{arcsinh} + \frac{1}{4}^{p} \frac{p}{1+2} + \frac{1}{2}^{2} \operatorname{arcsinh}^{2}$$
(25)

The energy of the deformed defects in Eq. (24) is $\mathbf{E}_{B} = 1.641$, which is greater than that for the 4 m odel and has a broader distribution

$$\mathfrak{E}_{1}(\mathbf{x}) = \cosh^{2}(\tanh \mathbf{x}) \operatorname{sech}^{4}(\mathbf{x})$$
 (26)

which is depicted in Fig. [2].




FIG.1: Plot of the deform ed defects. The thick line shows the kink of the the 4 model. The other lines show deform ed kinks, the dashed-dotted line representing the sinh-deform ation, and the dotted line the arcsinh-deform ation.

We see that the sinh-deform ation dim inishes the energy of the BPS solutions narrowing its distribution, and the arcsinh-deform ation operates in opposite direction, increasing the energy and spreading its distribution. These deform ations are smooth deform ations, which lead to potentials similar to the original potential. They map the interval (1;1) into itself, and their derivatives




FIG. 2: P lot of the energy density of the deform ed defects. The thick line refers to the 4 m odel. The other lines refer to the other cases, as explained in the previous gure.

 $f^0(\)$ have no divergence at any nite . They teach us how to deform a given defect, changing its parameters in the two possible directions, decreasing or increasing the amplitude and width of the original defect. Since the amplitude and width of the defect are important to characterize the defect, the proposed deform ations are of direct interest to applications involving kinks and walls in high energy physics and in condensed matter.

The recent interest on tachyons [18, 19, 20, 21, 22, 23, 24, 25] has inspired us to extend the above procedure to nontopological or lum p-like defects. We see that if (x) solves the equation of motion (1), then $e(x) = f^{-1}()$ solves the equation of motion for the deform ed model with potential $P() = V[f()]=[f^0()]^2$. This is always true, for solutions that obey the rst-order Eqs. (2), with energy density equally shared between gradient and potential portions.

A model which supports nontopological or lum p-like solutions is

$$V_1() = \frac{1}{2} {}^2 (1 {}^2)$$
 (27)

It has the solutions

$$^{1}(x) = sech(x)$$
 (28)

In quantum mechanics, the related problem has potential U (x) = 1 $6 \operatorname{sech}^2(x)$. This potential has the same form of the the modi ed Posch-Teller potential [see the comments just above Eq. (19)]. However, it plots differently, shifting the values of U (x) in a way such that the zero-mode is now identi ed with the upper bound state, making the lower bound state negative, signalling for tachyonic excitation.

We now consider deforming the lump-like solutions with sinh .We get

$$\mathfrak{P}_{1}() = \frac{1}{2} \tanh^{2} (1 \sinh^{2})$$
 (29)

The equation of m otion for = (x) is

$$\frac{d^2}{dx^2} = \tanh (1 \sinh^2 2 \tanh^2)$$
(30)

It supports the deform ed lum p solutions

$$e^{\perp} = \operatorname{arcsinh}[\operatorname{sech}(\mathbf{x})]$$
 (31)

as we can verify straightforw andly. The deform ation process m ay continue, and m ay also be done in the reverse direction, using arcsinh $\,$.

Sim ilar investigations apply to other potentials. For instance, V () = 2²(1) supports the lum p-like solution ¹(x) = sech²(x) { see Ref. [17] for further details on the ³ m odel. We deform the lum p-like solution with arcsinh . We get

$$\mathfrak{F}_{1}() = 2(1 + {}^{2}) \operatorname{arcsinh}^{2}(1 \operatorname{arcsinh})$$
 (32)

The deform ed lum p-like defect is

$$e_{1}(x) = \sinh[\operatorname{sech}^{2}(x)]$$
(33)

We can make the model supersymmetric introducing appropriate M a prana spinors. In this case, in general the Yukawa coupling is controlled by Y (), which has the form

$$Y() = \frac{d}{d} \frac{p}{2V()}$$
 (34)

This leads to the usual coupling Y () = W $^{(0)}$ () when the potential is given by V () = (1=2) [W $^{(0)}$ ()]², which is the form one uses to investigate kink-like structures. If one uses f () to change the model from V () = (1=2) [W $^{(0)}$ ()]² to $\ensuremath{\mathfrak{C}}$ () = (1=2) [W $^{(0)}$ (f ())=f $^{(0)}$ ()]², the Yukawa coupling should also change from Y () = W $^{(0)}$ () to

$$\hat{\Upsilon}() = \mathbb{W}^{0}(f()) - \frac{\mathbb{W}^{0}(f())}{f^{0}()} \frac{f^{0}()}{f^{0}()}$$
(35)

The importance of the deform ation procedure that we have introduced enlarges if one recognizes that it admits deform ations which lead to very dimensions that potentials, bearing no similarity to the original potential. Such deform ations are dimension, and may lead to further interesting situations. For instance, we consider the function $f() = \tanh$. It maps the interval (1;1) into the limited interval (1;1), and this allow s introducing new e ects, as we illustrate below.

W e consider the potential

$$V() = \frac{1}{2} (1 ^{2})^{3}$$
(36)

This potential is new. It is unbounded below, containing a maximum at = 0 and two in ection points at 1. In this case the modi ed potential becomes

which is the vacuum less potential considered in [4, 5]. In R ef. [5] the vacuum less model was shown to support kinklike solutions of the BPS type. This result indicates that the model (36) may also support this kind of solutions. Indeed, it is astonishing to see that the potential (36) supports the kink-like defects

$$(x) = p \frac{x}{1+x^2}$$
 (38)

which connect the two in ection points of the potential. These defects are stable, and they can be seen as deformations of the defects

$$(\mathbf{x}) = \operatorname{arcsinh}(\mathbf{x}) \tag{39}$$

which appear in the model de ned by the potential of Eq. (37). As far as we know, this is the nst example where kink-like defects connect two in ection points. In the recent Ref. [31] one has found another model, somehow sim ilar to the above one, but there the solution connects a localm inimum to a in ection point.

The solutions (38) are stable, and the Schrodinger-like equation that appears in the investigation of stability is de ned by the Ham iltonian

$$H = \frac{d^2}{dx^2} + 12\frac{x^2}{(x^2 + 1)^2}$$
(40)

The potential is a volcano-like potential, which supports the zero mode and no other bound state. The (normalized) wave function of the zero mode is $_0(x) = 2(2=3)^{1=2}(x^2 + 1)^{3=2}$. This should be contrasted with the zero mode of the vacuum less potential, which is given by [5]: $e_0(x) = (1=)^{1=2}(x^2 + 1)^{-1=2}$. We notice that the two zero modes localize very di erently in space.

The present work is of direct interest to investigations concerning systems described by two real scalar elds, as considered for instance in Refs. [32, 33]. A lso, it may be of some use in more complex situations, involving three or more scalar elds, in scenarios such as the one where we dealwith the entrapment of planar network of defects [34], or with the presence of non-trivial solutions representing orbits that connect vacuum states in the threedimensional con guration space [35].

The deform ation scheme that we have presented m ay also work in other contexts, in particular in the case where one couples the scalar eld to gravity in higher dimensions. We have found interesting investigations in Refs. [36, 37, 38], and we are now considering the possibility of extending the deform ation procedure to braneworld scenarios.
