M arginally Stable Topologically N on-Trivial Solitons in the G ross-N eveu M odel

We show that a kink and a topologically trivial soliton in the Gross-Neveu model form, in the large-N limit, a marginally stable static con guration, which is bound at threshold. The energy of the resulting composite system does not depend on the separation of its solitonic constituents, which serves as a modulus governing the prole of the compound soliton. Thus, in the large-N limit, a kink and a non-topological soliton exert no force on each other.

The problem of nding the particle spectrum (e.g., bound states) of quantum eld theory is a major objective of nonperturbative studies thereof. This issue may be addressed quantitatively in model eld theories in 1 + 1 space-time dimensions such as the Gross-Neveu (GN) model [1], in the largeN limit. The GN model (and other similar models) are particularly appealing, since they exhibit, among other things, asymptotic freedom and dynamical mass generation, like more realistic four dimensional models.

One version of writing the action of the 1 + 1 dim ensional GN m odel is

$$S = d^{2}x \qquad a i d \qquad a \frac{1}{2g^{2}} ; (1)$$

where the $_{a}$ (a = 1;:::;N) are N avors of m assless D irac fermions, with Yukawa coupling to the scalar auxiliary eld (x). This action is evidently sym m etric under the simultaneous transform ations ! and ! 5, which generate the so-called discrete (or \mathbb{Z}_{2}) chiral sym - m etry of the GN m odel. The GN action has also avor sym m etry O (2N), which can be seen by breaking the N D irac spinors into 2N M a jorana spinors. Related to this is the fact that the m odel is also invariant under charge-conjugation [2]. Thus, focusing on bound states of the D irac equation

$$i \not e \qquad (x) = 0 \qquad (2)$$

associated with the GN action, if $_{b}(x;t) = e^{i!_{b}t}u_{b}(x)$ (with 0 ! $_{b}^{2} < m^{2}$) is a bound state solution of (2), so is its charge conjugate spinor $_{b}^{c}(x;t) = e^{+i!_{b}t}u_{b}^{c}(x)$, so that bound state frequencies come in pairs: ! $_{b}$. If, how ever, (2) has a bound state at ! $_{b} = 0$, it is of course unpaired, i.e., self-charge-conjugate.

Performing functional integration over the grassmannian variables $_{R}$ in the GN action leads to the partition function Z = D expfiS_{eff} []g where the bare e ective action is

and the trace is taken over both functional and D irac indices.

The theory (3) has been studied in the limit N ! 1 with N g^2 held xed[1]. In this limit the partition function Z is governed by saddle points of (3) and the small uctuations around them. (In this Letter, as in [2], we will consider only the leading term in the 1=N expansion, and thus will not compute the e ect of the uctuations around the saddle points.) The most general saddle point condition reads

In particular, the non-perturbative vacuum of the GN model is governed by the simplest saddle point of the path integral associated with it, where the composite scalar operator develops a space-time independent expectation value, signaling the dynam ical breakdown of the discrete chiral symmetry by the non-perturbative vacuum. Thus, the ferm ions acquirem assm dynam ically.

A ssociated with this breakdown of the discrete symmetry is a topological soliton, the so called C allan-C olem an- $G \operatorname{ross-Zee} (CCGZ) \operatorname{kink} [2, 3, 4], (x) = m \tanh(m x),$ with mass M $_{kink} = \frac{Nm}{m}$ (m is the dynamically generated ferm ion m ass). It is topology which insures the stability of these kinks: they are the lightest topologically nontrivial solitons in the GN model. The D irac equation (2) in the kink background has a single self-charge-conjugate bound state at $!_{b} = 0$, which can populate at most N valence ferm ions. Thus, it gives rise to a multiplet of $2^{\mathbb{N}}$ degenerate states, with mass equal to M kink, which can be identied as the (reducible) spinor representation of 0 (2N) [5,6]. The expectation value of the ferm ion num ber operator N $_{\rm F}\,$ in a state in which the kink traps n valence ferm ions is n $\frac{N}{2}$, where the subtracted piece is the so-called \fractional part" of the ferm ion num ber [5, 6], due to uctuations of the ferm ion eld in the topologically nontrivial background. Thus, in the kink multiplet <u>N</u>2 Ν_F $\frac{N}{2}$.

The GN model bears also non-topological solitons,

which were discovered by Dashen, Hasslacher and Neveu (DHN) [2] (after the work of [3]). Henceforth, we shall refer to them as \D HN solitons". These non-topological solitons are stabilized dynam ically, by trapping ferm ions and releasing binding energy. In [2], DHN used inverse scattering analysis [7] to nd static soliton solutions to the large-N saddle point equations of the GN model. (DHN also found in [2] oscillatory, time dependent solutions of the saddle point equations, which we will not disucss in this Letter.) The remarkable discovery DHN m ade was that all the physically adm issible static, spacedependent solutions of (4), i.e., the static bag con gurations in the GN model (the CCGZ kink being a nontrivial example of which) were re ection less. That is, the static (x)'s that solve the saddle point equations of the GN model (subjected to the obvious boundary condition (1) = m) are such that the rejection coecient of the D irac equation (2) associated with the GN action, vanishes identically.

The D irac equation (2) in a DHN soliton background has a pair of charge conjugate bound states at $!_b$. The O (2N) avor symmetry mixes particles and antiparticles. At the level of the D irac equation (2) this means that we have to consider the pair $!_b$ of bound state eigenfrequencies together in the following way: D ue to Pauli's principle, we can populate each of the bound states

! with up to N (non-interacting) ferm ions. Then all the multi-particle states in which the negative frequency state is populated by N h fermions (i.e., has h holes) and the positive frequency state contains p ferm ions, with h + p = n xed are degenerate in energy, and thus form a $C_{2N}^{n} = (2N) \models n!(2N n)! dim ensional irreducible O (2N)$ multiplet, namely, an antisymmetric tensor of rank n [2]. Super cially, 0 2N, in accordance with Pauli's n principle. However, for dynam ical reasons, as explained in Section 3 of [8], only solitons with 0 < n < N are realized. The expectation value of the ferm ion num ber operatorN_F in a state in which the DHN soliton traps particles and h holes is simply $N_F = p h = 2p n$, i.e., purely the naive valence contribution. (There is no fracional contribution due to the trivial topology.) Thus, in the DHN soliton multiplet n N $_{\rm F}$ n.DHN found that in this case $!_{b} = m \cos \frac{n}{2N}$. The mass of such a soliton is $M_n = \frac{2Nm}{2N} \sin \frac{n}{2N}$ and its prole is $(x) = (1)_i +$ $tanh [(x x_0)] tanh (x x_0) + \frac{1}{2} \log \frac{m}{m}$ where (1) = (1) = m, = $m \sin \frac{n}{2N}$ = $\overline{m^2}$! $\frac{2}{b}$, and x_0 is a translational collective mode. Note that both M $_{\rm n}\,$ and M $_{\rm kink}\,$ are of order N as typical of soliton masses in weakly interacting QFT. The binding energy $B_n = nm$ M_n of the DHN soliton (as well as the binding energy per-ferm ion, $B_n = n$) increase with the number n of trapped valence ferm ions (this is the so-called \m attress e ect" in the physics of ferm ion bags). Thus, a DHN soliton is stable against decaying into a bunch of non-interacting fundamental ferm ions. It is also stable against decaying into lighter DHN bags, because any such presum ed process can be shown to violate either energy or ferm ion number conservation. Thus, DHN solitons are stable. Note that $M_{n=N} = \frac{2Nm}{2} = 2M_{kink}$, and more over, that as n ! N (i.e., ! m and !_b ! 0), the pro le (x) tends to (1)+m tanh (m x) m tanh [m (x+R)]; R ! 1 :Thus, the con guration at n = N is that of in nitely separated CCGZ kink and anti-kink bound at threshold. This singular behavior occurs because a DHN soliton, being a

The soliton solutions (both topological and nontopological) in the GN m odel serve as concrete calculable exam ples of ferm ion-bag [9, 10] form ation. Furtherm ore, these \multi-quark"bound states of the GN m odel are analogous to baryons in QCD in the lim it of large num – ber of colors [11]. Since the work of DHN, these ferm ion bags were discussed in the literature several other times, using alternative m ethods [12]. For a recent review on these and related m atters, see [13].

topologically trivial con guration, cannot support a nor-

malizable zero mode, as explained below.

In this Letter, we show that the spectrum of the GN model contains, in the large-N limit, a composite, marginally stable topological soliton, which may be interpreted as a kink and a non-topological soliton bound at threshold. Furthermore, the energy of this system does not depend on the intersoliton distance, which thus serves as a modulus controlling the shape of the corresponding static solution of the large-N saddle point equation.

It is a general feature of the D irac equation (2) in the background of a static topologically non-trivial (x) con gurations, that the spectrum contains an unpaired bound state at ! = 0. For example, for kink boundary conditions ((1) = (1) = m_R, such a norm alizable zero-m ode is given by $u_0 \exp$ (y) dy, where i ${}^{1}u_0 = u_0$.

To make our point, we have to nd a topologically non-trivial static solution of (4), which in a certain lim it appears as well separated kink and a DHN soliton. Thus, we must nd a re ectionless (x) con guration, such that (2) has a bound state at ! = 0, as required by topology, and a pair of charge conjugate bound states at som e $!_{b} \notin 0$, with $!_{b}$ considered a free parameter. To this end, we apply them achinery of [7] (see also [14]) and nd the most general such re ectionless background as

$$\begin{aligned} (\mathbf{x}) &= \mathbf{m} + \frac{2}{1 + \frac{\mathbf{m} +}{\mathbf{m}} - \mathbf{e}^{2 - (\mathbf{x} - \mathbf{y}_{0})}} \\ &= 2 \left(\mathbf{m} + - \right) \frac{1 + \frac{\mathbf{m} +}{(\mathbf{m} -)^{2}} - \mathbf{e}^{2\mathbf{m} - (\mathbf{x} - \mathbf{x}_{0})} + \frac{\mathbf{m} +}{(\mathbf{m} -)^{2}} - \mathbf{m} - \mathbf{e}^{2 - (\mathbf{x} - \mathbf{y}_{0})} \\ &= 1 + \frac{\mathbf{m} +}{\mathbf{m}} - \frac{2}{\mathbf{e}^{2\mathbf{m} - (\mathbf{x} - \mathbf{x}_{0})} + \frac{\mathbf{m} +}{\mathbf{m}} - \frac{2}{\mathbf{e}^{2} - (\mathbf{x} - \mathbf{y}_{0})} + \frac{\mathbf{m} +}{\mathbf{m}} - \frac{2}{\mathbf{e}^{2\mathbf{m} - (\mathbf{x} - \mathbf{x}_{0}) + 2 - (\mathbf{x} - \mathbf{y}_{0})} \\ &= 1 + \frac{1}{\mathbf{m}} - \frac{\sinh \left[\mathbf{m} - (\mathbf{x} - \mathbf{x}_{0}) + (\mathbf{x} - \mathbf{y}_{0}) + 2 - \mathbf{R} \right] + \sinh \left[\mathbf{m} - (\mathbf{x} - \mathbf{x}_{0}) - (\mathbf{x} - \mathbf{y}_{0}) \right] \\ &+ \frac{1}{\mathbf{b}} \frac{\sinh \left[\mathbf{m} - (\mathbf{x} - \mathbf{x}_{0}) + (\mathbf{x} - \mathbf{y}_{0}) + 2 - \mathbf{R} \right] + \sinh \left[\mathbf{m} - (\mathbf{x} - \mathbf{x}_{0}) - (\mathbf{x} - \mathbf{y}_{0}) \right] \\ &= \frac{1}{\mathbf{b}} \frac{\sinh \left[\mathbf{m} - (\mathbf{x} - \mathbf{x}_{0}) + (\mathbf{x} - \mathbf{y}_{0}) + 2 - \mathbf{R} \right] + \mathbf{e} - \mathbf{R} \cosh \left[\mathbf{m} - (\mathbf{x} - \mathbf{x}_{0}) - (\mathbf{x} - \mathbf{y}_{0}) \right] \\ &= \frac{1}{\mathbf{b}} \frac{1 + \frac{\mathbf{m} +}{\mathbf{m}} - 2 - (\mathbf{x} - \mathbf{x}_{0})}{\mathbf{b} - \mathbf{c} - \mathbf$$

= p_{m^2} , $R = \frac{1}{2}\log\frac{m}{m}$, and where where x_0 and y_0 are arbitrary real parameters. The latter two quantities arise in the inverse scattering form alism as arbitrary parameters, independent of the param eter ! b, which determine the coe cients in front of the asymptotic exponentially decaying normalized bound state wave functions. Thus, the normalized bound state at ! = 0 behaves asymptotically as $2m \exp m(x x_0)$, and the normalized bound states at ! behave asym ptotically as 2 exp $(x y_0)$, as x ! 1. Here, of course, x_0 and y_0 are translational collective coordinates of the soliton (x). Note that (x) in (5) satisfies kink boundary conditions: (1) = m and (1) = $2(+m) = m \cdot Sim i larly,$ m + 2 (x) is the desired extrem al con guration with boundary conditions of an anti-kink.

The e ective action S_{eff} in (3), evaluated at the background (5), is an ordinary function S_{eff} (! $_{b}$; y₀ x_0) of the param eters which determ ine the shape of (5), where we have invoked translational invariance of (3). (W ith no loss of generality, we can always set one of these collective coordinates, say x_0 , to zero.) M inus the value of S_{eff} (! $_{b}$; y_{0} x_{0}) per unit time is the rest energy, or mass M (!_b;y₀ x₀), of the static inhom ogeneous condensate (5). We still have to extrem ize M $(!_{b}; y_{0})$ x₀) with respect to ! b. As in the case of the DHN soliton, the extrem al value is determ ined by the num ber n of valence particles and antiparticles which are trapped in the bound states ! b. Follow ing the sam e technique used by DHN in [2] to calculate the mass of the DHN soliton, we nd that the extrem al value is again $!_{b} = m \cos \frac{n}{2N}$, and that the mass of (5), which we will refer to as the \heavier topological soliton" (HTS), is

$$M_{HTS;n} = \frac{Nm}{m} + \frac{2Nm}{m} \sin \frac{n}{2N}$$
 : (6)

Thus, $M_{HTS,m}$ coincides with the sum of masses of a CCGZ kink and a DHN soliton trapping n valence ferm ions. Clearly, the O (2N) quantum numbers of the HTS are those of the direct product of the 2^{N} dimensional spinorial representation and the antisymmetric

tensor representation of rank n. M ore details of the construction of (5) and the associated extrem um condition on $!_{b}$ will be given elsewhere [8].

N ote that $M_{HTS,n}$ is independent of the remaining collective coordinate y_0 . By varying y_0 (while keeping !_b xed at its extrem al value), we can modify the shape of (x) in (5) without a ecting the mass of the soliton. The translational collective coordinate y_0 is thus a at direction of the energy functional, or a modulus. In the following we will show that the modulus y_0 is essentially the separation between a CCGZ kink and a DHN soliton which we interpret as the loosely bound constituents of the HTS. Thus, the fact that $@M_{HTS,m} = @y_0 = 0$, means that these solitons exert no force on each other, whatever their separation is.

This is a somewhat surprising result, since one would norm ally expect soliton-soliton interactions to be of the order $\frac{1}{g^2}$ N in a weakly interacting eld theory, which is consistent, of course, with what one should expect from general $\frac{1}{N}$ counting rules. Indeed, drawing further the analogy between the solitons discussed in this Letter and baryons in QCD with large N color, the HTS would correspond to a dibaryon. From the general $\frac{1}{N}$ counting rules [11], the baryon-baryon interaction is expected to be of order N . Yet, due to dynamical reasons which ellude us at this point, the solitonic constituents of the HTS avoid these general considerations and do not exert force on each other.

It is straightforward to obtain the asymptotic behavior of (5) for large $j_{0}j$ (and $x_{0} = 0$). In the lim it y_{0} ! 1, the shape of (5) is that of a CCGZ kink, with a little \D HN bum p", centered on its left wing at $x_{bum p} = y_{0} + (3=4) \log \frac{m}{m+}$ ' y_{0} , of width 1=2 and maximum value of m 2!_b. Its shape is given approximately by $(x_{bum p} + z)$ ' $m + 2^{2} = (m + !_{b} \cosh 2 z)$. In the other lim it, y_{0} ! +1, (5) has the shape of a CCGZ kink, with a little \D HN dip", centered on its right wing at $x_{dip} = y_{0} + (1=4) \log \frac{m}{m+}$ ' y_{0} , of width 1=2 and minimum value of m 2 (m + !_{b})=(m + + !_{b}). Its shape is given approximately by $(x_{dip} + z)$ '

m 2 (m +)=(m + + ! $_{\rm b} \exp 2 z$) + 2 ! $_{\rm b}$ =(! $_{\rm b}$ + (m +) $\exp 2 z$). For y₀ in the range such that $iy_0 j$ 1, the \DHN disturbance" and the kink partly overlap. These statem ents are demonstrated in the gures, for the case m = 2 = 1.




FIG.1: The solution (5) for m = 2 = 1; 2 = 20




FIG.2: The solution (5) for m = 2 = 1; 2 = 1

The lim it n ! N is of some interest. Strictly speaking, there is no H TS with n = N, since at n = N the pair of bound states at $!_b$ of the D irac equation (2) would coincide with the bound state at ! = 0, which already exists due to non-trivial topology. Clearly, such a degeneracy cannot occur in the spectrum in one spatial dimension. (Form ore details see Sections 3.1.2 and B.3.2 in [8].) However, it is possible to study HTS's with n arbitrarily close to N. In this case, ! m, with R ! 1 in (5). Thus, for $j_x j_y j_0 j < < R$, (5) tends in this lim it




FIG.3: The soliton (5) for m = 2 = 1; 2 = 2

to

$$(\mathbf{x}) = m \frac{1}{1 + e^{-2m (\mathbf{x} - \mathbf{y}_0)}} e^{-2m (\mathbf{x} - \mathbf{x}_0)} e^{-2m (\mathbf{x} - \mathbf{x}_0)}$$

(where for clarity of presentation we have reinstated the parameter x_0 into the expression for (x)). In the asymptotic region $1 << m j x_0 y_0 j (< m R)$ (7) simplifies further, and appears as a kink m tanh [m (x $x_{m ax}$)], boated at $x_{m ax} = m axf x_0; y_0 g$. This clearly has m ass $M_{kink} = \frac{N m}{n}$, but according to (6), $M_{HTS;n'N}$ should tend to $\frac{3N m}{m} = 3M_{kink}$. The extra m ass $2M_{kink}$ corresponds, of course, to the kink-anti-kink pair which receded to spatial in nity.

Finally, we must settle the important issue of stability of the HTS. Due to conservation of the topological charge q = ((1))(1))=2m, the nal static conguration will obey the same kink boundary conditions as (5). The HTS is too light to decay into a con guration of CCGZ kink-kink-antikink (see (6)). Thus, it can only decay into a CCGZ kink plus a bunch of lighter DHN bags and/or free ferm ions. The binding energy $B_n = nm + M_{kink}$ $M_{HTS;n}$ of the HTS coincides with that of a DHN bag with the same quantum number n. Thus, sim ilarly to the latter, the HTS is stable against evaporation into a CCGZ kink and a cloud of non interacting ferm ions. Decay of the HTS (with O (2N) quantum numbern) into a CCGZ kink and a DHN bag (of quantum num ber n⁰) is alm ost totally forbidden: Energy conservation obviously requires $0 < n^0$ n. Ferm ion num ber conservation, on the other hand, requires (see [8] form ore details) n $n^0 < N$, i.e., the complimentary set of the possible range (0; N) for n^0 . The two conservation laws are compatible only at $n^0 = n$. Thus, the mass of the decay products equals the mass of the parent HTS, and the allowed channel in this case has no phase space. F inally, one can show, using elem entary considerations as above, that energy conservation and ferm ion num ber conI am happy to thank Y. Frishman, M. Karliner, M. M oshe and R.
