# $M$ atrix $m$ odels of 4-dim ensional quantum $H$ all uids

#### Abstract

We propose two non-abelian Chem-Sim ons matrix m odels as the e ective descriptions of 4 -dim ensional quantum $H$ all uids. O ne of them describes a new type of 4-dim ensional quantum $H$ all uid on the space of quatemions, the other provides the description of non-commutative eld theory for Zhang and Hu's 4dim ensional quantum $H$ all uid of $S^{4}$. The com plete sets of physical quantum states of these $m$ atrix $m$ odels are determ ined, and the properties of quantum $H$ all uids related w th them are discussed.

There has recently appeared an interesting connection betw een quantum $H$ alle ect ( Q HE ) if and noncommutative eld theory. In particular, Susskind A] proposed that non-com $m$ utative $C$ hem-Sim ons theory on the planem ay provide a description of the quantum Hall uid (QHF). Susskind's non-com mutative C hemSim ons theory on the plane describes a spatially in nite quantum $H$ all system. The elds of this theory are in nite $m$ atrices that act on an in nite $H$ ilbert space, appropriate to account for an in nite num ber of electrons. P olychronakos 3] proposed a m atrix regularized version ofSusskind's non-com $m$ utative C hemSim ons theory in e ort to describe nite system swith a nite num ber of electrons in the lim ited spatial extent. $T$ his $m$ atrix $m$ odel $w$ as show $n$ to reproduce the basic properties of the QHF [4].

Recently, Zhang and Hu [回] have found a 4dim ensional generalization of the quantum H all sys tem that is com posed ofm any particlesm oving in four dim ensional space under a SU (2) gauge eld. The authors in 18 , 9,10 have developed the idea of Zhang and Hu in other directions.

The goal of this paper is to establish the secondquantized eld theory description of 4-dim ensional QHFs, i.e, to do the non-commutative eld theories for 4-dim ensionalQ HFs.
$T$ he $m$ atrix $m$ odels proposed in the present paper originate from the investigation of $m$ atrix form ulation of $M$ theory [11]. In the $m$ atrix $m$ odel under the background of the longitudinal M 5-branes [12], the open $m$ em brane can be ended on the M 5-brane sim i-
lar to the fiundam entalstring ending on the $D$-branes in the string picture. If one consider the rigid properties of open $m$ em brane [13], the gauge transform ation of area preserving can lead to a non-com $m$ utative C hem-Sim ons theory [14]. For the bound con gurations of the open $m$ em brane and the spherical 5-brane in the xed background, the non-com $m$ utative $C$ hemSim ons eld is valued in the Lie algebra SO (4). The $m$ atrix $m$ odels presented here are the $m$ atrix regularized $m$ odels of such non-com $m$ utative non-abelian Chem-Sim ons theories. Since the group SO (4) is isom orphic to $S U(2) \quad S U(2)$, the $S U(2)$ nite $m$ atrix C hem-Sim ons $m$ odel is the fiundam entalbuilding block of these non-com $m$ utative $C$ hem-Sim ons theories. $H$ ence, $m y$ starting point is the $S U$ (2) nite $m a-$ trix Chem-Sim ons m odel.
$T$ he action of this $m$ atrix $m$ odel is

H ere, we consider the system com posed of N particles. The com plex coordinates $Z$, which can be expressed as $Z^{1}=Q^{1}+i Q^{2}$ and $Z^{2}=Q^{3}+i Q^{4}$ in term $s$ of four real coordinates, are represented by nite $N \quad N$ matrices. The gauge elds $A_{0}$ obey the relations $\mathrm{A}_{0}^{11}=\mathrm{A}_{0}^{22 \mathrm{y}}$ and $\mathrm{A}_{0}^{12}=\mathrm{A}_{0}^{21 \mathrm{y}}$, and each elem ent of them is a $N \quad N$ m atrix. The constant $H$ plays the role sim ilar to the constant $m$ agnetic eld in 2-dim ensionalQ HE. is the positive param eter characterizing the non-com $m$ utativity of the coordinates of particles. The action (1) is invariant under the gauge transform ations $Z$ ! $\mathrm{UZ} \mathrm{U}^{1}$, ! U
and $A_{0} \quad!\quad U A_{0} U^{1} \quad @_{t} U U^{1}$ if the level of this C hem-Sim ons theory is an integer. H ow ever, the $U(\mathbb{N})$ gauge transform ations are com bined with the SU (2) gauge transform ations (see below ). By choosing the gauge $A_{0}=0$ and im posing the equation of $m$ otion of $A_{0}$ as the constraints, we obtain

W e will proceed by rst quantizing our theory before solving the constraints, and then applying the
constraints as operator conditions on the physical states. A fter perform ing the quantization of the system, one can nd that the $m$ atrix elem ents of $Z$ and the com ponents of satisfy the follow ing com $m$ utation relations

where we had rescaled $\mathrm{P} \overline{\mathrm{H}=2 \mathrm{Z}}$ and $\mathrm{P} \overline{\mathrm{H}=2 \mathrm{Z}}$ into $Z$ and $Z$ respectively. Then, one can easily w rite the ham iltonian of the $m$ atrix $m$ odel at hand as

Follow ing [3], we can easily $x$ the operator expression of the $G$ auss constraints after the quantization. T he operators of the traceless part of the constraints (2) lead to the conditions of physical states as

In (6) and (7), $\mathrm{z}_{\mathrm{a}}$ represent the components of the expanding of $Z$ in the $S U(\mathbb{N})$ basis of $m a-$ trices. It can be easily proved that the generators of the constraints satisfy the commutation relations $\left[G^{a ; 3} ; G^{b ; 3}\right]=i f^{\mathrm{abc}} \mathrm{G}^{\mathrm{c} ; 3}$ and $\left[\mathrm{G}^{\mathrm{a} ; 3} ; \mathrm{G}^{\mathrm{b} ;+}\right]=$ if $^{\mathrm{abc}} \mathrm{G}^{\mathrm{c} ;+}$. It should be pointed that if we choose the $G$ auss constraints (5), $\mathrm{G}^{\mathrm{a} ;}=\left(\mathrm{G}^{\mathrm{a} ;+}\right)^{\mathrm{y}}$ acting on the physical states does not produce the vanishing result. So the physical states are not the $S U$ (2) invariants, but they are the $S U(\mathbb{N})$ invariants. Taking the trace of (2a), we obtain

 nality of ${ }^{1}$ and ${ }^{2}$ as the $N$-vectors under the transform ation of $S U(\mathbb{N})$. A fter quantization, its operator condition implies that it is impossible that ${ }^{1 y}$ together with ${ }^{2 y}$ appear in the physical states in a singlet of $S U(\mathbb{N})$.

By considering the $S U(\mathbb{N})$ invariance of the physicalstates and the structure of (5), one can easily show that 2 H is an integer, i.e., $2 \mathrm{H}=\mathrm{k}$. Furthem ore, the orth ${ }_{\mathrm{Y}} \mathrm{gonality} \mathrm{of}{ }_{\mathrm{i}}^{1}$ and ${ }^{2} \mathrm{~m}$ ake the equation (8) become ${\underset{i}{1 y}}_{\substack{1 \\ i}} \mathrm{Nk}$ jphysi $=0$. De ne the Fock
space vaccum $j 0 i$ by $Z_{i j} j 0 i=i_{i} j 0 i=0$. Thus, any physical state describing an energy eigenstate of the ham iltonian (4) should be the linear com binations of the follow ing Fock states
where, the findam ental indioes of $S U(\mathbb{N})$ are w ritten as upper indices, and the anti-fiundam ental indices as low er indices.

N ow, our task is to m ake the states of (9) into the singlets of $S U(\mathbb{N})$ by contracting allSU $(\mathbb{N})$ indices of it. We can do this in two m anners. O ne is to contract the indiges of ${ }^{1 y}$ and $Z$ in the $S U$ (2) invariant way. A nother $m$ anner is based on that
${ }^{1 y} ; Z^{1 y}$ and ${ }^{2 y} ; Z^{2 y}$ are the com ponents of 'spin up' and those of 'spin down' respectively, since both
$y$ and $Z{ }^{y}$ belong to the spinor representations of $S U(2)$. O ne can easily nd that these fundam ental blocks really satisfy the $G$ auss constraint conditions of the physical states. By em ploying the blocks and the technique in Al], we can w rite the Fock basis of the physical states of the $m$ atrix $m$ odel as

The $\mathcal{f} 0 \mathrm{~g} ; f 0 \mathrm{~g} ; \mathrm{ki}$ in (10) gives the physical ground w avefunction of our m atrix m odel. In fact, it is the Laughlin-type wavefunction of the 4 -dim ensionalQHF found by us.

It is just the sam e as the ground state $w$ avefunction of two-dim ensional Q HF on the H aldane's spherical geom etry [15]. H ow ever, in our system, $u$ and $v$ are the coordinates of the space $H$ of quatemions. $C$ onclusively, the SU (2) m atrix C hem-Sim ons m odel (1) describes the 4 -dim ensionalQ HF on the $H$. Ifwe denote the quantum num ber of the $S U$ (2) representation as $J$, for the $k=1$ case, we can nd that $N=2 J+1$ by noticing $Z^{1 y}$ and $Z^{2 y}$ associated w ith 'spin up' and 'spin down' respectively. That is, the particles of this 4-dim ensionalQHF are lled in the representation of the SU (2) level J. For the case of general $k$, the degeneracy given by the representation of $S U$ (2) is $2 J^{0}+1=k N$, while the particle number is still $N$. The lling factor in this case is $=\mathrm{N}=\mathrm{Nk}=1=\mathrm{k}$. So this 4-dim ensional Q HF has the properties sim ilar to the usual2-dim ensionalQ HF.
$N$ ow let us tum to the description of the $m$ atrix model corresponding to the 4-dim ensional QHF of Zhang and Hu of $\mathrm{S}^{4}$. In fact, this four-sphere $\mathrm{S}^{4}$ is the base of the H opf bundle $S^{7}$ obtained by the second Hopf bration, from the connection 16] betw een the second Hopf $m$ ap and Yang's SU (2) m onopole 17]. Equivalently, $\frac{S O(5)}{S U(2) S U(2)}=\frac{S^{7}}{S U(2)=S^{3}}=S^{4}$ since $S^{7}=\frac{S 0(5)}{S U(2)}$. This implies that the $S^{4}$ can be identi ed w ith the coset space of the group SO (5) under the $S O(4)=S U(2) \quad S U(2)$ gauge structure. Such geom etrical structure plays a key role in the description of our $m$ atrix $m$ odel. H ow ever, If one takes straightforw ardly the onbital part of the SO (5) generators as the generators of SO (4) and decom poses them into two SU (2) algebras, he can not use such SO (4) blocks to generate all irreps. of $S O$ (5) [18]. Only if these orbital SO (4) generators are m odi ed by the coupling of them w ith a SU (2) isospin, they can be used to generate the SO (4) block states of all so (5) irreps. 18]
$N$ ow it is clear that we can construct the $m$ atrix m odel by considering the SO (4) gauge structure and som e restriction conditions of the $m$ odel. $W$ e express the action (1) as $S=S[Z ; \quad ; A]$ and introduce the action of SO (4) m atrix Chem-Sim ons $m$ odel as follow ing

Two pairs of com plex coordinates $Z$ and $Z$ of the complex space $C^{4}$ can be expressed as $Z^{1}=Q_{1}^{1}+$ $i Q_{1}^{2} ; Z^{2}=Q_{1}^{3}+i Q_{1}^{4}$ and $Z^{1}=Z^{3}=Q_{2}^{1}+i Q_{2}^{2} ; Z^{2}=$ $Z^{4}=Q_{2}^{3}+Q_{2}^{4}$ in tem $s$ of eight real coordinates of the space $H^{2}$ of quatemions equivalent to $R^{8}$. We can get the restricted condition of $S^{7}$ by considering the sphere in $\mathrm{R}^{8}$, which is $\mathrm{Q}_{1}^{\mathrm{a} 2}+\mathrm{Q}_{2}^{\mathrm{a} 2}=\mathrm{Z}^{\mathrm{a}} \mathrm{Z}^{\mathrm{a}}=1$.
$Z^{a}, A_{0}$ and $A_{0}$ are nite $N \quad N m$ atrices, where $N$ is the num ber of particles of the system. Therefore, we w rite the geom etrically restricted condition of the m odelas

where $G$ is a param eter dependent on the $m$ odel. The equations of $m$ otion of $A_{0}$ and $A_{0}$ are taken as the constraint equations

From (13), one can see that the constraints are divided into two SU (2) parts of SO (4). So we can use the results of the $S U(2) m$ atrix $C$ hem-Sim ons m odel. A fter the quantization, there exist tw o groups of the physical states obeying the constraint equations given by (5) and (8) w ith respect to Z , and Z , . The geom etrical restricted condition becom es

where, phys >s represent the physical states of the geom etrically stable ob jects. In fact, the ground w avefunctions of Q HFs are such states. In general, if the physical states include the excitations, they do not satisfy the above geom etrically restricted condition.

O ur task is now to determ ine the physical states satisfying the geom etrical restricted condition while obeying the $G$ auss constraints and $U$ (1) charge constraints. In order to do that, we re-express the physicalground states of the SU (2) m odelas $\left[{ }^{\mathrm{y}} \mathrm{Z}^{\mathrm{y}}\right]^{\mathrm{j}_{1}}=$

It can be easily seen that the power of $Z^{1 y}$ and $Z^{2 y}$ in each term of $\left[{ }^{Y} Z{ }^{y}\right]^{j_{1}}$ is always $2 j_{1}$. If we use the direct product of the fundam ental blocks $\left[{ }^{Y} Z{ }^{Y}\right]^{j_{1}}$ and $\left[{ }^{Y} Z{ }^{Y}\right]^{j_{2}}$ to construct the fiunda$m$ ental block of $S O$ (4), we must $m$ ake the term $s$

Since the fiundam ental blocks $\left[Y_{Z} y^{j_{1}}\right.$ and [ $\left.y_{Z} \mathrm{y}\right]^{j 2}$ describe the states of the full lling of degeneracy $2 j_{1}+1$ and $2 j_{2}+1$ ofS $U$ (2)s respectively, the direct product of them gives the degeneracy $\left(2 j_{1}+1\right)$ $\left(2 j_{2}+1\right)$ of $S O$ (4). For the case of integer lling, each
fundam ental elem ent of the SO (4) block represents the lling ofa particle, and there are $\left(2 j_{1}+1\right) \quad\left(2 j_{2}+1\right)$ fundam ental elem ents in this $S O$ (4) block. Further$m$ ore, the $\left(2 j_{1}+2 j_{2}\right)\left(2 j_{1}+1\right)\left(2 j_{2}+1\right)$ th power of $Z^{1 y}, Z^{2 y}, Z^{3 y}$ and $Z^{4 y}$ is included in this block.

The physical states are built up by the factor products of all adm issive S O (4) blocks. Thus, the geom etrical restricted condition (14) acting on the physical states leads to

where, the range of the sum can be determ ined by $m$ eans of the fact that the $S^{7}$ is from the second Hopf bration of $S^{4}$. This bration can be realized by the m odi ed generators of orbitalso (4) through the coupling of a $S U(2)$ isospin. If the quantum num ber of isospin is $I$, the sm allest such irreps. of $\mathrm{SO}(5)$ is $(2 \mathrm{I} ; 0)_{5}$ 18], which consists of a collection of the SO (4) blocks $\left(j_{1} ; j_{2}\right)_{4}$ satisfying the relation $j_{1}+j_{2}=I ; 2 j_{1}=0 ; \quad ; 2 I$. This relation just gives the range of the sum (15). So we have

In sum $m$ ary, we have found the new type of 4dim ensional $\mathrm{H} F$ described by the $m$ atrix $m$ odel (1), and established the description of the e ective noncom m utative eld theory ofZhang and Hu'sQHF provided by the action (11) togetherw ith the geom etrical restricted condition (12) of $S^{7}$ which is from the second Hopf bration of $S^{4}$.

Note added: An interesting work 19] for 4dim ensional Q HE on $\mathrm{R}^{4}$ has appeared just recently in arX iv. However, the new type of 4-dim ensional
QHF in the present paper is di erent from their QHE system.
