Matrix models of 4-dimensional quantum Hall uids

We propose two non-abelian Chem-Simons matrix models as the elective descriptions of 4-dimensional quantum Hall uids. One of them describes a new type of 4-dimensional quantum Hall uid on the space of quaternions, the other provides the description of non-commutative eld theory for Zhang and Hu's 4-dimensional quantum Hall uid of S⁴. The complete sets of physical quantum states of these matrix models are determined, and the properties of quantum Hall uids related with them are discussed.

There has recently appeared an interesting connection between quantum Halle ect (QHE) [1] and noncommutative eld theory. In particular, Susskind [2] proposed that non-com m utative C hern-Sim ons theory on the planem ay provide a description of the quantum Hall uid (QHF).Susskind's non-com m utative Chem-Sim ons theory on the plane describes a spatially in nite quantum Hall system. The elds of this theory are in nite matrices that act on an in nite Hilbert space, appropriate to account for an in nite num ber of electrons. Polychronakos [3] proposed a matrix regularized version of Susskind's non-com m utative C hem-Sim ons theory in e ort to describe nite system swith a nite number of electrons in the limited spatial extent. This matrix model was shown to reproduce the basic properties of the QHF [4].

Recently, Zhang and Hu [5,6] have found a 4dimensional generalization of the quantum Hall system that is composed of many particles moving in four dimensional space under a SU (2) gauge eld. The authors in [7,8,9,10] have developed the idea of Zhang and Hu in other directions.

The goal of this paper is to establish the secondquantized eld theory description of 4-dimensional QHFs, i.e., to do the non-commutative eld theories for 4-dimensionalQHFs.

The matrix models proposed in the present paper originate from the investigation of matrix formulation of M-theory [11]. In the matrix model under the background of the longitudinal M 5-branes [12], the open membrane can be ended on the M 5-brane sim i-

lar to the fundam ental string ending on the D-branes in the string picture. If one consider the rigid properties of open membrane [13], the gauge transform ation of area preserving can lead to a non-com m utative Chem-Sim ons theory [14]. For the bound con gurations of the open m em brane and the spherical 5-brane in the xed background, the non-com mutative Chem-Sim ons eld is valued in the Lie algebra SO (4). The matrix models presented here are the matrix reqularized models of such non-commutative non-abelian Chem-Sim ons theories. Since the group SO (4) is isom orphic to SU (2) SU (2), the SU (2) nite matrix Chem-Sim onsm odel is the fundam ental building block of these non-commutative Chern-Sim ons theories. Hence, my starting point is the SU (2) nite matrix Chem-Sim onsm odel.

The action of this matrix model is

Here, we consider the system composed of N particles. The complex coordinates Z, which can be expressed as $Z^1 = Q^1 + iQ^2$ and $Z^2 = Q^3 + iQ^4$ in terms of four real coordinates, are represented by -N matrices. The gauge elds A $_0$ obey the nite N relations $A_0^{11} = A_0^{22y}$ and $A_0^{12} = A_0^{21y}$, and each element of them is a N N matrix. The constant H plays the role similar to the constant magnetic eld in 2-dim ensional QHE. is the positive param eter characterizing the non-commutativity of the coordinates of particles. The action (1) is invariant under the gauge transform ations $Z = U Z U^{-1}$, ! U and A_0 ! UA_0 U¹ QtUU¹ if the level of this Chem-Sim ons theory is an integer. How ever, the U (N) gauge transform ations are combined with the SU (2) gauge transform ations (see below). By choosing the gauge $A_0 = 0$ and imposing the equation of motion of A₀ as the constraints, we obtain

W e will proceed by rst quantizing our theory before solving the constraints, and then applying the constraints as operator conditions on the physical states. A fler performing the quantization of the system, one can nd that the matrix elements of Z and the components of satisfy the following commutation relations

where we had rescaled $p_{H=2Z}$ and $p_{H=2Z}$ into Z and Z respectively. Then, one can easily write the ham iltonian of the matrix model at hand as

Following [3], we can easily x the operator expression of the G auss constraints after the quantization. The operators of the traceless part of the constraints (2) lead to the conditions of physical states as

where G^{a;3} and G^{a;+} are given by

In (6) and (7), z_a represent the components of the expanding of Z in the SU(N) basis of matrices. It can be easily proved that the generators of the constraints satisfy the commutation relations $[G^{a;3};G^{b;3}] = if^{abc}G^{c;3}$ and $[G^{a;3};G^{b;+}] = if^{abc}G^{c;+}$. It should be pointed that if we choose the G auss constraints (5), $G^{a;} = (G^{a;+})^{y}$ acting on the physical states does not produce the vanishing result. So the physical states are not the SU (2) invariants, but they are the SU(N) invariants. Taking the trace of (2a), we obtain

The trace part of (2b) ${}_{i}^{1y} {}_{i}^{2} = 0$ gives the orthogonality of 1 and 2 as the N-vectors under the transformation of SU (N). A fler quantization, its operator condition in plies that it is in possible that 1y together with 2y appear in the physical states in a singlet of SU (N).

By considering the SU (N) invariance of the physical states and the structure of (5), one can easily show that 2H is an integer, i.e., 2H = k. Furtherm ore, the orthogonality of $\frac{1}{i}$ and 2 m ake the equation (8) become $\frac{1y}{i} \frac{1}{i}$ N k physi = 0. De ne the Fock

space vaccum $\text{Di by } Z_{ij}\text{Di} = i \text{Di} = 0$. Thus, any physical state describing an energy eigenstate of the ham iltonian (4) should be the linear combinations of the following Fock states

where, the fundam ental indices of SU (N) are written as upper indices, and the anti-fundam ental indices as lower indices.

Now, our task is to make the states of (9) into the singlets of SU (N) by contracting all SU (N) indices of it. W e can do this in two m anners. O ne is to contract the indices of 1^{y} and Z y in the SU (2) invariant way. The key point is to employ the fundam ental fact that $i < j (u_i v_j \ u_j v_i) = i_1 \ N \ n=1 \ (u^N \ n \ v^n \ 1)_{i_n}$, where u and v are two com ponents of spinor representation of SU (2). In this manner, we obtain the fundamentalblock $i_1 \longrightarrow f_{n=1}^{N} ({}^{1y}Z^{1yN} \xrightarrow{n} Z^{2yn-1})_{i_n}$ in a singlet of SU (N). A nother manner is based on that 1y ; Z^{1y} and 2y ; Z^{2y} are the components of 'spin up' and those of 'spin down' respectively, since both ^y and Z ^y belong to the spinor representations of SU (2). The SU (N) invariant block are then given by $i_1 \longrightarrow Q_{m=1}^N (1^{y_2} 2^{y_{m_m}+1} Z^{2y_{m_m}})_{i_m}$. One can easily nd that these fundam ental blocks really satisfy the G auss constraint conditions of the physical states. By employing the blocks and the technique in [4], we can write the Fock basis of the physical states of the

where, $P_{i=1}^{P} i(c_i c_i^0) = \mathbb{N}$, and l = 0;1;; k, which is from the fact that the physical states can be built by k second fundamental blocks at most since kN

 1y s always appear in the physical states. The energy eigenvalues of these states are E (fc_ig;fc_i⁰g;k) = $! (N^2 + kN (N 1) + \prod_{i=1}^{P} i(c_i + c_i^0))$. The jf0g;f0g;ki in (10) gives the physical ground wavefunction of our matrix model. In fact, it is the Laughlin-type wavefunction of the 4-dim ensionalQHF found by us.

After nishing the formal substitutions 1y ! 1 and Z_{ij}^{y} ! ${}^{ij}A_{j}$ in (10), we can get $D;ki = ({}^{i_1} \ {}^{N} \prod_{n=1}^{N} (A^{1yN} \ {}^{n}A^{2yn} \ {}^{1})_{i_n})^k Di$. Furthermore, if u and v are regarded as the eigenvalue parameters of A^1 and A^2 in the coherent state picture respectively, we not that hu;vD;ki =

 $(\overset{i_1}{} \overset{N}{} \overset{Q}{} \overset{N}{} \underset{n=1}{} (u^{N} \overset{n}{} v^{n-1})_{i_n})^k = \overset{Q}{} \underset{i < j}{} (u_i v_j \quad u_j v_i)^k.$ It is just the sam e as the ground state wavefunction of two-dimensionalQHF on the Haldane's spherical geometry [15]. However, in our system, u and v are the coordinates of the space H of quaternions. Conclusively, the SU (2) m atrix Chern-Sim ons m odel (1) describes the 4-dim ensionalQHF on the H . If we denote the quantum number of the SU (2) representation as J, for the k = 1 case, we can nd that N = 2J + 1by noticing Z^{1y} and Z^{2y} associated with 'spin up' and 'spin down' respectively. That is, the particles of this 4-dimensionalQHF are lled in the representation of the SU (2) level J. For the case of general k, the degeneracy given by the representation of SU (2) is $2J^0 + 1 = kN$, while the particle number is still N. The lling factor in this case is = N = N k = 1 = k. So this 4-dim ensional QHF has the properties sim ilar to the usual 2-dim ensional QHF.

Now let us turn to the description of the matrix model corresponding to the 4-dimensional QHF of Zhang and Hu of S^4 . In fact, this four-sphere S^4 is the base of the Hopf bundle S⁷ obtained by the second Hopf bration, from the connection [16] between the second Hopfmap and Yang's SU (2) monopole [17]. Equivalently, $\frac{SO(5)}{SU(2) SU(2)} = \frac{S^{7}}{SU(2)=S^{3}} = S^{4}$ since $S^7 = \frac{S \circ (5)}{S \cup (2)}$. This implies that the S^4 can be identied with the coset space of the group SO (5) under the SO (4) = SU (2) SU (2) gauge structure. Such geom etrical structure plays a key role in the description of our matrix model. However, If one takes straightforwardly the orbital part of the SO (5) generators as the generators of SO (4) and decom poses them into two SU (2) algebras, he can not use such SO (4) blocks to generate all irreps. of SO (5) [18]. Only if these orbital SO (4) generators are modi ed by the coupling of them with a SU (2) isospin, they can be used to generate the SO (4) block states of all SO (5) irreps. [18]

Now it is clear that we can construct the matrix model by considering the SO (4) gauge structure and some restriction conditions of the model. We express the action (1) as S = S [Z ; ;A] and introduce the action of SO (4) matrix Chern-Sim ons model as following

Two pairs of com plex coordinates Z and Z of the com plex space C⁴ can be expressed as $Z^1 = Q_1^1 + iQ_1^2; Z^2 = Q_1^3 + iQ_1^4$ and $Z^1 = Z^3 = Q_2^1 + iQ_2^2; Z^2 = Z^4 = Q_2^3 + iQ_2^4$ in terms of eight real coordinates of the space H² of quaternions equivalent to R⁸. We can get the restricted condition of S⁷ by considering the sphere in R⁸, which is $Q_1^{a2} + Q_2^{a2} = Z^a Z^a = 1$.

 $Z^{\,a}$, $A_{\,0}$ and $A_{\,0}$ are nite N $\,$ N m atrices, where N is the number of particles of the system . Therefore, we write the geometrically restricted condition of the model as

where G is a parameter dependent on the model. The equations of motion of A $_0$ and A $_0$ are taken as the constraint equations

From (13), one can see that the constraints are divided into two SU (2) parts of SO (4). So we can use the results of the SU (2) matrix Chem-Sim ons model. A fler the quantization, there exist two groups of the physical states obeying the constraint equations given by (5) and (8) with respect to Z , and Z , . The geom etrical restricted condition becomes

where, $phys >_s$ represent the physical states of the geom etrically stable objects. In fact, the ground wave-functions of QHFs are such states. In general, if the physical states include the excitations, they do not satisfy the above geom etrically restricted condition.

Our task is now to determ ine the physical states satisfying the geometrical restricted condition while obeying the Gauss constraints and U (1) charge constraints. If we use the direct product of the fundam ental blocks $[\ ^y Z \ ^y]^{j_1}$ and $[\ ^y Z \ ^y]^{j_2}$ to construct the fundamental block of SO (4), we must make the terms $^{1y}Z^{1y}($ $\overset{1}{Z}^{2y}($) and $^{3y}Z^{3y}($ $\overset{1}{Z}^{4y}($) become the fundamentalelment (${}^{1y}Z {}^{1ym_1}Z {}^{2ym_2} {}^{3y}Z {}^{3ym_3}Z {}^{4ym_4}$)_{i()} of the SO (4) block, where $m_1 + m_2 = 2j_1$ and $m_3 + m_4 =$ 2j₂. Since the fundamental blocks [^yZ ^y]^{j₁} and $\begin{bmatrix} y & Z & y \end{bmatrix}^{j_2}$ describe the states of the full lling of degeneracy $2j_1 + 1$ and $2j_2 + 1$ of SU (2)s respectively, the direct product of them gives the degeneracy $(2j_1 + 1)$ $(2\dot{p} + 1)$ of SO (4). For the case of integer lling, each

fundam ental elem ent of the SO (4) block represents the lling of a particle, and there are $(2j_1+1)$ $(2j_2+1)$ fundam ental elem ents in this SO (4) block. Furtherm ore, the $(2j_1 + 2j_2)(2j_1 + 1)$ $(2j_2 + 1)$ th power of Z^{1y}, Z^{2y}, Z^{3y} and Z^{4y} is included in this block.

The physical states are built up by the factor products of all adm issive SO (4) blocks. Thus, the geom etrical restricted condition (14) acting on the physical states leads to

where, the range of the sum can be determined by m eans of the fact that the S⁷ is from the second H opf bration of S⁴. This bration can be realized by the m odi ed generators of orbital SO (4) through the coupling of a SU (2) isospin. If the quantum number of isospin is I, the smallest such irreps. of SO (5) is (2I;0)₅ [18], which consists of a collection of the SO (4) blocks $(j_1; j_2)_4$ satisfying the relation $j_1 + j_2 = I;2j_1 = 0;$;2I. This relation just gives the range of the sum (15). So we have

From this we get N = $d_{(2I;0)_5}$. For the generalk, G becomes $2kId_{(2I;0)_5}$.

Let us introduce the following notation

W e can give straightforw andly the Fock basis of physical states of the SO (4) m atrix C hern-Sim ons m odel. The result is

One of use the ham iltonian of this system acting on these basis to give their energy eigenvalues E (fc_{1}^{a}g;k;I) = ! (2N² + 2IkN + $a_{;1}$ ic_{1}^{a}), where N = $d_{(2I;0)_{5}}$. The physical ground state wavefunction of this matrix m odel is given by jc_{1}^{a} = 0g;k;Ii in (18). If we perform the form al substitution ^{ay} ! 1, Z_{ij}^{ay} ! _{ij} (_a)_j in jf c_i^a = 0g;k; Ii, and consider _a as the components of spinor reps. of SO (5) in the [5], we nd that the ground state wavefunction of (18) in the coherent picture just becomes the ground state wavefunction of Zhang and Hu's 4-dimensional QHF on S⁴ [5]. Hence, we have exhibited the important properties of Zhang and Hu's 4-dimensional QHF in our SO (4) matrix Chem-Simonsmodel.

In summary, we have found the new type of 4dimensionalQHF described by the matrix model (1), and established the description of the e ective noncommutative eld theory of Zhang and Hu'sQHF provided by the action (11) together with the geometrical restricted condition (12) of S^7 which is from the second Hopf bration of S^4 .

Note added: An interesting work [19] for 4dimensionalQHE on R^4 has appeared just recently in arXiv. However, the new type of 4-dimensional QHF in the present paper is dierent from theirQHE system.
