#### Abstract

I study som e classes ofRG ow s in three dim ensions that are classically conform al and have $m$ anifest $g!\quad 1=g$ dualities. The RG ow intenpolates betw een know $n$ (four-ferm ion, $W$ ilson$F$ ischer, ${ }^{\prime}{ }_{3}^{6}$ ) and new interacting xed points. These m odels have tw o rem arkable properties: i) the RG ow can be integrated for arbitrarily large values of the couplings $g$ at each order of the $1=\mathrm{N}$ expansion; ii) the duality sym $m$ etries are exact at each order of the $1=\mathrm{N}$ expansion. I integrate the RG ow explicitly to the order $\mathrm{O}(1=\mathrm{N})$; w rite correlators at the leading-log level and study the interpolation betw een the xed points. I exam ine how duality is im plem ented in the regularized theory and veri ed in the results of this paper.


## 1 Introduction

In three-dim ensionalquantum eld theory it is often possible to derive non-perturbative results using a large $N$ expansion. Typically, $N$ is the number of scalar elds or ferm ions. To a given order of the $1=\mathrm{N}$ expansion in nitely $m$ any graphs can be collected by $m$ eans of sim ple resum $m$ ations and the resulting num ber of e ective graphs is nite. In som e cases it is not necessary to assum e that the couplings $g$ of the theory are $s m$ all and expand perturbatively in $g$, but it is possible to calculate the exact $g$-dependence at each order of the $1=\mathrm{N}$ expansion. Then, the com putation of a nite num ber ofe ective graphs allow s us to integrate the RG ow and study the interpolation betw een the xed points. If the theories satisfy a duality $g \$ 1=9$, then this sym $m$ etry is im plem ented exactly at each order of the $1=\mathrm{N}$ expansion. The purpose of this paper, which is an elaboration of the ideas of ref. [1ㅁㅁ], is to study a variety of $m$ odels w ith these features.

Speci cally, I study tw o classes of ow s. The rst class ofm odels involves K +1 sets of $N$ I, $I=0 ; 1 ;::: K$, ferm ions interacting by means of a -eld, that is to say a dynam ical souroe for a com posite operator. T he source is called dynam icalbecause the functional integral is perform ed also over. The large N lim it is obtained by assum ing that the numbers $\mathrm{N}_{\mathrm{I}}$ of ferm ions tend to in nity w ith equalvelocity. At the leading order of the $1=\mathrm{N}$ expansion the RG ow is trivial, in the sense that the $U V$ and $\mathbb{R}$ xed points are indistinguishable. A nontrivial RG ow appears at the level of $O$ ( $1=\mathrm{N}$ ) corrections. In the sim plest version of these $m$ odels, the xed points of these ows coincide w the thV xed points of the four-ferm ion $m$ odels梳, of new type.

The second class of $m$ odels is a scalar-eld counterpart of the rst class. Sets of scalar elds interact by m eans of a - eld. D ue to the radiative corrections, ${ }^{6}{ }^{6}$-potential term $s$ are generated. TheRG structure of these ows ism ore involved and the xed points include known conform al eld theories (W ilson $F$ ischer, ${ }^{\prime}{ }_{3}^{6}$ xed points) and new ones.
$T$ he theories satisfy certain dually sym $m$ etries, associated $w$ ith the exchange of ferm ions (or scalars) belonging to di erent sets. T he duality sym $m$ etries are exact at each order of the $1=\mathrm{N}$ expansion. N evertheless, due to som e subtleties of the regularization technique [1] [1] , the im plem entation of the dually sym $m$ etry at the regularized level needs to be studied carefilly.
$T$ he integration of the RG ow allows us to w rite all correlation functions exactly in $g$ to a given order in the $1=\mathrm{N}$ expansion. I stress again that the expansion is not around one xed point. N orm ally, an in nite resum $m$ ation is necessary to reach an interacting xed point from a G aussian xed point. H ere, instead, the entire RG ow is expanded at the sam e tim e in $1=N$ and no expansion is $m$ ade in the running couplings $g$. At each order of the $1=N$ expansion the xed points and the ow are determ ined with equal and consistent precision. Typically, both the $U V$ and $\mathbb{R}$ xed points are interacting.
$T$ he large $N$ expansion is crucial to $m$ ake the integration of the RG ow possible as described. To the order $O(1=N)$, the integration of the $R G \quad o w$ is equivalent to the resum $m$ ation of the leading logs, but in general (in QCD and non-Abelian Yang-M ills theory $w$ th $m$ atter, for
exam ple) the resum $m$ ation of the leading logs is not su cient to connect the $U V$ and $\mathbb{R}$ xed points, or the high - and low -energy lim its of the theory, although it gives a sort of result beyond the perturbative expansion.

A known theory exhibiting som e of the features of the m odels studied here is the large N ${ }_{3}^{6}$ theory. A s a classically conform al (tricritical) theory, it is $\mathbb{R}$ free and its O ( $1=\mathrm{N}$ ) -order beta function has a nontrivial ultraviolet xed point [ịl]. The ${ }_{3}^{6}{ }_{3}^{6}$ theory, how ever, does not have a duality sym $m$ etry. $V$ iew ed as a particular case of the $m$ odels analysed in this paper, it belongs to a m ore general fam ily of theories which do satisfy duality.

In the study of criticalphenom ena, stability puts som elim its on the values of the ${ }_{3}^{6}$ coupling
 xed point. N o attem pt is m ade here to apply the approach of $[\overline{1} \overline{1}]$ to the m odels of this paper. This study is left to a separate research, in view of the possible interest of these theories for condensed $m$ atter physics. In this paper I study only the tricritical dom ain.

O ther types of \exact" results about RG ow sexist in the literature. For exam ple, in fourdim ensionalsupersym $m$ etric theories it is often possible to $w$ rite an exact beta function [[4] [ T The N SV Z beta function, how ever, depends on the subtraction schem e and the present know ledge of this schem e does not allow us to integrate the RG ow. TheNSVZ form ula can be used to


Since the $m$ odels treated here are classically conform al, it is possible to work w ith a classically conform al subtraction schem $e$. In practioe this $m$ eans that, by default, the linear and quadratic divergences are subtracted aw ay, i.e. the associated renorm alized dim ensionful coupling constants are set to zero. This is autom atic in the fram ew ork of the dim ensional regularization. I recall that in these theories the naive dim ensional regularization has to be m odi ed adding an evanescent, RG invariant, non-local term to the lagrangian [1] $\overline{1}]$.

The RG ow is schem e independent to the order $O$ ( $1=\mathrm{N}$ ). Schem e dependences appear at the order $O\left(1=\mathrm{N}^{2}\right)$, but schem e-independent correlation functions can be w ritten to arbitrary order in the $1=\mathrm{N}$ expansion.

The m odels of this paper have been inspired by the study of the irreversibility of the RG ow $\underline{\underline{9}}_{\underline{-1}}^{-1}$. This research singles out, in even dim ensions, the specialness of classically conform al theories. In odd dim ensions the investigation of the irreversibility of the RG ow is m ore di cult, since we m iss the tools provided, in even dim ensions, by the em bedding in extemal gravity. It is useful to construct a large class of classically conform al theories as a laboratory to test som e ideas on this issue. T he interpretation of $[\underline{1} \overline{1} \overline{1}]$ suggests a $m$ ore physical choice for the expansion param eter, which is the schem e-invariant area of graph of the beta function betw een the xed points, de ned as

where is the trace of the stress tensor. The study of the quantity $a^{0}$ is left to a separate w ork [ $[\underline{1} \overline{1} 1 \overline{1}]$, w here the im plications on irreversibility are discussed.

In section 2 the ferm ionic $m$ odels are studied in detail. In section 3 correlation functions are
com puted explicitly and the RG interpolation betw een the xed points is studied. In section 4 I solve a particularly simple, but non-trivial, lim it, in which the ratios $\mathrm{N}_{\mathrm{I}}=\mathrm{N}_{0}$ are sent to zero after the large $N$ expansion. In section 5 I study the $m$ odels $w$ ith tw o-com ponent spinors, which have peculiar features and xed points of new type. Section 6 is devoted to the study of the scalar m odels, their beta functions, anom alous dim ensions and ow s . Section 7 contains the conclusions. In the appendix I discuss som e subtleties conceming the im plem entation of the dually sym $m$ etry in the fram ew ork of the $m$ odi ed dim ensional-regularization technique of ref. [1] $\left[_{1}^{1}\right]$.

## 2 Ferm ion m odels

The m odel we study was de ned in ref. [1] and describes $K+1$ sets of $\left(\mathbb{N}_{0} ;::: ; \mathrm{N}_{\mathrm{K}}\right)$ ferm ions interacting by m eans of a - eld. The lagrangian is

To sim plify various argum ents, I rst choose four-com ponent com plex spinors. T he generalization to models w th two-component spinors, which have xed points of new type, is discussed later. I work in the Euclidean fram ew ork, where and $y$ are independent from each other.
 is used for charge conjugation (see below). The matrioes 4 and 5 of the four-dim ensional $D$ irac algebra act on our spinors as avour $m$ atrioes. Since the fundam ental spinor in three dim ensions is real ( $M$ a jorana) and has tw o com ponents, a set of $N_{f} m$ assless four-com ponent complex spinors has a avour sym metry $O\left(4 N_{f}\right)$, while a set of $N_{f} m$ assive four-com ponent complex spinors has sym $m$ etry $O\left(2 \mathrm{~N}_{\mathrm{f}}\right) \quad \mathrm{O}\left(2 \mathrm{~N}_{\mathrm{f}}\right)$ : For other details see for exam ple $[\overline{\mathrm{B}}$ ]. The eld is a sort of dynam ical ferm ion m ass, but our ferm ions are otherw ise m assless. The expectation value is zero in the classically conform al phase.

Sym m etries. The theory ism anifestly invariant under re ection positivity (Herm itian conjugation com bined w ith a sign-change of the \tim e" coordinate $x_{3}$ ), parity, charge con jugation and tim e-reversal. The P , C and T transform ations are

Further sym $m$ etris are obtained replacing 4 W ith 5 . It is understood that, unless otherw ise stated, the transform ation of ${ }^{-}$is obtained from the one of as if $y$ were the adjoint of. In the list above, only tim e reversal requires to transform and $y$ independently.
$T$ he theory is also invariant under the chiral transform ation

and the analogous transform ation w ith $4!5$ : A consequence of chiral invariance is that the graphs w ith an odd num ber of extemal -legs vanish. In particular, no vertex ${ }^{3}$ is generated by renorm alization.
 the xed points as discussed below.

Further sim metries are the $g!1=g$ dualties, whidn I present after xing som e other notation.

for som e I only, we change the sign of the corresponding coupling ${ }_{I}$. So, we can assum e that all of the is are non-negative.
$R$ enorm alization. The eld has no propagator at the classical level, but has a propagator proportional to $1=\overline{\mathrm{k}^{2}}$ at the quantum level, generated by the ferm ion bubble. The theory is de ned using the P arisi large $N$ approach of ref. $\underline{2 R}_{1}^{-1}$. The eld has, by de nition, the sam e dim ension as the ferm ions, nam ely ( $d \quad 1$ ) $=2$.

Since the theory is classically conform al, we can choose the classically conform al subtraction schem e, in which the linear divergences are just ignored, which is equivalent to say that the renorm alized ferm ion $m$ ass and the renorm alized expectation value of vanish.

The dim ensional regularization ( $d=3 \quad$ ") and the $m$ in $m$ al subtraction schem e are used. H aving chosen doublets of com plex spinors, we can set the trace of an arbitrary odd num ber of gam $m$ a $m$ atrioes to zero. The sym $m$ etries listed in the previous paragraph are $m$ anifestly preserved at the quantum level.

It $w$ as show $n$ in $[\underline{1}[1]$ that the naive dim ensional-regularization technique does not $w$ ork properly, because the ferm ion bubble generates a -propagator proportional to $1=\left(k^{2}\right)^{2} d=2$, which is responsible for the appearance of $[0] s$ at the subleading orders. To properly regularize the theory, it is necessary to $m$ anually convert the -propagator to $1=\frac{\mathrm{k}}{\mathrm{k}^{2}}$. This can be achieved adding an RG-invariant evanescent non-local term to the lagrangian.
$W$ e choose a preferred set of ferm ions, say $I=0$, as a reference for the large $N$ expansion. W e de ne $\quad 0, N \quad N_{0}, ~ i \quad{ }_{i}^{0}$, etc. W e take $N$ large, $w$ ith $r_{J}=N_{J}=N_{0} r \quad J={ }_{J}^{2}={ }_{0}^{2}$ and

D ualities. The duality sym $m$ etries of the theory are related to the exchanges of ferm ions belonging to di erent sets [ī]. First of all, the theory is evidently sym $m$ etric under the exchange of $I$ with $J$ with $I_{\text {; }} J>0$, which means $I \$ \quad J \quad{ }_{I} \$ \quad J$ and $r_{I} \$ r_{J}$.

Let us now exchange the $I$ th set of ferm ions, $I>0$, w ith the zeroth set of ferm ions. The theory is sym $m$ etric under the duality transform ation

I now prove that, w thout loss of generality, we can take all of the $s$ to have values betw een zero and one. Suppose that $1>1$. (If $1 \quad 1$ then skip to 2 .) For practical convenience, this theory will be called $F \quad{ }_{N} \quad$ henceforth. H ere $N_{f}$ is the total num ber ofdecoupled ferm ions ( $\mathrm{I}=0$ ) and N is the totalnumber offerm ionscoupled to w th $\mathrm{I}=1 . \mathrm{T}$ he theory $[2,-\mathrm{G})$ has an enhanced avor symmetry group $\mathrm{O}\left(4 \mathrm{~N}_{\mathrm{f}}\right) \mathrm{O}(2 \mathrm{~N}) \mathrm{O}(2 \mathrm{~N})$. $T$ he conform al eld theory $F \quad N$ coincides $w$ ith the $U V$ xed point of the four-ferm ion $m$ odels

Follow ing [1] [1] these conform al eld theories can be form ulated per se, in a classically conform al fram ew ork, w ith no reference to a ow originating them as its large- or sm all-distance lim it.

The zeroth order of the large N expansion. The -propagator is dynam ically generated by the one-loop ferm ion bubble (graph (a) of Fig. 1) and reads

To the leading order of the large $N$ expansion the quantum action reads
$T h i s$ is a G aussian theory, w ith a non-local kinetic term for. The couplings are inert and no ow takes place. In this $\lim$ it, the $U V$ and $\mathbb{R}$ xed points are indistinguishable, and the constant $D\left(J ; r_{J}\right)$ can be reabsorbed in . It is $\mathrm{m} m$ ediate to check that the zeroth-order


The rst order of the large $N$ expansion. TheRG ow can be inspected com puting the O ( $1=\mathrm{N}$ ) corrections. T he relevant graphs are the one-loop ferm ion self-energy and the one-loop vertex (see Fig. 1) [11미]. A tw o-loop graph (d) containing a ferm ion triangle could in principle contribute to the vertex, but it is zero because of the conservation of chirality.

A fter resum $m$ ing the ferm ion bubbles, the num ber of relevant graphs becom es nite at each order of the $1=N$ expansion. This $m$ eans that the $I$-dependence can be determ ined exactly, order by order in the $1=\mathrm{N}$ expansion. M oreover, this know ledge is su cient to connect the xed points, so that it is possible to write 1 -exact beta functions and correlation functions to any given order of the $1=\mathrm{N}$ expansion. The order-O ( $1=\mathrm{N}$ ) expressions of the beta functions and anom alous dim ensions allow us to resum the leading logs (see next section).

The order-o $(1=\mathrm{N})$ renorm alization constants can be w ritten using the results of [1]-1] and read

$w h e r e t=\ln \dot{x} j$ and $\dot{x} j$ is the overall scale of the correlation function. This equation can alw ays be solved im plicitly in the form $t=t()$. In general, the function $t()$ can be inverted only num erically, but in the sim plest case ( $K=1, r_{1}=1$ ) it can be inverted also explicitly. The solution is then

## 3 C orrelation functions in ferm ion models

In this section I show how the integration of the RG ow allows us to w rite all correlation functions exactly in to any given order in $1=\mathrm{N}$. H ere it is understood that $\ln \mathrm{N}$, because the powers of (ln ) $=\mathrm{N}$ are resum m ed. In particular, to w rite the correlation functions at the leading-log level, it is su cient to know the beta function and renorm alization constants to the order $1=\mathrm{N}$. For concreteness, $I$ choose $K=1$ and $r=1$. $T$ his $m$ odel has two sets of ferm ions,
0 and ${ }^{1}$, and one coupling constant.

A particularly simple lim it is the case in which the $r_{I} s$ are zero. The is are not necessarily positive and $V_{6}\left({ }^{\prime}\right)$ denotes a potential term of the form ${ }^{\prime}{ }^{6}$ induced by renorm alization.

and so can be reabsorbed with an (im aginary) translation of the eld. T his is equivalent to say that $[\overline{6}-\overline{1})$ is \trivial" because proportional to the eld equation. The eld equation form ally sets the com posite operator ' ${ }^{2}$ to zero, but does not trivialize the theory. M ore details on the use of the eld equation can be found in the appendix.

The theory is classically conform al and we choose the classically conform al subtraction schem e, in which the renorm alized ${ }^{2}{ }^{2}$-and ${ }^{4}$ term $s$ are set to zero by default.

The -propagator is generated by the one-loop scalar bubble, which is proportional to $\left(k^{2}\right)^{d=2} 2$. If unm odi ed, a propagator $\left(k^{2}\right)^{2 d=2}$ generates [0]s at the subleading orders. It is therefore necessary to add an evanescent, RG-invariant, non-local term to the lagrangian and convert the propagator to $\overline{\mathrm{k}^{2}}$. Thism eans, in particular, that the eld has dim ension $(\mathrm{d}+1)=2$ and $\mathrm{B}_{\mathrm{B}}=\quad$ " $=2$. The $O(1=\mathrm{N})$ diagram s are the sam e as in F ig. $1 . \mathrm{T}$ he diagram ( d ) does not vanish identically, but is nite. Finally, the $O(1=N)$ results for , and are equal to those of the $F{ }_{\mathrm{N}} \mathrm{m}$ odels $(\underline{2}-\overline{1})$, w th the replacem ent N ! $\mathrm{N}=4$.
 classically conform al substraction schem $e$, and therefore assum e that the term $s$ of the form , 2 and ' 4 are subtracted aw ay by default. H ow ever, nothing forbids the generation of term $s$ of the form ' ${ }^{6}$ and this tim e they cannot be rem oved w ith a translation of the eld . The reason is that multiplies

I have dropped vertices of the form, 42 and ${ }^{2} 4$, since they can alw ays be reabsorbed w ith a translation while keeping duality m anifest. T he rem aining $\mathrm{V}_{6}$-vertioes are redundant (one su ces), but cannot be reduced to a single vertex in the fill space of param eters using the - eld equation. W e have to divide the param eter space into two charts, one contaning $g=0$ and the other containing $g=1$. In the rst chart, the ${ }^{6}$ vertex is trivial and can be reabsorbed into a translation. H ow ever, the ${ }^{6}$ vertex cannot be reabsorbed into a translation at the point $g=0$. Therefore, in the rst chart we rem ove the ${ }^{\prime}{ }^{6}$ vertex setting $60=0$ and take 06 as the unique $\mathrm{V}_{6}$-coupling. In the second chart, which contains $\mathrm{g}=1$, we have a sym m etric situation: the ${ }^{6}$ vertex can be reabsorbed aw ay, but the ${ }^{6}$ vertex cannot, so we set $06=0$ and the true coupling is 60 .

In each chart we have an appropriate specialization of the duality transform ation ( 6.5 exam ple, when we apply dually in the rst chart, we transform the potential $60^{\prime}{ }^{6}=\mathrm{N}^{2}$ into $e_{60}{ }^{6}=\left(N^{2} r^{2}\right)$. Then, we can use the - eld equation ${ }^{2}=,{ }^{2}=g$ and rew rite the potential as $e_{60}{ }^{\prime}=\left(r^{2} g^{3} N^{2}\right)$. i) The graphs contributing to the renorm alization of the scalar propagator are obtained from $G_{4 ; 2}$ suppressing the four extemal scalar legs exiting from the sam e six-leg vertex. We obtain the graph (b) off ig. 1 plustadpoles, nite graphs and a graph w ith a scalarbubble (from the third of $F$ ig. 4). This graph should not be counted, since the scalar bubbles are resum $m$ ed into the -propagator.

Fixed points. At $g=1$ and $g=0$ we work in the rst and second chart, respectively, and nd the beta function of ref.s [1] [1], nam ely

Thesolutions of $60=0$ are $60=0$ and $60=1$. At $60=0$ the xed point is the direct product ofan $S \mathrm{Nr}$ modeland N free scalars. At $60=1$ the xed point is the direct product of $S \mathrm{Nr}$ and the interacting ${ }_{3}^{6}$ xed point. In both cases, the avor symmetry group is $O(\mathbb{N}) \quad 0$ (Nr). $T$ he negative values of 60 and 60 are unphysical at $g=1$ and $g=0$, becuse the potential is unbounded from below.

Forg=1 we have

The equation $60=0$ has three real solutions, tw o positive and one negative. For r ! 1 the largest positive solution tends to 1 from above, the second positive solution 60 tends to $0^{+}$ and the negative solution tends to 0 .

The xed point $(9 ; 60)=(0 ; 1)$ is $U V$ unstable, while the xed points $(1 ; 0)$ and ( $1 ; 60)$ are $\mathbb{R}$ stable. $T$ he other xed points are partially stable and partially unstable.

TheRG ow s are plotted in F ig. 3. Since at $g=0$ the negative values of 60 are unphysical, we can argue that the unphysical region is the region below the line connecting the three xed points with 600 .

A particularly simple case is the lim it r! 1 , where 60 is independent of $g$ and coincides $w$ ith ( $\left.\overline{6}^{-} .9\right)$. H ere the RG ow s of $g$ and 60 separate.

## 7 C onclusions

In the realm of high-energy physics, classically conform al theories play a special role. Taking inspiration from $m$ assless Q CD, where hadrons and glueballs acquire $m$ asses dynam ically, it is tem pting to think that the ultim ate theory of the universe contains no dim ensionfulparam eter of classical origin, the classically conform al subtraction schem e should be universally used and the dynam ical generation of a scale by dim ensional transm utation originates all scales and dim ensionfulparam eters of nature, including the N ew ton constant.

A nother context in which the specialness of classically conform al theories is singled out, at least in even dim ensions, is the irreversibility of the RG ow. It would be interesting to know if the RG ow is irreversible also in odd dim ensions. The ow s of this paper are used for this investigation in ref. [1]

It is useful to have a large class of classically conform alm odels to test ideas around the issues just $m$ entioned and the strongly-coupled lim it of quantum eld theory. I believe that the $m$ odels studied in this paper can help us answ ering various unsolved problem $s$ and have a num ber of potential applications, $m$ aybe also in condensed-m atter physics.

I have explored tw o classes of theories, describing sets of ferm ions and scalar elds interacting by means of a - eld, with a variety of xed points, known and new. Typically, both end points of the ows are interacting conform al eld theories. The rem arkable properties of these theories are that i) at each order of the $1=\mathrm{N}$ expansion the RG ows can be integrated for arbitrary values of the running couplings; ii) \exact" beta functions, anom alous dim ensions and correlation functions interpolating betw een the $U V$ and $\mathbb{R}$ conform al lim its can be written; iii) the $m$ odels have $m$ an ifest $g!1=g$ dualities at each order of the $1=N$ expansion. D uality puts severe constraints on the form ulas and is a pow erfult tool to check the calculations. In special lim its ( $r$ ! 0 in the ferm ionic $m$ odels, $r$ ! 1 in the scalar $m$ odels) the integration of the ow equations further simpli es, yet the ow rem ains non-trivial.

A ppendix: diagram $m$ atics and duality in the scalar $m$ odels
$T$ he graphs contributing to the renorm alization of ${ }^{6}$ to the order O ( $1=\mathrm{N}$ ) are shown in Fig. 4. Som e diagram s have obvious countenparts $w$ ith two, four and six extemal -legs. The divergent tem sproportional to ${ }^{\prime 2}{ }^{4},{ }^{\prime 4} 2$ and ${ }^{6}$ are converted to ${ }^{6}$ using the - eld equation ${ }^{2}+\mathrm{g}^{2}=0$. (For subtleties in the use of this eld equation see below.) Several diagram sare nite, but have been draw $n$ for com pleteness.

The beta function ( $\overline{6} \cdot \overline{1})$ is invariant under the duality sym $m$ etry ( $(\overline{6} . \overline{6})$ and ( $\overline{6} . \overline{2})$. H ow ever, the renorm alization constant $Z_{60}$ is not. The com plete expression of $60 Z_{60}$ is very long and contains term swith the rst three powers of 60 plus a term independent of 60 . Here I focus on the term sproportional to ${ }_{60}^{3}$, for sim plicity, which are

Expanding $\left.\quad m "=(m)^{\prime}\right)$ as $1=\left(m^{\prime \prime}\right) \quad$ ln we see that the term sproportional to $\ln$, which contribute to the beta function, transform correctly under duality, while the pole term s , which have no physical signi cance, do not transform correctly.
$T$ hese facts are explained as follow $s$. T he sym $m$ etry of the theory under the duality trans form ation $(\overline{6} . \overline{6} . \overline{1})$ in the rst chart understands the use the eld equation. Naively, the eld equation is ${ }^{\prime 2}+g^{2}=0$, but the $m$ odi ed regularization technique of $[\overline{1}[1]$ dem ands to add the non local tem

T he evanescent right-hand side of this form ula provides extra vertioes which do contribute to the pole term s. H ow ever, these corrections are alw ays proportional to

for some $m_{1}$ and $m_{2}$ and so do not a ect the $\ln$ terms. This fact can be easily veri ed in a num ber of exam ples. M oreover, the term $s$ proportional to the eld equation $S=$ cannot be neglected. They give other contributions of the form (7, (1), which can be easily com puted functionally integrating by parts. Putting these ingredients together, we discover that the $m$ ism atch betw een $Z_{60}$ and its dual is due to the use of the eld equation and the di erence between the naive and regularized eld equations. It is not a lengthy work to $m$ ake a quantitative check for the term $s(70)$. T he im portant point is that the $m$ ism atch has no physical signi cance. W e can neglect these nuisances if we lim it ourselves to check duality w ithin the physical quantities.
