\INTEGRABILITY "OF RG FLOW SAND DUALITY IN THREE DIMENSIONS IN THE 1/N EXPANSION

A bstract

I study some classes of RG ow s in three dimensions that are classically conform aland have manifest g ! 1=g dualities. The RG ow interpolates between known (four-ferm ion, W ilson-Fischer, $\binom{6}{3}$) and new interacting xed points. These models have two remarkable properties: i) the RG ow can be integrated for arbitrarily large values of the couplings g at each order of the 1=N expansion; ii) the duality symmetries are exact at each order of the 1=N expansion. I integrate the RG ow explicitly to the order O (1=N); write correlators at the leading-log level and study the interpolation between the xed points. I exam ine how duality is implemented in the regularized theory and veri ed in the results of this paper.

1 Introduction

In three-dimensional quantum eld theory it is often possible to derive non-perturbative results using a large N expansion. Typically, N is the number of scalar elds or fermions. To a given order of the 1=N expansion in nitely many graphs can be collected by means of simple resummations and the resulting number of elective graphs is nite. In some cases it is not necessary to assume that the couplings g of the theory are small and expand perturbatively in g, but it is possible to calculate the exact g-dependence at each order of the 1=N expansion. Then, the computation of a nite number of elective graphs allow sus to integrate the RG ow and study the interpolation between the xed points. If the theories satisfy a duality g \$ 1=g, then this symmetry is implemented exactly at each order of the 1=N expansion. The purpose of this paper, which is an elaboration of the ideas of ref. [1], is to study a variety of models with these features.

Speci cally, I study two classes of ow s. The rst class of m odels involves K + 1 sets of N_I, I = 0;1;:::K, ferm ions interacting by means of a - eld, that is to say a dynam ical source for a composite operator. The source is called dynam ical because the functional integral is performed also over . The large N limit is obtained by assuming that the numbers N_I of ferm ions tend to in nity with equal velocity. At the leading order of the 1=N expansion the RG ow is trivial, in the sense that the UV and IR xed points are indistinguishable. A nontrivial RG ow appears at the level of O (1=N) corrections. In the simplest version of these m odels, the xed points of these ows coincide with the UV xed points of the four-ferm ion m odels [2, 3] plus decoupled m assless ferm ions. In a variant of these m odels there are also xed points of new type.

The second class of models is a scalar-eld counterpart of the rst class. Sets of scalar elds interact by means of a -eld. Due to the radiative corrections, '⁶-potential terms are generated. The RG structure of these own is more involved and the xed points include known conform all eld theories (W ilson-Fischer, '⁶₃ xed points) and new ones.

The theories satisfy certain duality symmetries, associated with the exchange of fermions (or scalars) belonging to dierent sets. The duality symmetries are exact at each order of the 1=N expansion. Nevertheless, due to some subtleties of the regularization technique [1], the implementation of the duality symmetry at the regularized level needs to be studied carefully.

The integration of the RG ow allows us to write all correlation functions exactly in g to a given order in the 1=N expansion. I stress again that the expansion is not around one xed point. Norm ally, an in nite resum mation is necessary to reach an interacting xed point from a Gaussian xed point. Here, instead, the entire RG ow is expanded at the same time in 1=N and no expansion is made in the running couplings g. At each order of the 1=N expansion the xed points and the ow are determined with equal and consistent precision. Typically, both the UV and IR xed points are interacting.

The large N expansion is crucial to make the integration of the RG ow possible as described. To the order O (1=N), the integration of the RG ow is equivalent to the resummation of the leading logs, but in general (in QCD and non-Abelian Yang-M ills theory with matter, for example) the resum m ation of the leading logs is not su cient to connect the UV and \mathbb{R} xed points, or the high-and low energy lim its of the theory, although it gives a sort of result beyond the perturbative expansion.

A known theory exhibiting some of the features of the models studied here is the large N ${}^{6}_{3}$ theory. As a classically conform al (tricritical) theory, it is IR free and its 0 (1=N)-order beta function has a nontrivial ultraviolet xed point [7]. The ${}^{6}_{3}$ theory, how ever, does not have a duality symmetry. V iewed as a particular case of the models analysed in this paper, it belongs to a more general family of theories which do satisfy duality.

In the study of critical phenom ena, stability puts som e lim its on the values of the $\binom{6}{3}$ coupling [8] and the UV xed point of [7], which lies in the instability region, is superseded by a di erent xed point. No attempt is made here to apply the approach of [8] to the models of this paper. This study is left to a separate research, in view of the possible interest of these theories for condensed matter physics. In this paper I study only the tricritical dom ain.

O ther types of \exact" results about RG ows exist in the literature. For example, in fourdimensional supersymmetric theories it is often possible to write an exact beta function [4]. The NSVZ beta function, however, depends on the subtraction scheme and the present know ledge of this scheme does not allow us to integrate the RG ow. The NSVZ formula can be used to obtain exact results about the xed points [5, 6].

Since the models treated here are classically conformal, it is possible to work with a classically conformal subtraction scheme. In practice this means that, by default, the linear and quadratic divergences are subtracted away, i.e. the associated renormalized dimensionful coupling constants are set to zero. This is automatic in the framework of the dimensional regularization. I recall that in these theories the naive dimensional regularization has to be modiled adding an evanescent, RG invariant, non-local term to the lagrangian [1].

The RG ow is scheme independent to the order O (1=N). Scheme dependences appear at the order O (1=N²), but scheme-independent correlation functions can be written to arbitrary order in the 1=N expansion.

The models of this paper have been inspired by the study of the irreversibility of the RG ow [9]. This research singles out, in even dimensions, the specialness of classically conformal theories. In odd dimensions the investigation of the irreversibility of the RG ow is more di cult, since we miss the tools provided, in even dimensions, by the embedding in external gravity. It is useful to construct a large class of classically conform al theories as a laboratory to test some ideas on this issue. The interpretation of [10] suggests a more physical choice for the expansion parameter, which is the scheme-invariant area of graph of the beta function between the xed points, de ned as

where is the trace of the stress tensor. The study of the quantity a^{0} is left to a separate work [11], where the implications on irreversibility are discussed.

In section 2 the ferm ionic m odels are studied in detail. In section 3 correlation functions are

com puted explicitly and the RG interpolation between the xed points is studied. In section 4 I solve a particularly simple, but non-trivial, limit, in which the ratios N_I=N₀ are sent to zero after the large N expansion. In section 5 I study the models with two-component spinors, which have peculiar features and xed points of new type. Section 6 is devoted to the study of the scalar models, their beta functions, anom alous dimensions and ows. Section 7 contains the conclusions. In the appendix I discuss some subtleties concerning the implementation of the duality symmetry in the framework of the model ed dimensional-regularization technique of ref. [1].

2 Ferm ion models

The model we study was de ned in ref. [1] and describes K + 1 sets of (N₀;:::;N_K) ferm ions interacting by means of a - eld. The lagrangian is

To simplify various arguments, I rst choose four-component complex spinors. The generalization to models with two-component spinors, which have xed points of new type, is discussed later. I work in the Euclidean framework, where and ^Y are independent from each other. The gamma matrices are Hermitian and $= {}^{Y}{}_{3}$. A basis with ${}^{T}{}_{1,3} = {}_{1;3}$ and ${}^{T}{}_{2} = {}_{2}$ is used for charge conjugation (see below). The matrices ${}_{4}$ and ${}_{5}$ of the four-dimensional D irac algebra act on our spinors as avour matrices. Since the fundamental spinor in three dimensions is real (M a prana) and has two components, a set of N f massless four-component complex spinors has a avour symmetry O (4N f), while a set of N f massive four-component complex spinors has symmetry O (2N f) O (2N f): For other details see for example [3]. The eld is a sort of dynamical fermion mass, but our fermions are otherwise massless. The expectation value is zero in the classically conform all phase.

Sym m etries. The theory ism anifestly invariant under re-ection positivity (Herm itian conjugation combined with a sign-change of the \pm coordinate x_3), parity, charge conjugation and tim e-reversal. The P,C and T transform ations are

Further symmetris are obtained replacing $_4$ with $_5$. It is understood that, unless otherwise stated, the transformation of $\overline{}$ is obtained from the one of as if y were the adjoint of . In the list above, only time reversal requires to transform and y independently.

The theory is also invariant under the chiral transform ation

and the analogous transform ation with $_4$! $_5$: A consequence of chiral invariance is that the graphs with an odd number of external -legs vanish. In particular, no vertex ³ is generated by renorm alization.

The global symmetry group of the theory (2.1) is ${}^{N}{}_{I=0}{}_{I=0}$ (O (2N I) O (2N I)), enhanced at the xed points as discussed below.

Further simmetries are the g ! 1=g dualities, which I present after xing some other notation.

If we perform a transform ation

for some I only, we change the sign of the corresponding coupling $_{I}$. So, we can assume that all of the $_{I}$ s are non-negative.

R enormalization. The eld has no propagator at the classical level, but has a propagator proportional to $1=\frac{p}{k^2}$ at the quantum level, generated by the ferm ion bubble. The theory is dened using the Parisi large N approach of ref. [2]. The eld has, by denition, the same dimension as the ferm ions, namely (d 1)=2.

Since the theory is classically conform al, we can choose the classically conform al subtraction scheme, in which the linear divergences are just ignored, which is equivalent to say that the renorm alized ferm ion m ass and the renorm alized expectation value of vanish.

The dimensional regularization (d = 3 ") and the minimal subtraction scheme are used. Having chosen doublets of complex spinors, we can set the trace of an arbitrary odd number of gamma matrices to zero. The symmetries listed in the previous paragraph are manifestly preserved at the quantum level.

It was shown in [1] that the naive dimensional-regularization technique does not work properly, because the ferm ion bubble generates a -propagator proportional to $1=(k^2)^2 d^{=2}$, which is responsible for the appearance of [0]s at the subleading orders. To properly regularize the theory, it is necessary to manually convert the -propagator to $1=\frac{k^2}{k^2}$. This can be achieved adding an RG-invariant evanescent non-local term to the lagrangian.

We choose a preferred set of fermions, say I = 0, as a reference for the large N expansion. We de ne $_0$, N N $_0$, $_i$ $_i^0$, etc. We take N large, with $r_J = N_J = N_0$, $_J = \frac{2}{J} = \frac{2}{0}$ and

The couplings $_J$ are exactly dimensionless. We de ne their renormalization constants by $(_I)_B = _I Z_I$. The renormalized Lagrangian reads

D ualities. The duality sym m etries of the theory are related to the exchanges of ferm ions belonging to di erent sets [1]. First of all, the theory is evidently sym m etric under the exchange of I with J with I; J > 0, which means $_{I}$ \$ $_{J}$, $_{I}$ \$ $_{J}$, and r_{I} \$ r_{J} .

Let us now exchange the Ith set of ferm ions, I > 0, with the zeroth set of ferm ions. The theory is symmetric under the duality transform ation

with $J \in I$;0. The norm alization condition (2.4) is duality invariant. The transform ation (2.5) will be called \the Ith duality transform ation".

I now prove that, without loss of generality, we can take all of the s to have values between zero and one. Suppose that $_1 > 1$. (If $_1$ 1 then skip to $_2$.) The rst duality transform ation changes $_1$ to $_1^0 = 1 = _1 < 1$ and $_I$ to $_I^0 = _I = _1$ for I > 1. Now suppose that $_2^0 > 1$. (If $_2^0$ 1 then skip to $_3^0$.) The second duality transform ation changes $_1^0 < 1$ to $_1^0 = _1^0 = _2^0 < 1$, $_2^0$ to $_2^0 = 1 = _2^0 < 1$ and $_I^1$ to $_I^0 = _1^0 = _2^0$, for I > 2. The important point is that the duality transform ation sends couplings with values 1 into couplings with values 1. C learly, after at most K steps we have 0 $_I$ 1 for every I.

In conclusion, it is not restrictive to assume

For practical convenience, this theory will be called F $_{\rm N}$ henceforth. Here N $_{\rm f}$ is the total number of decoupled fermions ($_{\rm I}$ = 0) and N is the total number of fermions coupled to with $_{\rm I}$ = 1. The theory (2.6) has an enhanced avor sym metry group O (4N $_{\rm f}$) O (2N) O (2N). The conform all eld theory F $_{\rm N}$ coincides with the UV xed point of the four-fermion models




Figure 1:0 rder 0 (1=N) graphs

Following [1] these conform al eld theories can be formulated per se, in a classically conform al fram ework, with no reference to a ow originating them as its large-or small-distance limit.

The zeroth order of the large N expansion. The -propagator is dynam ically generated by the one-loop ferm ion bubble (graph (a) of Fig. 1) and reads

To the leading order of the large N expansion the quantum action reads

This is a Gaussian theory, with a non-local kinetic term for . The couplings are inert and no ow takes place. In this limit, the UV and IR xed points are indistinguishable, and the constant D ($_{\rm J}$; $r_{\rm J}$) can be reabsorbed in . It is immediate to check that the zeroth-order expression (2.9) of is invariant under the duality transform ation (2.5).

The rst order of the large N expansion. The RG ow can be inspected computing the O (1=N) corrections. The relevant graphs are the one-loop ferm ion self-energy and the one-loop vertex (see Fig. 1) [1]. A two-loop graph (d) containing a ferm ion triangle could in principle contribute to the vertex, but it is zero because of the conservation of chirality.

A fler resum m ing the ferm ion bubbles, the number of relevant graphs becomes nite at each order of the 1=N expansion. This means that the $_{\rm I}$ -dependence can be determined exactly, order by order in the 1=N expansion. Moreover, this know ledge is su cient to connect the xed points, so that it is possible to write $_{\rm I}$ -exact beta functions and correlation functions to any given order of the 1=N expansion. The order-O (1=N) expressions of the beta functions and anom alous dimensions allow us to resum the leading logs (see next section).

The order-O (1=N) renorm alization constants can be written using the results of [1] and read

Solution of the RG equations. The RG ow can be integrated immediately in the space of couplings. We have

3 Correlation functions in ferm ion models

In this section I show how the integration of the RG ow allows us to write all correlation functions exactly in to any given order in 1=N. Here it is understood that ln N, because the powers of (ln)=N are resummed. In particular, to write the correlation functions at the leading-log level, it is su cient to know the beta function and renorm alization constants to the order 1=N. For concreteness, I choose K = 1 and r = 1. This model has two sets of ferm ions, 0 and 1 , and one coupling constant .

The two-point function. Using the Callan-Sym anzik equations we know that the two-point function has the form




Figure 2: Renorm alization of the operator 2

The calculation of the order-O (1=N) anom alous dimension of ² requires the evaluation of the divergent parts of two two-loop diagram s with a ferm ion loop (see Fig. 2). Since both the ferm ions with I = 0;1 circulate in the loops, the result is multiplied by 1 + ². Since there are two -propagators in these diagram s, the result has also a factor 1=(1 +)². We obtain, taking into account of the combinatorial factor and the number of ways in which the ferm ions can circulate in the loop,

O ther correlation functions. The integration of the RG ow solves the -dependence and allows us to write the correlation functions exactly in to any given order in 1=N. In this expansion, if s denotes the overall scale of the correlation function, $\ln s$ is considered of order N and the powers of $(\ln s)=N$ are resummed. In the previous paragraph I have considered two-point functions explicitly, but the procedure is general.

A particularly simple limit is the case in which the $r_{I}s$ are zero. Setting $r_{I} = 0$, I = 1; :::K, after expanding in 1=N is not equivalent to kill the ferm ions with I = 1; :::K. The large N and r_{I} ! 0 limits conject and leave a non-trivial remnant. When $r_{I} = 0$, however, duality is not manifest. We can see this immediately from the expression of the beta function:

5 M odels with two-component spinors and new xed points

Let us now consider a variant of the model (2.1) in which the spinors have two complex com ponents instead of four.

We have no chiral invariance (2.2) and the transform ation (2.3) does not apply. For this reason, the signs of the couplings g_I cannot be assumed to be positive. The P and T transformations are modied as follows:

The construction of the theories S $_{\rm N}$ follows the lines of the construction of the ferm ionic theories F $_{\rm N}$ of [1]. A caveat is that renorm alization generates a '⁶ term. Due to the O (N) symmetry, this term can only have the form

The eld equation form ally sets the composite operator \prime^2 to zero, but does not trivialize the theory. More details on the use of the eld equation can be found in the appendix.

The theory is classically conform all and we choose the classically conform all subtraction scheme, in which the renorm alized $'^2$ - and $'^4$ -term s are set to zero by default.

The -propagator is generated by the one-loop scalar bubble, which is proportional to $(k^2)^{d=2}$. If unm odi ed, a -propagator $(k^2)^2 d=2$ generates [0]s at the subleading orders. It is therefore necessary to add an evanescent, RG-invariant, non-local term to the lagrangian and convert the -propagator to k^2 . This means, in particular, that the eld has dimension (d + 1) = 2 and $B = \frac{m-2}{2}$. The O (1=N) diagram s are the same as in Fig. 1. The diagram (d) does not vanish identically, but is nite. Finally, the O (1=N) results for r and are equal to those of the F N models (2.7), with the replacement N ! N =4.

The running S $_{\rm N}$ models. Let us now consider the theories (6.1). We can still use the classically conform all substraction scheme, and therefore assume that the terms of the form \prime^2 and \prime^4 are subtracted away by default. However, nothing forbids the generation of terms of the form \prime^6 and this time they cannot be removed with a translation of the eld . The reason is that multiplies

with m, n and p generic. It is therefore necessary to introduce the m ost general '⁶-vertices in the lagrangian, m ultiplied by independent couplings.

I have dropped vertices of the form \prime^{4} ² and \prime^{2} ⁴, since they can always be reabsorbed with a -translation while keeping duality manifest. The remaining V₆-vertices are redundant (one su ces), but cannot be reduced to a single vertex in the full space of parameters using the - eld equation. We have to divide the parameter space into two charts, one containing g = 0 and the other containing g = 1. In the rst chart, the \prime^{6} vertex is trivial and can be reabsorbed into a -translation. However, the ⁶ vertex cannot be reabsorbed into a translation at the point g = 0. Therefore, in the rst chart we remove the \prime^{6} vertex setting

 $_{60} = 0$ and take $_{06}$ as the unique V₆-coupling. In the second chart, which contains g = 1, we have a symmetric situation: the ⁶ vertex can be reabsorbed away, but the ^{'6} vertex cannot, so we set $_{06} = 0$ and the true coupling is $_{60}$.

In each chart we have an appropriate specialization of the duality transform ation (6.5). For example, when we apply duality in the rst chart, we transform the potential $_{60}$, $^{6}=N^{2}$ into $^{e}_{60}$, $^{6}=(N^{2}r^{2})$. Then, we can use the -eld equation $^{2}=$, $^{2}=g$ and rewrite the potential as $^{e}_{60}$, $^{6}=(r^{2}g^{3}N^{2})$. To recover the initial potential we de ne $^{e}_{60} = r^{2}g^{3}_{60}$, so that duality in the rst chart reads

To the order O (1=N), the '⁶ and ⁶ vertices have no e ect on the renorm alization of the scalar kinetic terms and the -scalar-scalar vertices. This can be proved observing that the relevant graphs are in one-to-one correspondence with the graphs of Fig. 4 contaning four scalar external legs exiting from the same six-leg vertex. I call these graphs $G_{4;2}$ for clarity.

i) The graphs contributing to the renorm alization of the scalar propagator are obtained from $G_{4;2}$ suppressing the four external scalar legs exiting from the same six-leg vertex. We obtain the graph (b) of Fig.1 plus tadpoles, nite graphs and a graph with a scalar bubble (from the third of Fig. 4). This graph should not be counted, since the scalar bubbles are resummed into the -propagator.

ii) The graphs contributing to the renorm alization of the -scalar-scalar vertices are obtained from $G_{4;2}$ replacing the four external scalar legs exiting from the same six-leg vertex with one external leg. We obtain the graphs (c) and (d) of Fig. 1 plus tadpoles and nite graphs.

In sum m ary, the order O (1=N) anom alous dimensions and beta functions are exactly the same as in (2.11), with N ! N=4. In particular, we have

The equation $_{60} = 0$ has three real solutions, two positive and one negative. For r ! 1 the largest positive solution tends to 1 from above, the second positive solution $_{60}$ tends to 0^+ and the negative solution tends to 0 .

The xed point (g; $_{60}$) = (0;1) is UV unstable, while the xed points (1;0) and (1; $_{60}$) are IR stable. The other xed points are partially stable and partially unstable.




Figure 3: The xed points and RG ow softhe scalar models

The RG ow s are plotted in Fig. 3. Since at g = 0 the negative values of $_{60}$ are unphysical, we can argue that the unphysical region is the region below the line connecting the three xed points with $_{60}$ 0.

A particularly simple case is the limit r! 1, where $_{60}$ is independent of g and coincides with (6.9). Here the RG ow s of g and $_{60}$ separate.

7 Conclusions

In the realm of high-energy physics, classically conform all theories play a special role. Taking inspiration from massless QCD, where hadrons and glueballs acquire masses dynamically, it is tempting to think that the ultimate theory of the universe contains no dimension fulparameter of classical origin, the classically conform all subtraction scheme should be universally used and the dynamical generation of a scale by dimensional transmutation originates all scales and dimensionfulparameters of nature, including the Newton constant.

A nother context in which the specialness of classically conform all theories is singled out, at least in even dimensions, is the irreversibility of the RG ow. It would be interesting to know if the RG ow is irreversible also in odd dimensions. The ows of this paper are used for this investigation in ref. [11].

It is useful to have a large class of classically conform almodels to test ideas around the issues just mentioned and the strongly-coupled limit of quantum eld theory. I believe that the models studied in this paper can help us answering various unsolved problem s and have a num ber of potential applications, maybe also in condensed-matter physics.

Ihave explored two classes of theories, describing sets of ferm ions and scalar elds interacting by means of a - eld, with a variety of xed points, known and new. Typically, both end points of the ows are interacting conform all eld theories. The remarkable properties of these theories are that i) at each order of the 1=N expansion the RG ows can be integrated for arbitrary values of the running couplings; ii) \exact" beta functions, anom alous dimensions and correlation functions interpolating between the UV and IR conform allimits can be written; iii) the models have manifest g ! 1=g dualities at each order of the 1=N expansion. Duality puts severe constraints on the form ulas and is a powerful tool to check the calculations. In special limits (r ! 0 in the ferm ionic models, r ! 1 in the scalar models) the integration of the ow equations further simplifies, yet the ow remains non-trivial.

Appendix: diagram m atics and duality in the scalar m odels




Figure 4: Renorm alization of $'^{6}$ in the scalar models

The graphs contributing to the renormalization of 6 to the order O (1=N) are shown in Fig. 4. Some diagrams have obvious counterparts with two, four and six external -legs. The divergent terms proportional to 24 , 42 and 6 are converted to 6 using the -eld equation 2 + g 2 = 0. (For subtleties in the use of this eld equation see below.) Several diagrams are nite, but have been drawn for completeness.

The beta function (6.7) is invariant under the duality symmetry (6.6) and (6.8). However, the renorm alization constant Z_{60} is not. The complete expression of ${}_{60}Z_{60}$ is very long and contains term s with the rst three powers of ${}_{60}$ plus a term independent of ${}_{60}$. Here I focus on the term s proportional to ${}_{60}^{3}$, for simplicity, which are

Expanding m'' = (m'') as 1 = (m'') in we see that the terms proportional to in , which contribute to the beta function, transform correctly under duality, while the pole terms, which have no physical signi cance, do not transform correctly.

These facts are explained as follows. The symmetry of the theory under the duality transformation (6.6) in the rst chart understands the use the eld equation. Naively, the eld equation is $r^2 + g^2 = 0$, but the modi ed regularization technique of [1] dem ands to add the non local term r_7 !

The evanescent right-hand side of this form ula provides extra vertices which do contribute to the pole term s. However, these corrections are always proportional to

for som e m₁ and m₂ and so do not a ect the ln terms. This fact can be easily veried in a number of examples. Moreover, the terms proportional to the eld equation S =cannot be neglected. They give other contributions of the form (7.11), which can be easily computed functionally integrating by parts. Putting these ingredients together, we discover that the m ism atch between Z₆₀ and its dual is due to the use of the eld equation and the di erence between the naive and regularized eld equations. It is not a lengthy work to m ake a quantitative check for the terms (7.10). The important point is that the m ism atch has no physical signi cance. We can neglect these nuisances if we lim it ourselves to check duality within the physical quantities.
