A lternative dim ensional reduction via the density matrix: A test

A bstract

We derive and analyze the perturbation series for the classicale ective potential in quantum statistical mechanics, treated as a toy model for the dimensionally reduced elective action in quantum eld theory at nite temperature. The rst few terms of the series are computed for the harm onic oscillator and the quartic potential.

1 Introduction

Recently, a procedure was devised to rew rite the density matrix of a quantum eld in thermal equilibrium at nite temperature T as the exponential of an elective action in one less dimension [1]. This procedure has been termed alternative dimensional reduction, to distinguish it from the conventional dimensional reduction that occurs at in nite T [2], the latter being a special case of the former. The construction of such a dimensionally reduced elective action (DREA) is in fact equivalent to the construction of a Landau-G inzburg \correspondence grained free energy from a microscopic Hamiltonian, which can be further analyzed using the powerful methods of renormalization group theory.

The construction of the DREA cannot, in general, be performed exactly. It requires the use of perturbation theory or a dressed-loop expansion. The purpose of this work is to perform such a construction in the simpler context of quantum mechanics, in order to test the accuracy of the truncated perturbation series for the classical elective potential $V_{\rm e}$, the quantum mechanical version of the DREA. The examples considered here are the harmonic oscillator and the quartic potential.

 $^{^3}$ B ecause we have such an objective in m ind, we shall not discuss the sem iclassical [3] or variational [4] expansion of V_e , which, although generally yielding better results than perturbation theory, are much harder to implement in quantum eld theory.

2 Density matrix and e ective classical potential

The diagonal elements of the thermal density matrix for a particle of mass main the presence of the potential V(x) can be written as a path integral [5, 6] (h = m = 1):

In the classical limit, the temperature is high and (= 1=kT) is small. In this case, it is reasonable to assume that the most important paths are those for which y() x. Then Eq. (1) can be approximated by

is the diagonal element of the density matrix for the free particle. Inserting Eq. (3) into Eq. (2) and integrating over x one obtains the classical partition function,

In order to improve the approximation (2) in a systematic way, we shall put y() = x + (), with (0) = () = 0, into Eq. (1) and compute the path integral perturbatively. Thus,

where \mathcal{V}_{x} () V(x+) V(x). Expanding the exponential in powers of \mathcal{V}_{x} (), we obtain

If $\hat{\mathbb{V}}_x$ () is a polynom ial in , one can compute the expectation values in Eq. (6) with the help of W ick's theorem :

Eq. (9) can be easily solved, yielding

where () is the Heaviside step function.

As a nalstep, we shall resum the terms in brackets in Eq. (6) into an exponential. The result can be cast as

The index c in the expectation values means that only connected diagrams, or cumulants, should be taken into account when applying W ick's theorem. 5

Equation (12) formally de nes the e ective classical potential $V_{\rm e}$ (x) as a power series in x, with one cients that are functions of the temperature. It is the quantum mechanical analogue of the Landau-G inzburg functional in statistical mechanics. In the next section we shall compute the rst few terms of the cumulant expansion of $V_{\rm e}$ (x) for the harmonic oscillator and the quartic potential.

3 Examples

3.1 Harm onic oscillator

As our st example, let us consider the harm onic oscillator:

The rst two cumulants give us

Inserting these results into Eq. (12) and computing the integrals we obtain

This result should be compared with the exact result for the harm onic oscillator,

One can easily check that Eq. (16) correctly reproduces the $\,$ rst few terms of the expansion of $\,$ V $_{\rm e}$, $_{\rm ex}$ (x) in powers of $\,$.

3.2 Quartic potential

Let us now consider the quartic potential:

$$V(x) = \frac{1}{4}x^4; \quad \hat{\nabla}_x(x) = \frac{1}{4}(x^4 + 4x^3 + 6x^2)^2 + 4x^3)$$

In this case, the expansion of the e ective classical potential in cumulants, Eq. (12), is also an expansion in powers of . Thus, to second order in , we have

$$V_{e}(x) = V(x) + \frac{1}{4} \int_{Z_{0}}^{Z_{0}} d^{h} h^{4}() i_{0;c} + 6x^{2}h^{2}() i_{0;c} + O(^{2})$$

The second term on the rhs. of Eq. (19) is analogous to the radiatively induced therm al mass in the massless ' 4 model in eld theory at nite temperature [7].

There occurs a problem when one computes the 0 (2) correction to V_e (x). It is a sixth degree polynom ial in x, with the coe cient of x 6 given by

It follows that if one discards cubic and higher order terms in in the expansion (12), one ends up with a classical elective potential which is unbounded from below, with the disastrous consequence that (x;x;) diverges as jxj! 1. One can remedy this problem by going to the next order in the expansion (12). At this level of approximation, V_e (x) is an eighth degree polynomial in x, the coefficient of the highest power of x now being a positive number, given by

Instead of expanding V_e (x) in powers of , one m ay expand it in powers of | a high tem perature expansion. Using W ick's theorem and the explicit form of G_0 (; 0), and making the change of variables $_j = _j^0$ in the integral below, one can easily show that

In term s of Feynm an diagram s, this m eans that a (connected) graph with V vertices and L lines gives a contribution to V_e (x) proportional to V_e 1. Thus, we have

$$V_{e}(\mathbf{x}) = \frac{1}{4}x^{4} + \frac{1}{4}x^{2} + \frac{2}{40} \cdot \frac{\frac{2}{24}x^{6}}{\frac{2}{40}x^{4}} + \frac{\frac{71}{3360}x^{2} + \frac{3}{80}x^{8} + 0(5)}{\frac{3}{360}x^{2} + \frac{3}{80}x^{8} + 0(5)}$$

Notice that the second and third order approximations to V_e (x) are unbounded from below, hence physically nonsensical. Therefore, like the expansion in powers of , the expansion in powers of cannot be truncated at an arbitrary order, but only at those orders for which the resulting approximation to V_e (x) is bounded from below.

4 Conclusions

The perturbative construction of the DREA in quantum mechanics is, therefore, equivalent to a perturbative expansion of the classical elective potential in powers of x. The construction yields a high-tem perature series in , or a series in the coupling constant , as shown in the quartic case.

The generalization to eld theories [1] will also yield perturbative expansions in powers of the \boundary" elds, i.e., the eld con gurations on the euclidean time boundaries at = 0 and = , a role played by x in quantum mechanics. The coe cients will, in general, depend on temperature, couplings, and on an ultraviolet cuto. The boundary elds are independent of the euclidean time (they only depend on spatial coordinates). Thus, their elective action accomplishes the dimensional reduction advertised. For practical applications, a truncation of the series will be required, just as in quantum mechanics.

There is, however, an additional complication in eld theory: the terms in the elective action are, in general, nonlocal in the boundary elds. The coe cient of the term involving n boundary elds is given by an n-point connected G reen function of the uctuations around a background" eld. The latter is de ned as the solution to the free eld equation of motion that interpolates between the boundary eld at = 0 and = (in our quantum mechanical examples, the background eld coincides with the boundary eld, both being given by x; in general, the background is -dependent).

Hopefully, both di culties | the need to truncate and the nonlocality | can be circum - vented in certain cases. Renorm alization theory will dictate the dependence of the coe cients on the ultraviolet cuto, so that nonrenorm alizable terms will probably not contribute in the continuum limit, leading to a natural truncation. If, in addition, we investigate the infrared limit, as in the study of critical behavior near phase transitions, we might restrict our attention to the zero momentum limit of the coe cients, and recover a local structure. In summary, we hope that the combination of ultraviolet and infrared limits will restrict the form of the elective action, and give us a Landau-G inzburg free energy of the expected form, whose parameters we will be able to compute from the underlying microscopic theory.
