D om ain wall lattices

We construct lattices with alternating kinks and anti-kinks. The lattice is shown to be stable in certain models. We consider the forces between kinks and antikinks and nd that the lattice dynam ics is that of a Toda lattice. Such lattices are exotic metastable states in which the system can get trapped during a phase transition.

D om ain walls are among the simplest topological defects known and have offen been used as a test-bed for studying non-perturbative e ects. An example of a dom ain wall is the \setminus ⁴ kink" trivially extended to three spatial dimensions. This solution is offen thought to typify all dom ain walls. However, it has recently become clear that the properties of ⁴ kinks do not simply carry over to m ore complicated systems [1, 2, 3, 4, 5, 6] including condensed matter system s such as He-3 [7]. Instead a much richer structure of kinks emerges. A swe show in this paper, the enhanced structure of kinks in SU (N) Z₂ (for odd N) allows for the construction of lattices of kinks and anti-kinks. In related models the kink lattice is also perturbatively stable.

The lattices we are constructing are di erent from other known lattices such as an Abrikosov lattice [8]. The total topological charge of an Abrikosov lattice is non-vanishing. In contrast, the kink lattice we will construct will have zero topological charge. This means that we can construct the kink lattice in a box with periodic boundary conditions, and also that the lattice is topologically equivalent to the vacuum . Hence if we start out in an unbroken symm etry phase, with vanishing net topological charge, there is a chance that, after the symm etry is spontaneously broken, the system will be trapped in the lattice phase instead of the true vacuum . From the lattice phase, the system can then only reach the true vacuum by quantum tunneling.

W e start with an SU (N) $\rm Z_2\,$ eld theory whose Lagrangian is:

where is an SU (N) adjoint and V () is invariant under

N 3 is taken to be odd, and the parameters in V are such that has an expectation value that can be chosen

to be

where, $n = (N \quad 1)=2, 1_p$ is the p p identity matrix and is an energy scale determ ined by the minima of the potential V. Such an expectation value spontaneously breaks the symmetry down to:

Wewill choose V () to be a quartic polynom ial:

where V_0 is a constant chosen so that the minimum of the potential has V = 0. The Lagrangian is symmetric under ! and it is the breaking of this Z₂ symmetry that gives rise to topological domain wall solutions. We could also extend the model by making it locally gauge invariant. The solutions described below will still be valid with the gauge elds set to zero; the stability analysis will change.

W hile our analysis can easily be carried out for general N, the physics is more transparent for a speci c choice of N. Hence we will choose N = 5 and, where relevant, remark on the case of general N¹. Then the desired symmetry breaking to

¹ The corresponding quartic m odel with N = 3 has an accidental SO (8) sym m etry. We could consider N = 3 if $(Tr(^3))^2$ and $Tr(^6)$ terms were added to the potential. We have chosen to work with quartic potentials and with the larger value of N.

The vacuum expectation value (VEV), $_{\rm 0}$ is (up to any gauge rotation)

In Refs. [1, 2, 3] it was found that there are several dom ain wall solutions in this model but a solution with least energy is achieved if $(1) = _0$ and

Two features of + are worthy of note. First, there is a minus sign in front. Thisputs + and in disconnected parts of the vacuum manifold. The second feature is that two blocks of entries of + are permuted with respect to those of . In other words, and + are related by a non-trivial gauge rotation. Furtherm ore, the kink solution (or, domain wall solution, in more than one dimension) can be written down explicitly in the case when h = 3=20 [1, 2]:

where $= m = \frac{p}{2}$. For other values of the coupling constants, the solution has been found num erically [1].

The topological charge of a kink can be de ned as

where $_{\rm R}$ and $_{\rm L}$ are the asymptotic values of the Higgs eld to the right (R) and left (L) of the kink. (The rescaling has been done for convenience.) Then the charge of the kink in eq. (11) is:

Similarly, one can construct kinks with charge matrices $Q^{(i)}$ (i = 1;:::;5) which have 4 as the ii entry and +1 in the remaining diagonal entries. Hence there are kink solutions with 5 di erent topological charge matrices. Individually, the kinks can be gauge rotated into one another. But when two kinks are present, the di erent charges are physically relevant. This is most easily seen by noting that the interaction between a kink with charge $Q^{(i)}$ and an antikink with charge $Q^{(j)} = Q^{(j)}$ is proportional to $Tr(Q^{(i)}Q^{(j)})$ [4]. Then we have

= +5 if $i \neq j$ (14)

The sign of the trace tells us if the force between the kink and antikink is attractive (m inus) or repulsive (plus). Hence the force between a kink and an antikink with different orientations (i \notin j) is repulsive. This observation is key to the construction of kink lattices.

In Ref. [4], the repulsive potential between a kink and an antikink at rest was derived. W hen the kink and antikink separation, R, is large, the result reduces to:

To construct a kink lattice, we now need to arrange a periodic sequence of kink charges such that the nearest neighbor interactions are repulsive. Kinks that are not nearest neighbors but are further apart will also interact, and perhaps even attract each other. However the forces between kinks and antikinks fall o exponentially fast and just taking nearest-neighbor interactions into account should be su cient, at least for lattice spacing larger than the kink width. So now we can write down a sequence of charges that can form a kink lattice. This is:

and the sequence just repeats itself. A Itemately, we could have a nite lattice if the kinks were in a compact space, such as a compact higher dimension, or the S¹ that arises in evaluating the partition function in statistical mechanics.

The sequence listed above is the minimum sequence for which the nearest neighbor interactions are repulsive. The repeating length of 6 kinks is independent of N in SU (N) since it is clear that we need at least, and no more than, 3 di erent kinds of kink charges.

A nother way to write the kink sequence is to write it as a sequence of Higgs eld expectation values. W e write this sequence for the above m inim al lattice:




FIG.1: The energy of the minimal lattice versus lattice spacing for h = 3 = 20, = 0.5 and = 1.

W e have constructed the solution for the m inim alkink lattice num erically on a space with periodic boundary conditions. In Fig. 1 we show the total energy of the m inim al lattice as a function of lattice spacing.

The m inimal lattice of 6 kinks is easily generalized to longer sequences. A sequence of 10 kinks in the N = 5 case is aesthetic in the sense that it uses all the 5 di erent charge m atrices dem ocratically:

Similarly one can construct sequences in the general N case.

W e have also num erically studied the dynam ics of the lattice by giving one of the kinks an initial velocity. W e nd that the kink scatters elastically on the neighboring anti-kink, and the motion propagates down the lattice.




FIG.2: A linear row of barm agnets placed N orth to N orth and South to South has an instability towards rotations in the transverse directions as shown.

Indeed, lattices of m asses interacting via exponentially decaying repulsive forces (see eq. (15)) have been studied in the literature and are known as Toda lattices [9]. Hence the kink lattice is a Toda lattice.

W e now discuss the stability of the lattice. A detailed stability analysis shows that the lattice in eq. (16) has three unstable modes, corresponding to rotations in the 1-3, 1-5, 3-5 blocks. To clarify the instability, we draw an analogy between the kink lattice and a lattice of bar magnets (Fig. 2). Each barm agnet on its own has a zero m ode that corresponds to rotations in three dim ensional space. W hen placed in the lattice shown in Fig. 2, rotational zero m odes turn into unstable m odes. Sim ilarly, an isolated kink has zero modes corresponding to rotations in gauge space { for example, a kink with charge Q_1 can be rotated into the kink with charge Q_3 without any cost in energy. W hen a kink of charge Q_1 is placed near an antikink of charge Q₃, the zero m ode becom es an unstable mode, making it favorable for Q_1 to rotate into Q_3 after which the kink and antikink can annihilate.

This understanding of the instability also suggests a resolution: if the rotational zero m odes are su ciently suppressed or absent, the lattice will become stable. To suppress the rotational zero m odes, we could break the

symmetry further so that the kink is no longer invariant under rotations. We can also consider a case where the zero modes are completely absent right from the start. We will discuss this latter case as it is simpler to deal with and provides an explicit example of a eld theory with stable kink lattices.

Consider the model with four real scalar elds,

+ $\frac{p}{5} f_{2} f_{4} - f_{1}^{2} - \frac{f_{2}^{2}}{3} + \frac{m^{2}}{4} \sum_{a=1}^{2} (20)$

This model has been obtained by truncating the eld occurring in eq. (1) to its diagonal elements. The elds f_1 and f_2 correspond to the diagonal generators $_3$ and $_8$ of SU (3) (see eq. (6)) in the G ell-M an basis, f_3 corresponds to the diagonal generator $_3$ of SU (2), and f_4 corresponds to the generator of U (1). Now our four eld m odel does not have the continuous SU (5) sym m etry of the m odel in eq. (1). The only remnant of the SU (5) sym m etry corresponds to the permutation of the ve diagonal entries of . In addition, the m odel also has the Z_2 sym m etry under which f_i ! f_i . Hence the m odel has an S_5 Z_2 sym m etry.

A vacuum of the model is given by $f_1 = 0 = f_2 = f_3$ and $f_4 \in 0$. This breaks the symmetry to $S_3 = S_2$, corresponding to permutations of in the SU (3) and SU (2) blocks. The vacuum manifold consists of 5! 2=3! 2!= 20 discrete points. If we x the vacua at x =

1, this in plies that there are 20 kink solutions in the model. All these 20 kink solutions have been described in Ref. [3].

The construction of kink lattices proceeds exactly as in the SU (5) case above because the o -diagonal components of vanish there. Hence the S₅ Z_2 model contains kink lattice solutions. Furtherm ore, these lattices are stable because the dangerous rotational perturbations are absent by the very construction of the model.

The occurrence of stable kink lattices with net vanishing topological charge in plies that there are m etastable states in the eld theory. Generally m etastable states are present in eld theories due to features in the potential. Here, how ever, the m etastable states are nonperturbative features of the m odel.

The existence of dom ain wall lattices is of interest in the context of phase transitions. W hat is the probability that a dom ain wall lattice will form during a phase transition? The answer depends on the complicated dynam ics of a dom ain wall network in three spatial dim ensions. For example, the model adm its wall junctions of




FIG.3: The distribution of H iggs expectation values in three dom ains can lead to a wall junction [5]. In the SU (5) m odel, the dashed line is a non-topological wall [3]. In the S_5 m odel the dashed line denotes a topological wall but without Z_2 charge.

the kind shown in Fig. 3 [5] and di erent walls can have di erent tensions. A simpler situation to consider is the form ation in one spatial dim ension for the S₅ m odel. W e rst note that the kinks with charge given in eq. (13) (and permutations thereof) are the lightest kinks in the system having Z₂ topology. O ther kinks will decay into these kinks upon evolution. So we can restrict our attention to a sequence of kinks with charges given in eq. (13) and permutations. Now let us assume that we have a kink with charge Q1. A neighboring antikink can have charge Q_1 , Q_4 or Q_5 (see eq. (17)). Of these only the rst is unsuitable for a lattice and has a probability 1/3. Therefore if the phase transition produces 2n kinks, then the probability of having exactly 2j kinks that annihilate and 2n 2j survive to form a lattice is derived by nding the number of ways of choosing the j annihilating pairs j surviving pairs and multiplying by the probaand n bility of annihilation (1/3) and survival (2/3). The result is that the probability of exactly j pairs annihilating is: ⁿC_j $(1=3)^{j}(2=3)^{n}^{j}$. Sum m ing this expression from j=03 gives the total probability for obtaining a latto n tice provided we have 2n kinks. The sum can easily be evaluated. The interesting lim it is when 2n is large. In that case, the probability tends to unity. Hence a kink lattice is certain to form if there are a large num ber of kinks. Further, the number of kinks is large if a large num ber of correlation dom ains are produced during the

phase transition.

It would be interesting to test these ideas in a laboratory systems in which a kink lattice can exist. Periodic boundary conditions could be achieved if a toroidal sam ple were to undergo a phase transition.

Finally we mention the implications of a domain wall lattice produced during a cosm obgical phase transition. If spacetime is $R^4 ext{ S}^1$ and the wall lattice resides in the (sm all) compact dimension, there will be an elective cosm obgical constant in the R^4 due to invariance under Lorentz boosts of the wall Ref. [10, 11]. The elective cosm obgical constant may be time dependent if the coupling constant were to run with energy scale, or to depend on the dynam ics of the spacetime, or on another

ed. Yet another source of time dependence can come via the number of walls in the lattice since the wall lattice is not protected by topology or any conserved number. So the number of walls in the lattice can cascade down and eventually become zero. The di culty with this cosm ological scenario is that the extra compact dimension will not be static and will lead to an elective Newton's gravitational constant that is time dependent. Since the m etric of the system is not yet known, it is not possible to say if the time variation can be slow enough for the scenario to be viable.

In conclusion, we have shown that stable lattices of domain walls can exist in a wide class of eld theories. These are exotic metastable states in which the system can get trapped with high probability during a phase transition.
