Free boson form ulation of boundary states in W $_3$ m in in alm odels and the critical Potts m odel

A bstract: W e develop a Coulomb gas form alism for boundary conform all eld theory having a W symmetry and illustrate its operation using the three state Pottsmodel. W e nd that there are free-eld representations for six W conserving boundary states, which yield the xed and mixed physical boundary conditions, and two W violating boundary states which yield the free and new boundary conditions. O ther W violating boundary states can be constructed but they decouple from the rest of the theory. Thus we have a complete free-eld realization of the known boundary states of the three state Pottsmodel. W e then use the form alism to calculate boundary correlation functions in various cases. W e nd that the conform alblocks arising when the two point function of 2;3 is calculated in the presence of free and new boundary conditions are indeed the last two solutions of the sixth order di erential equation generated by the singular vector.

1. Introduction

The Coulomb gas form alism [1, 2] provides a powerfulm ethod for calculating correlation functions and conform alblocks in m in in alrational conform all eld theories (CFTs) without having to solve complicated di erential equations. Boundary CFTs have been of great interest since Cardy's fam ous paper [3] and recently it has been shown that free-eld representations m ay be extended from bulk CFTs to system s with boundary (ies) [4, 5] in the case of the V irasoro diagonalm in im alm odels. The boundary states appear as coherent states in the free-eld form alism. As in the bulk case these m ethods again provide a m echanism for calculating correlation functions, this tim e in the presence of a boundary.

The three state Potts m odel is of particular interest because the conform all eld theory describing its critical point is the simplest in which there is a higher dimensional chiral operator of integer dimension. The resulting extended symmetry, generated by a W₃ algebra, has important consequences. In particular the theory is diagonal in the bigger W₃ algebra but not in the smaller V irasoro algebra. Such theories can be represented by a multi-component C oulom b gas form alism [6]. A great deal is known about the boundary states in this model. There are six states originally found by C ardy in which the W current is conserved at the boundary [7] and which correspond to xed and m ixed boundary

conditions in the spin system. In addition there are known to be two more states in which the W current is not conserved. One of them is the state corresponding to free boundary conditions on the spin system, which was of course expected to exist, and the other is the so-called new boundary condition; these were found in [8]. Subsequently it was shown in [9] that the set of eight states is in some sense complete and in [10] it was suggested that this completeness amounts to the set of boundary conditions for which the model is an integrable system. C learly none of these boundary states can correspond to boundary conditions on the spin system which are not conform ally invariant.

The purpose of this paper is to show how the multi-component C oulom b gas form alism m ay be used to provide a free-eld description of the boundary states in theories with a W algebra using the three state P otts m odel to illustrate the m ethod. W e start in section 2 by brie y reviewing those aspects of the standard form alism that we need. In section 3 we record in detail the representations of the prim ary elds for the P otts m odel and in section 4 explain how to construct the free-eld representations for C ardy's boundary states. Section 5 contains som e example calculations of correlation functions in the presence of boundaries; these act as a useful cross-check that the states we have constructed are correct.

Finally in section 6 we discuss some open issues and some useful results are recorded in the appendices.

2. Free-eld construction of CFTs with W algebra

The usual C oulom b gas form alism [1, 2] can be extended to CFT s with a larger symmetry than the V irasoro algebra by introducing a multiple component scalar eld [6] j(z;z), j = 1:::r, which is a vector in the root space of a nite dimensional Lie A lgebra A of rank r. In practice we will be considering the simplest case in this paper so we will con ne ourselves to the algebra A_r from the outset. Let us rst x some notation. The simple roots will be denoted $e_j; j = 1:::r$, and the corresponding dual weights j; j = 1:::r. W e will use \setminus " to denote multiplication of vectors and matrices in the root space. So the scalar product of two vectors u and v in the root space will be written u v, the product of two matrices m₁ m₂ and so on. The simple roots and dual weights then satisfy

as can be checked using the commutation relations (2.10). The physical H ilbert space of the theory is much smaller than the direct sum of the Fock spaces and is given by the cohom ology of a nilpotent BRST operator [11].

This generalized free-eld construction contains an extra sym m etry which corresponds to the presence of the higher dimensional conserved chiral primary elds found in theories with a W sym m etry (see [12, 13] for reviews). 3. Free-eld approach to the three state Potts model

The three state Pottsm odel is a m inim alm odel that is not diagonal in the sm all" V irasoro algebra but becomes diagonal in the larger W₃ algebra. To not its representation in terms of the A₂ C oulom b gas we have to not irreducible highest weight representations for which the Verm a modules are completely degenerate, that is to say have as m any singular vectors as possible. 

The conform ald in ensions of the elds obtained this way using (2.19) are the same as for the elds in the three state Potts model which are shown in Table 2. This six-fold redundancy in the choice of s for the primary elds in the bulk theory is a consequence of the property (2.20) and the Z_3 symmetry of the root diagram for A_2 which is in turn responsible for the existence of the chiral W₃ algebra. This changes when we consider boundary conditions which only preserve the V irasoro symmetry and not the full W symmetry. A swewill see in section 4, only the Felder complexes (discussed below) built on the rst column of Table 1 yield W violating boundary states which do not decouple from the bulk theory.




Figure 1: A part of the complex C . The open circles correspond to the root of the base cell F $_{n_1,n_2}^m$ and its images under translations by pe_i. D i erent types of arrow have the same meaning as in 3.11 and only those which are part of Q_B are shown.

a portion of which is shown in Fig.1. It was shown in [14, 15] that a nillpotent BRST operator Q_B graded in the direction can be dened on C. To do this we rst dene operators $d_n^{(i)}$ whose action on the Fock spaces is given by $Q_n^{(i)}$ for i = 1;2, and which increase the ghost number g by one. To keep track of the phases occuring we then dene a cocycle operator N with the properties

This agrees with the W $_3$ characters calculated in other ways (see [13] for a review). For each one of the representations, this form ula gives the same as for the corresponding operators in the three state Potts model (see eg [16]) which allows us to conclude that W $_3$ (4;5) does indeed describe the Potts model.

4. Boundary states in free-eld representation

C oherent boundary states m ay be de ned in a straightforward generalization of the procedure for the one component C oulom b gas. First we introduce the states j; ; $_0$ i which are constructed by applying the vertex operator V (z) and its antiholom orphic counterpart, \overline{V} (\overline{z}) to the SL (2;C)-invariant vacuum D;0; $_0$ i,

Thus the W current is conserved for coherent boundary states m ade w ith the operator C $_{\rm I}$ but not for those m ade w ith the operator C $_{\rm W}$.

We see in mediately that only those representations for which is proportional to the Weyl vector have non-zero mixed amplitudes between W conserving and W violating boundary states. It is straightforward to check by examining Table 1 that in the Potts model case only I and have this property and only for the charges and 4_0 where the s are drawn from the rst column of Table 1. Thus we can construct W conserving boundary states built on the six operators in the three state Potts model and two extra W violating boundary states corresponding to I and . Linear combinations of these represent the six physical boundary states rst found by Cardy [7] plus the free and new boundary states are the complete set of boundary states for this model. In the present form alism four other W violating boundary states corresponding to , ^y, and ^y can also be written dow n but are com pletely decoupled; thus of course they never appear in the fusion rule analysis of [9].

The states β (;)i lie in the Fock spaces. To obtain states in the Hilbert space of the conform al eld theory we must sum over the Felder complex to obtain

5. Critical Potts m odel correlation functions with boundary

We will now show how the free-eld formalism can be used to compute exact correlation functions of bulk operators in the presence of a boundary when the boundary condition is represented by the states (425, 428).

5.1 General considerations

otherw ise they vanish. These neutrality conditions relate the boundary charges to possible con gurations of the screening operators. The disk am plitudes are evaluated using the form ula,

The presence of screening operators leads to integral representations for the amplitudes. The integration contours are originally Felder's contours (concentric circles around the origin and attached to vertex operators). It is argued [5] that at least in the cases of 1 and 2-point functions these contours can be deformed suitably to give convergent functions which correspond to certain conform alblocks. We will now use this simple setup to compute Potts model correlation functions.

5.2 Vertex operators

In order to compute disk correlation functions in the C oulom b gas form alism, we need to de ne non-chiral prim ary operators in terms of chiral operators and then represent them with vertex operators.

In the second step, we need to represent each W primary eld by a vertex operator having one of the six charges of (3.5). In the bulk theory and also in presence of a W conserving boundary, one may allocate whichever of the six charges is most convenient as they should be all equivalent under the chiral algebra. However, as we have seen, in the presence of W violating boundary conditions this equivalence breaks down and only charges associated with the rst column of Table 1 are allowed. We are still free to use or its conjugate 4 $_0$ + w to construct a chiral vertex operator and can, in particular, represent a non-chiral operator as a product of di erent holom orphic and antiholom orphic vertex operators, e.g. I (z;z) = V₀(z) V_{4 0} (z). In practice we shall choose a set of vertex operators which minim izes the number of screening operators.





We have seen that the 2-point functions are determ ined completely, and it is easy to verify that the results have reasonable near-boundary behaviours. We have checked (by computer) that the six conform alblocks I, I, I_I , I_I , I_I , I, all satisfy the 6th order differential equation obtained from (5.34), and also that their W ronskian is non-trivial. Thus these conform alblocks are indeed six independent solutions of the di erential equation.

6.D iscussion

The purpose of this paper has been to describe the extension of the C oulom b gas form ulation of boundary CFTs to models with a higher chiral algebra. We have shown in detail how this works for A₂ to yield exactly the conform all boundary states that are expected on the basis of general arguments for the three state Potts model. At the level of a single boundary (ie a disk topology) the correlation functions that we have computed are all consistent with our understanding of the physics of the model. The two point amplitudes lead naturally to the two extra conform all blocks that are expected over and above those associated in the ordinary (ie as in rational minimal models) way with the primary elds. This is very satisfactory; in this form ulation we can calculate an integral representation for essentially any correlation function of the CFT in the disk topology, just as the original C oulom b gas method can for the bulk theory.

There are some questions that are not settled. Firstly the work reported here is not a complete test of the formulation at higher topology. The expectation of the identity operator in the cylinder topology is given correctly (ie as the cylinder amplitudes) but we have not calculated other correlation functions and the constants $_{\rm wM\,N}$ in (4.20) have not been completely determ ined (at least up to trivial ambiguities). This is all intimately related to the BRST formulation of the Felder complex for the W₃ algebra and there seem to be some gaps in what is known about this; for example, so far as we know, there is no proof of the statem ent (3.17) in the literature. Secondly it is clear that the general structure of this formulation can be extended without much di culty to higher W algebras and can be used as a means of classifying possible conform al invariant boundary states which do not preserve the higher symm etry; whether all such states can be found this way is an open question.
