# Integrable C ircular B rane M odel and C oulom b Charging at Large C onduction

#### Abstract

W e study a m odelof2D QFT w ith boundary interaction, in which tw o-com ponent $m$ assless B ose eld is constrained to a circle at the boundary. We argue that this m odel is integrable at two values of the topological angle, $=0$ and $=$. For $=0$ we propose exact partition function in term s of solutions of ordinary linear di erential equation. The circular brane $m$ odel is equivalent to the $m$ odel of quantum $B$ row nian dynam ics com $m$ only used in describing the Coulomb charging in quantum dots, in the lim it of sm all dim ensionless resistance $g_{0}$ of the tunneling contact. O ur proposal translates to partition function of this $m$ odel at integer charge.


## 1 The m odel

In this note we address a m odelof2D Euclidean eld theory with boundary interaction which we call the circular branem odel. Them odelcontains tw ocom ponent Bose eld $X(z ; z)=X^{1}(z ; z) ; X^{2}(z ; z)$ de ned on a disk of a radius $R$ w ith usual com plex coordinates $(z ; z)$, 文j $R$. Its bulk dynam ics is that of a fiee $m$ assless eld, as described by the action

$w$ here $X_{B}$ stands for the values of $X$ at the boundary $\dot{K} j=R$, and $g_{0}$ is a coupling constant. D ue to the nonlinear boundary condition, the theory needs renorm alization. It has to be equipped w ith the ultraviolet (UV) cuto, and consistent rem oval of the UV divergences requires that the bare coupling constant $g_{0}$ be given a dependence of the cuto $m$ om entum , according to the $R$ enorm alization $G$ roup ( $R G$ ) ow equation

$T$ he leading two term s of the beta function written down in ( $\overline{3}_{1}^{-1}$ ) were com puted in [1] [1] and $\left[\begin{array}{l}{[1]}\end{array}\right]$ and indeed agree w ith the $m$ ore general calculations
 distances the e ective size of the circle ( 2 (2) becom es large. It is believed that the theory develops a physicalenergy scale E, and at the distances $1=\mathrm{E}$ from the boundary the e ect of the boundary is that of the xed boundary condition $X_{B}=0$ (the boundary $(\bar{Z})$ ( $\backslash$ ow $s^{\prime \prime}$ to the $D$ irichlet boundary). A s usual, the e ect of the boundary can be described in term $s$ of the boundary state [|니]. The boundary state $j B$ i is a special vector in the space of states of radialquantization (in our case the space of states of tw ocom ponent free $m$ assless B ose eld on a circle of the circum ference 2 R ). $T$ his state incorporates all inform ation about the boundary conditions; any correlation function can be w ritten in term $s$ of the Euclidean-tim e H eisenberg operators sandw iched betw een $j B$ i and the radial-quantization vacuum
$j 0$ i. In particular, the overlap h0 $j B$ i coincides $w i t h$ the disk partition function, up to the factor $R^{c=6}$. In our case $j 0 i$ is the Fock vacuum of the free $m$ assless eld $X(z ; z) w$ th the zerom ode $m$ om entum $P=0$. M ore generally, we will be interested in the overlap amplitude hP jB i, where jP i is the Fock vacuum $w$ th the zerom ode $m$ om entum $P$; of course, this am plitude relates to the (unnorm alized) one point correlation function of the exponential eld inserted at the center of the disk,

W e note that by the nature of the boundary condition $(\overline{\underline{Q}})$ ) the partition function $Z(R ; H)$ is expected to be an entire function of $H$, and its analytic continuation to pure im aginary $H$ is unam biguous. In the form ( $\overline{1} \overline{\underline{0}}$ ) the $m$ odelhas interpretation as $1+1$ QFT on a half-line, at the tem perature $\mathrm{T}=\frac{1}{2 \mathrm{R}}$. At R ! 1 the partition function (G్G) develops standard linear asym ptotic

 A nother sim ilarity is apparent when one observes that the eld con gurations $Y(;)$ in ( 8 ) $)$ can be separated into the topological classes characterized by the integer-valued winding num ber

just like the sigm a-m odel eld con gurations $n$ fall into their topological classes characterized by the $m$ apping degree $S^{2}!S^{2}$. M oreover, in the sigm a-m odel the instanton con gurations $m$ in $m$ izing the action in each topological sector are found explicitly in term $s$ of rational functions [ig]; very sim ilar expressions exist for the instanton con gurations in the circular brane m odel $[\underline{0}, 1,1]$
exhibit much sim ilarity [1] $\overline{1}[\{\overline{1} \overline{1}]$. As usual, existence of the integer-valued topological charge allow s one to introduce another param eter, the topologicalangle ,

where the partition functions $Z^{(w)}$ are the functionalintegrals ( $(\overline{8})$ ) taken over the eld con gurations in the topological class $w$ only. The fill partition function $Z$, as de ned by Eq. (8ا"), involves all topological sectors $w$ ith equal weights, i.e. $Z=Z=0$. It is this $=0$ partition function which we had in $m$ ind in de ning the boundary energy $E(H)$ and the energy scale $E$ through $\left(\underline{1} \overline{3}_{1}\right), ~(\overline{1} \overline{1})$.

O ne of the reasons we mention this analogy here is because the $O$ (3) sigm a m odelis know $n$ to be integrable at tw o special values of the topological angle, $=0$ and $=[4518$. Therefore it is natural to expect that the circular brane $m$ odel is also integrable at these tw o special values of $\tilde{\underline{Z}}_{\mathbf{1}}^{\tilde{L}_{1}}$. We argue in A ppendix that for these values of the m odel adm its a number of nontrivial higher-spin local integrals of $m$ otion. In fact, our argum ent there goes for the whole class of the $\backslash O(\mathbb{N})$ spherical brane m odels", w ith N -com ponent eld X , subject to the spherical brane boundary condition $(\overline{2})$. M oreover, in these $m$ odels it is possible to describe the w hole set of the local integrals of m otion $I_{2 k} \quad 1, k=1 ; 2 ; 3::$ : in som e details.

The aim of this note is to present a proposal for the exact form of the partition function ( $(\overline{8})$ ) at the integrable point $=0$ in term sof solutions of certain ordinary di erential equation. We will present this in the next section, but let us rst $m$ ake som e rem ark and introduce suitable notations. A swasm entioned above, renorm alization trades the bare coupling constant $g_{0}$ for the RG invariant scale $(\overline{4} \overline{1})$, and the partition function actually depends on the dim ensionless com bination RE. In fact, in the circular brane m odel (as well as in the O (3) sigm a m odel) the last statem ent is not entirely true. A s w as observed in [1] $\overline{1} 1]$, the functional integral ( $\overline{\mathrm{G}}$ ) has a speci c nonperturbative divergence due to the sm all-size instantons, which cannot be absorbed into the renorm alization of the coupling constant $g_{0}$. D ue to this e ect, the partition function (伿) is expected to have the form

H ere $A$ is a constant, which is univensal (actually $A=2)$, but $B\left(g_{0}\right)$ is not \{ it depends on the details of $U V$ cuto . Thefactor $Z$ depends on the RG invariant param eters ; h and only. Sim ilar nonperturbative sm all-instanton divergence is well know $n$ to be present in the $O$ (3) sigm a m odel [1] 1 it is blam ed, for instance, for the violation of the norm alscaling of the topological susceptibility [ $\left[\underline{2} \overline{0}_{1}^{\prime}\right]$. It is im portant to note that the sm all instanton divergence does not a ect the $h$-dependence of the free energy (interaction of sm all instantons w th the extemal eld $H$ is negligible), therefore the energy
 In what follow s we discuss the universal factor $Z$ ( ; h ) in the fullpartition function at $=0$,

## 2 The partition function

It w as discovered som e years ago in Ref. $\overline{[2} \overline{1} \overline{1}]$ that in the case of the boundary ow in the minim alCFT w ith integrable boundary perturbation $\left.\underline{2}_{2}^{2} \underline{2}^{\prime}\right]$ the overlap analogous to ( $\overline{\text { Sin }}$ ) can be related exactly to the eigenvalue problem of certain ordinary di erential operator. D espite the fact that this relation w as proven $\left[\begin{array}{c}{[3]}\end{array}\right]$, and sim ilar relations w ere found in other integrable m odels of C F T w th non-conform alboundary interactions [2] rem ainsm ystery to us. $N$ onetheless, it looks natural to assum e that it $m$ ight be a generalphenom enon, and try to identify associated di erentialoperator
for the circular brane $m$ odel. Below we sim ply present our proposals for such di erential operator. The m otivations cam e from detailed studies of som ew hat m ore general, but still integrable \brane" model (we call it the \paperclip brane m odel"); 辻 generalizes the circular m odel in a way sim ilar to the \sausage" deform ation of the $O$ (3) sigm a m odel $\overline{\underline{2} \bar{G}] .}$. W e w ill report these studies elsew here [2] $\left._{\underline{1}}^{1}{ }^{\prime}\right]$.

## 3 Low tem perature expansion

At large R (low tem peratures) the equation ( $\mathbf{2}_{2} \overline{2}$ ) can be studied using $W$ K B expansion. The leading $W$ K B approxim ation yields explicit expression for the boundary energy (2 2 1'),

## 4 H igh tem perature expansion

It is also possible to develop short distance (high tem perature) expansion of the partition function $\left.\mathbf{( 2 5}_{\mathbf{1}}\right)$. For sm all the solutions (v) and $+(v)$ can be evaluated using appropriate versions of perturbation theory. To make the resulting form ulae com pact we shall describe here these expansions in the case $\mathrm{h}=0$ only. The solution (v) can be w ritten as

## 6 O n other spherical brane m odels

The circular brane $m$ odel is a particular case $N=2$ of the $\backslash O(\mathbb{N})$ spherical brane m odel", the latter containing N -com ponent eld X , sub ject to the sam e boundary condition (2̄), so that $X_{B} \quad 2 \quad S^{N} \quad 1 \quad\left[\begin{array}{l}{[1]}\end{array}\right]$. As we argue in A ppendix, the sphericalbrane $m$ odel is integrable for any $N \quad 1$. A though the bulk part of this paper is devoted to the circular case $N=2$, here we would like to say few words about other cases. First, for generic $N \in 2$ there are no topological sectors, and the sm all-instanton divergence is not present. For N 2 the overlap ( $(\underset{1}{5})(\mathrm{c}=\mathrm{N})$ can be w rilten as

H ow ever, for tw 0 other cases, $N=1$ and $N=3$, representations of the function $Z$ in ( $4 \overline{4} \overline{-1}$ ) in term s of solutions of certain di erential equations exist. H ere we w ould like to describe w hat these di erential equations are.

For $N=1$, it is usefiul to note that the $m$ odel is equivalent to the interacting sector of the one-channel spin $-\frac{1}{2} \mathrm{~K}$ ondo model. At $\mathrm{N}=1$ the sphere degenerates to two points, which represent tw o states of the im purity spin. E xact equivalence is established by bosonizing the $K$ ondo ferm ions (see e.g. R ef. [ $\left.\left[\overline{3}_{-1}^{-1}\right]\right)$. A s is w ell know $n$, the $K$ ondo $m$ odel is solvable by $m$ eans of $B$ ethe ansatz technique $[\overline{3} \bar{n}, \bar{i} \bar{i}]$. A ltemative (and equivalent) representation of the partition function can be given in term $s$ of the solutions of the di erential equation $[\overline{2} \overline{2}]$

M oreover, higher orders of the W K B expansion reproduce the eigenvalues $(\overline{6} \overline{6} \overline{1}),\left(\underline{6} \overline{-} \overline{9}_{1}\right)$ perfectly.

m odi cation to m ore generalm odel, which contains N -com ponent B ose eld $\mathrm{X}=\mathrm{X}^{1}$; $\quad{ }^{\mathrm{N}}$; Xw ith $\mathrm{N} \quad 1$, but otherw ise is described by the same action $(\underline{1})$ ) and the \spherical brane" boundary condition ( throughout this appendix we m ostly address this N -com ponent spherical brane $m$ odel. Presence of anbitrary number of com ponents allow sfor a num ber of checks w thin the $1=\mathrm{N}$ expansion.

### 7.2 Integrals of m otion

In the bulk, the spherical brane $m$ odel is a free Bose eld, and as such it certainly has in nite number of integrals of $m$ otion. The derivative $@ x$, where © $Q_{u}$ stands for the derivative over $u=+i$, is a holom orphic eld in the bulk. Therefore we regard the above argum ent as a strong indication of integrability of the sphericalbrane m odel.

It is possible to check that this expression agrees w ith the leading order of $1=\mathrm{N}$ expansion in the $\mathrm{O}(\mathbb{N})$ sphericalbranem odel. T he con jecture $\left[\overline{1} \bar{I}_{1}^{1}\right)$ concems $w$ th the coe cients $C_{k}$ w ith $k \quad 1$, but it does not directly apply to the coe cient C 0 . A ccording to ( $\overline{\underline{\eta}} \overline{0})$, the latter relates to the boundary energy at zero extemal eld $H, E(0)=C_{0} E$. Presently, we do not have de nite idea what exact value of $C_{0}$ is. Sim ply setting $k=0$ in ( $\underline{17}_{1}^{\prime}$ ') is not quite acceptable, since doing so results in com plex num bers for generic N . O n the other hand, it is likely that exact $\mathrm{C}_{0}$ is closely related to
 is that ( $\overline{7} \overline{1} 11)$ w ith $\bar{k}=0$ develops a pole at $\mathrm{N}=2$, presum ably sign ifying the sm all-instanton divergence speci $c$ to this value of $N$. Sim ilarpole at $N=3$ is present in the bulk vacuum energy of $(\mathbb{N})$ sigm a m odel [ $[\overline{4} \overline{2}]$.
