# Integrable C ircular B rane M odel and C oulom b C harging at Large C onduction

#### A bstract

W e study a model of 2D QFT with boundary interaction, in which two-component massless Bose eld is constrained to a circle at the boundary. W e argue that this model is integrable at two values of the topological angle, = 0 and = . For = 0 we propose exact partition function in terms of solutions of ordinary linear di erential equation. The circular brane model is equivalent to the model of quantum Brownian dynamics commonly used in describing the C oulomb charging in quantum dots, in the limit of sm all dimensionless resistance  $g_0$  of the tunneling contact. Our proposal translates to partition function of this model at integer charge.

## 1 Themodel

In this note we address a model of 2D Euclidean eld theory with boundary interaction which we call the circular brane model. The model contains twocomponent Bose eld X (z;z) =  $X^{1}(z;z);X^{2}(z;z)$  de ned on a disk of a radius R with usual complex coordinates (z;z), jzj R. Its bulk dynamics is that of a free massless eld, as described by the action

 $(d^2z = dxdy)$ , but it obeys nonlinear boundary condition

where X  $_{\rm B}\,$  stands for the values of X at the boundary  $j_{\rm Z}j=R$ , and  $g_0$  is a coupling constant. Due to the nonlinear boundary condition, the theory needs renormalization. It has to be equipped with the ultraviolet (UV) cuto , and consistent removal of the UV divergences requires that the bare coupling constant  $g_0$  be given a dependence of the cuto momentum , according to the Renormalization G roup (RG) ow equation

The leading two terms of the beta function written down in (3) were computed in [1] and [2], and indeed agree with the more general calculations in [3] and [4]. Eq.(3) shows that the theory is asymptotically free { at short distances the electric size of the circle (2) becomes large. It is believed that the theory develops a physical energy scale E , and at the distances 1=E from the boundary the electron of the boundary is that of the xed boundary condition X  $_{\rm B} = 0$  (the boundary (2)  $\setminus$  ow s" to the D inichlet boundary). As usual, the e ect of the boundary can be described in terms of the boundary state [5]. The boundary state jB i is a special vector in the space of states of radial quantization (in our case the space of states of twocomponent free massless Bose eld on a circle of the circum ference 2 R). This state incorporates all information about the boundary conditions; any correlation function can be written in terms of the Euclidean-time H eisenberg operators sandwiched between jB i and the radial-quantization vacuum j0 i. In particular, the overlap h0 jB i coincides with the disk partition function, up to the factor R<sup>c=6</sup>. In our case j0 i is the Fock vacuum of the free massless eld X (z;z) with the zero-mode momentum P = 0. More generally, we will be interested in the overlap amplitude hP jB i, where jP i is the Fock vacuum with the zero-mode momentum P; of course, this am plitude relates to the (unnormalized) one point correlation function of the exponential eld inserted at the center of the disk,

Here c = 2 is the central charge of the bulk theory. It will be convenient to transform the spherical brane model to the geometry of sem i-in nite cylinder, using the standard exponential map:

where u = +i; u = i, with ranging from 1 to 0, and being a periodic coordinate with the period 2 R. In what follows we will write (with some abuse of notations) X (;) for the eld X in (1) expressed in terms of these cylindrical coordinates. Then, introducing the shifted eld variable

one can relate the the amplitude hP jB i to the partition function<sup>1</sup>:

Here and below  $\overset{\rm H}{\rm d}$  stands for  $^{\rm R_{2\ R}}_{0} \rm d$  . The \external eld" H relates to P in (5) as

where the factor  $\frac{p_{1}}{p_{2}}$  is the boundary degeneracy [6] of the infrared (D irichlet)

xed point. W e note that by the nature of the boundary condition (9) the partition function Z (R;H) is expected to be an entire function of H, and its analytic continuation to pure in aginary H is unambiguous. In the form (10) the model has interpretation as 1+1 QFT on a half-line, at the tem perature  $T = \frac{1}{2R}$ . At R ! 1 the partition function (8) develops standard linear asymptotic

where E(H) is the boundary energy. This quantity depends on H and  $g_0$ , the latter dependence being through the energy scale E, Eq.(4). We found it convenient to x overall norm alization of E relating it to the zero tem – perature susceptibility,

The circular brane m odel shows m any similarities with the O (3) sigm a m odel (or n - eld), the asymptotic freedom (3) being just one of them [7]. A nother similarity is apparent when one observes that the eld con gurations Y (; ) in (8) can be separated into the topological classes characterized by the integer-valued winding number

just like the sigm a-m odel eld con gurations n fall into their topological classes characterized by the mapping degree  $S^2$  !  $S^2$ . Moreover, in the sigm a-m odel the instanton con gurations minimizing the action in each topological sector are found explicitly in terms of rational functions [8]; very sim ilar expressions exist for the instanton con gurations in the circular brane m odel [9,10]. The calculations of the instanton determ inants [11] also

exhibit much similarity [12 $\{14$ ]. As usual, existence of the integer-valued topological charge allows one to introduce another parameter, the topological angle ,

where the partition functions Z <sup>(w)</sup> are the functional integrals (8) taken over the eld con gurations in the topological class w only. The full partition function Z, as de ned by Eq.(8), involves all topological sectors with equal weights, i.e.  $Z = Z_{=0}$ . It is this = 0 partition function which we had in m ind in de ning the boundary energy E (H) and the energy scale E through (13),(14).

One of the reasons we mention this analogy here is because the O (3) sigm a model is known to be integrable at two special values of the topological angle, = 0 and = [15{18}]. Therefore it is natural to expect that the circular brane model is also integrable at these two special values of  $^2$ . We argue in Appendix that for these values of the model admits a number of nontrivial higher-spin local integrals of motion. In fact, our argument there goes for the whole class of the  $\langle 0 \rangle$  spherical brane models", with N -component eld X, subject to the spherical brane boundary condition (2). Moreover, in these models it is possible to describe the whole set of the local integrals of motion I<sub>2k</sub> 1, k = 1;2;3::: in some details.

The aim of this note is to present a proposal for the exact form of the partition function (8) at the integrable point = 0 in terms of solutions of certain ordinary di erential equation. We will present this in the next section, but let us rstmake some remark and introduce suitable notations. A swasmentioned above, renorm alization trades the bare coupling constant  $g_0$  for the RG invariant scale (4), and the partition function actually depends on the dimensionless combination RE. In fact, in the circular brane m odel (as well as in the O (3) sigm a m odel) the last statement is not entirely true. A swas observed in [12], the functional integral (8) has a speci c non-perturbative divergence due to the small-size instantons, which cannot be absorbed into the renorm alization of the coupling constant  $g_0$ . Due to this e ect, the partition function (8) is expected to have the form

Here A is a constant, which is universal (actually A = 2), but B ( $g_0$ ) is not { it depends on the details of UV cuto . The factor Z depends on the RG invariant parameters ; h and only. Sim ilar nonperturbative small-instanton divergence is well known to be present in the O (3) sigm a model [11], where it is blamed, for instance, for the violation of the norm all scaling of the topological susceptibility [20]. It is important to note that the small instanton divergence does not a ect the h-dependence of the free energy (interaction of small instantons with the external eld H is negligible), therefore the energy scale E de ned through (13) and (14) enjoys the norm alRG behavior (4). In what follows we discuss the universal factor Z (; h) in the full partition function at = 0,

which carries all interesting dependence on H and R. Since any factor of the form  $e^{const}$  can be absorbed into the rede nition of B (g<sub>0</sub>) in (18), we x the ambiguity by assuming that Z (;0) ! 1 as ! 1. With this convention, the boundary energy can be written as

## 2 The partition function

It was discovered som e years ago in R ef. [21] that in the case of the boundary ow in the minimal CFT with integrable boundary perturbation [22], the overlap analogous to (5) can be related exactly to the eigenvalue problem of certain ordinary di erential operator. D espite the fact that this relation was proven [23], and sim ilar relations were found in other integrable m odels of CFT with non-conform alboundary interactions [24,25], its deeper reason remainsmystery to us. N onetheless, it looks natural to assume that it might be a general phenom enon, and try to identify associated di erential operator for the circular brane m odel. Below we simply present our proposals for such di erential operator. The m otivations came from detailed studies of som ew hat m ore general, but still integrable \brane" m odel (we call it the \paperclip brane m odel"); it generalizes the circular m odel in a way sim ilar to the \sausage" deform ation of the O (3) sigm a m odel [26]. W e w ill report these studies elsew here [27].

Consider the following ordinary di erential equation

where E i(x) is the integral exponent function, E i(x) = P N:  $\frac{R_1}{x} \frac{dt}{t} e^{t}$ . The asymptotics (23) and (24) specify the solutions (v) and  $_+$  (v) uniquely, including their norm alizations. Then

where W is the W ronskian  $_{+} @_{v}$   $@_{v} _{+}$  and  $_{E} = 0.577216:::$  is Euler's constant. Thus determination of Z reduces to the problem of the ordinary dimension.

# 3 Low tem perature expansion

At large R (low temperatures) the equation (22) can be studied using W KB expansion. The leading W KB approximation yields explicit expression for the boundary energy (21),

This expansion should be understood in terms of the expansion (66), with the powers H  $^{2k}$  representing the highest order term s  $h^{2k}$  of the polynom ials  $I_{2k-1}$ , the vacuum eigenvalues of the local IM  $I_{2k-1}$ . Note that the above expression for the coe cients C  $_k$  is consistent with (71). The next order of the W K B expansion provides leading correction to the linear asymptotic (13),

## 4 High tem perature expansion

It is also possible to develop short distance (high tem perature) expansion of the partition function (25). For small the solutions (v) and  $_+$  (v) can be evaluated using appropriate versions of perturbation theory. To make the resulting form ulae compact we shall describe here these expansions in the case h = 0 only. The solution (v) can be written as

where the coe cients a  $_n() = 0$  (<sup>2</sup>) and adm it system atic expansions in powers of . The ! 0 expansion of the solution  $_+$  (v) is more subtle. Instead of powers of , it expands in powers of the \running coupling constant" g = g() de ned by the equation

For  $\dot{\mathbf{x}}$  j 1 the term U (x) is O (g); in this domain solutions of (36) adm it systematic expansion in powers of g. Expansion of \_+ is obtained by iterations of (36), starting with \_\_^{(0)} = C (g) K\_0 2 e^{\mathbf{x}=2}, where K<sub>0</sub> is the M acdonald function and the normalization constant C (g) must be adjusted to m atch the asymptotic form (24). It turns out that both expansions, of

in the powers of , and of + in the powers of g, have common domain of validity at v  $\log(g)$ , and can be used there for evaluation of the W ron-skian in (25). As the result, the following form of the small expansion of the partition function (20) emerges

where the coe cients  $z_n$  (g) are power series in g. The term n = 0 in (38) should be interpreted as the perturbative contribution to the partition function, the term n = 1 corresponds to the one-instanton contribution, and the higher nonperturbative term s n = 2;3::: presum ably describe the contributions of multiple instanton and anti-instanton con gurations. Explicit com putation along the lines described above yields

# 5 Dissipative quantum rotator

The circular brane model has useful interpretation in terms of Brownian dynamics of quantum rotator. It was noticed a while ago in Ref. [28] that the free massless bulk dynamics (10) is equivalent to the Caldeira-Leggett model of quantum therm ostat [29]. Upon xing the boundary values Y  $_{\rm B}$  () and integrating out the bulk part of the eld Y (; ), Eq.(8) reduces to

where () is the angular eld de ned through H  $Y_B$  () = H =  $p \overline{g_0} \cos$  (). The model sim ilar<sup>3</sup> to (41) was introduced in [30] (see e.g. [31] for a review) as an elective eld theory describing tunneling of quasiparticles between superconductors. More recently it was subject of much interest in studying of the phenom enon of C oulom b blockade in quantum dots [32], in the regime where the dimensionless resistance of the tunneling contact  $g_0$  is small [2, 12{14,33}. In this context, the elective action in fact contains another term,

where  $E_{\rm C}$  has the meaning of the charging energy of the dot in the absence of the tunneling,  $E_{\rm C} = e^2 = 2C$ . Of course, is the M atsubara time, and

W ith the cuto procedure thus specified, the \sm all-instanton" factor e<sup>L</sup> in (20) becomes unambiguous. By comparing (38),(39) with direct one-instanton calculation in (42) [12{14} one nds for sm all  $g_0$

Eqs.(20),(25) then provide the partition function of the model (42) at = 0, in the lim it of sm all  $g_0$ . One only has to relate the energy scale E in (19) to the parameters  $g_0$  and  $E_c$  in the above action (42). When  $E_c = g_0$  H E and  $g_0$  is sm all, the boundary energy E (H) (21) can be computed directly from (42), using the standard perturbation theory in  $g_0$ . By developing two-bop order in this perturbative expansion and comparing it with the H = E 1 behavior of the integral in (26), we found

Finally, let us make a remark on the topological susceptibility in the model (42). A swas already mentioned, the topological susceptibility

in the circular brane model su ers from the small-instanton divergence, which leads to the non-universal factor e<sup>L</sup> cos in (17). On the other hand, in applications to the C oulom b blockade, the topological susceptibility in (42) has direct physical meaning { it coincides with measurable capacitive energy of the quantum dot. Explicit cuto in the action (42) makes the small-instanton factor unambiguous. A coording to (17), at zero temperature and zero H, E<sub>C</sub> has the form 2<sup>2</sup> (L + const) E, where the constant com es from the -dependence of the second factor in (17). Since our proposal is strictly limited to the case = 0, it does not allow for determ ination of this constant. However, at small g<sub>0</sub> the dom inating contribution com es from the term LE, and therefore in view of (44) and (45), the charging energy at zero temperature is estimated as

O fcourse, the leading behavior  $(1=g_0 \text{ in the brackets})$  here is consistent with the one-instanton analysis in the Gaussian approximation [12{14]. Nontrivial prediction which follows from our proposal is the logarithm ic term in (47).

## 6 On other spherical brane models

The circular brane m odel is a particular case N = 2 of the O(N) spherical brane m odel", the latter containing N -component eld X, subject to the same boundary condition (2), so that  $X_B \ 2 \ S^{N-1}$  [1]. As we argue in Appendix, the spherical brane m odel is integrable for any N 1. A lthough the bulk part of this paper is devoted to the circular case N = 2, here we would like to say few words about other cases. First, for generic N  $\leftarrow$  2 there are no topological sectors, and the sm all-instanton divergence is not present. For N  $\leftarrow$  2 the overlap (5) (c = N) can be written as

where and h are still the dimensionless parameters (19), and E is defined in Eq.(14). The factor Z (;h) here is normalized as in (20), i.e. Z (;0) ! 1 as ! 1, and the N-dependent constant C<sub>0</sub> is the same as in Eqs. (66),(70).

For generic N we were not able to nd di erential equations which could possibly generate the overlap (48), as (22) does for N = 2. How ever, for two other cases, N = 1 and N = 3, representations of the function Z in (48) in term s of solutions of certain di erential equations exist. Here we would like to describe what these di erential equations are.

For N = 1, it is useful to note that the model is equivalent to the interacting sector of the one-channel spin $\frac{1}{2}$  K ondo model. At N = 1 the sphere degenerates to two points, which represent two states of the impurity spin. Exact equivalence is established by bosonizing the K ondo ferm ions (see e.g. Ref. [34]). As is well known, the K ondo model is solvable by means of B ethe ansatz technique [35,36]. A lternative (and equivalent) representation of the partition function can be given in terms of the solutions of the di erential equation [25]

Like in the case N = 2, the ! 1 expansion of (52) can be obtained by W KB analysis of the solutions of (51). Thus, the leading W KB approximation yields the boundary energy (70), with the coe cients C <sub>k</sub> given exactly by (71) with N = 3. M oreover, higher orders of the W KB expansion reproduce the eigenvalues (68), (69) perfectly.

# 7 Appendix

### 7.1 The O(N) spherical brane m odel

In this appendix we present arguments in favor of integrability of the circular brane model at = 0 and =. In fact, the arguments apply without much

m odi cation to m ore generalm odel, which contains N -component B ose eld  $X = X^{1}$ ; <sup>N</sup>; Xw ith N 1, but otherwise is described by the same action (1) and the \spherical brane" boundary condition (2). Therefore throughout this appendix we mostly address this N -component spherical brane model. Presence of arbitrary number of components allows for a number of checks within the 1=N expansion.

#### 7.2 Integrals of m otion

In the bulk, the spherical brane model is a free Bose eld, and as such it certainly has in nite number of integrals of motion. The derivative @X, where @  $@_u$  stands for the derivative over u = + i, is a holom orphic eld in the bulk. Hence any local polynom ial P (u) = P (@X; @<sup>2</sup>X; ) of this and higher derivatives with respect to u gives rise to a local integral of motion

$$I[P] = \frac{d}{2} P (@X; @^{2}X; :::);$$
(53)

where we have assumed the coordinate along the cylinder to be the Euclidean time. Here and below the bulk composite elds entering these polynomials are always understood in terms of the norm all ordering with respect to the standard W ick pairing hX<sup>a</sup> (u;u) X<sup>b</sup> (u<sup>0</sup>;u<sup>0</sup>) i = <sup>ab</sup> log ju u<sup>1</sup> j corresponding to a bulk free eld in an in nite space. Certainly, there is a \left-m oving" counterpart to each of the integrals (53),

where  $Q_1$ . The integrals (53),(54) are operators acting in the space of states of free N -component massless Bose eld quantized on a spatial circle of the circum ference 2 R, i.e.

where  $F_P$  is the Fock space of the right-m oving bosons with the zero-m ode momentum P. Large set of integrals (53) contains many in nite subsets  $I[P_s]$  (corresponding to special sequences of the polynom ials  $P_s$ ) of m utually commutative operators,

$$I\mathbb{P}_{s}]; I\mathbb{P}_{s^{0}}] = 0 :$$

The polynomial elds  $P_s$  can always be chosen to have de nite spin, and it is convenient to label them accordingly; below we always assume that s indicates the spin of  $P_s$  (u). We will also use conventional notation  $I_{s-1}$  for the integral IP<sub>s</sub>].

As is discussed in [37], integrability of the eld theory (1) in the presence of the boundary requires that the boundary state satis as the equations

for all  $I_s$  in one such subset. These equations must follow from special properties of the boundary conditions, which should be such that the corresponding elds  $P_s(u)$  and  $P_s(u)$ , being brought to the boundary = 0, satisfy the conditions

where  $_{\rm s}$ () are some (renorm alized) local boundary elds. In the case of the spherical brane boundary condition (2), existence of the rst few polynom ials satisfying (58) can be demonstrated by an argument similar to that previously used to support integrability of the O (N) sigma model [15]. The O (N) symmetry of the boundary condition (2) suggests that the polynom ials P<sub>s</sub> must have this symmetry as well. We thus can look for the corresponding integrals I<sub>s 1</sub> in the form :

Note that in writing these expressions we have xed the norm alization of the currents  $P_{2k}$ : the term  $QX = QX^k$ , having the highest power of X, comes

with the coe cient 1. In what follows we always assume this norm alization of the integrals  $I_{2k}$  1. The term s om itted in (60) have powers of X equal 2k 4 or lower. In general case, the dierence  $P_s(u)$ P<sub>s</sub> (u) = 0 is a combination of local boundary elds having appropriate symmetries. These include the O (N) symmetry and the anti-symmetry with respect to the re ection 1 . Note that for N = 2 the last relation symmetry is violated unless = 0 and = . Also, only the elds of right scale dimensions (i.e. equal or below the scale dimension of  $P_s$ ) are admitted. E lem entary counting shows that for s = 2 the only admissible eld is a total derivative over , of the form of the rh.s. of (58). For s = 4 there is only one admissible eld which is not a total derivative, and for s = 6 there are three adm issible non-derivative elds. It follows that  $P_2$  always satisfy (58), and the coe cients in (59) can be adjusted to ensure that P  $_4$  and P  $_6$  satisfy (58) as well. The role of the boundary condition (2) in this counting is in reducing the number of independent boundary elds: the boundary conditions determ ine the number of redundant boundary elds. As usual, this kind of argum entation fails for higher spins, since the num ber of adm issible elds grows too fast. Nonetheless, in many other models similar \low-spin test" was successful in detecting full integrability, with no known (to us) exceptions. Therefore we regard the above argum ent as a strong indication of integrability of the spherical brane m odel.

In fact, the coe cients in (59) for P  $_4$  and P  $_6$  can be determined explicitly from the commutativity condition (56). While I<sub>1</sub> automatically commutes with any IP ] of the form (53), the condition [I<sub>3</sub>; I<sub>5</sub>] = 0 turns out to be rather rigid. As it turns, it has only one solution (for the coe cients b;c;d in (59)) with suitable properties<sup>4</sup>, namely

At large N the integrals  $I_3$  and  $I_5$  reduce to their quadratic in X term s, in

 $<sup>^4</sup>$  In fact, there are exactly three solutions. The other two correspond to previously known systems of commuting integrals. One represents the trivial free-eld case, where all integrals  $I_{2k\ 1}$  are quadratic in X (obviously, norm alization assumed in (59) has to be changed to accommodate this case); such integrals can be compatible only with the free eld boundary conditions (i.e. no nonlinear constraints on  $X_B$  (), and possibly a term  $d\ X_B^2$  () added to the action (10)). agreem ent with easily established fact that in the N ! 1 lim it the spherical brane m odel becomes a free theory [38]. Moreover, we have checked that with this choice the integrals (60) indeed satisfy (57) in the rst nontrivial order of the 1=N expansion.

It looks likely that ones  $I_3$  is xed through Eqs.(59),(61), the higherspin integrals  $I_{2k}_1$  with k = 3;4;5::: are determined uniquely by the commutativity condition  $[I_s; I_3] = 0$ . A though for higher spins the bruteforce computation of the commutators becomes dicult, it is possible to determine this way the coe cients explicitly written in (60):

#### 7.3 Boundary state

In view of the structure (55) of the space H, it is convenient to think of the boundary state in terms of associated boundary operator. Natural isom orphism between  $F_P$  and  $F_P$  (the right movers are replaced by the left movers) makes it possible to to establish one to one correspondence between the states in  $F_P$  =  $F_P$  and operators in  $F_P$ . Thus the boundary state jB i can be re-interpreted as an operator  $B : F_P$  !  $F_P$ . This idea was extensively used in the study of conform al boundary conditions since the original works [39,40]. In this interpretation the equation (58) reduces to the statem ent of commutativity,

The boundary state therefore can be written as

where jn; P i are the (orthonorm alized) simultaneous eigenvectors of the operators  $I_{\rm s}$  in the space F  $_{\rm P}$ , and B  $_{\rm n}$  (P) are corresponding eigenvalues of B,

The eigenvalue B  $_0$  (P) corresponding to the Fock vacuum j0; P i in F  $_P$  coincides with the overlap h0 jP i. This structure of jB i emphasizes in portance

of the problem of simultaneous diagonalization of the integrals of motion  $I_s$ . Similar problem was addressed in [22] for somewhat simpler model of integrable boundary interaction { the minimal CFT perturbed by the boundary eld  $_{1;3}$ . In that case associated system of integrals  $I_s$  was the K dV series (see footnote # 4). It was observed in [22] that the eigenvalues of  $I_s$  are related to corresponding eigenvalues of B in the following way. When the length of the boundary 2 R ! 1, the operator logB admits asymptotic expansion in terms of the local integrals  $I_s^5$ . We expect similar relation to hold in the case of the spherical brane model, namely

where  $B_{IR}$  is the boundary operator associated with the infrared xed point, E is the energy scale (14),  $I_{2k-1}$  with k 1 are the integrals (59),(60),  $I_{-1} = R$ , and the coe cients C k are just numbers, independent of the parameters  $g_0$ , R, and P. The expansion (66) is expected to hold in the sense of asymptotic R ! 1 series (note that  $I_{2k-1} = R^{1-2k}$  by dimensional counting). The dependence of the matrix elements (66) on R and P comes through the integrals  $I_{2k-1}$ . For instance, for the vacuum -vacuum matrix element

 $<sup>^5</sup>$  This structure appears in integrable boundary ows down to the <code>\basic"</code> conform al boundary, the one which adm its no prim ary boundary elds but the identity. In those cases the expansion in  $I_{\rm s}$  corresponds to expansion of the infrared e ective action in terms of descendents of the identity. C learly, the D inichlet boundary X  $_{\rm B}$  = 0 is of that kind. For integrable boundary ows down to <code>\elevated"</code> xed points, which adm it nontrivial boundary prim aries, the asymptotic expansions of B at large R should contain <code>\dual"</code> nonlocal integrals ofm otion [41] as well. This is what we would expect to have in the case of = of the circular brane.

and for general k

where  $h^2 = \frac{P^2}{4}$ . In the lim it when R ! 1 with  $H = \frac{h}{2R}$  kept xed, these eigenvalues become simply  $I_{2k-1}$  ! R (2 H)<sup>2k</sup>, and therefore  $C_k$  in (66) are just the coe cients of the power series expansion of the boundary energy E (H) in (13),

At the moment we have only a conjecture about exact form of these coe - cients in the spherical brane model,

$$C_{k} = (1)^{k} (2)^{1} (2)^{1} (2)^{k} (2)^{2k} (2)^{2$$

with  $= \frac{1}{N-1}$  and k 1. It is possible to check that this expression agrees with the leading order of 1=N expansion in the O (N) spherical brane m odel. The conjecture (71) concerns with the coe cients C k with k 1, but it does not directly apply to the coe cient C 0. A coording to (70), the latter relates to the boundary energy at zero external eld H, E (0) = C 0 E . P resently, we do not have de nite idea what exact value of C 0 is. Sim ply setting k = 0 in (71) is not quite acceptable, since doing so results in com plex num bers for generic N . On the other hand, it is likely that exact C 0 is closely related to the expression (71) with k = 0 (its realpart = 2 cot()?). One indication is that (71) with k = 0 develops a pole at N = 2, presum ably signifying the sm all-instanton divergence speci c to this value of N . Sim ilar pole at N = 3 is present in the bulk vacuum energy of 0 (N) sigm a model [42].
