# A tw isted conform al eld theory description of dissipative quantum mechanics

#### Abstract

W e show how the recently proposed CFT for a bilayer Q uantum $H$ all  to the system of two m assless scalar bosons $w$ th a $m$ agnetic boundary interaction as introduced in $\left[\frac{\boxed{4}]}{}\right]$, at the so called \m agic" points. W e are then $a b l e$ to describe, w thin such a fram ew ork, the dissipative quantum $m$ echanics of a particle con ned to a plane and subject to an extemal m agnetic eld norm al to it. Such an analogy is further developed in term s of the TM boundary states, by describing the interaction betw een an im purity w ith a Hall system.

## 1 Introduction

In ref.[फ़्ך] the e ect of the dissipative term ( q) on the m otion of an electron con ned in a plane and in the presence of an extemalm agnetic eld $B$, norm al to the plane, was analyzed. By using the correspondence principle it was possible to quantize the system and to study its time evolution on large time scales (t $\quad \underline{\text { ) }}$ ) em ploying coherent states techniques. It was found that the e ect of dissipation would sim ply be accounted for by a rotation com bined w th a scale transform ation on the coordinate $z$ of the electron: $z!\left(e^{i}\right) z,={\frac{2^{2}+!^{2}}{!^{2}}}^{\frac{1}{2}},=\arctan !$. As a result, the gaussian width describing the electron in the low est Landau level (LLL) state would get reduced. Furtherm ore the current operator, lying in the $H$ all direction in the absence of dissipation, for 0 would acquire a longitudinal com ponent, w ith a resulting $m$ etallic conductance $i \in 0$ for the $m$ ultielectron system.

It is rem arkable that such an e ect was soon after proposed in ref. text of boundary conform al eld theories (BCFT). The authors consider a system of two $m$ assless free scalar elds which have a boundary interaction $w$ ith a periodic potential and furtherm ore are coupled to each other through a boundary m agnetic term. By using a string analogy, this last interaction allows for exchange of $m \mathrm{o}$ $m$ entum of the open string $m$ oving in an extemal $m$ agnetic eld. The $m$ agnetic interaction enhances one chirality with respect to the other producing the same e ect of a rotation together with a scale transform ation on the elds as for the dissipative system of ref. [⿶凵1] where the string param eter places the role of dissipation. It is crucial to observe that conform al invariance of the theory is preserved only at special values of the param eters entering the action, the so called \m agic" points.

The aim of this letter is to show that the e ective conform al eld theory, the
 dissipative system precisely at the $\backslash \mathrm{m}$ agic" points. In fact the presence of a $\mathrm{Z}_{\mathrm{m}}$ tw ist accounts, in the open string picture, for a m ism atch of m om entum exchange at its two endpoints. For the special $Z_{2}$ case the TM has central charge $c=2$ and describes a system oftw o layers coupled through a topologicaldefect. It is interesting to notioe that the elds which diagonalize such an interaction can be expressed in term s of the original layers elds through a rotation and a scale transform ation. T he am ount of the rotation and scale transform ation is xed by the order of the tw ist. $T$ his is the content of the $m$ reduction procedure introduced in ref. [ब़̄]. The paper is organized as follow s:

In sec. 2 we recall som e results of the dissipative quantum $m$ echanics obtained in refs.

In sec. 3 we review the properties of the TM which are relevant to the description of the dissipative e ects and m ake a correspondence w th the BCFT approach of ref. $\left[\frac{14}{4}\right]$.

In sec. 4 we analyze the e ect of the magnetic eld on the TM boundary states (BS) recently introduced in ref. [3-1] and m ake a correspondence w ith the bulk degrees of freedom of ref.

In sec. 5 we give explicitly the duality transform ations which relate the UV properties $w$ ith the $\mathbb{R}$ ones in the TM context.

## 2 D issipative quantum mechanics

In the presence of dissipation, the equations of $m$ otion of an electron $m$ oving in $a$ plane w ith a magnetic eld B transverse to it are given by:

The coordinates $z_{1}, \bar{z}_{1}$ describe the center of the Larm or orbit of the electron and $b_{1}, \frac{\varepsilon_{1}}{}$ are the corresponding operators. If we require that the zero angular $m$ om entum state $0(z)$ is annihilated by $\mathbb{B}$ (that is we require unitarity in our description), then we im m ediately get
 w th eq. (5.) we can infer that the e ect of dissipation can be simply accounted for by $m$ aking the follow ing transform ations on the variable $z: z!\left(e^{i}\right) z$, where $={\frac{2}{}+!^{2}}_{!^{2}}{ }^{\frac{1}{2}}$ and $=\arctan \Gamma$, that is a rotation plus a scale transform ation. The striking consequence of the apove relations (see ref. [5] ]) is that, if one starts w th the current density operator $\mathcal{J}$ which accounts for a H all conductance ${ }^{\mathrm{H}}=\frac{1}{!}$ (being $\dot{J}^{\text {J }}=\frac{\mathrm{E}}{!} ; 0$ ) only, by applying the transform ations given in eq. $(\overline{\mathrm{T}}, \mathrm{i}$ ) one obtains

It is rem arkable that such an e ect was soon after proposed in ref. [īin] in the context of BCFT.A system of two massless scalar elds in $1+1$ dimensions is considered, which are free in the bulk except forboundary interactions, which couple

In the equations above determ ines the strength ofdissipation and is related to the potentialV, as it can be seen, by rescaling the elds; is related to the strength of the $m$ agnetic eld $B$ orthogonal to the $X \quad Y$ plane, as $=2 \mathrm{~B}$.
$T$ he $m$ agnetic term introduces a coupling between $X$ and $Y$ at the boundary keeping conform al invariance. Such a sym $m$ etry gets spoiled by the presence of the interaction potential term except for the $m$ agic points $(;)=\frac{1}{n^{2}+1} ; \frac{n}{n^{2}+1} ; n 2$ $Z$. For such param eters values the theory is conform al invariant for any potential strength $V$. It is possible to express all the degrees of freedom of such a system in term s of the boundary states, whidh can be easily constructed in tw o steps:

By considering rst them agnetic interaction term it is easy to see that the net e ect of the $m$ agnetic eld is a chiralo(2) rotation of the $N$ eum ann boundary state ${ }^{\mathrm{N}} \mathrm{N}$ > as:

Since the $o(2)$ rotation com $m$ utes $w$ th the $V$ irasoro generators $L_{n}$, the state $\beta_{v}>$ satis es the Ishibashi condition $L_{n} \quad \Theta_{n} \quad \mathcal{B}_{\mathrm{v}}>=0$. N otice the strong resem blance of the above relations $w$ ith the transform ation properties given in eq. (i, in), describing the e ect of dissipation on the vector operator $O$. W e will com e back later to further com $m$ ent on this analogy, after introducing the TM in section 3. Let us only observe here that it is possible to get further insight into this analogy by considering the partition function $\mathrm{Z}_{\mathrm{N}} \mathrm{B}_{\mathrm{V}}$ de ned as:

because, in the open string language, the rotation $\mathrm{R}_{\mathrm{M}}$ introduces now tw isted boundary conditions in the direction.

In the follow ing section we will introduce the tw o interacting layers system in the picture of the tw isted theory and show that the interlayer interaction is diagonalized by the e ective elds X; which are related to the layers elds $Q{ }^{(1)}$; $Q^{(2)}$ just by the relation given in eq. (1], ) for $=$. A lso a generalized construction of the partition function $Z_{N B_{V}} w$ ill be perform ed in that context.

## 3 The TM m odel

In order to introduce the TM model let us consider a system of two interacting parallel layers of 2D electrons in a strong perpendicular magnetic eld B. The lling factor ${ }^{(a)}=\frac{1}{2 p+2}$ is the sam efor the two $\mathrm{a}=1,2$ layers (balanced system) while the total lling is $=\frac{1}{p+1}$. The CFT description for such a system can be given in term softwo compacti ed bosons $Q^{(a)}$ (w ith central charge $c=2$ ) de ned on the single layer \a".
$W$ e review now the construction of the $Q^{(a)}$ elds in the TM description in its key steps, which will tum out to be also relevant for the analogy we are proposing. $W$ e show how the $m$ reduction procedure is equivalent to the e ect of a m agnetic boundary term ; in otherw ords them agnetic term can result in a tw ist on the neutral eld.

[1ָ1 $142 \overline{1} 1]$ ) can be con jectured to represent the correct CFT which describes dissipative quantum $m$ echanics ( $\mathrm{D} Q \mathrm{M}$ ) of ref. 坒].

The full set of characters and the partition function for this $m$ odel was given in [2]. In [3] the e ect of the presence of an im purity in the system was analyzed by $m$ apping the im purity into a boundary state by using the well known folding procedure and the boundary partition function $Z_{A B} w a s$ given. In the rest of the paper we will try to convince the reader that such a conjecture is correct even in the context of boundary CFT. M ore precisely we will study the e ect of the magnetic eld on the BS of the TM m odel $\left[\begin{array}{l}{[1 /]}\end{array}\right]$ and construct the correspondent partition function $Z_{N B_{V}}$ (see eq. (ī̄̄)). In the follow ing section we will explicitly see how the boundary state so constructed is related, for the di erent values of $=0$ or $=\frac{1}{2}$, to the description of the bulk degrees of freedom of the TM.

## 4 T w isted M odel and m agnetic boundary interaction

In order to analyze the e ect of a m agnetic boundary term in the TM we can resort to the ferm ionized theory and de ne a pair of left-m oving ferm ions as:

At the rst non-trivial $\backslash m$ agic" point $==\frac{1}{2}$ of ref. [ī $]$ corresponding in our $m$ odel to the $m=2, p=0$ case it is very smple to obtain the action of the $m$ agnetic boundary term on the $N$ eum ann state $\mathcal{N} \gg$. In fact, separating the tw o D irac ferm ions into real and im aginary parts, ${ }_{1}=11+i_{12} \prime^{\prime}{ }_{2}={ }_{21}+$ i 22 , we get four left-m oving M a jorana ferm ions given by $=(11 ; 12 ; 21 ; 22)=$ (cosX ; $\sin \mathrm{X} ; \cos ; \sin )$ and a corresponding set of right-m oving ones. In this new
language the $m$ agnetic term acts only on the fourth $M$ ajorana ferm ion as $R_{M}=e^{2 i}$ where $=0\left(=\frac{1}{2}\right)$ for the untw isted (tw isted) sector of our theory, being its action the identity for the other com ponents. N ow we add a potential term which acts on the $M$ ajorana as:

W e will com ment on such results in the follow ing section, resorting to the duality properties of the TM vacua, which are explicitly evidenced in its analogy w ith the one im purity K ondo m odel.

## 5 D uality properties and com m ents

O ur description adapts very closely to a system of tw o interacting Luttinger liquids coupled resonantly through an im purity placed in between. Indeed, as stated in ref. [i], the problem of tunneling between two di erent quantum $H$ all states at
$=1$ and $=1=3$ can be $m$ apped onto that of tunneling through a barrier in a $g_{L}=1=2$ Luttinger liquid; in particular, if the two layers are equivalent the two tunneling barriers are sym $m$ etric. This is the condition for a perfect resonance, where
 $m$ odel can be $m$ apped to an anisotropic two channel $K$ ondo problem in which the occupation of the im purity state corresponds to the state of the $K$ ondo spin, the tw o leads are the two channels, the tunneling am plitudes play the role of the transverse couplings and the scaling dim ensions of the elds are related to anisotropy. So we get:

Indeed let us consider the anisotropic K ondo m odelde ned by a boundary Lagrangian as in eq. ( $(\overline{0} 0 \overline{1})$ where X, arem assless bosonic elds. Such an interaction induces a ow from $N$ eum ann ( $U V$ ) to $D$ irichlet ( $\mathbb{R}$ ) boundary conditions as $V$ increases. The integrability constraint requires the infrared Lagrangian to contain a single non-trivial tem :

If we rem ember the relation $R=2^{\mathrm{p}} \overline{g_{L}}[\underline{1} \overline{\mathrm{O}} \overline{-}]$, we see that duality m aps the com pacti cation radius $R^{2}$ to $4=R^{2}$, a half-integer spin to an integer one (i.e. no spin) and conversely. At the sam e tim e the weak coupling lim it goes to the strong one, N eum ann boundary conditions to $D$ irichlet ones and a description in tem sofLaughlin quasinoles to one in term $s$ of electrons. It also $m$ aps an untw isted sector to a tw isted one ( ! + =2) and conversely. In such a context, the theory w ithout spin is dual to our TM model in which the presence of a spin-1=2 im purity gives rise to tw isted boundary conditions [3].]. In fact the above duality can be explicitly realized as follow s. Let us consider the UV vacuum corresponding to the boundary partition function $Z_{N B_{V}}\left(=0 ; V=\frac{1}{2}\right)$; by perform ing the transform ations: ! $\quad 1$ and

i.e. the partition function $Z_{N B_{V}}\left(D=\frac{1}{2} ; V_{D}=\frac{1}{2}\right)$ corresponding to the $\mathbb{R}$ vacuum. The nite renom alized value of $\mathrm{V}_{\mathrm{D}}$ is the consequence of the non-perturbative multi-solitons corrections (see ref. $[\overline{4}]$ ] for details). M oreover the e ect of the spin-1=2 im purity (a quasihole im purity in our case) is to induce tw isted boundary conditions (i.e. $=0!=2$ ). This is the analog of the non $F$ erm iliquid behavior of the overscreened K ondo problem. M oreover, the duality betw een the two xed points with tw isted (untw isted) boundary conditions im plies that two equivalent descriptions exist in which the role of the electrons and quasiholes gets exchanged. T hat extends the dually between Laughlin quasiparticles and electrons to the quasiholes which characterize the paired states. In this case the im purity spin, which is not present in the classic problem of tunneling between edge states in the fractional Q uantum H alle ect, plays a crucial role, as discussed before. The im purity spin leads us to de ne a larger group w ith respect to the $m$ odular transform ations in which it also plays a role: the \duality" group.

It is useful now to give a physical interpretation of our results in term s of dissipation. The present fram ew ork adapts very well to the description of an im purity interacting w ith a them albath which is realized in term softw o kinds of light particles (i.e. the tw $\circ Q$ uantum $H$ allF luids). The dissipation is given by the kinetic term for the two uids and a periodic potential is added. This problem can be solved in the two regim es of strong and week \cormgation" [īin] and ow occurs tow ard the
stable point. W hen a magnetic term is added for the im purity, the system drastically changes its properties and a m ore stable point with $=\quad=1=2$ appears. The e ect of $\quad 0$ is to rotate the current $J$ getting a $\backslash m$ etallic" com ponent (see eq. ( $(\bar{\theta})$ ) ). In the two layers system this im plies that a current ow sbetween the layers due to the tw isted boundary conditions.
$F$ inally we point out that this description can be also applied to a system of two $B$ ranes interacting $w$ ith strings as it was proposed in [ $[1 \overline{2} \overline{1}]$.
