# EDGE CURRENTS IN NON-COMMUTATIVE CHERN-SIMONS THEORY FROM A NEW MATRIX MODEL

#### Abstract

This paper discusses the form ulation of the non-commutative Chem-Simons (CS) theory where the spatial slice, an in nite strip, is a manifold with boundaries. As standard products are not correct for such manifolds, the standard non-commutative CS theory is not also appropriate here. Instead we form ulate a new nite-dimensional matrix CS model as an approximation to the CS theory on the strip. A work which has points of contact with ours is due to Lizzi, Vitale and Zampini where the authors obtain a description for the fuzzy disc. The gauge elds in our approach are operators supported on a subspace of nite dimension N + of the Hilbert space of eigenstates of a simple harm onic oscillator with N; 2 Z<sup>+</sup> and N  $\notin$  0. This oscillator is associated with the underlying M oyal plane. The resultant matrix CS m odel has a fuzzy edge. It becomes the required sharp edge when N and

! 1 in a suitable sense. The non-commutative CS theory on the strip is defined by this limiting procedure. A fler performing the canonical constraint analysis of the matrix theory, we not that there are edge observables in the theory generating a Lie algebra with properties similar to that of a non-abelian K ac-M oody algebra. Our study shows that there are (+1)<sup>2</sup> abelian charges(observables) given by the matrix elements  $(A_{1})_{N-1N-1}$  and  $(A_{1})_{nm}$  (where n orm N) of the gauge elds, that obey certain standard canonical commutation relations. In addition, the theory contains three unique non-abelian charges, localized near the N<sup>th</sup> level. We observe that all non-abelian edge observables except these three can be constructed from the (+1)<sup>2</sup> abelian charges above. U sing som e of the results of this analysis we discuss in detail the limit where this matrix model approximates the CS theory on the in nite strip. Finally, we include a short section containing our comments on the commutative limit of ourm odel, where we also give a closed form ula for the central charge of the K ac-M oody-like algebra of the non-commutative CS theory in terms of the diagonal coherent state matrix elements of operators and star products.

#### 1 Introduction

Recently, there has been much interest in form ulating Chem-Sim onstheories on non-commutative manifolds [1]. In [2] the non-commutative CS theory has been used for the purpose of obtaining a new description of the Quantum Hall E ect (QHE). Polychronakos [3] and M orariu and Polychronakos [4] have proposed nite-dimensional matrix models of CS theory and used them to explain certain properties of the Fractional Quantum Hall E ect (FQHE).

In this paper we report on our work on the form ulation of non-commutative CS theory where the spatial slice, an in nite strip, is a manifold with boundaries. It can serve to describe noncommutative QHE in such a strip.

There have been previous attempts to carry out such a formulation on a disc and on a halfplane in the presence of spatial non-commutativity [5, 6]. The main obstacle faced in these attempts can be traced to the absence of a well-de ned ?-product for these types of manifolds. We discuss this problem in the beginning of section 3 in some detail to better explain our motivation and the need for the matrix CS model we introduce afterwards. Recently, Pinzuland Stem [7] have studied the CS theory written on a non-commutative plane with a hole'. They have shown that in this case the algebra of observables is a nonlinear deformation of the w<sub>1</sub> algebra. In another work [8], Lizzi, V itale and Zampinihave formulated a fuzzy disc, on which the non-commutative CS theory can be formulated. It has overlaps with our work here and has also points of contact with [5].

Our model stems from taking gauge elds as operators supported on an N + -dimensional subspace of the Hilbert space, where N; 2 Z<sup>+</sup> and N € 0. It is spanned by the eigenstates of a simple harm onic oscillator associated to the underlying M oyal plane. The resultant m atrix CS model has a fuzzy edge and it becomes the required sharp edge when N and ! 1 in a suitable sense. The non-commutative CS theory on the strip is de ned by this limiting procedure. In this fram ework we perform the canonical constraint analysis for the nite-dimensional matrix CS model and nd out that there are edge observables in the theory generating a Lie algebra with properties sim ilar to that of a non-abelian K ac-M oody algebra. Our study shows that there are  $(+1)^2$  \abelian" charges (observables) given by the matrix elements  $(\hat{A}_i)_{N-1N-1}$  and  $(\hat{A}_i)_{nm}$ N) of the gauge elds, that obey certain standard canonical commutation (where norm relations. In addition, the theory contains three unique \non-abelian" charges, localized near the N<sup>th</sup> level. We show that all \non-abelian" edge observables, except these three can be constructed from the  $( + 1)^2$  \abelian" charges above. U sing some of the results of this analysis we discuss in detail the limit where this matrix model approximates the CS theory on the in nite strip. F inally, we discuss the commutative limit of our model, where we also give a closed form ula for the central charge of the Kac-M oody-like algebra of the non-commutative CS theory in terms of the diagonal coherent state m atrix elements of operators and star products.

The organization of our paper is as follows: In section 2 we start with a brief review of the form ulation of edge currents in a commutative CS theory on an in nite strip. Here we also demonstrate how one can form ulate these edge e ects while working on the fullplane and encoding the boundary structure in the test functions. The next three sections system atically develop the ideas outlined in the last paragraph. We conclude with highlighting the main results of our work and their possible physical signi cance.

#### 2 Edge Currents R evisited

Here we brie y review the derivation of K ac-M oody algebra obeyed by edge observables in an abelian Chem-Sim ons theory. Results sum marized in this section are well-established and extensively discussed in [9, 10]. We consider the simplest case of an in nite strip (say in  $x_2$  direction) in R<sup>2</sup> R<sup>1</sup>, where R<sup>1</sup> stands for time. This formulation closely follows the one given in [10] for a disc. Here we also describe another way in which we can work on the full plane and encode the boundary structure in the dom ains of the test functions. This will serve as a prototype approach we shall use for the nite-dimensional matrix CS model.

Let x  $(x_1; x_2)$  denote the points of  $\mathbb{R}^2$ . The strip T is dened by

The usual action for the abelian Chern-Sim ons theory on T is  $^{7}_{\rm Z}$

The gauge elds satisfy the equal time Poisson Brackets (P.B.'s)

From the variation of S under A  $_0$  we have the G auss law constraint, which can be written by introducing test functions  $^0$  as

Dierentiability of g( $^{0}$ ) in poses the condition  $^{0}_{QT} = 0$ . Using (3) and (4) it can be shown that g( $^{0}$ ) are rst class constraints:

and generate the gauge transform ations  $A ! A d^{0}$ .

The charges of this theory are

they constitute the observables of this theory. We note that are test functions associated with q()'s and unlike <sup>0</sup> they in general do not vanish on QT.

Now note that for  $_1 _2 = {}^0$ ,

This means that test functions which are equal on @T generate charges which are equal modulo constraints. Thus, q() are indeed edge observables. They generate the transform ations A ! A d which do not necessarily vanish on @T.

The PB 's of charges can be identied to be the U (1) Kac-M oody algebra on @T, since

Choosing the basis for the test functions on @T as

(9) can be written as

which is the usual form of the U (1) Kac-M oody algebra.

An equivalent formulation of the above can be given as follows. Consider the CS theory on  $R^2 = R^1$ . However, now the spatial components of the gauge elds are supported in the region  $jx_1 j = L$  (i.e. in T), whereas  $A_0$  has support in  $jx_1 j < L$ . Obviously, (3) holds now only if  $x_1; x_1^0 \ge T$ , otherwise its R H S. vanishes.

From the variation of S under A  $_0$  we still have the G auss law constraint

where now the integration is over  $\mathbb{R}^2$ . The condition that <sup>0</sup>'s are supported in  $\mathbf{j}_1\mathbf{j} < L$  follows from that of  $A_0$  which is of course the same as that of  $A_0$ . Thus we have

The results of the canonical analysis (given in (5)-(7)) go through where now integrals are over all  $\mathbb{R}^2$  and  $^0$  is as given in (13). This establishes G ( $^0$ )'s as rst class constraints and

as the observables. Clearly, can be supported on all of R<sup>2</sup>, but if it is supported only on R<sup>2</sup> nT (i.e.  $\dot{x}_1 j > L$ ) then we immediately see from (14) that Q() 0.

It follows from this and the remark after (14) that Q () are observables localized at  $x_1 = L$ . The P.B.'s of charges gives the Kac-M oody algebra:

A suitable choice for 's to compute this algebra at  $x_1 = L$  is

where  $(x_1 L)$  is the step function centered at  $x_1 = L$  with (0) = 1. Then we have from (16) that

which is the same as (11). In order to get the algebra of observables at  $x_1 = L$  one has to replace (17) by

This way of treating edge properties is not completely new and has examples in planar system s of condensed matter physics [11]. We now turn our attention to the treatment of the non-commutative case.

- 3 Non-commutative Chern-Sim ons Theory on the In nite Strip
- 3.1 Remarks on the Non-commutative CS theory on a Manifold with Boundaries

A spointed out by [5, 6] the canonical form ulation of C hem-Sim ons theory on a non-commutative manifold with boundaries (such as a disc, an in nite strip etc.) presents serious di culties. In fact the problem underlying such a form ulation is that the standard ?-product on the M oyal plane is no longer valid on manifolds with boundaries. To make this point clear and supply enough m athem atical basis for this assertion let us consider rst the C hem-Sim ons action on the M oyal plane with no boundaries:

Here (; ; = 0;1;2),  $x_0$  is time  $x_1$  and  $x_2$  are coordinates on the M oyal plane and  $"_{123} = 1$ . The M oyal algebra is characterized by the ?-product

the spatial non-commutativity can be expressed as

being the non-com mutativity parameter.

Naively, one may consider  $S_{NCCS}$  on a manifold with boundaries, say the in nite strip T, and write the Gauss law constraint as  $\frac{7}{2}$

where (i; j = 1; 2) and  ${}^{0}_{\mbox{\scriptsize @T}} = 0$ . However, this expression as well as the  $S_{NCCS}$  when written on the strip T is not well de ned. This is because  $?_{M}$  product does not exist on T. To prove this fact we note that the formula for the  $?_{M}$  product in (21) contains the exponential of the di erential operator  $i@_{x_{1}}$ . With the usual de nition of its domain  $i@_{x_{1}}$  generates translations so that  $e^{i(-ic@_{x_{1}})}$  translates functions of  $x_{1}$  by  $c: e^{i(-ic@_{x_{1}})}$  ( $x_{1}$ ) = ( $x_{1} + c$ ). Consequently, if has support [ L;L],  $e^{i(-ic@_{x_{1}})}$  does not, and  $?_{M}$  is not de ned on functions supported in [ L;L] [12].

A lternatively, to circum vent the impossible task of obtaining a well-de ned and useful ?product on these types of manifolds we propose a nite-dimensional matrix model where the edges are fuzzy. It becomes the CS theory on a non-commutative in nite strip in the limit where the size of the matrices approaches in nity. In this respect, we emphasize that our approach is completely dierent from the previous attempts in the literature as the following section illustrates.

#### 3.2 The Matrix Model

We now describe our matrix model. Since we will be working in the operator formalism in this subsection, we discriminate the operators from the elements of the corresponding M oyal? algebra of functions by putting a hat symbol on the elements of the former. Thus the M oyal plane is described by operators  $\hat{x}_i$  (i = 1;2) with the relation

To supply the m athem atical basis for our arguments we think of a simple harm onic oscillator in the  $x_1$ -direction, described by the H am iltonian

and the oscillation frequency  $! = \frac{k}{m}$ . Now consider the Hilbert space H spanned by the eigenstates of this H am iltonian. In the matrix CS model we will construct H will be associated to the underlying M oyal plane, and its nite-dimensional subspaces will serve as the carrier spaces of the operators that we are going to introduce in our matrix model. M ore precisely, we will de ne these operators in terms of their action on the elements of a nite-dimensional subspace of H and its orthogonal complement.

The number of energy eigenstates of this Ham iltonian below the energy  $E = \frac{1}{2}kL^2$  with L being the maximum classical amplitude (given by the location of the edges) is nite and given by

where  $\left[\frac{kL^2+}{2!}\right]$  is the largest integer smaller than  $\frac{kL^2+}{2!}$ . These M states span a subspace H<sub>M</sub> of the harmonic oscillator H ilbert space H and they can be taken as an orthonorm all basis in

 $H_{M}$ <sup>1</sup> From (27) it is easy to see that keeping both oscillation frequency ! and the maximum oscillation amplitude L xed while increasing k (i.e. steepening the potential) results in larger  $\frac{1}{2}$ kL<sup>2</sup>. Hereafter we keep ! xed unless otherwise stated. Let num ber of states with energy E M. Then the large K M levels with energy E  $\frac{1}{2}$ kL<sup>2</sup> get us consider a level K with K localized near the edges  $x_1 =$ L, since their probability amplitudes are maximum there. On the  $\frac{1}{2}$ kL<sup>2</sup> are localized well inside L contrary, those levels with E ¥ L for large M . W e also note that all levels decay exponentially outside  $jx_1 j = L \cdot L$  inear operators on  $H_M$  which are zero on the orthogonal com plem ent  $H_{M}^{?}$  behave also in a similar fashion. Later we will show that diagonal coherent state m atrix elements of operators, say like K > K jwith K M willpeak near L for all is j< M for large M, while those with K much less than M acquire maxima within  $jx_1 j < L$ . The characteristic width of the peaks at L, which gets narrower as M gets larger, gives us a natural scale to which we will relate the thickness `of the \fuzzy edge" of our m atrix m odel.

For the nite-dimensional matrix CS theory we have in mind, we treat spatial components of the gauge elds as operators supported on this M-dimensional subspace  $H_M$  of H. This and the physical picture described above for the underlying M oyal plane in ply two immediate consequences:

It is those states contained within the thickness `of the edges that will be responsible for the edge observables in our nite-dimensional matrix CS model;

The M ! 1 lim it of this matrix CS theory can be taken to de ne the non-commutative CS theory on the in nite strip with boundaries at  $x_1 = L$ .

A first writing the matrix CS model and performing the constraint analysis for it, we will nd these observables, and we will have the necessary information to explain and elaborate on the properties of the large M limit and how it is realized.

We now split M as M = N + where N; 2 Z<sup>+</sup> and N  $\leq$  0, and use this separation of the total dimension to de ne the domains and the ranges of our operators. In our form alism the gauge elds  $\hat{A}$ ; (= 0; iwhere i = 1; 2) are anti-H erm it in operators that we choose to take in the way given below:

Here for any K 2  $Z^+$ ,  $H_K^2$  denotes the orthogonal complement of  $H_K$ . The fact that  $\hat{A_0}$  is nonzero only on  $H_N_{-1}$  and not on  $H_{N+}$  should be noted. The reason behind this condition will be explained later in connection with the canonical analysis of the model.

If  $j_n > denotes the n<sup>th</sup> norm alized energy level and <math>\hat{P}_{nm}$  is the operator given by  $\hat{P}_{nm} = j_n > < m j$  then we can write,

Several remarks about properties of  $L_{NCCS}$  are in order. First,  $L_{NCCS}$  changes by total derivatives under in nitesim algauge transform ations of the form

where  $\hat{}$  is a matrix with in nitesimal elements. Next, as in Chem-Simons theory on a commutative manifold, the conjugate momenta  $\hat{}_0$  to  $\hat{A_0}$  are weakly equal to zero and next class, thus  $\hat{A_0}$  is not an observable and can be eliminated from the rest of our discussion.

The equal time PB s of  $(\hat{A}_i)_{nm}$  can be written as

#### 3.3 Canonical Analysis of the Matrix Model

From the variation of  $L_{NCCS}$  with respect to  $\hat{A_0}$ , we have the Gauss law constraint

Equation (39) is the statem ent of G auss law in ourm atrix m odel and  $^{0}$ 's are non-commutative analogues of the test functions of the commutative CS theory.

\Integrating" by parts  $g(^{0})$  can be written as

In fact one can take the vanishing of the central term as a requirement on  $^{0}$ 's and nd out that the maximally large subspace of H where  $^{0}$  is supported and for which (56) holds is H<sub>N</sub> 1. This explains how we arrive at the particular form of the operators for  $\hat{A}_{0}$  and  $^{0}$  given in (28) and (40) respectively.

As a consequence of (58), q()'s w ith  $^{=} ^{0} + ^{0}$  are rst class, and they constitute a set of non-abelian observables of our matrix m odel.

Furtherm ore, for

In order to discuss implication of these results we need one more ingredient, this is contributed by the PB.

for norm N and for n = m = N 1. Thus  $A_{1}^{\prime}_{nm}$  for norm N and  $A_{i}^{\prime}_{N-1N-1}$  are observables of our matrix theory. The algebra of these observables is standard and given by (36) together with the same restrictions on indices r and s as on n and m. It is easy to see that for xed N and there are  $( + 1)^2$  of these observables. For instance, for = 0 we have  $(A_i)_{N-1N-1}$  as an observable, for = 1, we have  $(A_i)_{N-1N-1}$ ,  $(A_i)_{N-N}$ ;  $(A_i)_{N-N-1}$ ;  $(A_i)_{N-1N}$  as observables.

From (62) we see that the observables  $q(\hat{})$  generate a nite-dimensional Lie algebra with properties similar to a non-abelian K ac-M oody algebra. The dimensional Lie algebra is nite-dimensional and its central charge is modiled, due to the appearance of the projectors  $\hat{1}_{N+}$  in the expression.

Independently of the value of , q() is nonzero for nonzero entries of  $_{N \ 1N \ 1}$ ;  $_{N \ 1N \ 1N}$  and  $_{N \ N \ 1}$  in a given  $\hat{}$ . Thus we have three unique non-abelian K ac-M oody-like observables. For xed N and the rest of such non-abelian observables are (+2)<sup>2</sup> 1 3 = (+4) in num ber and they can be constructed from the (+1)<sup>2</sup> observables ( $\hat{A}_{1}$ )<sub>nm</sub> given above.

We now investigate the lim it M ! 1 .

## 4 The Large M Limit

First we introduce the coherent state  $j_z > by$


Substituting (68) into (65) we de ne the L H S. of the resulting expression by

From Eqn. (65) we see  $P_M_1$  has maxima<sup>2</sup> at the value  $z = z_0$  given by  $jz_0 \hat{f} = (M_1)$ . This implies that the function  $Q_M_1(x_1;x_2)$  has maxima on an ellipse given by

the axes of the ellipse being given by  $\frac{q}{\frac{M-1}{M-\frac{1}{2}}L}$  and  $\frac{2}{L}$   $\frac{q}{(M-1)(M-\frac{1}{2})}$  respectively. Now holding constant and taking M large we see from Figure 1 that the maxima of  $Q_{M-1}(x_1;x_2)$  have the geometry of an ellipse which is extended along the  $x_2$  direction. For large M and xed and L this conclusion is also seen from the ratio of sem in a jor axis of the ellipse to its sem in inor axis, which is approximately  $\frac{2}{L}$  M : L. From this reasoning and from Figure 1 and Figure 2 we conclude that the extended elliptical geometry in the limit M ! 1 converges to an in nite

strip along the  $x_2$  axis with peaks at  $x_1 = L$ . This proves our assertion in section 3.2 about the behavior of diagonal coherent state matrix elements of operators on  $H_M$  for large M.

In order to get a measure of the sharpness of the maxim a of Q<sub>M</sub> 1, we now compute the width of the function Q<sub>M</sub> 1 at  $x_1 = \frac{M-1}{M-\frac{1}{2}}L$ ;  $x_2 = 0$ , the computation for  $x_1 = \frac{M-1}{M-\frac{1}{2}}L$ ;  $x_2 = 0$  being similar. It may also be noted that although we do the computation at  $x_2 = 0$  our result is valid for all  $\dot{x}_2$  jindependent of M in the large M limit, where the geometry is that of an in nite strip. Let the width of the maxim a of the function  $Q_M$  1 by denoted by  $x_1$ . We estimate  $x_1$  by imposing the requirement that  $Q_M$  1 ( $x_1 + \frac{1}{2} x_1$ ;  $x_2 = 0$ ) =  $\frac{1}{e}Q_M$  1 ( $x_1$ ;  $x_2 = 0$ ). For large values of M, the width  $x_1$  can be obtained (using M aple) as

Thus the width  $x_1$  gets narrow er as M gets larger. It is how ever, in portant to remark the following: The value of the maxim a of  $Q_{M-1}$  for large M is proportional to  $\frac{p}{M-1}$ . This implies that for  $_{R}$  xed , the height of the peaks decreases as M gets larger. Nevertheless, the normalization integral  $Q_{M-1}(x_1;x_2)d^2x = 1$  is preserved. A rough estimate of the volume under the graph of  $Q_{M-1}$  would be enough to see that this is the case. For large values of M, the width  $x_1 = \frac{p_{M-1}^1}{M}$ ,

the height h  $\frac{p_{M}^{1}}{M}$  and  $x_{2}$  extends to order M. Thus for large values of M, the volume under the graph is independent of M.

It is natural to take the thickness `of the Yuzzy edge"'s in our matrix model to be given by the characteristic width  $x_1 \text{ of } Q_M_1$ . As M ! 1 we have  $x_1 = \frac{pL}{M} ! 0$ , and consequently we get sharp boundaries (i.e. thin edges) at L. Thus this limit de nes the non-commutative CS theory on the in nite strip.

W e end this section by estimating the spacing between the edge states of ourmodel. First recall that for a given  $2 Z^+$ , the number of edge states in our matrix model is  $(+2)^2 1 + 2$ . Let (M) be the spacing of these edge states. As argued before, the thickness 'of the \fuzzy edge" is given by  $x_1$ . We therefore have

However, we note that by construction of our model we have 0 < M. This enables us to extract both an upper bound and a lower bound for the spacing of the edge states (M). Thus in the large M limit, using (71) and (72), we not that

## 5 Commutative Limit

In this section, we would like to comment on the commutative limit of our matrix model dened by M ! 1 and ! 0. First, we dene F (z;z)  $= \langle z \mathbf{j}^{\hat{r}} \mathbf{j} \mathbf{z} \rangle$  for an arbitrary operator  $\hat{F}$ . The standard star product is then given by

we can express (62) in the diagonal coherent state representation as

The rst term in R H S. of the above expression vanishes as ! 0 since the ?-product becomes the ordinary product and the commutator of functions  $_i$  under ordinary product is zero. A loo in this limit, we see from (31) that  $\hat{1}_M$  ! 1. Using these in (76) we recover the standard U (1) K ac-M oody algebra of the edge observables of commutative CS theory:

In getting this nalresult we have made use of the identity [13] Z = Z

where  $\mathbb{F}(x_1;x_2)$  denotes the M oyal representation of the operator  $\hat{F}$ , and the fact that the  $?_M$  is removed under integration over the M oyal plane.

Finally it may be noted that the parameter may tend to zero in dierent fashions resulting to dierent geometries in the commutative limit. For example, taking  $p\frac{1}{M}$  still gives a strip geometry in the large M limit. In this case the height of the maxim a of the function  $Q_{M-1}(x_1;x_2)$ at  $x_1 = L$  is constant,  $x_2$  extends to M and  $x_1$  varies as  $\frac{p1}{M}$ . To be more precise for all M ! 1 as M ! 1 results in a strip geometry. On the other hand, as discussed by Lizzi, V itale and Zampiniin [8], the ! 0 limit keeping the product M xed gives the geometry of a disc.

## 6 Concluding Remarks

In this work we have form ulated the Chem-Sim ons theory on an in nite strip on the M oyal plane. O ur form ulation involved the construction of a new m atrix C S m odelwhose features are associated with the underlying M oyal plane. Performing canonical analysis revealed that this matrix m odel has fizzy" edges whose thickness ', we found out to be inversely proportional to M in the large M limit. Thus in this limit ourmatrix m odel approximated the non-commutative C S theory on the in nite strip. O ur results show that the edge observables on the boundaries of the non-commutative in nite strip are given by a nite-dimensional Lie algebra with properties similar to that of a non-abelian K ac-M oody algebra. O ur notings generalize the well-known results of the usual C S theory to non-commutative manifolds with boundaries, thereby opening new possibilities for the treatment of non-commutative Q uantum Hall E ect and for other applications in such dom ains.
