# Edge states for quantum $H$ all droplets in $h$ igher dim ensions and a generalized W ZW m odel

#### Abstract

W e consider quantum $H$ alldroplets on com plex projective spaces $w$ th a com bination of abelian and nonabelian background $m$ agnetic elds. C arrying out an analysis sim ilar to what was done for abelian backgrounds, we show that the e ective action for the edge excitations is given by a chiral, gauged $W$ ess-Zum ino-w itten (W ZW ) theory generalized to higher dim ensions.

## 1 <br> Introduction

The study of quantum $H$ alle ect in dim ensions higher than tw o and especially the edge excitations ofquantum H alldroplets have been of som e research interest follow ing the originalanalysis by Zhang and $\mathrm{Hu} \quad T$ hey considered the Landau problem for charged ferm ions on $S^{4} w$ th a background $m$ agnetic eld corresponding to the standard SU (2) instanton. In this case, the edge excitations, which correspond to the deform ations of the edge of a quantum H all droplet, are gapless, as in two dim ensions, but now have spin degrees of freedom as well. In particular, one could have spintw o gapless excitations suggesting an altemate description of the graviton. A though this has not been bom out in the expected fashion, edge excitations for a quantum $H$ all droplet lead to a very interesting class of eld theories. The original model has by now been extended to many new geom etries and contexts In a recent paper, we gave a general m ethod for obtaining the e ective action for the edge excitations of a quantum $H$ all droplet $T h i s w a s$ applied to higher dim ensional quantum $H$ all system $s$, speci cally for droplets in the complex projective space $C P^{k}$. On C P ${ }^{k}$ one can have abelian or nonabelian background $m$ agnetic elds. In the case of an abelian background, which w as analyzed in the edge excitations can be described in term $s$ of a chiral action for an abelian bosonic eld. For C $P^{1}=S^{2}$, this is the well known onedim ensional chiral bosonic action, de ned on the boundary $S^{1}$, which describes the edge excitations of the $=1$ tw o-dim ensional Q HE

For general even dim ensional spaces $C P^{k}$, the notion of chirality is expressed by the fact that there is a preferred direction along the $S^{2 k}{ }^{1}$ droplet boundary which is relevant for the dynam ics of the edge excitations. This is determ ined by the K ahler form of $\mathrm{C} \mathrm{P}^{\mathrm{k}}$. The e ective action is eventually integrated over all tangential directions. The bosonic eld itself can be expanded in term $s$ of the boundary surface oscillation $m$ odes of the incom pressible droplet. $T$ his analysis also leads to the edge action for $Q H E$ droplets on $S^{4}$, using the fact that $C P^{3}$ is an $S^{2}$ toundle over $S^{4}$.

In this paper we extend our analysis of the edge e ective action in the case of nonabelian background $m$ agnetic elds, thus com pleting the fullderivation of the edge action for allbackgrounds. ${ }^{2}$ In this case the edge excitations are described in term s of a m atrix valued bosonic eld and the corresponding e ective action is given in term sof a higher dim ensional generalization of a nonabelian, chiral, gauged W ess-Zum ino-W ilten action. The form of the action suggests som e kind of scale invariance and the possibility of an elegant current algebra structure. Therefore we believe these actions de ne an interesting new class of theories in higher dim ensions which are worth studying in their ow n right.

This paper is organized as follows. In section 2, we review brie y the results for the edge e ective action for quantum $H$ all droplets in $C P^{k}$ with a $U$ (1) background eld and state the $m$ ain result that we derive for the nonabelian case. In section 3 we present a detailed analysis $w$ hen the background eld is $U(k)$. T he e ective action for the edge excitations is derived in the lim it where the num ber of states of the lowest Landau level, $N$, becom es very large. W e start w ith a discussion of the low est Landau level (LLL) wavefunctions. W e then discuss star products and evaluate the large $N$ lim it of operator com $m$ utators in term $s$ of sym bols, which are classical functions corresp onding to operators. U sing this we derive the large N lim it of the kinetic energy

[^1]term of the action. W e separately evaluate the sym bol corresponding to the density operator and using this we sim plify the potential energy term. W e nally combine everything to arrive at the e ective action which is given in equation of a chiral, gauged W ess-Zum ino-w itten (W ZW ) theory. In section 4 we discuss in m ore detail properties of this e ective action and we point out sim ilarities to other higher dim ensionalW ZW m odels, such as the $K$ ahler W ZW m odels The paper is concluded w ith a short discussion.

## 2 Thee ective action for edge states

The e ective action for edge states $w$ as obtained in by considering uctuations of the density $m$ atrix follow ing the strategy used by Sakita in the case of the two-dim ensional droplet. W e shall begin by brie $y$ recalling the essential points of this $m$ ethod. Let $\wedge_{0}$ be the density $m$ atrix corresponding to the droplet. Allelem ents of $\wedge_{0}$ are zero except for the diagonalones corresponding to the lled states, for which it is equal to one. Tim evolution of $\wedge_{0}$ is given by a unitary matrix $\hat{U}$. T he action which determ ines $\hat{U}$ is given by

where $\hat{H}$ is the $H$ am iltonian. W e used the following strategy in sim plifying this action. First of all, we restrict to the single particle $H$ ibert space, since it is a good approxim ation to neglect any dynam ically correlated states of two or m ore ferm ions. This is essentially a H artree Fock approxim ation. For a droplet in the lowest Landau level (LLL) or any xed Landau level, we can then take the H am iltonian, up to an additive constant, as the potential $\hat{V}$ which con nes the particles to the droplet. If $N$ is the dim ension of the one-particle $H$ ilbert space and $K$ states are occupied, we can simplify by taking N ! 1 and K very large but nite.

We will rst recapitulate the results for an abelian background. As we have shown in the LLL states are characterized by an integer $n \quad B R^{2} w h e r e B$ is the $m$ agnetic eld and $R$ is the radius of the $C P^{k}$; the dim ension $N$ of the $H$ ilbert space corresponding to the LLL sector depends on $n$, in particular $N \quad n^{k}$ and scaling is done $w$ ith $R \quad P \bar{n}$. In the large $N$ lim it two $m$ ain results were used to identify the edge e ective action.

1. The operator com $m$ utators tend to the P oisson brackets of appropriate classical functions, nam ely

$W$ e can $w$ rite $\hat{U}=\exp \left(i^{\wedge}\right)$ for som e herm itian operator ${ }^{\wedge}$, expand various term $s$ in in term $s$ of com $m$ utators and extract their large $N$-lim it. If the background magnetic eld is abelian, the classical eld corresponding to ${ }^{\wedge}$ is a scalar which param etrizes the surface deform ations of the droplet.
2. ${ }_{\mathrm{P}}^{\mathrm{K}}$ The classical function 0 , the symbol corresponding to the density operator $\hat{\mathrm{o}}_{0}=\underset{\mathrm{i}=1}{\mathrm{~K}} \underset{\mathrm{Ji} h i j}{ }$ is essentially a step function identifying the droplet. The term $\frac{@}{@ \mathrm{r}^{2}}$, $w$ here $r^{2}=\quad$, is a -function $w$ ith support only at the edge of the droplet.

U sing these two results and taking into account the scaling properties of various quantities as $n!1$, we found that the nale ective action, up to an additive constant, is of the form

$N$ otioe that the fulle ective action is an edge action de ned on the boundary @D of the droplet D. L involves only derivatives of with respect to a particular tangential direction, which is essentially determ ined by the $K$ ahler form of the $m$ anifold. The density 0 is chosen so as to $m$ in im ize the potential energy, the particles being located at states of $m$ inim um available energy. $V$ is thus a constant along directions tangential to the boundary of the droplet @D, it depends only on the norm alcoordinate $r$. ! is a constant related to the derivative of the potential, in particular $!=\frac{1}{\mathrm{n}} \frac{\mathrm{QV}}{\varrho \mathrm{r}^{2}}$ (the scaling of V is such that $!$ is n independent).

show s that the e ective edge dynam ics involves only the tim e-derivative of and one tangential derivative given by L . The action is chiral in this sense. Generally the eld depends on the rem aining tangential directions, leading to a m ultiplicity ofm odes. For a spherical droplet in even dim ensions $2 \mathrm{k}, @ \mathrm{D} \mathrm{S}^{2 \mathrm{k}}{ }^{1}$. The m ode analysis of the eld has been indicated in In the special case of $C P^{1}=S^{2}$, the corresponding action in is the well known onedim ensional chiralbosonic action describing edge excitations for $=1$ two-dim ensionalQHE

On CP ${ }^{k}=S U(k+1)=U(k)$, it is possible to have a nonzero badkground value for the $S U(k)$ gauge elds as well as the $U$ (1) elds. As m entioned in the introduction, in this paper, we shall carry out a sim ilar large N sim pli cation of the action for a background which has nonzero values for the $S U(k)$ and $U(1)$ subalgebras. O ne of the $m$ ain di erences in the nonabelian case is that now the low est Landau level states belong to a representation of $S U(k+1) w$ ith a low est weight state which transform s nontrivially under $S U(k)$, say, as a representation $J$. As a result, the classical function which is the symbol corresponding to the herm itian operator ${ }^{\wedge}$, is now a matrix of dim ension (dim $\mathcal{J}$ dim $\mathcal{J}$ ). A gain, as in the abelian case, the key to extracting the large $N$ lim it of the e ective action are the two properties 1 and 2 m entioned above, appropriately modi ed in the case of the nonabelian bakground.

Property 2 still rem ains true, w ith the di erence that the sym bol corresponding to the density operator is a diagonalm atrix of dim ension (dim $J \quad d i m ~ J$ ) proportional to a step function, whidh again identi es the droplet.

Property 1 is $m$ ore seriously $m$ odi ed. The large $N \quad \lim$ it of the operator com $m$ utator, due to the $m$ atrix nature of the sym bols, w illnow involve a P oisson bracket-type term along w ith a m atrix com m utator term. In particular

$N$ otice that the $P$ oisson bracket now involves the gauge covariant derivative $D=@+\llbracket \mathbb{A}$; $]$, where $A$ is the $S U(k)$ gauge potential.

The relevant eld in writing dow $n$ the e ective action is a unitary $m$ atrix $G w h i c h$ is an elem ent of $U$ (dim J). As expected, since we have an $S U(k)$ background, the action has an $S U(k)$ gauge sym $m$ etry. The eld space is essentially $U(\operatorname{dim} J)=S U(k)$. The nal result tums out to be a chiral, gauged $W$ ess-Zum inow itten action generalized to higher dim ensions.

$H$ ere the rst term is on the boundary @D of the droplet and it,is precisely the gauged, nonabelian analogue of . The operator $L$ in is the gauged version of

The second term in w ritten as a di erential form, is a higher dim ensionalW ess-Zum ino term ; it is an integral over the rescaled droplet D itself, w ith the radial variable playing the role of the extra dim ension. This term is very sim ilar to the $W$ ess-Zum ino term appearing in $K$ ahler-W essZum inow itten models used in the context of higher dim ensionalconform al eld theories. The e ective action is the m ain result of th is paper.

## 3 A nalysis on CP ${ }^{k}$ w ith a nonabelian background eld

## 1. W avefunctions

W e begin w ith a discussion of the Landau level states and w avefunctions for the case when the background is nonabelian. W ew ill follow the group theoretic analysis given in $\quad$ Since C $P^{k}$ is the coset space $S U(k+1)=U(k)$, the $w$ avefiunctions can be obtained as fiunctions on $S U(k+1)$ which have a speci ctransform ation property under the $U(k)$ subgroup. Let $t_{A}$ denote the generators of $S U(k+1)$ as matrices in the fundam ental representation; we norm alize them by $\operatorname{Tr}\left(t_{A} t_{B}\right)=\frac{1}{2}$ Aв. $T$ he generators corresponding to the $S U(k)$ part of $U(k) \quad S U(k+1) w$ ill be denoted by $t_{a}$, $a=1 ; 2 ; \quad 2 ; k 1$ and the generator for $U(1)$ direction of the subgroup $U(k) w$ ill be denoted by $t_{k^{2}+2 k}$. A basis of functions on $S U(k+1)$ is given by the $W$ igner $D$-functions which are the $m$ atrioes corresponding to the group elem ents in a representation $J$

$w$ here $T_{A}$ are the $S U(k+1)$ generators in the representation to which $g$ belongs. Since $C P^{k}=$ $S U(k+1)=U(k)$, one can have, in general, a background $m$ agnetic eld which is a $U(k)$ gauge eld. P reviously, we concentrated on the case of a $U(1)$ eld, here we are interested in the case of a $U(k)$ background, where the wavefunctions transform as a speci c representation, say $J$, of $S U(k)$, for the action of the right generators $\mathrm{R}_{\mathrm{a}} 2 \mathrm{SU}(\mathrm{k})$ and carry a charge corresponding to the right $\mathrm{U}(1)$ generator $R_{k^{2}+2 k}$. The $U$ (1) generators $L_{k^{2}+2 k}$ and $R_{k^{2}+2 k} w$ illbe referred to as the $\backslash$ hypercharge operators", taking over the standard term inology for $S U$ (3).
$T$ here are $2 k$ right generators of $S(k+1)$ which are not in $U(k)$; these can be separated into $T_{+}$ir $i=1 ; 2 \quad ; k, w h i c h$ are of the raising type andi 1 Tw hich are of the low ering type. The covariant derivatives on $C P^{k}$, in term sof their action on the w avefunctions, can be identi ed w ith these $\hat{R}{ }_{i}$ right rotations on $g$. T his is consistent w ith the fact that the com m utator of covariant derivatives is the $m$ agnetic eld. The commutatons of $\hat{R}_{+i}$ and $\hat{R}{ }_{i}$ are in the Lie algebra of $U(k)$; given the values of these $U(k)$ generators on the $w$ avefunctions, we see that they correspond to constant $m$ agnetic $P_{P}$ elds. In the absence of a con ning potential, the H am iltonian $\hat{H}_{0} \mathrm{~m}$ ay be reduced to the form ${ }_{i} \hat{R}+{ }_{i} \hat{R} \quad$ i, apart from additive constants. The corresponding energy eiaenvalues of $a$ charged particle on C $P^{k}$ in the presence of a nonabelian background are given by

$T$ he states for a representation ofS $U(k+1)$ can be labelled by tw o integens $(P ; Q)$, corresp onding to a tensor of the form $\mathrm{T}_{1} \stackrel{1:::{ }_{\mathrm{p}}}{ }{ }^{Q}$ which is sym m etric in all the upper indices, sym m etric in all the

The fact that $n$ has to be integer implies that ( $\left.\begin{array}{ll}l & l^{0}\end{array}\right)=\mathrm{k}$ is an integer, thus constraining the possible $S U(k)_{R}$ representations $J$.

Since the background $m$ agnetic eld and the representation (or charges) of the $m$ atter eld are the given data for setting up the Landau problem, wem ust identify the wavefunctions for a given $S U(k)$ representation $\mathcal{J}=\left(1 ; 1^{0}\right)$ and $U$ (1) charge $n k . W$ ith $\mathcal{J}$ and $n$ xed, the lowest energy eigenstates correspond to $q=0$. The index $q$ plays the role of the Landau level index. Notice that for $J$ of the form $J=\left(0 ; 1^{0}\right)$, the low est energy eigenstate is the low est weight vector in the representation $J$ of $S U(k+1)$ annihilated by $\hat{R}_{i}$. This choice ofbackground is particularly sim ple and for the rest of the discussion we will consider this case. (For other backgrounds, the e ective action will have the sam e general qualitative features of the action we nd here.) So the LLL states we consider correspond to the tensor $T_{p}^{1^{0}}$, where $p=n \quad \frac{1^{0}}{k}$ and $l^{0}=j k ; j=1 ; 2 ; \quad{ }^{3}$.

The Landau $H$ am iltonian $\hat{H}_{0}$ com $m$ utes $w$ ith the left action. This corresponds to the $m$ agnetic translation sym $m$ etry of the Landau problem $w$ th the left operators $\hat{\mathrm{L}}_{\mathrm{A}}$ representing m agnetic translations. The degeneracy of the LLL states corresponds to the dim ension of the $J=\left(p ; 1^{0}\right)$ representation, where

Thus the rst tem on the right hand side of is evidently a boundary term . T he second term is a (gauged) W ess-Zum ino term for the eld G; the integration is over the droplet whose boundary is the edge @D. U sually the $W$ ess-Zum ino term is written in term $s$ of integration over a three$m$ anifold whose boundary is the spacetim e of interest; in such a representation, the $W$ ess-Zum ino term can be displayed as the integral of a local di erential form. H ere we see that the droplet, along $w$ ith tim e, plays the role of this three-m anifold, the radial variable of the droplet serving as the extra dim ension. O f course this is not really a threem anifold, the actual dim ension is $2 \mathrm{k}+1$. O nly derivatives w ith respect to a particular spatial direction, nam ely $L$, appear in the action. H ow ever, once the integration over the various directions are carried out the result will involve all the coordinates of the edge of the droplet for the rst term. Finally, since the gauged $W$ ess-Zum ino term is the integral of a locally exact form, as show $n$ in the next section, it should be considered as part of the boundary action; it is not a bulk term.

## 4 P roperties of the e ective action

## 1: G auge sym $m$ etry

The e ective action we have derived is a generalized gauged W ZW action. The eld G is a
 we have $m$ entioned earlier, the $U$ (1) gauge eld does not appear in the covariant derivative and in the e ective action.

U sually, in a gauged W ZW action, the kinetic term s have gauge covariant derivatives replacing the ordinary derivatives as in H ow ever, the gauging of the W Z-term is not done by replacing derivatives by covariant derivatives, rather it involves additional term s which are local boundary term $s$ such that the anom alies of the gauge sym m etry cancel out Explicitly, such a gauged W $Z$-term $w$ ith a vector gauge sym $m$ etry is given, for a three-dim ensionalm anifold, by

This is veri ed to be zero using $\left({ }^{1}\right)^{l r}=i\left(E^{1}\right)_{m}^{l}\left(E^{1}\right)_{m}^{r}$ and the fact that $\left.{ }^{P}{ }_{i} \operatorname{tr}\left(t_{a} \mathbb{t}{ }_{i} ; t_{+}\right]\right)=0$. Thus $\left(G^{1} D G\right)^{3}$ does indeed reduce to the usual gauging of the $W$ Z-term for the present case.

In sum $m$ ary, we have a gauged W ZW m odel generalized to higher dim ensions where the eld $G$ takes values in the unitary group $U(\operatorname{dim} J)$ and the gauge group is $S U(k)$, in other words a $\mathrm{U}(\operatorname{dim} \mathcal{J})=S \mathrm{U}(\mathrm{k})$ coset m odel.

## 2: The level num ber of the action

The W Z-term in has the tim e-derivative term separated $O$. W e can write it in a m ore sym $m$ etric fashion as

In com paring this $w$ th the usual $W$ Z-term, we have to take account of an additional factor of $\frac{1}{2}$ $w$ hich arises due to the fact that $r^{2}$, not $r$, is the variable of integration for the extra coordinate'. ( $T$ he volum e elem ent will have a factor rdr; w ith the factor of 2 we inserted inside the integral, this $w$ ill becom e d $\left(r^{2}\right)$.) Equation show $s$ that the level num ber of the $W Z$-term is given by

The right hand side of this equation is entirely in term $s$ of rescaled coordinates, with the radius of the droplet being unity. W e have taken the lim it of large $n$ for the prefactors as well. Thus the term s displayed here are the term swhich have a nite lim it as n! 1 ; the corrections to this action are of order $1=n$.

## 3: C hirality

The e echive action is a gauged $\mathrm{W} \mathrm{ZW}_{\mathrm{i}} \mathrm{m}$ odel and carries a notion of chirality It has the
 is chirality in the theory. The eventual integration over all spatial directions will give an action which has rotational sym $m$ etry, but the tim e-derivative $w$ ill still occur in a sim ilar com bination.

4: Relationship to other higher dim ensionalW Z W m odels
Thee ectiveaction we have obtained is a higher dim ensionalgeneralization of the W ZW action. G oing back to we write it as

This theory has the equations of $m$ otion

leading to antiselfdual elds on M functions of the form $\exp [i S(G)$. T he canonical quantization of the action leads to w aveuncuons of the fom $\exp (G)$ sim ilar to the usual connection betw een the Chem-Sim ons and W ZW theories The action $S(G)$ so obtained is on the boundary of $\left.M \quad t_{i} ; t_{f}\right]$, i.e., on the tw o equaltim e surfaces at $t_{i}$ and $t_{f} w h i d h$ are copies of $M$, for a com pact $M$ w ith no boundary.
$T$ he di erence with our present situation of $H$ all e ect is the follow ing. If we consider not all of $M$ but a certain region $D$ in $M$, there is an additionalboundary @D $\left.t_{i} ; t_{f}\right]$. The analogue of the action on this boundary is w hat we have in the present case.

## 5 D iscussion

W e have derived the e ective action, in the lim it of large num ber of ferm ions, for quantum $H$ all droplets in $C P^{k}=S U(k+1)=U(k)$ in the presence of abelian ( $U(1)$ ) and nonabelian ( $S U(k)$ ) backoround $m$ aometic elds. This result, which is the $m$ ain result of this paper, is sum marized in and . The action describes a higher dim ensional gauged $W$ ZW model. W ith the SU(k) nonabelian background eld, the states of the lowest Landau levelbelong to an $S U(k+1)$ representation $J$, with a set of lowest weight states form ing a representation $J$ of $S U(k)$. The $e$ ective action is for a unitary $m$ atrix eld $G$ which is an elem ent of $U$ (dim J ), which is coupled to the background $S U(k)$ eld in a left-right sym metric or vectorialway. There is an $S U(k)$ gauge invariance to take account of this coupling to the $S U(k)$ gauge eld. Thus, e ectively, the eld space is the coset $U(\operatorname{dim} \mathcal{J})=S U(k)$.

The e ective action we have derived is very sim ilar to the gauged version of the $K$ ahler $W$ ZW $m$ odel used in the context of higher dim ensional conform al eld theories $T$ he $W$ Z-term of this action is de ned on the $(2 k+1)$-dim ensionalm anifold $D \quad R$, corresponding to the droplet $D$ and time. The rest of the action is de ned on $@ D \quad R$, corresponding to the boundary of the droplet and time. The radial variable for the droplet plays the role of the extra dim ension in expressing the W Z-term as the integral of a local di erential form. Further, the action involves the spatial derivative along a particular tangentialdirection on the boundary of the droplet, which is eventually integrated over. There is also a certain chirality property due to the $m$ anner in which the space and tim e derivatives appear. Finally, as exnected, for an abelian background, the action reduces to the chiral $U$ (1) bosonic action given in

The e ective action has a very interesting current algebra structure whidn will have im plications on the nature of the spectrum of edge excitations. This facet of the problem and related issues w ill be analyzed in m ore detail elsew here.

The W ZW theory is well known to lead to conform al eld theories in two dim ensions; in particular it is a xed point under the renorm alization ow. G iven that we nd a generalized version of the W ZW theory, 辻 is natural to ask how it changes under renom alization. W e have not carried out a full study of this question, but the follow ing rem ark $m$ ay be interesting in this context. T he variational problem for the action gives the fill quantum dynam ics. A part from assum ing a $H$ artree Fock type factorization of them any-body w avefunctions in term sofone-particle w avefiunctions, which was explained in we have not $m$ ade any other approxim ation. T hus the e ective action we derived is the exact quantum action in the large $n$ lim it as far as states in the
low est Landau level are concemed. C ontributions from virtual transitions to higher Landau levels have not been calculated.

For a Ferm i liquid in dim ensions higher than one, expansion around the Ferm i surface has been used to rew rite the low energy excitations in term sof a set of one-dim ensionalm odels which can be bosonized. W hat we have done here is sim ilar; our result $m$ ay be view ed as a partial bosonization which is adequate for the low energy excitations.
$F$ inally, we note that while quantum $H$ alle ect and the droplet picture $m$ ay serve as a physical picture for this class of theories, they can be given an independent form ulation. The Landau levels and the e ective eld $G$ are sections of appropriate $H$ boundles on $a G=H$ space. Thekinetic term of the e ective action is an analogue of the $K$ irillov form. T hus the class of theories we are discussing $m$ ay be view ed in a purely geom etric way. It is also clear that these theories $m$ ay have som $e$ relevance to the dynam ics of droplets of incom pressible uids in general.
