Edge states for quantum Halldroplets in higher dim ensions and a generalized W ZW model

A bstract

We consider quantum Hall droplets on complex projective spaces with a combination of abelian and nonabelian background magnetic elds. Carrying out an analysis similar to what was done for abelian backgrounds, we show that the elective action for the edge excitations is given by a chiral, gauged Wess-Zumino-Witten (WZW) theory generalized to higher dimensions.

1 Introduction

The study of quantum Halle ect in dimensions higher than two and especially the edge excitations of quantum Hall drop lets have been of som e research interest following the original analysis by Zhang and Hu [1]. They considered the Landau problem for charged ferm ions on S4 with a background magnetic eld corresponding to the standard SU (2) instanton. In this case, the edge excitations, which correspond to the deform ations of the edge of a quantum Hall droplet, are gapless, as in two dimensions, but now have spin degrees of freedom as well. In particular, one could have spintwo gapless excitations suggesting an alternate description of the graviton. Although this has not been born out in the expected fashion, edge excitations for a quantum Hall droplet lead to a very interesting class of eld theories. The original model has by now been extended to many new geom etries and contexts [2]-[4]. In a recent paper, we gave a general method for obtaining the e ective action for the edge excitations of a quantum Hall droplet [5]. This was applied to higher dim ensional quantum Hall systems, specically for droplets in the complex projective space CP k. On CP k one can have abelian or nonabelian background magnetic elds. In the case of an abelian background, which was analyzed in [5], the edge excitations can be described in terms of a chiral action for an abelian bosonic eld. For $CP^1 = S^2$, this is the well known one-dimensional chiral bosonic action, de ned on the boundary S¹, which describes the edge excitations of the two-dim ensional QHE [6]. For general even dim ensional spaces CP $^{\rm k}$, the notion of chirality is expressed by the fact that there is a preferred direction along the S^{2k-1} droplet boundary which is relevant for the dynam ics of the edge excitations. This is determined by the Kahler form of CP k. The e ective action is eventually integrated over all tangential directions. The bosonic eld itself can be expanded in term s of the boundary surface oscillation m odes of the incom pressible droplet. This analysis also leads to the edge action for QHE droplets on S⁴, using the fact that CP³ is an S^2 -bundle over S^4 .

In this paper we extend our analysis of the edge e ective action in the case of nonabelian background magnetic elds, thus completing the full derivation of the edge action for all backgrounds. ² In this case the edge excitations are described in terms of a matrix valued bosonic eld and the corresponding e ective action is given in terms of a higher dimensional generalization of a nonabelian, chiral, gauged Wess-Zumino-Witten action. The form of the action suggests some kind of scale invariance and the possibility of an elegant current algebra structure. Therefore we believe these actions de nean interesting new class of theories in higher dimensions which are worth studying in their own right.

This paper is organized as follows. In section 2, we review brie y the results for the edge e ective action for quantum Hall droplets in CP^k with a U (1) background eld and state the main result that we derive for the nonabelian case. In section 3 we present a detailed analysis when the background eld is U (k). The e ective action for the edge excitations is derived in the lim it where the number of states of the lowest Landau level, N, becomes very large. We start with a discussion of the lowest Landau level (LLL) wavefunctions. We then discuss star products and evaluate the large N lim it of operator commutators in terms of symbols, which are classical functions corresponding to operators. Using this we derive the large N lim it of the kinetic energy

term of the action. We separately evaluate the symbol corresponding to the density operator and using this we simplify the potential energy term. We nally combine everything to arrive at the elective action which is given in equation (9). This action is a higher dimensional generalization of a chiral, gauged Wess-Zum ino-Witten (WZW) theory. In section 4 we discuss in more detail properties of this elective action and we point out similarities to other higher dimensional WZW models, such as the Kahler WZW models [7]. The paper is concluded with a short discussion.

2 The e ective action for edge states

The e ective action for edge states was obtained in [5] by considering uctuations of the density matrix following the strategy used by Sakita [8] in the case of the two-dimensional droplet. We shall begin by brie y recalling the essential points of this method. Let $^{\circ}_{0}$ be the density matrix corresponding to the droplet. Allelements of $^{\circ}_{0}$ are zero except for the diagonal ones corresponding to the led states, for which it is equal to one. Time evolution of $^{\circ}_{0}$ is given by a unitary matrix \hat{U} . The action which determines \hat{U} is given by

where \hat{H} is the Ham iltonian. We used the following strategy in simplifying this action. First of all, we restrict to the single particle Hilbert space, since it is a good approximation to neglect any dynamically correlated states of two or more ferm ions. This is essentially a Hartree-Fock approximation. For a droplet in the lowest Landau level (LLL) or any xed Landau level, we can then take the Ham iltonian, up to an additive constant, as the potential \hat{V} which con nest he particles to the droplet. If N is the dimension of the one-particle Hilbert space and K states are occupied, we can simplify (1) by taking N ! 1 and K very large but nite.

We will stretcapitulate the results for an abelian background. As we have shown in [2], [5] the LLL states are characterized by an integer n BR² where B is the magnetic eld and R is the radius of the CP^k; the dimension N of the Hilbert space corresponding to the LLL sector depends on n, in particular N n^k and scaling is done with R n^k in the large N n^k limit two main results were used to identify the edge elective action.

1. The operator commutators tend to the Poisson brackets of appropriate classical functions, namely

We can write $\hat{U} = \exp(i\hat{\ })$ for some herm it in operator $\hat{\ }$, expand various terms in (1) in terms of commutators and extract their large N-limit. If the background magneticeld is abelian, the classical eld corresponding to $\hat{\ }$ is a scalar which parametrizes the surface deformations of the droplet.

2. The classical function $_0$, the symbol corresponding to the density operator $\hat{0} = \sum_{i=1}^K jiihij$ is essentially a step function identifying the droplet. The term $\frac{\theta}{\theta} \cdot r^2$, where $r^2 = 0$, is a -function with support only at the edge of the droplet.

U sing these two results and taking into account the scaling properties of various quantities as $n \, ! \, 1$, we found that the <code>nale</code> ective action, up to an additive constant, is of the form

Notice that the fulle ective action is an edge action de ned on the boundary @D of the droplet D. L involves only derivatives of with respect to a particular tangential direction, which is essentially determined by the Kahler form of the manifold. The density $_0$ is chosen so as to minimize the potential energy, the particles being located at states of minimum available energy. V is thus a constant along directions tangential to the boundary of the droplet @D, it depends only on the normal coordinate r.! is a constant related to the derivative of the potential, in particular $! = \frac{1}{D} \frac{\partial V}{\partial x^2}$ (the scaling of V is such that ! is n independent).

Equation (5) shows that the elective edge dynamics involves only the time-derivative of and one tangential derivative given by L. The action is chiral in this sense. Generally the eld depends on the remaining tangential directions, leading to a multiplicity of modes. For a spherical droplet in even dimensions 2k, $@D S^{2k-1}$. The mode analysis of the eld has been indicated in [5]. In the special case of $CP^1 = S^2$, the corresponding action in (5) is the well known one-dimensional chiral bosonic action describing edge excitations for $E^{-1} = E^{-1}$.

On $CP^k = SU(k+1)=U(k)$, it is possible to have a nonzero background value for the SU(k) gauge elds as well as the U(1) elds. As mentioned in the introduction, in this paper, we shall carry out a similar large N simplication of the action for a background which has nonzero values for the SU(k) and U(1) subalgebras. One of the main differences in the nonabelian case is that now the lowest Landau level states belong to a representation of SU(k+1) with a lowest weight state which transforms nontrivially under SU(k), say, as a representation \mathcal{F} . As a result, the classical function which is the symbol corresponding to the herm it in operator \hat{f} , is now a matrix of dimension (dim \mathcal{F} dim \mathcal{F}). A gain, as in the abelian case, the key to extracting the large N lim it of the elective action are the two properties 1 and 2 mentioned above, appropriately modified in the case of the nonabelian bakground.

Property 2 still remains true, with the dierence that the symbol corresponding to the density operator is a diagonal matrix of dimension (dim \mathcal{J} dim \mathcal{J}) proportional to a step function, which again identies the droplet.

Property 1 is more seriously modied. The large N $\,$ lim it of the operator commutator, due to the matrix nature of the symbols, will now involve a Poisson bracket-type term along with a matrix commutator term. In particular

Notice that the Poisson bracket now involves the gauge covariant derivative D = @ + [A;], where A is the SU(k) gauge potential.

The relevant eld in writing down the e ective action is a unitary matrix G which is an element of U (dim J). As expected, since we have an SU (k) background, the action has an SU (k) gauge symmetry. The eld space is essentially U (dim J)=SU (k). The nalresult turns out to be a chiral, gauged W ess-Zum ino-W itten action generalized to higher dimensions.

Here the rst term is on the boundary @D of the droplet and it is precisely the gauged, nonabelian analogue of (5). The operator L in (9) is the gauged version of (6),

The second term in (9), written as a di erential form, is a higher dimensional Wess-Zum inoterm; it is an integral over the rescaled droplet D itself, with the radial variable playing the role of the extra dimension. This term is very similar to the Wess-Zum inoterm appearing in Kahler-Wess-Zum ino-Witten models [7], used in the context of higher dimensional conformal eld theories. The elective action (9) is the main result of this paper.

3 Analysis on CP ^k with a nonabelian background eld

1. W avefunctions

We begin with a discussion of the Landau level states and wavefunctions for the case when the background is nonabelian. We will follow the group theoretic analysis given in [2], [5]. Since CP k is the coset space SU (k + 1)=U (k), the wavefunctions can be obtained as functions on SU (k + 1) which have a speci c transform ation property under the U (k) subgroup. Let t_A denote the generators of SU (k + 1) as matrices in the fundamental representation; we normalize them by $Tr(t_A t_B) = \frac{1}{2} AB$. The generators corresponding to the SU (k) part of U (k) SU (k + 1) will be denoted by t_A , $t_A = 1$; t_A

where L_i ; R_i stand for two sets of quantum numbers specifying the states on which the generators act, for left and right SU (k+1) actions on g, respectively. On an element g 2 SU (k+1), we can de ne left and right SU (k+1) actions by

where T_A are the SU (k + 1) generators in the representation to which g belongs. Since CP k = SU (k + 1)=U (k), one can have, in general, a background magnetic eld which is a U (k) gauge eld. P reviously, we concentrated on the case of a U (l) eld, here we are interested in the case of a U (k) background, where the wavefunctions transform as a speci c representation, say \mathcal{J} , of SU (k), for the action of the right generators R_a 2 SU (k) and carry a charge corresponding to the right U (l) generator R_{k^2+2k} . The U (l) generators L_{k^2+2k} and R_{k^2+2k} will be referred to as the \hypercharge operators", taking over the standard term inology for SU (3).

There are 2k right generators of SU(k+1) which are not in U(k); these can be separated into T_{+i} , i=1;2; k, which are of the raising type and iTwhich are of the lowering type. The covariant derivatives on CP^k , in terms of their action on the wavefunctions, can be identified with these \hat{R}_i right rotations on g. This is consistent with the fact that the commutator of covariant derivatives is the magnetic eld. The commutators of \hat{R}_{+i} and \hat{R}_i are in the Lie algebra of U(k); given the values of these U(k) generators on the wavefunctions, we see that they correspond to constant magnetic elds. In the absence of a conning potential, the Hamiltonian \hat{H}_0 may be reduced to the form $\hat{R}_{+i}\hat{R}_i$, apart from additive constants. The corresponding energy eigenvalues of a charged particle on CP^k in the presence of a nonabelian background are given by [2]

where M is the mass of the charged particles, R is the radius of C P k , C $_2$ is the quadratic C asim ir operator for the group and representation indicated.

The states for a representation of SU (k+1) can be labelled by two integers (P;Q), corresponding to a tensor of the form T $_1^1:::_P$ which is symmetric in all the upper indices, symmetric in all the

lower indices and traceless for any contraction between upper and lower indices; the indices; take values 1;2; ; (k+1). In the case of a U (1) SU (k) nonabelian background, it is convenient to label the irreducible representation of SU $(k+1)_R$ by $(p+1;q+1^0)$ corresponding to the tensor

The fact that n has to be integer [2] implies that $(1 1^0)=k$ is an integer, thus constraining the possible SU $(k)_R$ representations J.

Since the background magnetic eld and the representation (or charges) of the matter eld are the given data for setting up the Landau problem , we must identify the wavefunctions for a given SU (k) representation $\mathcal{J}=(l;l^0)$ and U (l) charge nk. W ith \mathcal{J} and n xed, the lowest energy eigenstates correspond to q=0. The index q plays the role of the Landau level index. Notice that for \mathcal{J} of the form $\mathcal{J}=(0;l^0)$, the lowest energy eigenstate is the lowest weight vector in the representation \mathcal{J} of SU (k+1) annihilated by \hat{K}_i . This choice of background is particularly simple and for the rest of the discussion we will consider this case. (For other backgrounds, the elective action will have the same general qualitative features of the action we not here.) So the LLL states we consider correspond to the tensor $T_p^{l^0}$, where $p=n-\frac{l^0}{k}$ and $l^0=jk$; j=1;2;

The Landau H am iltonian $\hat{H_0}$ com m utes with the left action. This corresponds to the m agnetic translation sym m etry of the Landau problem with the left operators \hat{L}_A representing m agnetic translations. The degeneracy of the LLL states corresponds to the dimension of the $J=(p;1^0)$ representation, where

 $^{^3}$ In deriving the LLL condition for CP 2 in [2] we had assumed $1 > 1^0$ (the notation $(k;k^0)$) was used instead of $(1;1^0)$). With this assumption the lowest energy states within the q=0 sector were of the form (p+1;1). The assumption $1 > 1^0$ is not necessary; without this assumption the lowest energy states are of the type $(p;1^0)$, with 1=0.

In order to obtain a quantum Hall droplet for QHE on CP k with a nonabelian background, we need a U (1) charge n R^2 ! 1 while the dimension N 0 = dim $^{\circ}$ of the SU (k) representation remains nite.

The rst of these equations shows that the wavefunctions (25) under right rotations transform as a representation of SU (k), (T_a^J) being the representation matrices for the generators of SU (k) in the representation J. n is an integer characterizing the abelian part of the background eld.; label states within the SU (k) representation J (which is itself contained in the representation J of SU (k + 1)). The index carried by the wavefunctions (25) is basically the gauge index. The wavefunctions are sections of a U (k) bundle on C P k .

The wavefunctions (25) are normalized by virtue of the orthogonality theorem

where d (g) is the H aar m easure on SU (k + 1), norm alized to unity. The orthonorm ality relations for wavefunctions should involve integration over the space, which is CP k = SU (k + 1)=U (k) rather than SU (k + 1) as we have done in (27). The di erence has to do with the gauge transform ations. This will be clear if we consider U (k)-invariant combinations. If ; transform under U (k) as the representation \mathcal{J} , then the combinations J_m ; and J_m ; are invariant and we can write

The integration can be extended to the full group and the orthogonality theorem (27) used by virtue of the U (k)-invariance of the integrand.

2. Star products; com m utators and P oisson brackets

The simplication of the commutators in the large N-limit is achieved by use of the star product which represents the operator product in terms of classical functions corresponding to the operators. The classical function corresponding to an operator is called the symbol of the operator. To see how the symbol emerges naturally, consider the trace of a product of two operators \hat{A} and \hat{B} . By virtue of the orthogonality theorem, we can write

Notice that the symbol for an operator is now a (N 0 N 0) m atrix valued function. Under a U (k) transform ation, g! gh, it transforms as A ! h A h where h is the element of U (k) in the m atrix representation corresponding to \mathcal{J} . 6: Sim plification of the potential energy term

The large n lim it of the potential energy term can now be derived in a fairly straightforward m anner. First we calculate the symbol corresponding to \hat{V} as dened in (80).

S (G) is a generalized chiral, gauged W ess-Zum ino-W itten (W ZW) action [10], [11]. Since $_{0}$ is a step function as in (92), its derivative with respect to r^{2} is a delta function with support at the boundary @D of the droplet, namely

Thus the rst term on the right hand side of (112) is evidently a boundary term. The second term is a (gauged) W ess-Zum ino term for the eld G; the integration is over the droplet whose boundary is the edge @D . U sually the W ess-Zum ino term is written in terms of integration over a three-manifold whose boundary is the spacetime of interest; in such a representation, the W ess-Zum ino term can be displayed as the integral of a local dierential form. Here we see that the droplet, along with time, plays the role of this three-manifold, the radial variable of the droplet serving as the extra dimension. Of course this is not really a three-manifold, the actual dimension is 2k+1. Only derivatives with respect to a particular spatial direction, namely L, appear in the action. However, once the integration over the various directions are carried out the result will involve all the coordinates of the edge of the droplet for the rst term. Finally, since the gauged W ess-Zum ino term is the integral of a locally exact form, as shown in the next section, it should be considered as part of the boundary action; it is not a bulk term.

4 Properties of the e ective action

1: G auge sym m etry

The elective action we have derived is a generalized gauged W ZW action. The eld G is a unitary (dim J dim J)-m atrix and it is gauged vectorially with respect to the group SU (k). As we have mentioned earlier, the U (1) gauge eld does not appear in the covariant derivative and in the elective action.

U sually, in a gauged W ZW action, the kinetic term shave gauge covariant derivatives replacing the ordinary derivatives as in (112). However, the gauging of the W Z-term is not done by replacing derivatives by covariant derivatives, rather it involves additional terms which are local boundary terms such that the anomalies of the gauge symmetry cancel out [11]. Explicitly, such a gauged W Z-term with a vector gauge symmetry is given, for a three-dimensional manifold, by

Here F is the eld strength associated to the potential A and in the second line we use the fact that F has no time -components. The eld strength F can be calculated from the potential as

The wedge product with d (C P k 1) in (115) leads to the term F $^a_{lr}$ (1) lr . This is veri ed to be zero using (1) lr = $i(E \ ^1)^1_m$ (E 1) r_m and the fact that p_i tr(ta [t $_i$; t+ $_i$]) = 0. Thus (G 1 D G) 3 does indeed reduce to the usual gauging of the W Z-term for the present case.

In sum mary, we have a gauged W ZW model generalized to higher dimensions where the eld G takes values in the unitary group U (dim \mathcal{J}) and the gauge group is SU (k), in other words a U (dim \mathcal{J})=SU (k) coset model.

2: The level num ber of the action

The W Z-term in (112) has the time-derivative term separated o . We can write it in a more symmetric fashion as

In comparing this with the usual W Z-term, we have to take account of an additional factor of $\frac{1}{2}$ which arises due to the fact that r^2 , not r, is the variable of integration for the extra coordinate'. (The volume element will have a factor rdr; with the factor of 2 we inserted inside the integral, this will become $d(r^2)$.) Equation (117) shows that the level number of the W Z-term is given by

The right hand side of this equation is entirely in terms of rescaled coordinates, with the radius of the droplet being unity. We have taken the \lim it of large n for the prefactors as well. Thus the terms displayed here are the terms which have a nite \lim it as n! 1; the corrections to this action are of order 1=n.

3:Chirality

The e ective action is a gauged W ZW_i m odel and carries a notion of chirality [12]. It has the structure tr $G^{Y}G$ + ! $G^{Y}LG$ G $G^{Y}LG$; the combination $G^{Y}G$ + ! $G^{Y}LG$ indicates that there is chirality in the theory. The eventual integration over all spatial directions will give an action which has rotational symmetry, but the time-derivative will still occur in a similar combination.

4: Relationship to other higher dimensional W Z W models

The e ective action we have obtained is a higher dim ensional generalization of the W $\,$ ZW $\,$ action. Going back to (111), we write it as

The action density which is integrated is in the form of the exterior product of the density for the two-dimensional WZW action with k 1 . A generalization of the WZW action to higher dimensions along these lines has been considered before [7]. The action for a k-complex dimensional Kahler manifold is

leading to antiselfdual elds on M . The canonical quantization of the action (122) leads to wavefunctions of the form exp [iS (G)] [7], sim ilar to the usual connection between the Chem-Sim ons and W ZW theories [13]. The action S (G) so obtained is on the boundary of M $t_i; t_f$, i.e., on the two equal-time surfaces at t_i and t_f which are copies of M , for a compact M with no boundary.

The di erence with our present situation of Halle ect is the following. If we consider not all of M but a certain region D in M, there is an additional boundary @D $[t_i;t_f]$. The analogue of the action (121) on this boundary is what we have in the present case.

5 Discussion

We have derived the elective action, in the limit of large number of fermions, for quantum Hall droplets in $CP^k = SU(k+1)=U(k)$ in the presence of abelian (U(1)) and nonabelian (SU(k)) background magnetic elds. This result, which is the main result of this paper, is summarized in (112) and (119). The action describes a higher dimensional gauged WZW model. The e ective action we have derived is very similar to the gauged version of the Kahler W ZW model used in the context of higher dimensional conformal eld theories [7]. The W Z-term of this action is dened on the (2k+1)-dimensional manifold D R, corresponding to the droplet D and time. The rest of the action is dened on @D R, corresponding to the boundary of the droplet and time. The radial variable for the droplet plays the role of the extra dimension in expressing the W Z-term as the integral of a local dierential form. Further, the action involves the spatial derivative along a particular tangential direction on the boundary of the droplet, which is eventually integrated over. There is also a certain chirality property due to the manner in which the space and time derivatives appear. Finally, as expected, for an abelian background, the action reduces to the chiral U (1) bosonic action given in [5].

The elective action (119) has a very interesting current algebra structure which will have implications on the nature of the spectrum of edge excitations. This facet of the problem and related issues will be analyzed in more detail elsewhere.

The W ZW theory is well known to lead to conformal eld theories in two dimensions; in particular it is a xed point under the renormalization ow. Given that we nd a generalized version of the W ZW theory, it is natural to ask how it changes under renormalization. We have not carried out a full study of this question, but the following remark may be interesting in this context. The variational problem for the action (1) gives the full quantum dynamics. A part from assuming a Hartree-Fock type factorization of the many-body wavefunctions in terms of one-particle wavefunctions, which was explained in [5], we have not made any other approximation. Thus the excitive action we derived is the exact quantum action in the large n limit as far as states in the

lowest Landau level are concerned. Contributions from virtual transitions to higher Landau levels have not been calculated.

For a Ferm i liquid in dimensions higher than one, expansion around the Ferm i surface has been used to rewrite the low energy excitations in terms of a set of one-dimensional models which can be bosonized. What we have done here is similar; our result may be viewed as a partial bosonization which is adequate for the low energy excitations.

Finally, we note that while quantum Halle ect and the droplet picture may serve as a physical picture for this class of theories, they can be given an independent formulation. The Landau levels and the elective eld G are sections of appropriate H-bundles on a G=H space. The kinetic term of the elective action is an analogue of the K irillov form. Thus the class of theories we are discussing may be viewed in a purely geometric way. It is also clear that these theories may have some relevance to the dynamics of droplets of incompressible uids in general.
