A conformal eld theory description of magnetic ux fractionalization in Josephson junction ladders

Abstract

We show how the recently proposed e ective theory for a Quantum Hall system at \paired states" lling = 1 [1][2], the twisted model (TM), well adapts to describe the phenom enology of Josephson Junction ladders (JJL) in the presence of defects. In particular it is shown how naturally the phenom enon of ux fractionalization takes place in such a description and its relation with the discrete symmetries present in the TM. Furtherm ore we focus on \closed" geometries, which enable us to analyze the topological properties of the ground state of the system in relation to the presence of half ux quanta.

1 Introduction

A mays of weakly coupled Josephson junctions provide an experimental realization of the two dimensional (2D) XY model physics. A Josephson junction ladder (JJL) is the simplest quasione dimensional version of an array in a magnetic eld [3]; recently such a system has been the subject of many investigations because of its possibility to display dimensions and dissipation. In this paper we focus on the phenomenon of fractionalization of the ux quantum $\frac{hc}{2e}$ in a fully frustrated JJL, the basic question being how the phenomenon of Cooper pair condensation can cope with properties of charge (ux) fractionalization, typical of a low dimensional system with a discrete Z_2 symmetry.

W e must recall that charge fractionalization has been successfully hypothesized by R.Laughlin to describe the ground state of a strongly correlated 2D electron system, a quantum Hall uid, at fractional llings = $\frac{1}{2p+1}$, p = 1;2; In such a system charged excitations are present with fractional charge (anyons) and elementary ux $\frac{hc}{e}$. Furtherm one the phenom enon of fractionalization of the elementary ux has been found in the description of a quantum Hall uid at non standard llings = $\frac{m}{m p+2}$ [1][2], within the context of 2D C onform alfield Theories (CFT) with a Z_m twist.

In Refs. [4][5] it has been shown that the presence of a Z_2 symmetry accounts for more general boundary conditions for the propagating electron elds which arise in quantum Hall systems in the presence of impurities or defects. Furthermore such a symmetry is present also in the fully frustrated XY (FFXY) model or equivalently, see Ref. [6][7], in two dimensional Josephson junction arrays (JJA) with half ux quantum $\frac{1}{2}\frac{hc}{2e}$ threading each square cell and accounts for the degeneracy of the ground state.

It is interesting to notice that it is possible to generate non trivial topologies, i.e. the torus, in the context of a CFT approach. That allows in our case to show how non trivial global properties of the ground state wave function emerge and how closely they are related to the presence of half ux quanta, which can be viewed also as \topological defects".

The aim of this paper is to show that the twisted model (TM) well adapts to describe the phenom enology of fully frustrated JJL with a topological defect and to analyze the implications of \closed" geometries on the ground state global properties.

The paper is organized as follow s:

In Section 2 we introduce the physics of a fully frustrated JJL evidencing the underlying Z_2 sym m etry and then present the m odi ed ladder with a topological defect.

In Section 3 we describe the role played by such a symmetry in the construction of the TM model and its relation with the ladder physics. Furthermore the degeneracy of the ground state appears to be closely related to the number of excitations (primary elds) of the CFT description.

In Section 4 the symmetry properties of the ground state conform alblocks are analyzed and its relation with their topological properties shown.

In Section 5 a brief sum m ary of the results is presented together with som e com m ents and suggestions.

In the Appendix the TM conform alblocks are explicitly given in terms of its boundary states (BS) content [4][5].

2 Josephson junction ladder with a topological defect




Figure 1: Josephson junction ladder




Figure 2: JJL with an impurity

In this Section, after describing the general properties of a ladder of Josephson junctions as drawn in Fig.1, we introduce an interaction of the charges (C coper pairs) with a magnetic impurity (defect), as drawn in Fig. 2. With each site i we associate a phase $'_i$ and a charge 2en_i, representing a superconducting grain coupled to its neighbors by Josephson couplings; n_i and $'_i$ are conjugate variables satisfying the usual phase-num ber commutation relation. The Ham iltonian describing the system is given by the quantum phase model (QPM):

where $E_c = \frac{(2e)^2}{c}$ (C being the capacitance) is the charging energy at site i, while the second term is the Josephson coupling energy between sites i and j and the sum is over nearest neighbors. $A_{ij} = \frac{2}{o} \prod_{i=1}^{R_j} A$ dl is the line integral of the vector potential associated to an external magnetic eld B and $_0 = \frac{hc}{2e}$ is the magnetic ux quantum. The gauge invariant sum around a plaquette is $_p A_{ij} = 2$ f with $f = \frac{1}{o}$, where is the ux threading each plaquette of the ladder. Let us label the phase elds on the two legs with $'_i^{(a)}$, a = 1;2 and assum $e E_{ij} = E_x$ for horizontal links and $E_{ij} = E_y$ for vertical ones. Let us also make the gauge choice $A_{ij} = + f$ for the upper links, $A_{ij} = -f$ for the ladder and taking opposite values on upper and low er branches.

Thus the electric quantum Ham iltonian (2.1) can be written as [3]:

The correspondence between such H am iltonian and our TM model can be best shown performing the change of variables: ${'}_{i}^{(1)} = X_{i} + {}_{i}, {'}_{i}^{(2)} = X_{i} + {}_{i}, so eq. (2.2)$ can be cast in the form :

where X_{i} , i_{i} (i.e. $r_{i}^{(1)}$, $r_{i}^{(2)}$) are only phase deviations of each order parameter from the commensurate phase and should not be identified with the phases of the superconducting grains [3].

W hen $f = \frac{1}{2}$ and $E_c = 0$ (classical lim it) the ground state of the 1D frustrated quantum XY (FQXY) m odel displays - in addition to the continuous U (1) sym m etry of the phase variables - a discrete Z_2 sym m etry associated with an antiferrom agnetic pattern of plaquette chiralities p = 0

1, m easuring the two opposite directions of the supercurrent circulating in each plaquette. Thus it has two symmetric, energy degenerate, ground states characterized by currents circulating in the opposite directions in alternating plaquettes. For small E_c there is a gap for creation of kinks in the antiferrom agnetic pattern of $_p$ and the ground state has quasilong range chiral order.

Performing the continuum limit of the Hamiltonian (2.3):

we see that the X and elds are decoupled. In fact the X term of the above H am iltonian is that of a free quantum eld theory while the one coincides with the quantum sine-G ordon model. Through an imaginary-time path-integral formulation of such a model [8] it can be shown that the 1D quantum problem maps into a 2D classical statistical mechanics system, the 2D fully frustrated XY model, where the parameter $= \frac{E_x}{E_c}^{\frac{1}{2}}$ plays the role of an inverse temperature [3]. We work in the regime E_x E_y where the ladder is well described by a CFT with central charge c = 2.

We are now ready to introduce the modi ed ladder as represented in Fig. 2. In order to do so let us not require the compactication of the '^(a) variables in order to recover the angular nature of the up and down elds. In such a way the XY-vortices, causing the K osterlitz-T houless transition, are recovered. Also let us indicate the compacti ed phases '⁽¹⁾;'⁽²⁾ as '⁽¹⁾_L, '⁽²⁾_R respectively (where L;R stay for left, right components). As a second step let us introduce at point x = 0 a magnetic in purity which couples the up and down phases through

its interaction with the Cooper pairs of the two legs (see Fig. 2). In the lim it of strong coupling, that is in the full screening case, such an interaction gives rise to non trivial boundary conditions for the elds [4]:

It is interesting to notice that such a condition is naturally satis ed by the twisted eld (z) of our TM model (see eq. (3.8)). Furtherm one such a eld describes both the left moving component $'_{\rm L}^{(1)}$ and the right moving one $'_{\rm R}^{(2)}$, which naturally appear in a folded description of a system with a boundary. In fact our TM results in a chiral description of the system just described, in terms of the chiral elds X and (see eqs. (3.7), (3.8)). In Section 3 and in the Appendix we give further details on such an issue [4][5]. In particular we adopt the m-reduction technique [9] which accounts for these non trivial boundary conditions [4][5] for the Josephson ladder due to the presence of a topological defect. Furtherm ore its realization on closed geometries could be relevant for the description of JJA s with non trivial topologies, which are believed to provide a physical in plem entation of an ideal quantum computer [10] because of the topological ground state degeneracy which appears to be \protected" from external perturbations [11][12].

In a forthcom ing paper [7] we will be also studying in detail two dimensional systems with frustration, the fully frustrated XY model and a two dimensional array of Josephson junctions in an external magnetic eld with half ux quantum per cell. Such frustrated systems represent a two dimensional generalization of the linear chain of frustrated plaquettes considered here. Furtherm ore the phase diagram of such systems [13][14] can be simply understood within our TM description. Recently conform all eld theory techniques have been applied as well [6][15][16]; our work follows such a line.

3 The Twisted M odel

W e are now ready to show the main steps of our construction.

- We rst construct the bosonic theory, i.e. the TM, and show that its energy m om entum tensor fully reproduces the H am iltonian of eq. (2.4) for the JJL. That allow s us to describe the JJL excitations in term s of the prim ary elds V (z) given later on in this Section and in Sec. 4 for the torus topology.
- 2. Then by using standard conform all eld theory techniques we show that it is possible to construct the N vertices correlator for the torus topology in 2D (basically by letting the edge to evolve in \tim e" and to interact with external vertex operators placed at di erent points). Throughout this paper we will assume that a suitable correlator is apt to describe the ground state wave function of the JJA at T = 0 tem perature. We must notice that such an assumption is supported by the plasm a description of the system ground state on the plane, given later on in this Section. An analysis of the symmetry properties of its center of mass wave function (conform alblocks), which emerge in the presence of vortices carrying half quantum of ux $(\frac{1}{2}, \frac{hc}{2e})$, will be given in Section 4.

In this Section we recall those aspects of the TM which are relevant for the fully frustrated $(f = \frac{1}{2})$ JJL presented in the previous Section. We focus on the m-reduction procedure [9] for the special = 2 case (see R ef. [1] for the general case), since we are interested in a system with a Z₂ symmetry. We showed in Refs. [2][4] that such a theory well adapts to describe a system consisting of two parallel layers of 2D electrons gas in a strong perpendicular magnetic eld coupled via a defect line (a topological defect or topological twist). The two layers edges appear coupled at a contact point carrying a magnetic impurity (twist). The bulk electrons isospin interacts with the magnetic in purity and in the lim it of strong coupling non trivial boundary conditions, of the Z_2 type in the considered case, for the relevant elds emerge. In this paper we choose the \bosonic" theory, which well adapts to the description of a system with Cooper pairs of electric charge 2e in the presence of a topological defect, i.e. a fully fustrated JJL.As pointed out in the previous Section, its ground state can be viewed as a sequence of opposite current chiralities in adjacent plaquettes, in close analogy with the checkerboard ground state of the two dimensional JJAs [17]. To each of the two legs (edges) of the ladder we assigned a chirality, making a correspondence between up-down leg and left-right chirality states. Then we identify in the continuum the corresponding phase elds ' (a), each de ned on the corresponding leg, with the two chiral elds Q $^{(a)}$ (a = 1;2) of our CFT with central charge c = 2.

In order to construct the elds Q ^(a) for the TM, we start from a bosonic CFT with c = 1 described in terms of a scalar chiral eld Q compacti ed on a circle with radius R² = 2. It is explicitly given by:

with a_n , q and p satisfying the commutation relations $[a_n;a_n\circ] = n_{n,n\circ}$ and [q;p] = i; its primary elds are the vertex operators U⁻¹(z) = : $e^{i_{-1}Q(z)}$: where $1 = \frac{p!}{2}$, l = 1;2. It is possible to give a plasm a description through the relation $j_{-1}^2 = e^{-H_{eff}}$ where $(z_1;...;z_N) = e^{i_{-1}Q(z)}$

From such a CFT (mother theory), using the m-reduction procedure, which consists in considering the subalgebra generated only by the modes in eq. (3.6) which are a multiple of an integer m, we get a c = m orbifold CFT (daughter theory, i.e. the TM). Then the elds in the mother CFT can be organized into components which have well de ned transform ation properties under the discrete Z_m (twist) group, which is a symmetry of the TM. Its primary elds content, for the special m = 2 case, can be expressed in terms of a Z_2 -invariant scalar eld X (z), given by

describing the continuous phase sector of the new theory, and a twisted eld

which satis as the twisted boundary conditions $(e^i z) = (z)$ [1]. More explicitly such a eld can be written in terms of the left and right moving components ${}^{(1)}_{L}$, ${}^{(2)}_{R}$; then the boundary conditions given in eq. (2.5) are fully described by the boundary conditions for . This will be more evident for closed geometries, i.e. for the torus case, where the magnetic impurity gives rise to a line defect so allowing us to resort to the folding procedure and introduce boundary states [4][5] (see Appendix for details).

Furtherm one the elds in eqs. (3.7)-(3.8) coincide with the ones introduced in eq. (2.4). In fact the energy momentum tensor for such elds given in eq. (3.13) fully reproduces the second quantized H am iltonian of eq. (2.4) as we will see at the end of the Section. Let us notice that the angular nature of the phase elds in our theory takes into account also the presence of vortices, i.e. topological excitations which cause a K osterlitz-T houless transition, which are responsible for the periodicity of the phase diagram and which were not considered in the analysis of R ef. [3].

The whole TM theory decomposes into a tensor product of two CFTs, a twisted invariant one with $c = \frac{3}{2}$ and the remaining $c = \frac{1}{2}$ one realized by a M ajorana ferm ion in the twisted sector. In the $c = \frac{3}{2}$ sub-theory the primary elds are composite vertex operators V (z) = $U_X^{(1)}(z)$ (z) or $V_{qh}(z) = U_X^{(1)}(z)$ (z), where

is the vertex of the continuous sector with $l = \frac{1}{2}$, l = 1; ...,4 for the SU (2) Cooper pairing symmetry used here. The corresponding energy-momentum tensor is:

Regarding the other component, the highest weight state in the isospin sector, it can be classied by the two chiral operators:

which correspond to two $c = \frac{1}{2}$ M a jorana ferm ions with R am ond (invariant under the Z₂ twist) or N eveu-Schwartz (Z₂ twisted) boundary conditions [1][2] in a ferm ionized version of the theory. Let us point out that the energy-m om entum tensor of the R am ond part of the isospin sector develops a cosine term :

The Ram ond elds are the degrees of freedom which survive after the tunneling and the parity symmetry, which exchanges the two Ising fermions, is broken.

So the whole energy-m om entum tensor within the $c = \frac{3}{2}$ sub-theory is:

The correspondence with the Ham iltonian of eq. (2.4) is more evident once we observe that the isospin current @ appearing above coincides with the term (@ $\frac{1}{2}$) of eq. (2.4), since the $\frac{1}{2}$ -term coming from the frustration condition, here it appears as a zero mode, i.e. a classical mode. That is the frustration $\frac{1}{2}$ (in general f) of the ladder cells here in the TM construction is related to the order of the twist Z_2 ($Z_{1=f}$ in the general case). Besides the elds appearing in eq. (3.11), there are the (z) elds, also called the twist elds, which appear in the quasi-hole primary elds V_{qh} (z). Its presence is a peculiarity of the fully frustrated XY model in which they appear at the corner where two dom ain walls meet [6]. The twist elds have non local properties and decide also for the non trivial properties of the vacuum state, which in fact can be twisted or not in our form alism. Such a property for the vacuum is more evident for the torus topology, where the - eld is described by the conform alblock $\frac{1}{12}$ (see Appendix).

W ithin this fram ework the ground state wave function for the plane is described as a correlator of N $_{2e}$ C ooper pairs:

where P f $\frac{1}{z_1 z_1^0} = A \frac{1}{z_1 z_2} \frac{1}{z_3 z_4} \dots$ is the antisymmetrized product over pairs of C ooper pairs, so reproducing well known results [18]. In a similar way we also are able to evaluate correlators of N_{2e} C ooper pairs in the presence of (quasi-hole) excitations [18][1] with non A belian statistics [19].

It is now interesting to notice that the charged contribution appearing in the correlator of N_e electrons is just: hN_e $j_{i=1}^{Q_e} U_X^{1=2}(z_i) = \sum_{\substack{i < i^0 = 1 \\ i < i^0 = 1}}^{Q_e} z_i z_i^{0} z_i^{1=4}$, giving rise to a vortices plasma with $H_{eff} = \frac{1}{4} P_{i < j=1}^{N} h_j z_i z_j$ at the corresponding temperature $= \frac{2}{R_X^2} = 2$, that is it describes vortices with vorticity $v = \frac{1}{2}!$

4 Symmetry properties of the TM conform alblocks

In Section 3 we identified our chiral elds Q^(a) with the continuum limit of the Josephson phase $'^{(a)}$ defined on the two legs of the ladder respectively and considered non trivial boundary conditions at its ends, so constructing a version in the continuum of the discrete system. By using standard conform alleld theory techniques it is now possible to generate the torus topology, starting from the edge theory, just defined in the previous Section. That is realized by evaluating the N-vertices correlator

where V (z_i) is the generic primary eld of Section 3 representing the excitation at z_i , L_0 is the V irasoro generator for dilatations and the propertime. The neutrality condition = 0 m ust be satisfied and the sum over the complete set of states jui is indicating that a trace must be taken. Even though for the present paper it is not necessary to go through such a calculation, it is very illuminating for the non expert reader to pictorially represent the above operation in terms of an edge state (that is a primary state defined at a given) which propagates interacting with external elds at $z_1 ::: z_N$ and nally getting back to itself. In such a way a 2D surface is generated with the torus topology. From such a picture it is evident then how the degeneracy of the non perturbative ground state is closely related to the number of primary states. Furtherm ore, since in this paper we are interested in the understanding of the topological properties of the system, we can consider only the center of mass contribution in the above correlator, so neglecting its short distances properties. To such an extent the one-point functions are extensively reported in the following.

On the torus [2] the TM primary elds are described in terms of the conformal blocks of the Z_2 -invariant $c = \frac{3}{2}$ subtheory and of the non invariant $c = \frac{1}{2}$ Ising model, so re exting the decomposition on the plane outlined in the previous Section. The following characters

represent those of the Z₂-invariant $c = \frac{3}{2}$ CFT. They are given in term sofa \charged" K (w_cj) contribution, (see de nition given below) and a \isospin" one (0j), (the conform alblocks of the Ising M odel), where w_c = $\frac{1}{2}$ in z_c is the torus variable of \charged" component. Notice that the corresponding argument of the isospin block is w_n = 0 everywhere.

In order to understand the physical signi cance of the c = 2 conform alblocks in terms of the charged low energy excitations of the system, let us evidence their electric charge (magnetic ux contents in the dual theory, which is obtained by exchanging the compacti cation radius $R_e^2 ! R_m^2$ in the charged sector of the CFT). In order to do so let us consider the \charged" sector conform alblocks appearing in eqs. (4.16 { 4.18):

Such a factorization is a consequence of the parity selection nule (m -ality), which gives a gluing condition for the \charged" and \isospin" excitations. The conform all blocks given above represent the collective states of highly correlated vortices, which appear to be incom pressible. In order to show the corresponding sym metry properties it is useful to give a pictorial description of the conform all blocks appearing in eq. (4.19). To such an extent let us in agine to cut the torus along the A-cycle. The di erent prim ary elds then can be seen as excitations which propagate along the B-cycle and interact with the external C cooper pair at point w_c. We can now test the sym metry properties of the characters of the theory (given above) by simply evaluating the B ohm (A haronov phase they pick up while a C cooper pair is taken along the closed A-cycle. In order to do that, it is in portant to notice that the transport of the "C cooper pair" from the upper (with isospin up) leg to the down (with isospin down) leg can be realized by a translation of the variables w_c and w_n, which must be identical for the "charged" and the "isospin" sectors. In fact it turns out that the translation with w_c = w_n allows us to describe, for example in the twisted sector, the charge transport from leg 1 (isospin up) to leg 2 (isopsin down) through the crossing point shown in Fig. 2.

So under a 2 -rotation the torus variables transform as w $_{\rm c}$ = w $_{\rm n}$ = 1 and it is easy to check that:

Let us observe that the change in sign in the last relation of eq. (4.30) is strictly related to the presence in the spectrum of excitations carrying fractionalized charge quanta. Now, turning on also the isospin sector contribution in the Cooper pair transport along the A-cycle, we obtain in a straightforward way:

and the same is true for the characters \cdot . Notice that the phase factor $i = e^{i^2}$ appearing above in the transport of the isospin "cloud" by the $\frac{1}{16}$ character is again due to the presence of a half-ux.

does not change sign under the transport of a C ooper pair along the closed A-cycle by the amount $w_c = w_n = 1$. In fact the negative sign coming from the continuous phase sector is compensated by the negative sign coming from the other sector! O f course the same is true for all the other characters of the untwisted sector, i.e. we cannot trap a half ux quantum in the hole in the untwisted sector.

Instead in the twisted sector the ground state wave-functions show a non trivial behavior. In fact under w $_{\rm c}$ = ~ w $_{\rm n}$ = 1 ~

The change in phase given above evidences the presence of a half ux quantum in the hole as it will be clear below. In fact in the twisted case geometry (see Fig.2) the Cooperpair ow s along the ladder and changes isospin in a 2 -period, so in plying that in such a case the transport of a Cooperpair from a given point w on the A-cycle to the same point has a 4 -period, that is it corresponds to $w_c = w_n = 2$. Under this transform ation the characters given above get the follow ing non trivial B ohm -A haronov phase:

so explicitly evidencing the trapping of $\frac{1}{2}$ $\frac{hc}{2e}$ in the hole.

It is worthwhile to notice that the properties just discussed are independent of the short distance properties of the vortices plasma, the only crucial requirement for its stability being the neutrality condition.

5 Brief sum mary with comments

In this paper we presented a simple collective description of a ladder of Josephson junctions with a macroscopic half ux quanta trapped in the hole. It was shown how the phenom enon of ux fractionalization takes place within the context of a 2D conformal eld theory with a Z_2 twist, the TM. The presence of a Z_2 symmetry indeed accounts for more general boundary conditions for the elds describing the C coper pairs propagating on the ladder legs, which arise from the presence of a magnetic in purity strongly coupled with the Josephson phases. For closed geometries and in the limit of the continuum the phase elds ' ^(a) de ned on the two legs were identied with the two chiral Fubini elds Q ^(a) of our TM, and a correspondence between the

energy momentum density tensor for such elds (or better the X and elds of eqs. (3.7)-(3.8)) and the H am iltonian of eq. (2.4) traced. For such geometries it was also indicated that the K osterlitz-T houless vortices were recovered.

Furtherm one it was shown that for closed geom etries the JJL with an impurity gives rise to a line defect, which can be turned into a boundary state after employing the folding procedure. That enabled us to derive the low energy charged excitations of the system as provided by our description, with the superconducting phase characterized by condensation of 4e charges and gapped 2e excitations. Finally, by simply evaluating a Bohm-A haronov phase, it has been evidenced that non trivial symmetry properties for the conform all blocks emerge due to the presence in the spectrum of fractionalized ux quanta $\frac{1}{2}$ $\frac{hc}{2e}$. As it has been explained before, that signals the presence of a topological defect in the twisted sector of the TM. The question of an emerging topological order in the ground state together with the possibility of providing protected states for the implementation of a solid state qubit has been addressed elsewhere [12][7]. Notice also that the di erent behavior of the 2e and 4e excitations is well evidenced by the Bohm-A haronov phase. Indeed while the transport of a 2e along the cycle induces a -1 phase factor, in the 4e excitation transport the phase factor is trivial [10]. This is the consequence of the symmetry of the 4e with respect to the leg index.

It is interesting to notice that the presence of a topological defect has been experim entally evidenced very recently for a two layers quantum Hall system, by measuring the conduction properties between two edge states of the system [21].

We conclude by observing that it would be useful to extend our approach to a generic flustration $f=\frac{1}{m}$.

6 Appendix: TM boundary states

Let us now recall brie y the TM boundary states (BS) recently constructed in [4].

For closed geom etries, that is for the torus, the JJL with an impurity gives rise to a line defect in the bulk. In order to describe it we resort to the folding procedure. Such a procedure is used in the literature to m ap a problem with a defect line (as a bulk property) into a boundary one, where the defect line appears as a boundary state of a theory which is not anym ore chiral and its elds are de ned in a reduced region which is one half of the original one. Our approach, the TM, is a chiral description of that, where the chiral eld de ned in (L=2, L=2) describes both the left moving component and the right moving one de ned in (L=2, 0), (0, L=2) respectively, in the folded description [4][5]. Furtherm ore to make a connection with the TM we consider more general gluing conditions:

the (+) sign staying for the twisted (untwisted) sector. We are then allowed to use the boundary states given in [22] for the c = 1 orbifold at the Ising² radius. The X eld, which is even under the folding procedure, does not su er any change in boundary conditions [4].

The most convenient representation of such BS is the one in which they appear as a product of Ising and $c = \frac{3}{2}$ BS. These last ones are given in terms of the BS j > for the charged boson and the Ising ones $j \neq j > j \neq j$, $j \neq j \neq j$, according to (see ref.[20] for details):

Such a factorization naturally arises already for the TM characters [2].

The vacuum state for the TM m odel corresponds to the $\sim_{(0)}$ character which is the product of the vacuum state for the $c = \frac{3}{2}$ sub-theory and that of the Ising one. From eqs. (4.25,4.27) we can see that the lowest energy state appears in two characters, so a linear combination of them must be taken in order to de ne a unique vacuum state. The correct BS in the untwisted sector are:

So we can discuss topological order referring to the characters with the implicit relation to the di erent boundary states present in the system . A loo we point out that these BS should be associated to di erent kinds of linear defects compatible with conform al invariance.
