A bstract

Free spinor elds, with spin 1/2, are explored in details in the momentum picture of motion in Lagrangian quantum eld theory. The eld equations are equivalently written in terms of creation and annihilation operators and on their base the anticommutation relations are derived. Some problems concerning the vacuum and state vectors of free spinor eld are discussed. Several Lagrangians, describing free spinor elds, are considered and the basic consequences of them are investigated.

1. Introduction

The paper is devoted to a detailed investigation, in Lagrangian quantum—eld theory 1 , of a free spinor (spin $\frac{1}{2}$)—eld in momentum picture, introduced in [9] and developed in [10]. It is a direct continuation of [11], where similar exploration of free scalar—elds was carried out, and, respectively, most of the methods of loc. cit. are mutatism utandis applied to problem s of free spinor—elds. Most of the known fundamental results are derived in a new way (and in a slightly modified form), but the work contains and new ones; e.g. the eld equations in terms of creation and annihilation operators and a uniform consideration of the massive and massless cases.

The basic moments of the method, we will follow in this work, are the following ones:

- (i) In Heisenberg picture is xed a (second) non-quantized and non-normally ordered operator-valued Lagrangian, which is supposed to be polynomial (or convergent power series) in the eld operators and their rst partial derivatives;
- (ii) As conditions additional to the Lagrangian form alism are postulated the commutativity between the commonents of the momentum operator (see (2.6) below) and the Heisenberg relations between the eld operators and momentum operator (see (2.7) below);
- (iii) Following the Lagrangian form alism in momentum picture, the creation and annihilation operators are introduced and the dynamical variables and eld equations are written in their terms;
- (iv) From the last equations, by imposing some additional restrictions on the creation and annihilation operators, the (anti)commutation relations for these operators are derived;
- (v) At last, the vacuum and normal ordering procedure are de ned, by means of which the theory can be developed to a more or less complete form .

The main di erence of the above scheme from the standard one is that we postulate the below-written relations (2.6) and (2.7) and, then, we look for compatible with them and the eld equations (anti)commutation relations. (Recall, ordinary the (anti)commutation relations are postulated at rst and the validity of the equations (2.6) and (2.7) is explored after that [12].)

The layout of the work is as follows.

Section 2 contains a review of the momentum picture of motion in quantum eld theory. As a new material, a consideration of the angular momentum in it is added. On that base, in Sect. 3, a free spinor eld is described in momentum picture. In particular, the Dirac equation in momentum picture is derived and special attention is paid to the operators of momentum, charge and angular momentum.

In Sect. 4, the (system of) D irac equation (s) describing a free spinor eld is analyzed in term s of operators which, possibly, up to normalization and pure phase factor, are identical with the Fourier coecients of the eld in Heisenberg picture. From these operators, in Sect. 5, is constructed a set of operators which admit interpretation as creation and annihilation operators. Then, the last operators are expressed via a new set of operators with the

In this paper we considered only the Lagrangian (canonical) quantum eld theory in which the quantum elds are represented as operators, called eld operators, acting on some Hilbert space, which in general is unknown if interacting elds are studied. These operators are supposed to satisfy some equations of motion, from them are constructed conserved quantities satisfying conservation laws, etc. From the view-point of present-day quantum eld theory, this approach is only a preliminary stage for more or less rigorous formulation of the theory in which the elds are represented via operator-valued distributions, a fact required even for description of free elds. Moreover, in non-perturbative directions, like constructive and conformal eld theories, the main objects are the vacuum mean (expectation) values of the elds and from these are reconstructed the Hilbert space of states and the acting on it elds. Regardless of these facts, the Lagrangian (canonical) quantum eld theory is an inherent component of the most of the ways of presentation of quantum eld theory adopted explicitly or implicitly in books like [1{8}]. Besides, the Lagrangian approach is a source of many ideas for other directions of research, like the axiomatic quantum eld theory [3,7,8].

same physical interpretation, which operators, up to a phase factor, coincide with the creation/annihilation operators known from the investigation of free spinor eld in Heisenberg picture. The eld's dynamical variables, i.e. the momentum, charge and angular momentum operators, are expressed via the creation and annihilation operators in Sect. 6, which results in expressions similar to ones in the momentum representation in Heisenberg picture.

In Sect. 7, the equations of motion for a free spinor eld are equivalently written as a system of operator equations in terms of creation and annihilation operators. These equations are trilinear ones and their form is similar to the one of the paraferm i relations. The obtained system of equations is analyzed in Sect. 8, where from it, under some explicitly presented additional conditions, the anticom mutation relations for the creation and annihilation operators are derived.

The concept of a vacuum for a free spinor eld is introduced in Sect. 9. Som e problem s in the theory are pointed and their solution is described via the introduction of normal ordering of products (compositions) of creation and annihilation operators. In Sect. 10 are discussed some general aspects regarding state vectors of free spinor eld.

In Sect. 11 are investigated di erent Lagrangians, which do not di er by a full 4-divergence, from which the quantum theory of free spinor elds can be derived. They and their consequences are compared from di erent positions and the best one of them is pointed out. It is the one which is charge symmetric; so that in it is encoded the spin-statistics theorem for free spinor elds.

Section 12 closes the work.

The books [1{3] will be used as standard reference works on quantum—eld theory. Of course, this is more or less a random—selection between the great number of (text)books and papers on the them e to which the reader is referred for more details or other points of view. For this end, e.g., [4,13,14] or the literature cited in [1{4,13,14}] m ay be helpful.

Throughout this paper ~ denotes the P lanck's constant (divided by 2), c is the velocity of light in vacuum, and i stands for the imaginary unit. The superscripts y and > means respectively Herm itian conjugation and transposition of operators or matrices, the superscript denotes complex conjugation, and the symbol denotes compositions of mappings/operators. By $_{fg}$, or $_{f}^{g}$ or $_{f}^{fg}$ (= 1 for f = g, = 0 for f = g) is denoted the K ronecker -symbol, depending on arguments f and g, and $_{f}^{n}$ (y), y 2 R $_{f}^{n}$, stands for the n-dimensional D irac -function; (y) = $_{f}^{fg}$ (y) for y 2 R.

The M inkow ski spacetime is denoted by M. The G reek indices run from 0 to dim M. 1 = 3. All G reek indices will be raised and lowered by means of the standard 4-dimensional Lorentz metric tensor and its inverse with signature (+). The Latin indices a;b;::: run from 1 to dim M. 1 = 3 and, usually, label the spacial components of some object. The E instein's sum mation convention over indices repeated on dierent levels is assumed over the whole range of their values.

At the end, a technical rem ark is in order. The derivatives with respect to operator-valued (non-com muting) arguments will be calculated according to the rules of the classical analysis of com muting variables, which is an everywhere silently accepted practice [1,12]. As it is demonstrated in [15], this is not quite correct. We shall pay attention on that item at the corresponding places in the text. With an exception of the consequences of a Charge symmetric Lagrangian, considered and explained in Sect. 11, this method for calculation of derivatives with respect to operators does not lead to incorrect results when free spinor elds are involved.

2. The momentum picture

In this section, we present a sum mary of the momentum picture in quantum eld theory, introduce in [9] and developed in [10].

Let us consider a system of quantum elds, represented in Heisenberg picture of motion by eld operators $'^{-}_{i}(x):F$! F, i=1;:::;n2 N, acting on the system 's Hilbert space F of states and depending on a point x in M inkowski spacetime M. Here and henceforth, all quantities in Heisenberg picture will be marked by a tilde (wave) $\$ over their kernel symbols. Let P denotes the system 's (canonical) momentum vectorial operator, dened via the energy-momentum tensorial operator T of the system, viz.

realizes the transition to the momentum picture. Here X is a state vector in system 's Hilbert space of states F and $A^{\sim}(x): F$! F is (observable or not) operator-valued function of $x \ge M$ which, in particular, can be polynomial or convergent power series in the eld operators $'^{\sim}(x)$; respectively X (x) and A (x) are the corresponding quantities in momentum picture. In particular, the eld operators transform as

Notice, in (2.2) the multiplier $(x x_0)$ is regarded as a real parameter (in which P is linear). Generally, X(x) and A(x) depend also on the point x_0 and, to be quite correct, one should write $X(x;x_0)$ and $A(x;x_0)$ for X(x) and A(x), respectively. However, in the most situations in the present work, this dependence is not essential or, in fact, is not presented at all. For that reason, we shall not indicate it explicitly.

As it was said above, we consider quantum—eld theories in which the components P of the momentum—operator commute between them selves and satisfy the Heisenberg relations/equations with the eld operators, i.e. we suppose that P and $^{\prime}$ -i(x) satisfy the relations:

The notation x_0 , for a xed point in M , should not be confused with the zeroth covariant coordinate 0×0 of x which, following the convention x := x, is denoted by the same symbol x_0 . From the context, it will always be clear whether x_0 refers to a point in M or to the zeroth covariant coordinate of a point $x \ge 0$.

It should clearly be understood, this is the general form of all state vectors as they are eigenvectors of all (commuting) observables [3, p. 59], in particular, of the momentum operator.

In m om entum picture, all of the eld operators happen to be constant in spacetime, ie.

Evidently, a similar result is valid for any (observable or not such) function of the eld operators which is polynomial or convergent power series in them and/or their rst partial derivatives. However, if $A^{\sim}(x)$ is an arbitrary operator or depends on the eld operators in a dierent way, then the corresponding to it operator A(x) according to A(x) is, generally, not spacetime-constant and depends on the both points A(x) and A(x) and A(x) are independent of A(x), we, usually, write A(x) for A(x), on itting all arguments.

It should be noted, the H eisenberg relations (2.7) in m om entum picture transform into the identities ($^{\prime}$) $^{\prime}$ = 0 m eaning that the eld operators $^{\prime}$ $^{\prime}$ in m om entum picture are spacetime constant operators (see (2.15)). So, in m om entum picture, the H eisenberg relations (2.7) are incorporated in the constancy of the eld operators.

Let Γ be the system's Lagrangian (in Heisenberg picture). It is supposed to be polynomial or convergent power series in the eld operators and their rst partial derivatives, i.e. $\Gamma = \Gamma('_1(x); 0'_1(x))$ with 0 denoting the partial derivative operator relative to the the coordinate x. In momentum picture it transforms into

Since L is supposed to be polynomial or convergent power series in its arguments, the equations (2.17) are algebraic, not di erential, ones. This result is a natural one in view of (2.15).

In (2.17) and sim ilar expressions appearing further, the derivatives of functions of operators with respect to operator arguments are calculated in the same way as if the operators were ordinary (classical) elds/functions, only the order of the arguments should not be changed. This is a silently accepted practice in the literature [2,3]. In the most cases such a procedure is harm less, but it leads to the problem of non-unique de nitions of the quantum analogues of the classical conserved quantities, like the energy-mom entum and charge operators. For some details on this range of problems in quantum eld theory, see [15]. In Sect. 11, we shall met a Lagrangian whose eld equations are not the Euler-Lagrange equations (2.17) obtained as just described.

The author is completely aware of the fact that in the literature, for instance in [3, p.77, eq. (2-87)] or in [4, eq. (2.187)], the relation (2.33) is written with an opposite sign, i.e. with + ir instead of ir on its rhs. (In this case (2.33) is part of the commutation relations characterizing the Lie algebra of the Poincare group | see, eg., $[7, pp.143\{147]$ or [8, sect.7.1].) However, such a choice of the sign in (2.33) contradicts to the explicit form of P and E in terms of creation and annihilation operators (see sections 6 and 7) in the fram ework of Lagrangian form alism. 4. A nalysis of the D irac equation (s)

The D irac equations (3.6), together with the equality (2.22) and the explicit expression (3.10) for the energy-m omentum operator, form a complete algebraic-functional system of equations for determination of the spinor eld and its D irac conjugate $= y^0$ (and its momentum operator P too). This situation is similar to the one concerning a free charged scalar eld, investigated in [11]; respectively similar results hold for the structure of spinor eld operators. Moreover, there is now a simplication due to the linearity of the D irac equation relative to the momentum operator, contrary to the scalar eld case, when the corresponding K lein-G ordon equations are quadratic in momentum operator. 12

Below we shall need a system of classical, not operator-valued, suitably normalized solutions of the equations (4.19). The idea of their introduction is to be separated the invariant operator properties of the spinor eld from its particular in atrix' representation as a collection of (operator) components which depend on some concrete reference frame with respect to which it is studied. This will be done in Sect. 5 by expanding the operator-valued quantum spinors as linear combinations of the mentioned system, in fact a basis, of classical spinors, the coe cients of which expansion are fram e-independent invariant operators characterizing the spinor eld.

5. Frequency decompositions

As a consequence of the results of Sect. 4, one can expect the existence of decom positions of the constant D irac spinors and similar to the one in Heisenberg picture [1,2]. Such expansions, in fact, exist and can be introduced in almost the same way as it was done for a free charged scalar eld in [11]; the only dierences being the spinor (polarization) index s in (421) and the multi-component character of the spinors.

7. The eld equations in terms of creation and annihilation operators

This is the quantized version of the exotic solutions (4.1) (see the paragraph containing equation (5.17) in Sect. 5). Meanwhile, we notice that the solutions (4.1) are rejected by (8.10) and (8.4) (see (5.17)) (5.20)).

The developed until now theory cannot make a distinction between the cases " = 1 and " = +1 in (8.4), corresponding to quantization with commutators and anticommutators, respectively. These quantization rules will be accepted hereafter in the present work. In Sect. 11, we shall show how they can be derived without invoking the spin-statistics theorem.

As we have noted several times above, the concepts of a distribution (generalized function) and operator-valued distribution appear during the derivation of the commutation relations (8.13). We rstmet them in the tri-linear relations (7.4). In particular, the canonical commutation relations (8.13) have a sense i the anticommutators in them are operator-valued distributions (proportional to il_F), which is not the case if the eld is described as an ordinary operator acting on F . These facts point to inherent contradiction of quantum eld theory if the eld variables are considered as operators acting on a H ilbert space. The rigorous mathematical setting requires the elds variables to be regarded as operator-valued distributions. However, such a setting is out of the scope of the present work and the reader is referred to books like [7,8,20,21] form ore details and realization of that program. In what follows, the distribution character of the quantum elds will be encoded in the D irac's delta function, which will appear in relations like (7.4) and (8.13).

As a rst application of the anticommutation relations (8.13), we shall calculate the commutator between the components (6.27) of the spin operator. 9. Vacuum and norm alordering

The introduction of the vacuum (state) of a free scalar elds was discussed in momentum picture in [11]. Here is a brief mutatis mutandis sum mary of the arguments leading to a correct de nition of the vacuum of free spinor eld.

The proof in Heisenberg picture is more simple, but also too long.

The vacuum of a eld is a particular its state which describes, in a sense, the 'absence' of the eld itself. Since the eld is considered as a collection of particles, the vacuum should contain no particles of the eld. Therefore the conserved dynamical characteristics of the vacuum should vanish as an 'absent' particle has zero 4-m om entum, no charge, etc. Besides, since the vacuum does not contains any particles, the action of an annihilation operator on it should produce the zero state vector as one cannot destroy som ething that does not exist. On the contrary, the action of a creation operator on the vacuum should produce a non-zero vector describing a state with one particle in it and, consequently, the vacuum cannot be represented by the zero vector. Applying these heuristic ideas to a free spinor eld, we may say that its vacuum should be represented by a non-vanishing state vector which has zero 4-m om entum, charge and total angular momentum and the action of an annihilation operator on it results in the zero vector. So, denoting by X_0 the state vector representing the vacuum, which is also called the vacuum, we should have

The Lagrangian and dynam ical variables should be written in term s of creation and annihilation operators and, then, any composition (product) of such operator must be replaced by its normally ordered form. By de nition, the normal form of a composition of creation and/or annihilation operators is called a composition of the same operators, in which all creation operators stand to the left relative to all annihilation operators, multiplied by minus one or plus one, depending on is the permutation, bringing the operators from the initial composition to the nalone, odd or even, respectively.³⁹ The norm al form of a composition of creation and/or annihilation operators is known as their norm alproduct (com position) and the m apping assigning to a product of such operators their norm alproduct will be denoted by N and it is called norm alordering (operator). The action of N on polynomials or convergent power series in creation and/or annihilation operators is extended by linearity. The dynam ical variables after norm alordering are denoted by the sam e symbols as before this operation.

The second problem concerns the interpretation of the operators a_s (k) and a_s^y (k) as creation/annihilation operators (see Sect. 5). Since the eld can be thought as a collection of particles, one can expect that the dynam ical variables should be expressible as sum s/integrals of the corresponding individual characteristics of these particles; this is rigorously expressed via results like (6.6) { (6.16) and (6.41) { (6.43). However, if we want to retain the interpretation of a_s (k) and a_s^y (k), introduced in Sect. 5, the signs before the second terms in the braces in (6.7) and (6.10) should be opposite. The reason being quite simple: the 4-momentum of a system of two particles, one created by a_s^+ (k) and another one by a_s^{y+} (k), should be a sum of the 4-momenta of these particles, while the charge of this system should be the difference of the charges of the particles, measured in the units q_s^{40} . As we see from (9.4) and (9.5), this problem automatically vanishes after normal ordering.

The equality (9.7) partially changes the interpretation of the creation and annihilation operators with respect to the polarization (spin) index s (see (6.41) and the conclusions after it). So, in the frame in which (9.7) is derived, the projection of the spin vector on the third axis is $+\frac{1}{2}$ ~ (resp. $\frac{1}{2}$ ~) for the particles corresponding to a_1^+ (k), a_2^y (k), and a_2^{y+} (k) (resp. a_1^y (k), a_1^{y+} (k), a_2^y (k), and a_2^y (k)).

The description of the state vectors of a free spinor eld is almost identical with the one of state vectors of free charged (with non-zero charge) scalar eld [11]. Formally, the only essential di erence is in the polarization index s carried by the creation and annihilation operators of a spinor eld.

The conclusions from this formula are similar to the ones concerning free scalar elds [11]. However, the Lagrangian (11.1) has two advantages: on one hand, it is Herm it contrary to (11.3) and, on the other hand, it vanishes when the eld variables satisfy the eld equations, which simplifies some calculations.

Before going on, we emphasize that the calculation of the derivatives in (11.5) and in (11.8) below according to the rules of the classical analysis of commuting variables is not quite correct. This method is harm less when the Euler-Lagrange equations are considered but it requires some additional operator ordering rules for the expressions of the conserved quantities; for details, see [15]. However, this approach breaks down for the Lagrangian (11.18) (or (11.15)) which we shall investigate below; the cause being that all its derivatives vanish if they are calculated according to the rules mentioned. For the correct treatment of that Lagrangian, the methods developed in [15] are required.

Lagrangian (11.15) is constant as a functional of the eld variables, which, obviously, is not the case. This paradox' is explained in the paper [15] in which it is proved that it is due to an incorrect transferring of the di erentiation rules from the classical analysis of commuting variables and functions of them to the 'quantum' one of non-commuting variables, such as the operators on Hilbert spaces, and functions of them. Thus, we see that, when one starts from the Lagrangian (11.18), the only free spinor elds that are possible to be quantized via commutators are (4.1), in the massless case m=0, and the missing eld ==0 in the massive case $m\in 0$. The former solutions of the eld equations were investigated at length in the previous sections and the latter solution, ==0, of the eld equations is completely unphysical as it cannot lead to any physically observable consequences. But, moreover, these solutions are rejected by the properties (8.5) and (8.6) of the (generalized) functions in the right-hand-sides of the equations in (8.4). Therefore, the Lagrangian (11.18) does not admit quantization by commutators, contrary to the Lagrangians (11.16) and (11.17), and, consequently, for it we must put "= +1 in (8.4). The further analysis of (11.36) with "= 1 and (11.37) with "= +1 is practically

Consequently, the Lagrangians (11.16) { (11.18) lead to identical anticom mutation relations, viz. (8.13), and in this direction the only dierence between them is that (11.18) does not require as an additional condition the quantization via anticom mutators, or an equivalent to it hypothesis, like the spin-statistics theorem or charge sym metry, as this condition is encoded in it from the very beginning.

identical to the one of (8.2) and leads to the anticom mutation relations (8.13).

Since the anticommutation relations for the Lagrangians (11.16) { (11.18) are identical, the vacuum and normal ordering for them should be introduced in an identical way, viz. as it was described in Sect. 9. As a result of (11.31) { (11.33), after normal ordering, the operators of the dynamical variables for them become identical and are given by (9.4) { (9.9).

Let us sum marize. The Lagrangians (11.16) { (11.18) (or (11.13) { (11.15) in Heisenberg picture) are equivalent in a sense that they entail identical nal quantum eld theories.

⁵⁶ O ne can derive (8.13) without any calculations by taking into account that the lhs. of (11.36) is equal to the lhs. of (8.2) combined with the change a_s (q) \$ a_s^y (q) and that the lhs. of (11.37) is equal to the sum of the left-hand-sides of (8.2) and (11.36). This implies similar changes in (8.13) under which it is invariant.

The principle di erence between them is that in (11.18) is encoded additionally the charge symmetry of (or, equivalently, the spin-statistics theorem for) a free spinor eld and there is not a need to impose it as additional condition on a later stage of theory's development.

12. Conclusion

In this paper, we made a more or less comprehensive investigation of free spin $\frac{1}{2}$ quantum elds in momentum picture of motion in Lagrangian quantum eld theory. The methods we used and the results obtained are near (similar) to the ones in [11], concerning free charged scalar elds. The main dierence from the scalar case comes from the multi-component character of a spinor eld, which is due to its non-zero spin.

A feature of the momentum picture is the introduction of creation and annihilation operators without invoking explicitly the Fourier transform (as in Heisenberg picture). We have written the eld equations in terms of these operators. In this form they turn to be trilinear algebraic (-functional) equations relative to the creation and annihilation operators. On this base, the standard anticommutation relations are derived under some explicitly presented additional conditions. Under these conditions, the anticommutation relations are tantam ount to the initial eld equations for free spinor elds. We have also brie y studied the state vectors, vacuum and normal ordering procedure for these elds.

An analysis of the initial Lagrangian, from which the quantum theory of free spinor eld is derived, is presented. The consequences of several Lagrangians are described and the best' one of them is single out. It is the one which is charge symmetric, i.e. it is the one which is invariant under the change particle\$ antiparticle described in suitable variables. This is the Lagrangian (11.15) in Heisenberg picture or (11.18) in momentum picture. It entails, before quantization and normal ordering, the eld equations (11.35) in terms of creation and annihilation operators. Evidently, these equations can be rewritten as

Trilinear relations, like equations (12.1), are typical for the so-called parastatistics and para eld theory [24{28}], where they play a role of (para)commutation relations. Elsewhere we shall show how from (12.1) the paraferm i commutation relations for a free spinor eld can be derived.

We shallend with the evident remark that the particles and antiparticles of a free spinor eld (, described via some of the Lagrangians considered in this paper) are always dierent, due to the fact that the charge of eld's particles and antiparticles is q and +q, respectively, and their spin and orbital (angular momentum) operators are always non-zero and dierent (see, e.g., (10.9), (10.10), (6.27) and (6.38)).
