N on-commutative dynamics and roton-like spectra in bosonic and fermionic condensates

The relation between symmetry breaking in non-commutative cut-o eld theories and transitions to inhom ogeneous phases in condensed matter is discussed. The non-commutative dynamics can be regarded as an elective description of them echanism swhich lead to inhom ogeneous phase transitions and their relation to the roton-like excitation spectrum. The typical infrared-ultraviolet mixing in non-commutative theories contains the peculiar ingredients to describe the interplay between short and long distance particle interactions which is responsible for the non-uniform background and the roton spectrum both in bosonic and fermionic condensates.

The relation between symmetry breaking in quantum eld theory and phase transitions in condensed matter is wellknown.Spontaneoussymmetry breaking in ⁴ with a constant vacuum expectation of the eld corresponds to a Bose - Einstein condensation (BEC) and there is a strong analogy between the cut-o eld theory and the hard sphere Bose gas description of super uidity [1]. Chiral symmetry breaking is the eld theoretical version of superconductivity and the ground state is described by a condensation of ferm ion-antiferm ion pairs corresponding to the Cooper pairs in the Bardeen-Cooper-Schrie er (BCS) state [2]. The previous correspondences are usually restricted to the cases of constant order param eters, that is of transitions to uniform phases, because this guarantees the translational and rotational invariance of the eld theory.

On the other hand, in condensed matter, due to particle interactions or to external experimental setups (for example a trapped condensate), one considers transitions from hom ogeneous to inhom ogeneous phases with nonconstant order parameters. For a bosonic system, according to [3], the transition from hom ogeneous to inhom ogeneous phases, with an order parameter which for large distances is an oscillating function, is associated to a roton-like behavior of the excitation spectrum. For the ferm ionic system s it is possible to build superconducting states, like the Larkin-O vchinnikov-Fulde-Ferrell (LOFF) state [4], with energy lower than the BCS state, where the C coper pairs have a non-zero total momentum and then the ferm ionic condensate is not uniform.

In [5] the application of non-commutative dynamics to the lowest Landau level, to quantum Halle ect and to uid dynamics has been discussed. In [6, 7, 8] it has been proposed that one can continue to follow the previous analogies with condensed matter also for transition to inhom ogeneous phases if the quantum eld theory is generalized to non-commutative coordinates. In particular, the non-commutative generalization of 4 shows [6, 7, 9] that the spontaneous symmetry breaking occurs for a non-uniform stripe phase and in the non-commutative G ross-N eveu (G N) model there is an inhom ogeneous chiral symmetry breaking corresponding to spin density waves [8].

In this letter we consider the symmetry breaking in cut-o non-commutative eld theories as an elective approach to understand the general dynamical mechanisms which lead to inhom ogeneous phase transitions and the correlated roton-like excitation spectrum. Indeed the non-commutative dynamics indicates that also for condensed matter system s:

a) there is a strong link between a roton-like excitation spectrum and a transition to an inhom ogeneous background, which con rm s [3];

b) for bosonic system s the non-uniform behavior and the correlated roton spectrum is due to non-local particle interactions (also induced by external setups), i.e., to the interplay between short and long distance e ects;

c) for ferm ionic system s there are: a transition to inhom ogeneous states with a pairing with totalm om entum P \notin 0; a roton dip in the excitation spectrum; e ects due to m om enta non-equal to the Ferm im om entum (this is m ainly due to the infrared/ultraviolet (IR/UV) connection (for a review see [10]));

d) the observed phase transitions turn out to be rst order.

We shall rst discuss the relation between the noncommutative scalar eld theory and the roton excitation in BEC and then we consider ferm ionic system s.

On general grounds, in a bosonic condensate the roton spectrum is due to a non-local interatom ic potential V ($r r^0$), with a momentum dependent Fourier transform [11]. Indeed, the roton spectrum has been recently obtained by considering a BEC with a ground state wave function which takes explicitly into account the van der W aals interaction [12] or by a dipole-dipole induced atom ic interaction in trapped condensate [13, 14, 15, 16] or by considering a BEC close to the solid phase [17]. Since the BEC with the local (pseudo)potential ($r r^0$) is analogous to the spontaneous symmetry breaking in

⁴ theory, one can assume that some relevant physical e ects due to the non-local repulsive interaction can be described by generalizing the self-interacting eld theory in such a way to introduce an e ective non-local coupling.

A simple approach is to consider the non-commutative

The \deform ation" of the self-interaction term by the M oyal product gives a momentum dependent repulsive e ect which is responsible, as we shall see below, for the roton spectrum and for the phase transition to an inhomogeneous background.

In [7] the spontaneous sym m etry breaking for the theory in Eqs. (1) and (2) has been analyzed with the following results:

1) the transition occurs to a stripe phase where the order parameter is $(x) = A \cos Q + x$;

2) A;Q and the energy excitation ! (p) are xed by minim izing the energy;

3) Q is orthogonal to ~ and Q is sm all for large ;

4) the excitation spectrum can be approximated by

where the function M (p) will be discussed later.

The previous results, obtained by variationalm ethods in the static limit, represent the solutions of a set of selfconsistent m in in ization equations of the elective potential in the Hartree-Fock approximation for the parameters A;Q;M. As discussed in detail in [7], since Q is small, the inhom ogeneous background is a smooth function of x and then, the breaking of translational (sm ooth) and rotational invariance is approximated by a translational invariant propagator with a momentum dependent m ass term.

In the particular case $_{ij} = _{ijk}$ ^k with ~ = (0;0;), Q = (Q = 2; Q = 2; 0) and large values of ² (is the UV cut-o), it turns out that

and that M (p), for sm all p, is given by

where is a constant and indicates the usual vector product.

The peculiar behavior for small p of the last term in the previous equation is due to the \mathbb{R}/UV connection of the non-commutative eld theory and gives a divergent mass term in the \mathbb{R} region and a minimum of the irreducible two-point function. However the elective theory has a natural self-generated \mathbb{R} cut-o Q where it is more correct to cut the smallm om enta also because one is neglecting the phonon branch. Then the excitation spectrum, which is related to the phase transition, should be correctly identied by Eqs. (3) and (5) with p Q and has a roton-like dip at a typical scale of order Q.

It should be clear that the M oyal-deform ed term in Eq. (1) can m in ic e ective interactions which are non-local and globally repulsive. Then, within this simple m odel, the previous results of the non-commutative theory can describe some interesting physical e ects of the Bose – E instein condensates when the repulsive interaction is dom inant and one focuses only on the rotonic part of the spectrum because the spontaneous symmetry breaking with a single scalar eld gives a gap.

For example, for a system trapped along the z direction, with a typical dimension L, where atoms interact by a dipole-dipole interaction, it has been shown by standard condensed m atter m ethods [13], that the excitation spectrum has di erent features according to the value of the momentum q in the x y plane: if qL << 1 there is a phononic behavior; if qL >> 1, due to the dependence of the coupling strength on the momentum, there is a roton excitation. All the dipoles are oriented along the z axis and for a tight con nem ent one has (alm ost) a dipole system in the x y plane with a repulsive dipole-dipole interaction.

W e shall see that an analogous result on the roton spectrum can be obtained by the non-commutative 4 theory. M oreover, for a dipole-dipole interaction, there is another reason why the system can be associated with a non-commutative dynamics. A coording to [18] it easy to show that in the x y plane a system of interacting dipole-like objects, compound by two bound opposite charge particles in a strong magnetic eld B along the z axis, follow s a non-commutative dynamics

Although this form all analogy with the usual dipoledipole interaction should be considered in a restricted sense, mainly because in the non-commutative dynam ics the "dipole" dimension depends on its center mass momentum, the previous discussion suggests that som e features of the previous BEC with trapped atoms with m agnetic m om ent can be reproduced by considering the

Indeed, by Eqs. (3), (5) and (7), in the small pregion, it is easy to verify that the non-commutative ⁴ theory, in the x y plane, has a roton-like spectrum, sim ilar to Figure 1 of [13] with a minimum at momentum $p_x^2 + p_y^2 = 2Q^2$ (with $(p_x^2 + p_y^2)L^2 >> 1$). The roton spectrum of the non-commutative theory is associated to a spatially modulated background in the x y plane according to point 1), quoted above, and one expects that a sim ilar oscillating behavior should be present in the dipolar atom ic BEC. This aspect has not been analyzed in [13], but an oscillating condensate was obtained by solving the G ross-P itaevskii equation with laser induced dipoledipole interaction in an elongated cigar-shaped BEC [15] and, in [14], it has been shown that, in the same geom etrical con guration, the dipolar interaction gives a roton dip in the excitation spectrum .

This dynamical correlation between roton-like spectrum and non-uniform background is not limited to dipole-dipole (induced) interactions. Indeed in [17] it has been suggested that a roton spectrum also occurs in a BEC close to a M ott-insulating phase with a m acroscopic population of the states with m om enta equal to the reciprocal lattice vector. The above examples con m, in our opinion, the suggestion given in [3] that the roton spectrum is correlated to an inhom ogeneous phase and the crucial dynam ical ingredient is a non-local, globally repulsive interaction.

A fler the indications obtained for bosonic systems, let us now consider the informations coming from noncommutative eld theories for fermionic system with a transition from a hom ogeneous phase, where < > is constant, to an inhom ogeneous one, where < > is \times dependent. The simplest eld theoretical approach to chiral symmetry breaking, corresponding to superconductivity, is the GN model with four fermion interaction described by the Lagrangian

In 4 dim ensions, for g larger than som e critical value, g_c , the chiral sym m etry is broken and the dynam icalgenerated m ass is constant m₀ ' g < $>_0$.

In [B] the transition from hom ogeneous to inhom ogeneous phase has been obtained by generalizing the GN m odel to the non-commutative case with Lagrangian

For g larger than some critical value, one nds again chiral symmetry breaking but, this time, in an inhom ogeneous phase where the pair correlation function has a dependence on a total momentum, P' of the ("Cooper") pair, with P ' (1 = 2).

The order parameter turns out to be an oscillating function of x and one has the breaking of translational, rotational and chiral invariance:

where $>_0$ is the constant order parameter of the commutative case and c is a numerical constant.

Since the translational invariant breaking e ects are small for large , in the analysis of the non-commutative GN model in [8] the static two-point function has been computed to order O (P⁴) and the background, < (x) (x) >, turns out to be a slow ly changing function. Then one can identify the quasiparticle spectrum as $!^2(K) = k^2 + m^2(K)$. As in the scalar case, for small momenta, k P, the quasiparticle spectrum has a leading contribution due to the IR/UV connection of the noncommutative theory, and the self-consistent IR and UV behavior of the gap equation has been interpolated by

where the constant m has been xed by the minimization of the energy and reduces to m $_{\rm 0}$ in the planar limit

 2 ! 1 , where the non-commutative e ects disappear. A lso in this case the spectrum has a roton-like dip in the plane orthogonal to \sim and one recovers the dynamical relation with the non-uniform ground state [3].

The previous eld theoreticalm odel is then analogous to a condensed matter system with a non-local fourferm ion interaction, with an inhom ogeneous phase where the particle-hole (p-h) pairs have a non-zero total momentum. From this point of view the model min ics a non-s wave superconductor in a strong coupling regime.

A kind of p-h instability has been originally proposed in [19] for speci c electronic materials (for a review see [20]) and is known as spin density wave. An anabgous phase, known as chiral density wave [21], has also been analyzed in QCD at nite density (for a review see [22, 23]). In [24] it has been suggested the possibility of a color magnetic superconducting phase, above a critical density, by breaking the chiral symmetry in a chiral density wave background.

The results of the non-com m utative m odels, where the anisotropic behavior is due to \sim , indicate that in condensed m atter and in QCD systems in analogous conditions, i.e., with a pairing for $P' \notin 0$ and in strong coupling regime, there is a transition to an inhom ogeneous phase and the excitation spectrum should have a small roton-like dip.

In the standard treatm ent of inhom ogeneous superconductivity the anisotropic behavior of the gap is usually associated only with a dependence on the angular variables of the quasiparticle m om entum, because its m odule is xed at the Fermim om entum. In our case there is a dependence on the mom entum and a deform ed Fermi surface [25].

Then, also for ferm ionic condensates, the elective eld theory approach suggests that a roton dip in the spectrum should be related to a non-uniform background. In fact this result has been for example obtained by analyzing the relation between chiral symmetry breaking and magnetism in [24] with isoscalar and isovector chiral density wave background. The lower energy spectrum is given by

where q is the momentum of the chiral density waves. For p parallel to q, E_p has a minimum for $p = 10^{-2} q^2 = 4 M^2$. The condition $q^2 = 4 M^2 = 0$ is fullled for all values of q and M which minimize the energy in the range 1

 $_2$ of the chem ical potential where the transition occurs. Finally, the eld theoretical results indicate that the phase transitions to inhom ogeneous condensates are rst order and one expects similar behavior for the corresponding condensed matter systems. This conclusion could be a by-product of the self-consistent approach [6, 7, 8] but, at least for the scalar case, it has been con rm ed by lattice calculations [9]. Points (a)-(d) sum - m arize the results of this letter, pointing out the general relation between a m inim um in the self-energy and the inhom ogeneous background, due to non-contact interactions, as the com m on underlying ingredient shared by the various physical system s and set-ups analyzed above.
